DESCRIPTION

FIG. 5 is a right side view of the cosmetic container of FIG. 1;

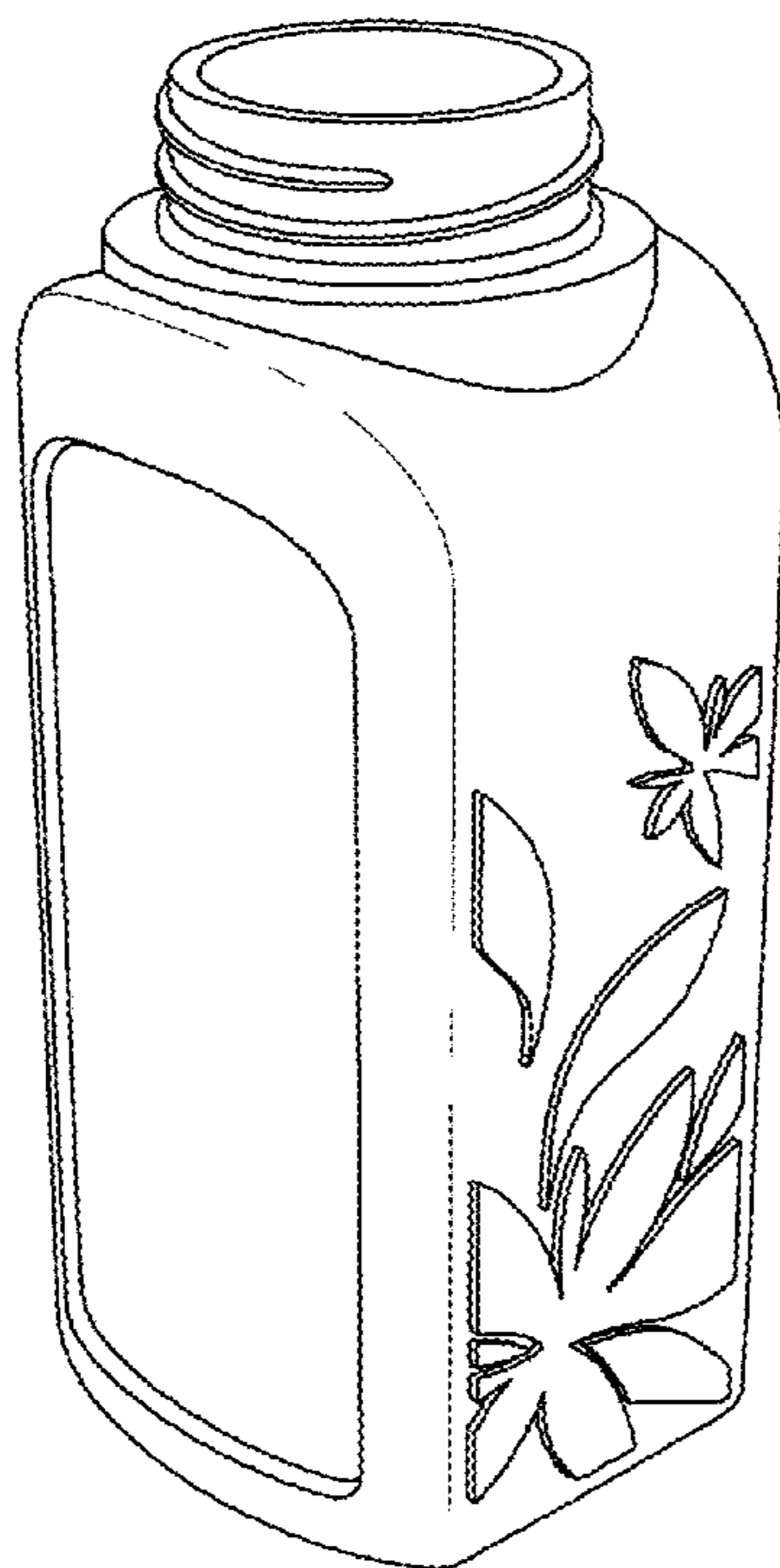
FIG. 6 is top plan view of the cosmetic container of FIG. 1;

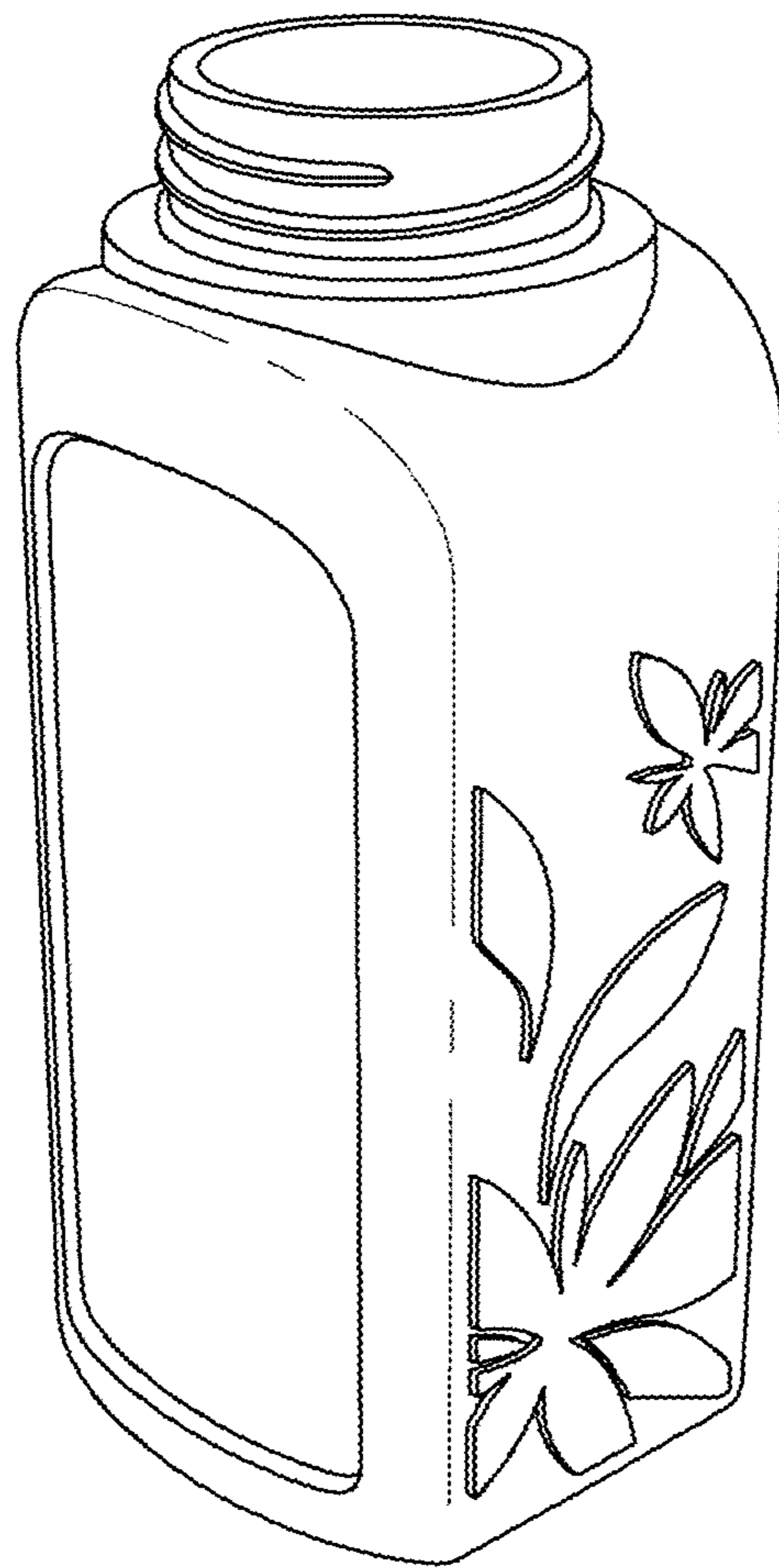

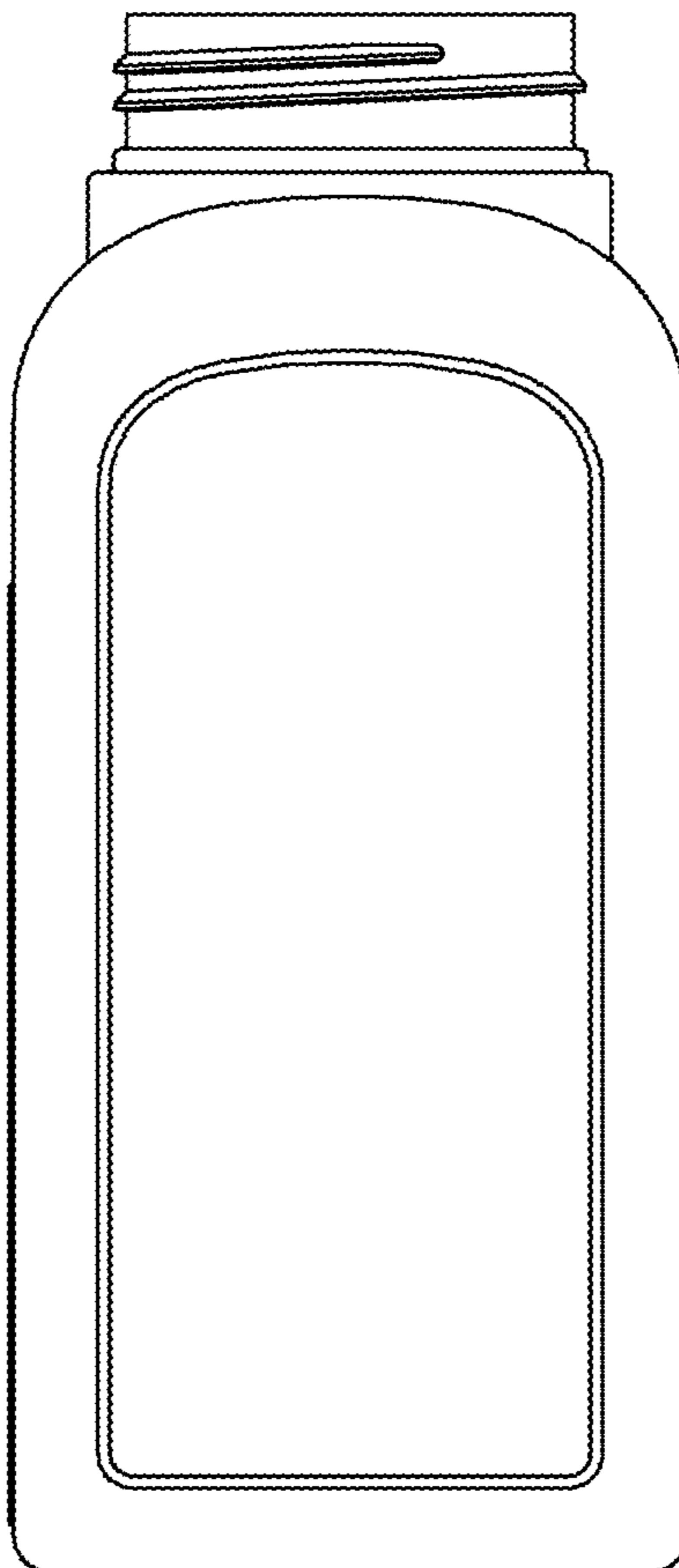

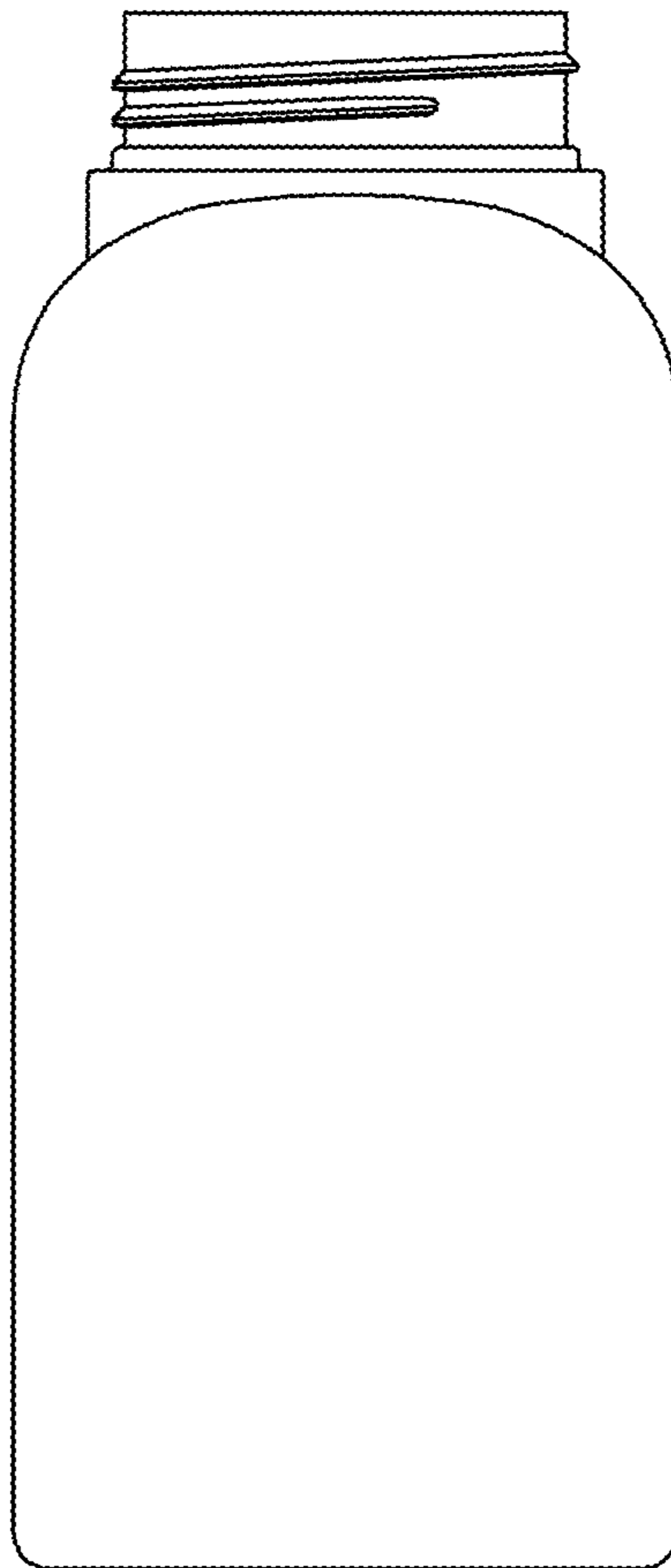

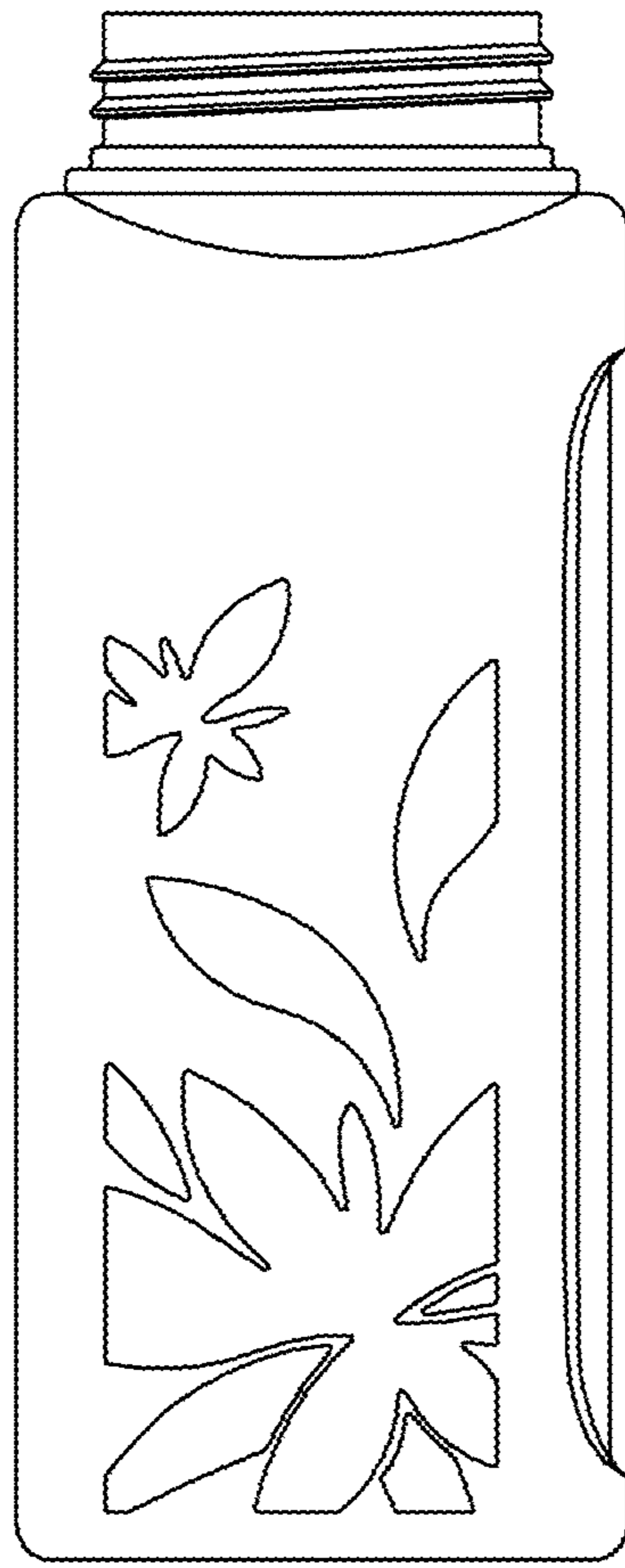

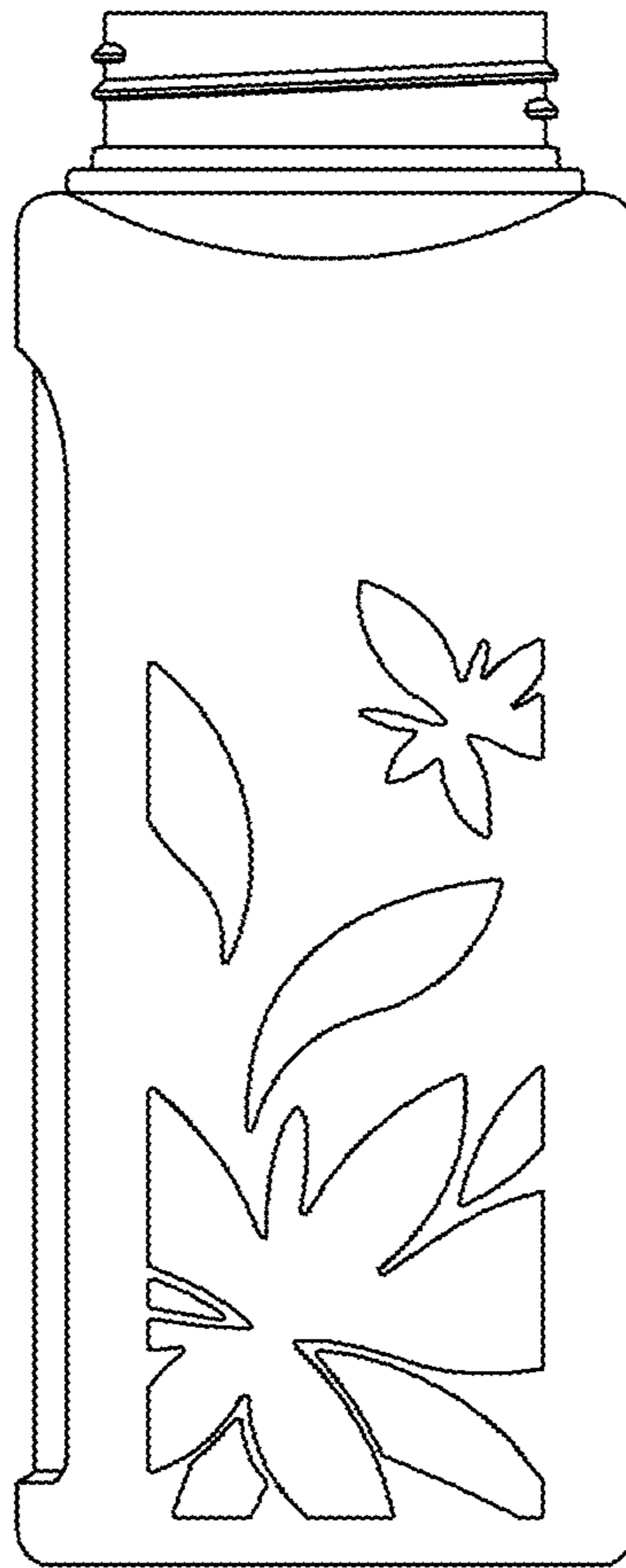

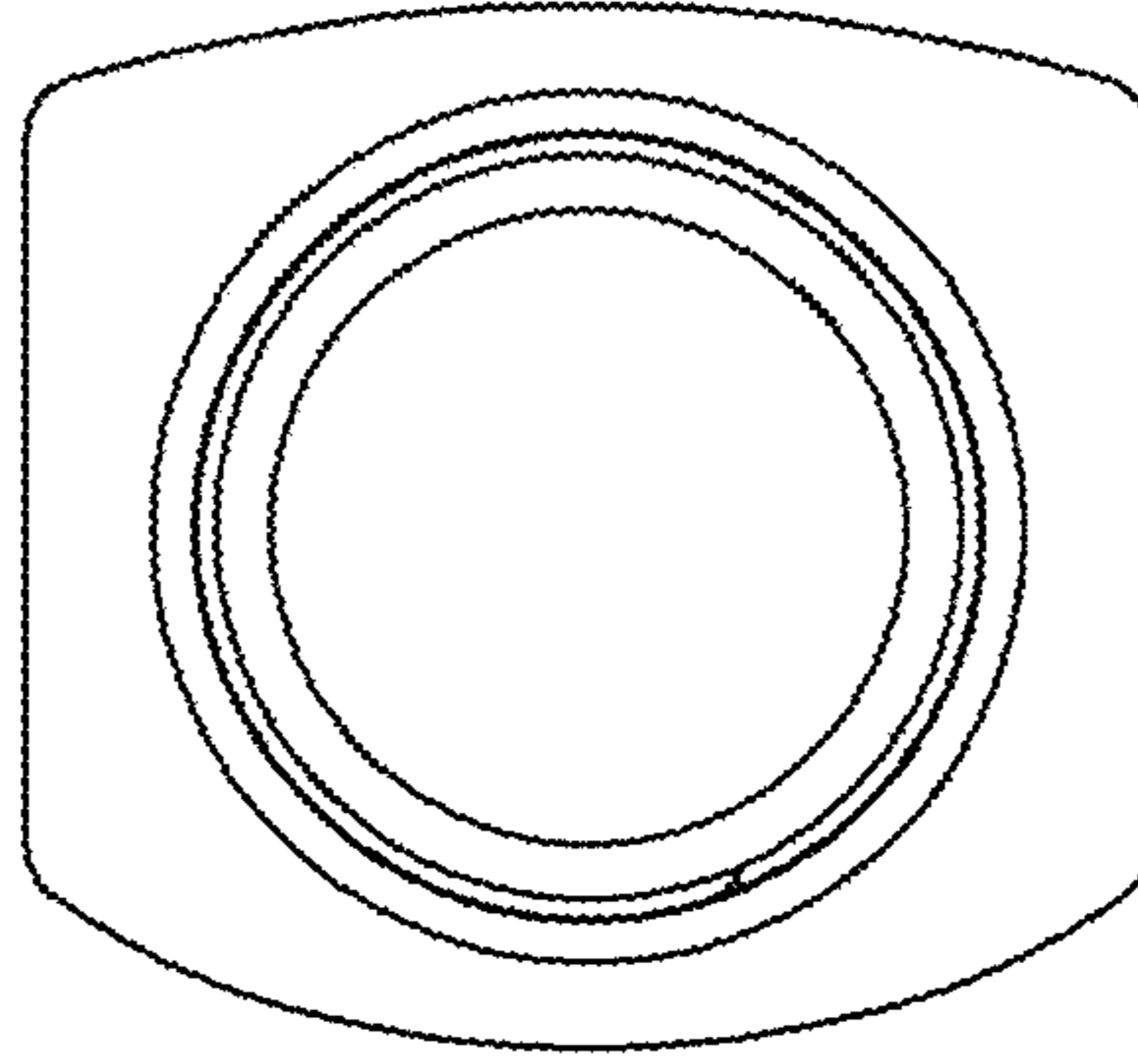

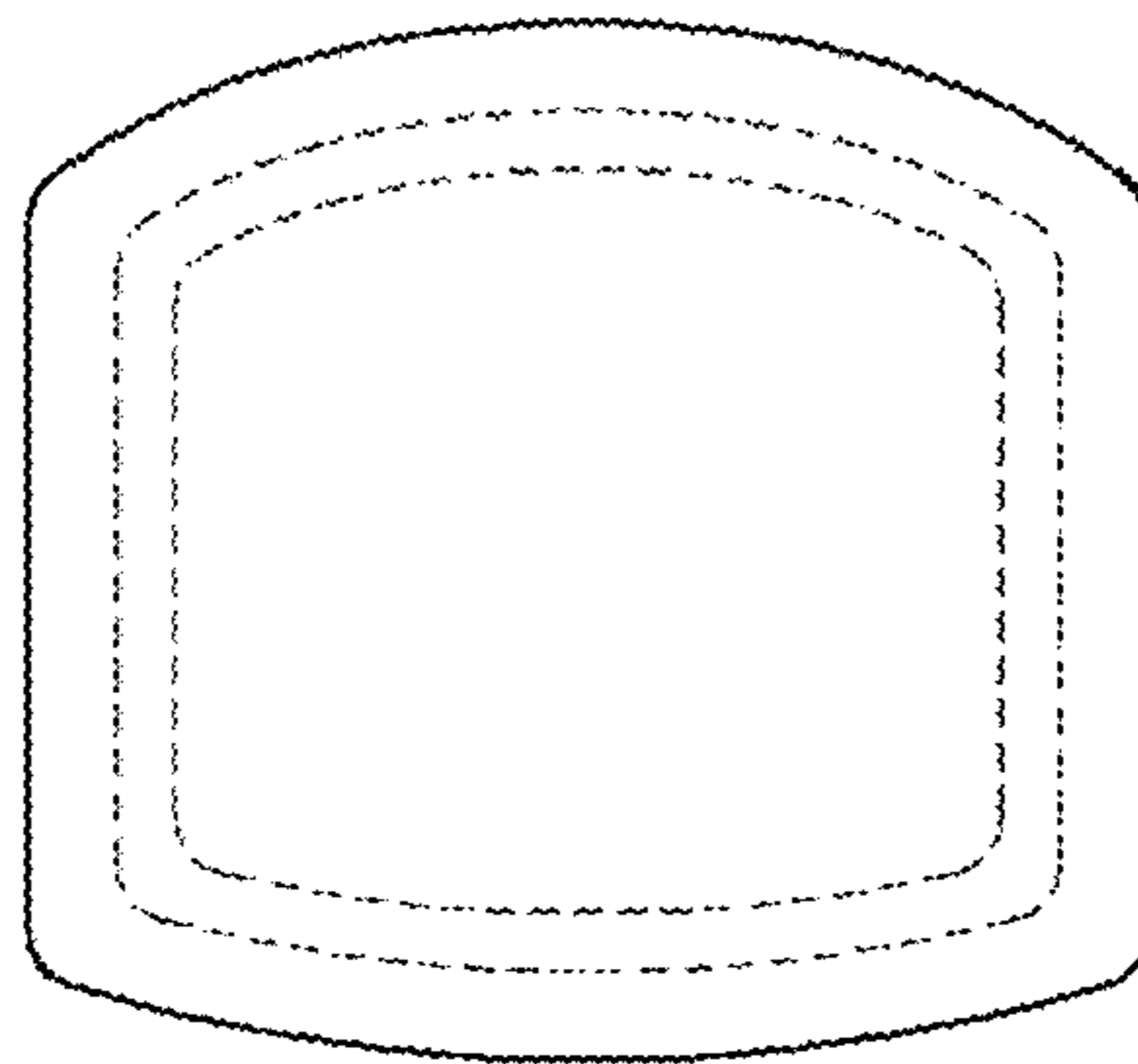
