(57) **CLAIM**

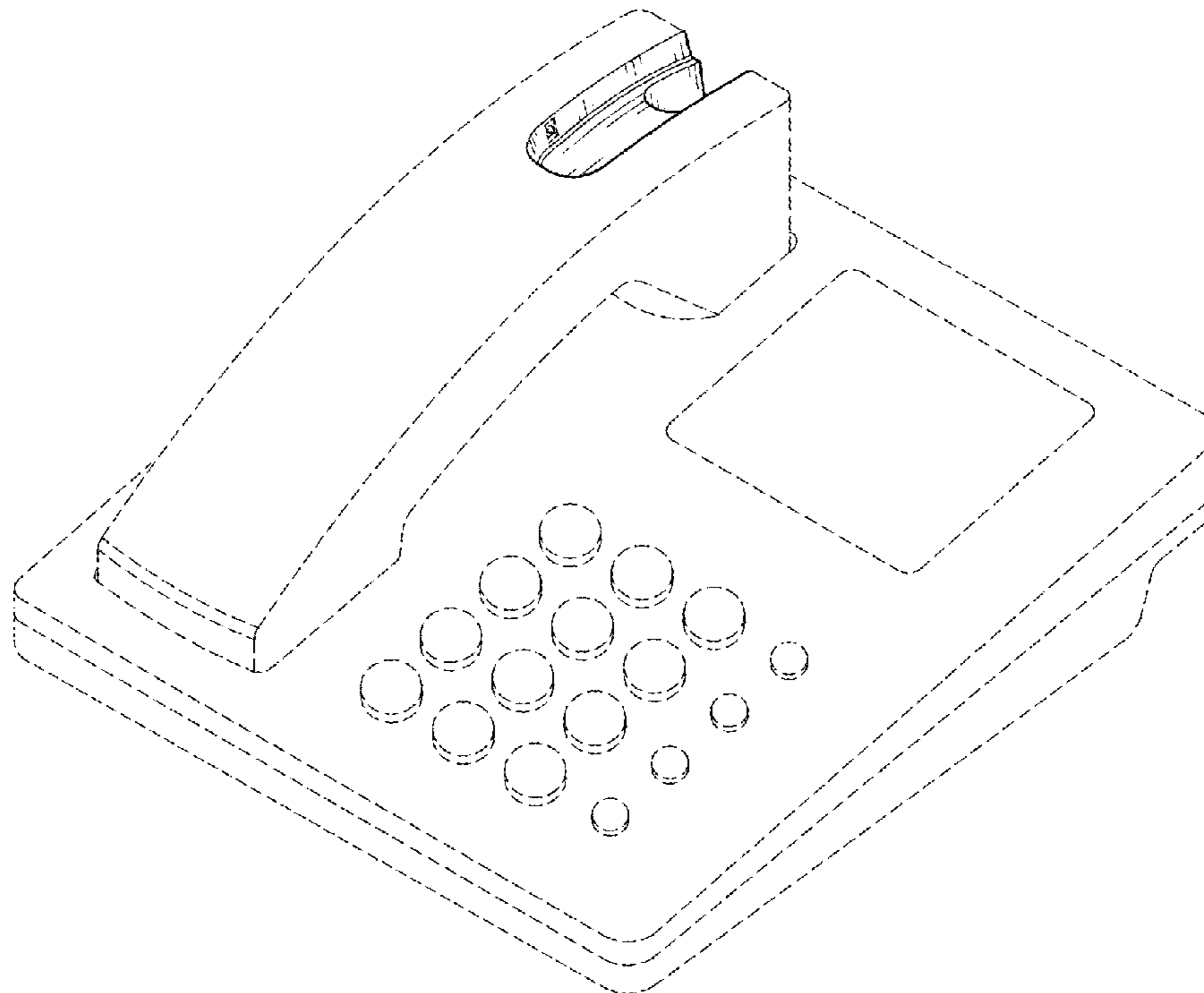
The ornamental design for an “earphone jack for telephone

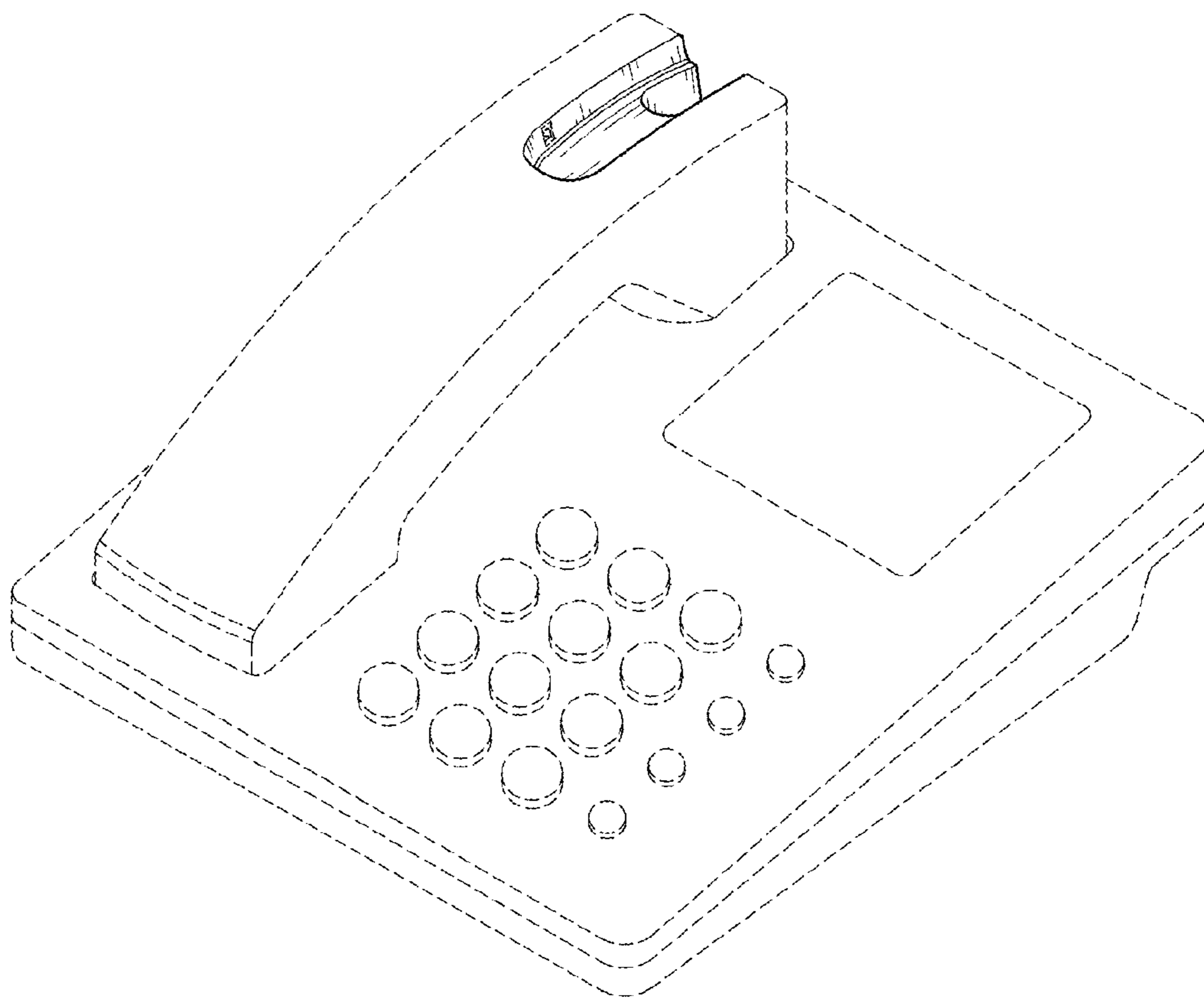

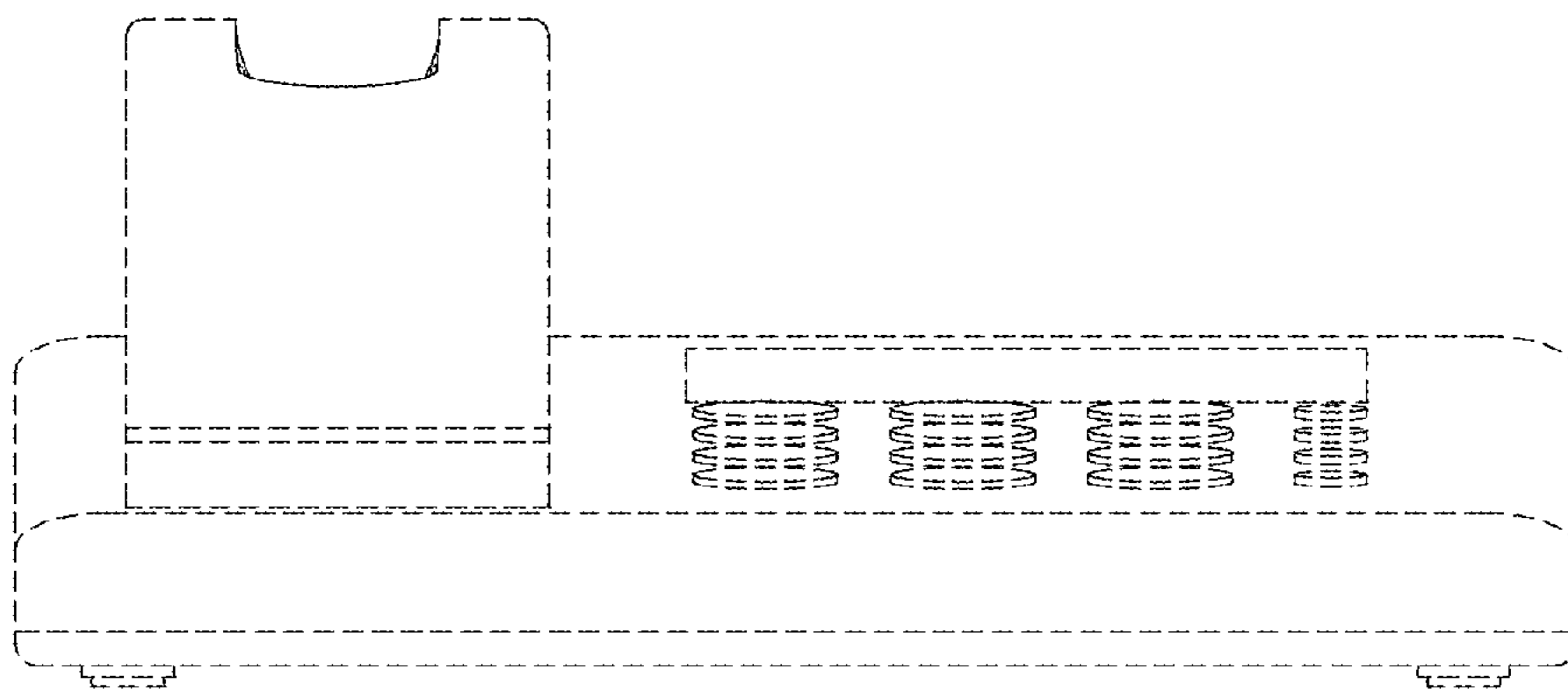

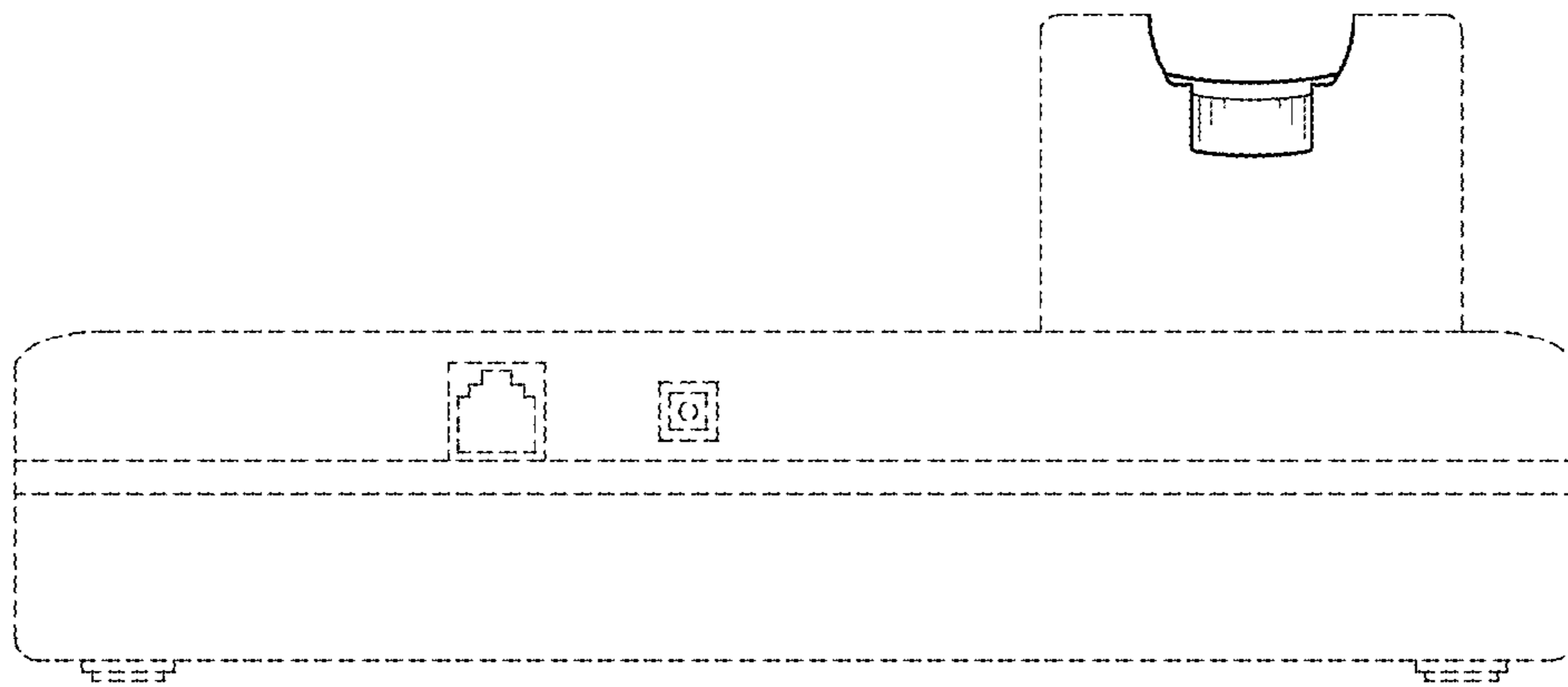

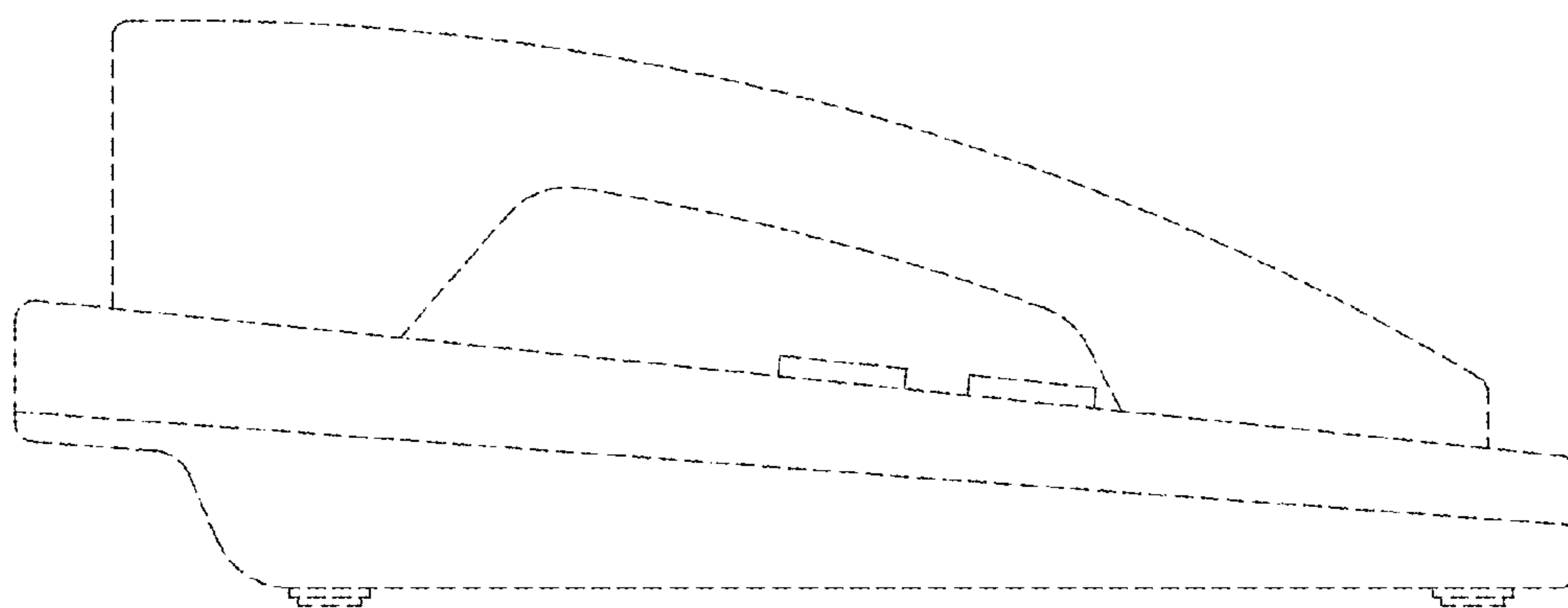

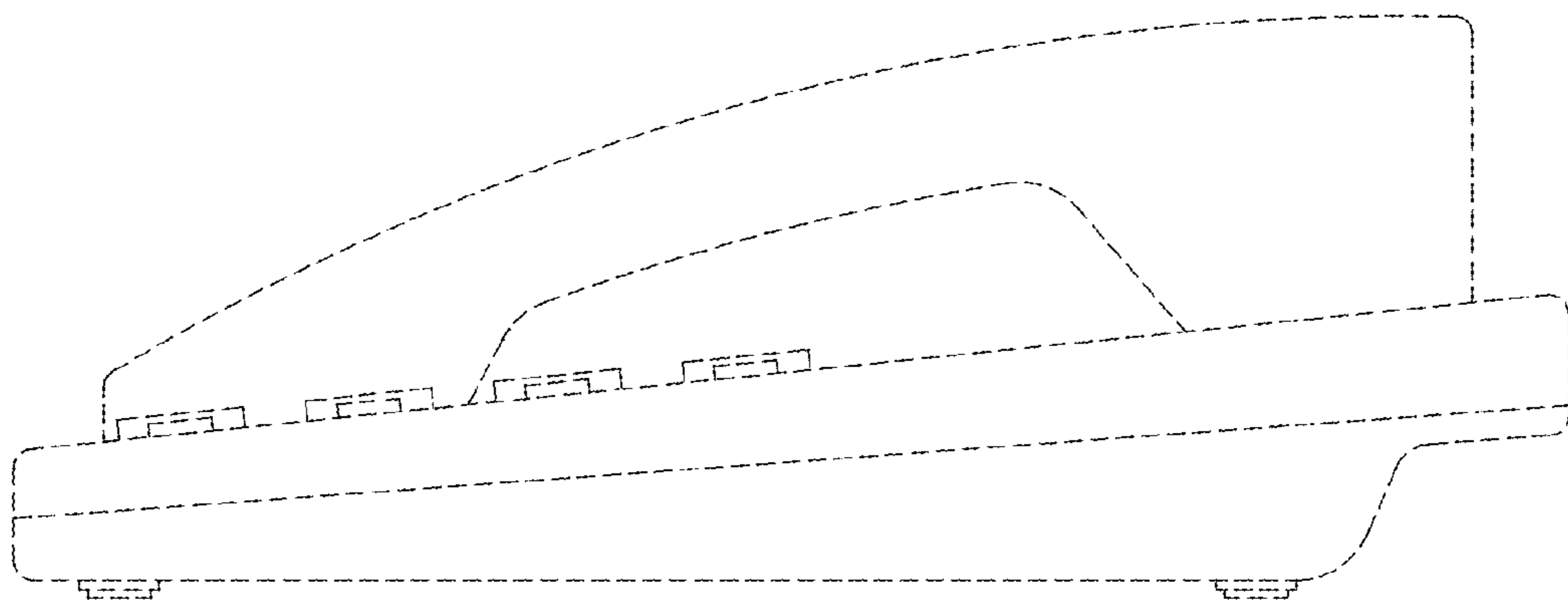

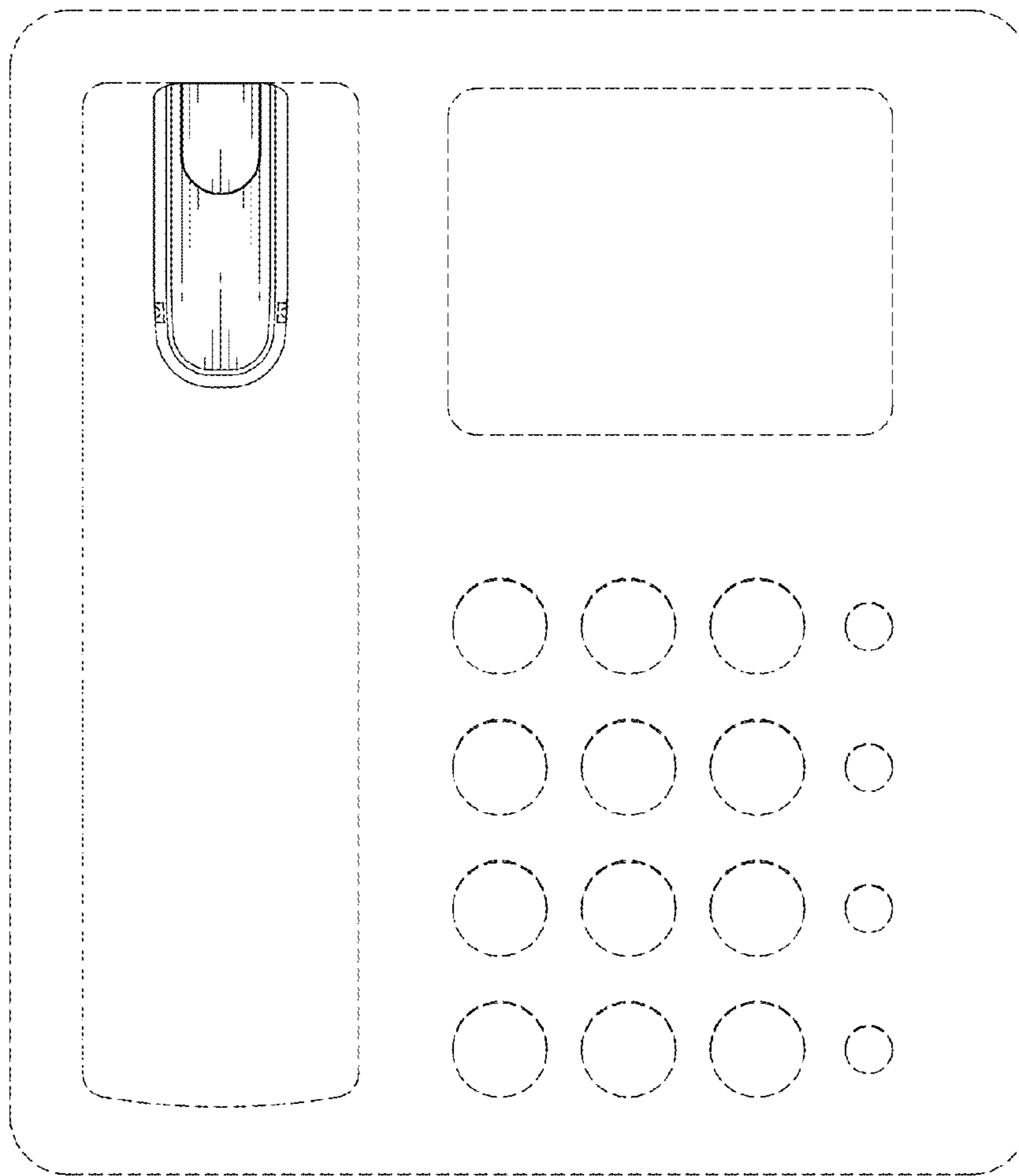

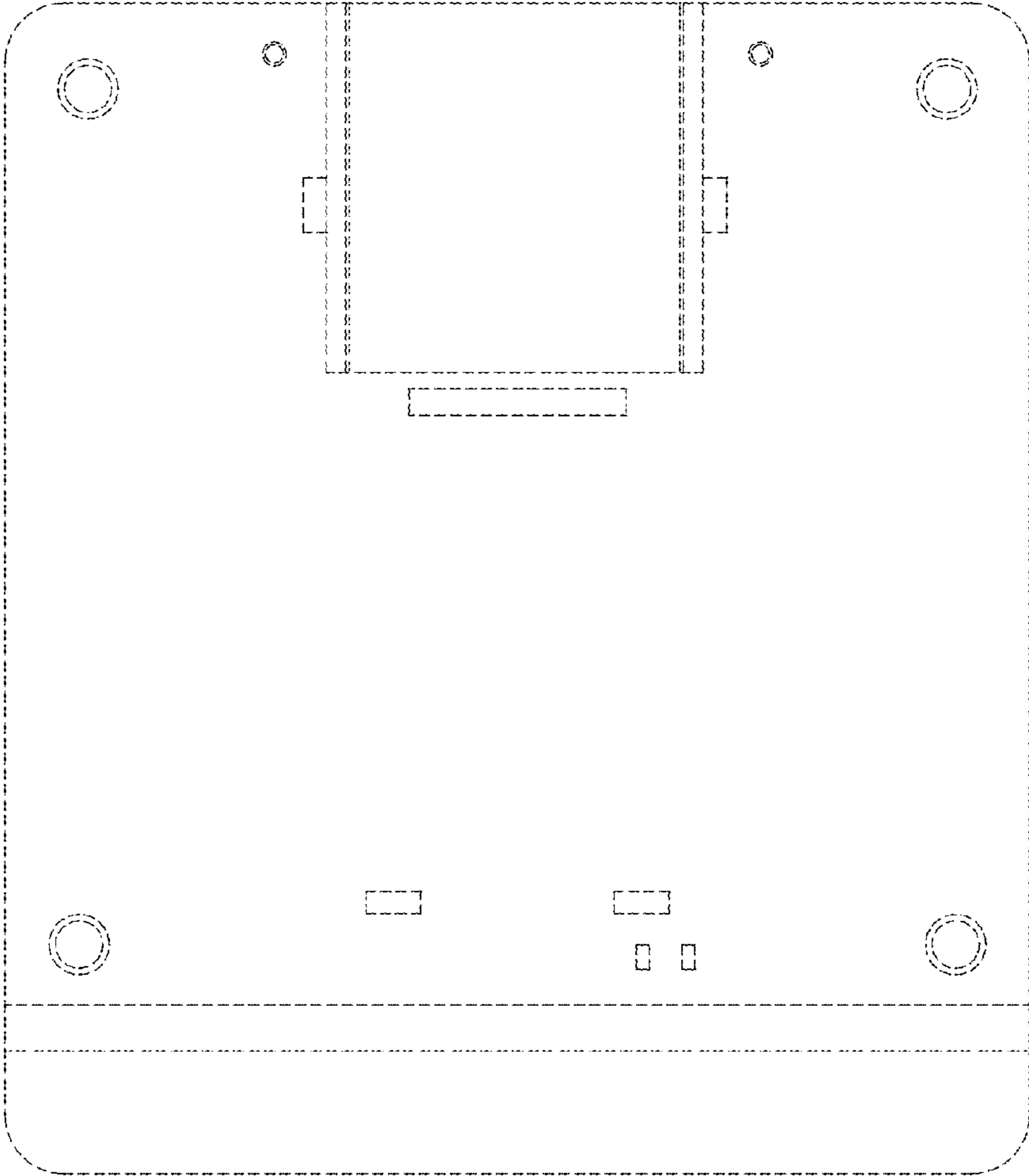

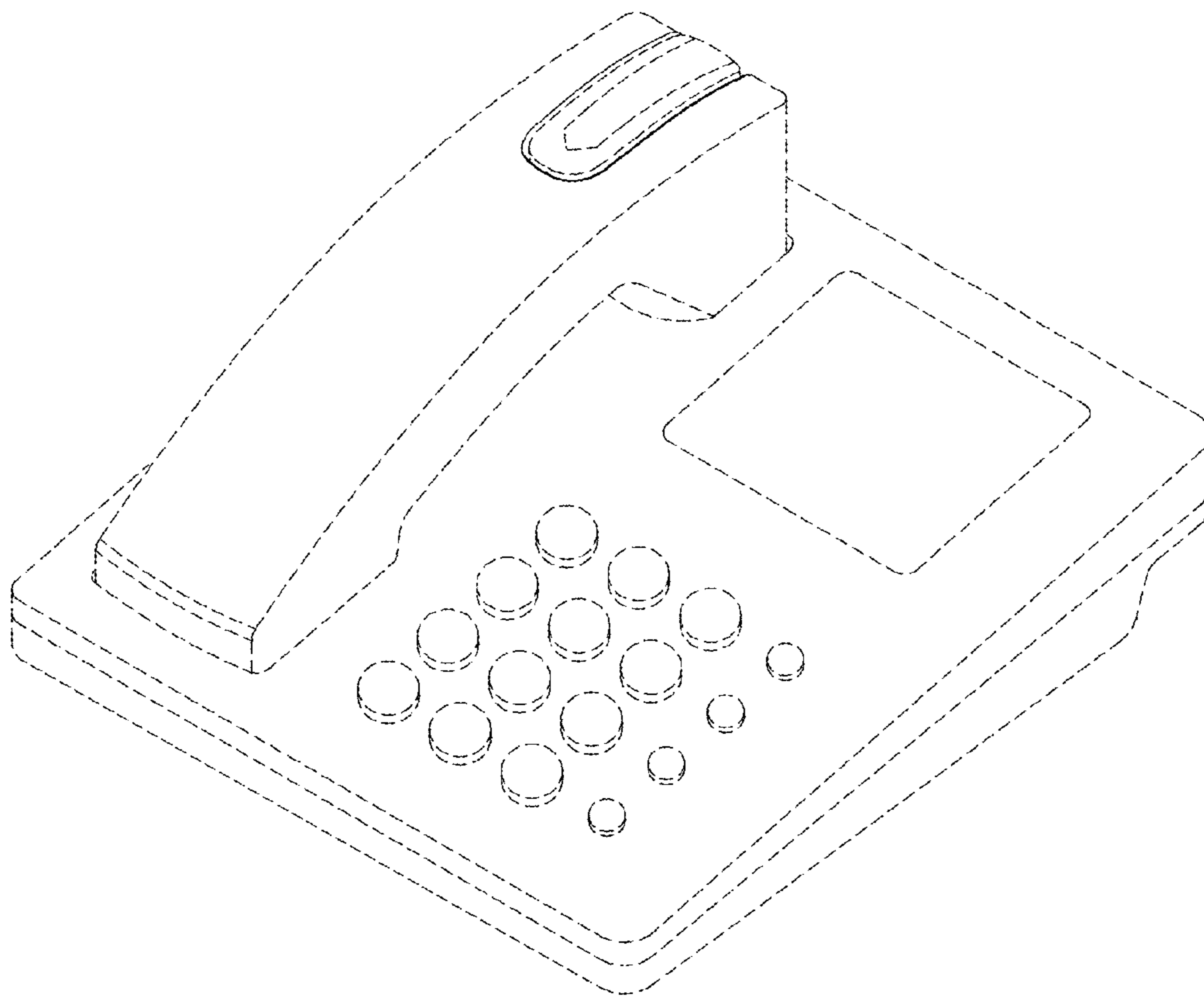
