**DESCRIPTION**

FIG. 1 is a front, lower perspective view of a three dimensional sign showing my new design;

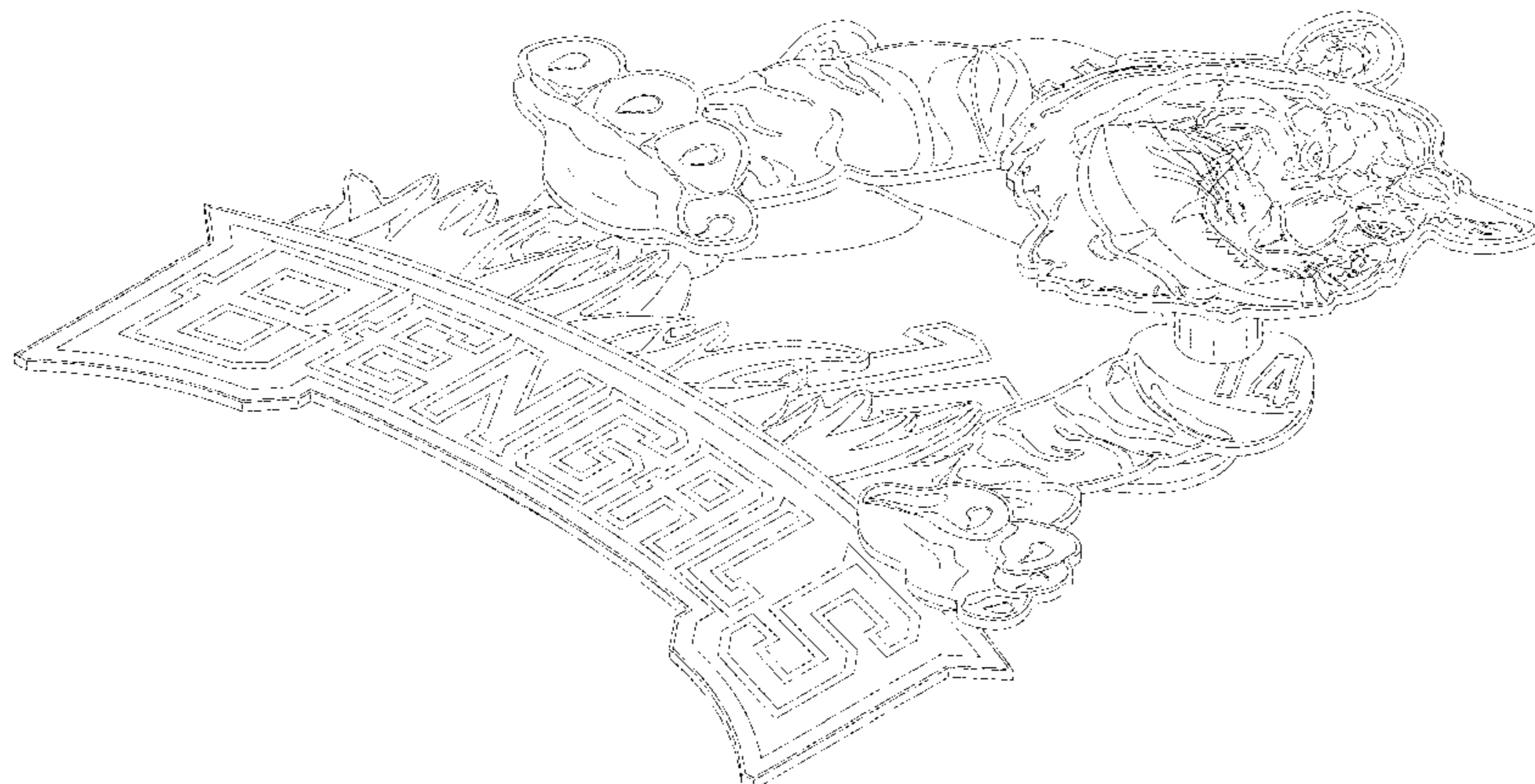

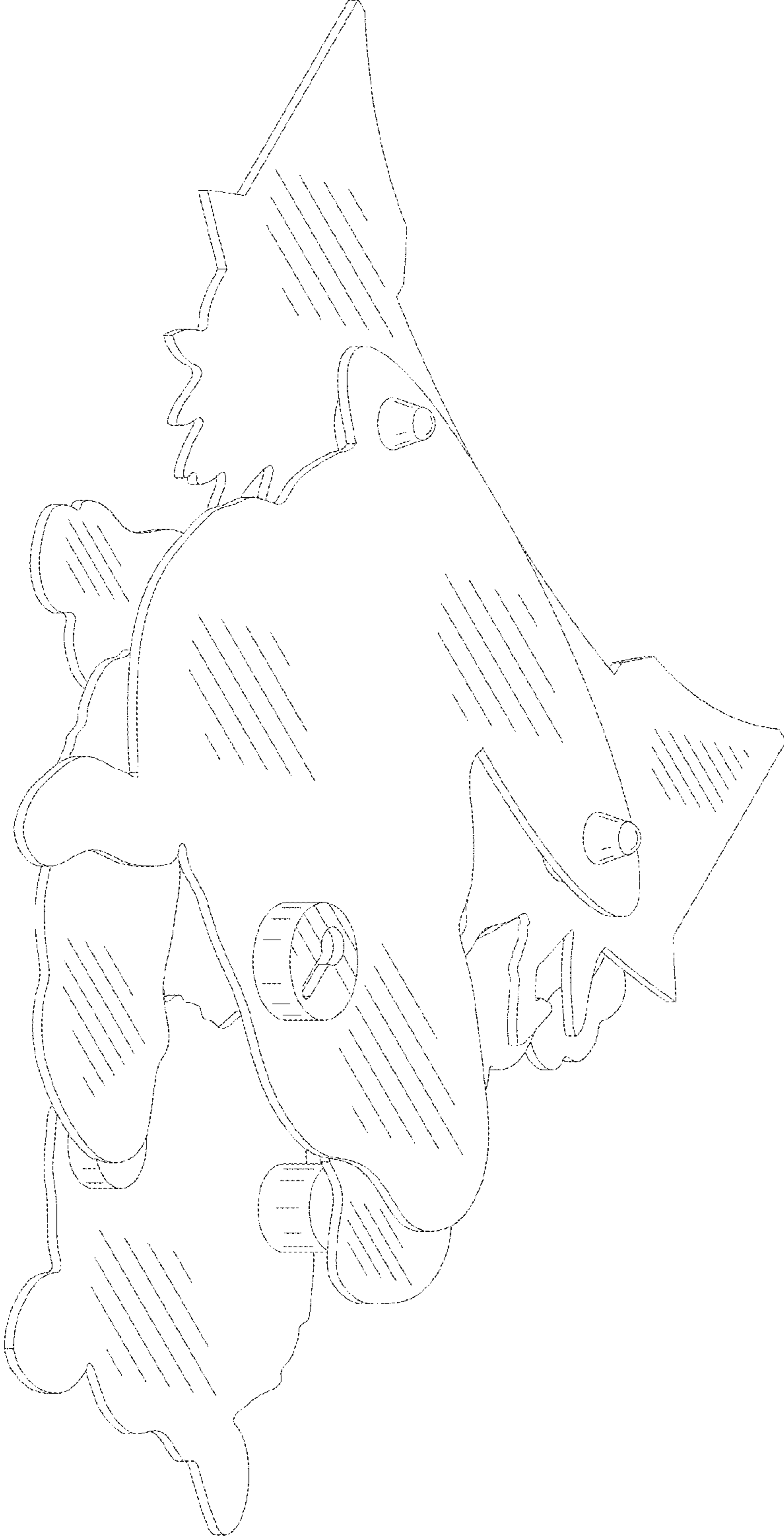

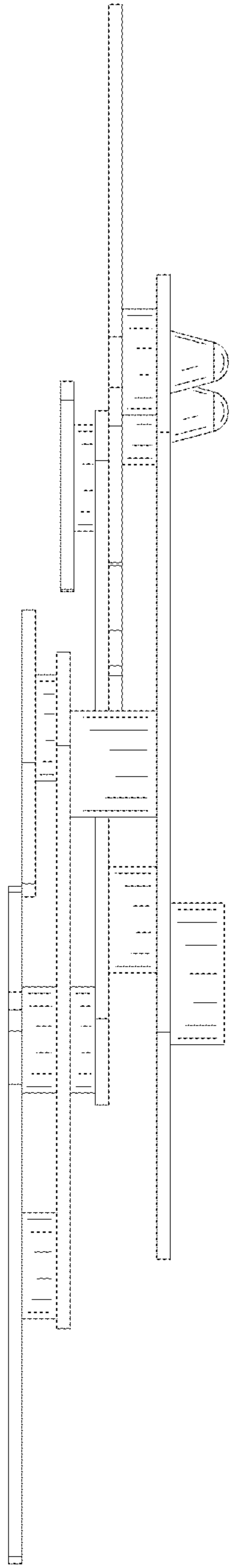

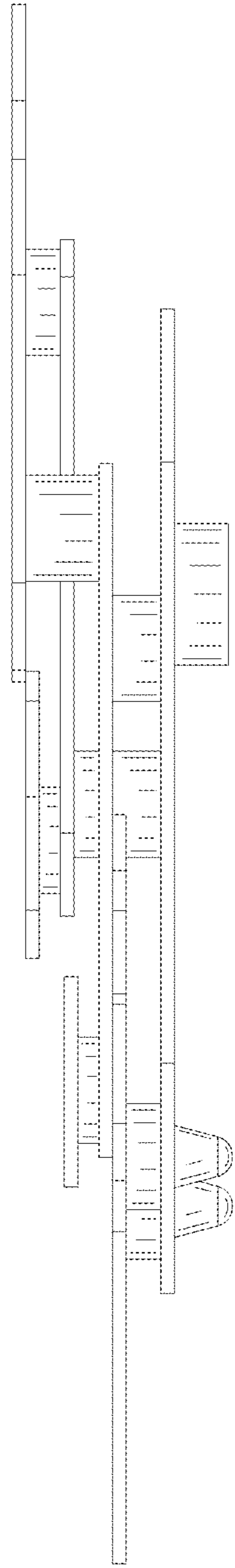

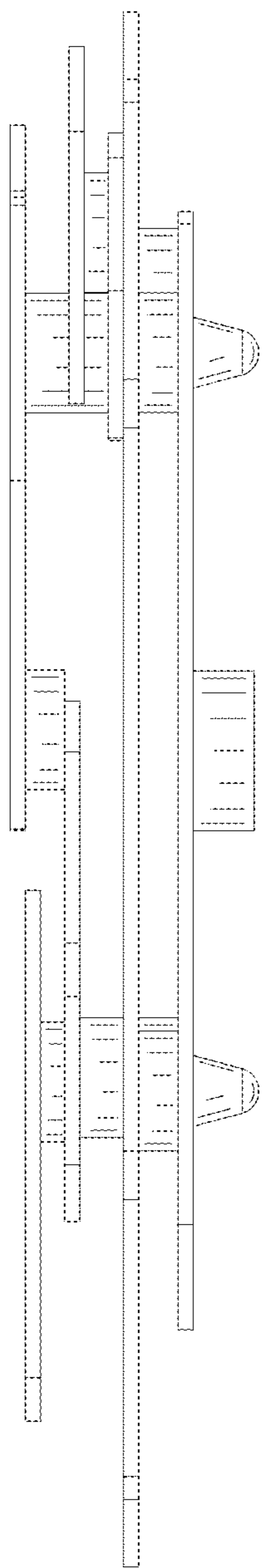

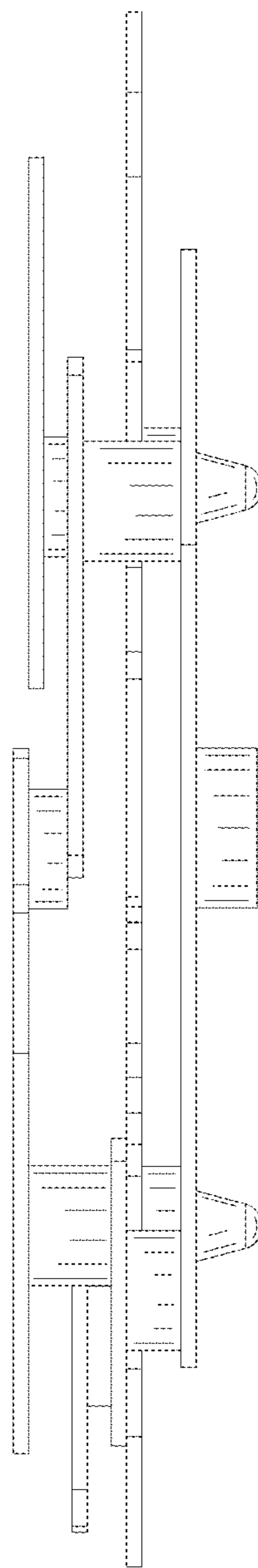

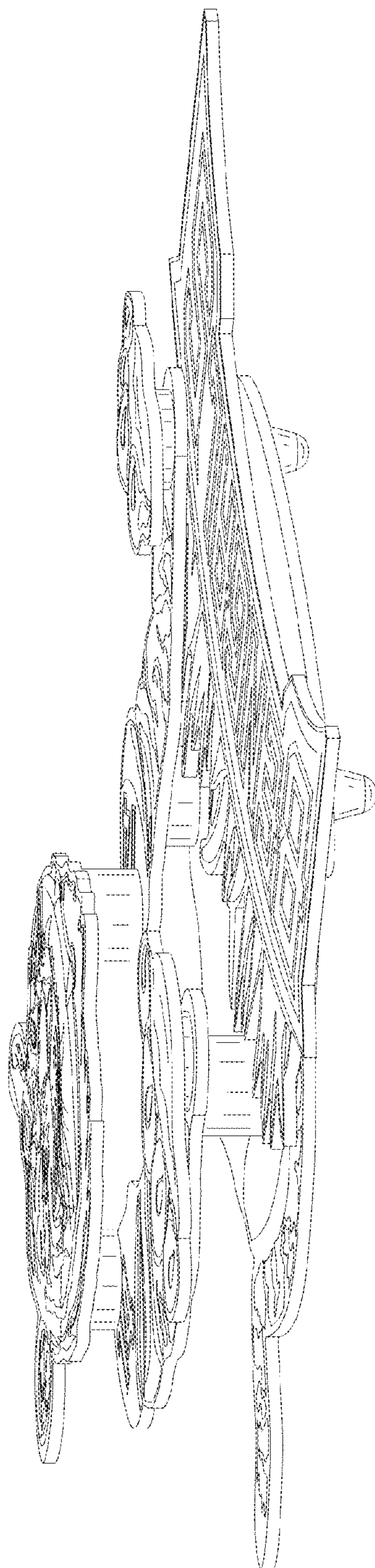
