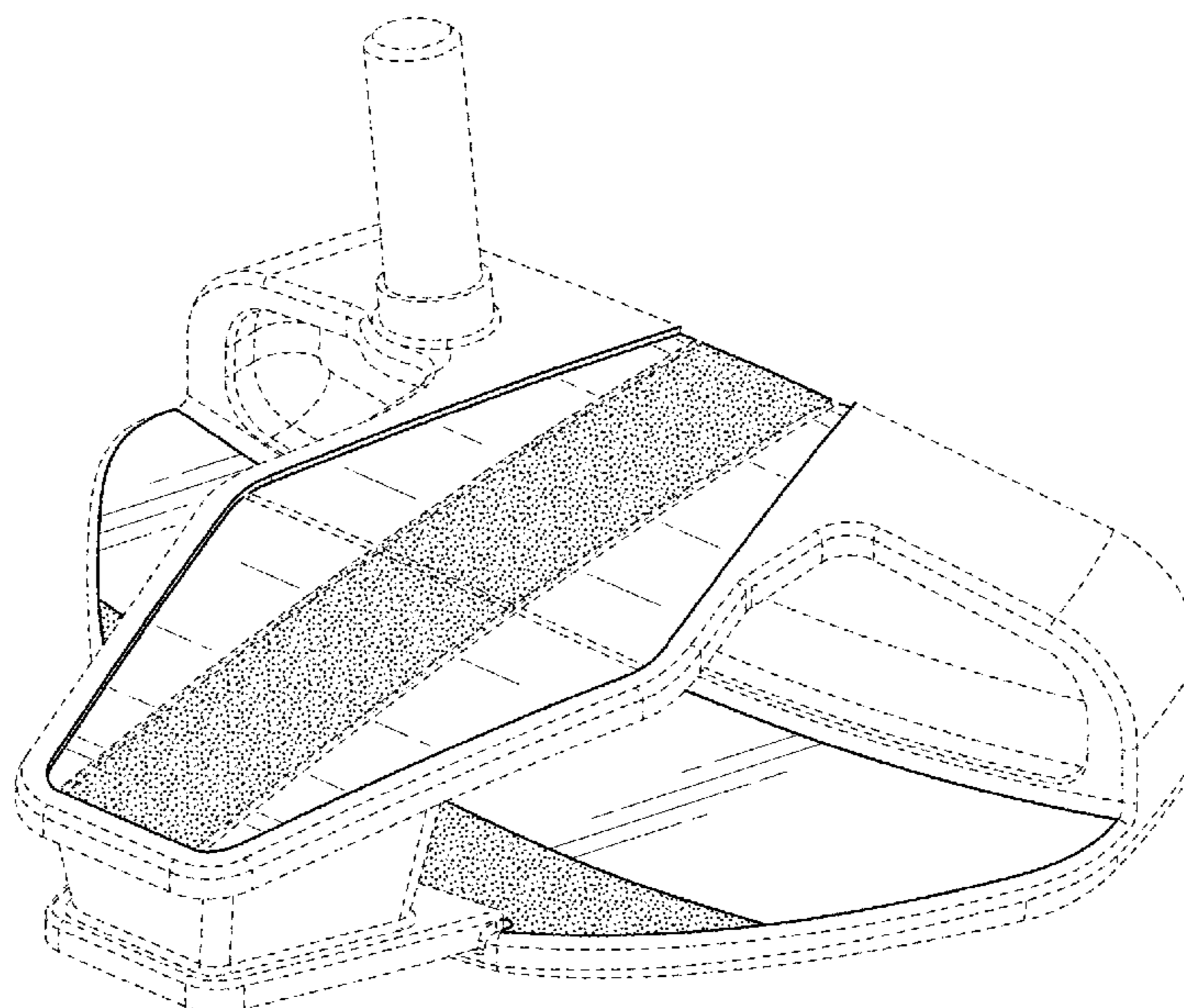
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a rear perspective view of a golf club head alignment pattern as claimed herein;

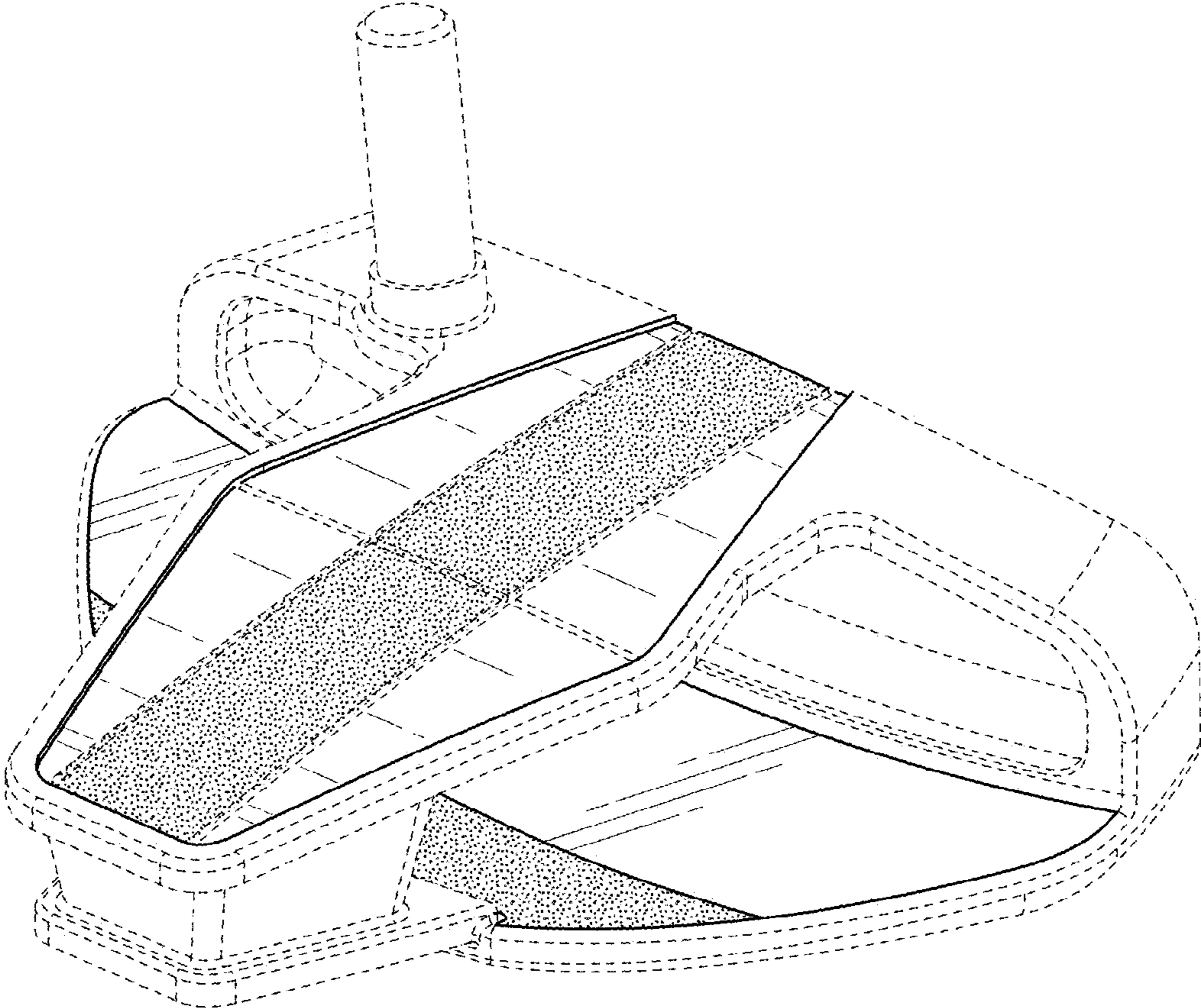

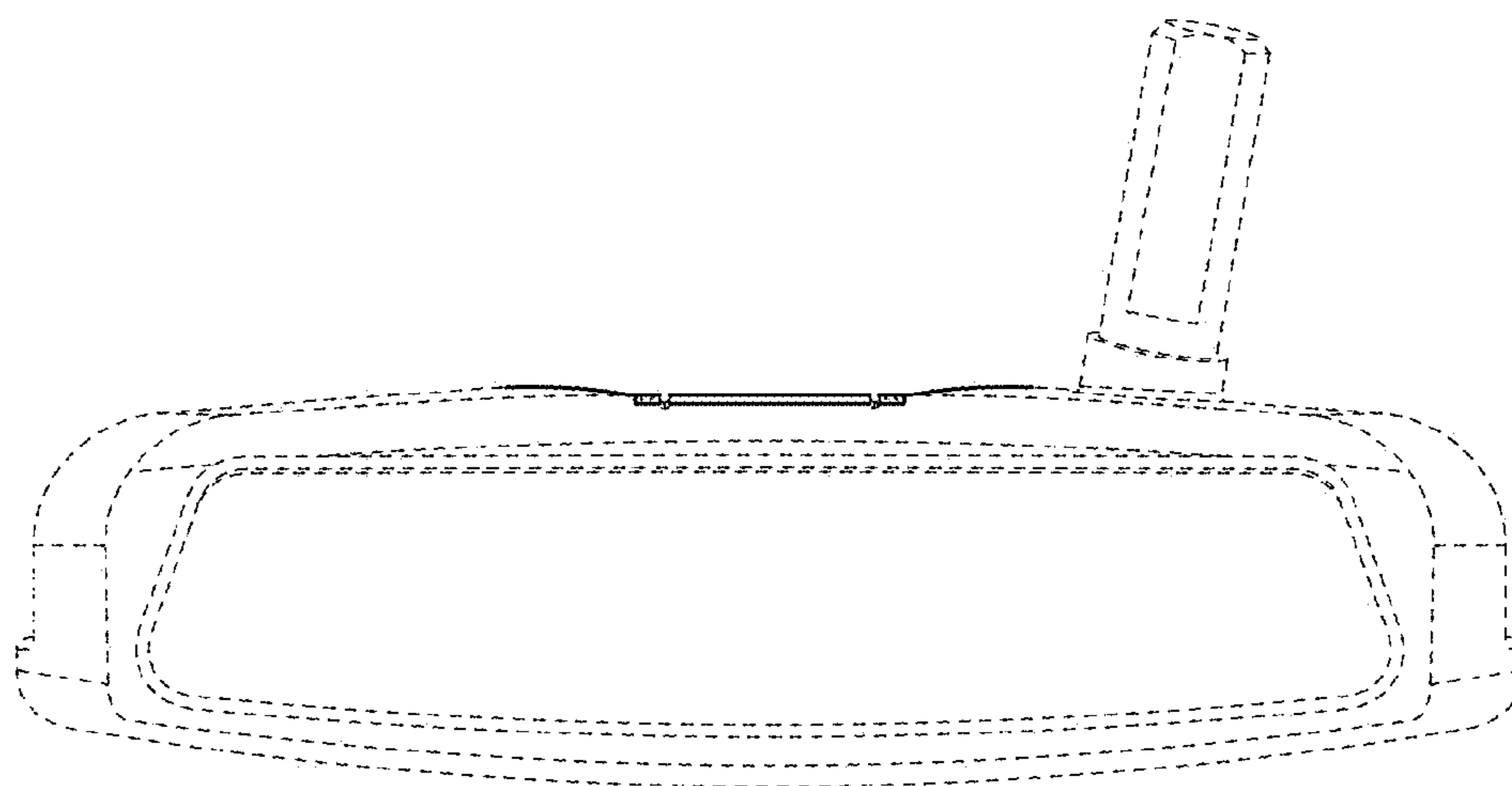

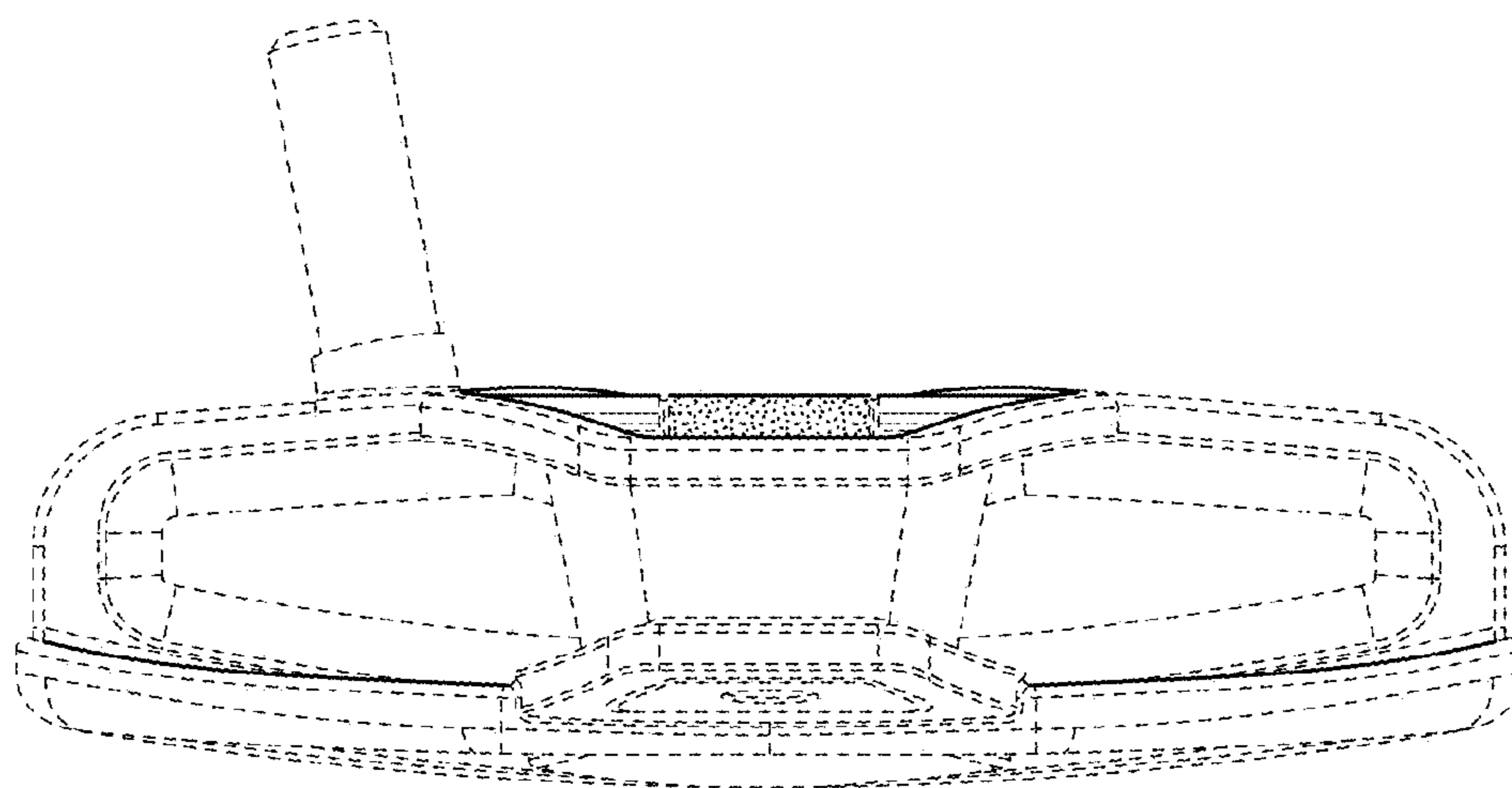

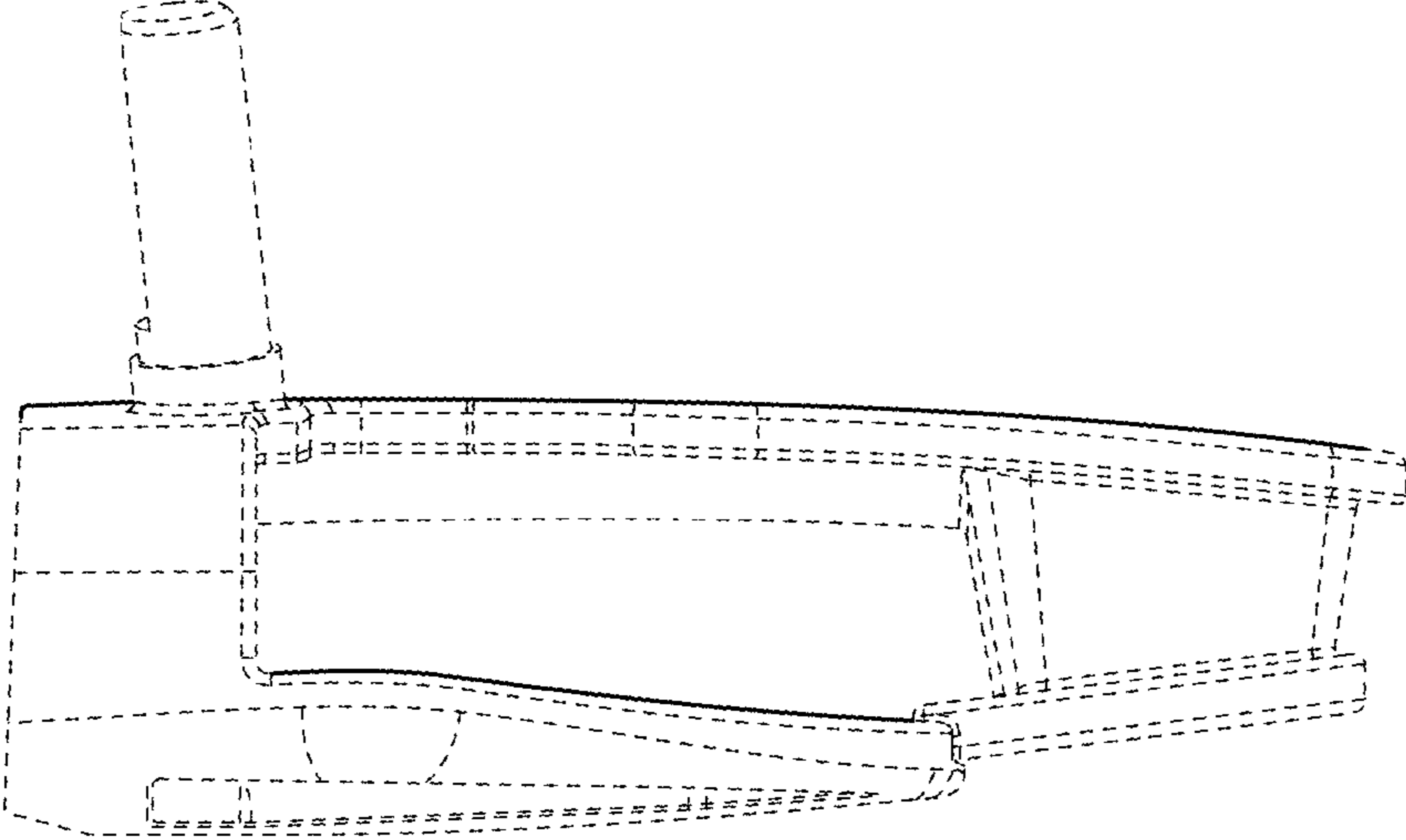

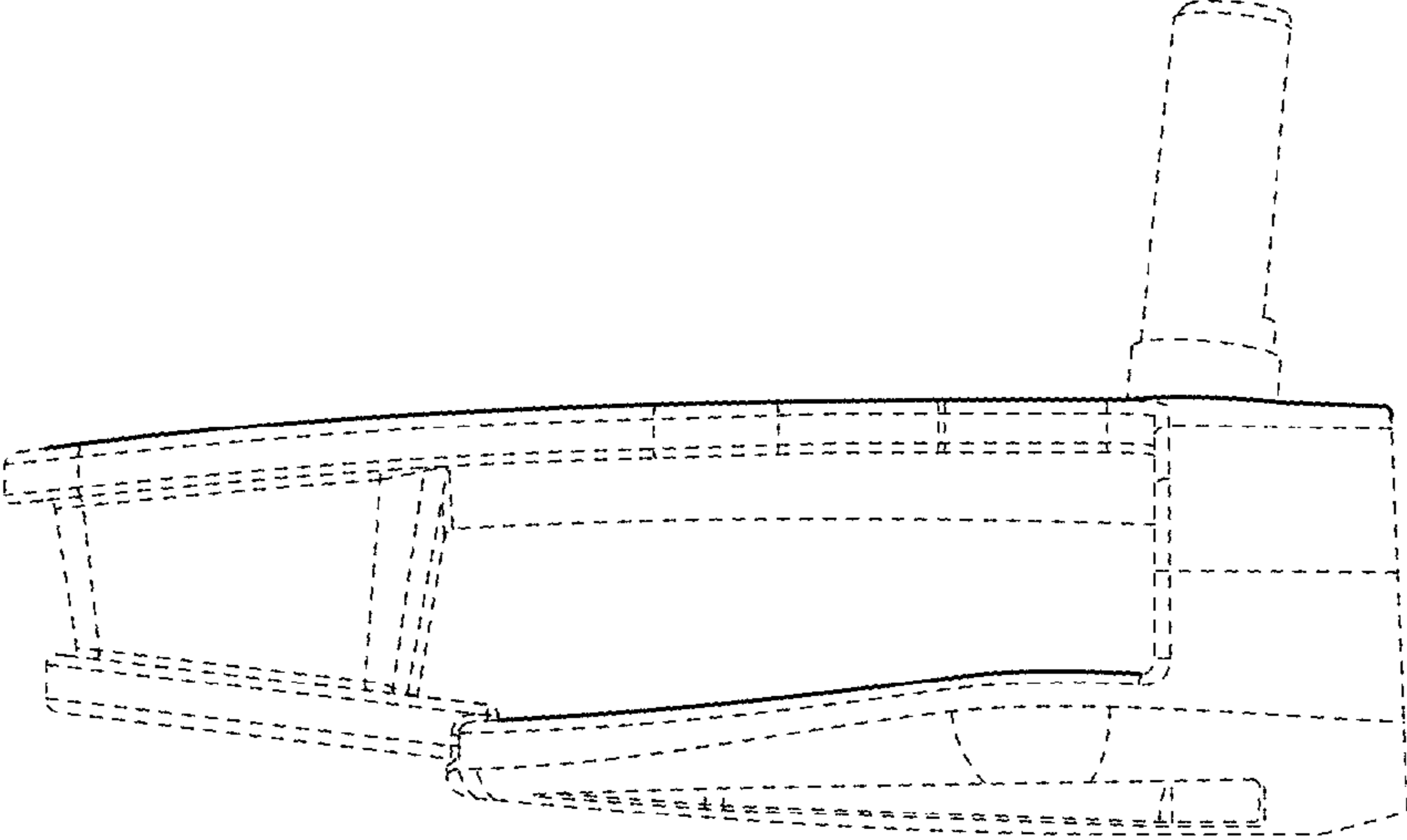

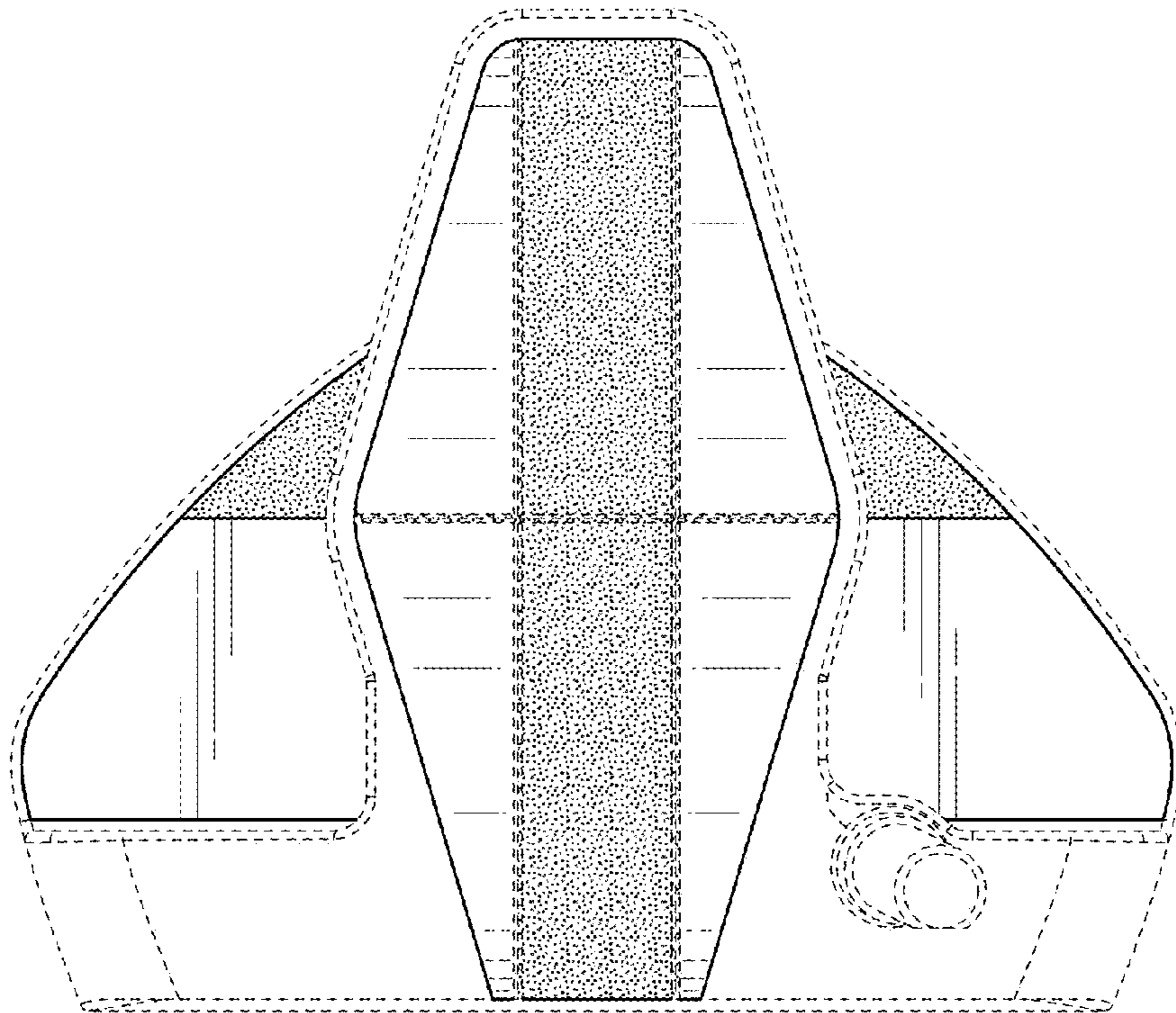

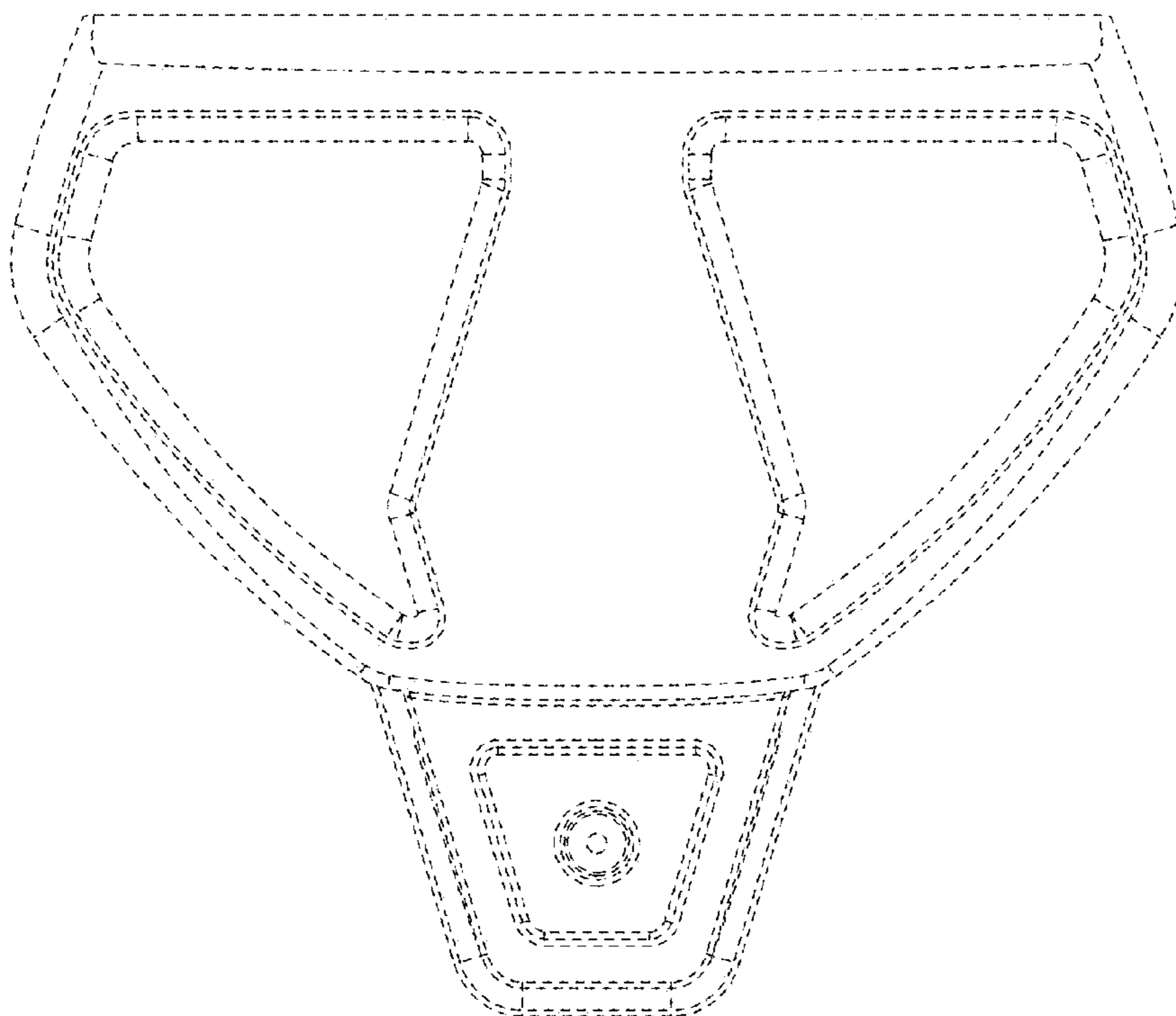
