(57) **CLAIM**

The ornamental design for a fishing lure with curved lip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the fishing lure according to the present invention.

FIG. 2 is a side view of the fishing lure illustrated in FIG. 1.

FIG. 3 is another side view of the fishing lure illustrated in FIG. 1.

FIG. 4 is top view of the fishing lure illustrated in FIG. 1.

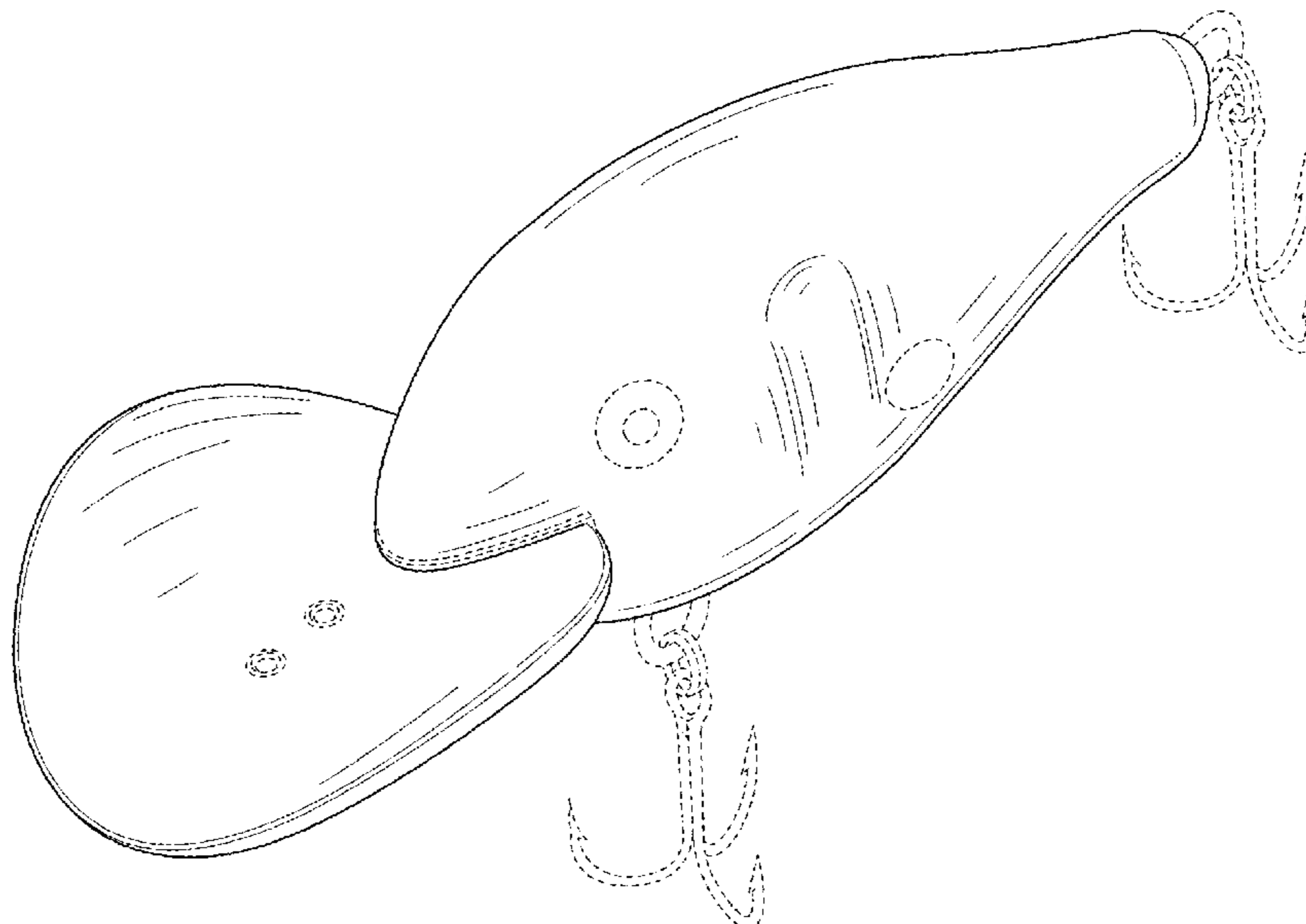
FIG. 5 is bottom view of the fishing lure illustrated in FIG. 1.

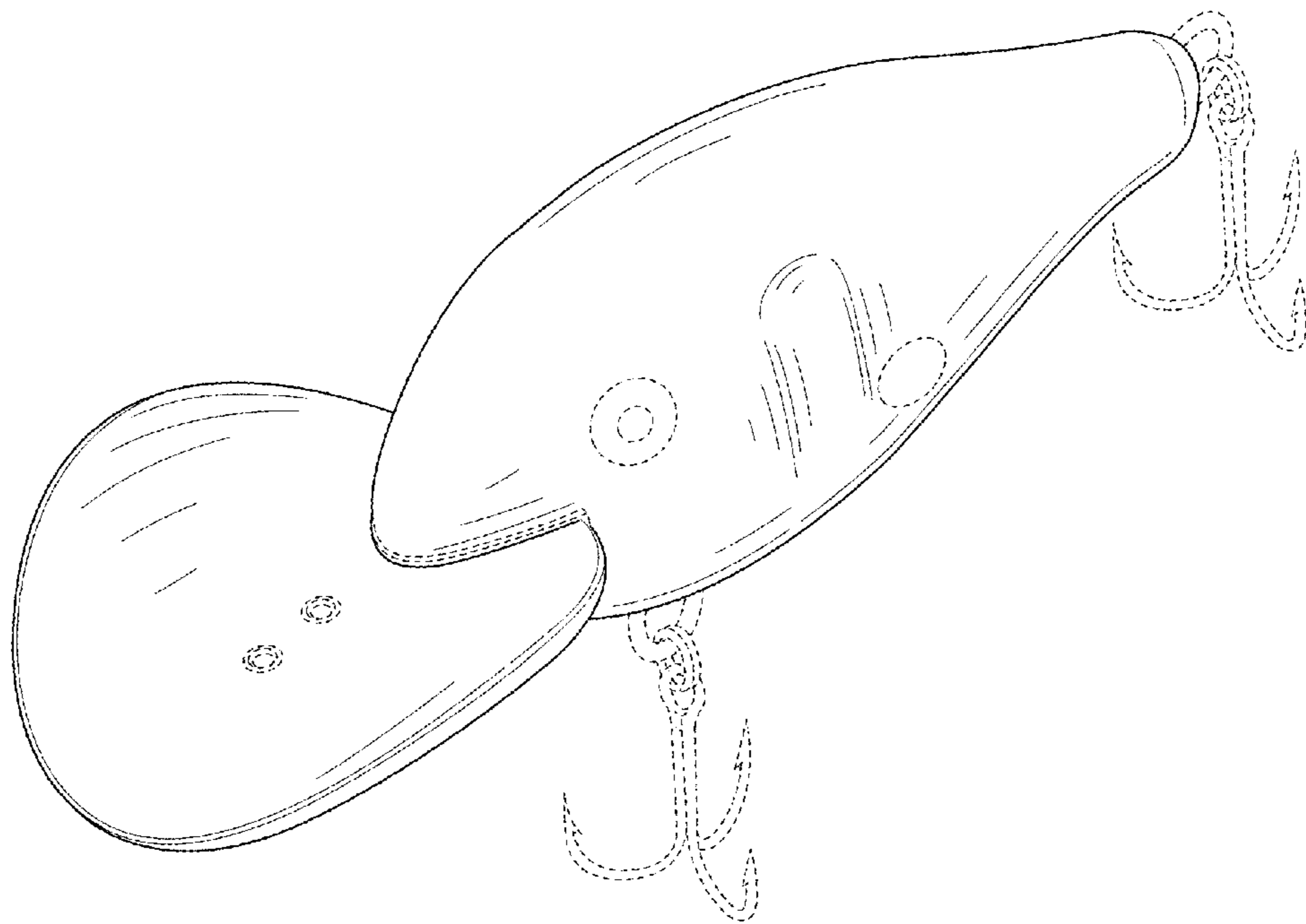

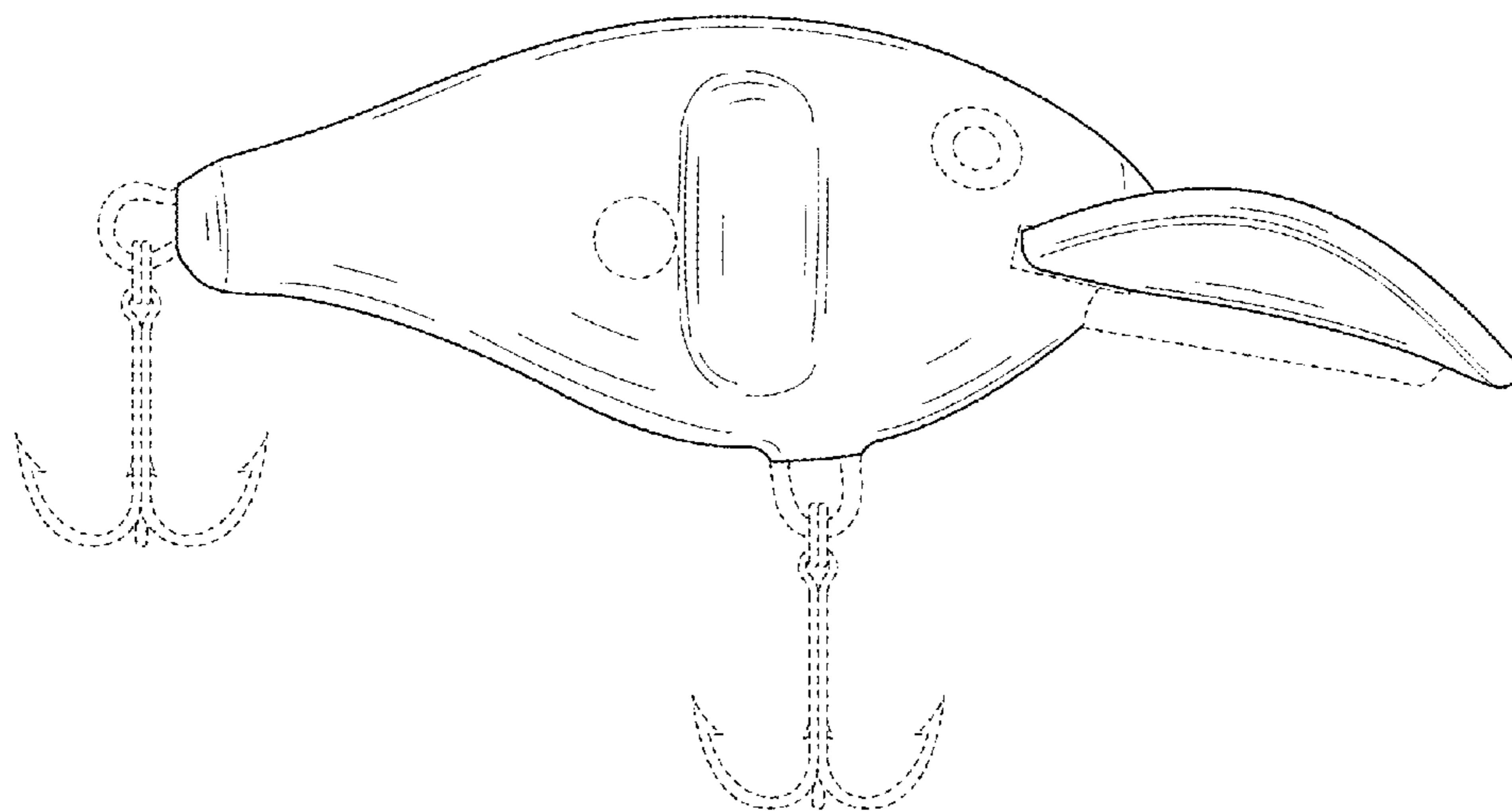

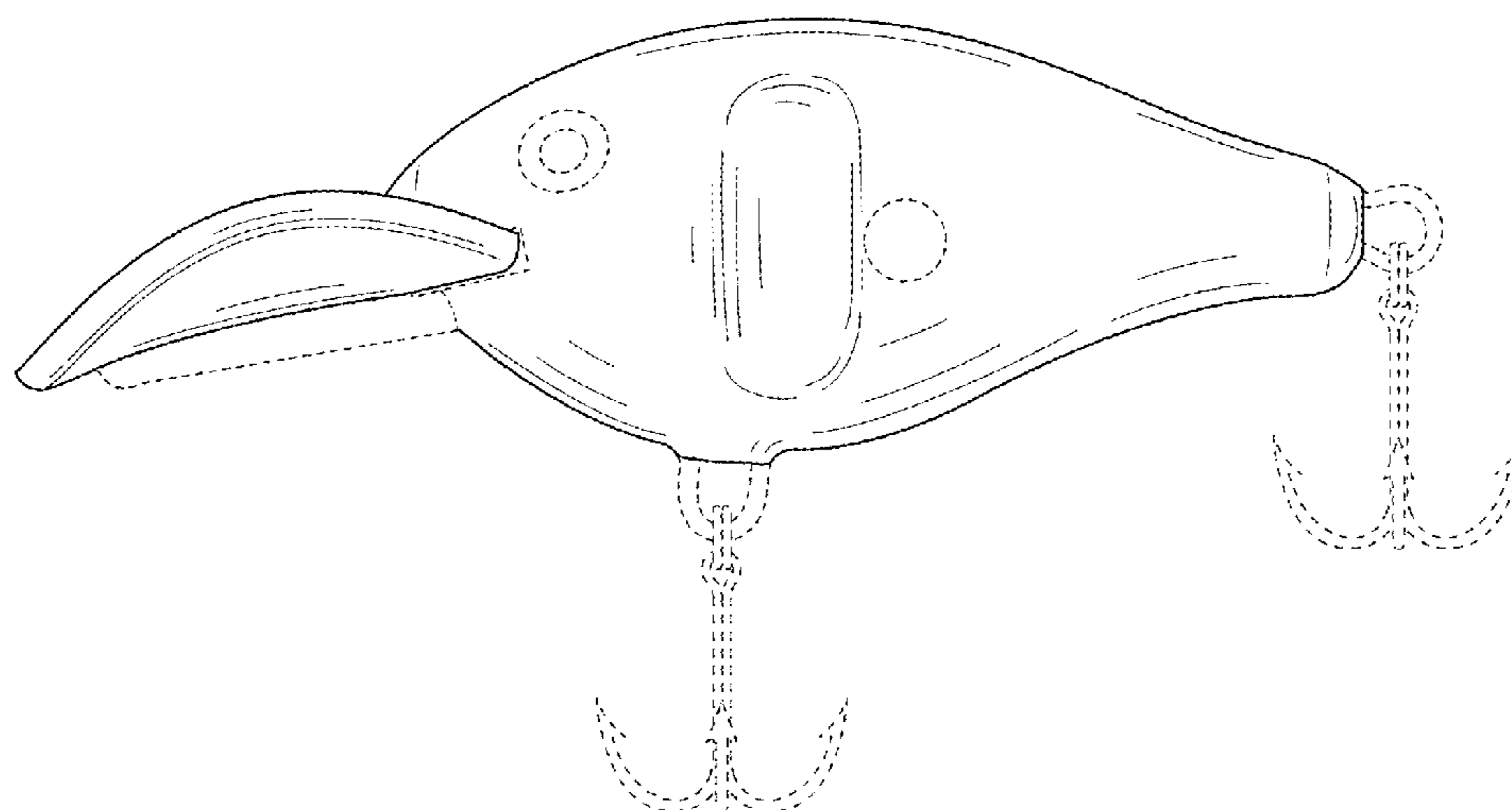

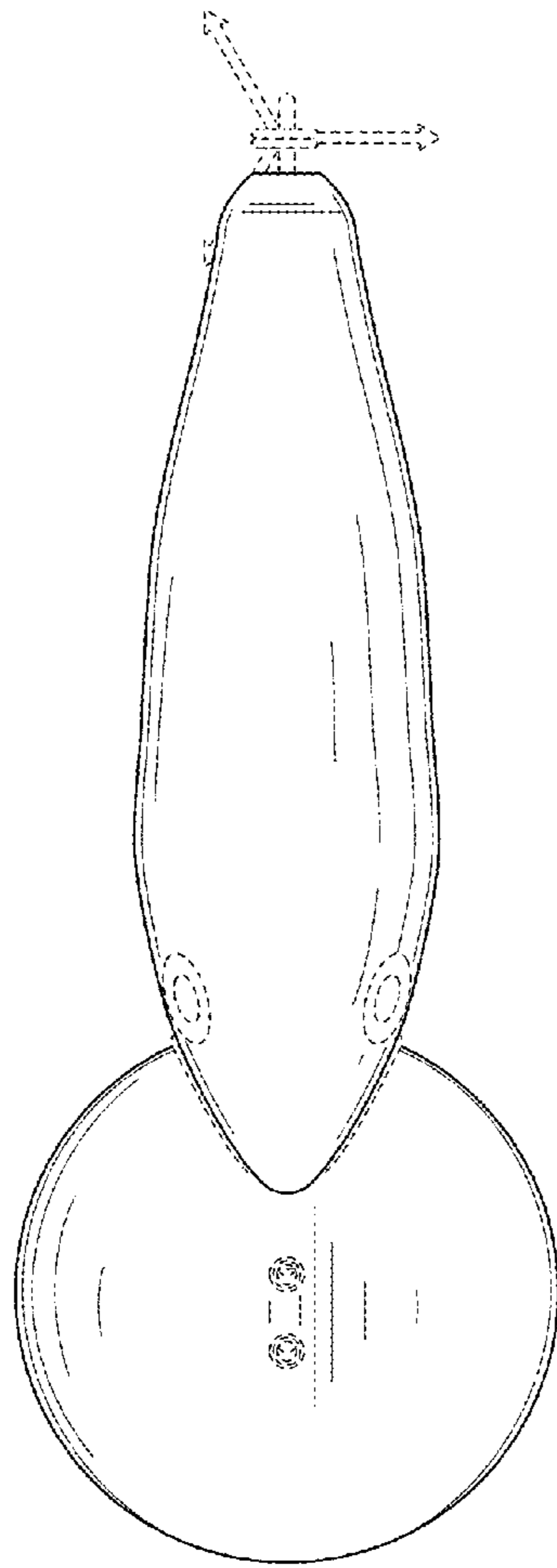

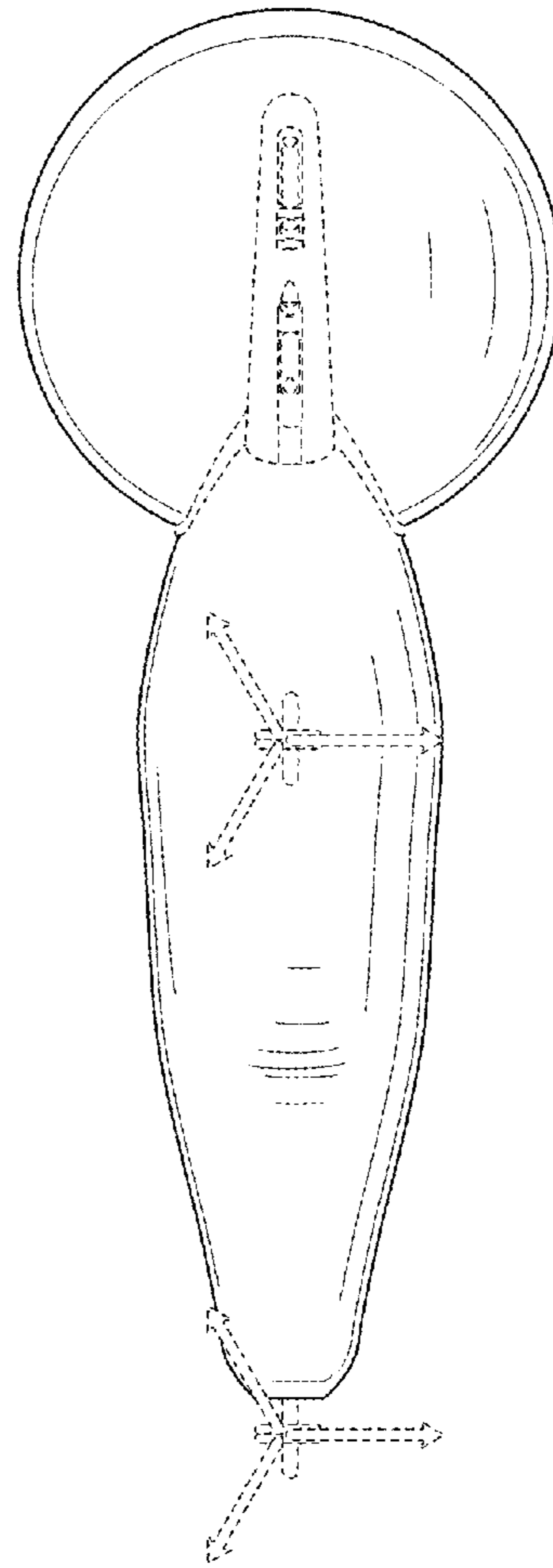

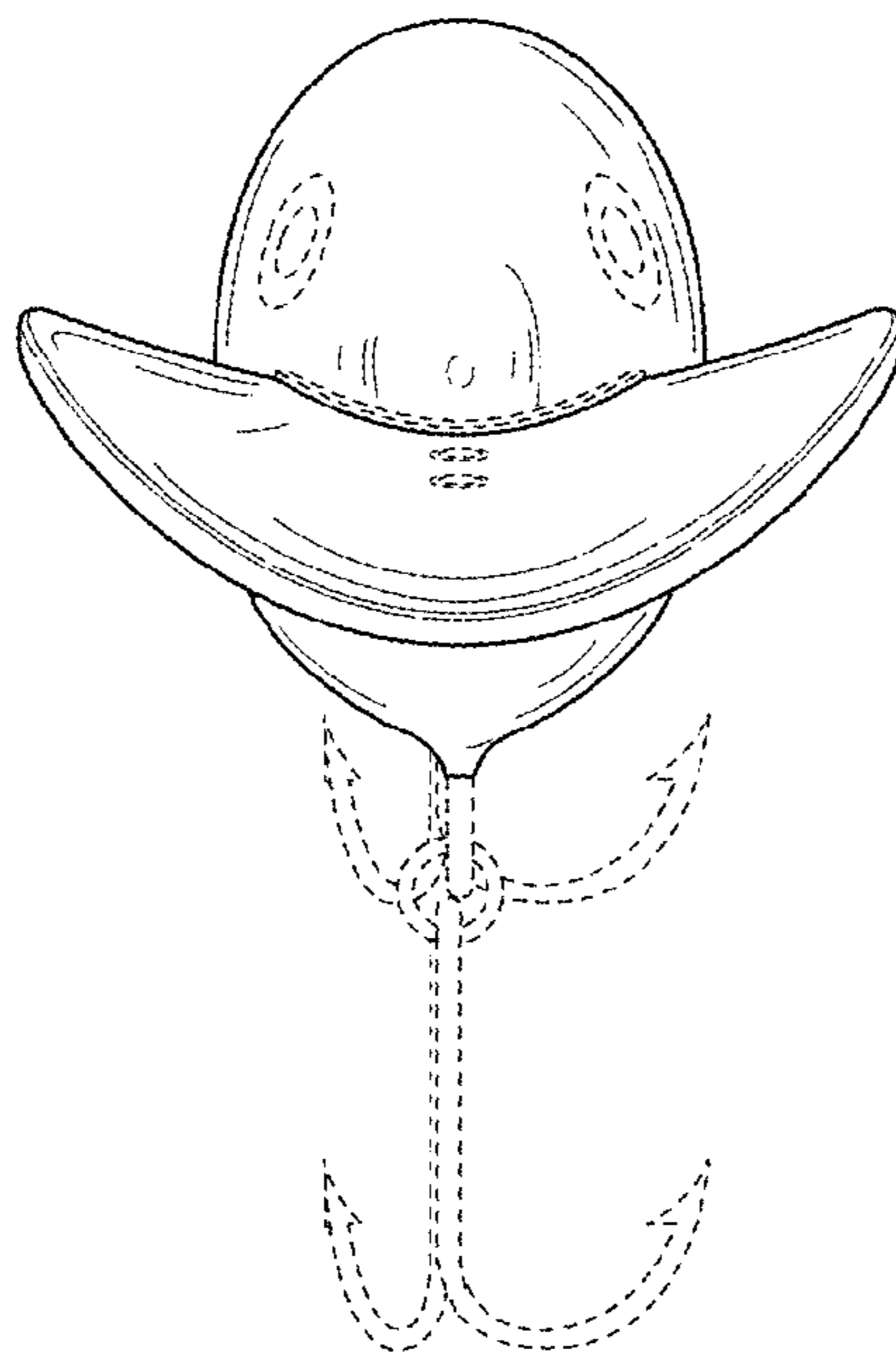

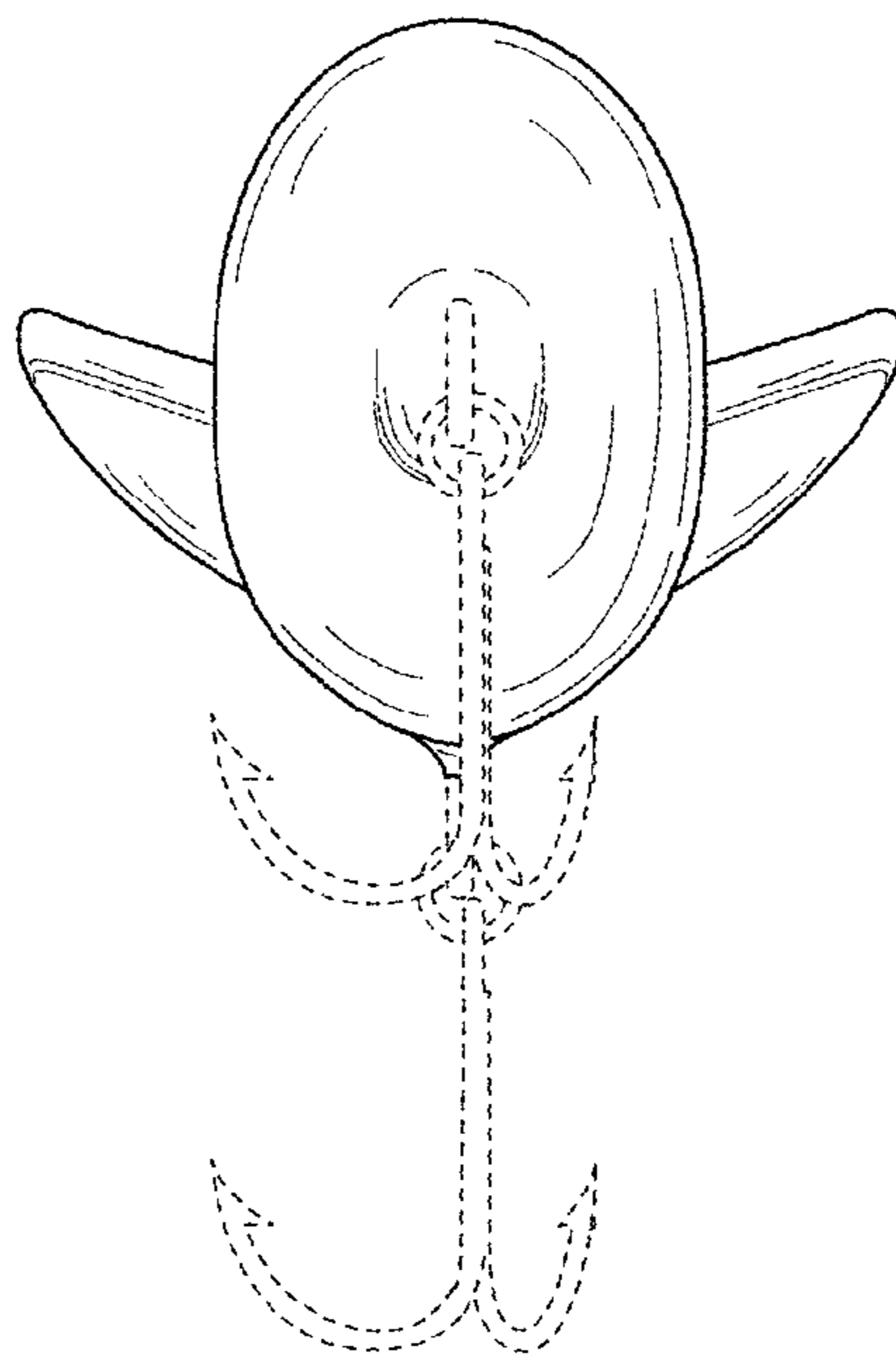
