The ornamental design for a water aerator, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side perspective view showing a representative embodiment of my new design comprising an attachment, wherein the front, left side perspective view is a mirror image thereof;

FIG. 2 is a front elevation view of a representative embodiment thereof;

FIG. 3 is a back elevation view of a representative embodiment thereof;

FIG. 4 is a left side elevation view of a representative embodiment thereof;

FIG. 5 is a right side elevation view of a representative embodiment thereof;

FIG. 10 is a back elevation view of a representative embodiment thereof;

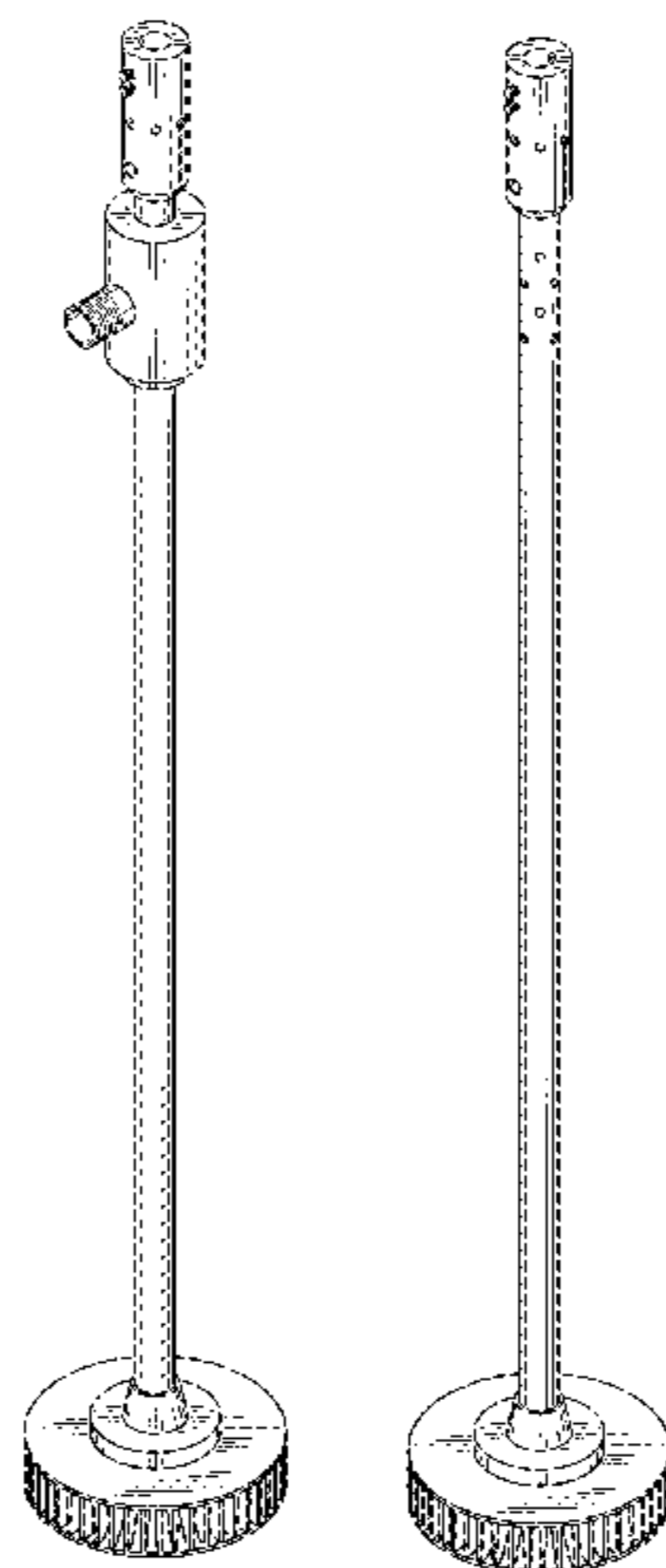
FIG. 11 is a left side elevation view of a representative embodiment thereof;

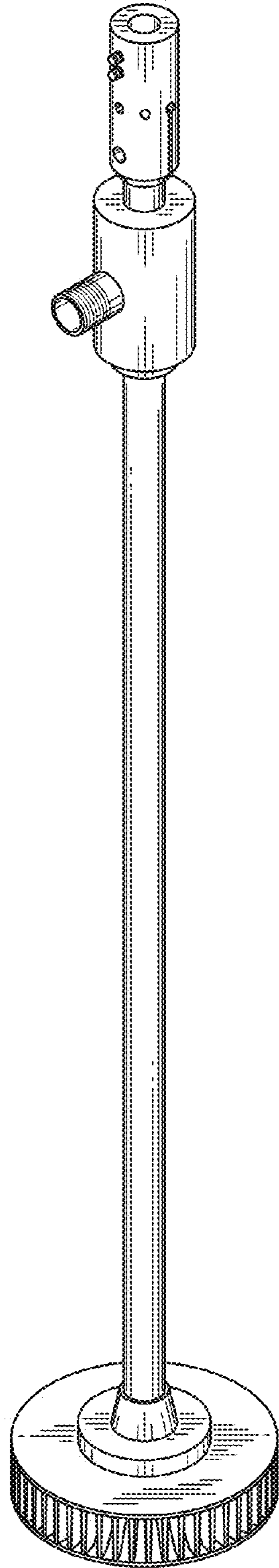

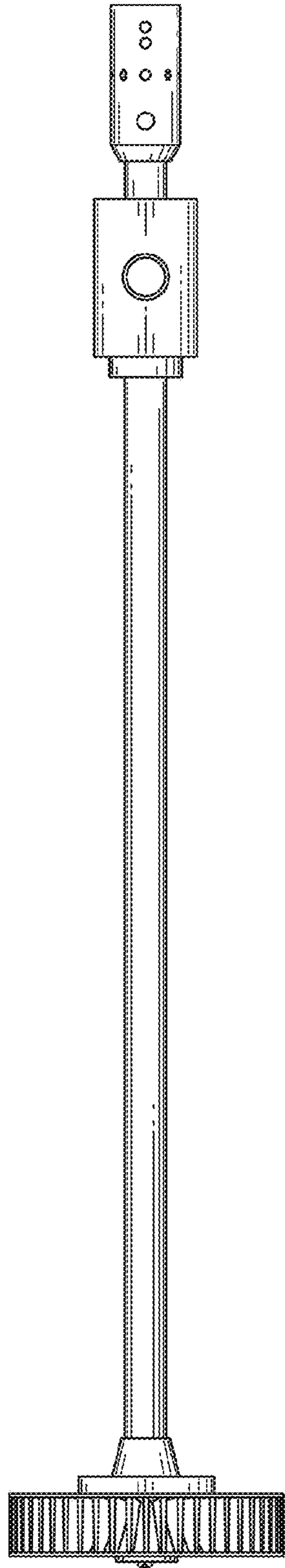

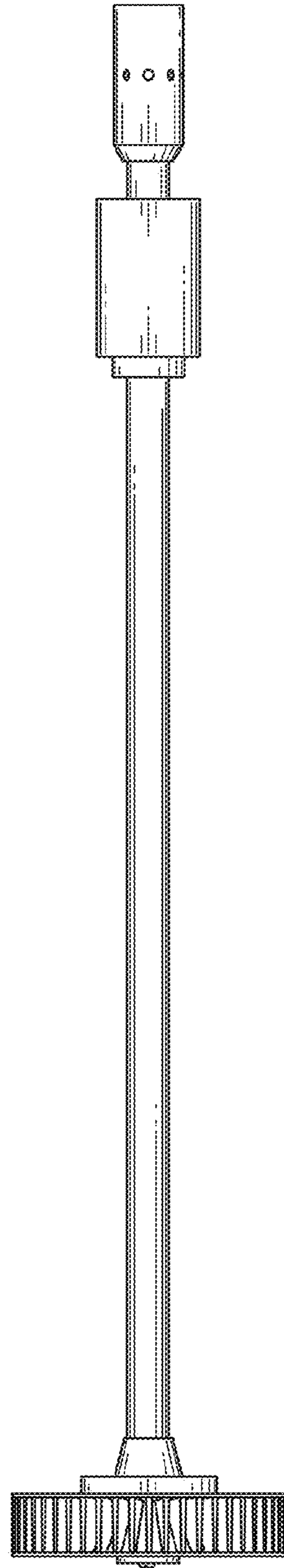

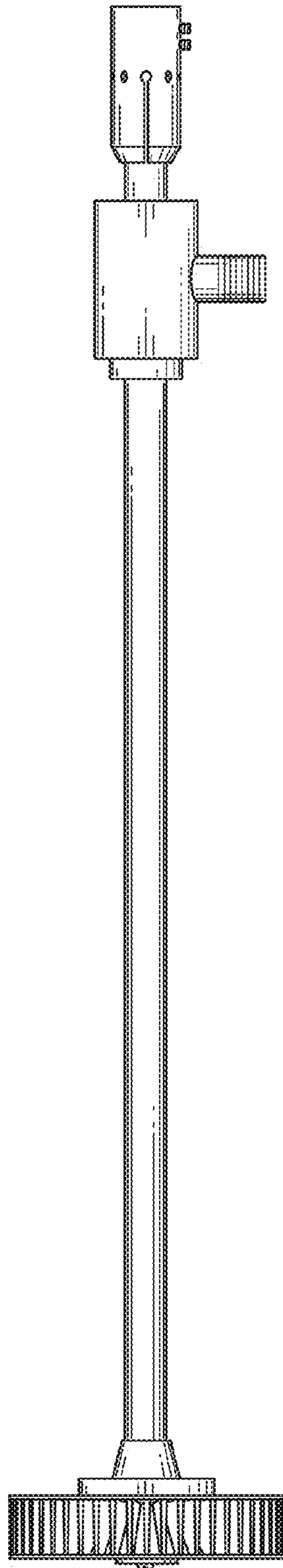

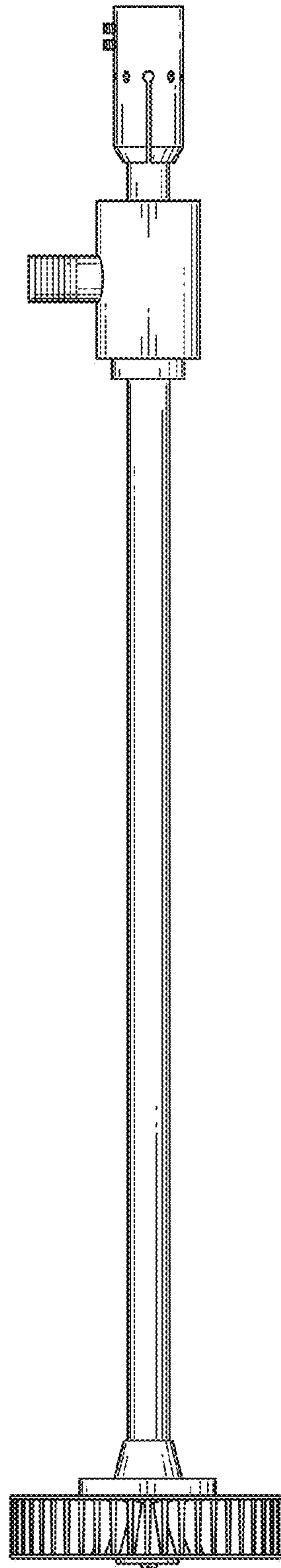

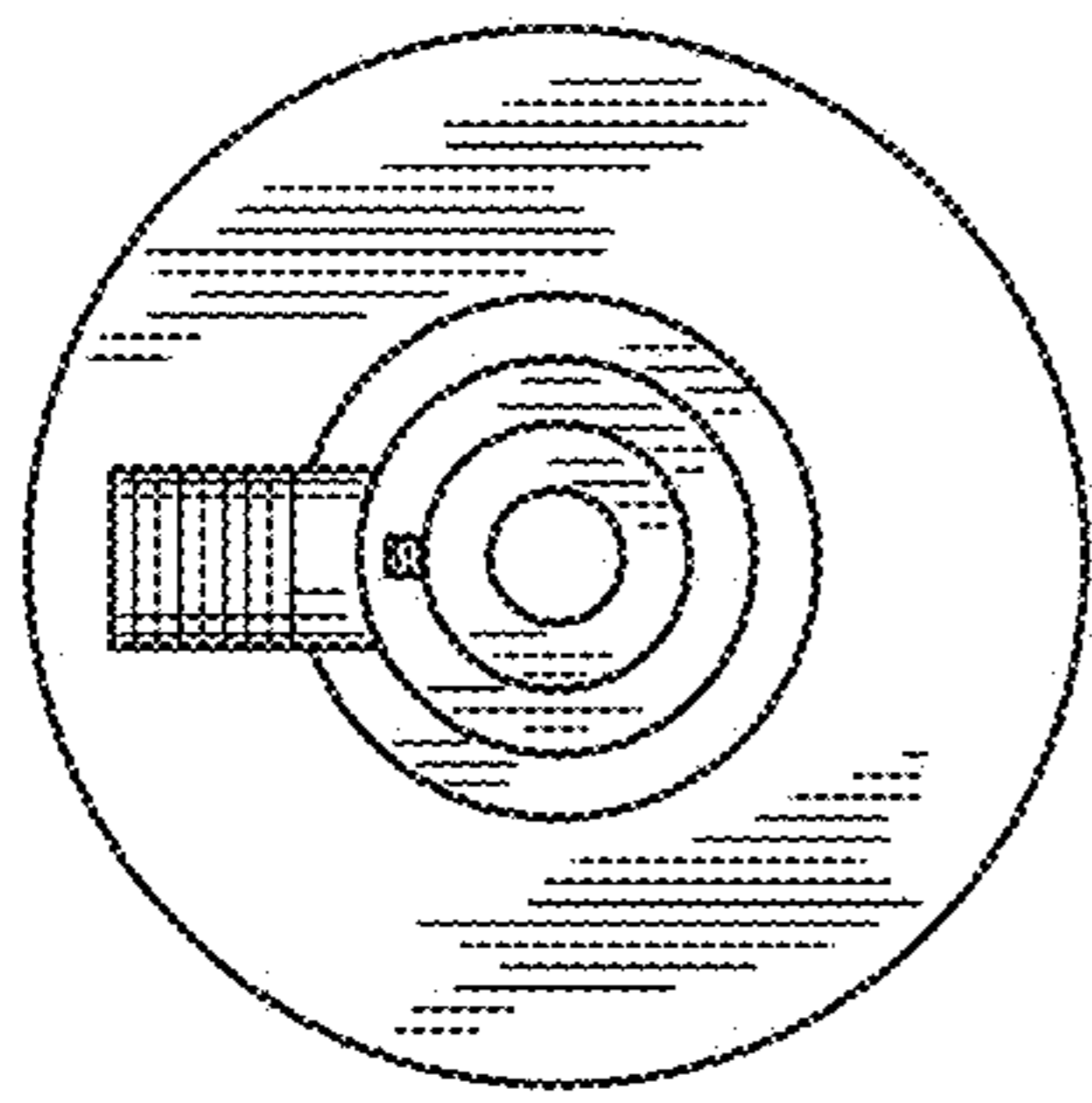

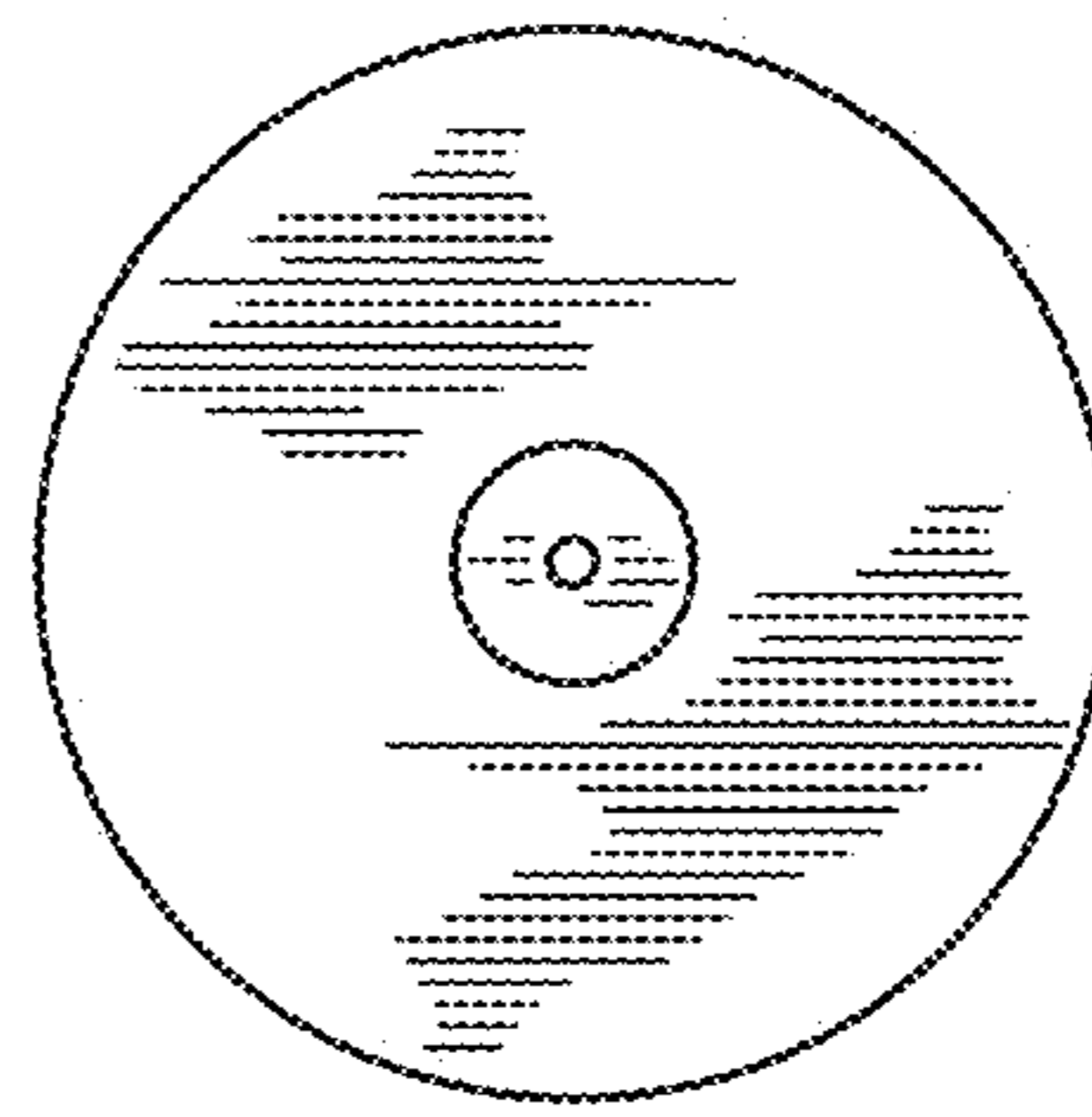

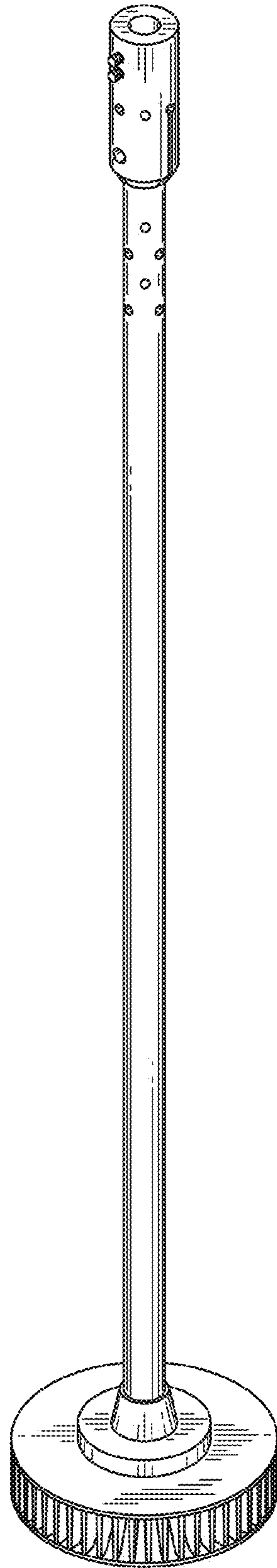

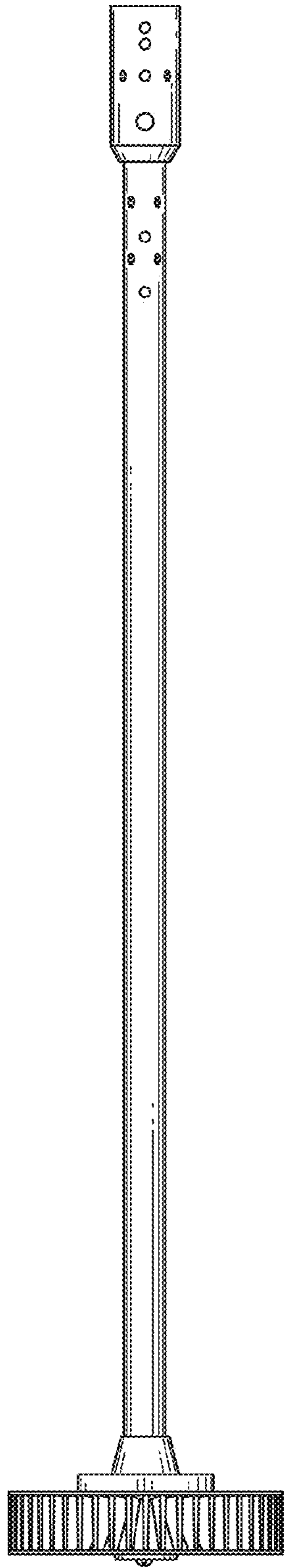

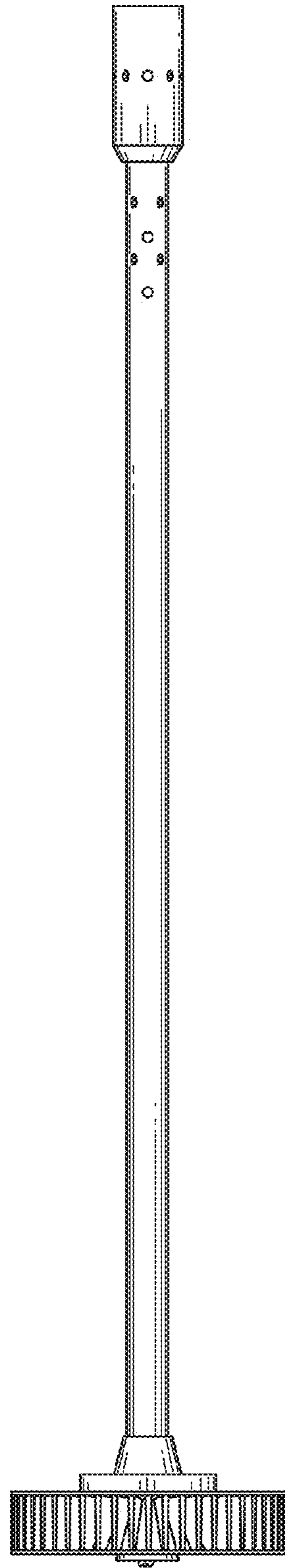

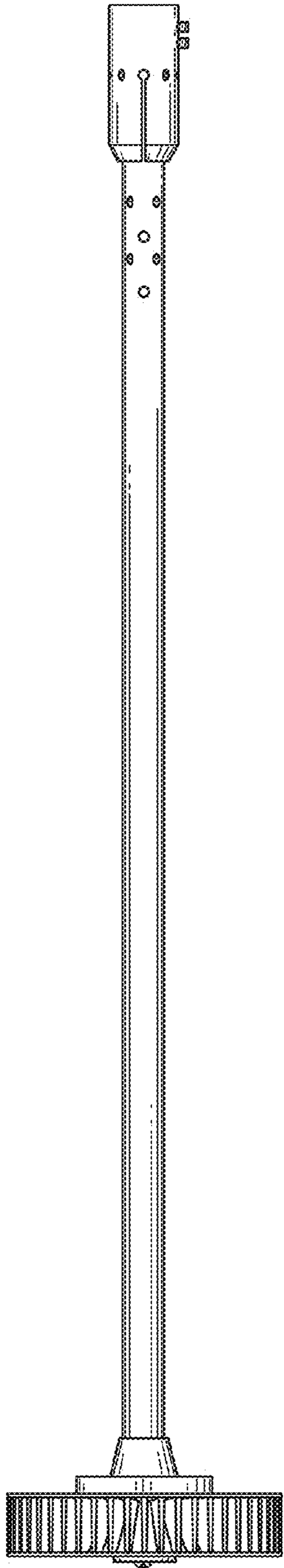

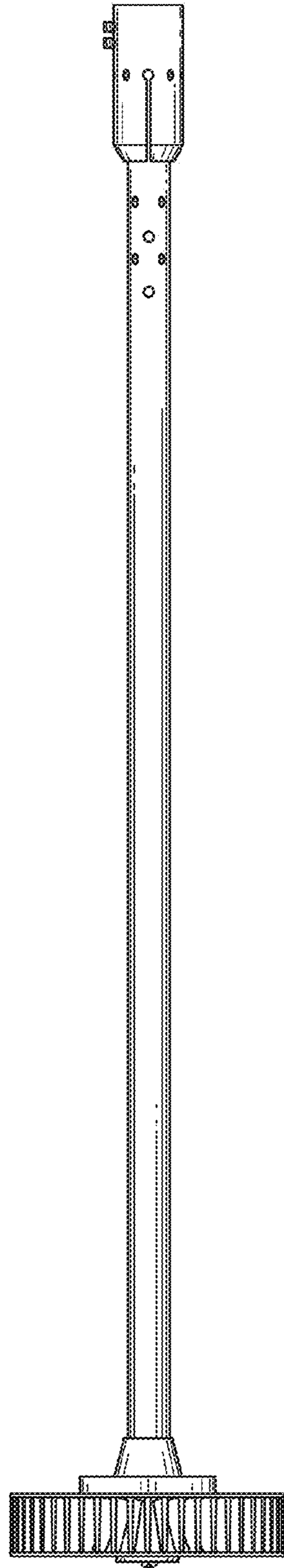

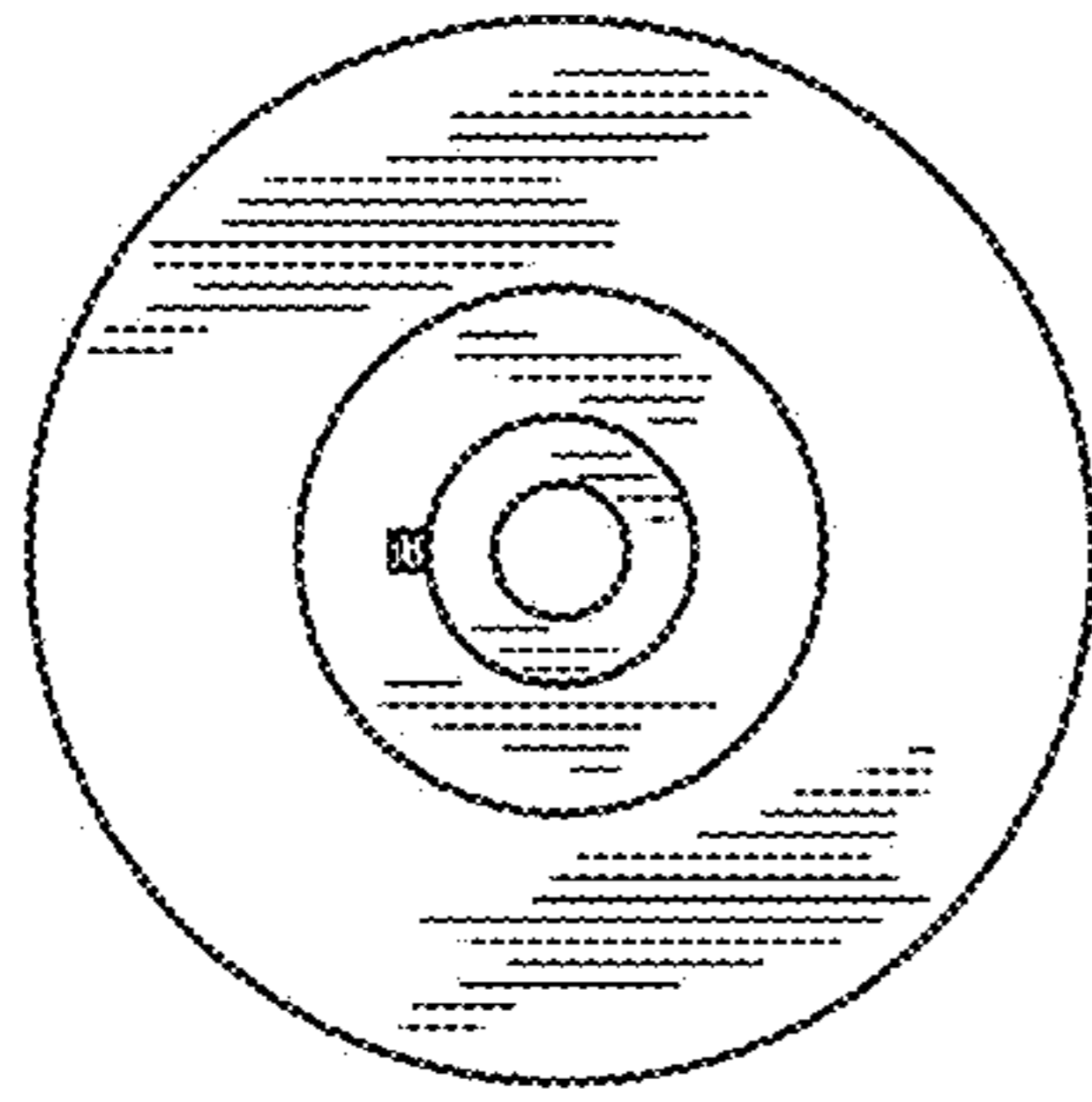

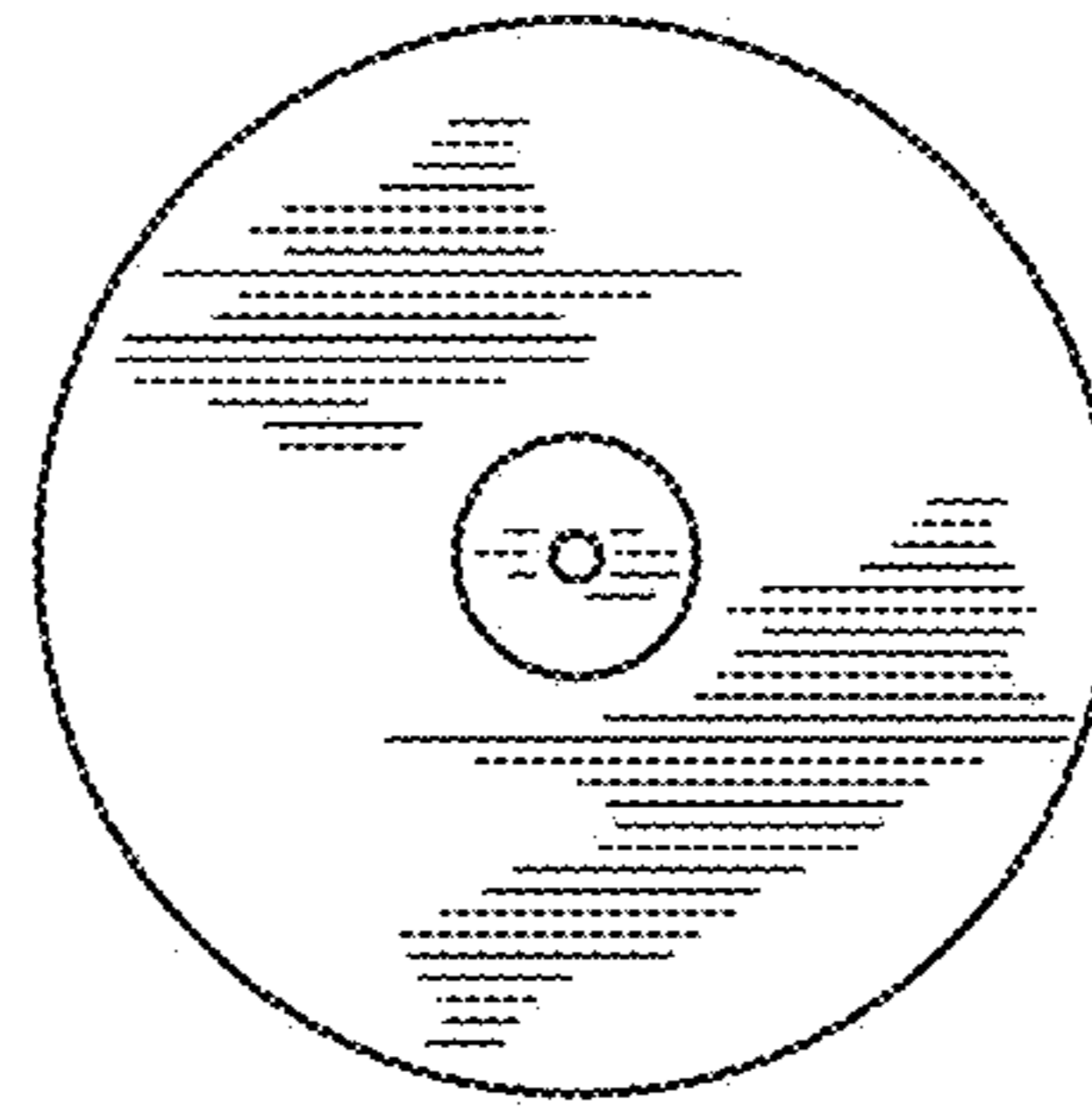
