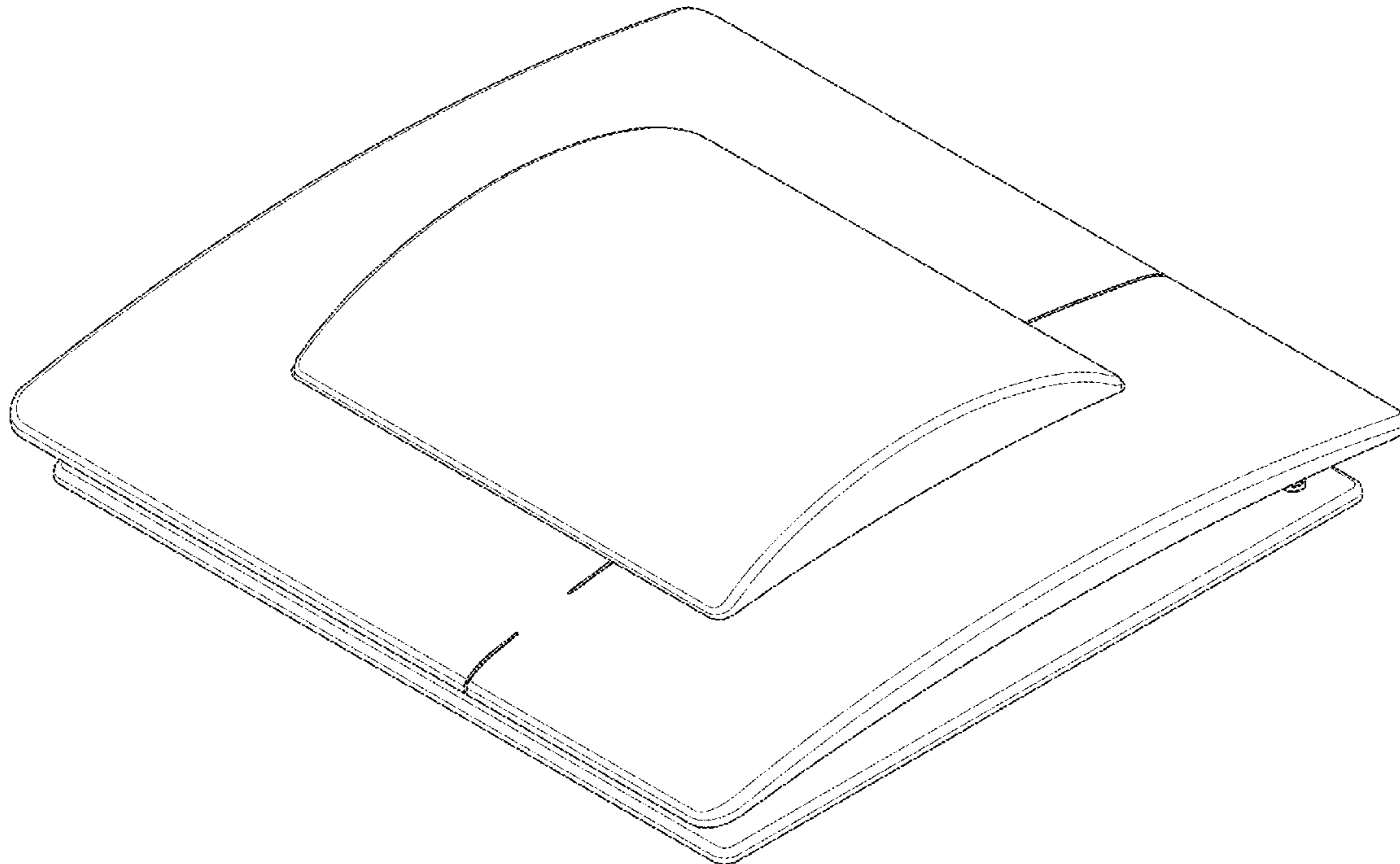
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a vent grille according to this invention;
FIG. 2 is a top view of the vent grille shown in FIG. 1;

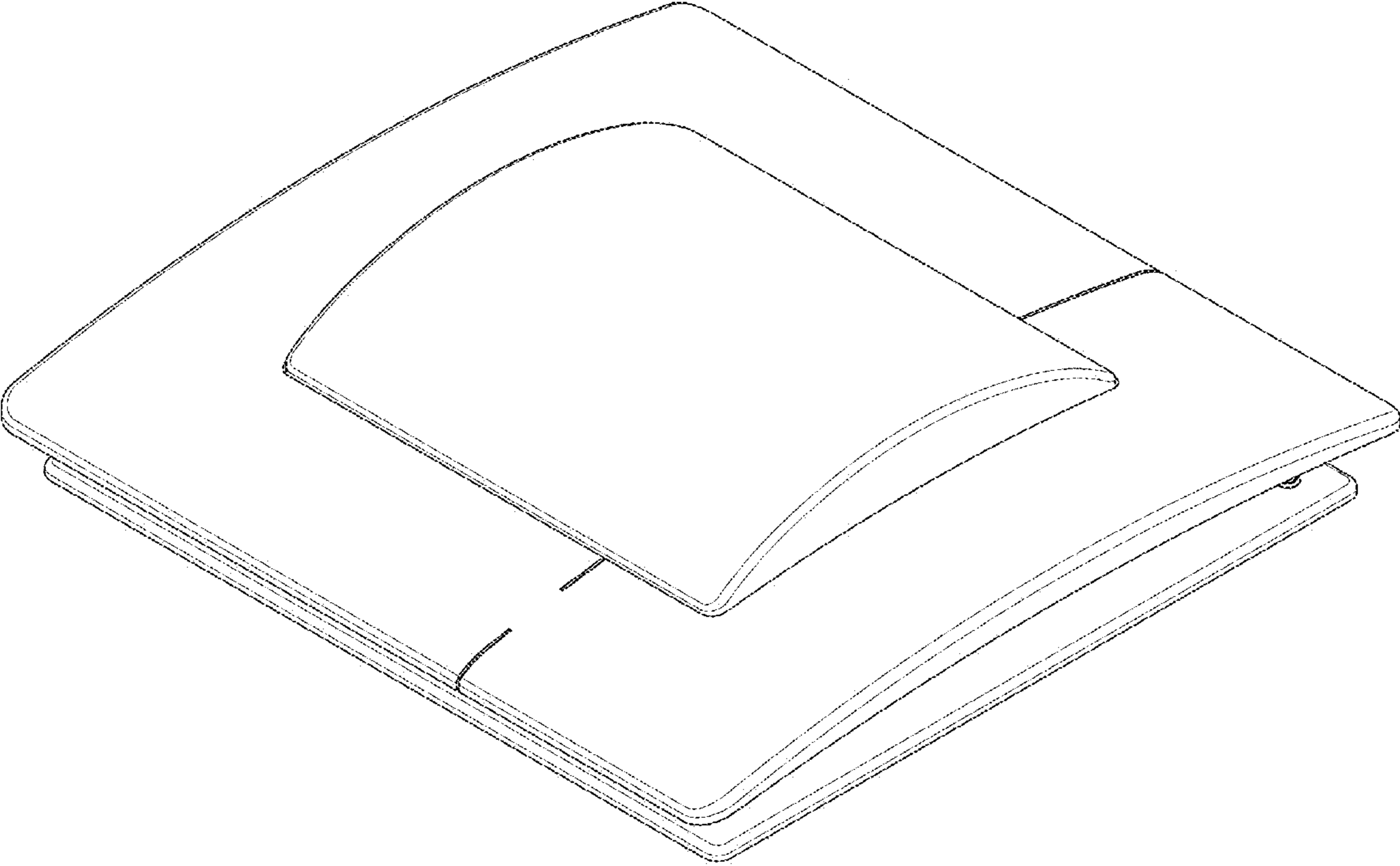

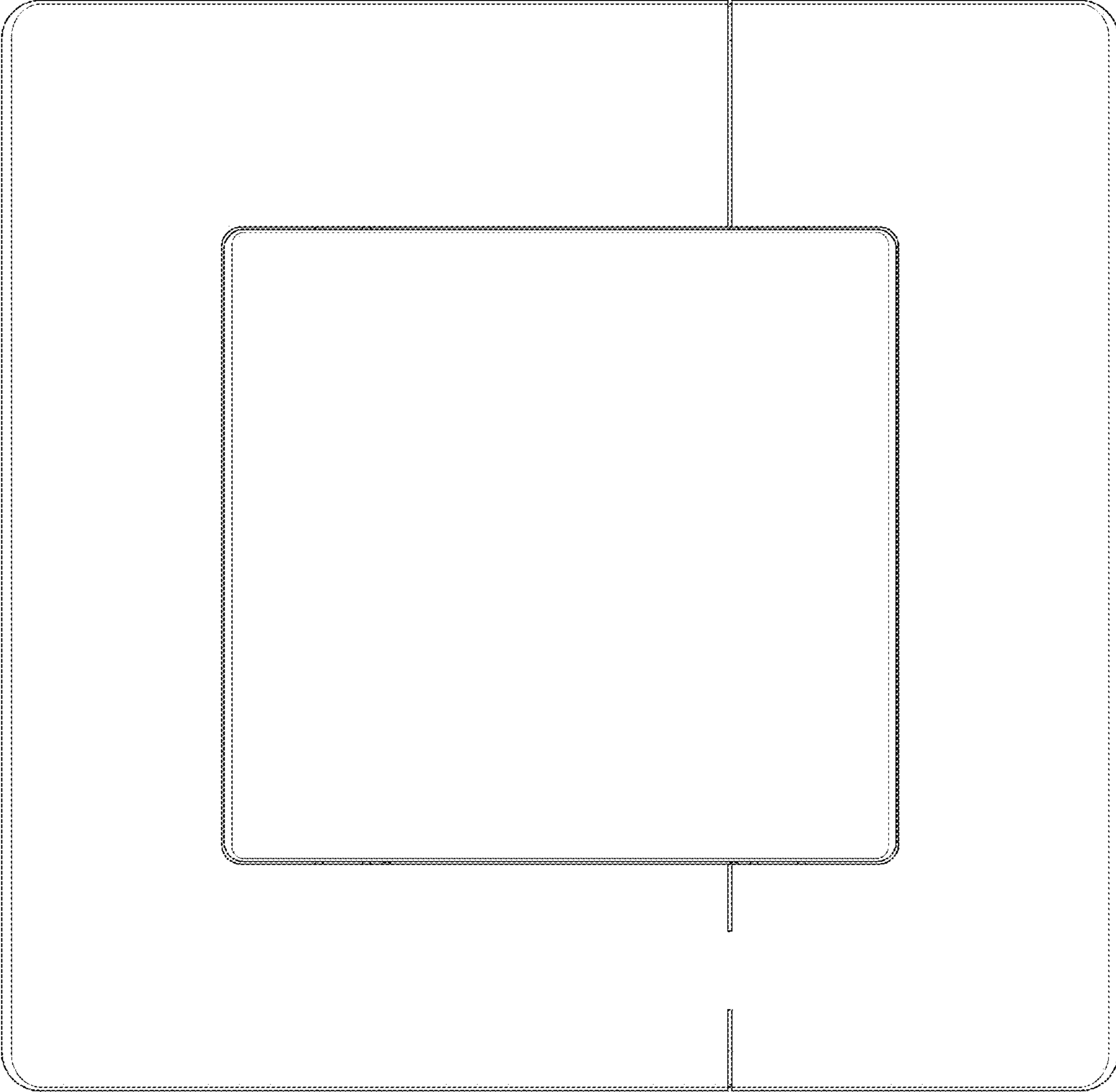

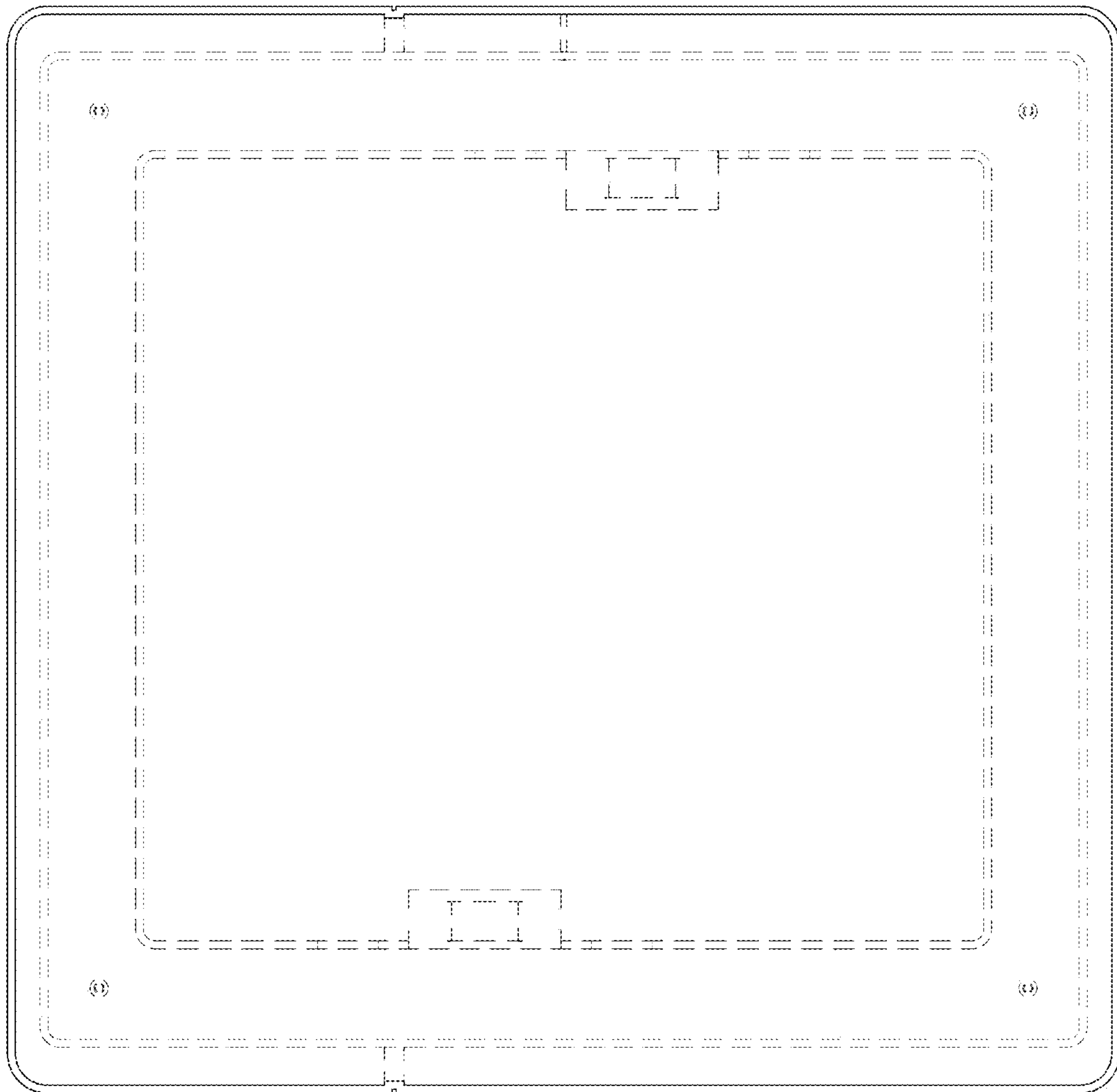

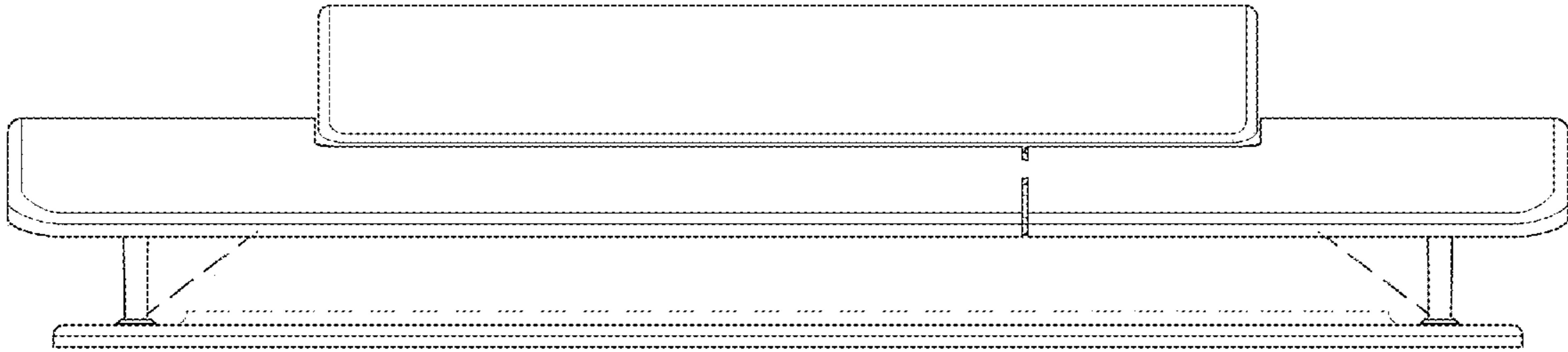

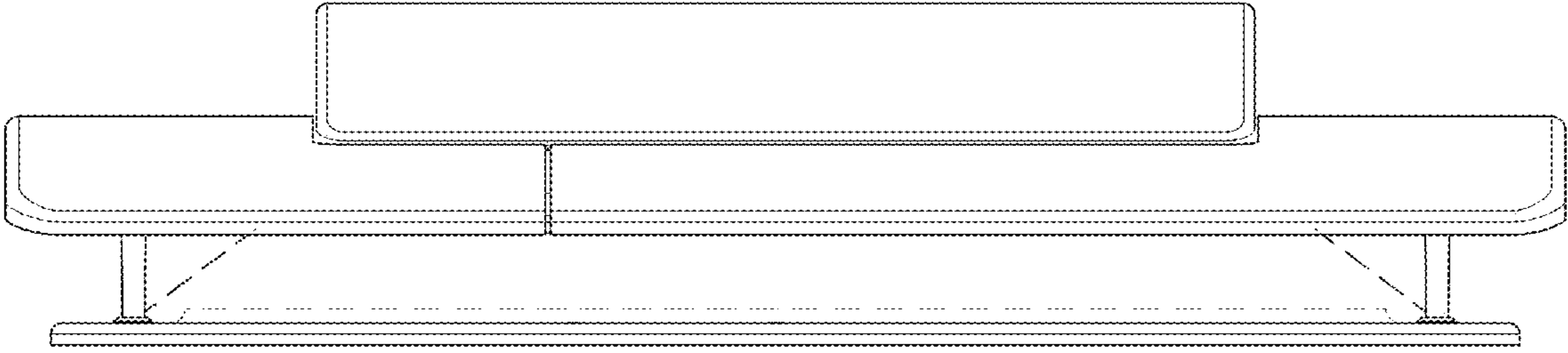

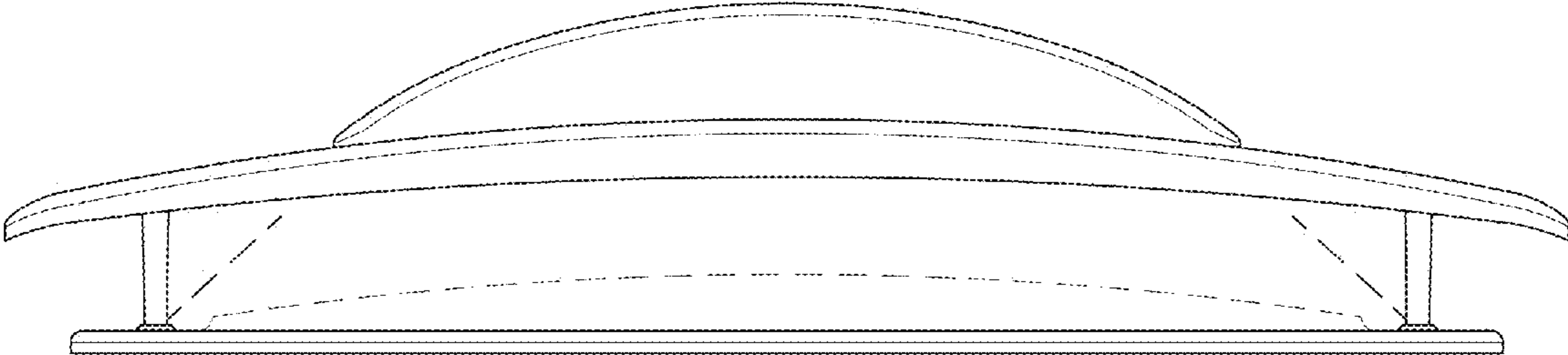

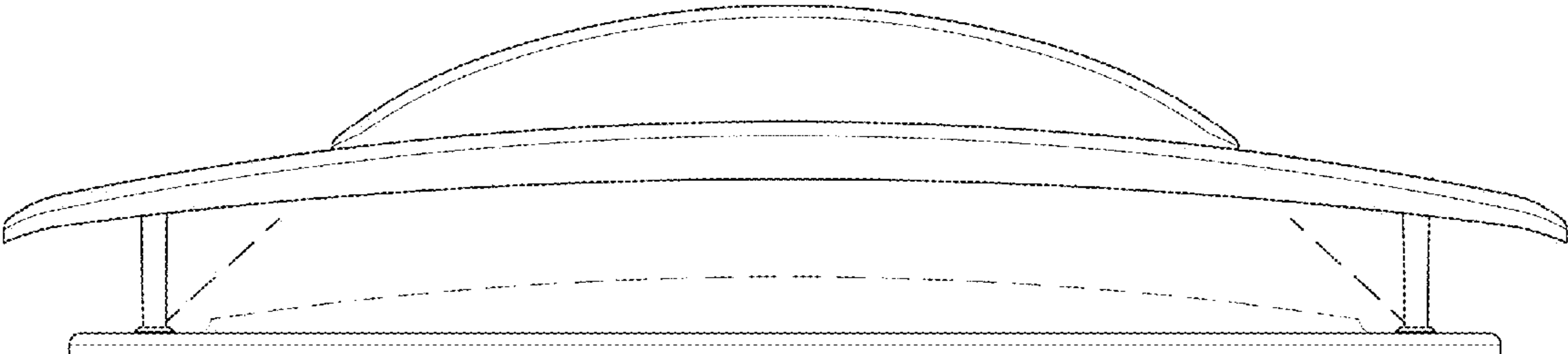
