DESCRIPTION

FIG. 5 is a bottom plan view thereof.

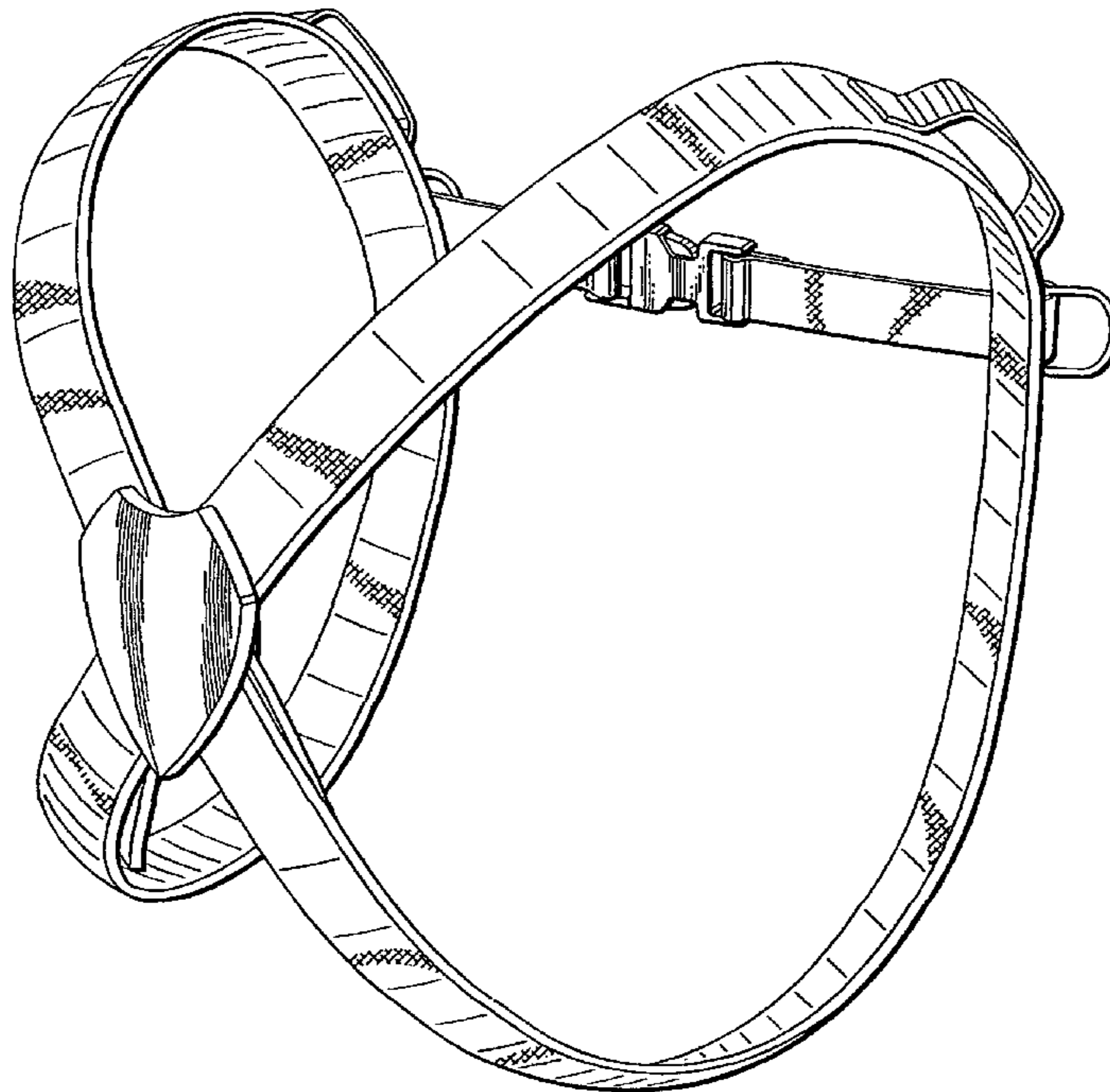
FIG. 6 is a side elevational view thereof.

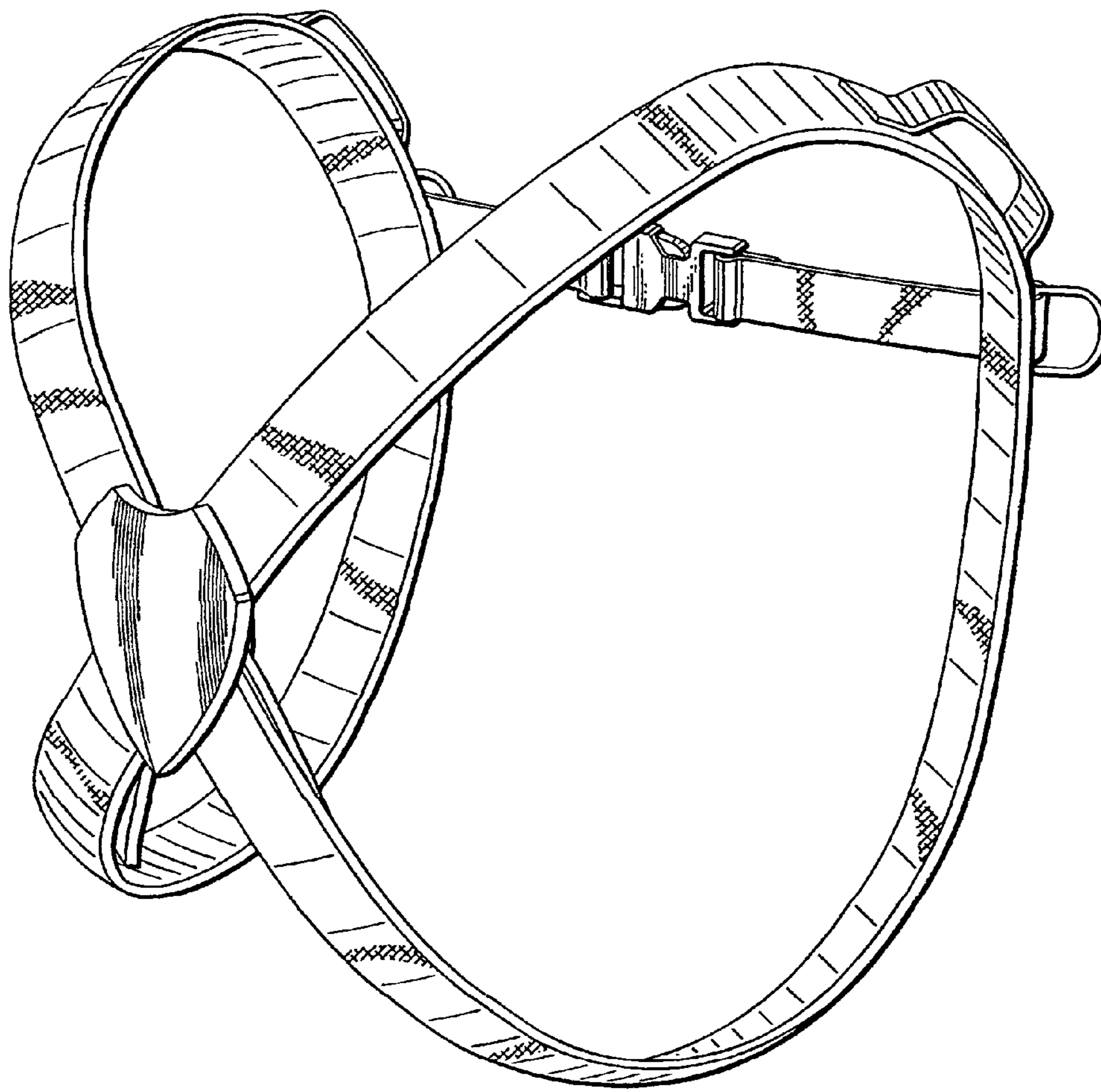

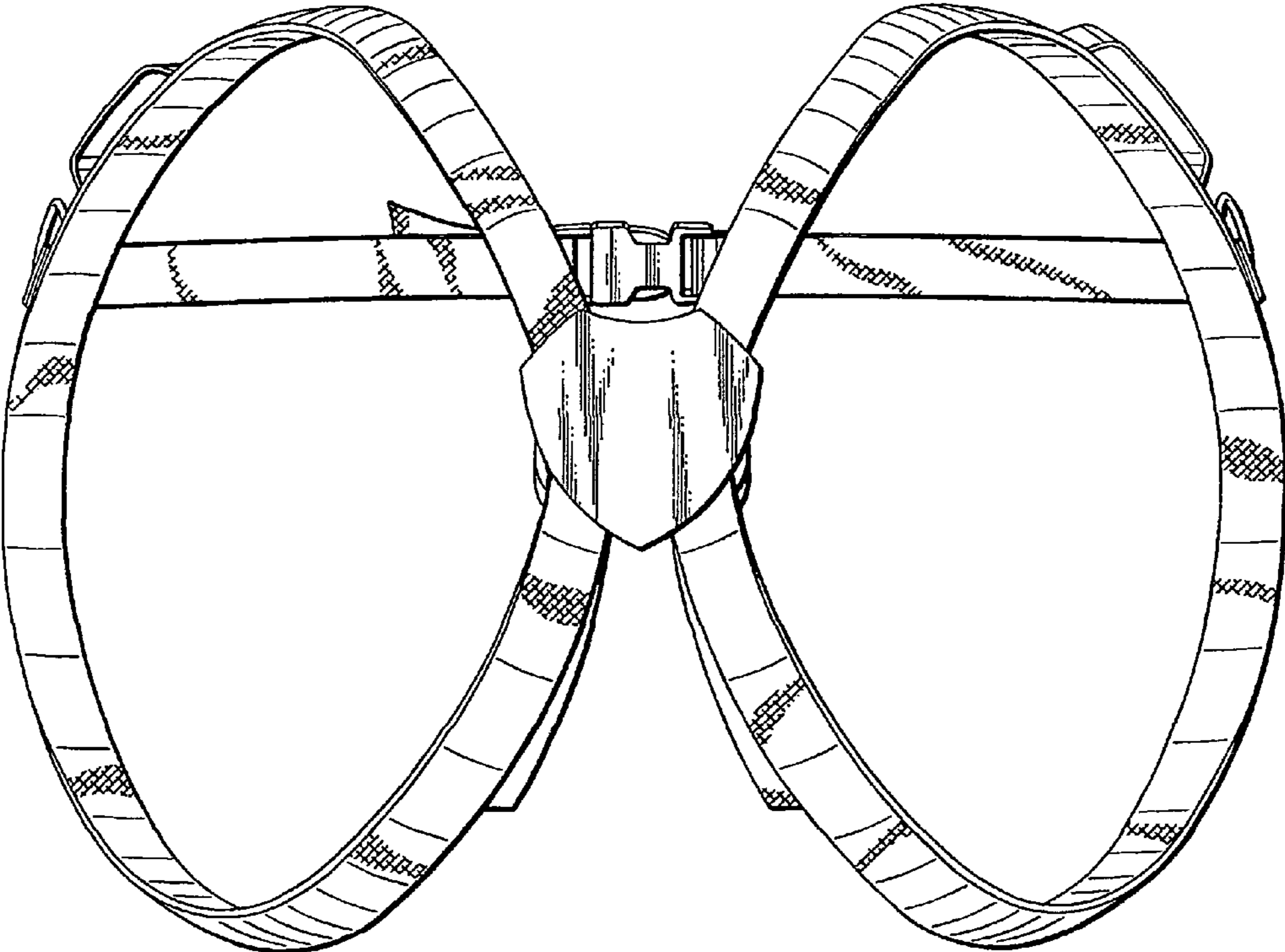

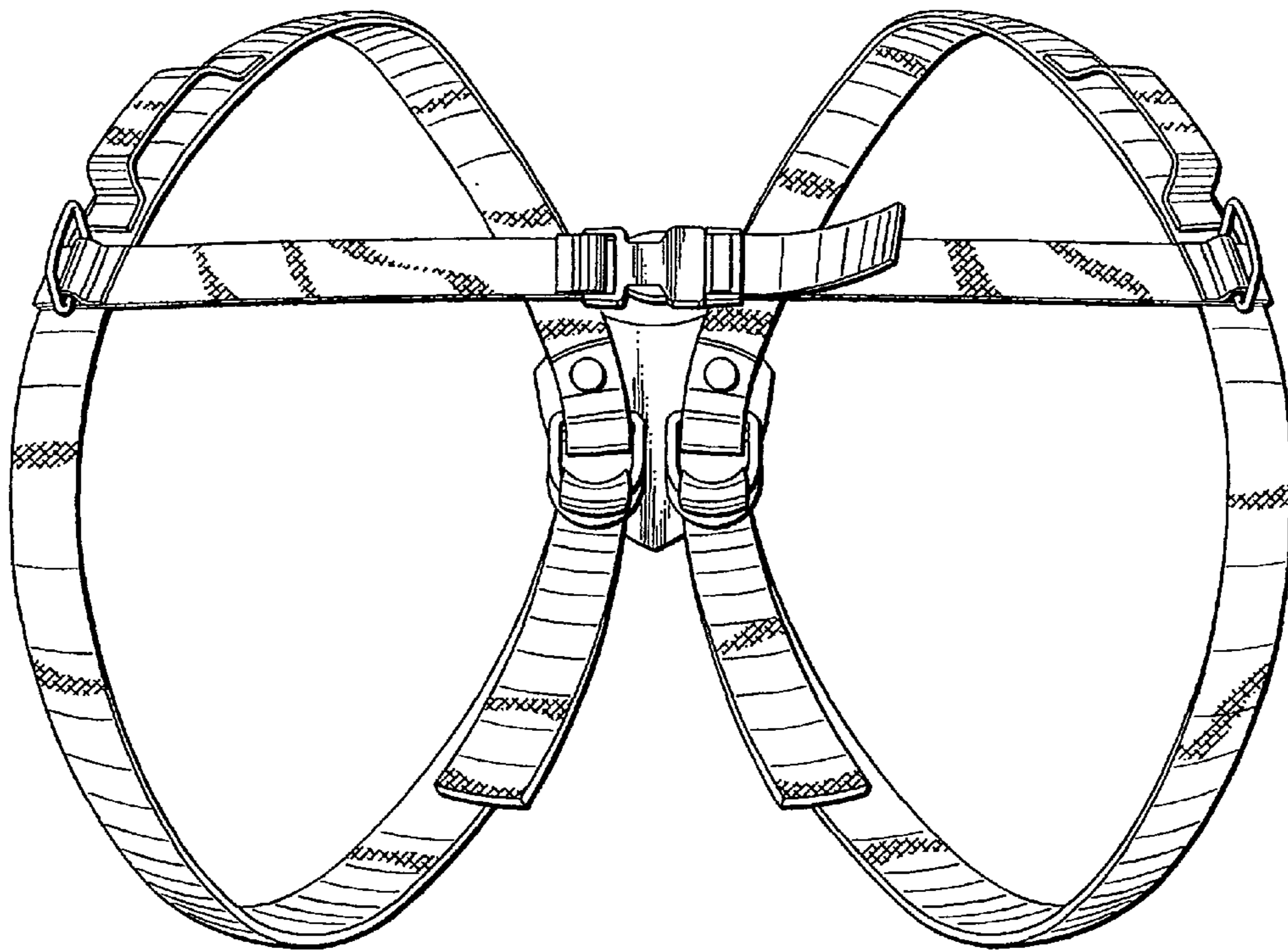

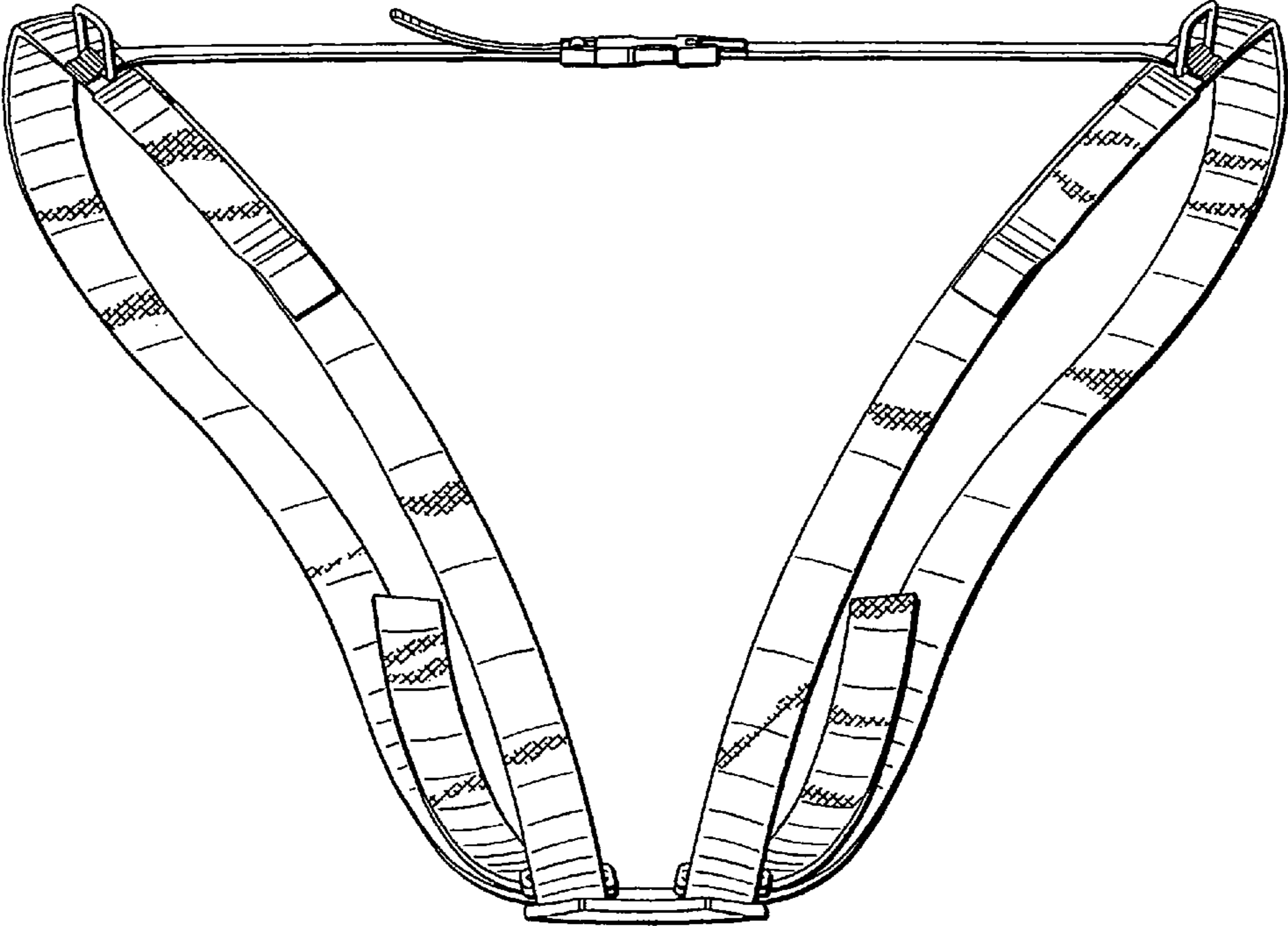

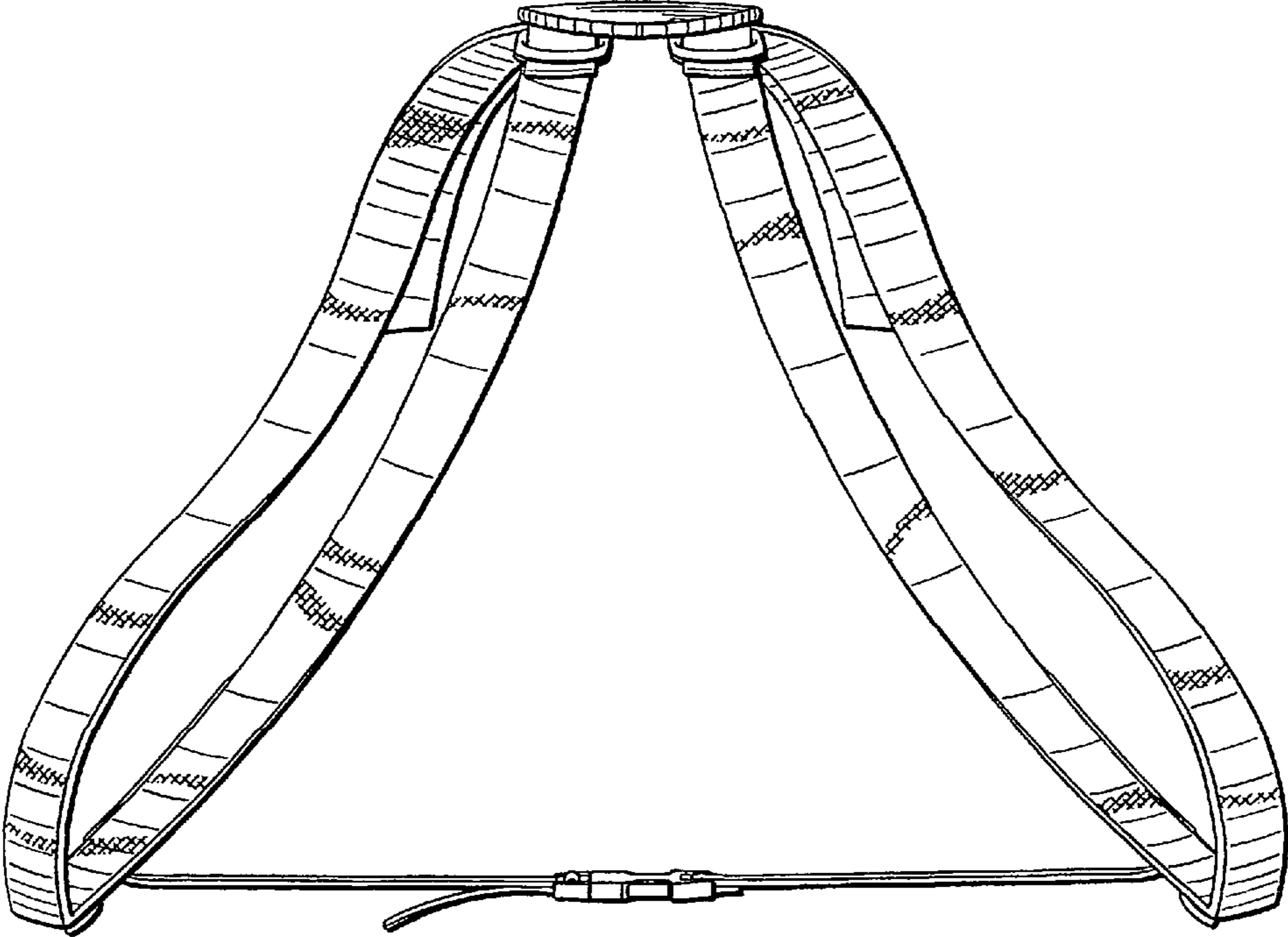

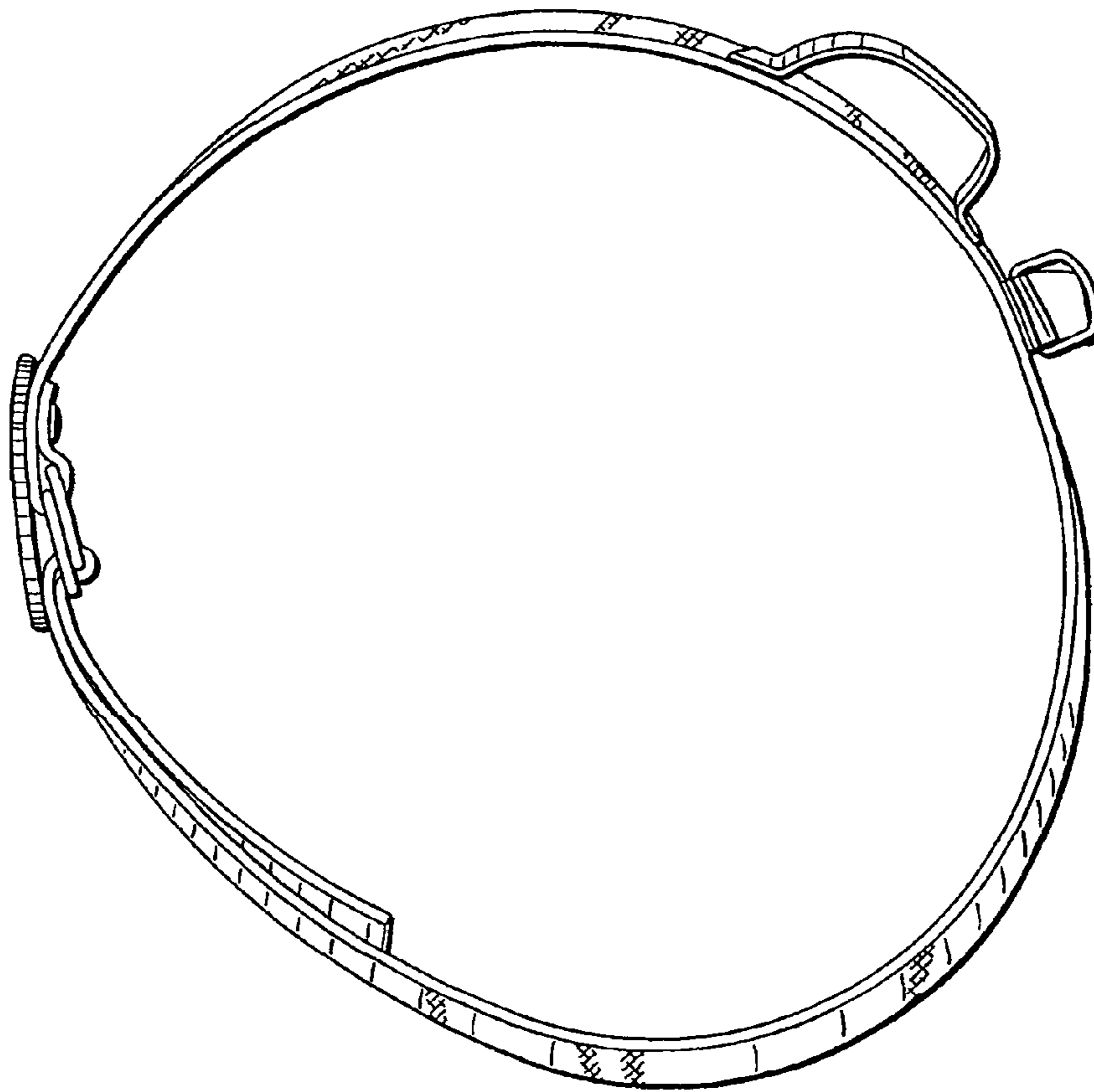

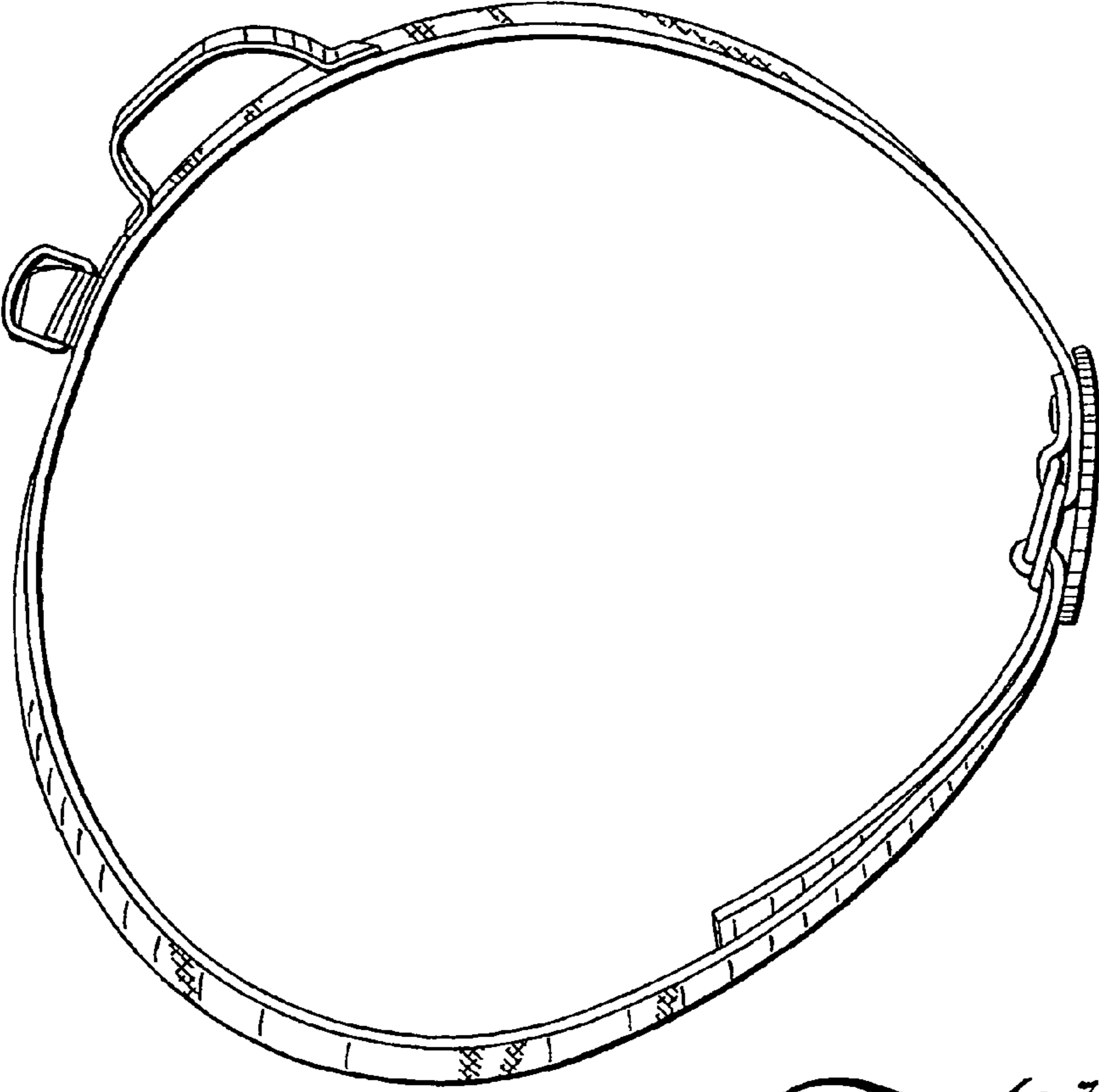
