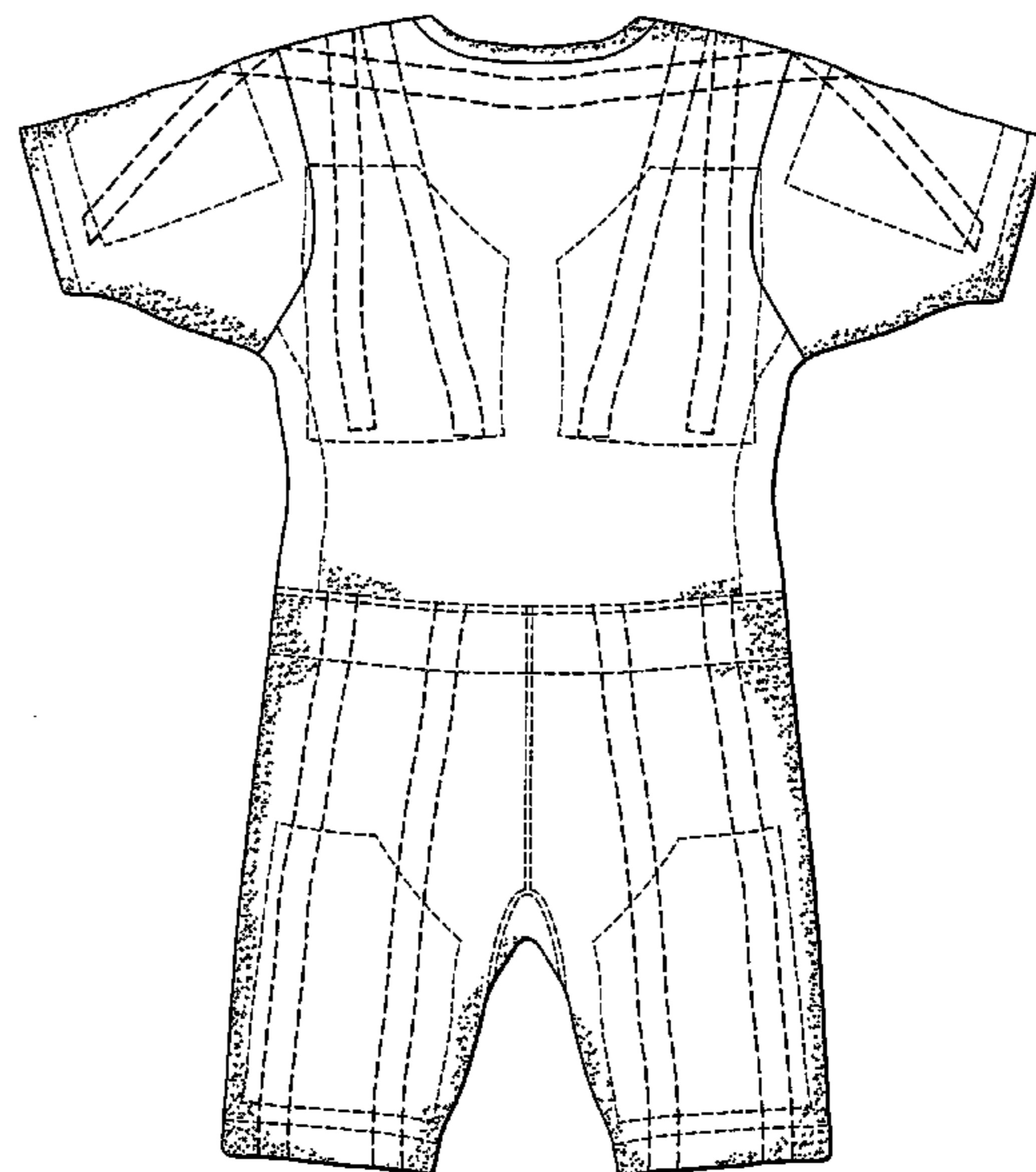
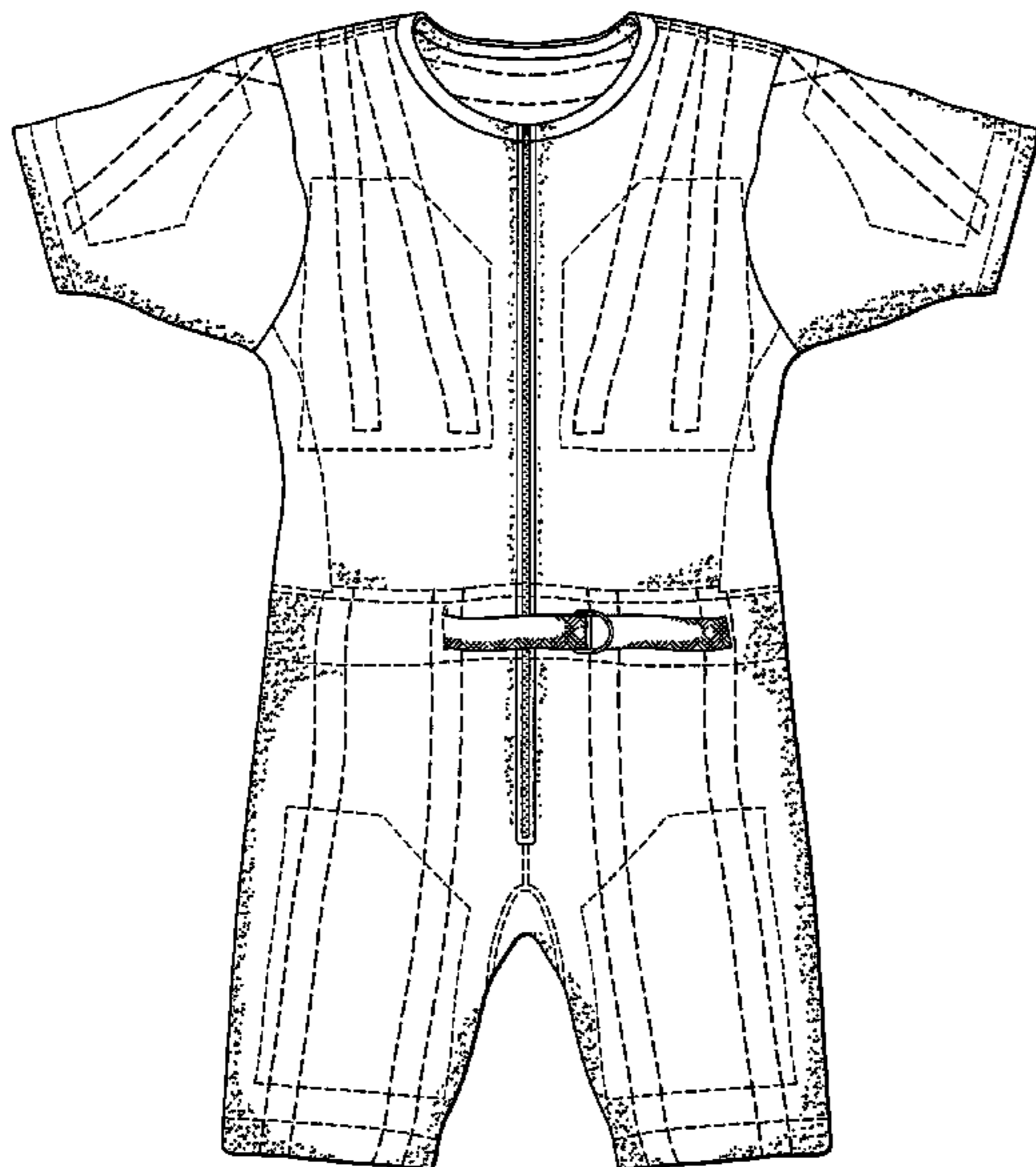
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a weighted body suit showing my new design;  
FIG. 2 is a front view of the weighted body suit of FIG. 1.  
FIG. 3 is a rear view of the weighted body suit of FIG. 1.  
FIG. 4 is a right side view of the weighted body suit of FIG. 1.

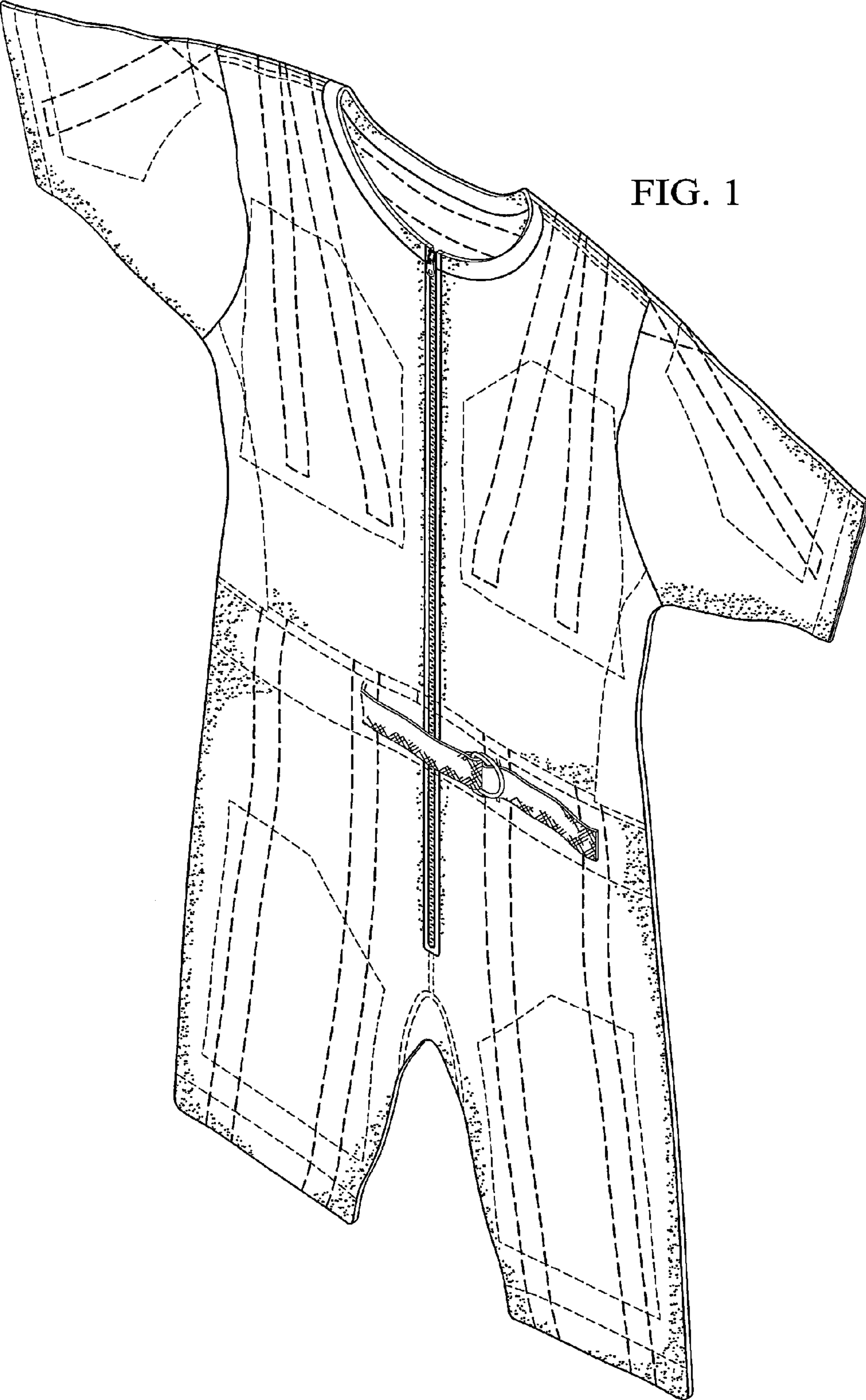

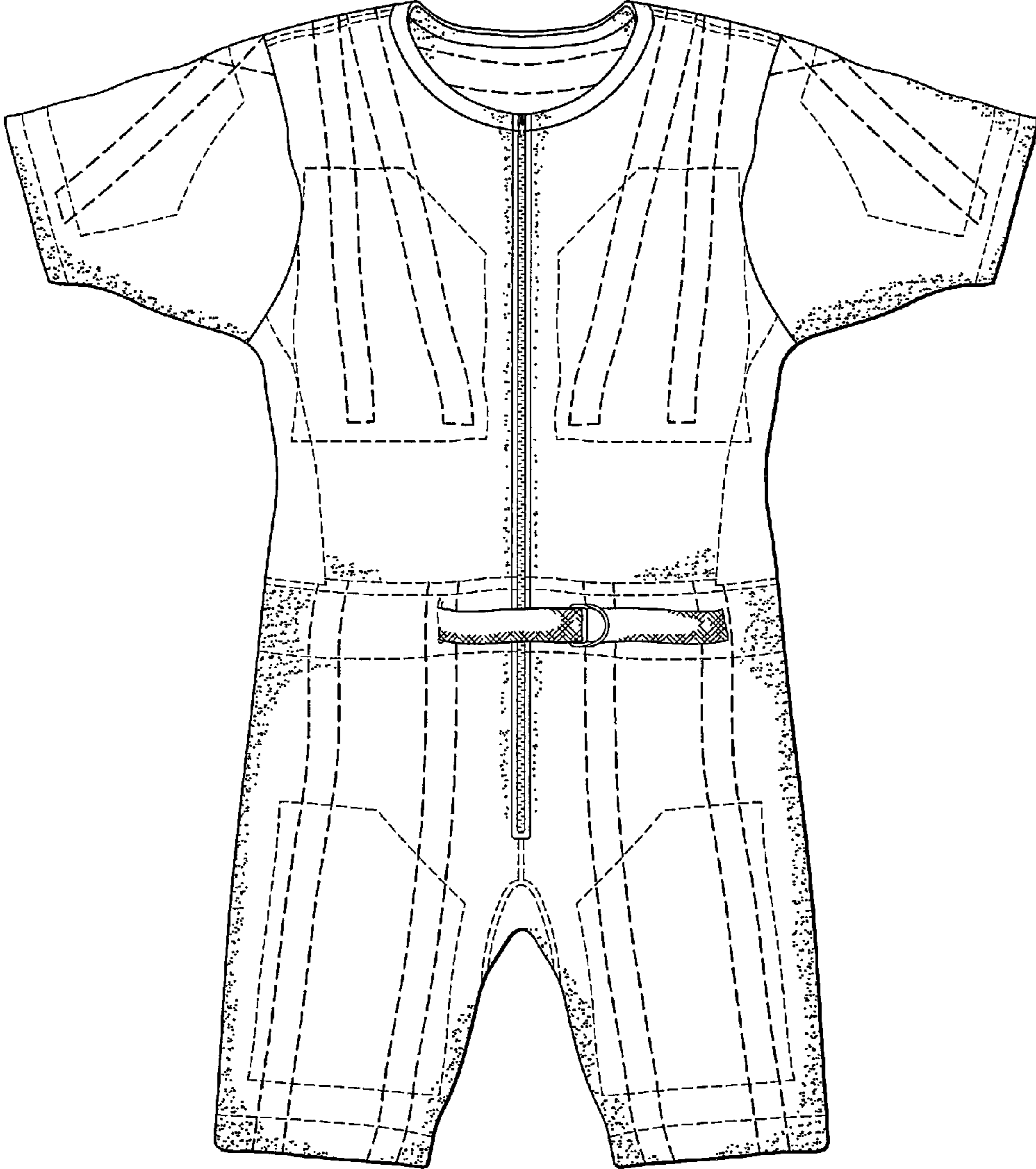

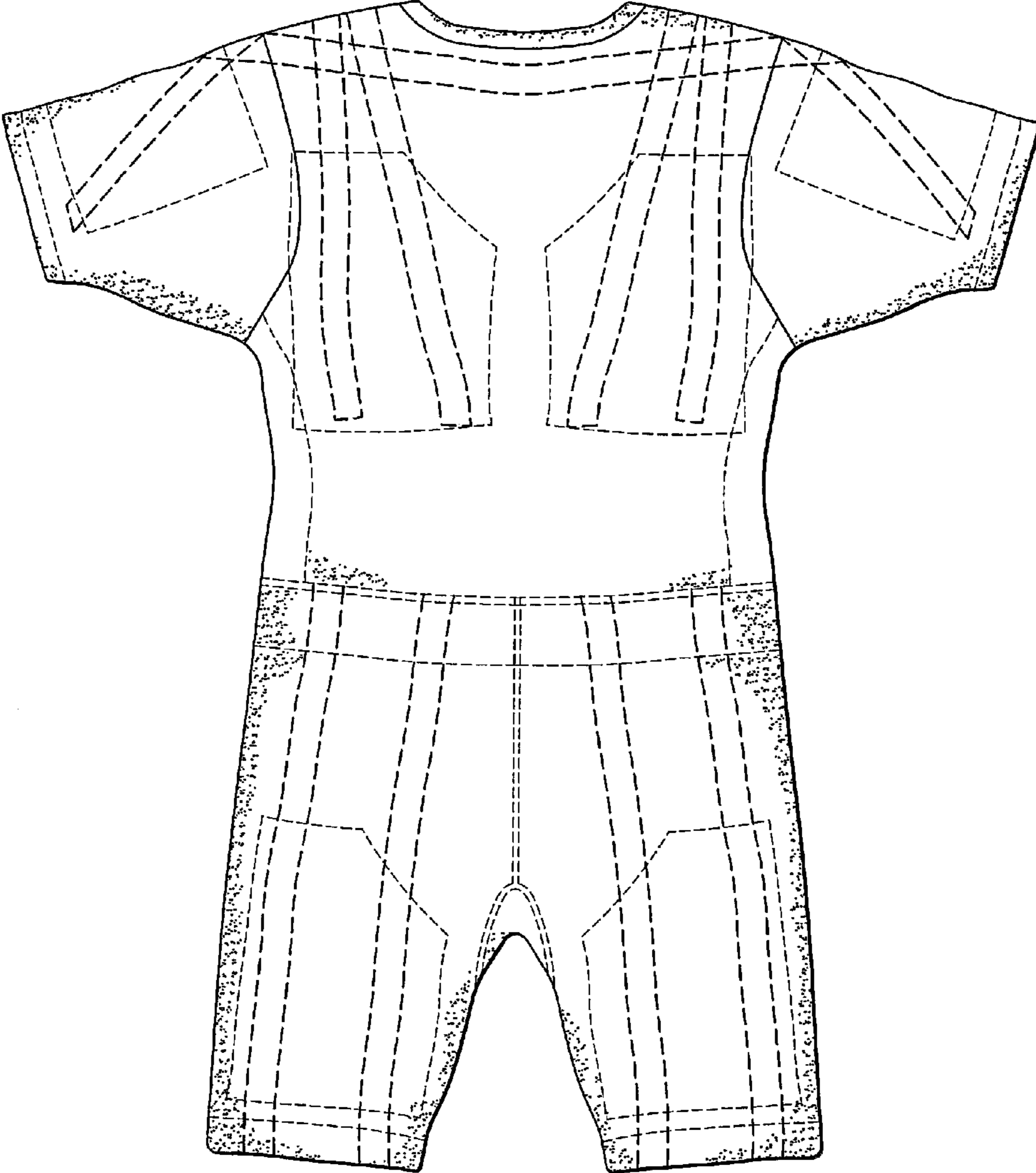

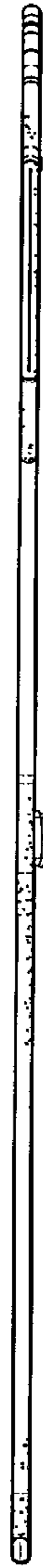

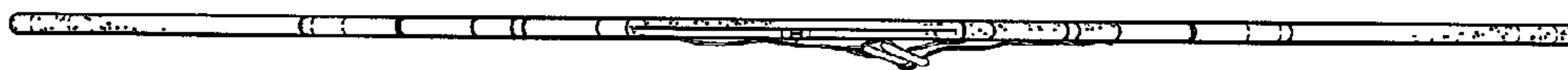
