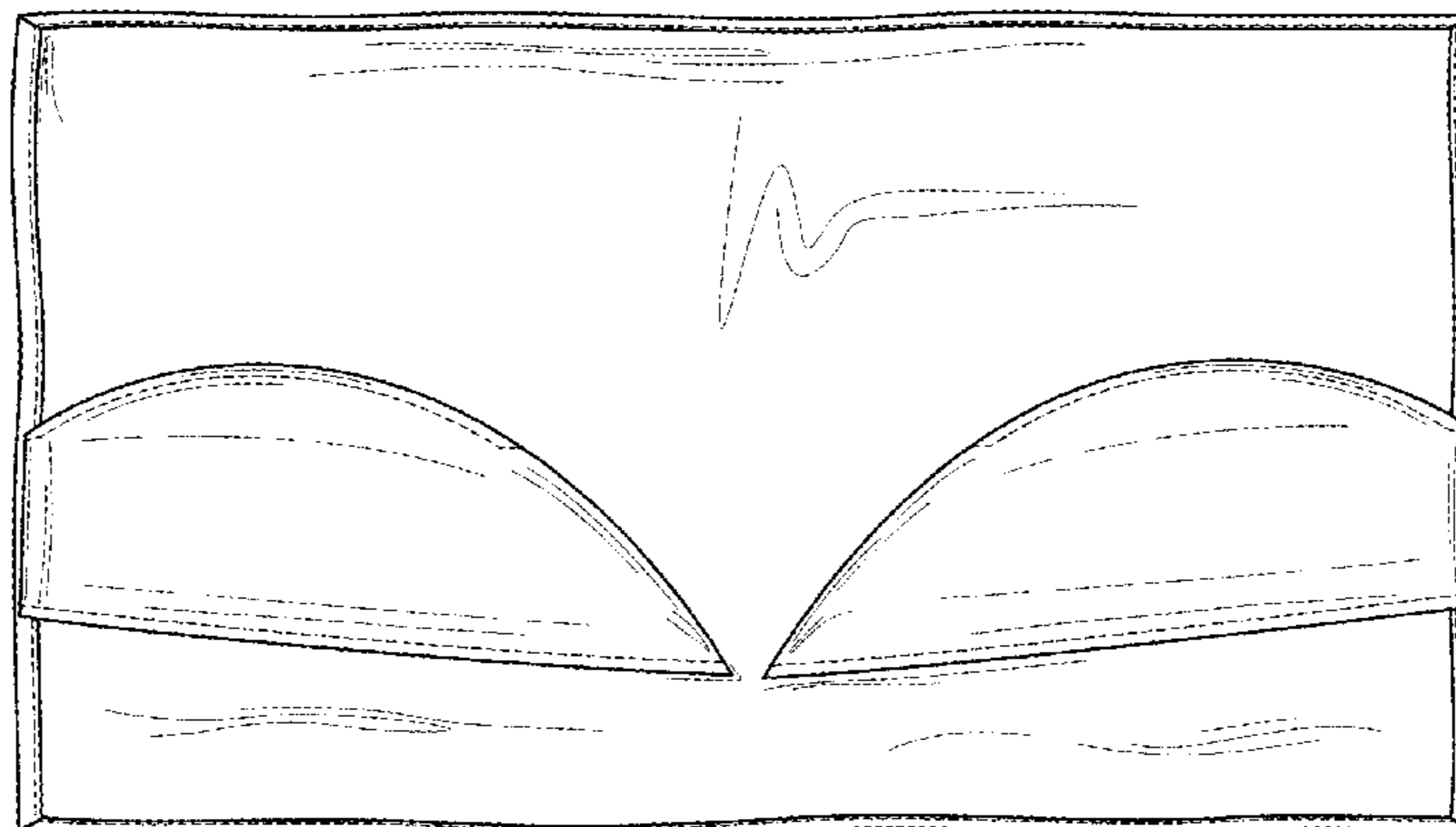
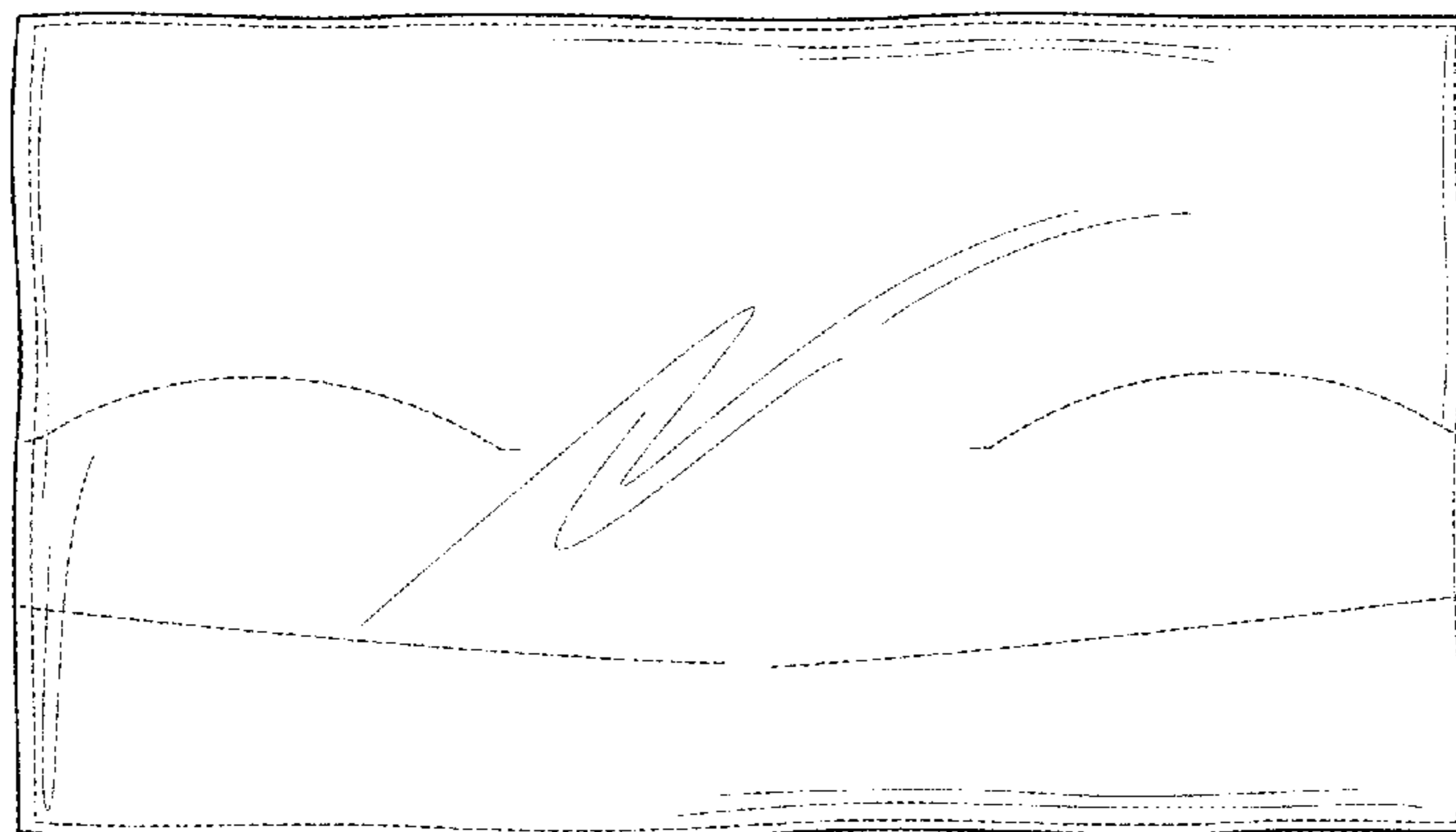
(57) **CLAIM**

I claim the ornamental design for a towel with arm channels, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of the towel with arm channels showing my new design;  
 FIG. 2 is a front elevation view thereof;  
 FIG. 3 is a rear elevation view thereof;  
 FIG. 4 is a left side elevation view thereof;  
 FIG. 5 is a right side elevation view thereof;  
 FIG. 6 is a top plan view thereof;

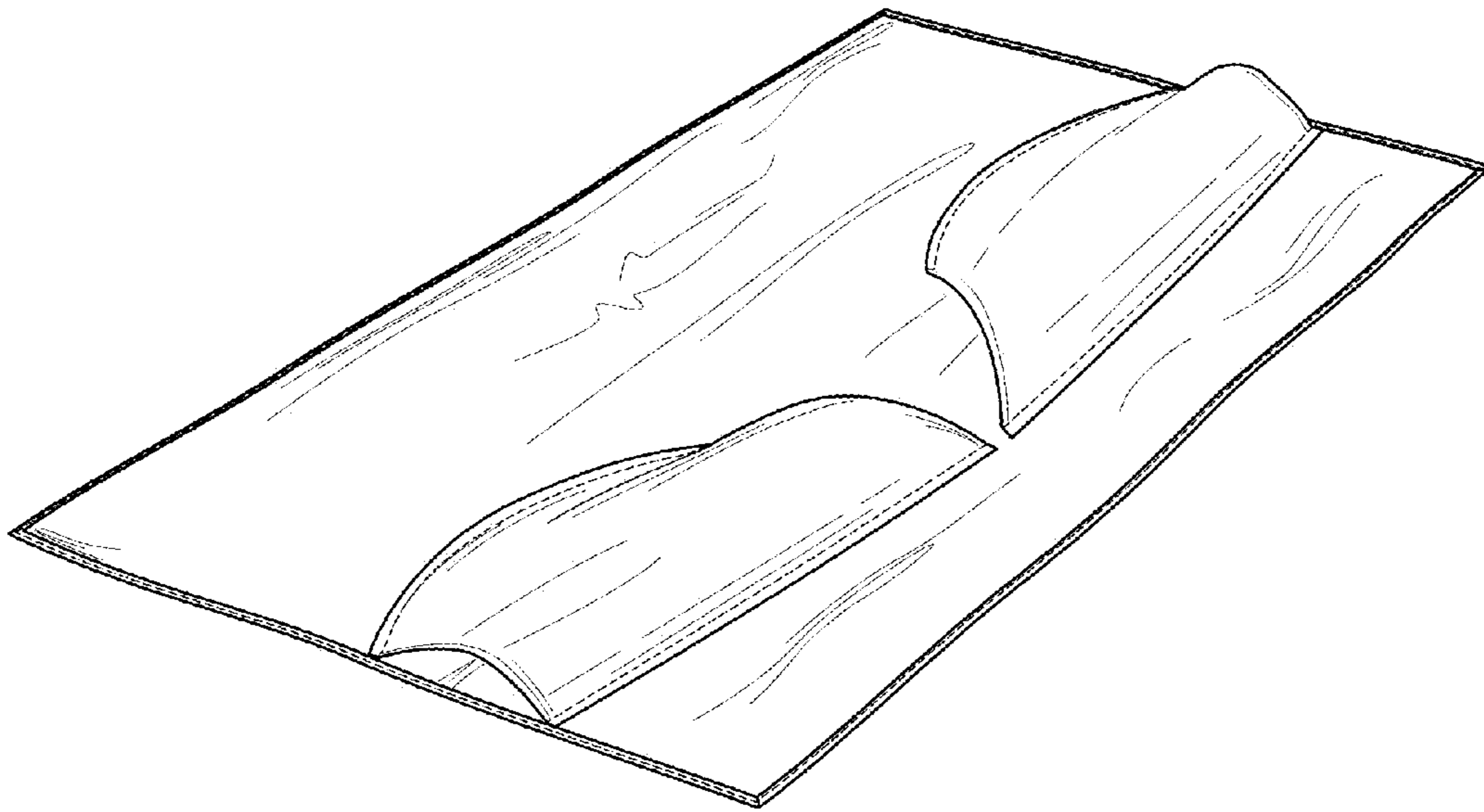

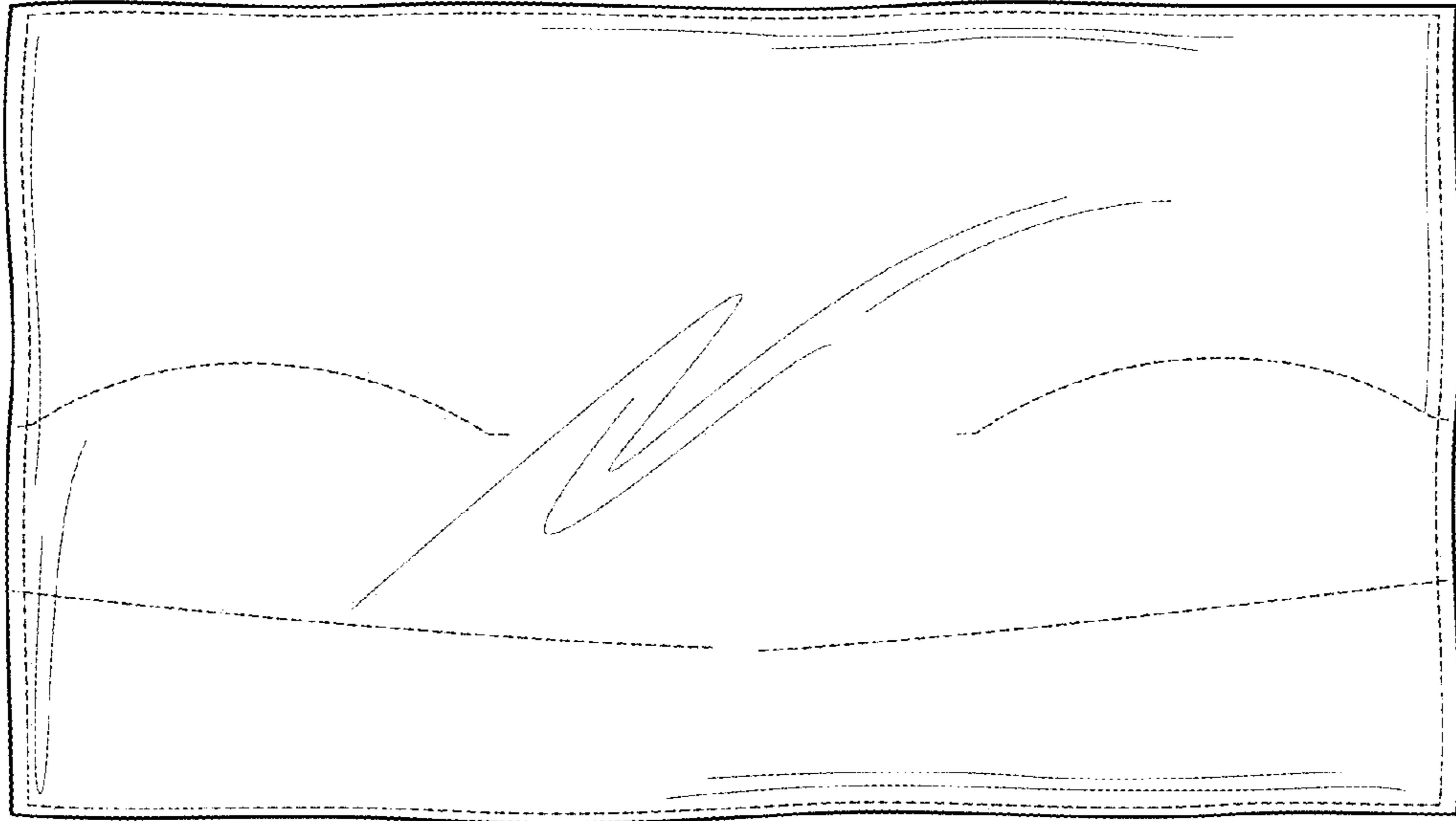

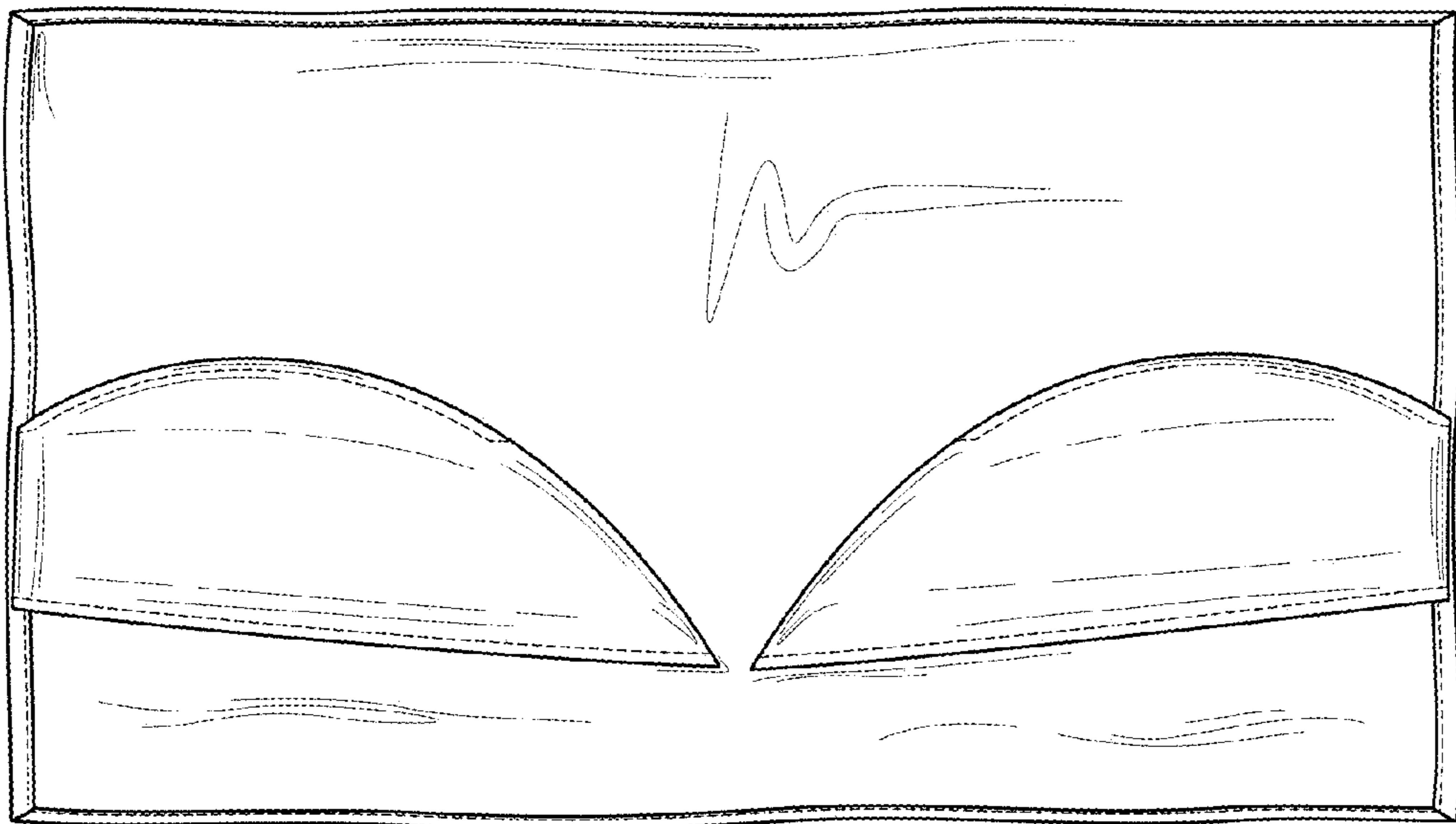

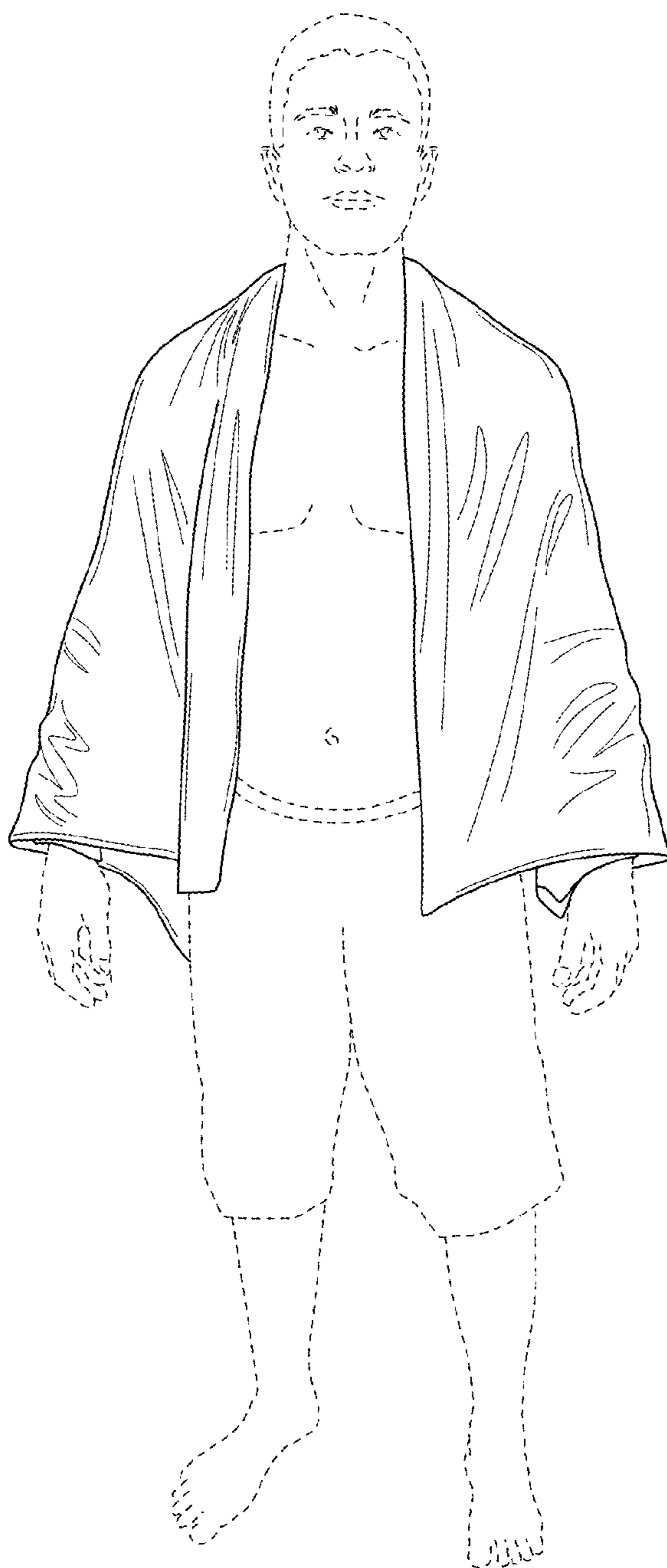

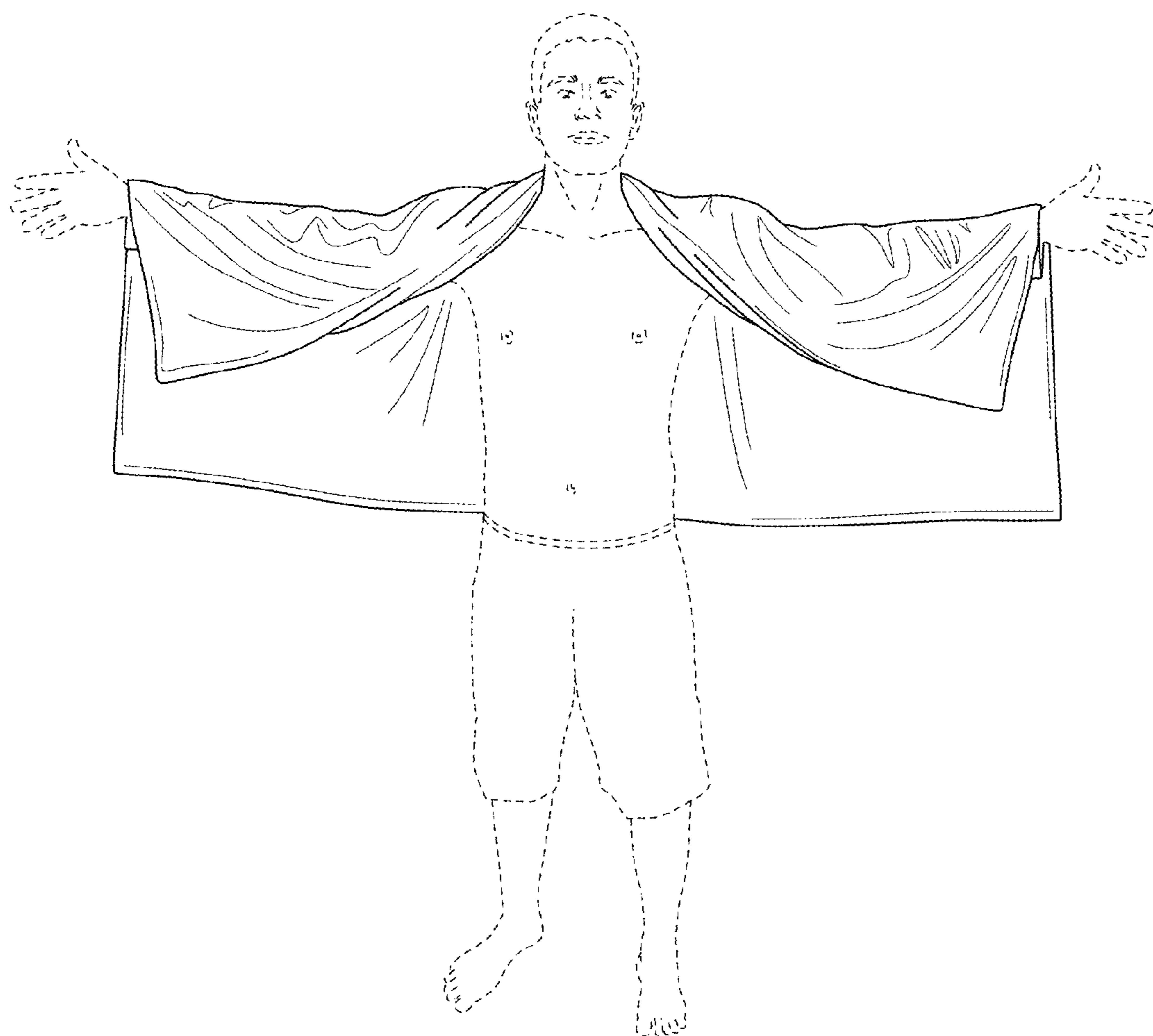
