(57) **CLAIM**

The ornamental design for an article of clothing for the upper torso, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the article of clothing for the upper torso including four flexible straps adapted for the attachment of toys as well as ends of a string extending from the neck of the article of clothing for the upper torso.

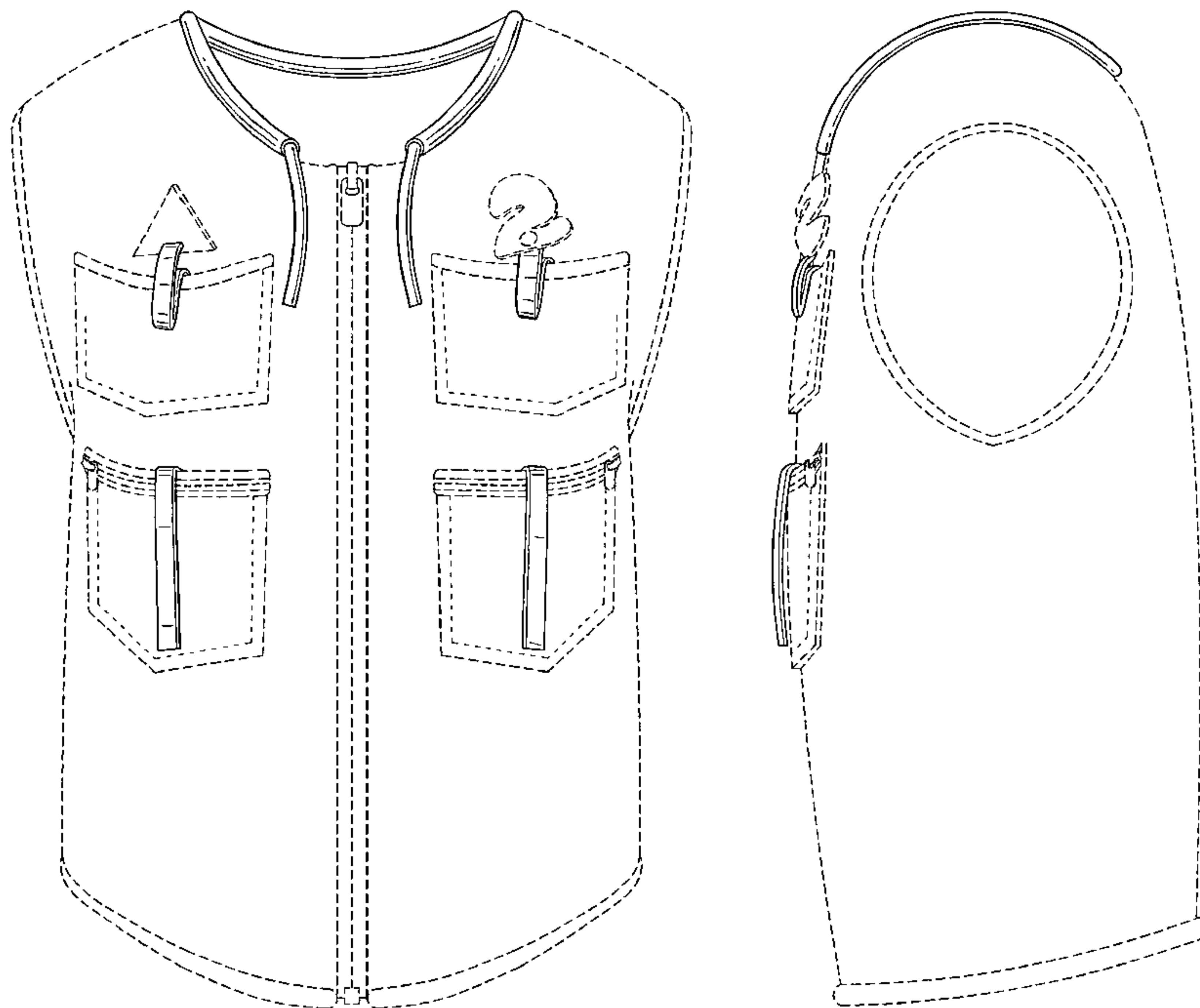
FIG. 2 is a left side perspective view thereof.

FIG. 4 is a right side view thereof.

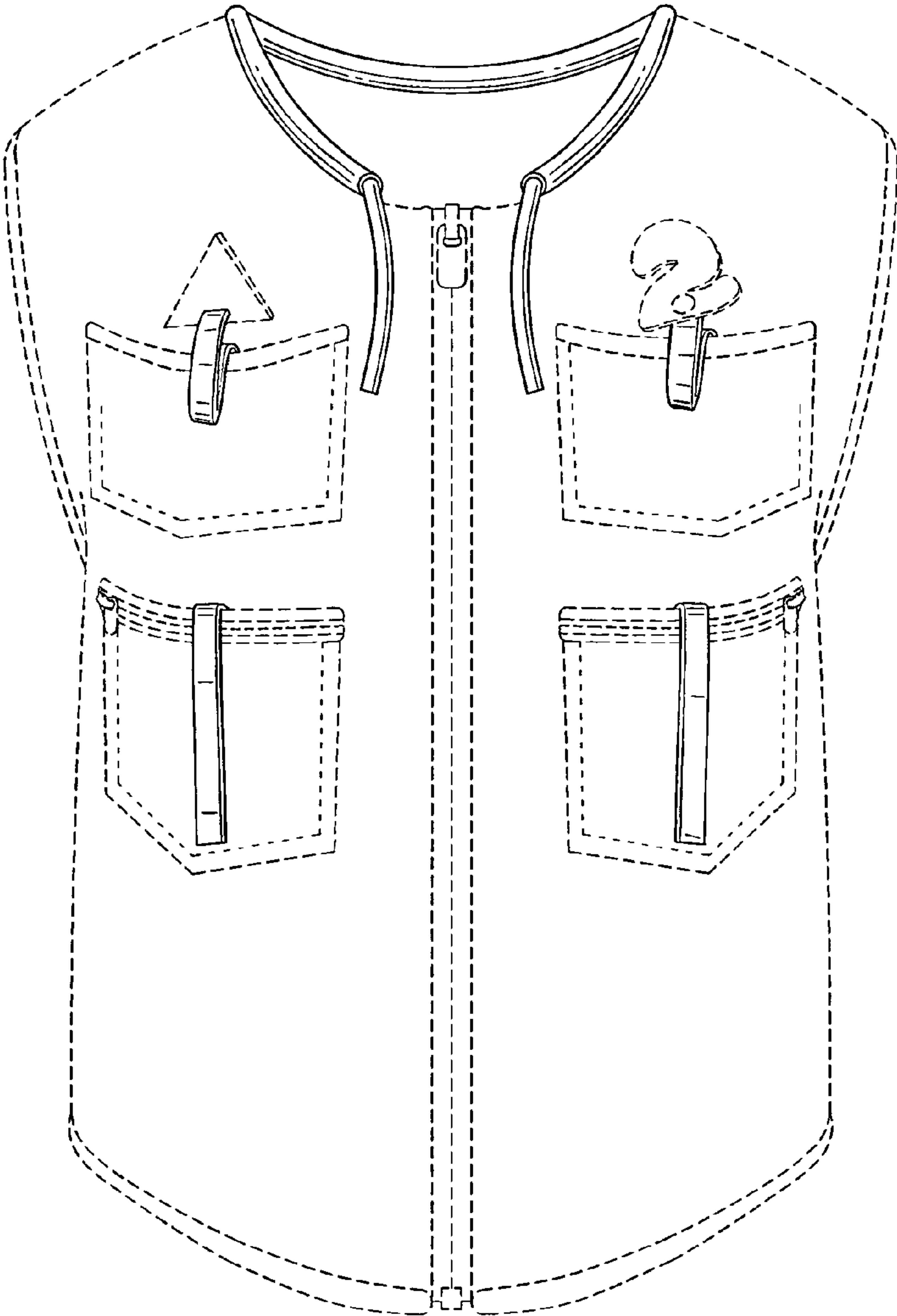

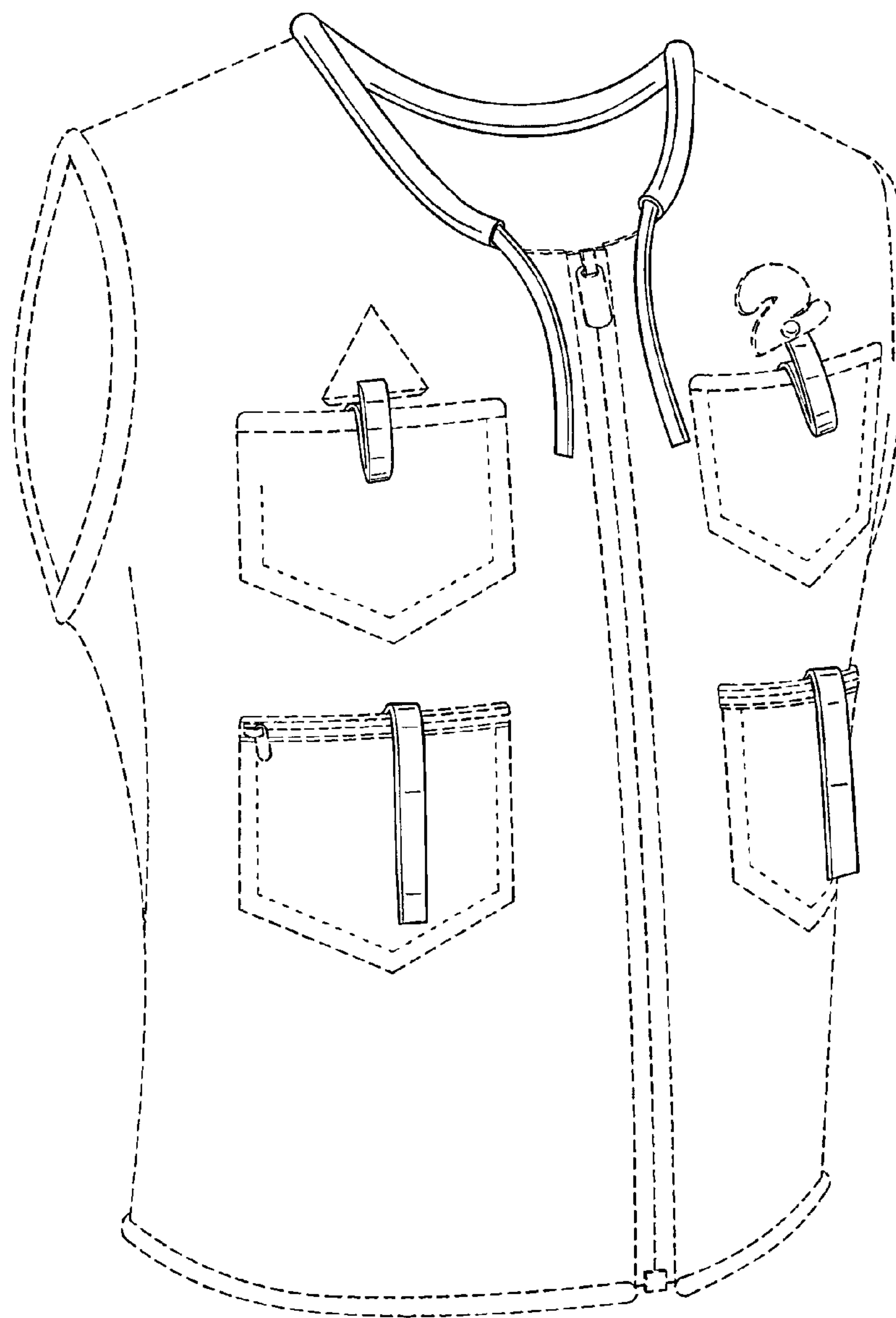

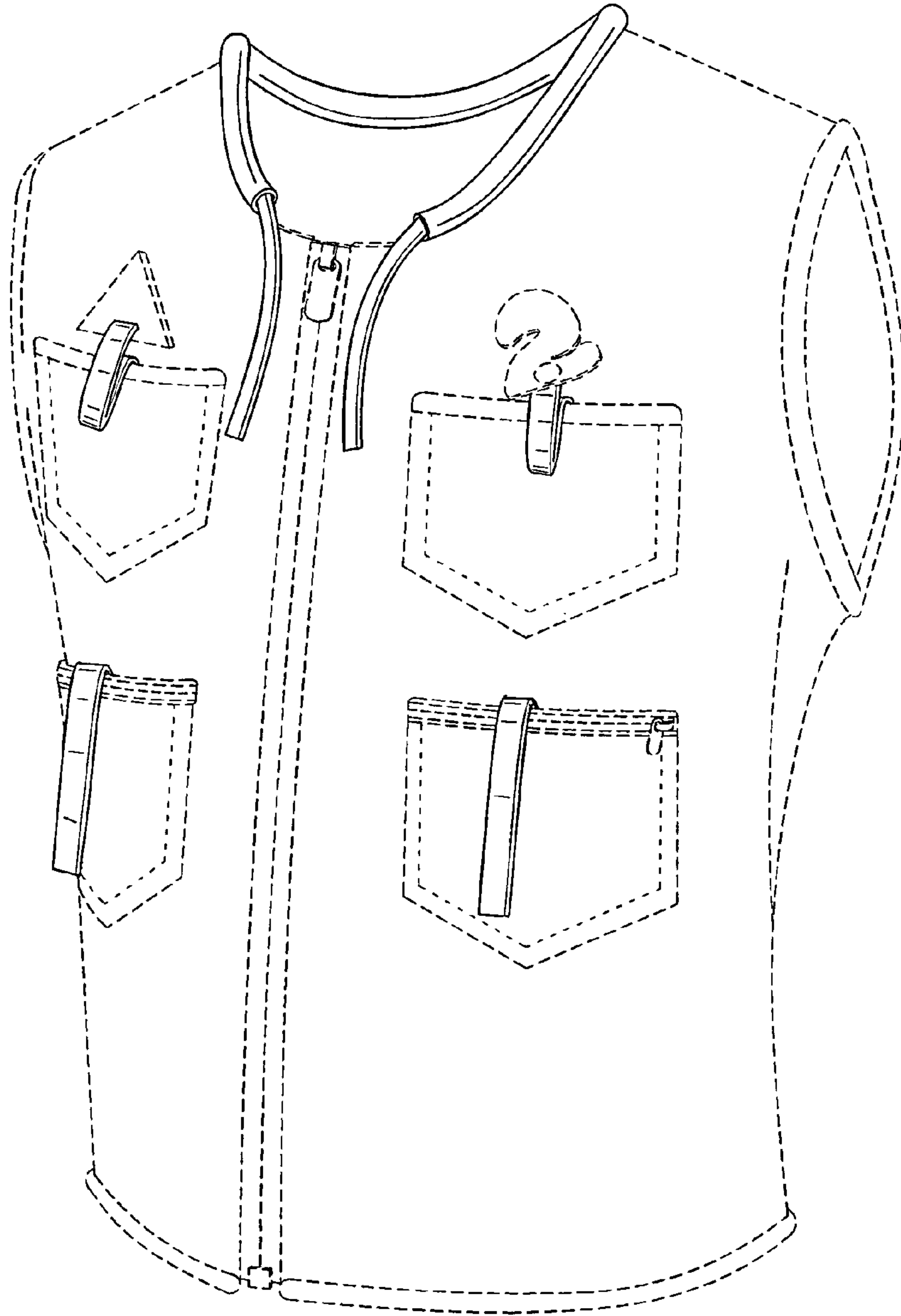

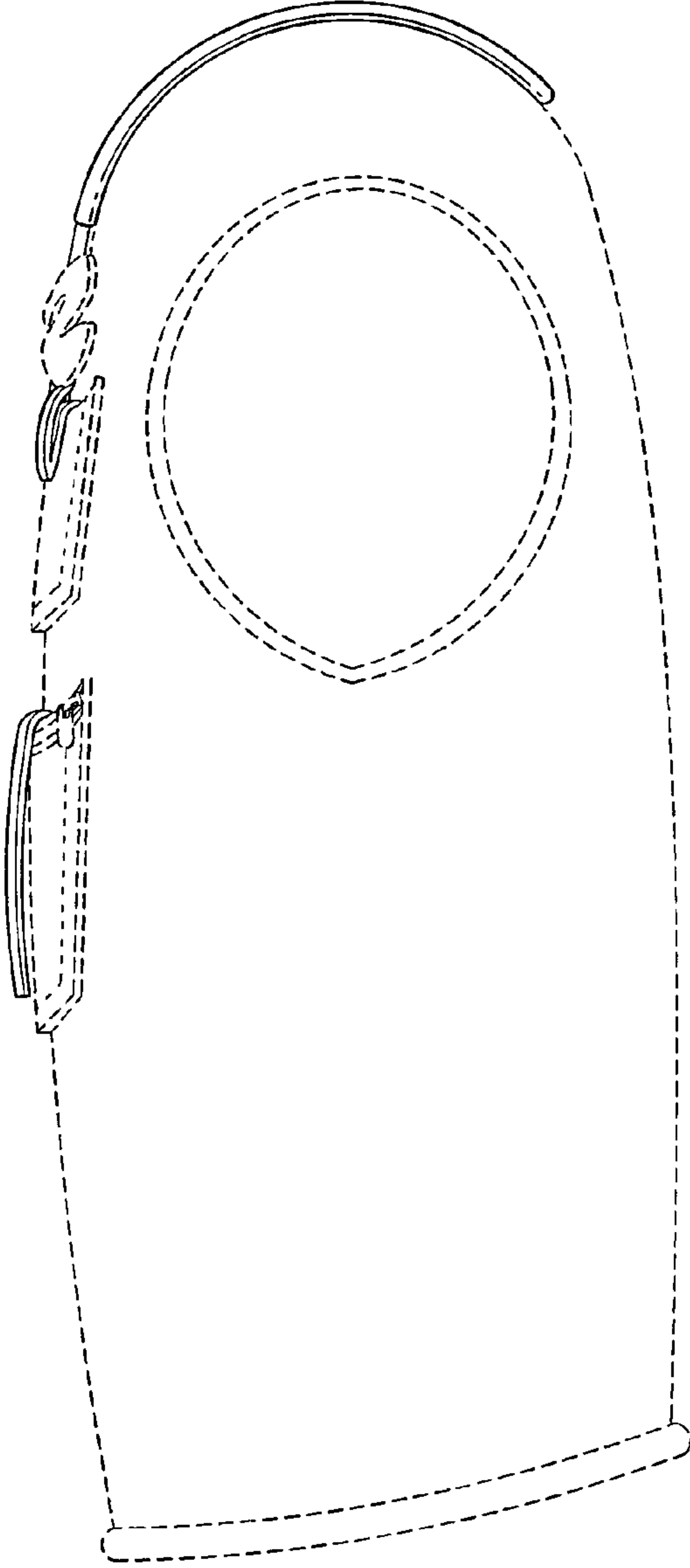
