(57) **CLAIM**

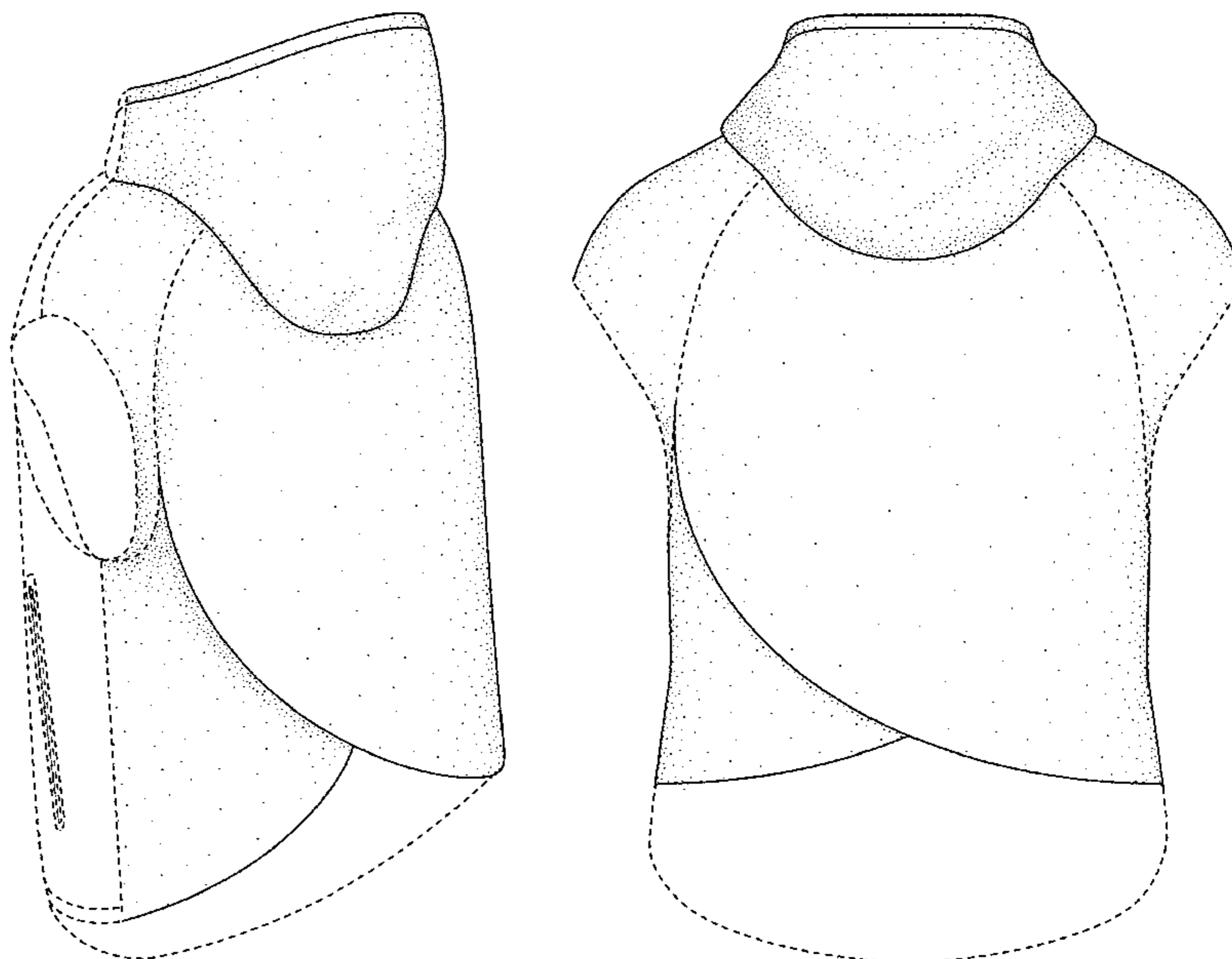
The ornamental design for a hooded garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a left perspective rear view of a hooded garment showing my new design in an in-use configuration; FIG. 2 is rear view thereof; FIG. 3 is a right view thereof; FIG. 4 is a left side view thereof; and, FIG. 5 is a top view thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken lines within the shaded area are for environmental purposes only and form no part of the claimed design. The broken lines showing the remainder of the hooded garment and the unshaded regions therein are for environmental purposes only and form no part of the claimed design.

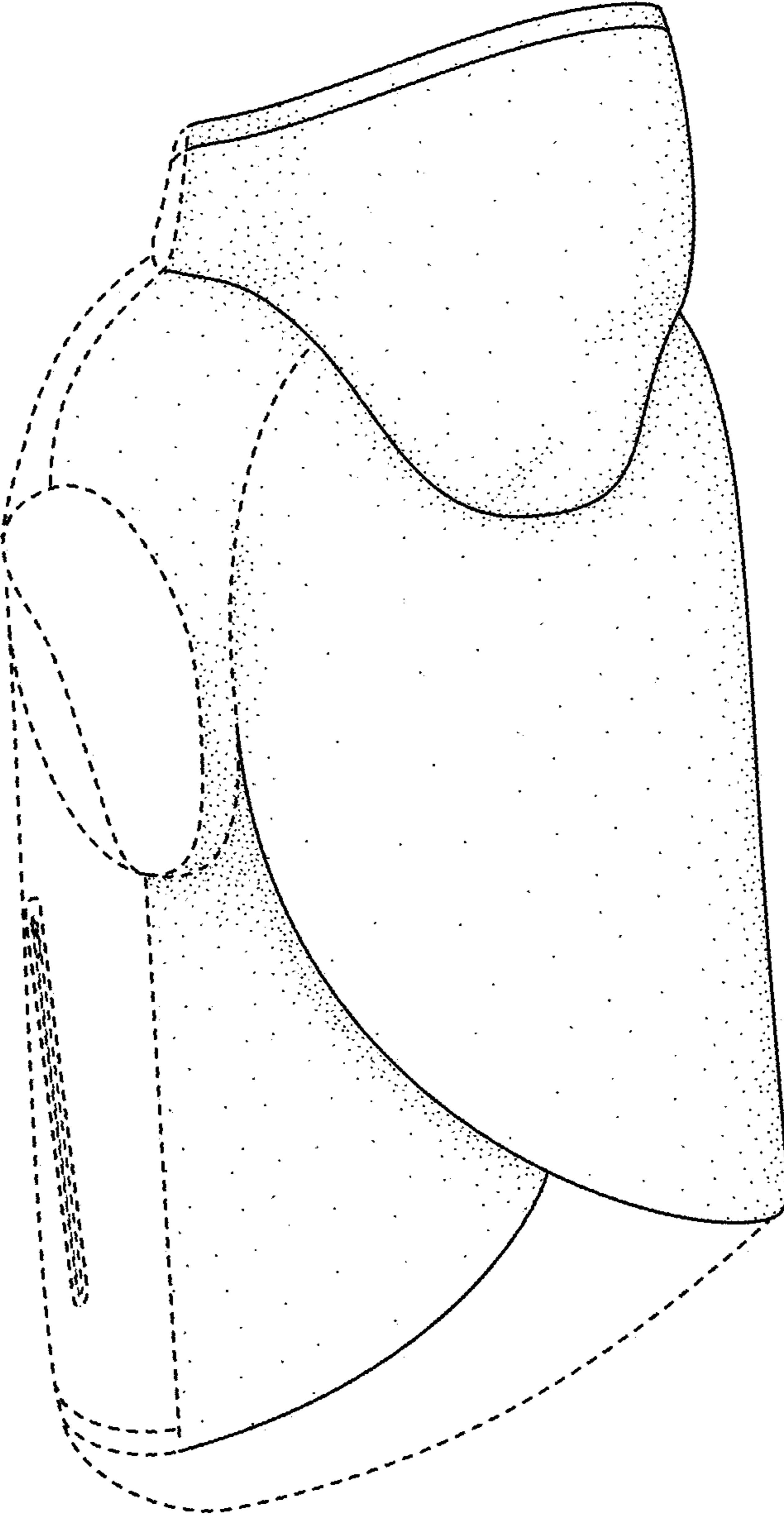

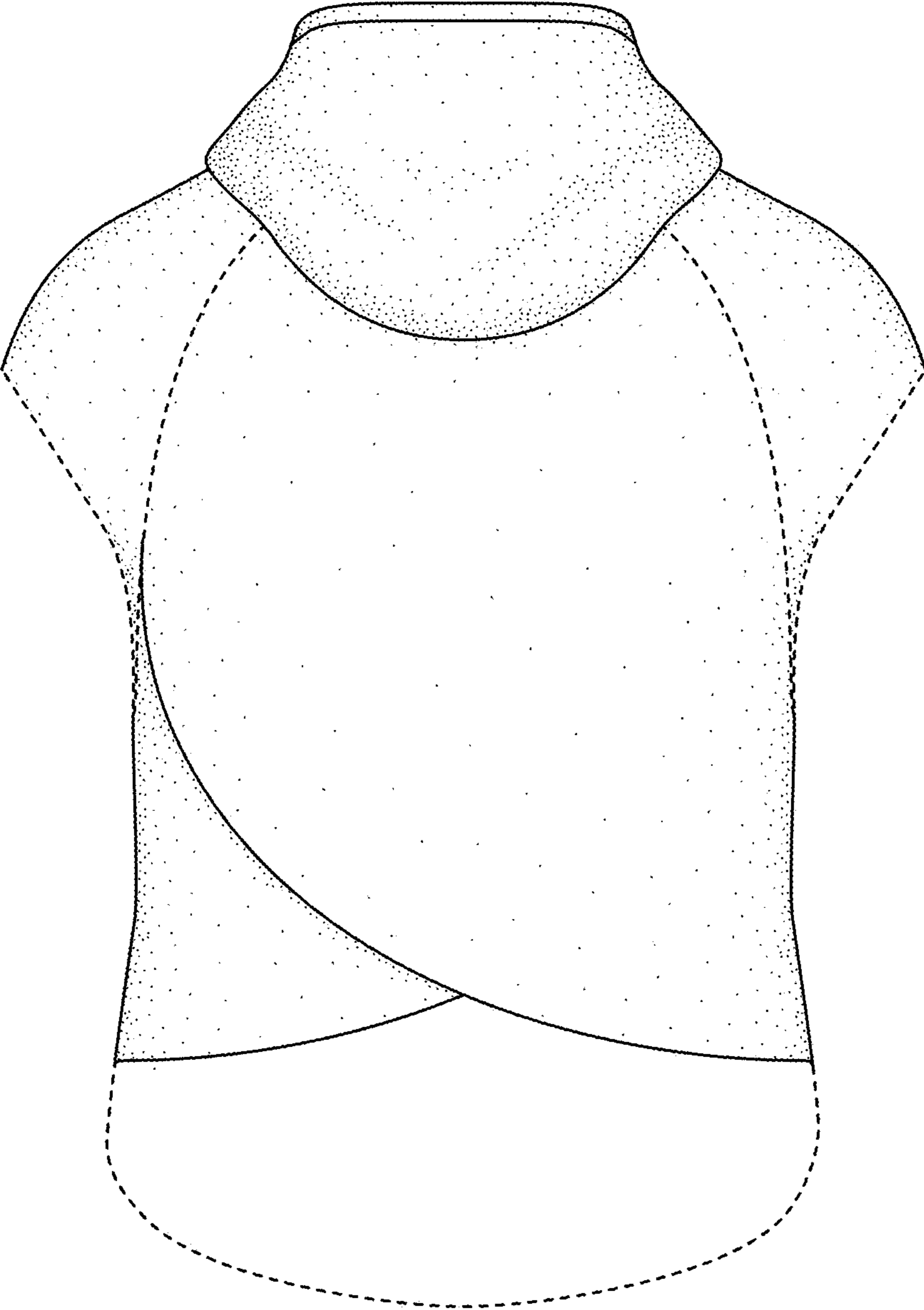

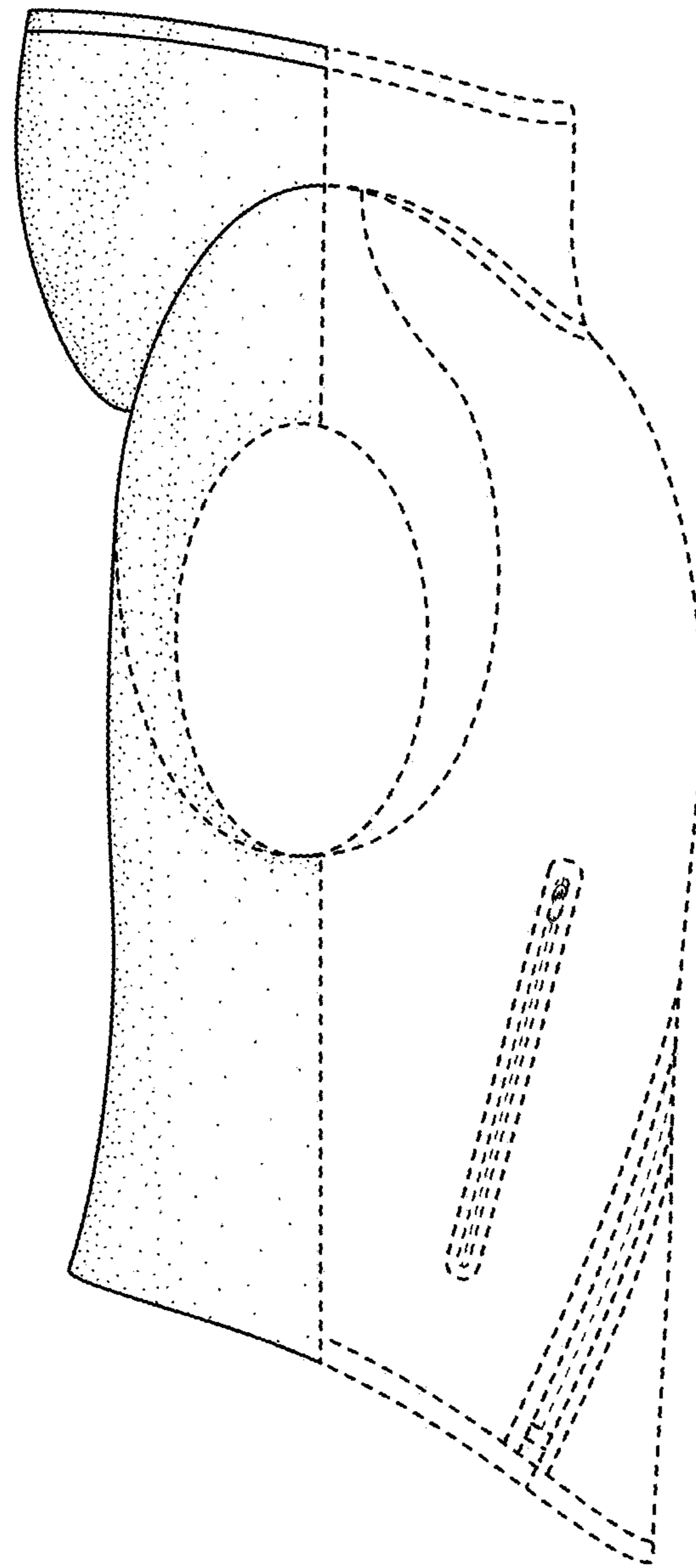

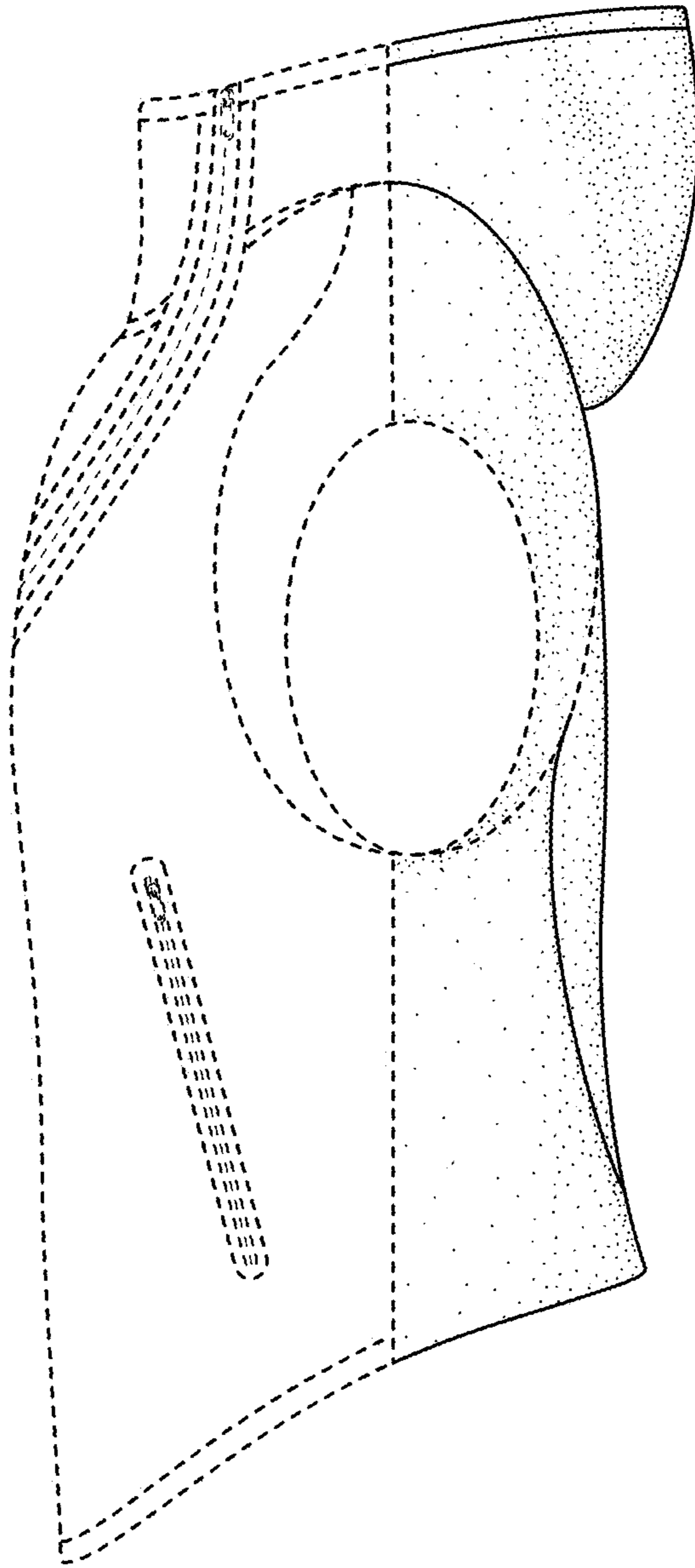

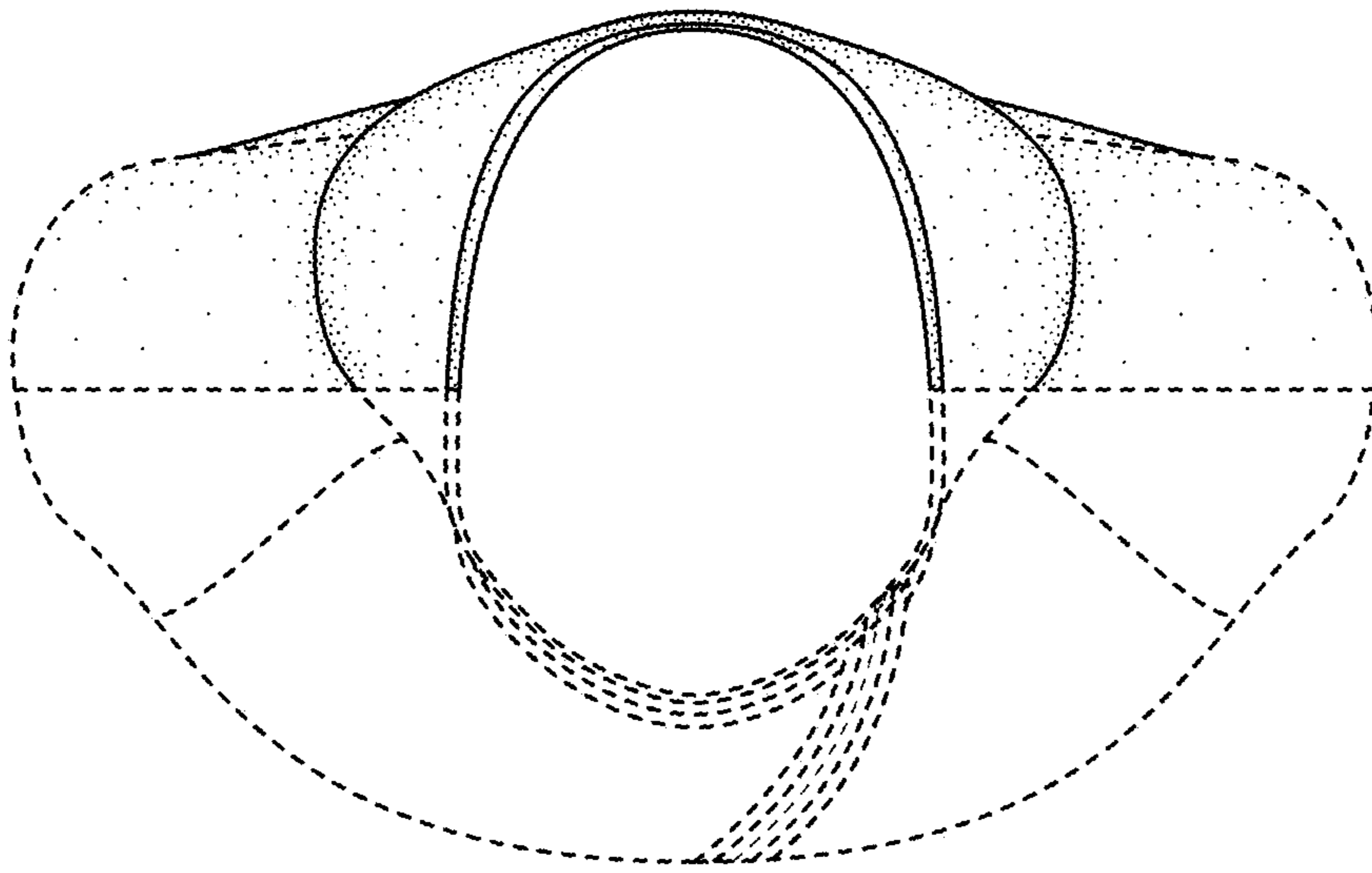
