The ornamental design for a tote apparatus, as shown and described.

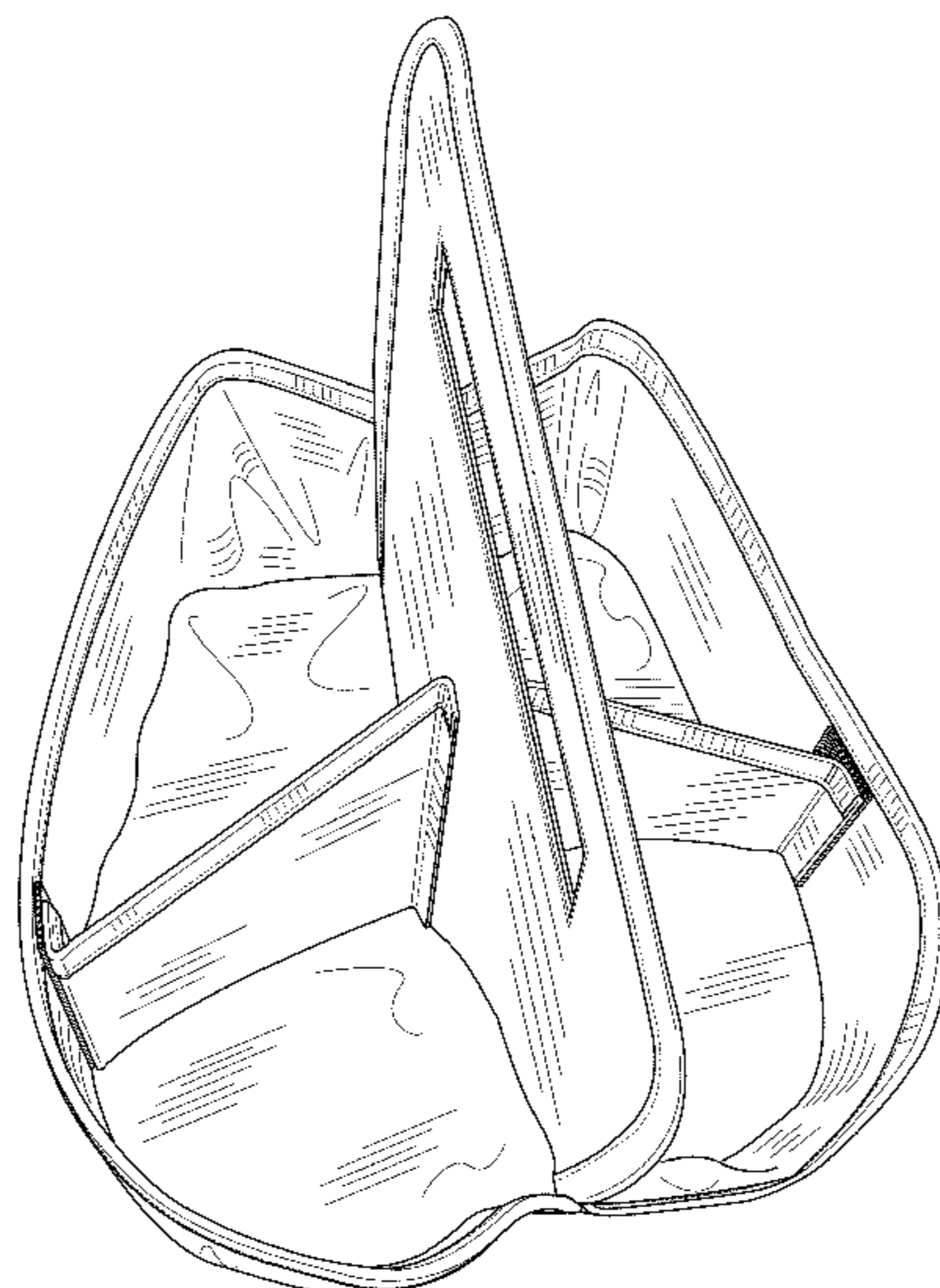
DESCRIPTION

FIG. 1 is an isometric view of the tote apparatus;
FIG. 2 is another isometric view thereof;
FIG. 3 is a top view of the tote apparatus in which divider elements thereof are in attached positions;
FIG. 4 is a top view of the tote apparatus in which one of the divider elements is in a detached position;
FIG. 5 is a top view of the tote apparatus in which the divider elements are in detached positions;
FIG. 6 is a side view of the tote apparatus;
FIG. 7 is an end view thereof;
FIG. 8 is a bottom view thereof; and,
FIG. 9 is an isometric view thereof showing environment.

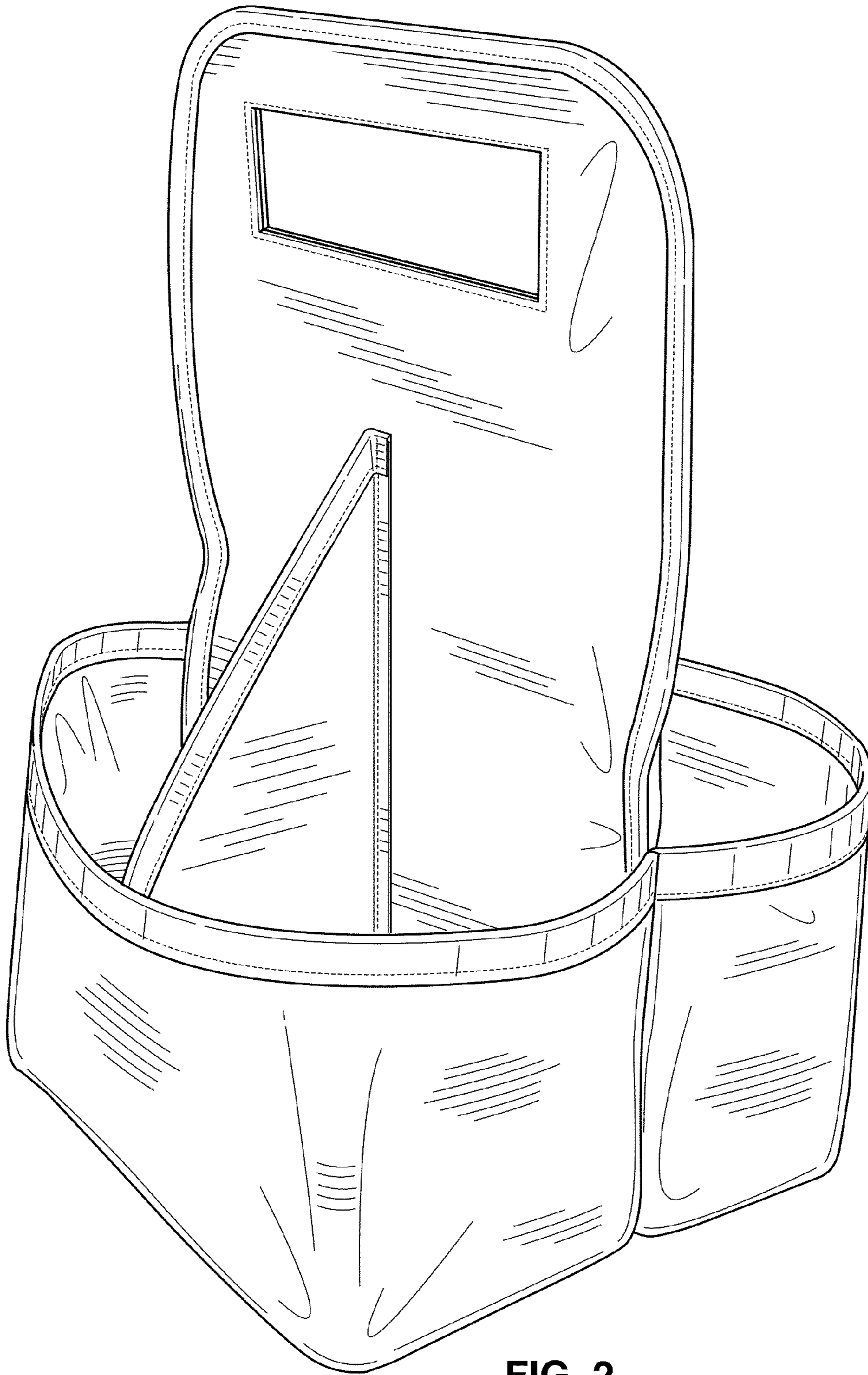

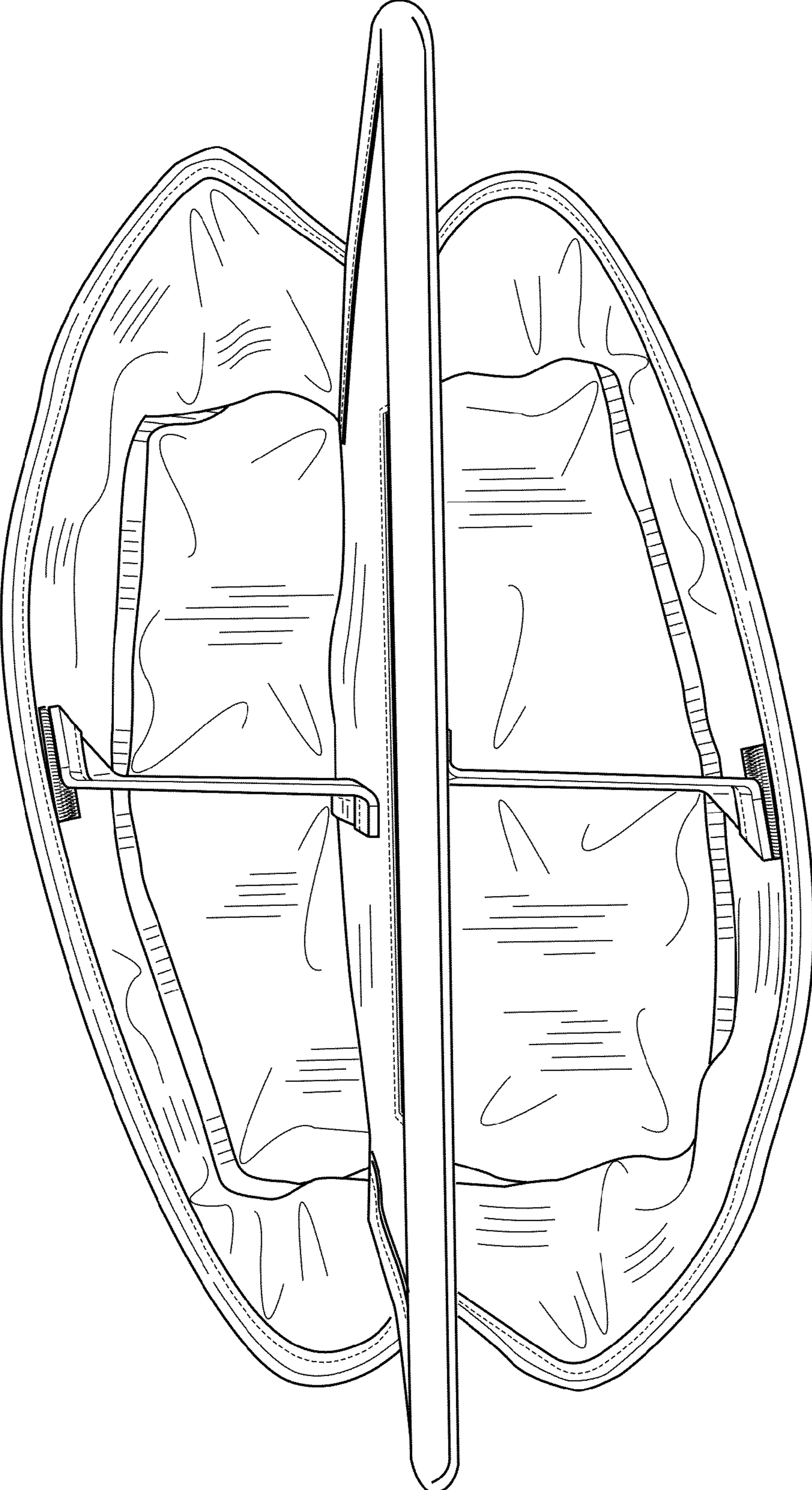

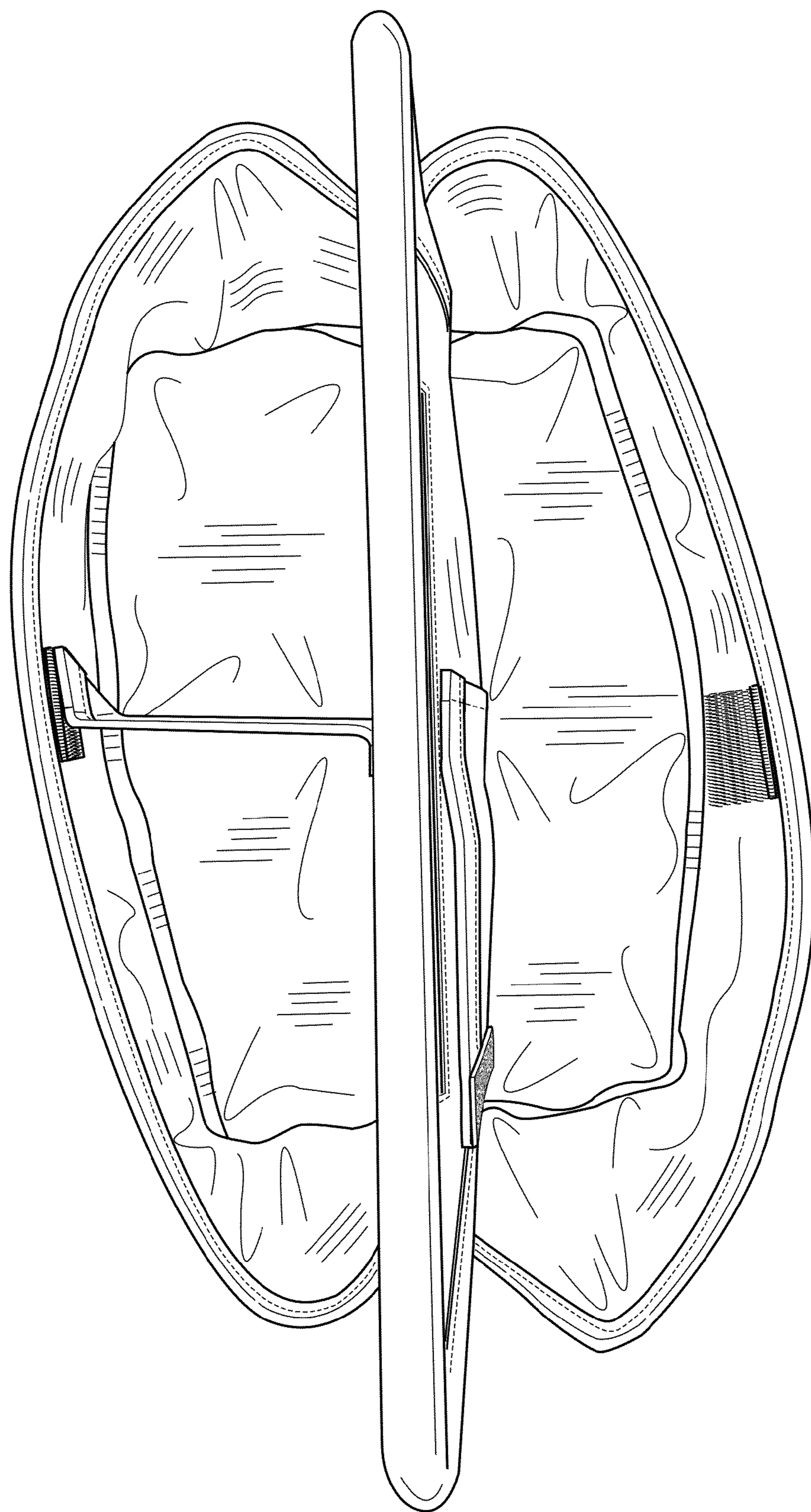

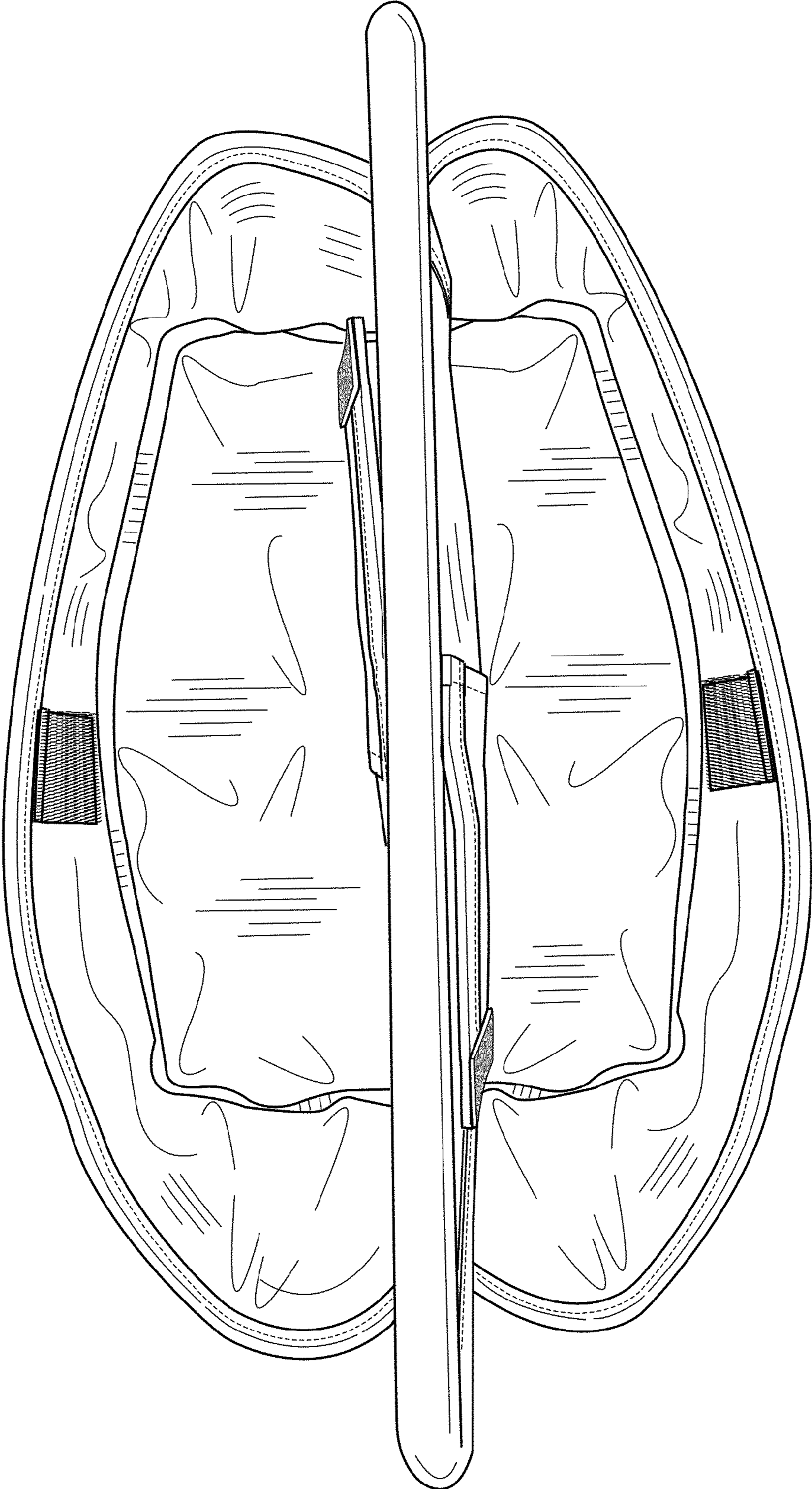

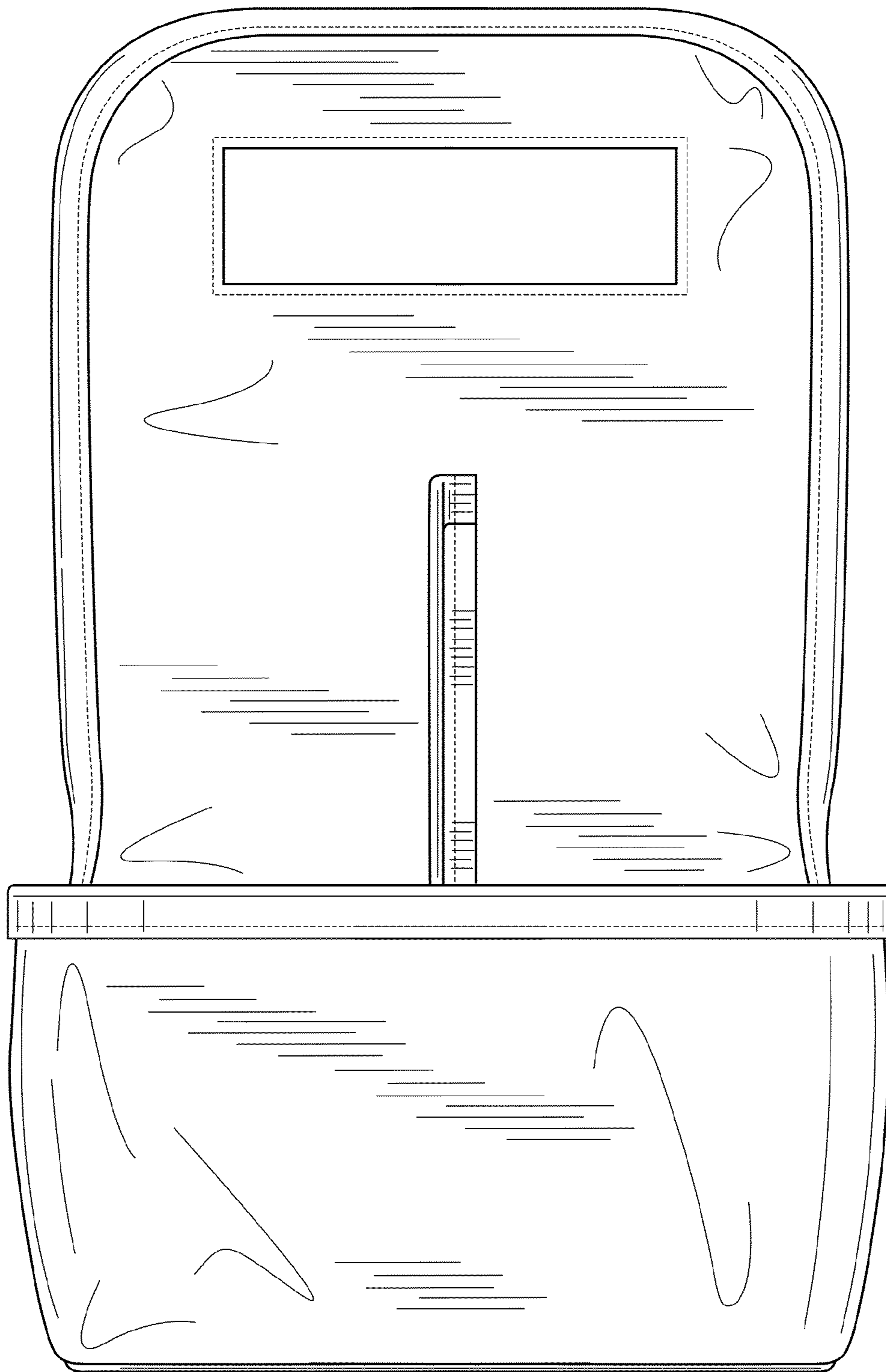

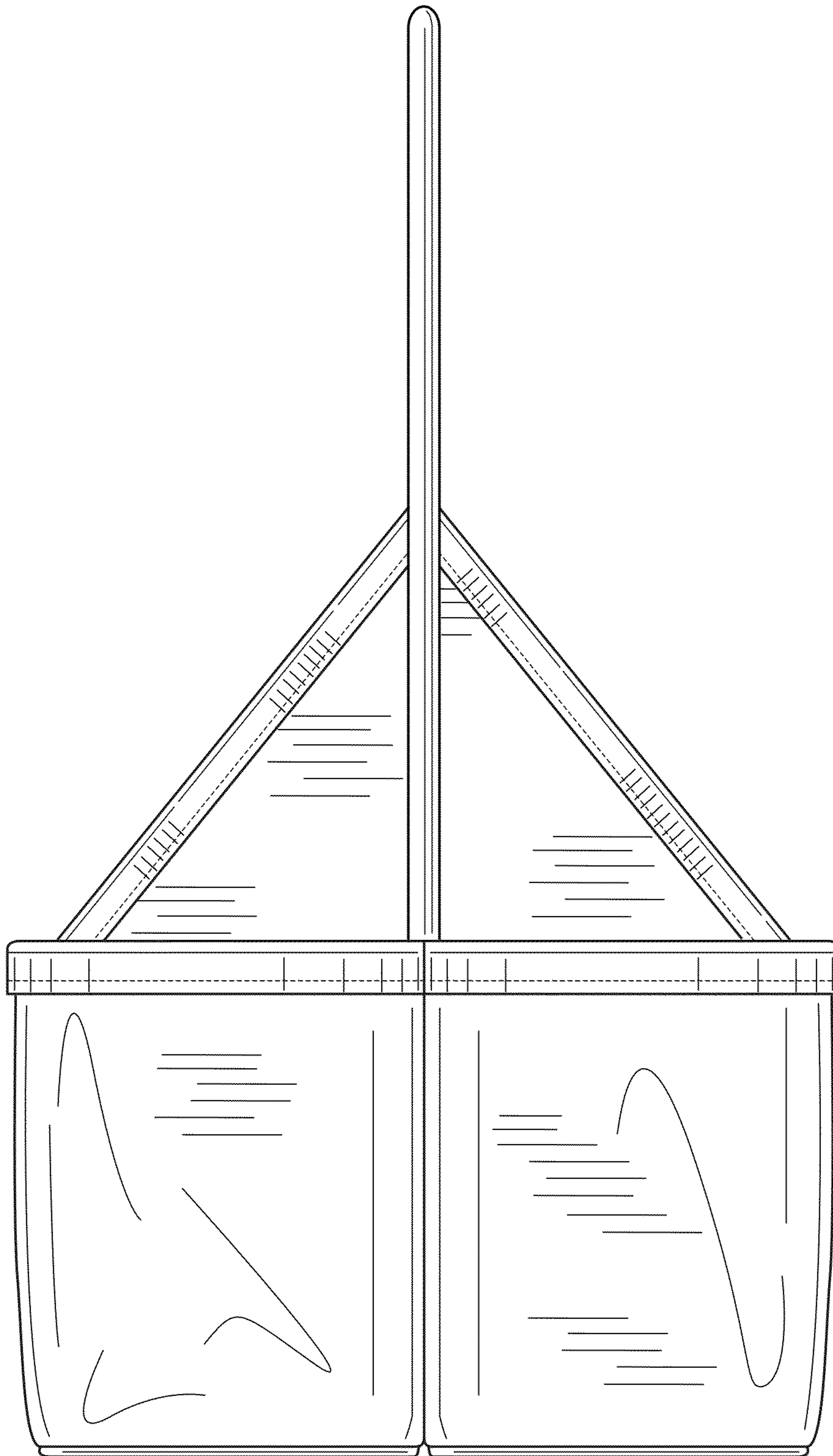

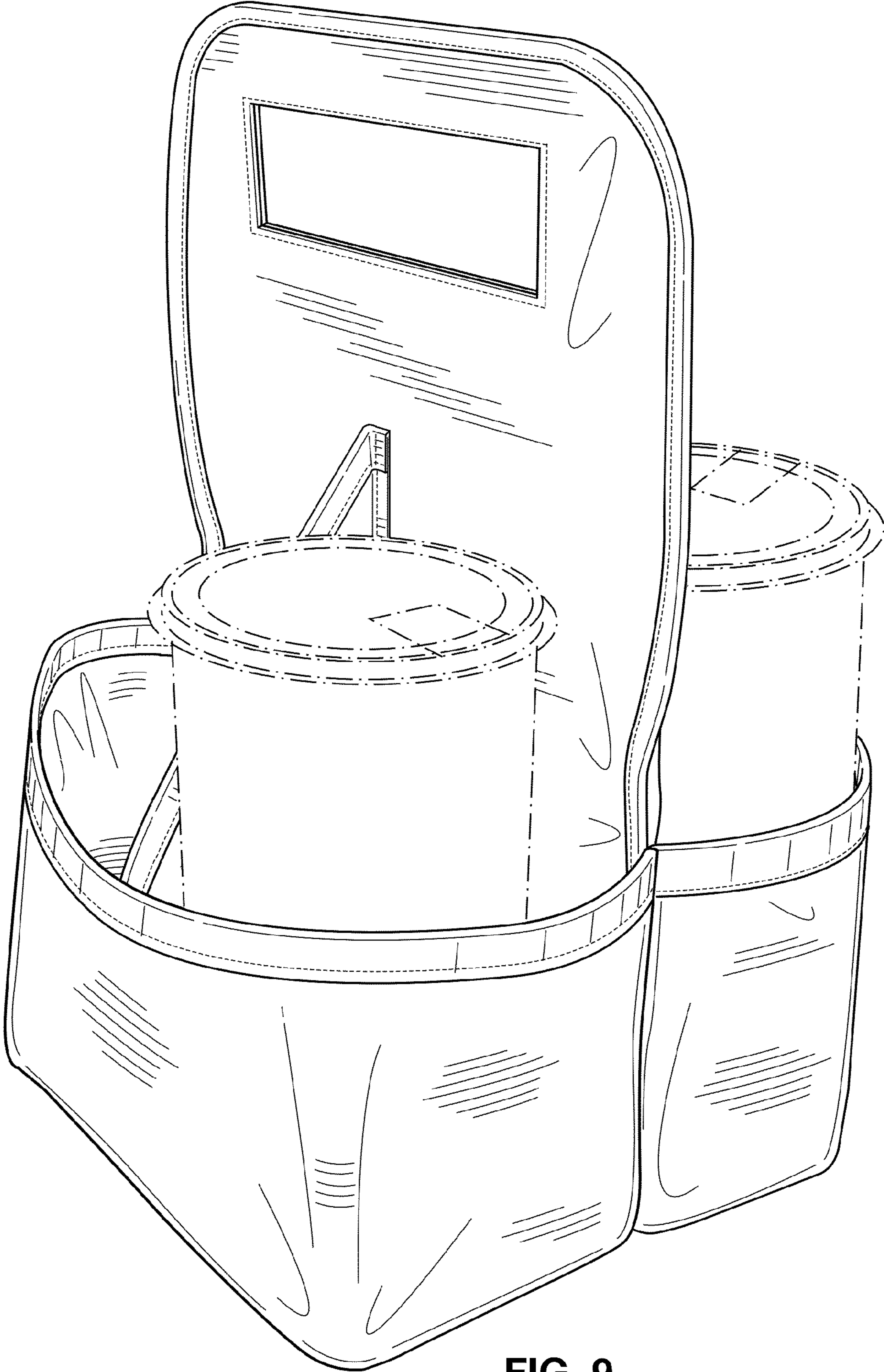
