The ornamental design for a luggage handle with tablet PC support, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the luggage handle with tablet PC support.

FIG. 2 is a right side view of the luggage handle.

FIG. 3 is a left side view of the luggage handle, showing the opposite side from FIG. 2.

FIG. 4 is a top view of the luggage handle.

FIG. 5 is a bottom view of the luggage handle.

FIG. 6 is a front view of the luggage handle; and,

FIG. 7 is a back view of the luggage handle.

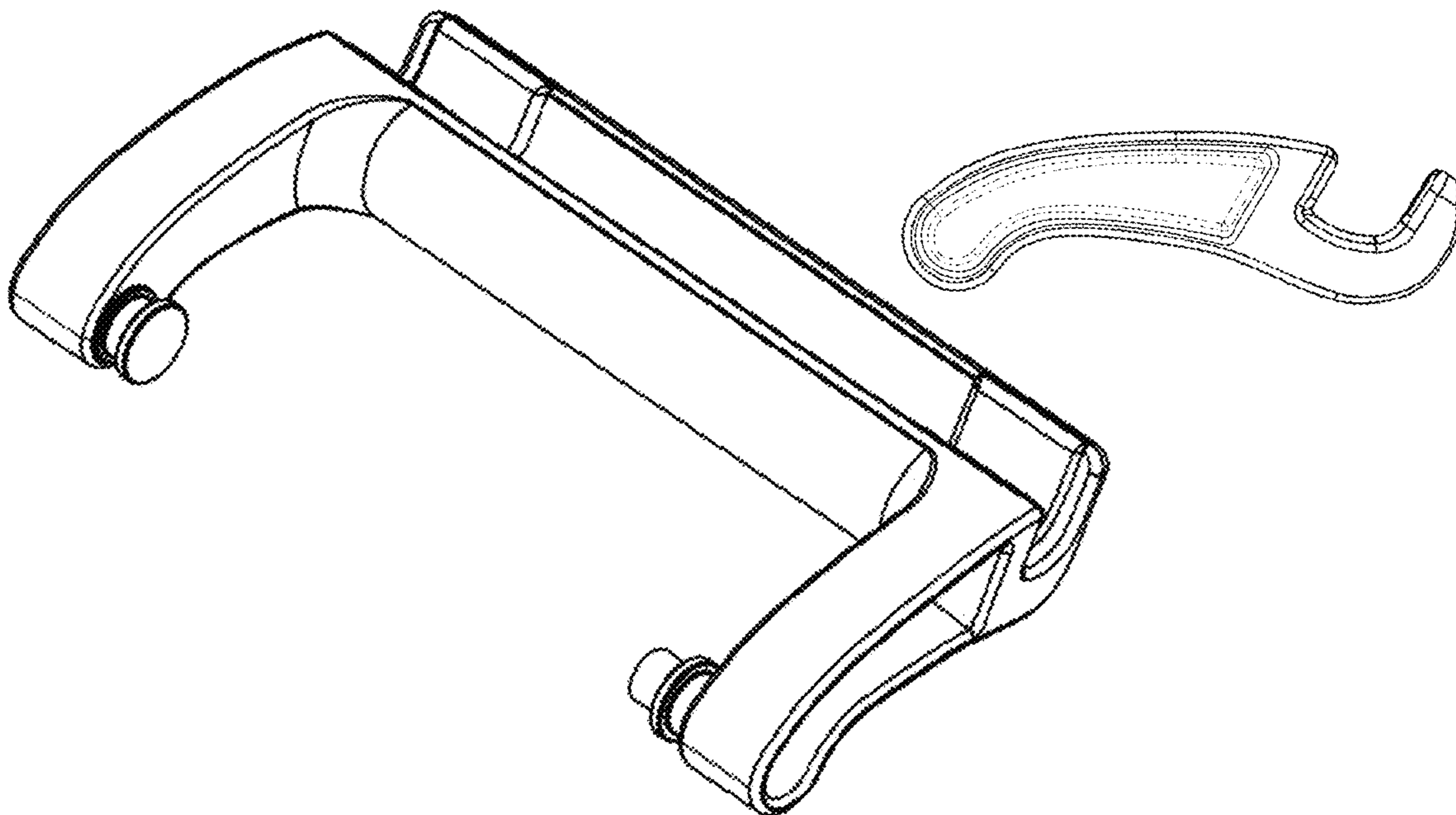

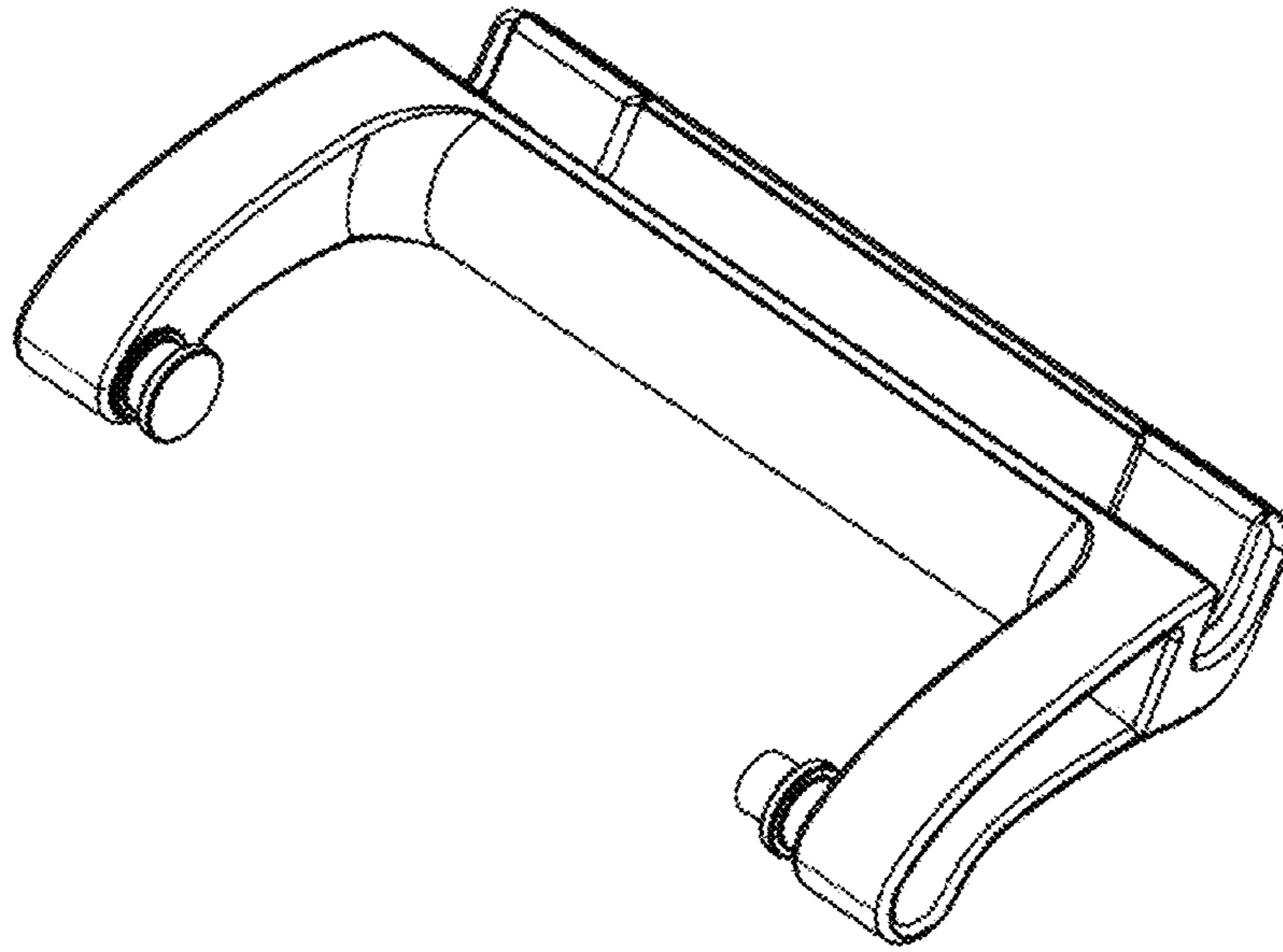

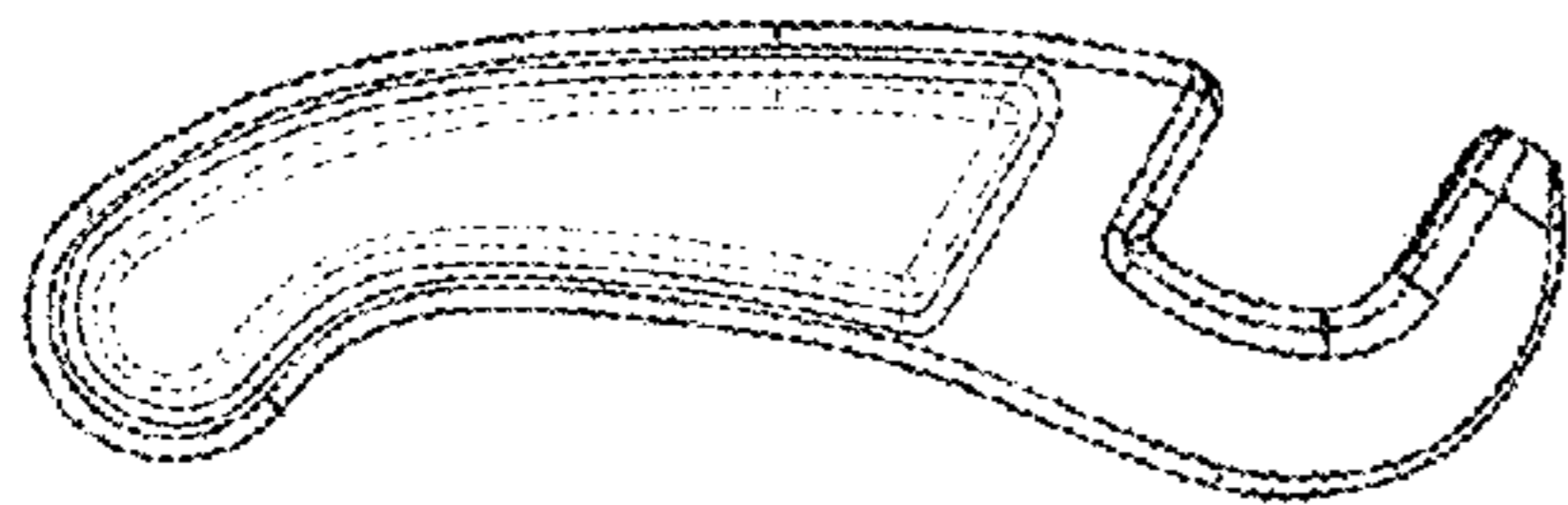

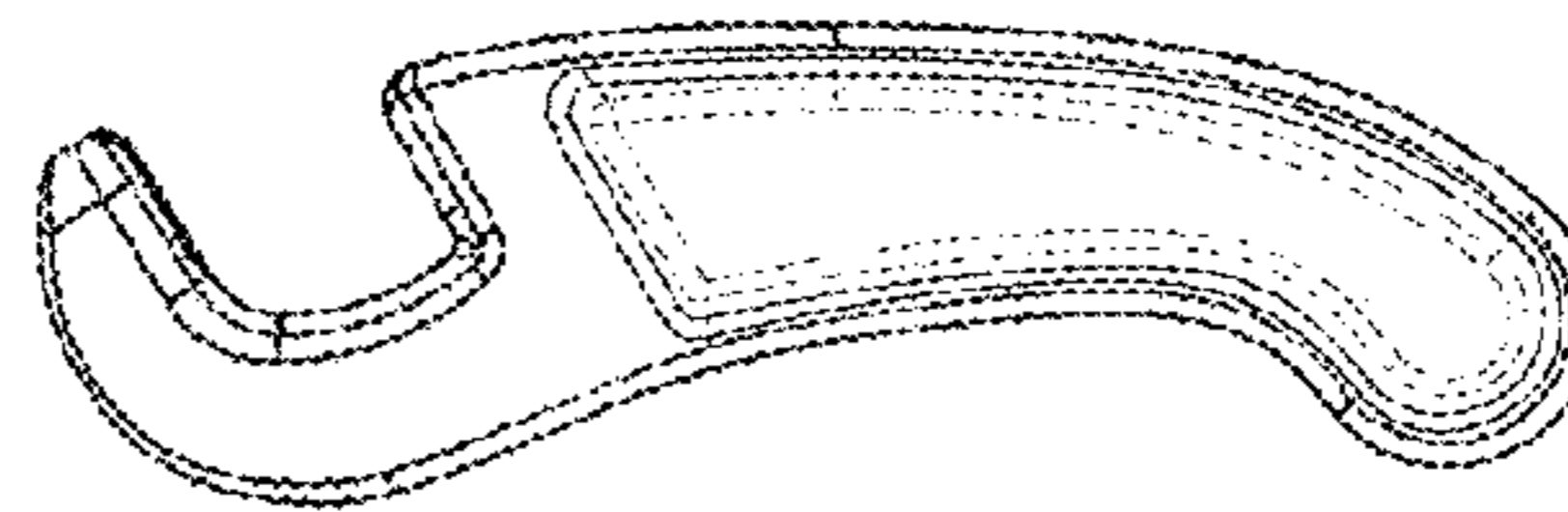

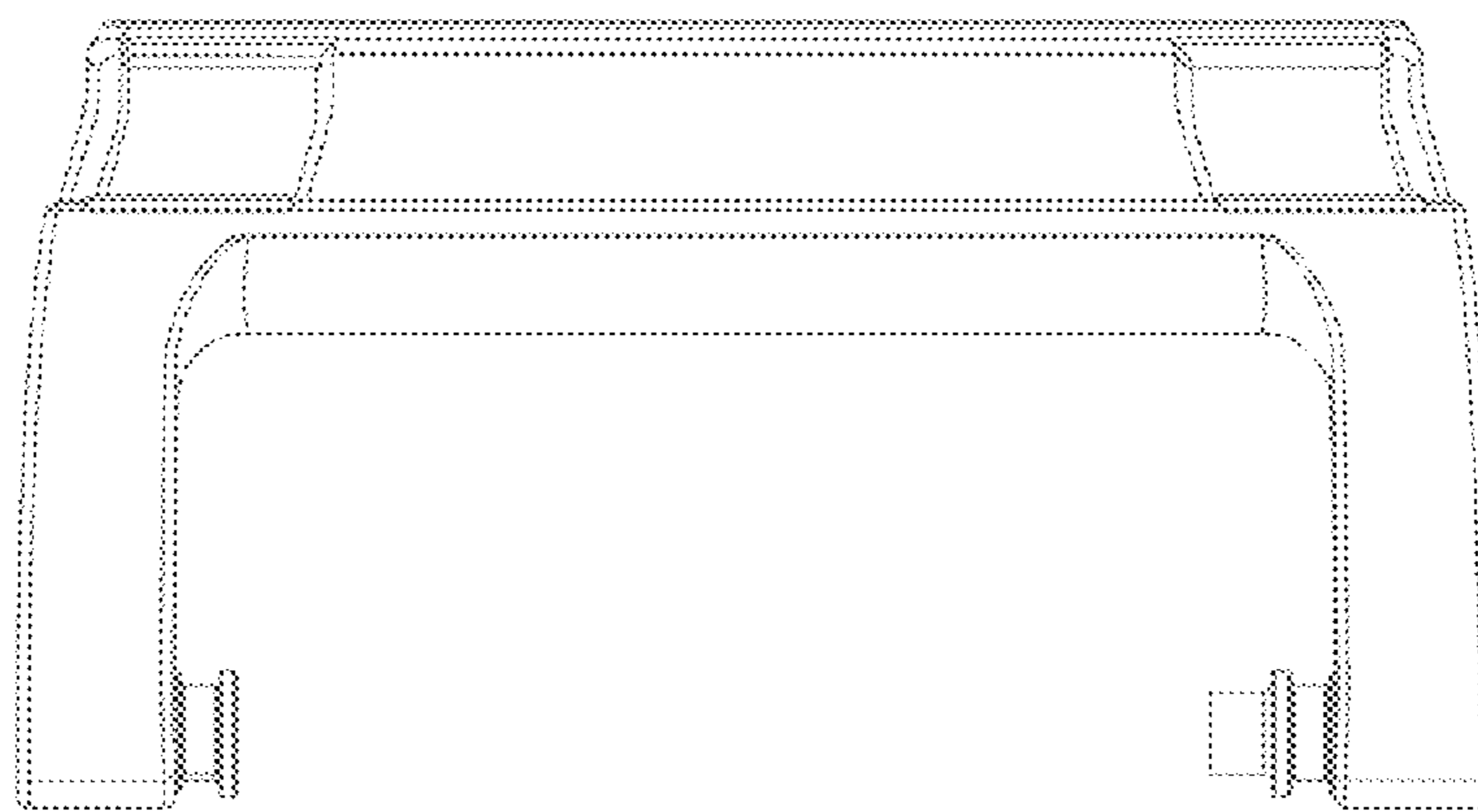

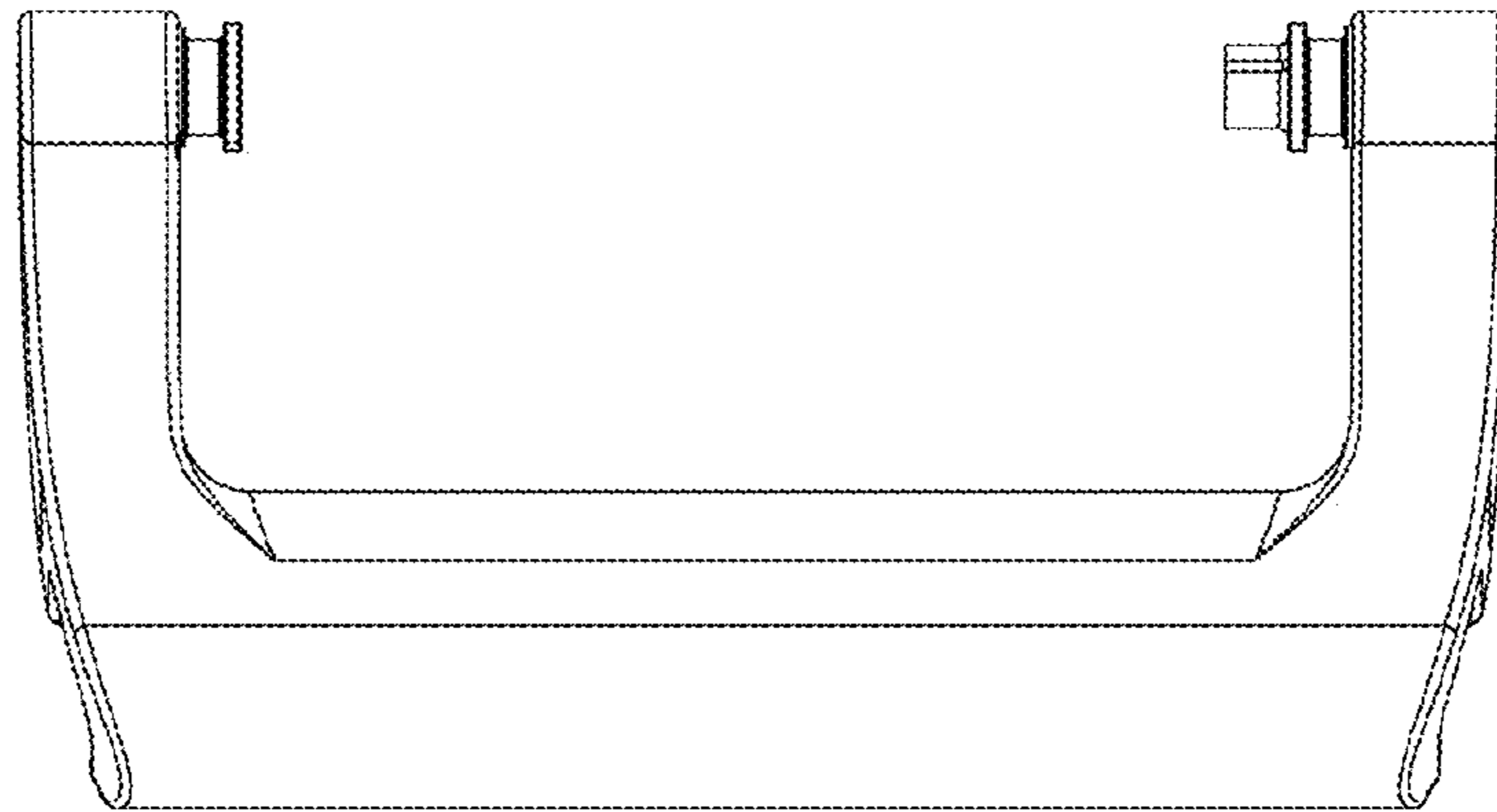

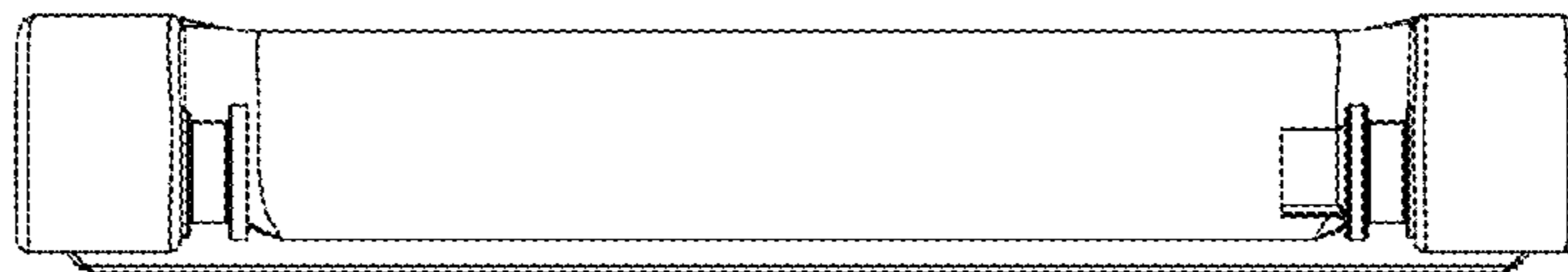
