FIG. 4 is a left side elevational view showing the design for the sander of FIG. 1;

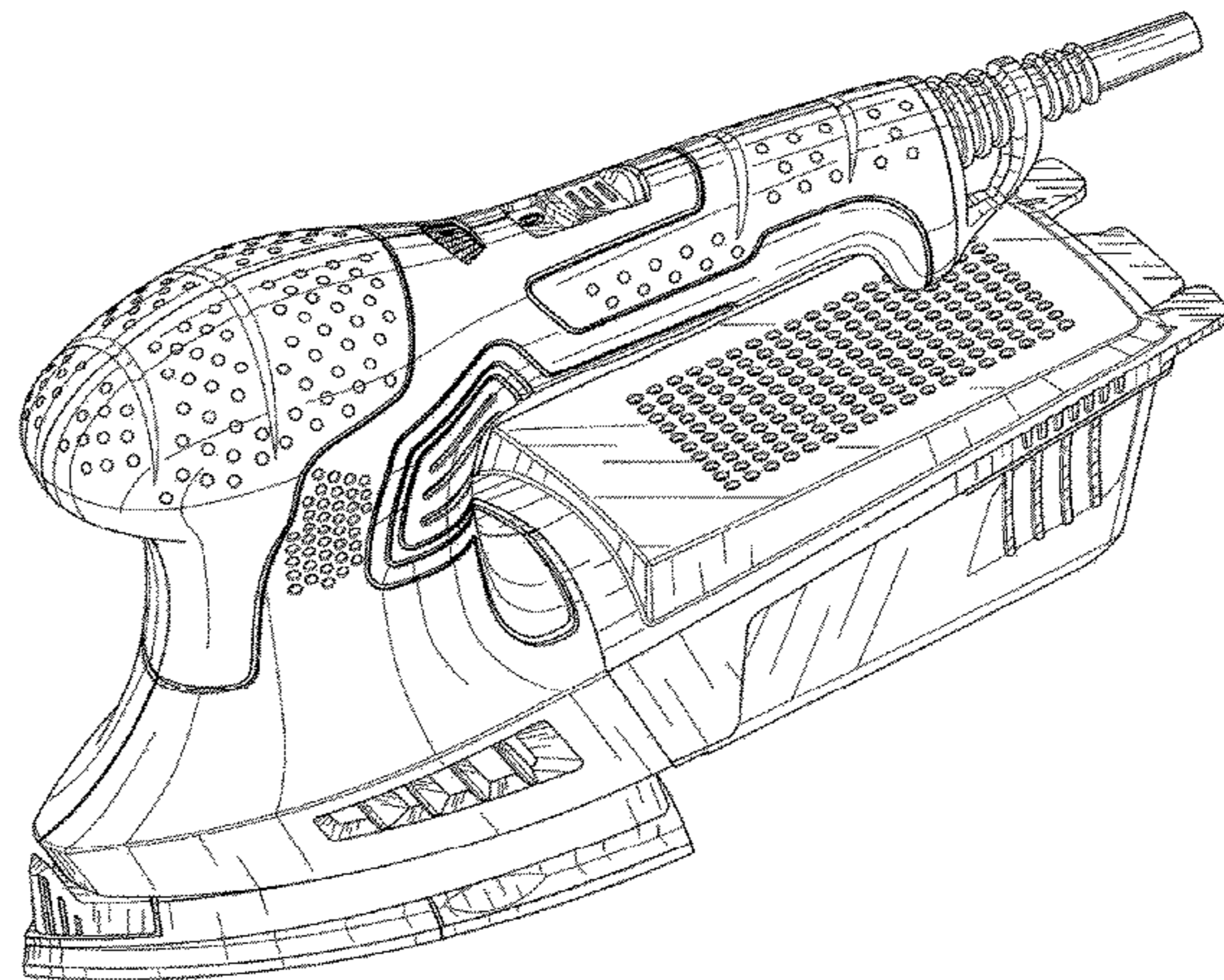
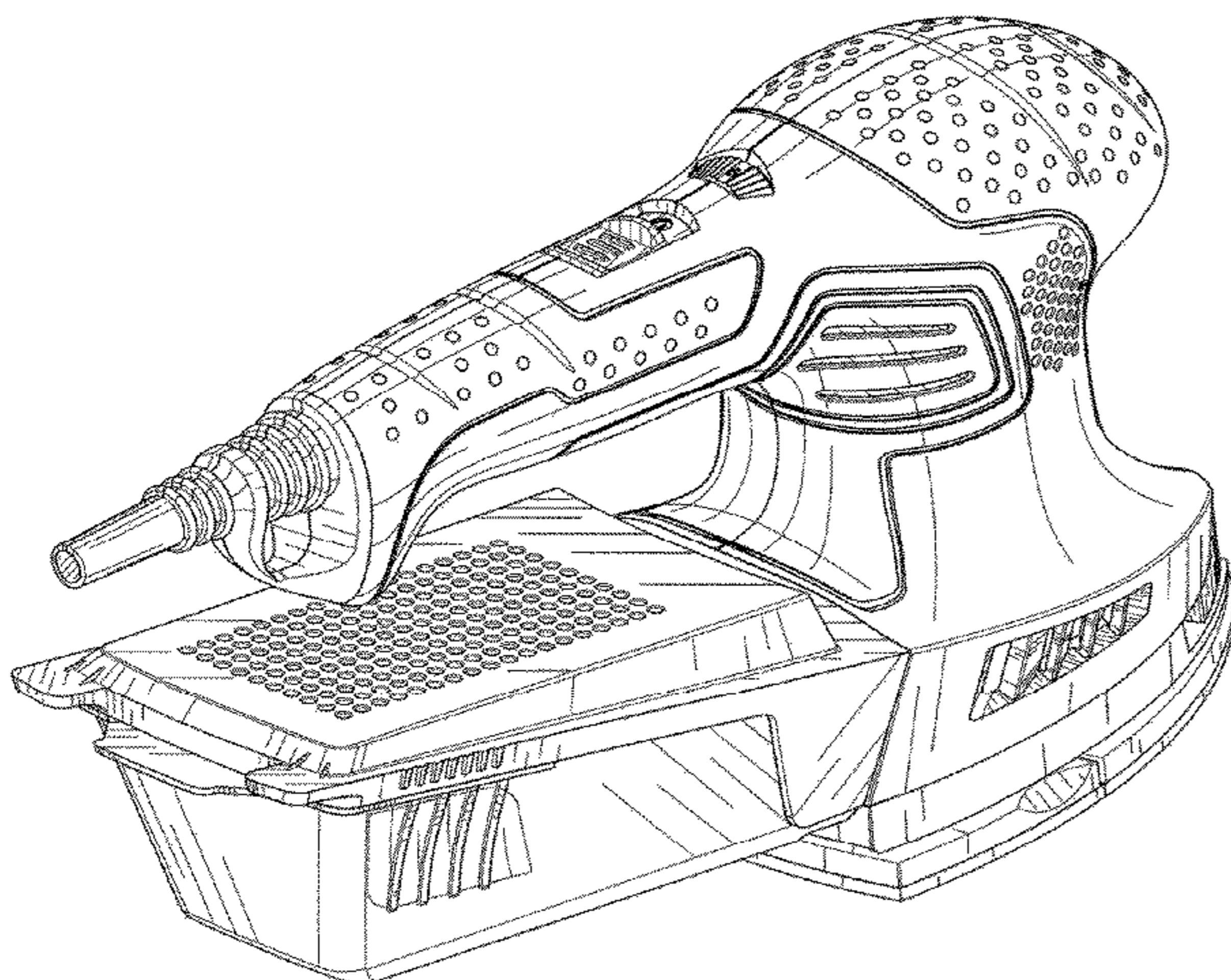
FIG. 5 is a rear elevational view showing the design for the sander of FIG. 1;

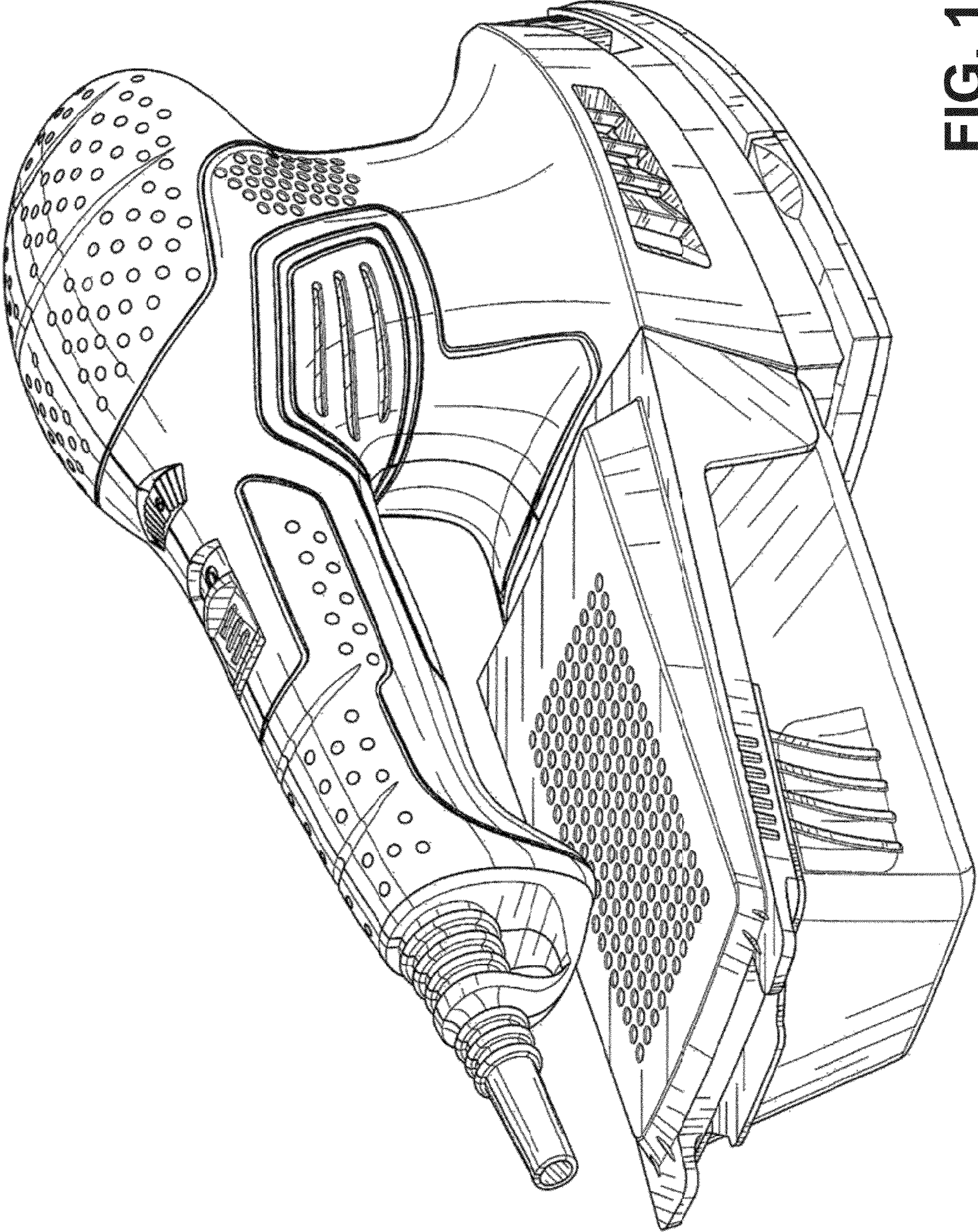

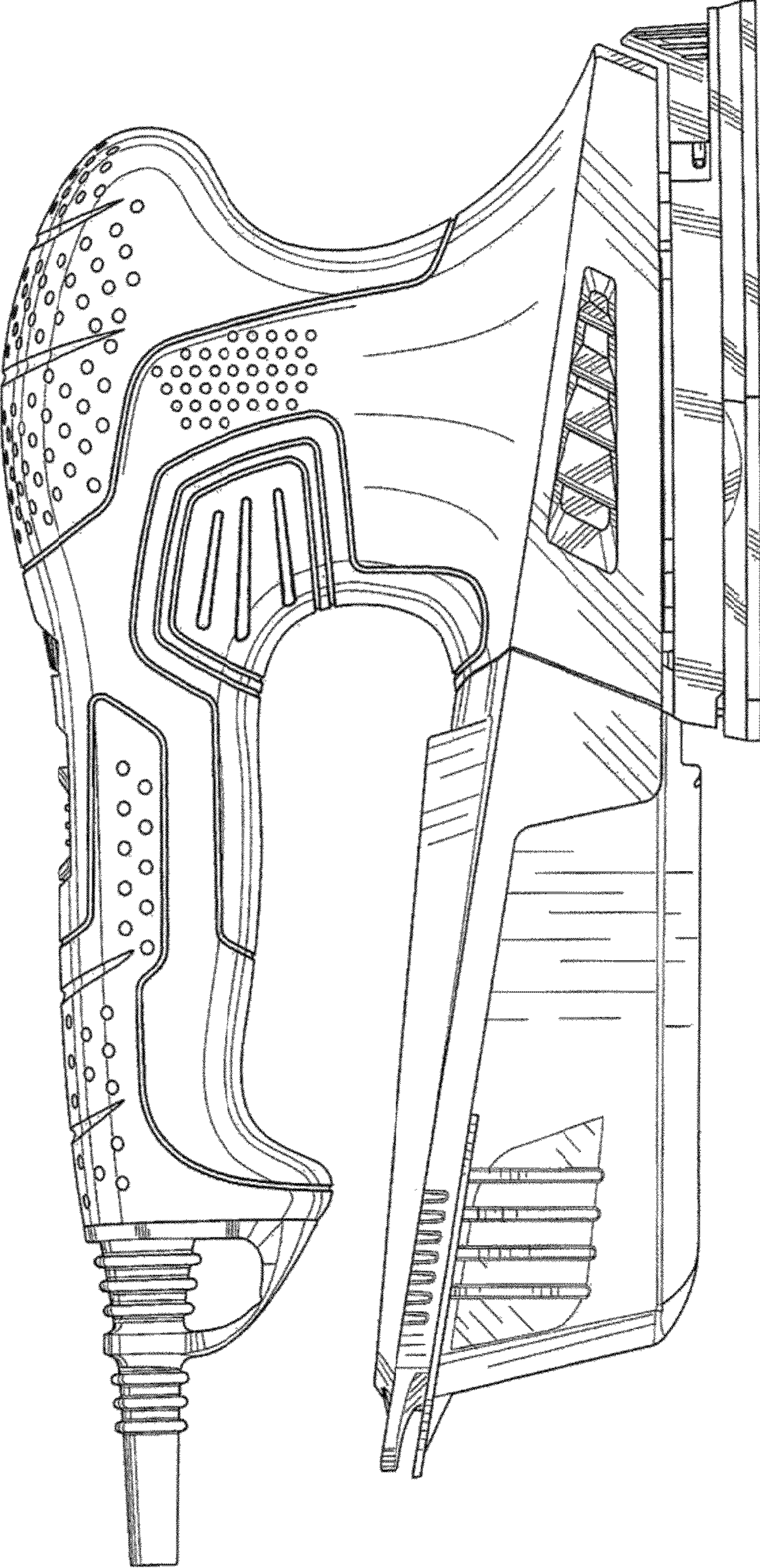
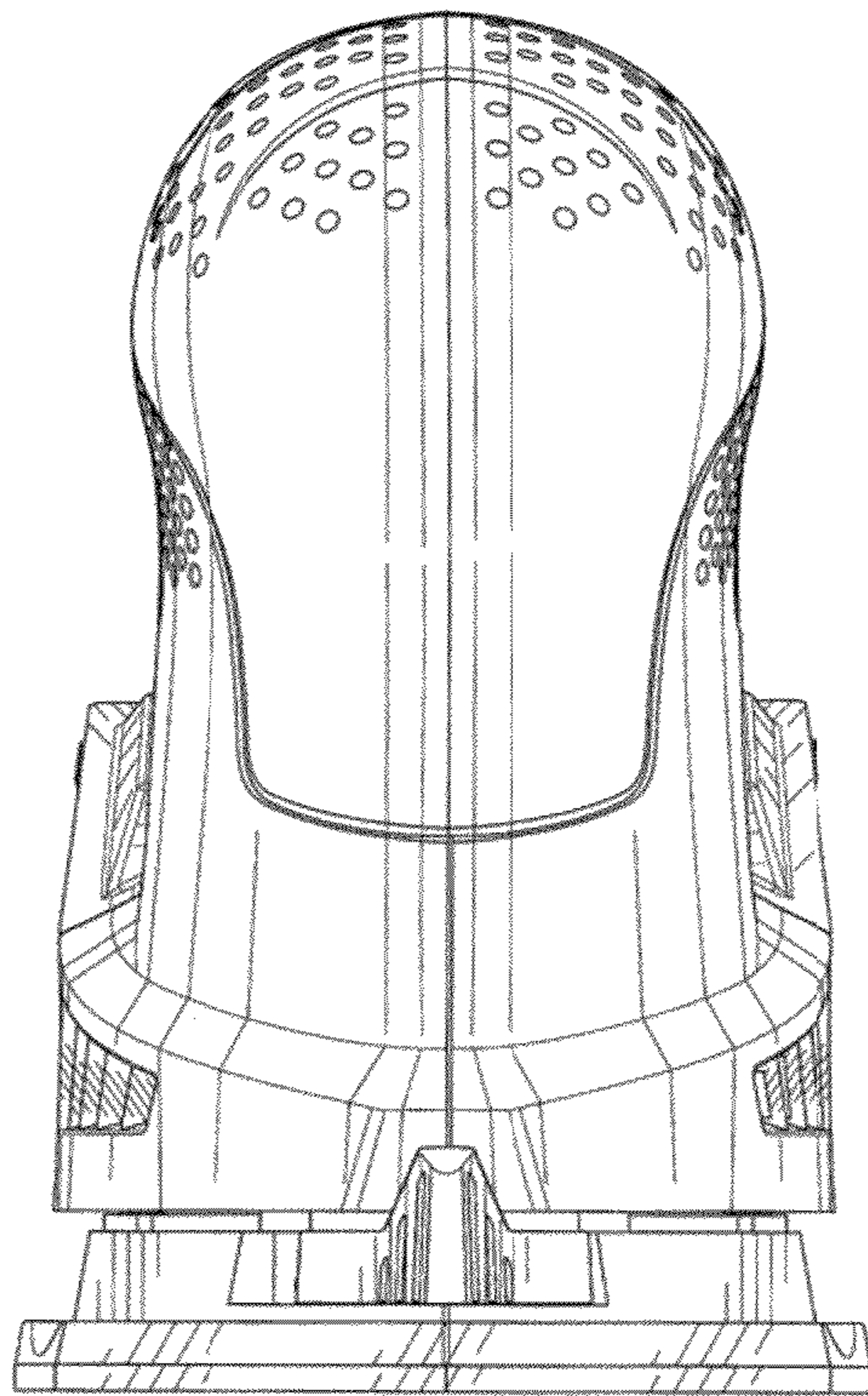

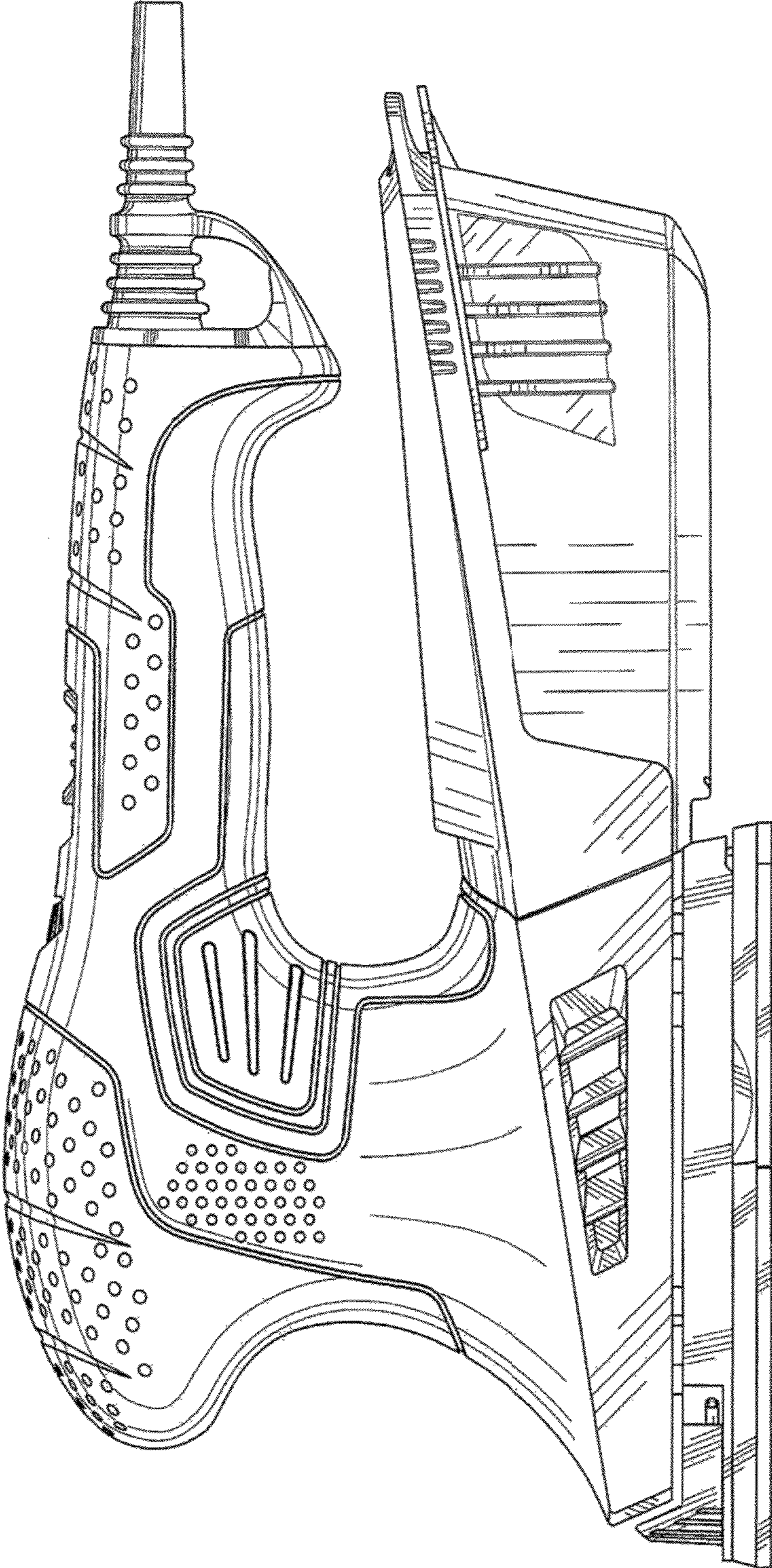
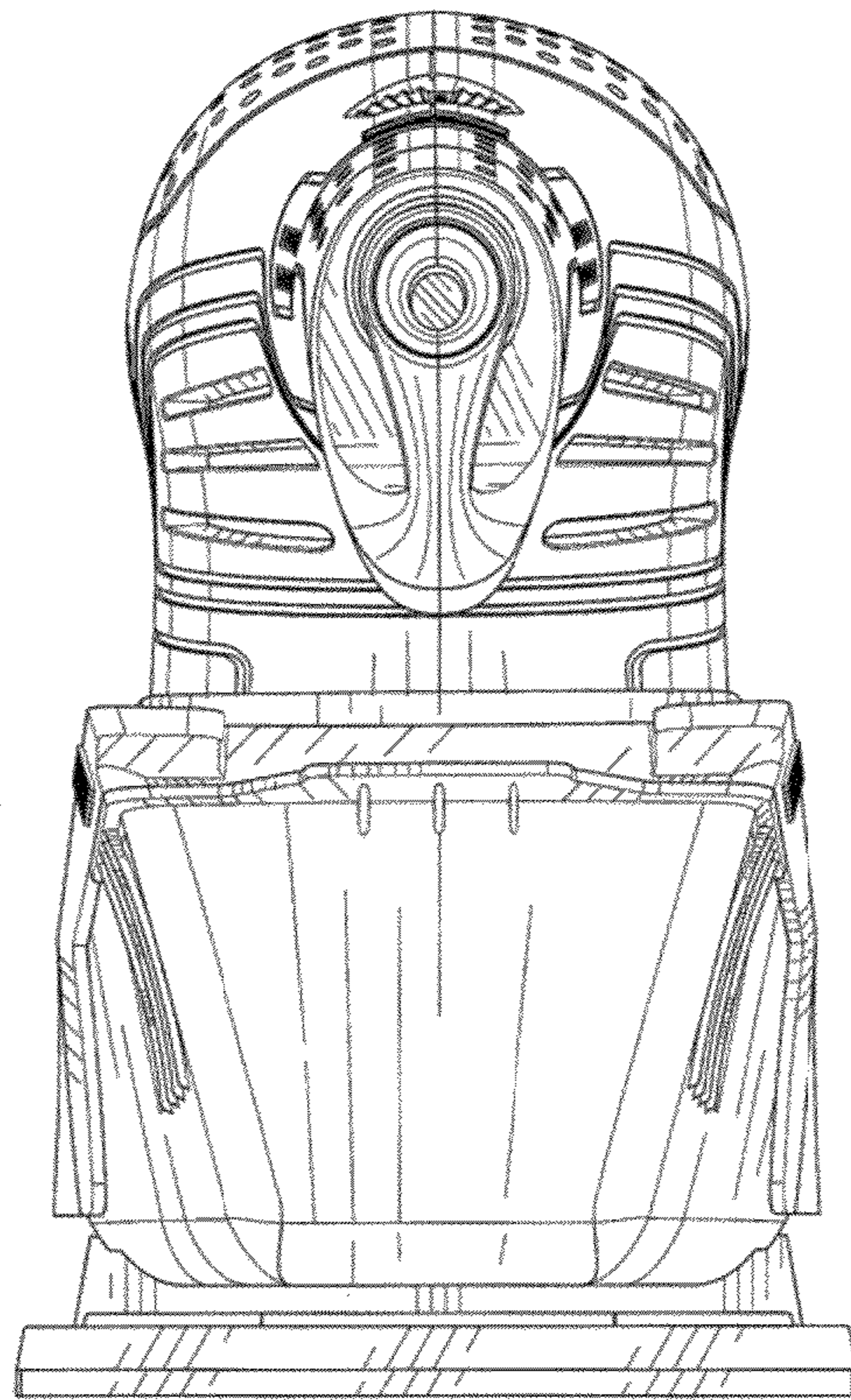

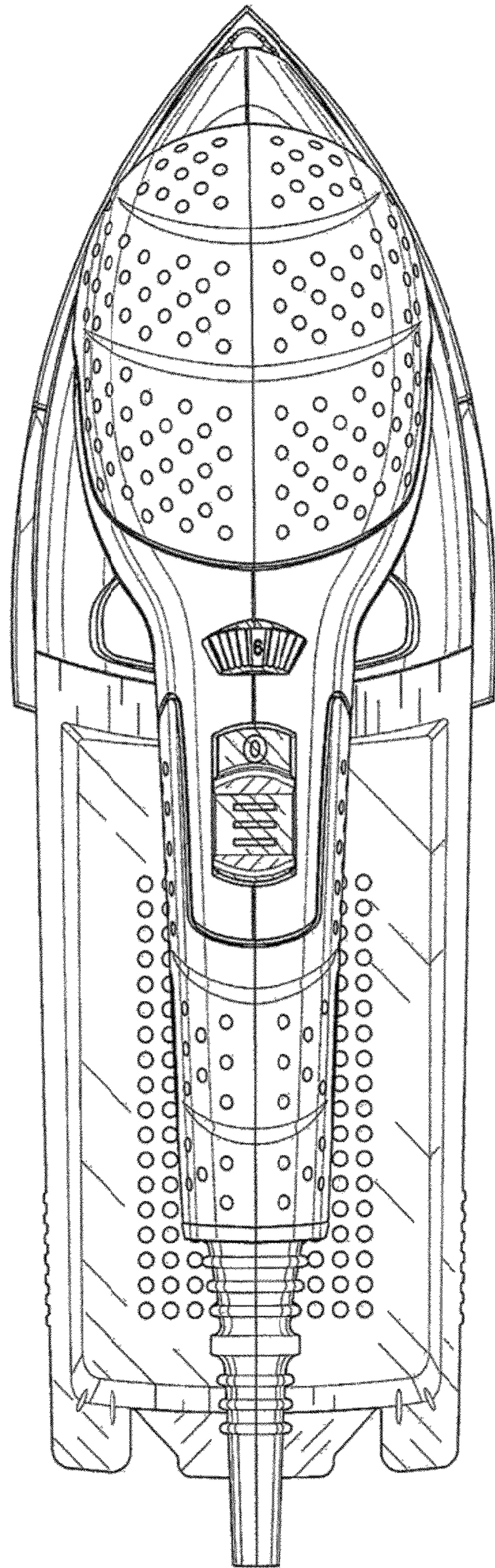

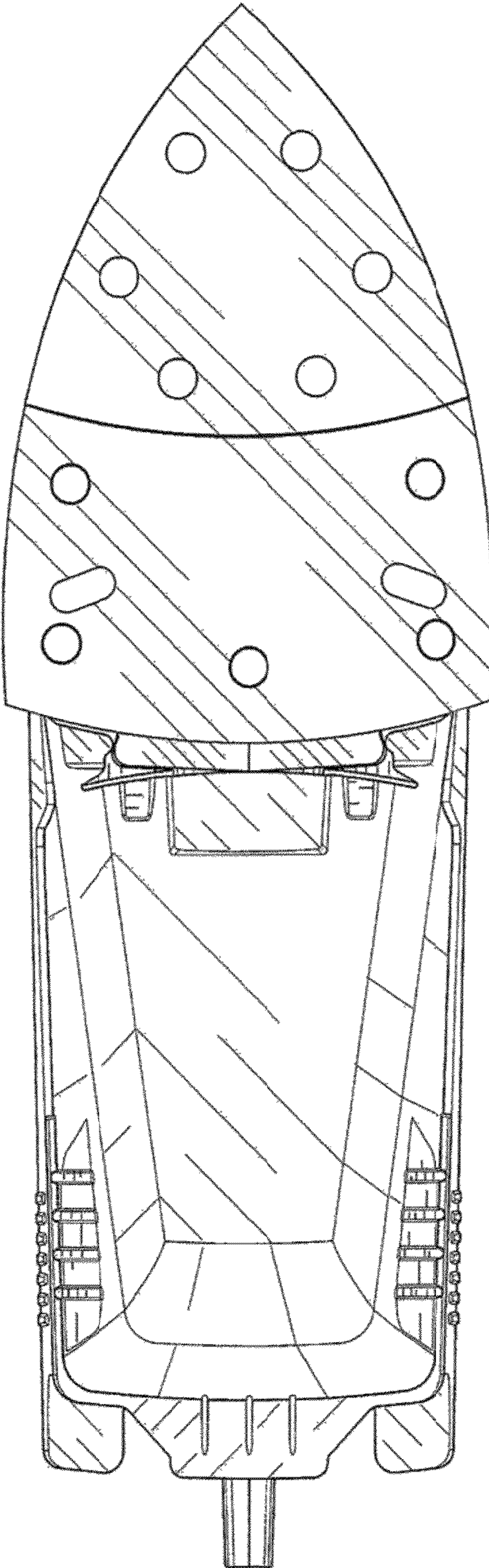

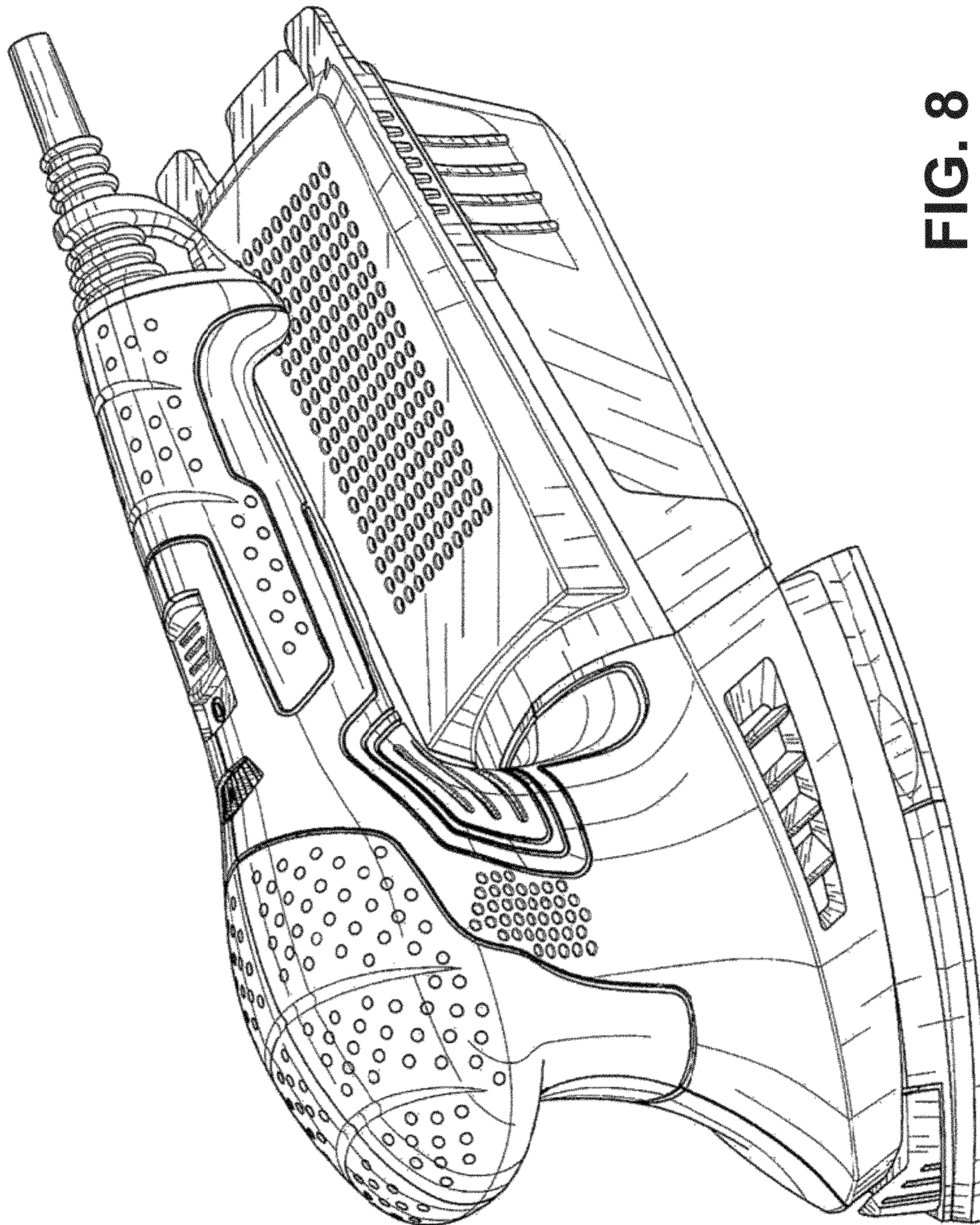
