(57) **CLAIM**

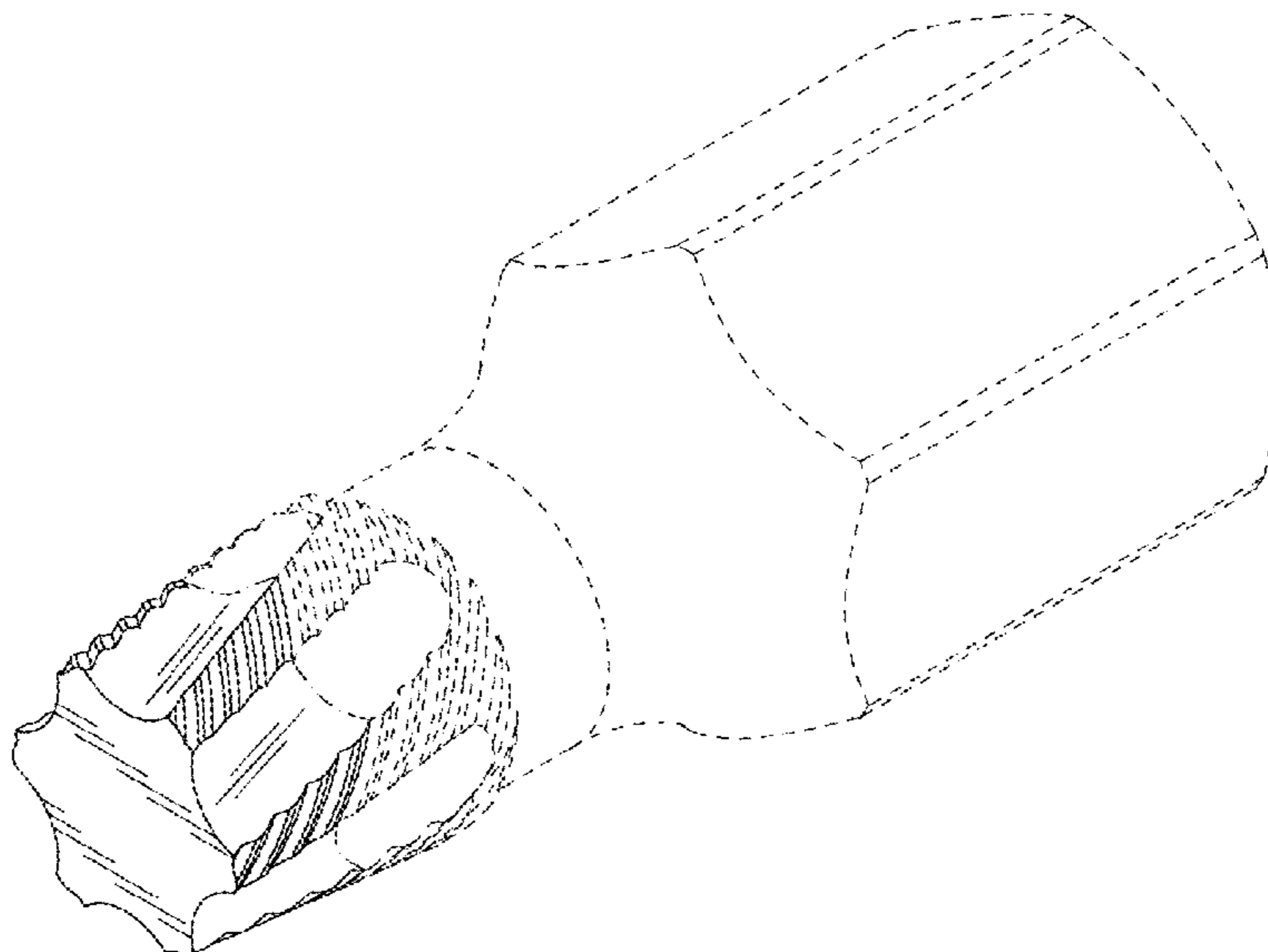
The ornamental design for a removal tool, as shown and described.

DESCRIPTION

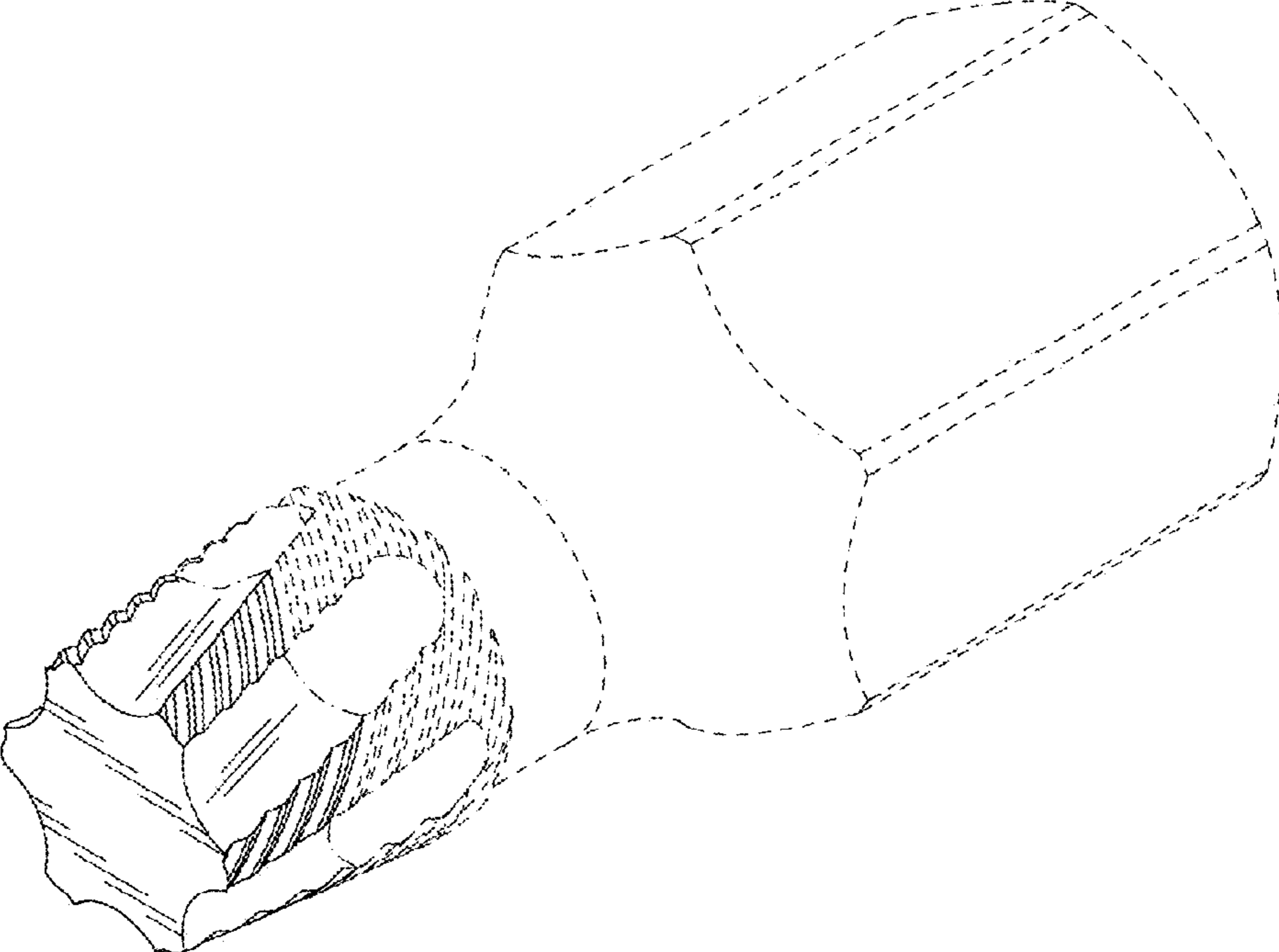

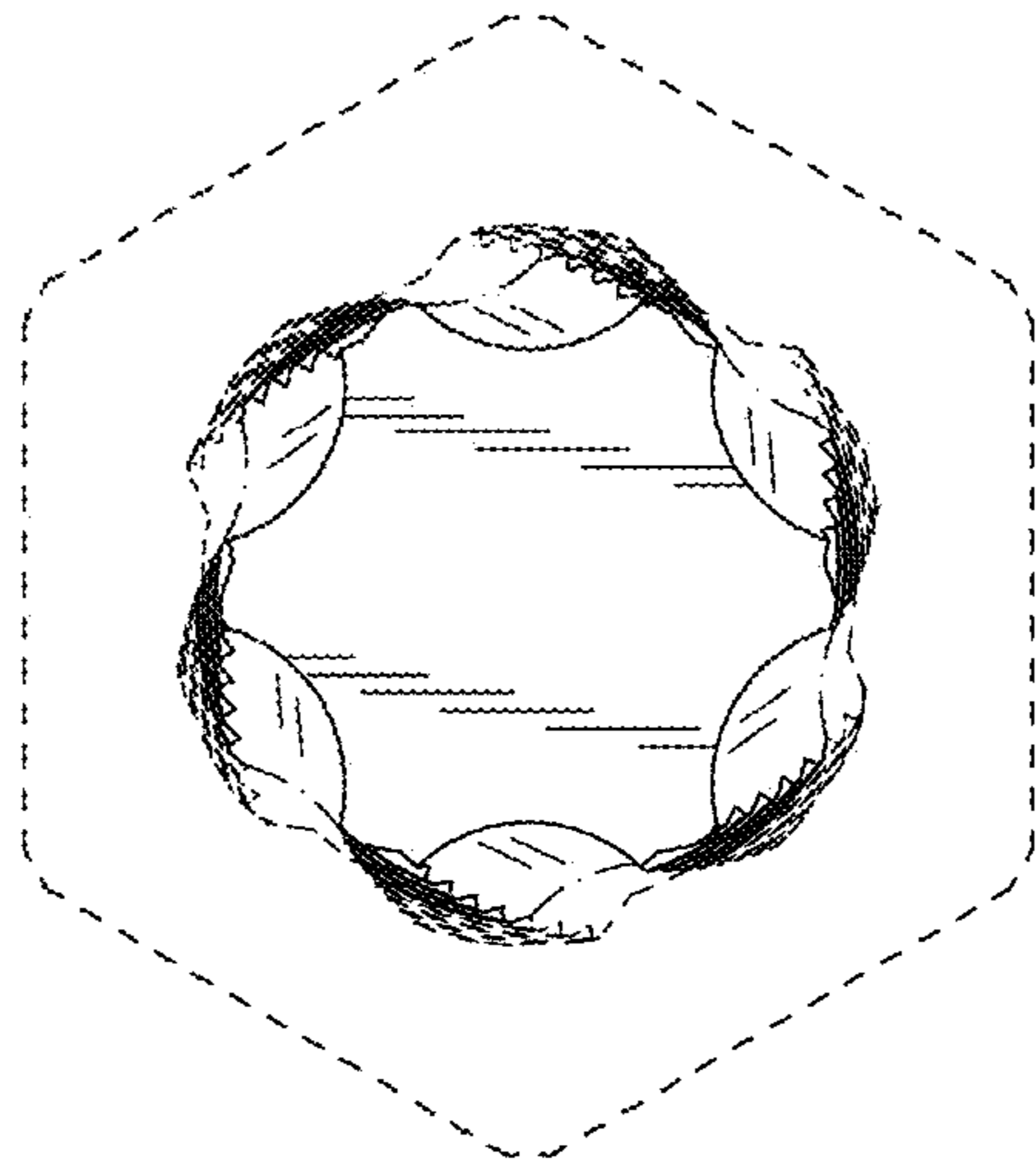

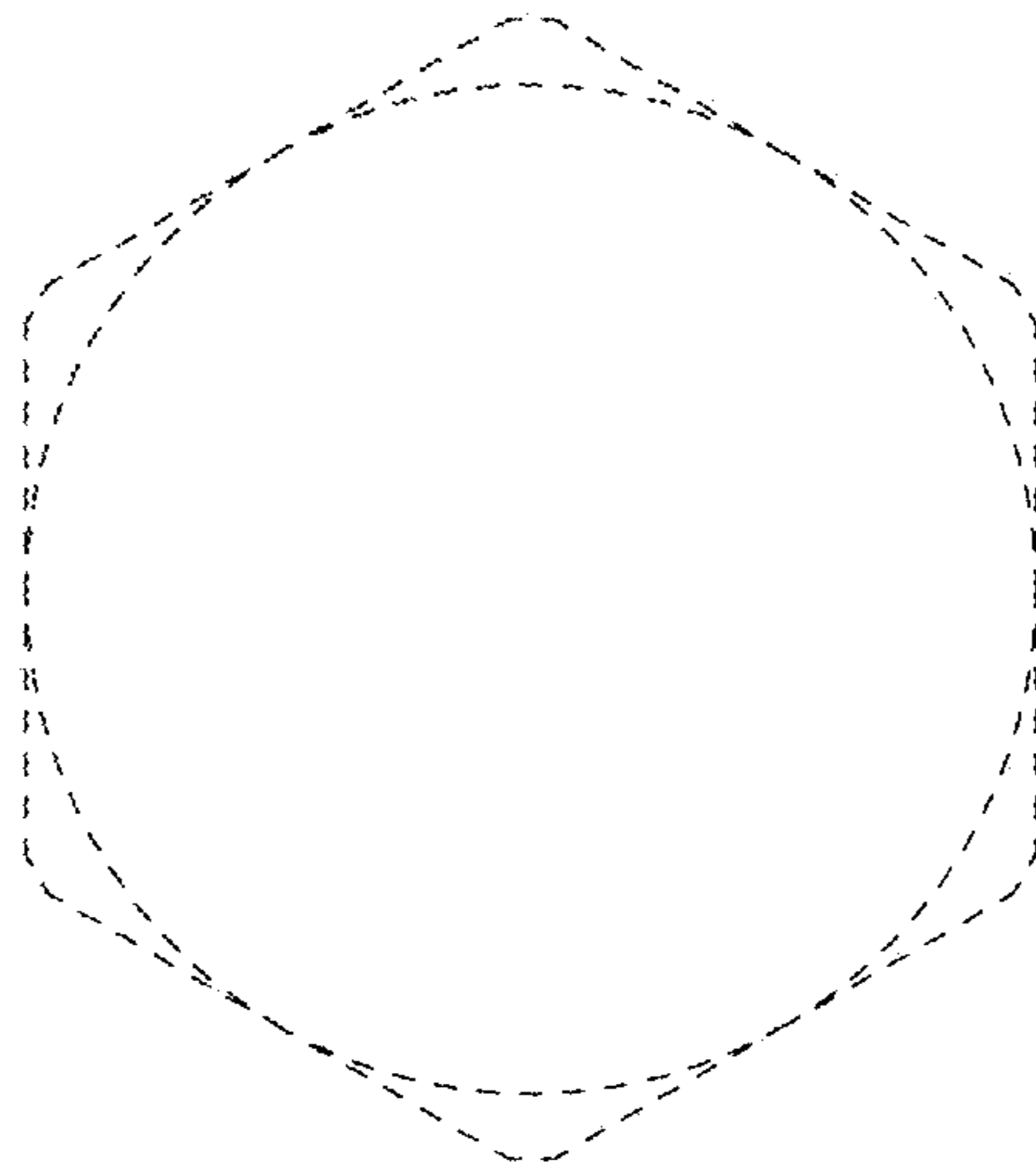

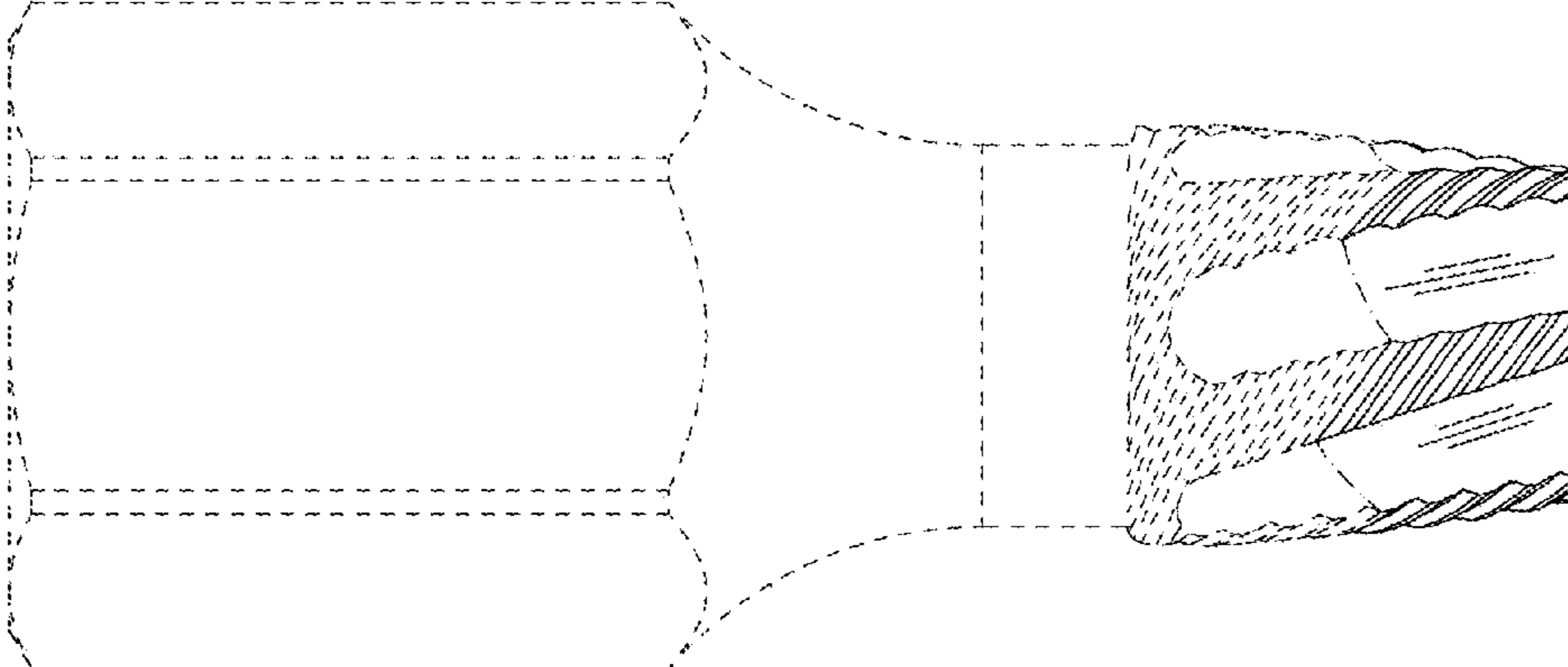

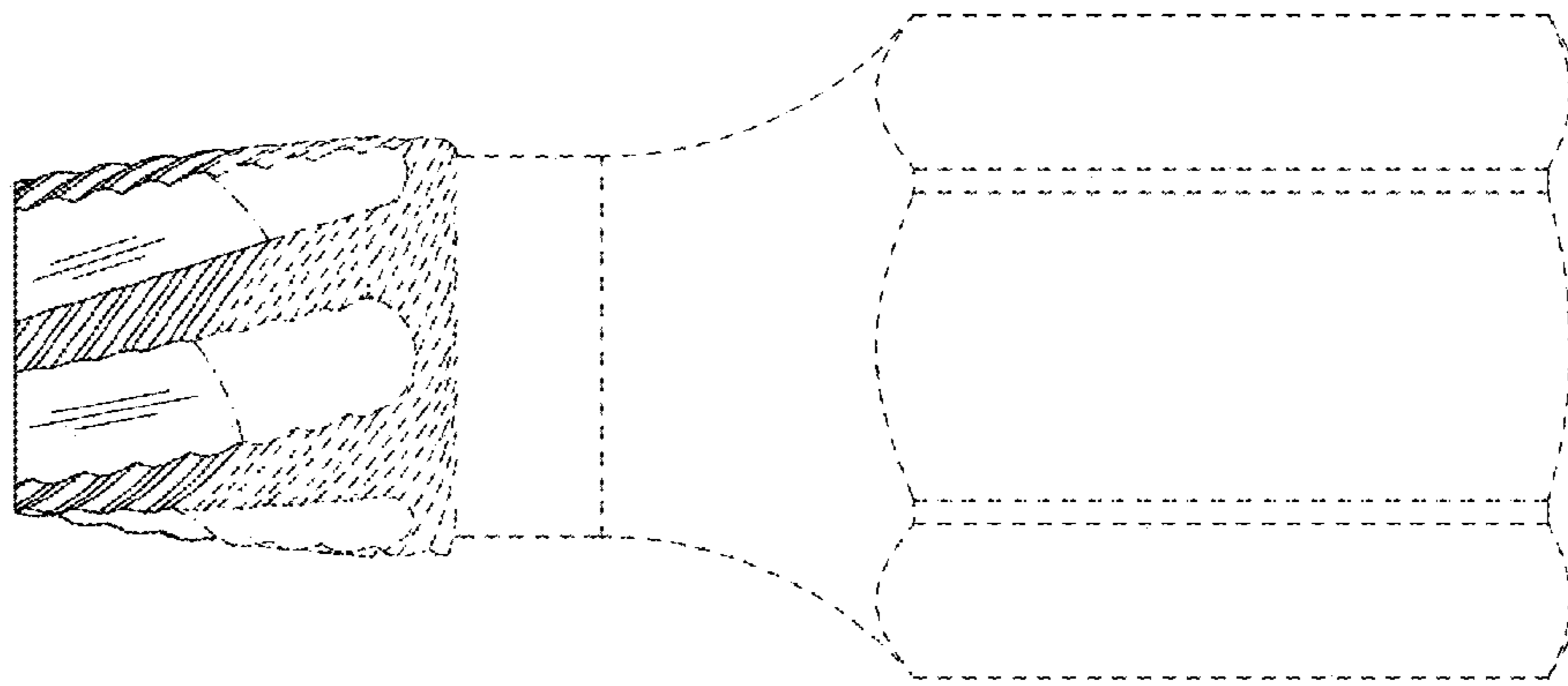

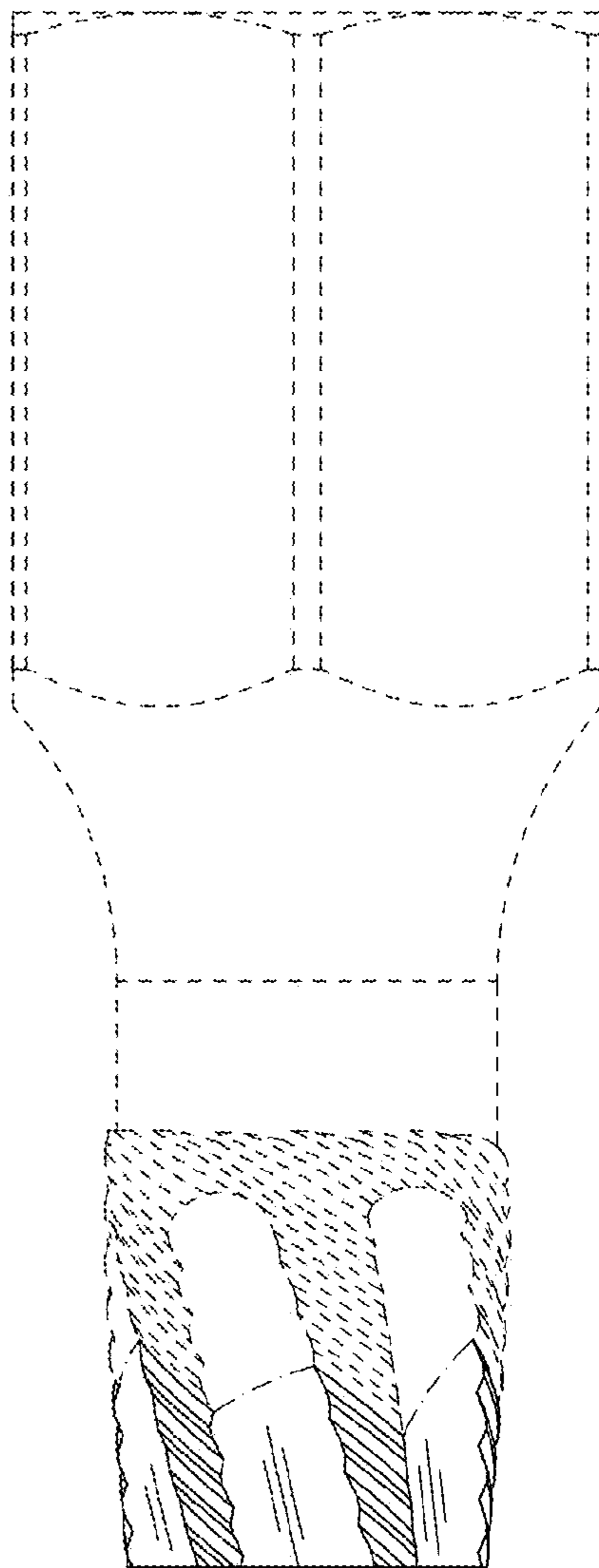

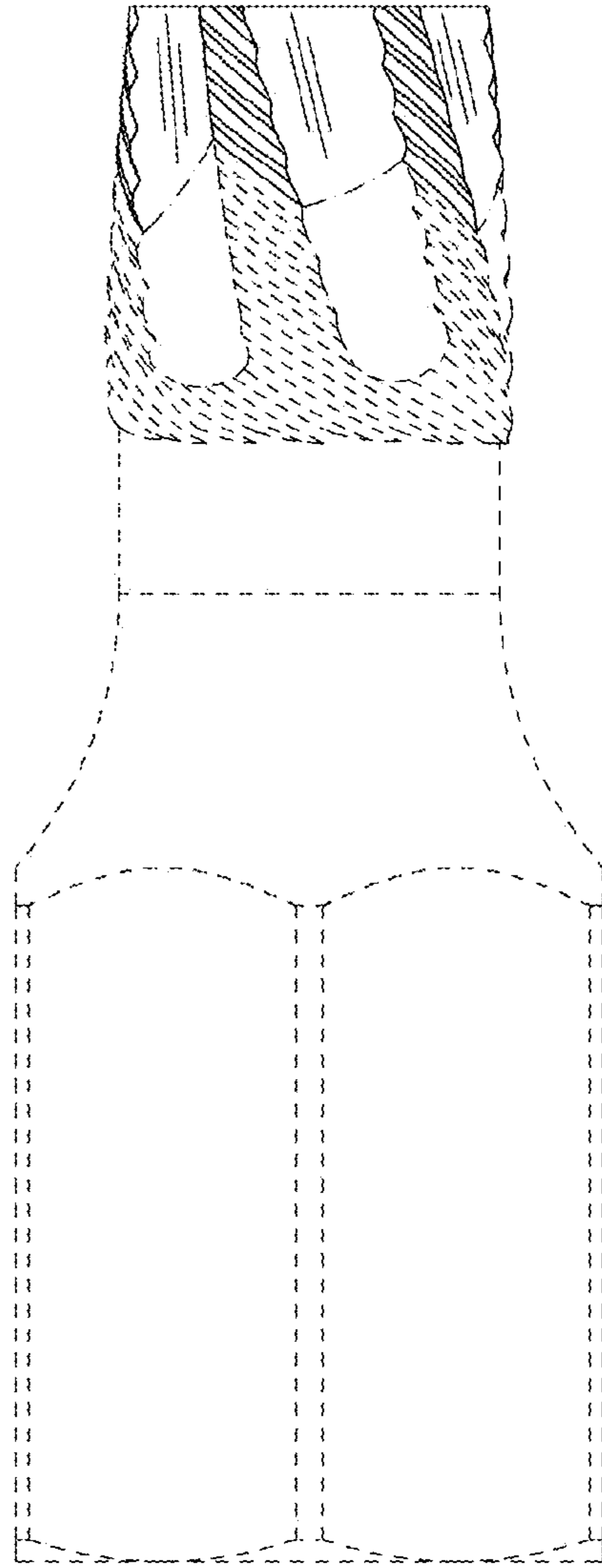
