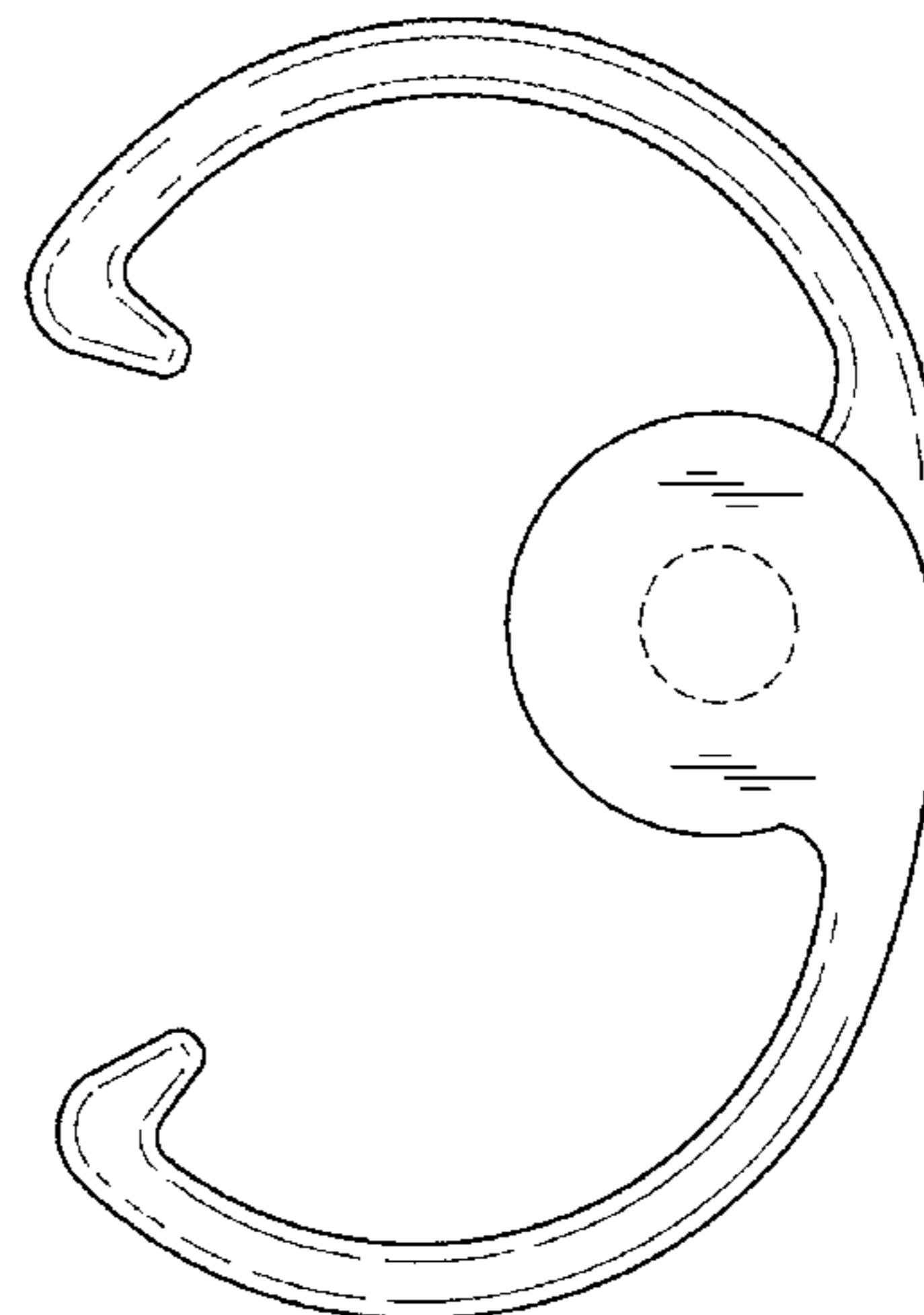
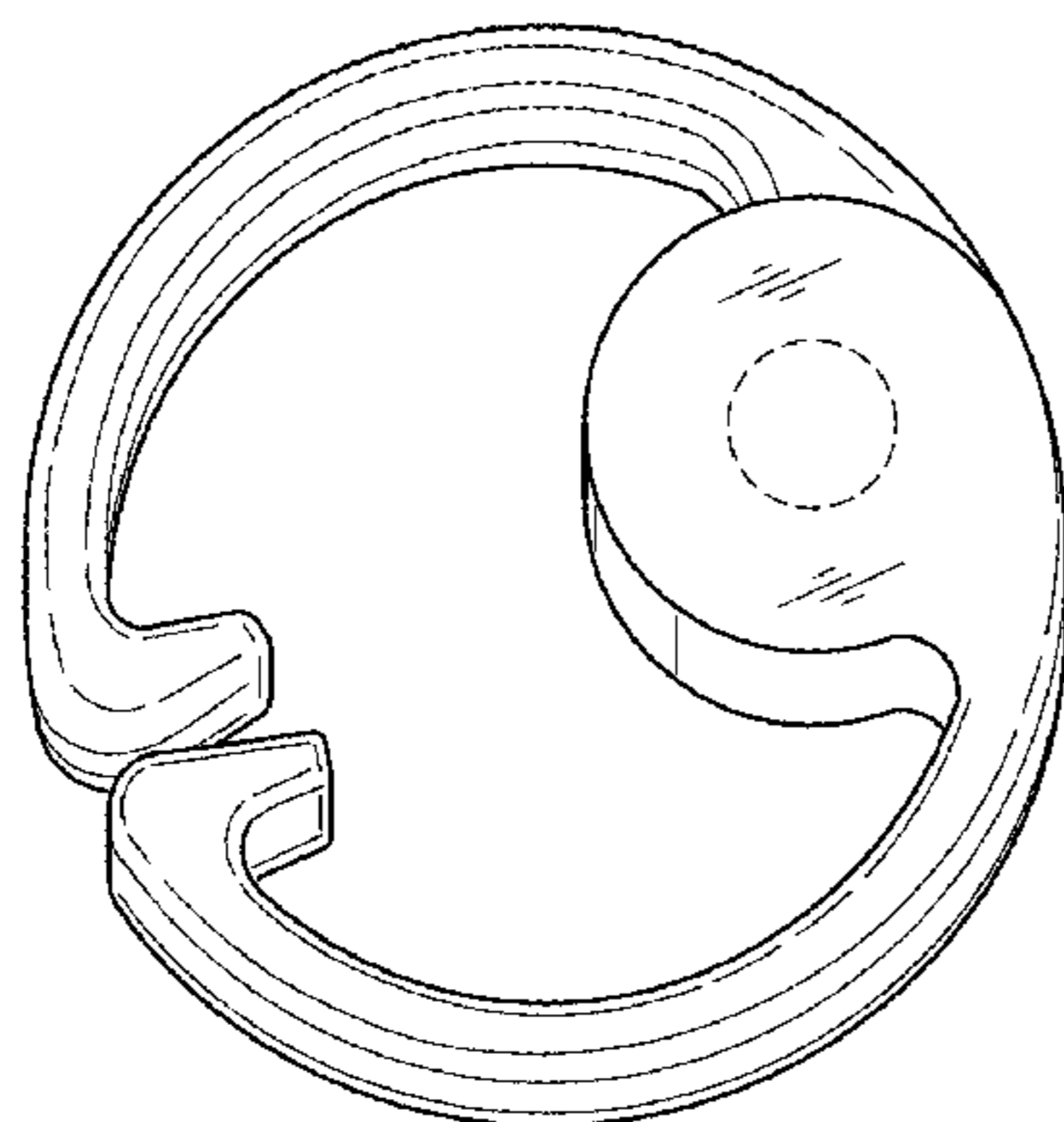
(57) **CLAIM**

The ornamental design for a purse or bag strap clamp, substantially as shown and described.

FIG. 1 is a front perspective view of a purse or bag strap clamp, showing the novel design in a closed position; FIG. 2 is a rear perspective view of the purse or bag strap clamp as shown in FIG. 1; FIG. 3 is a rear view of the purse or bag strap clamp shown in FIG. 1; FIG. 4 is a front view of the purse or bag strap clamp shown in FIG. 1; FIG. 5 is a side view of the purse or bag strap clamp as shown in FIG. 1; FIG. 6 is a side view of the purse or bag strap clamp as shown in FIG. 1 that is opposite of the side view in FIG. 5; FIG. 7 is a top view of the purse or bag strap clamp as shown in FIG. 1; FIG. 8 is a bottom view of the purse or bag strap clamp as shown in FIG. 1; FIG. 9 is a front perspective view of the purse or bag strap clamp, showing the novel design in a partially open position; FIG. 10 is a rear view of the purse or bag strap clamp as shown in FIG. 9; FIG. 11 is a rear view of the purse or bag strap clamp, showing the novel design in a fully open position; FIG. 12 is a front perspective view of an alternative embodiment of the purse or bag strap clamp, showing the novel design in a closed position; FIG. 13 is a rear perspective view of the purse or bag strap clamp as shown in FIG. 12; FIG. 14 is a rear view of the purse or bag strap clamp shown in FIG. 12; FIG. 15 is a front view of the purse or bag strap clamp shown in FIG. 12; FIG. 16 is a front perspective view of the alternate embodiment shown in a partially open position; FIG. 17 is a rear view of the alternate embodiment shown in a partially open position; and, FIG. 18 is a rear view of the alternate embodiment shown in a fully open position.

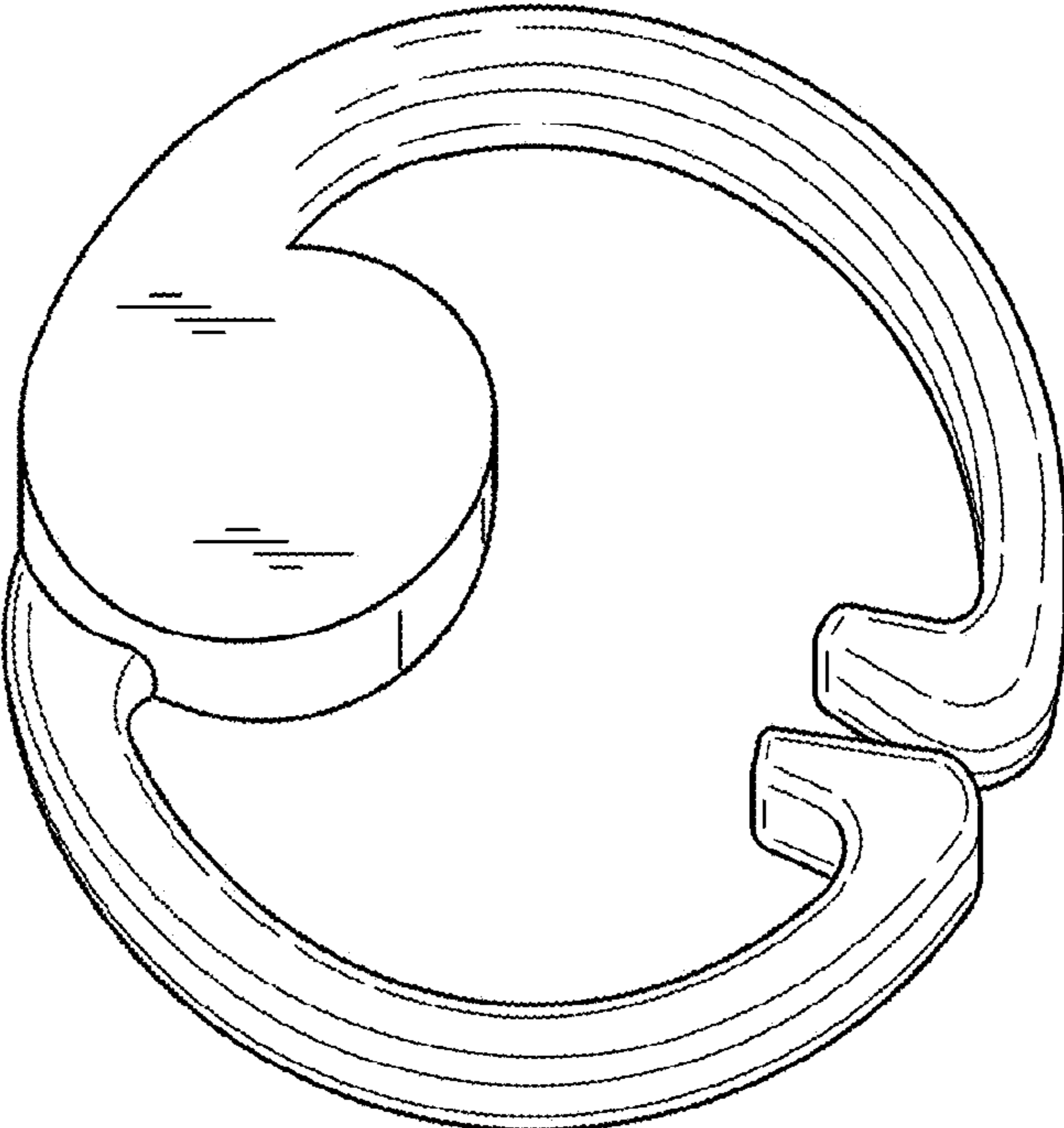

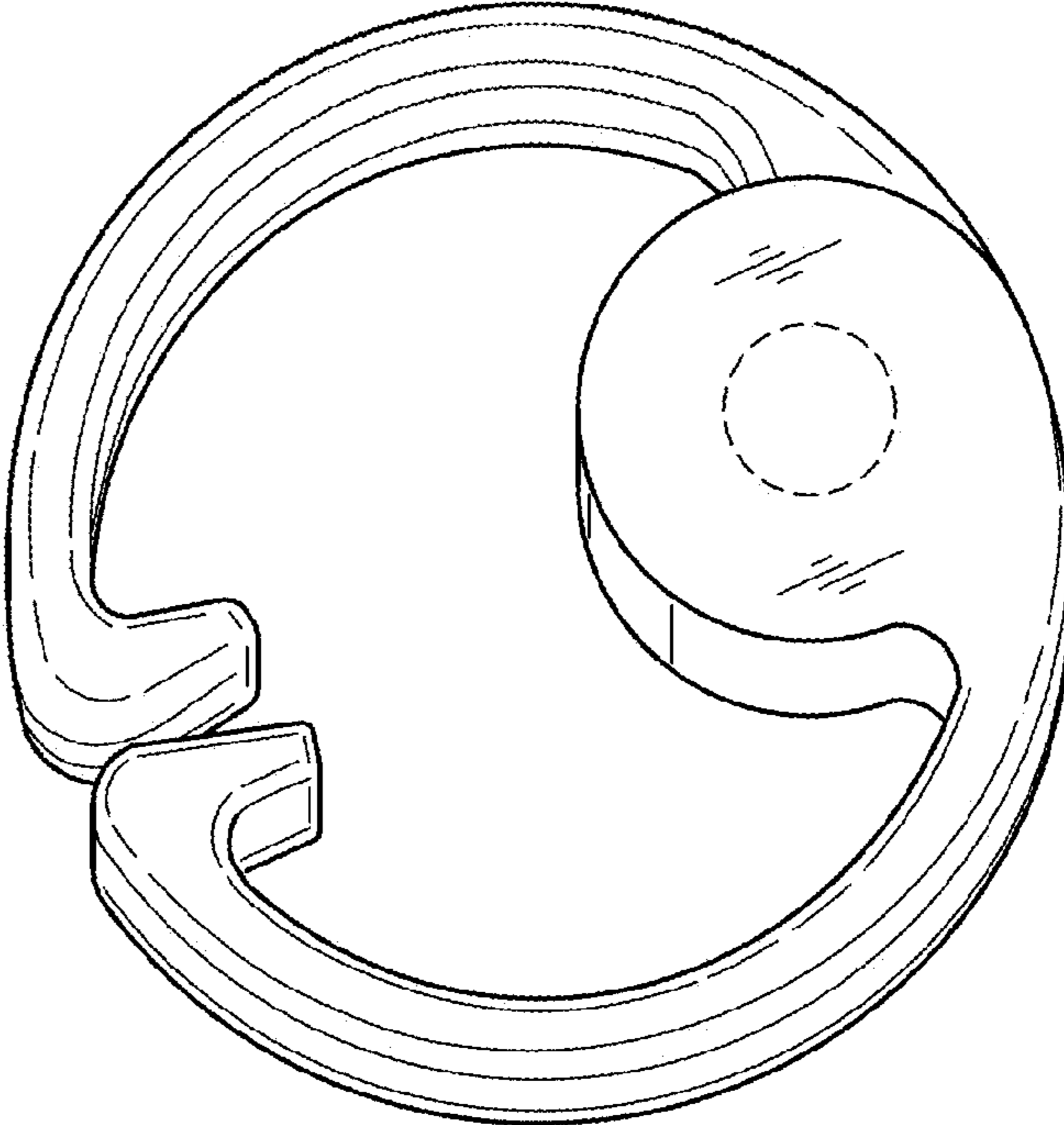

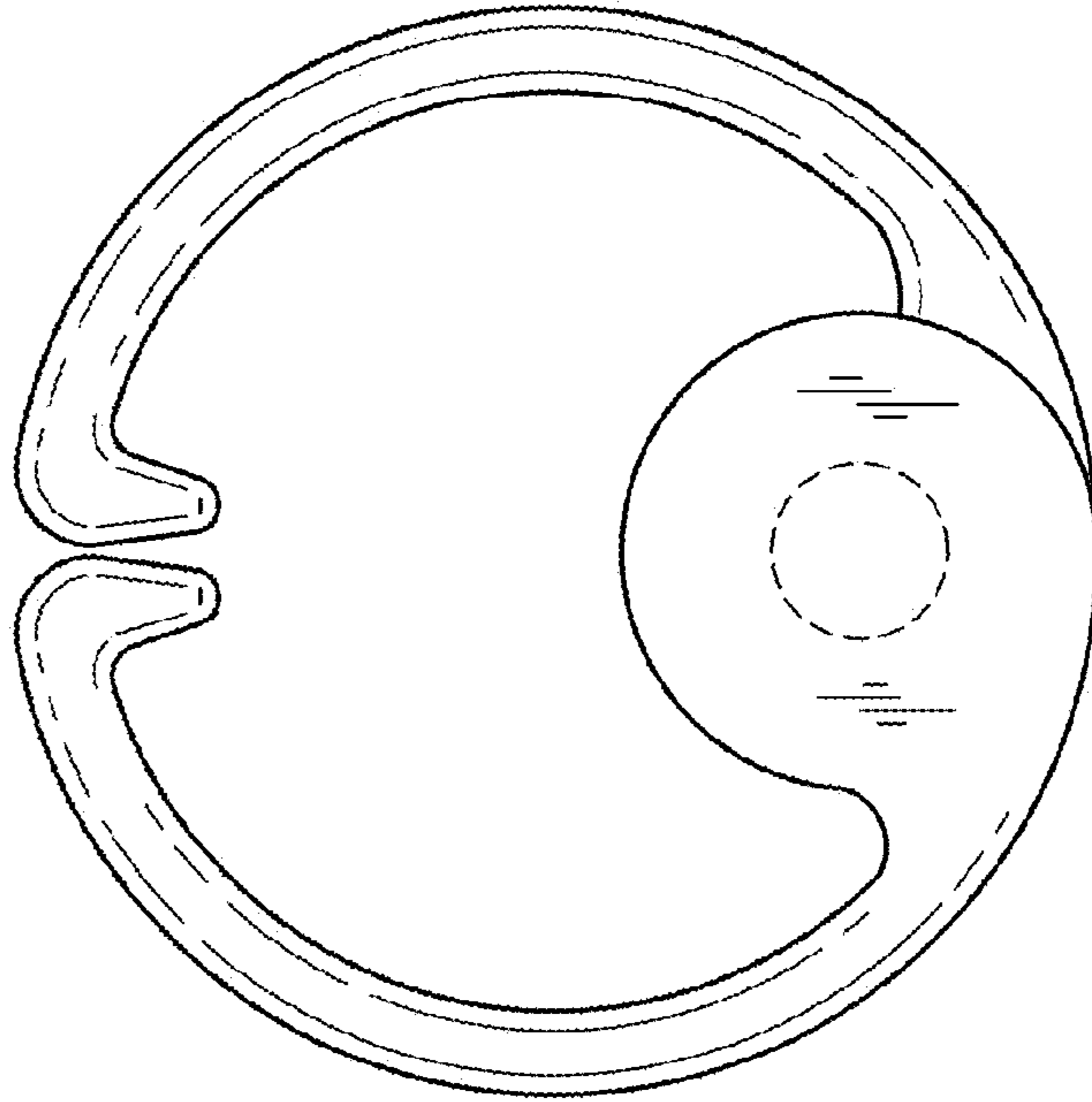

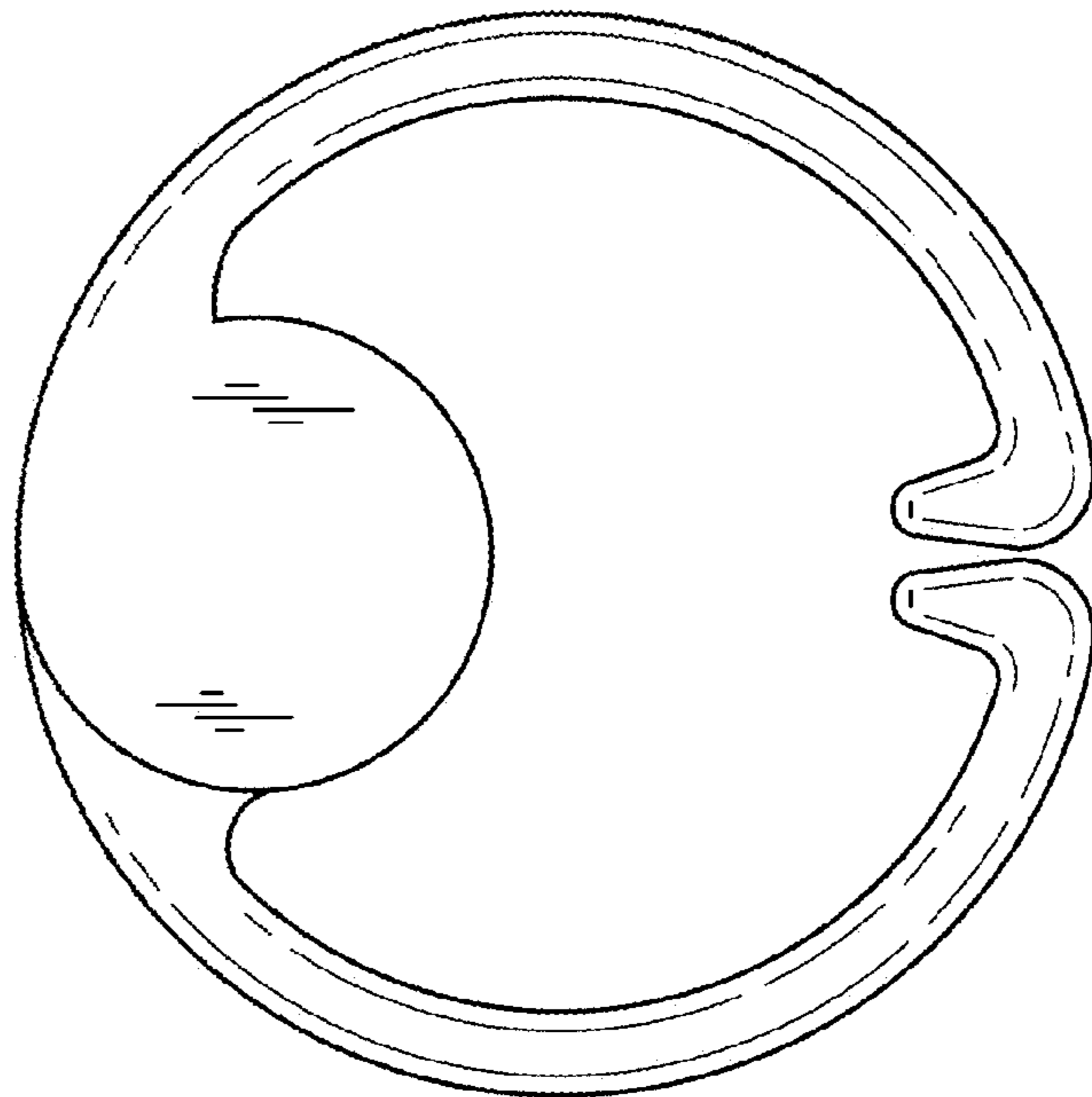

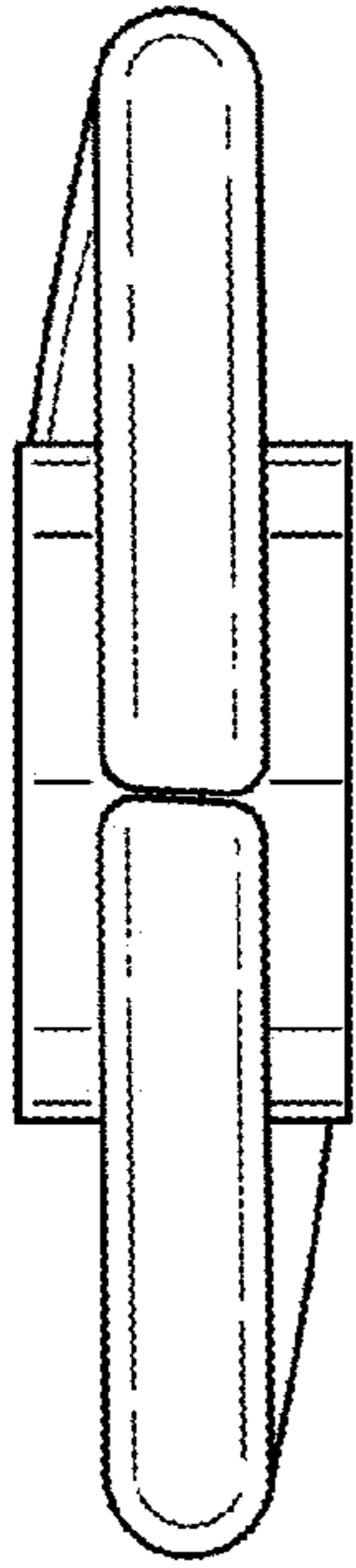

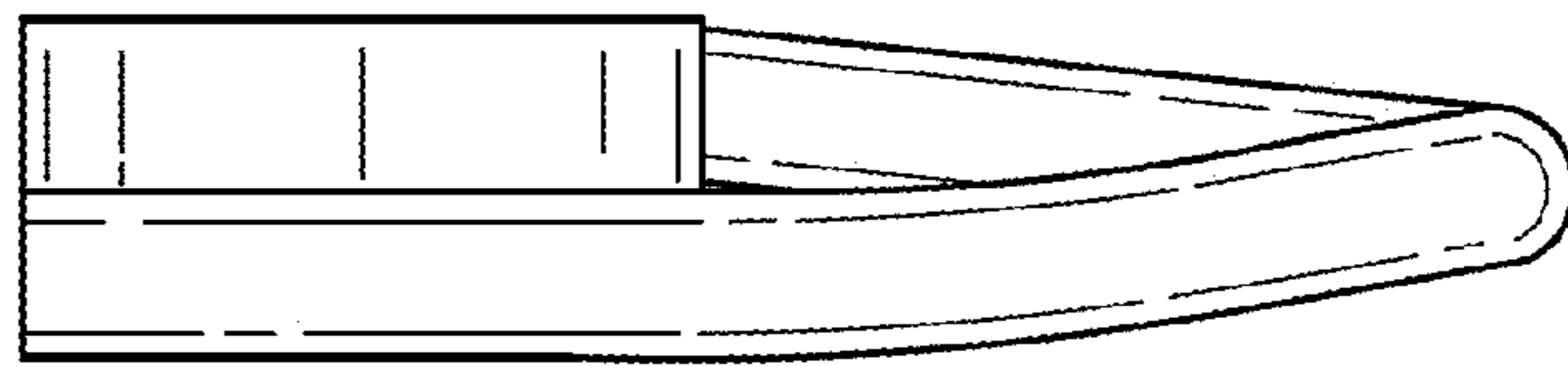

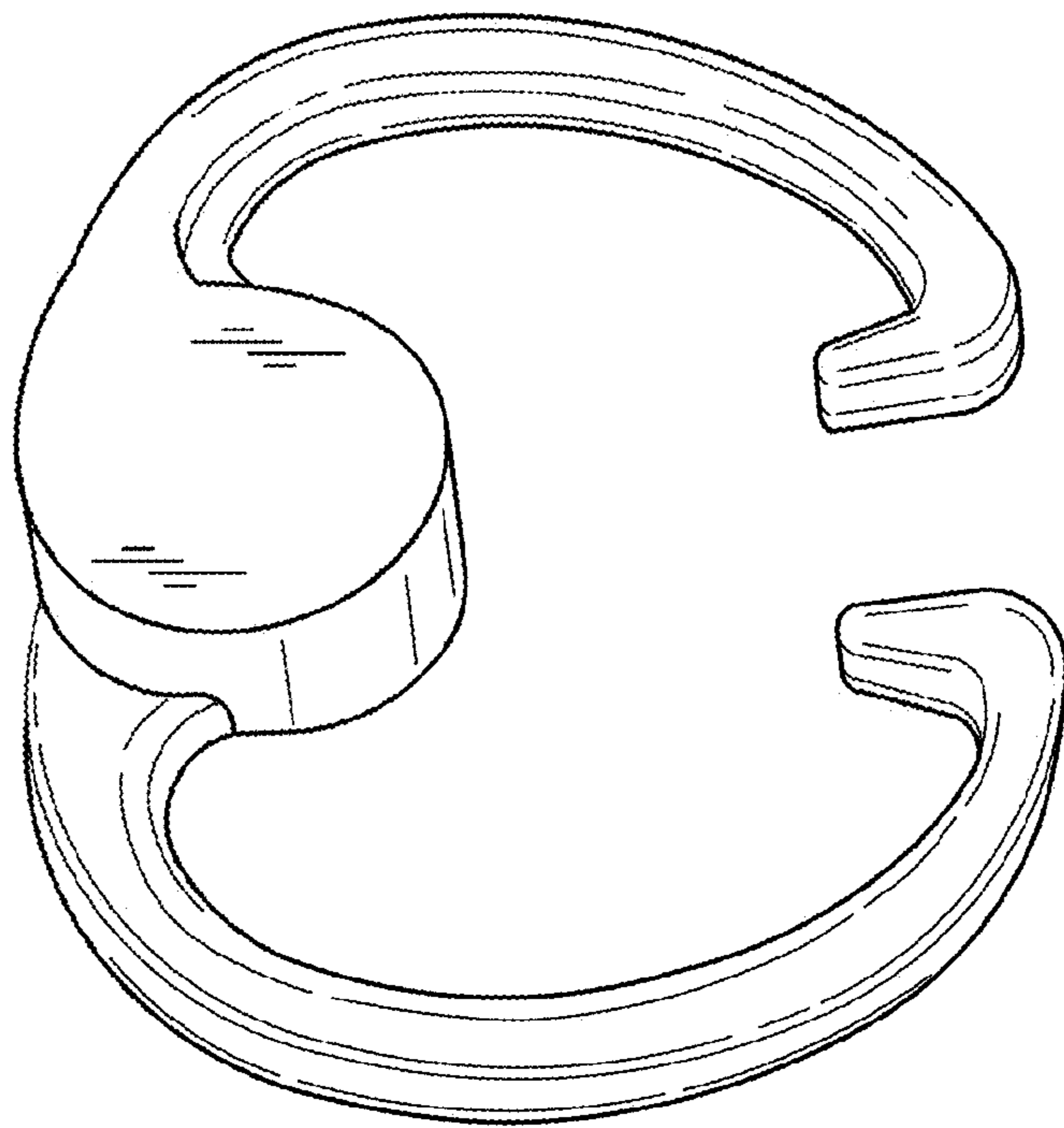

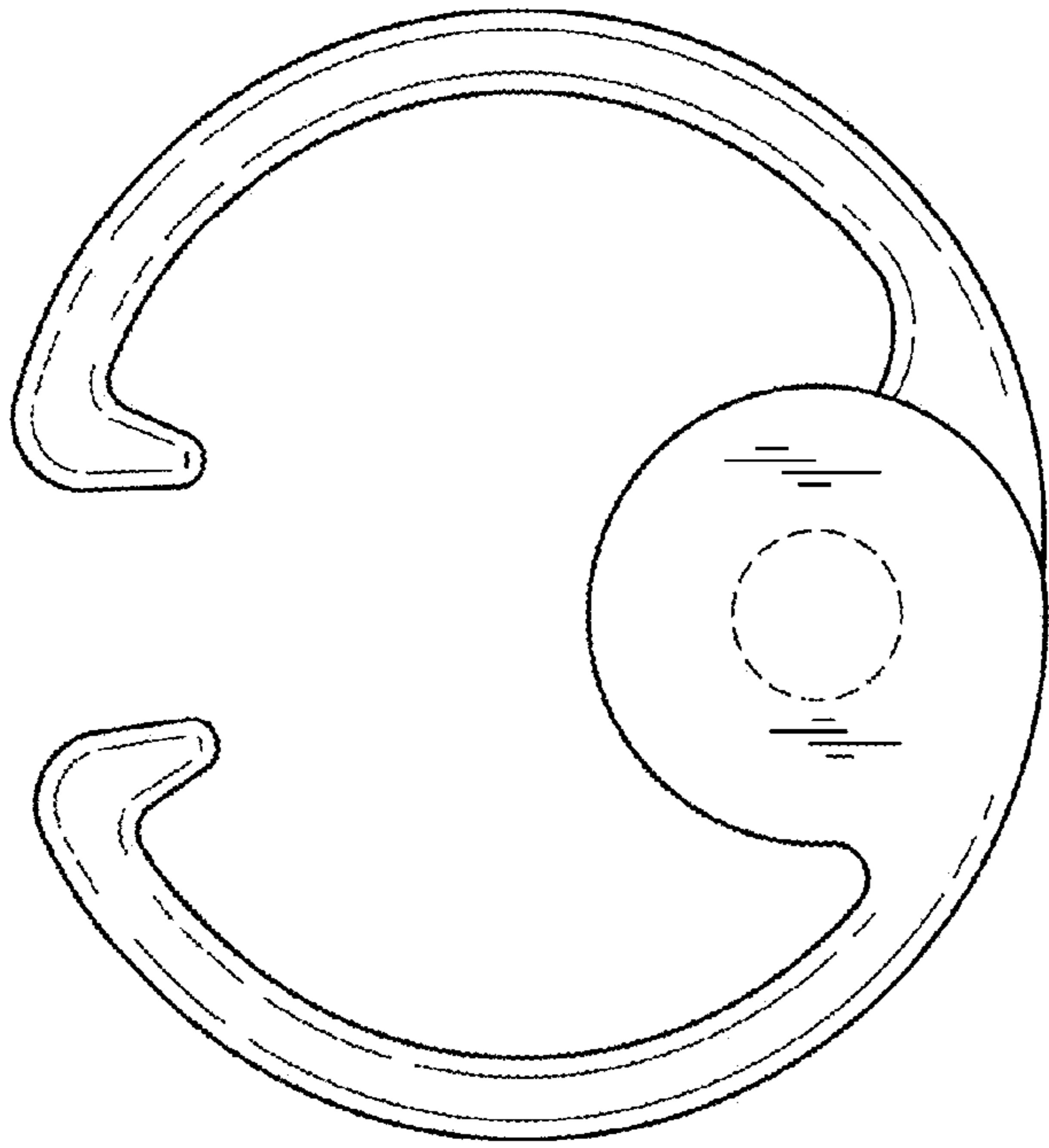

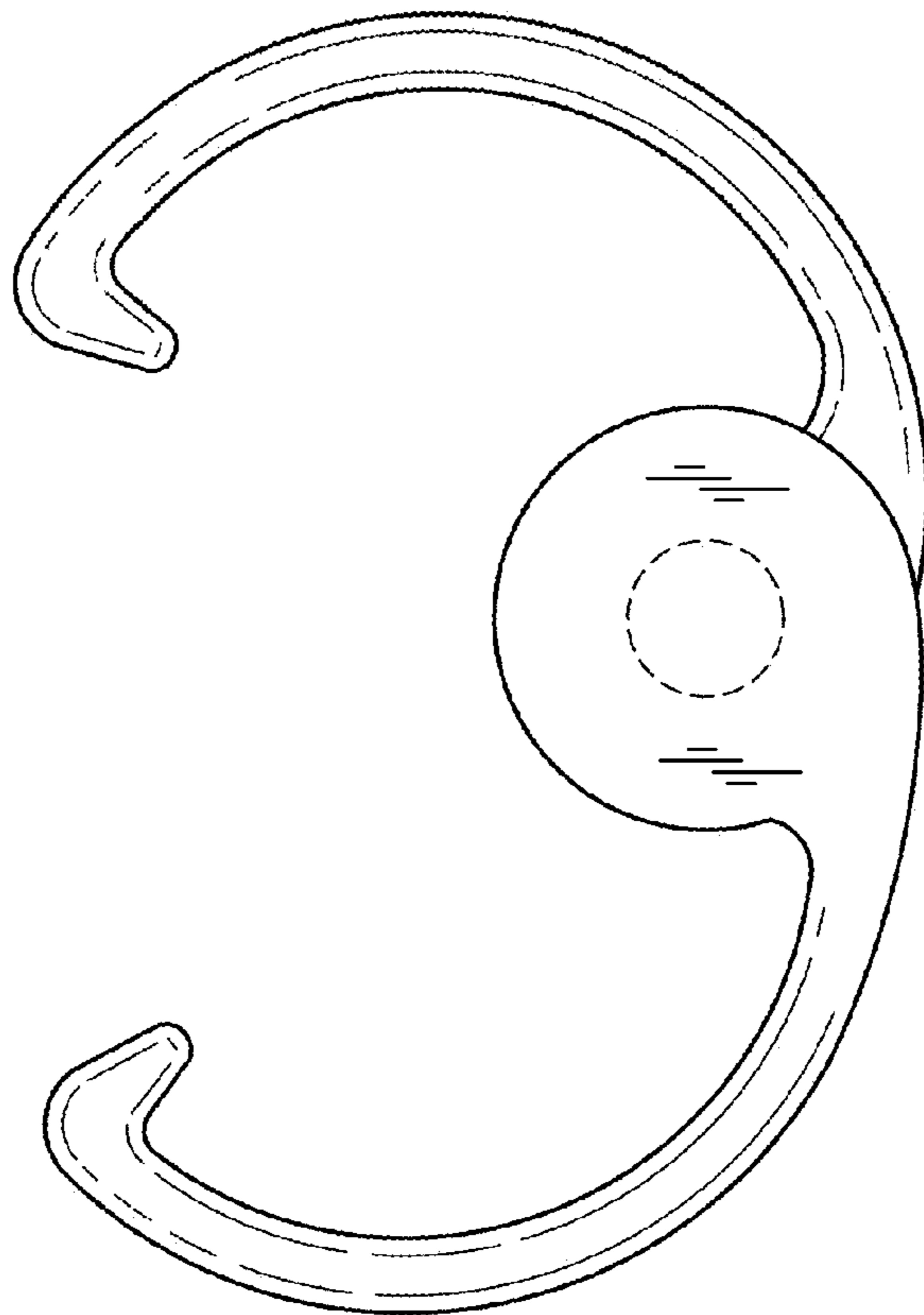

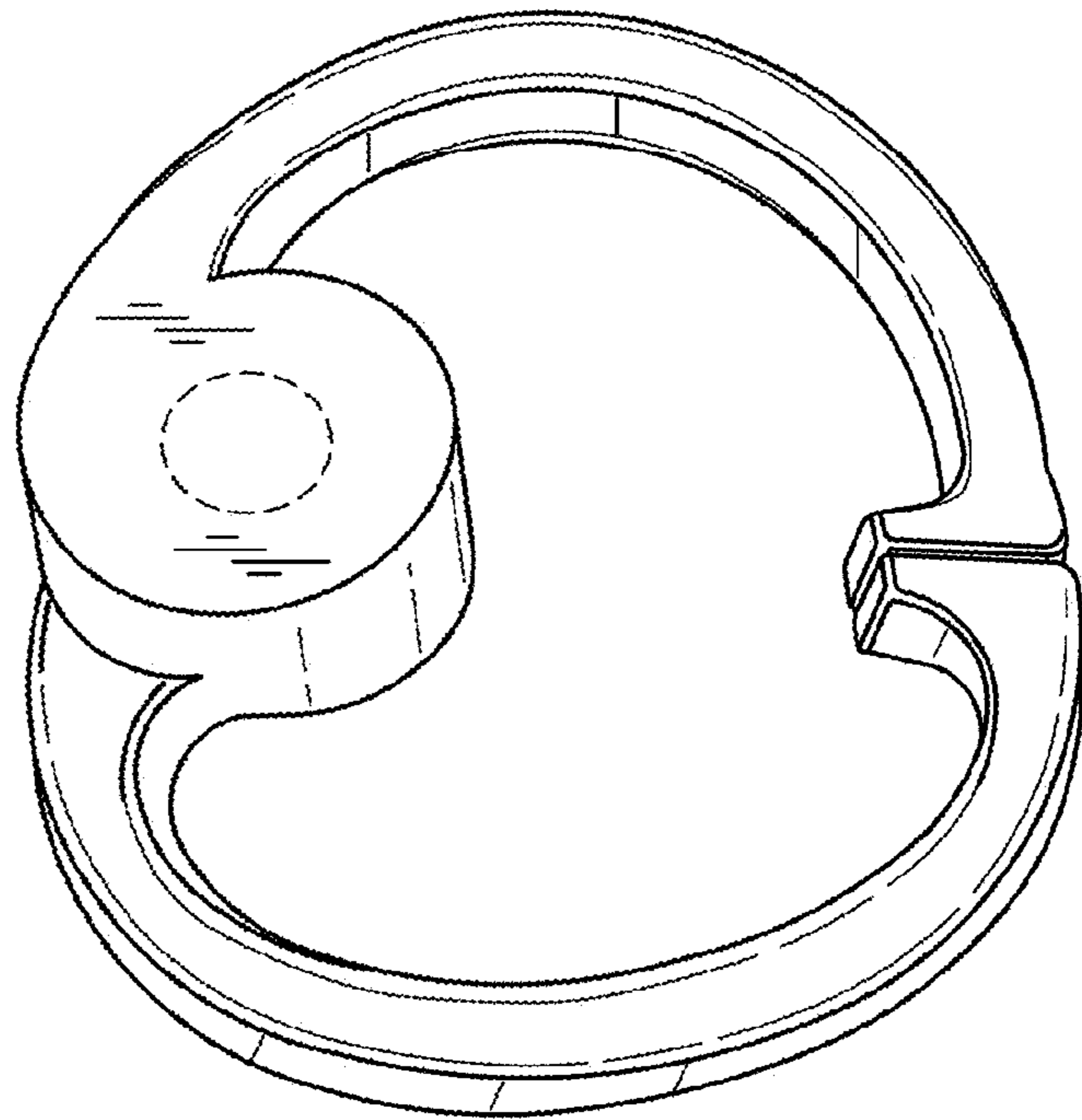

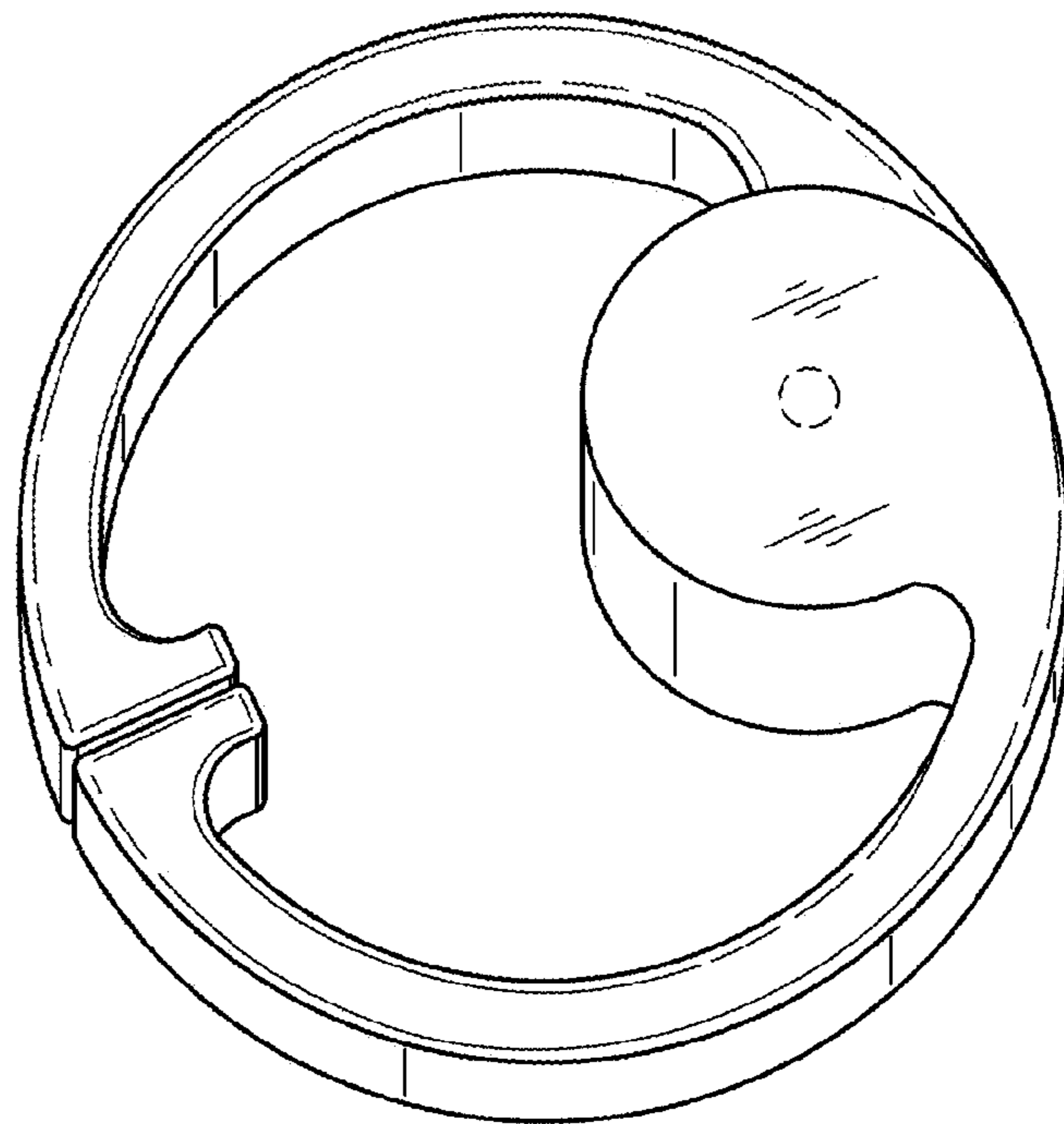

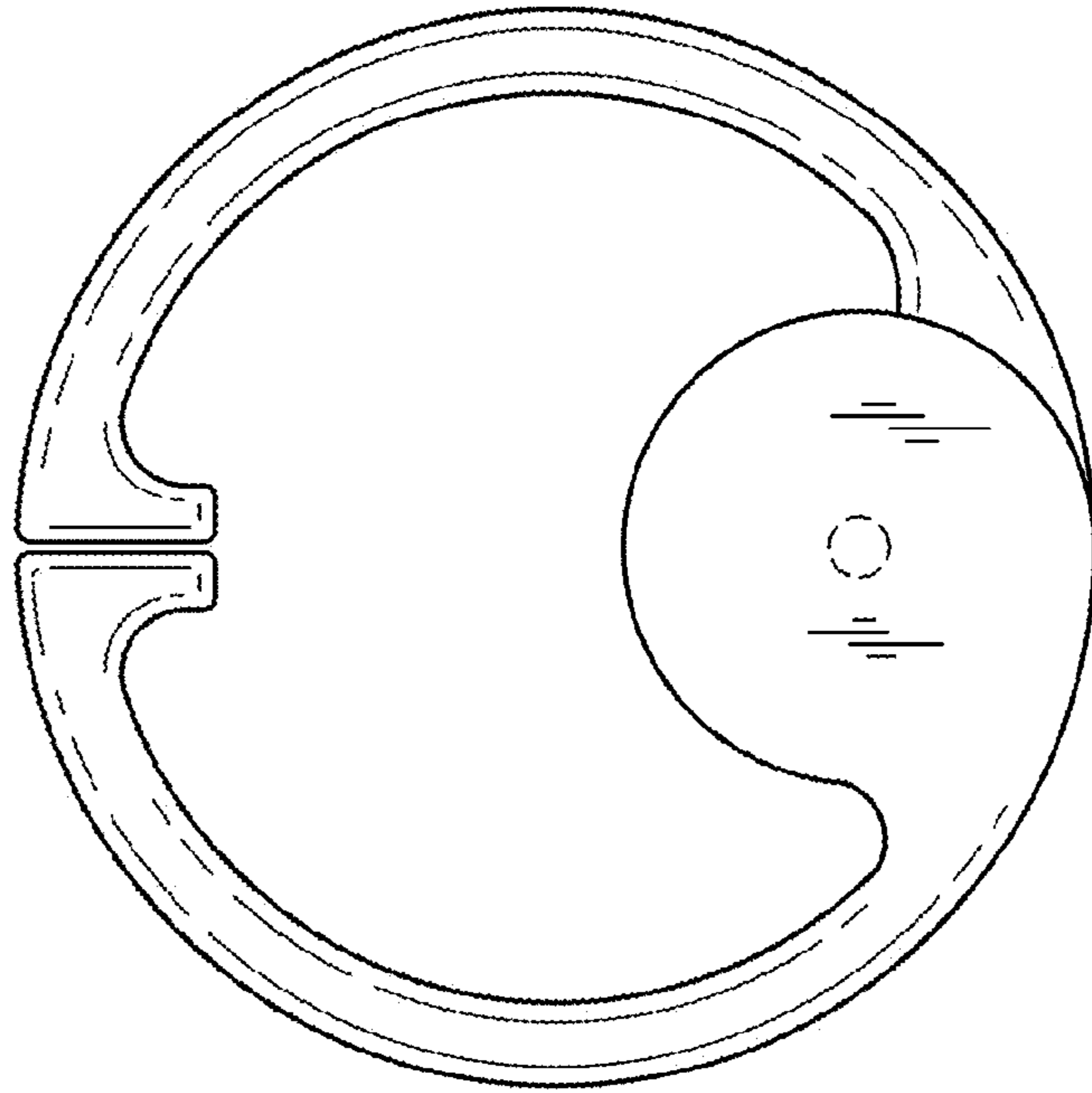

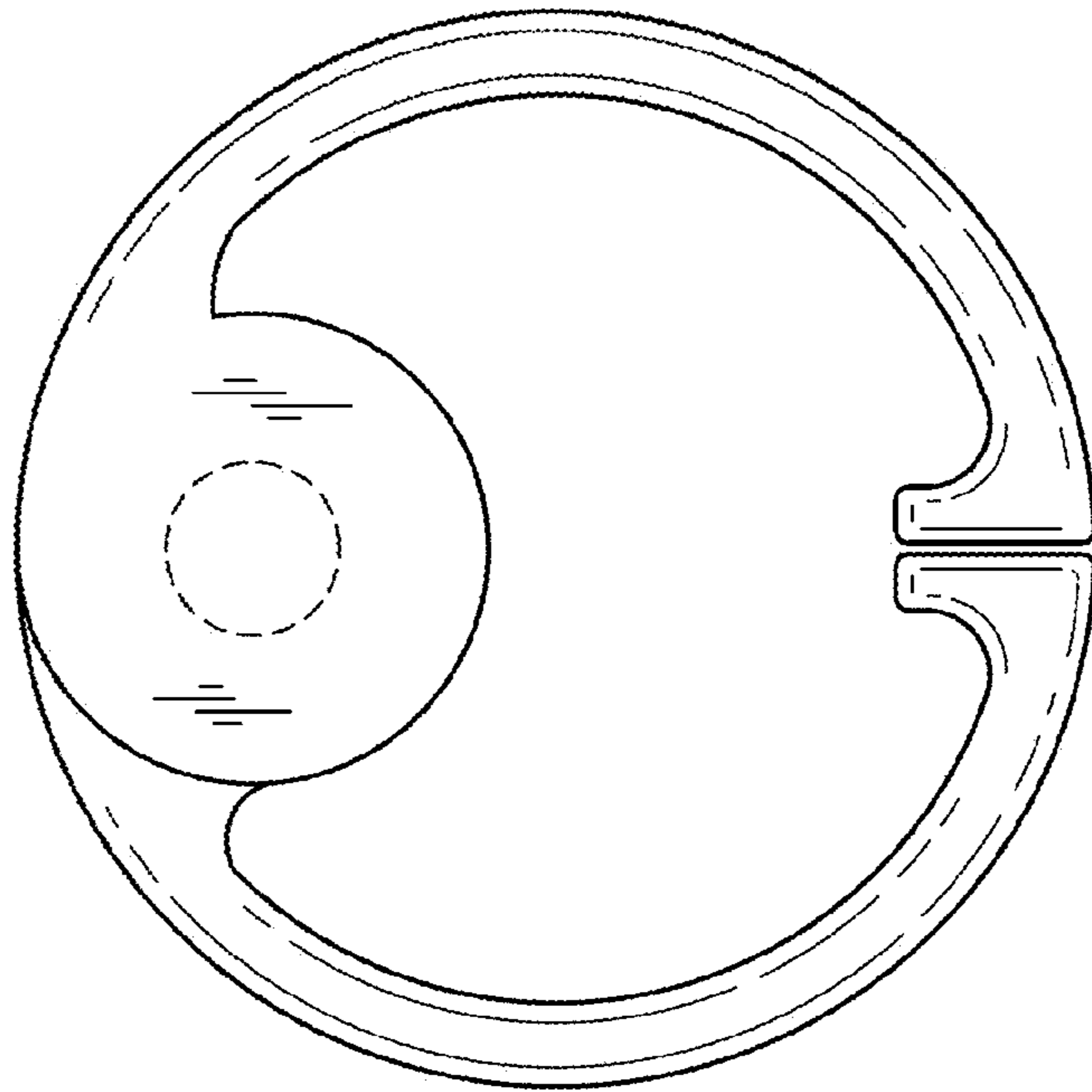

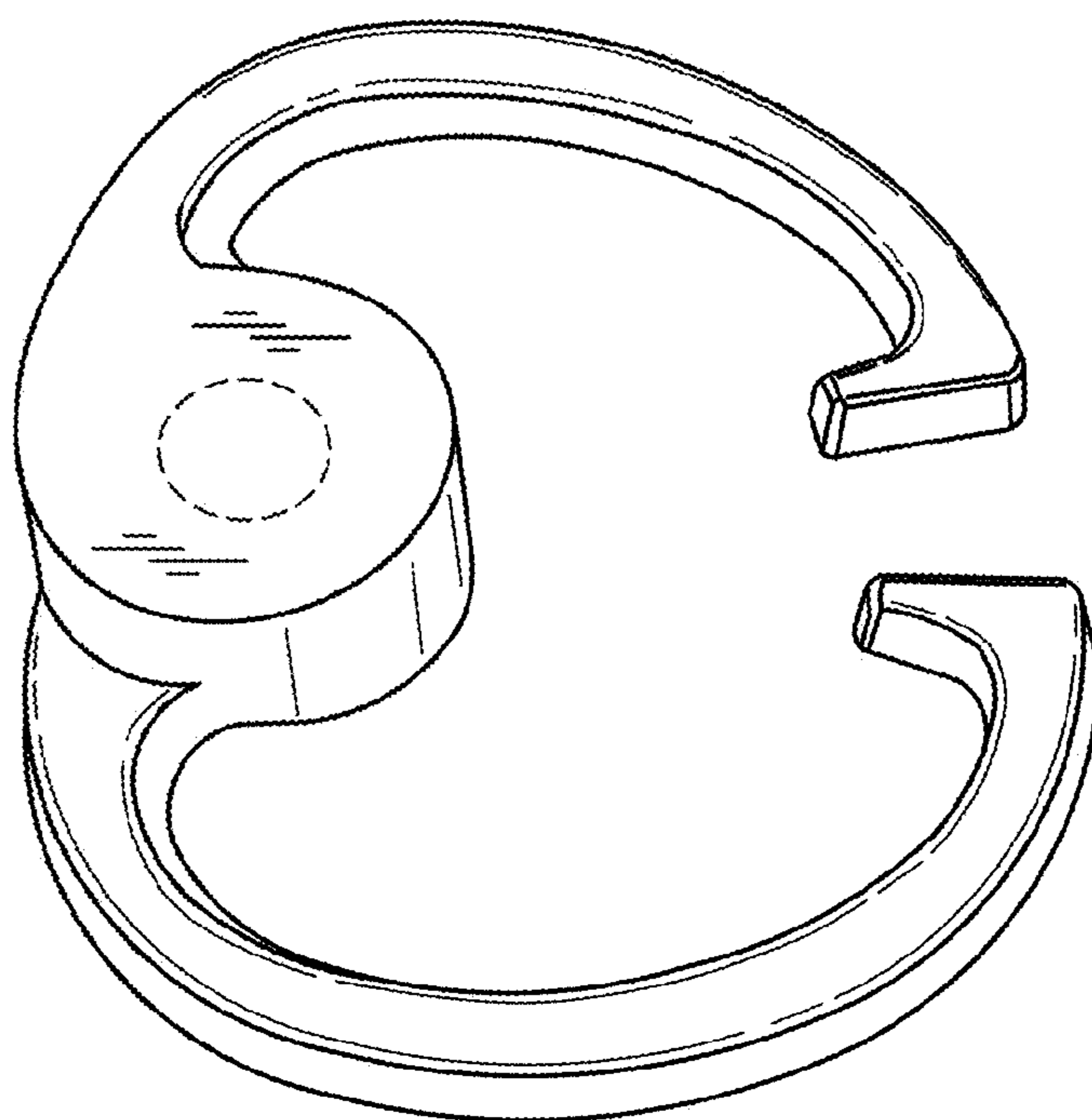

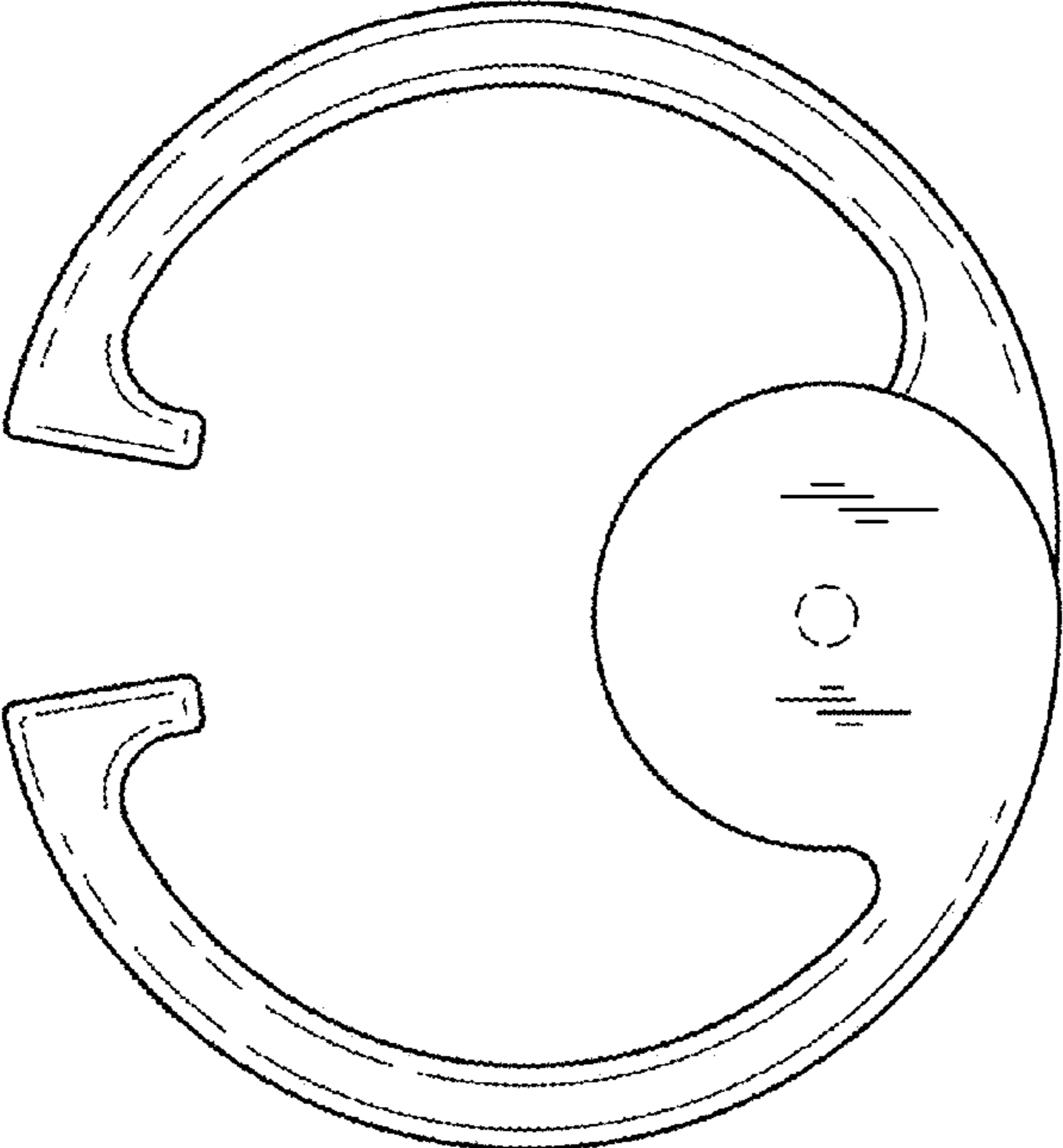

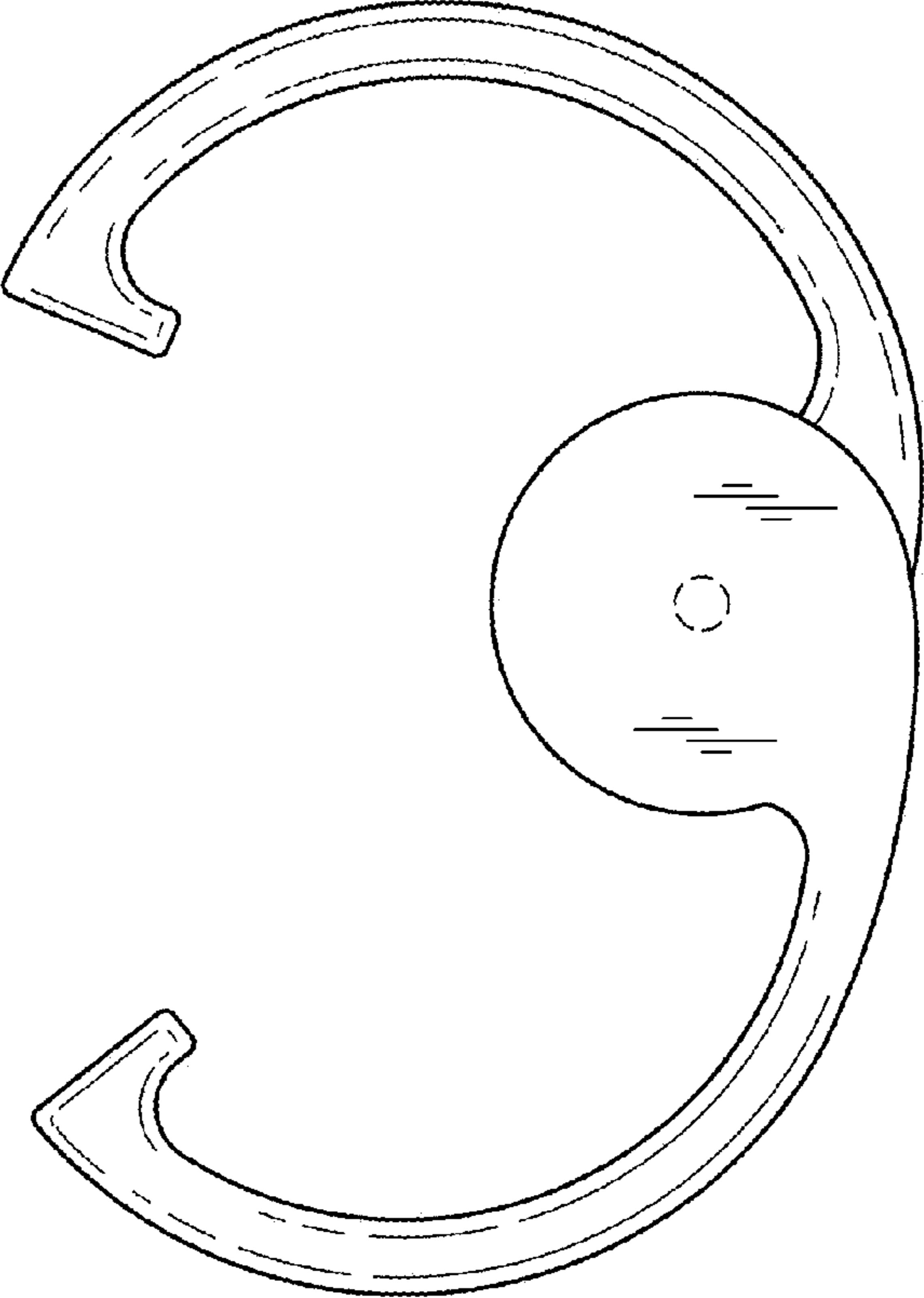
