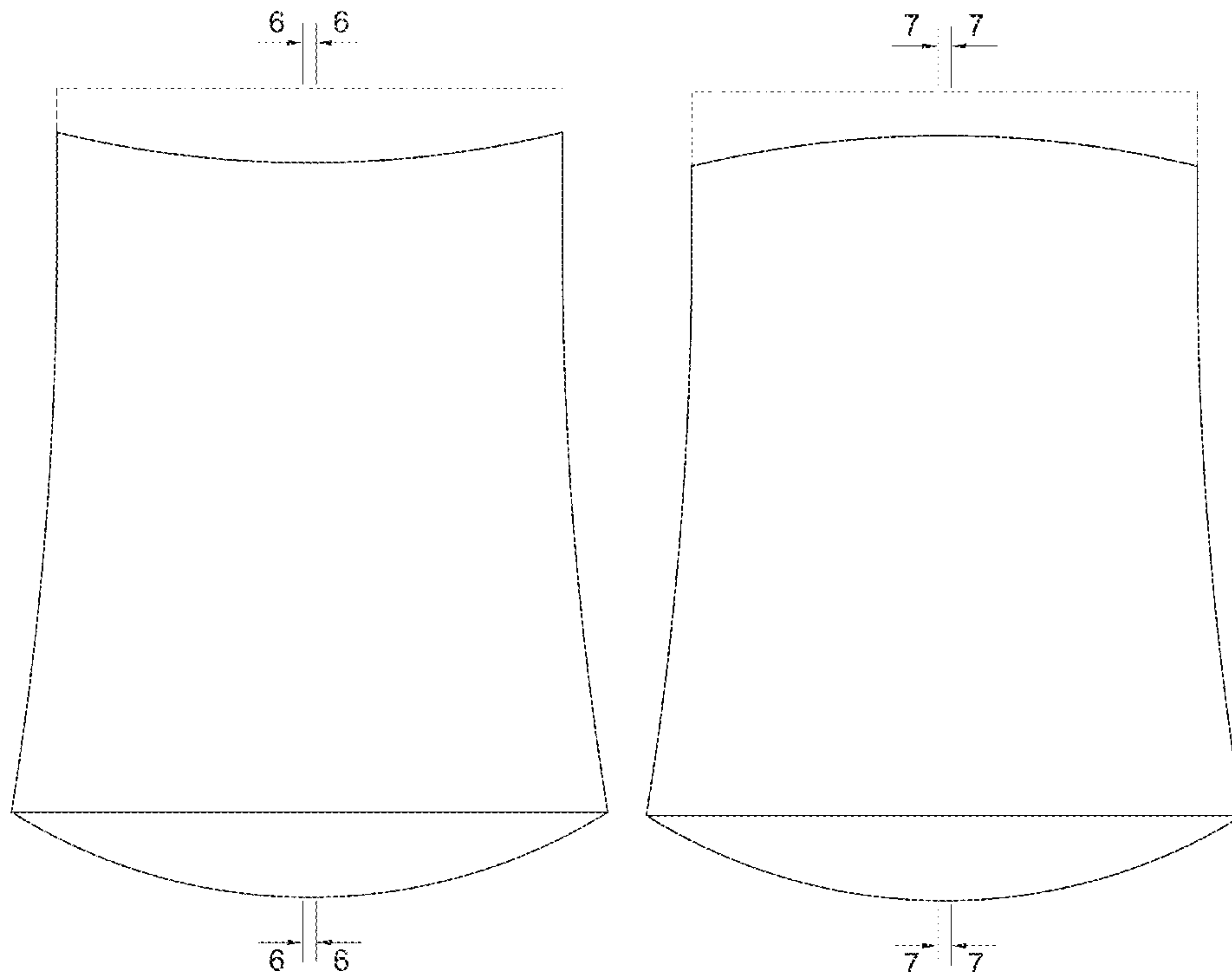
(57) **CLAIM**

The ornamental design for a container for package, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a container for package; FIG. 2 is a front elevation view thereof, the rear elevation view being identical; FIG. 3 is a right side elevation view thereof, the left side elevation view being identical; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a section view taken along the lines 6-6 in FIG. 2; FIG. 7 is a section view taken along the lines 7-7 in FIG. 3; FIG. 8 is a top plan view of the container for package of FIGS. 1-5 with the lid removed; and, FIG. 9 is a front elevation view of FIGS. 1-5 in an open state. The broken lines in the drawings showing the closure portion of the container for package illustrate the portions of the design that form no part of the claim. The present article is a container used for packaging granulated confectionery.

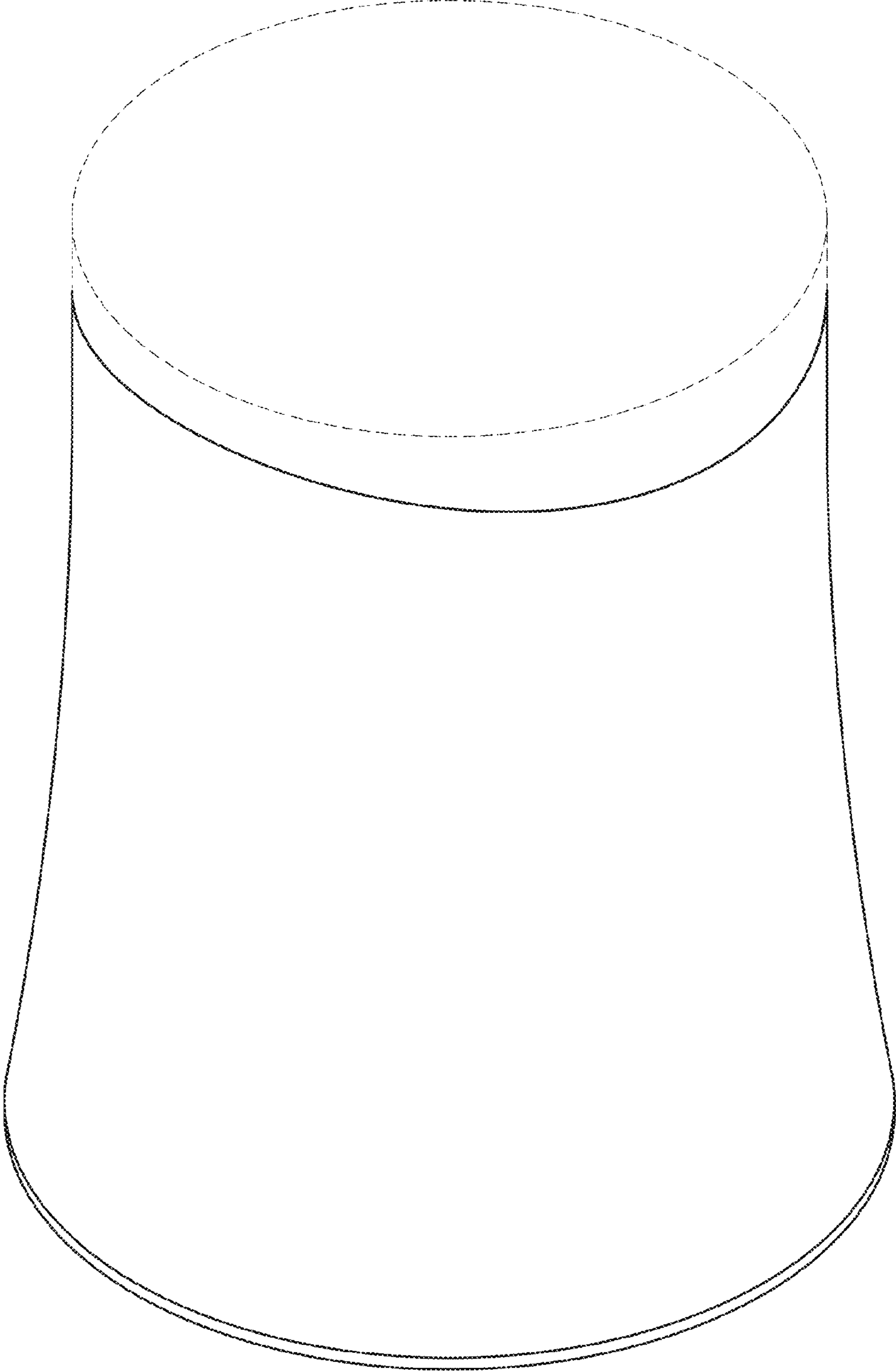

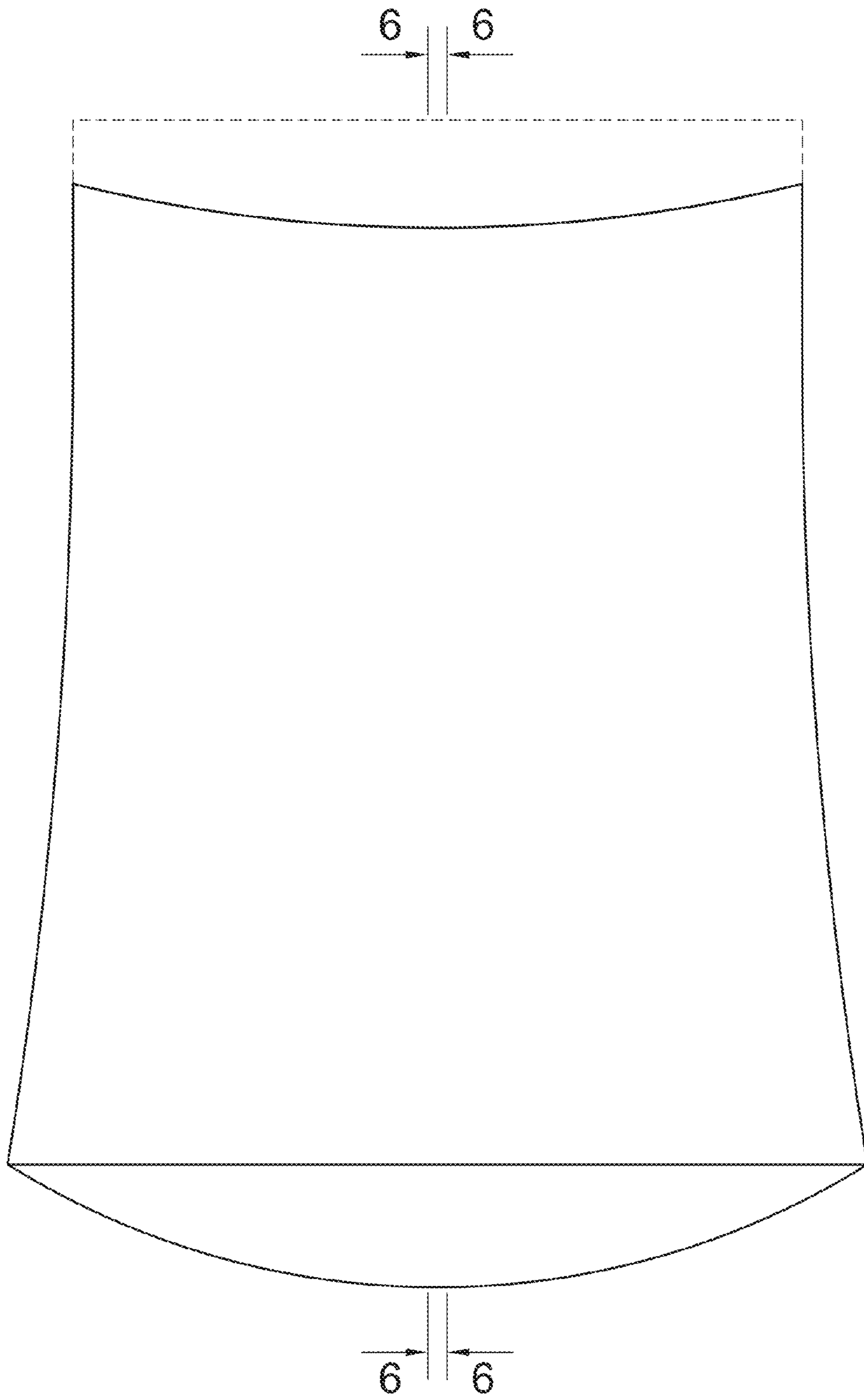

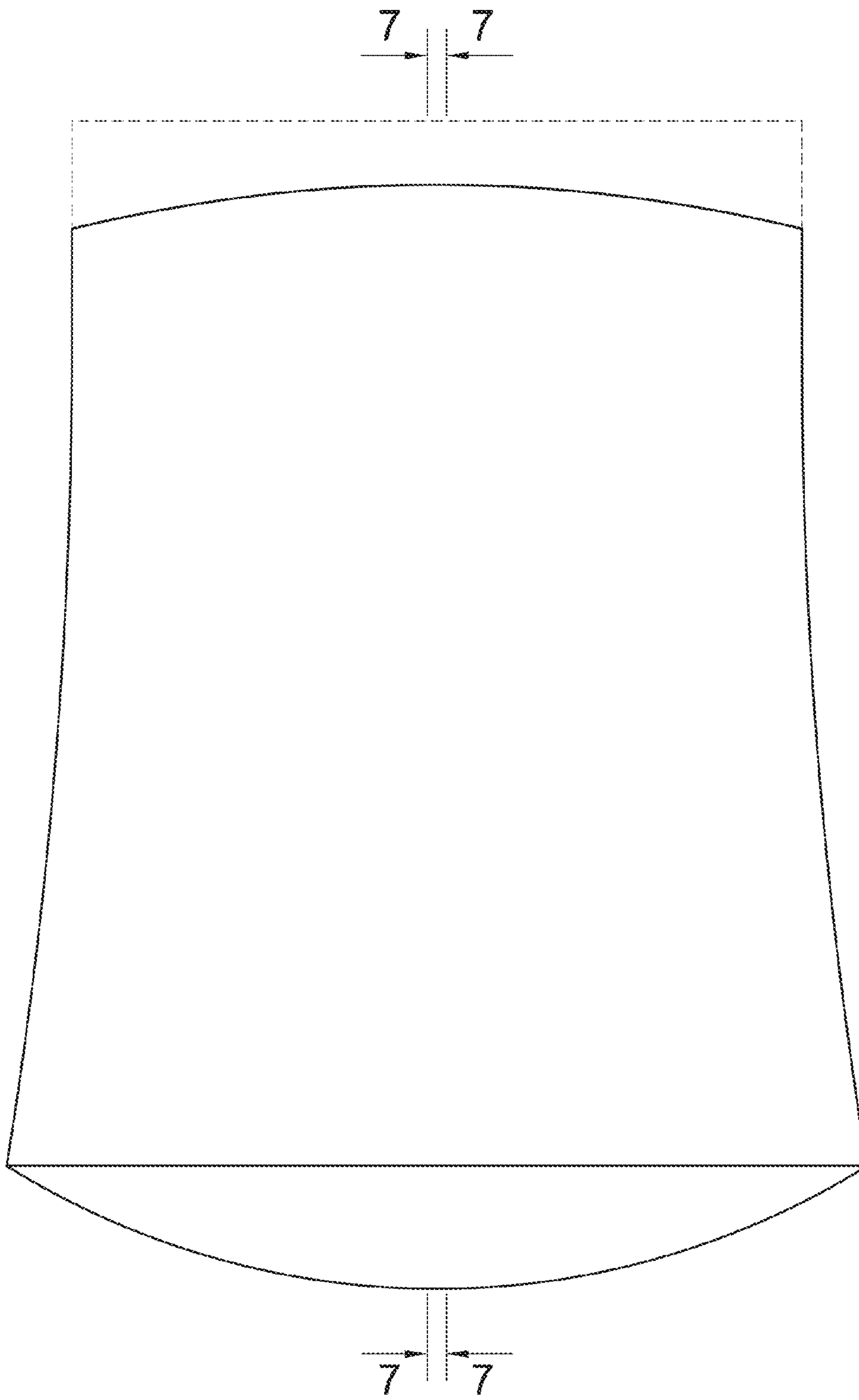

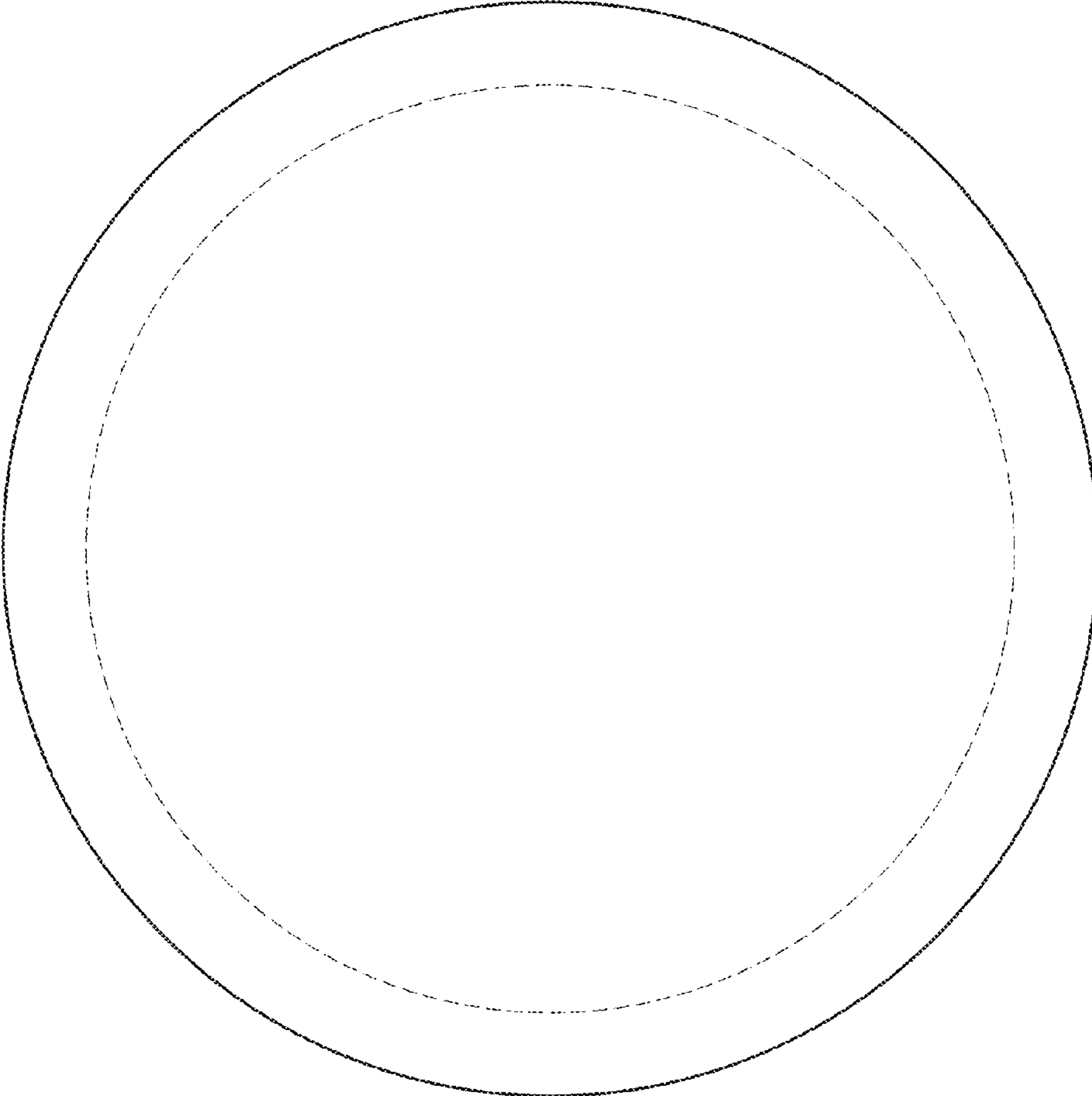

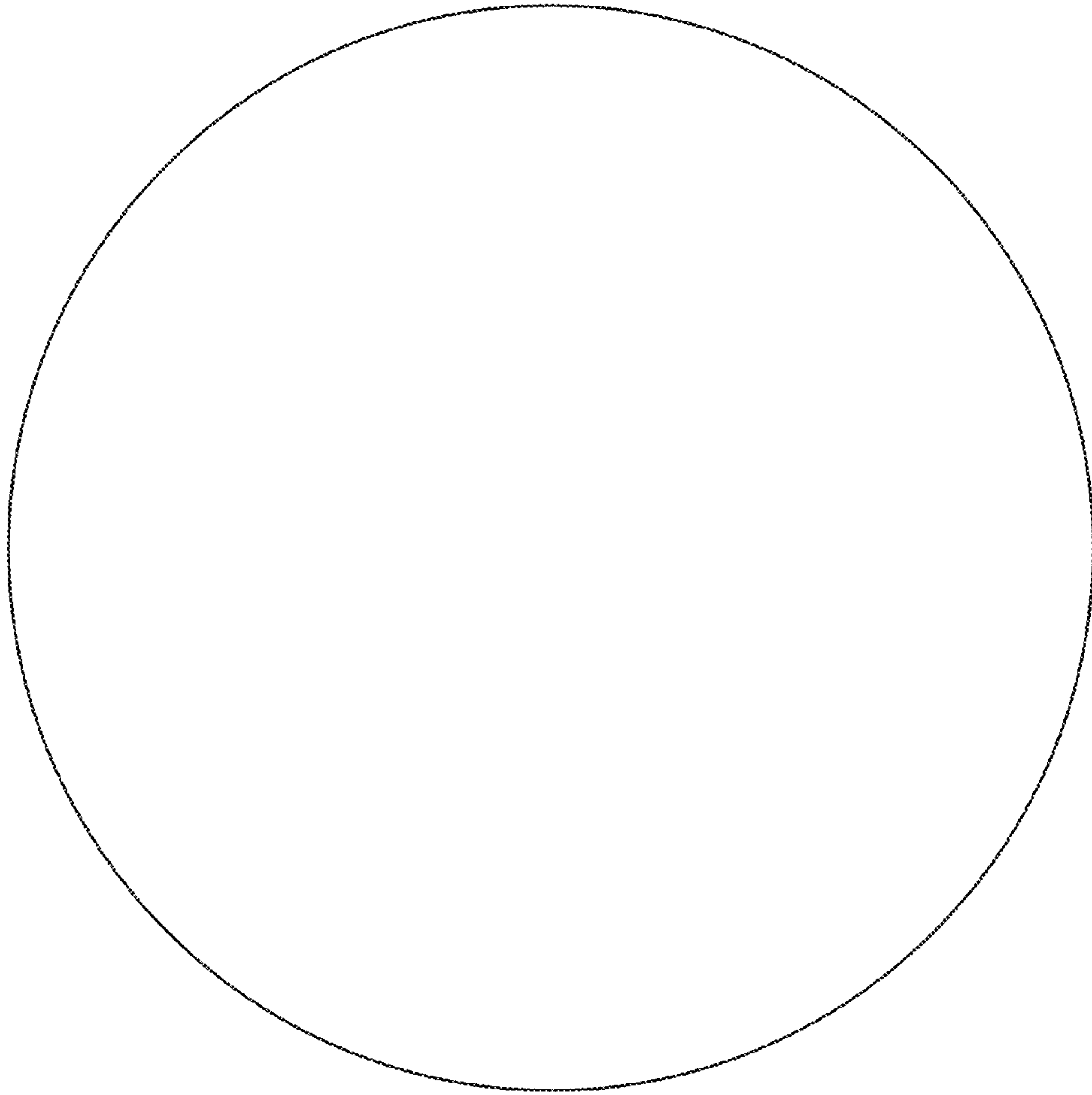

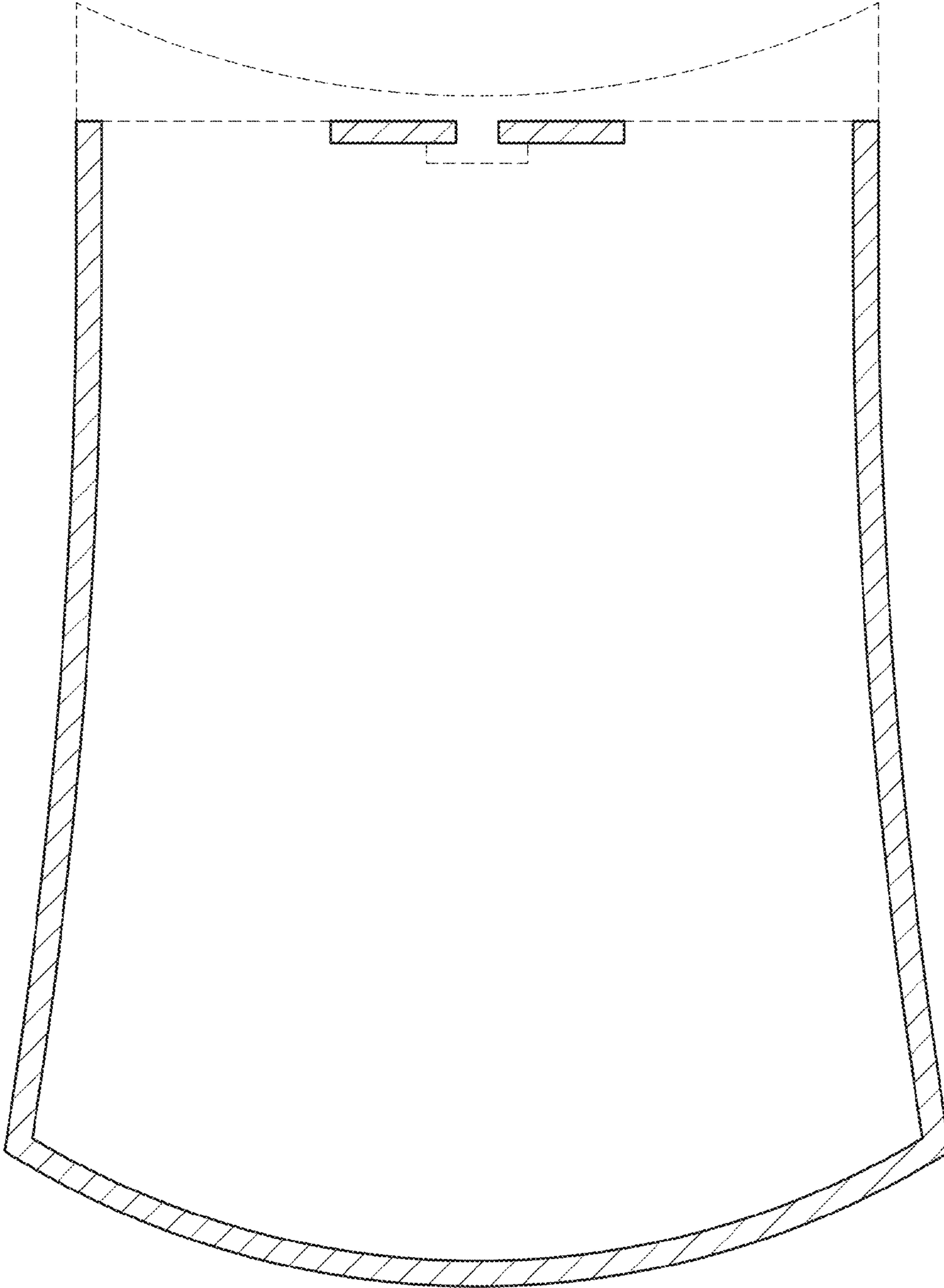

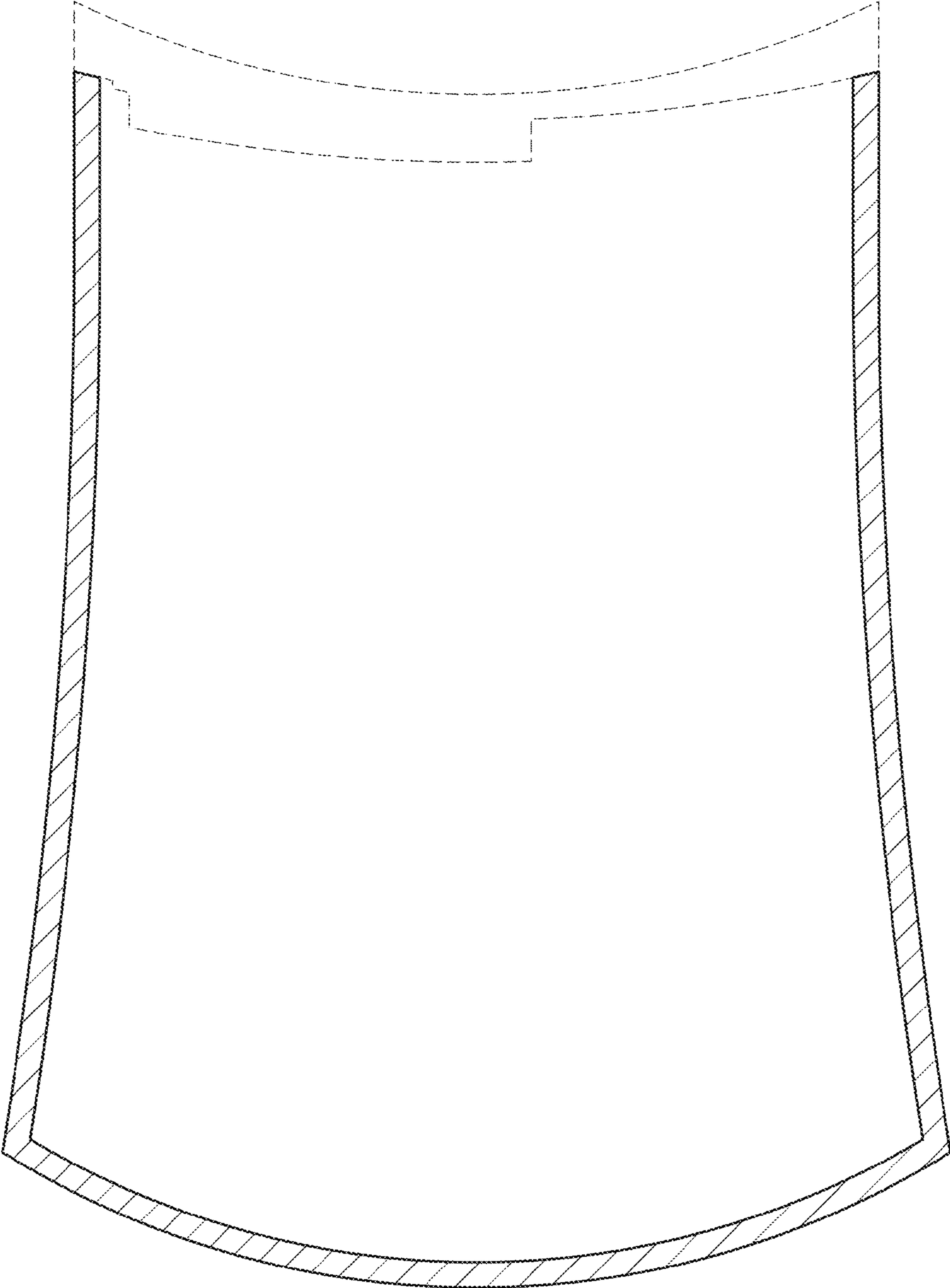

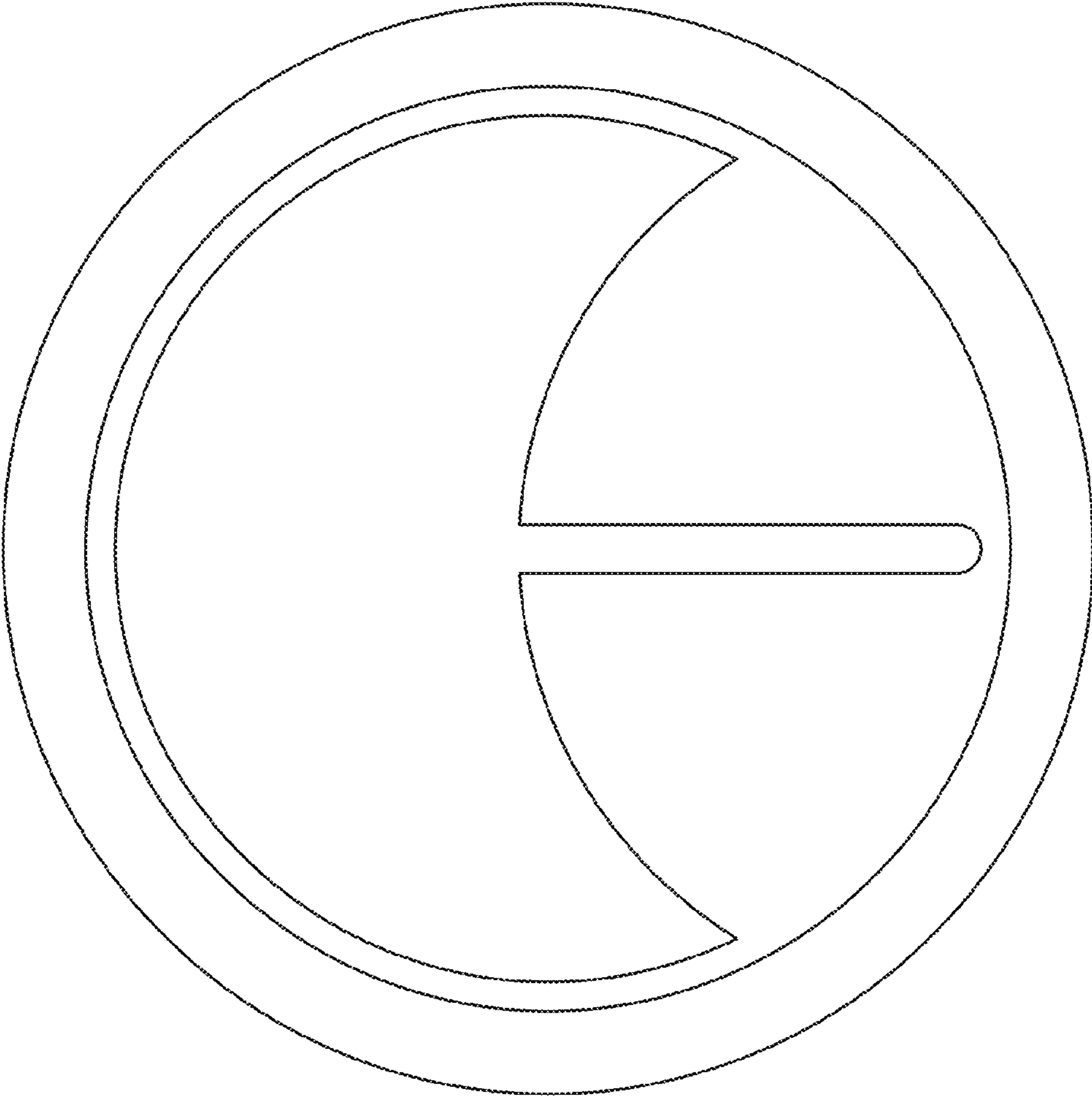

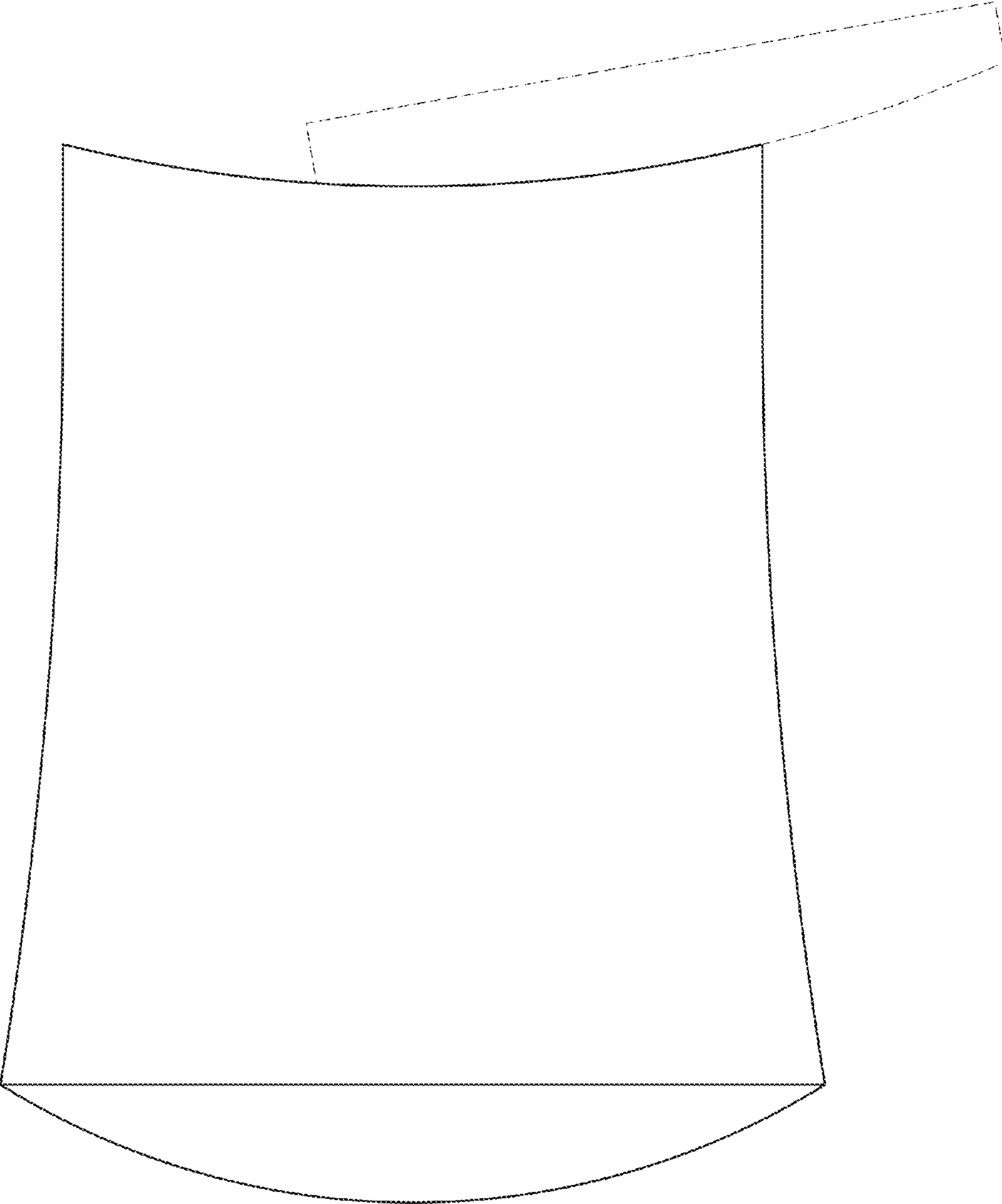
