(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a bottle showing my new design (with the rear view and side views being the same);

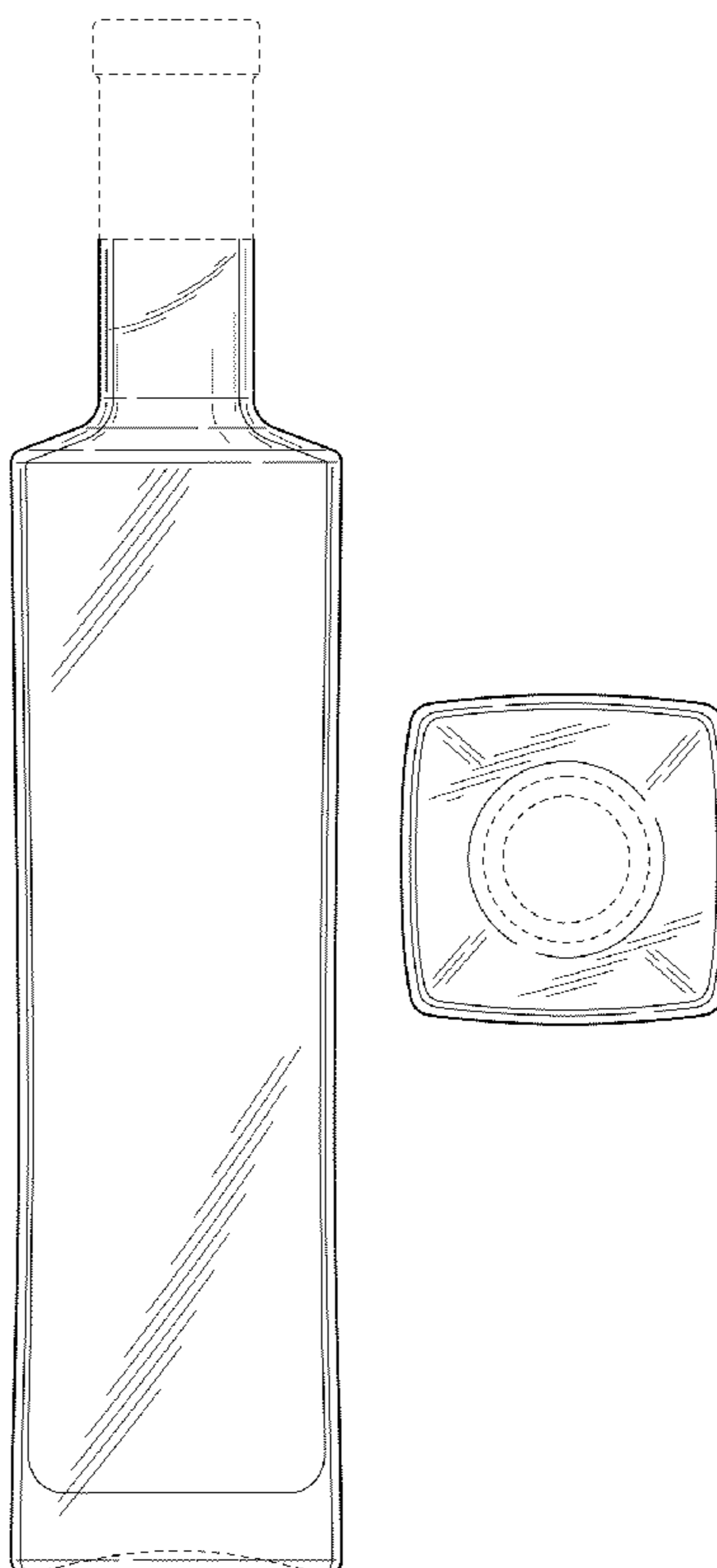
FIG. 2 is a top view of the bottle shown in FIG. 1;

FIG. 3 is a bottom view of the bottle shown in FIG. 1; and,

FIG. 4 is a front perspective view of the bottle shown in FIG. 1.

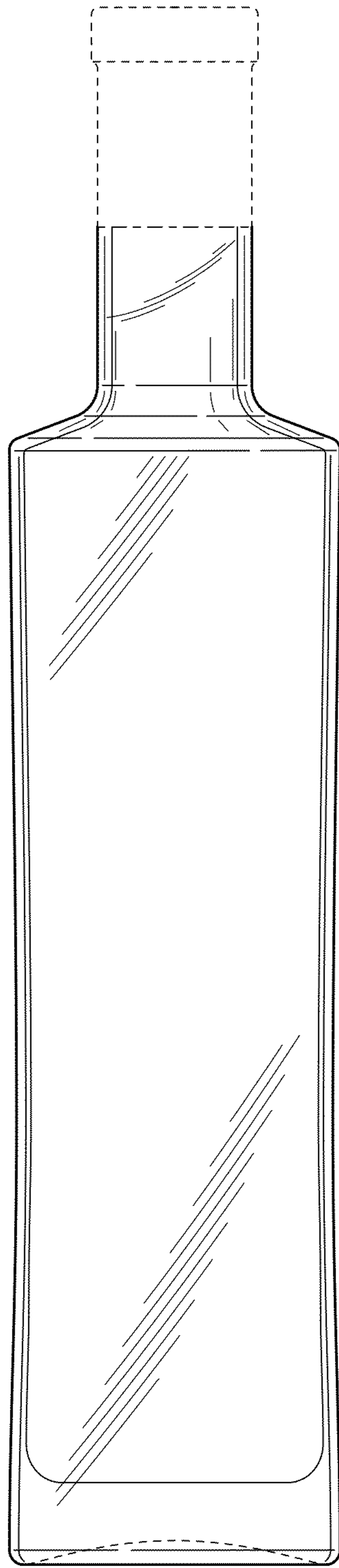
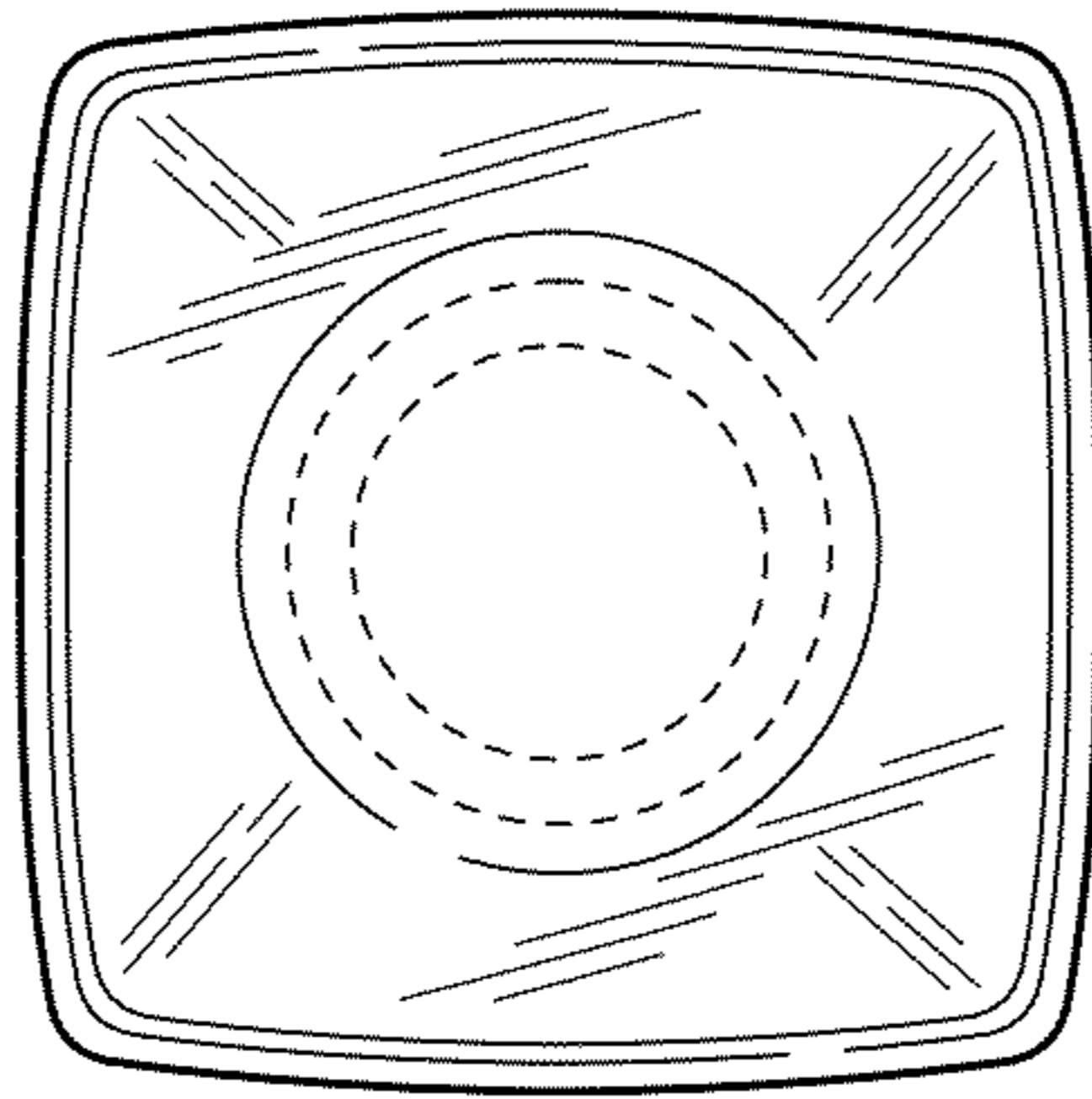
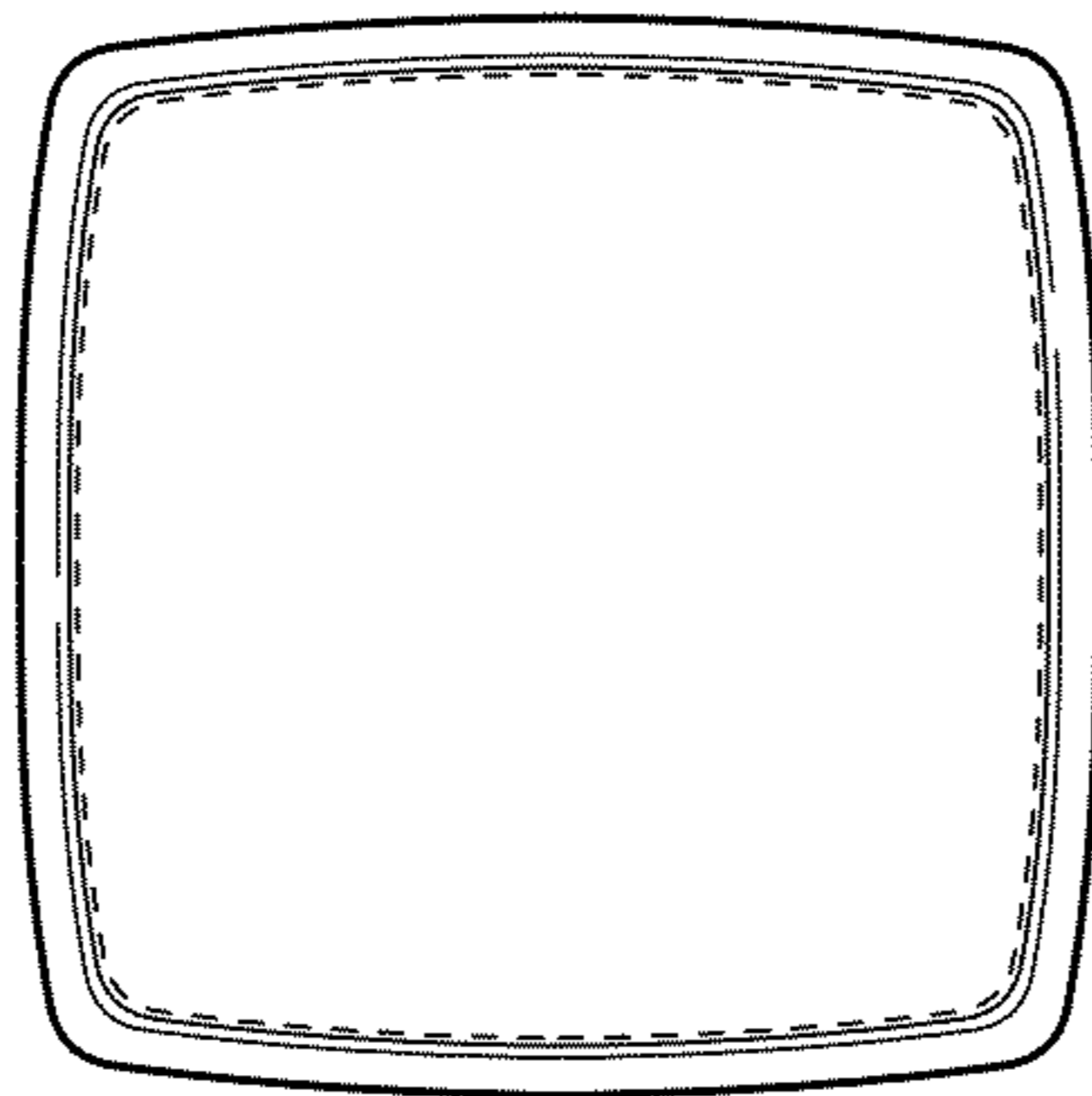

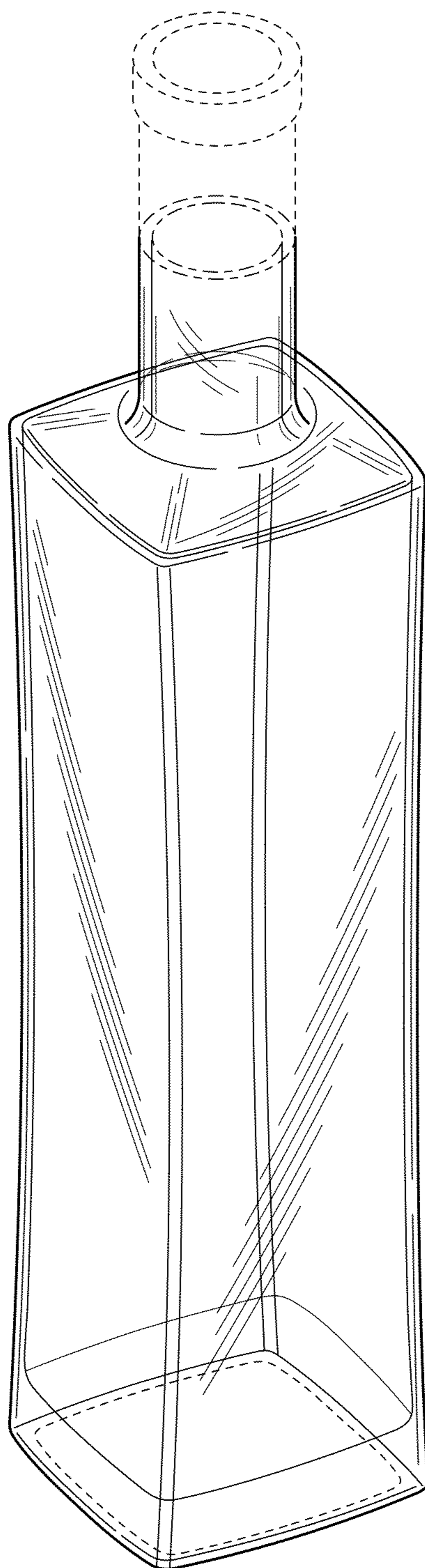
