(57) **CLAIM**

The ornamental design for a planter box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the planter box showing a front side and a left side in which a corresponding perspective view of the planter box showing a rear side and a right side is identical to the view shown;

FIG. 2 is a front elevational view of the planter box in which the opposing rear elevational view is identical to the view shown;

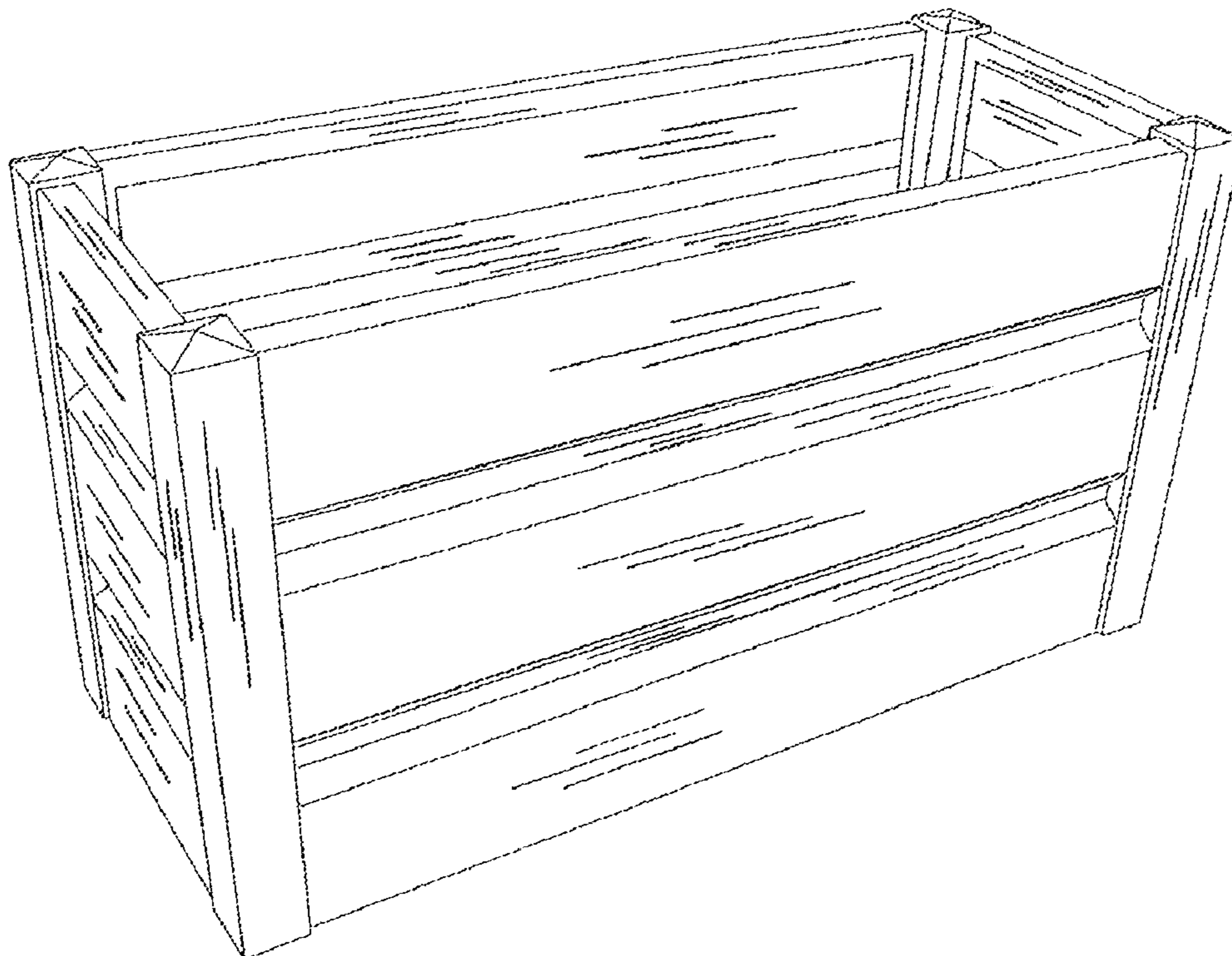
FIG. 3 is a right side elevational view of the planter box in which the opposing left side elevational view is identical to the view shown;

FIG. 4 is a bottom view of the planter box; and,

FIG. 5 is a top plan view of the planter box.

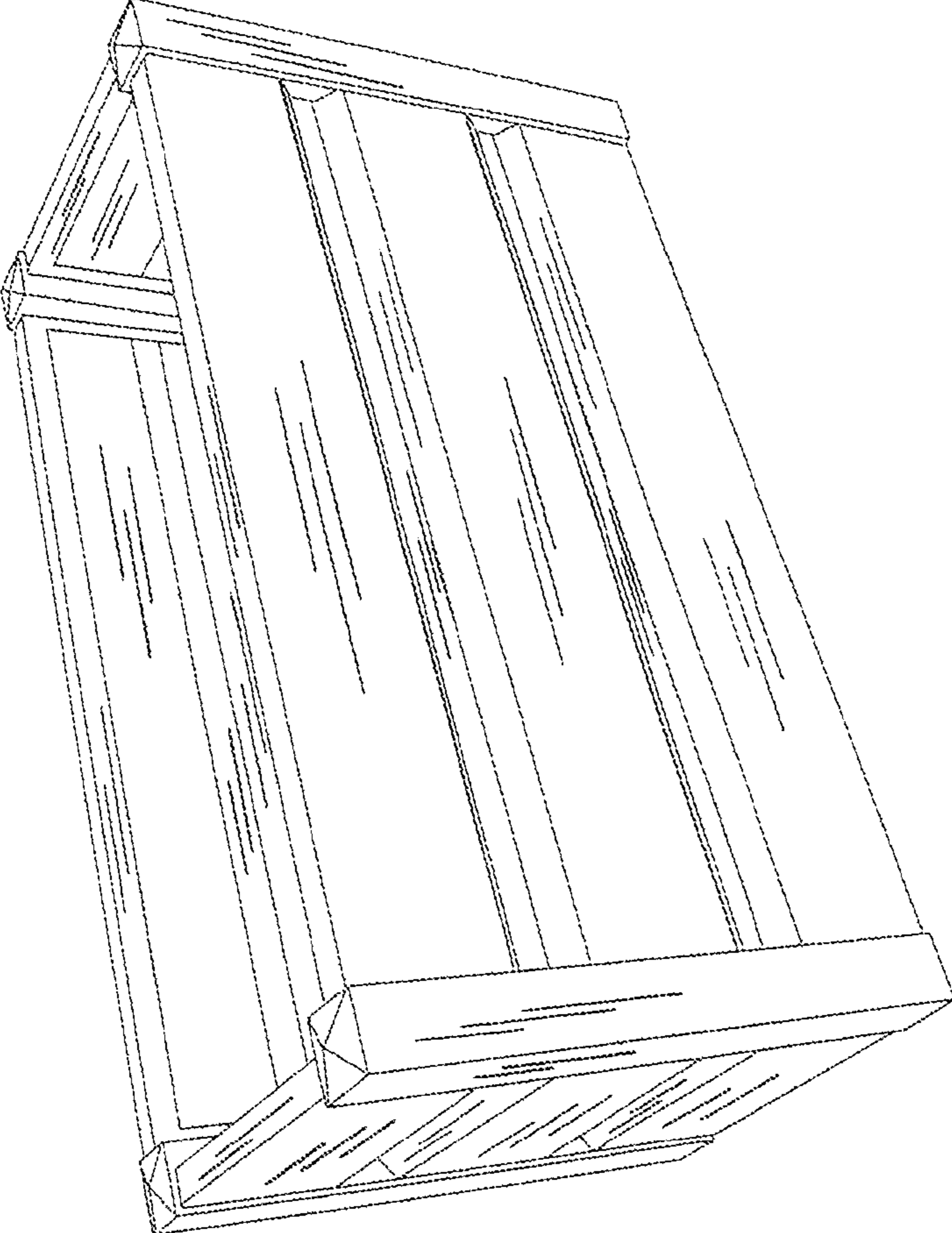

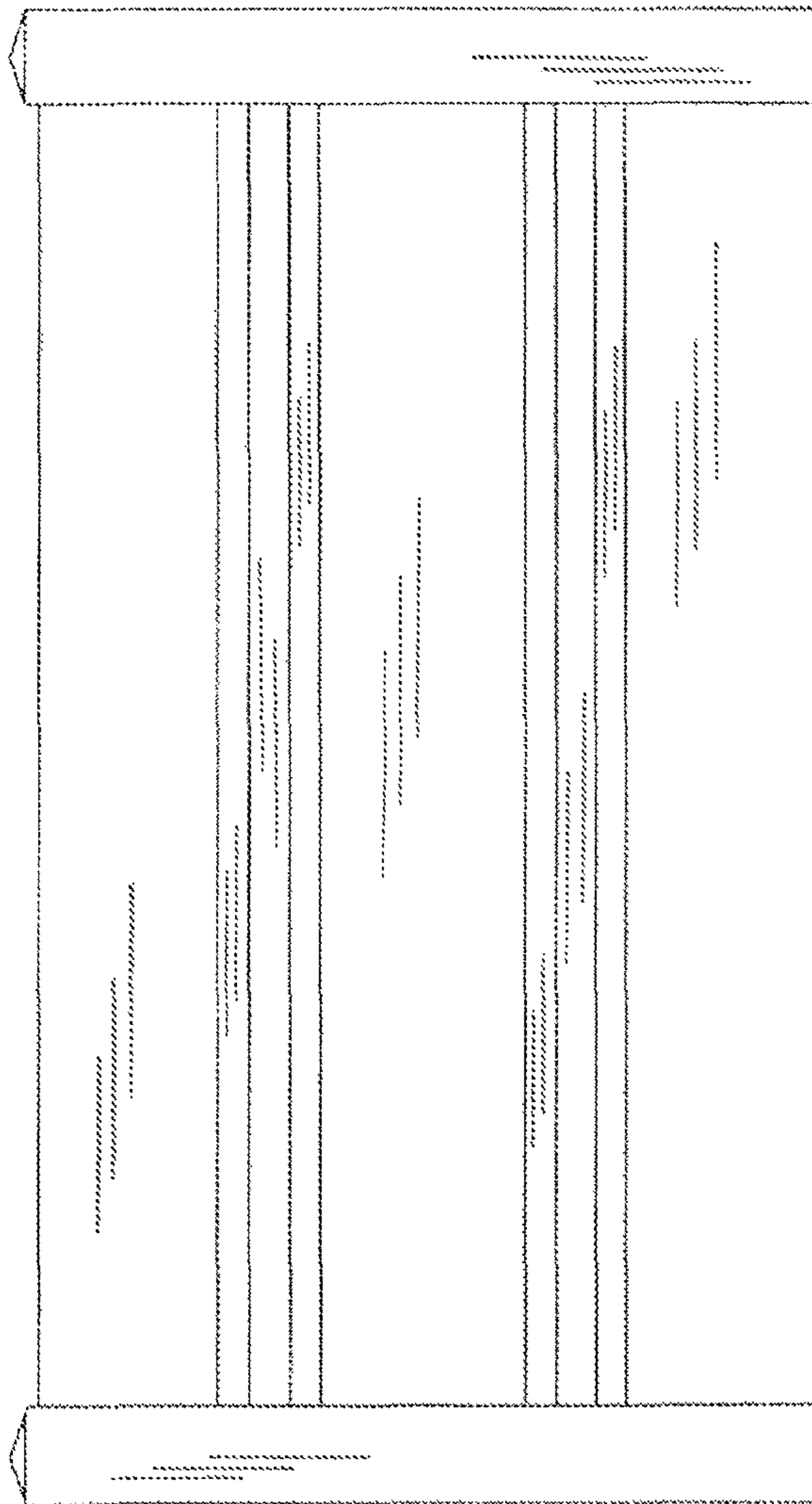

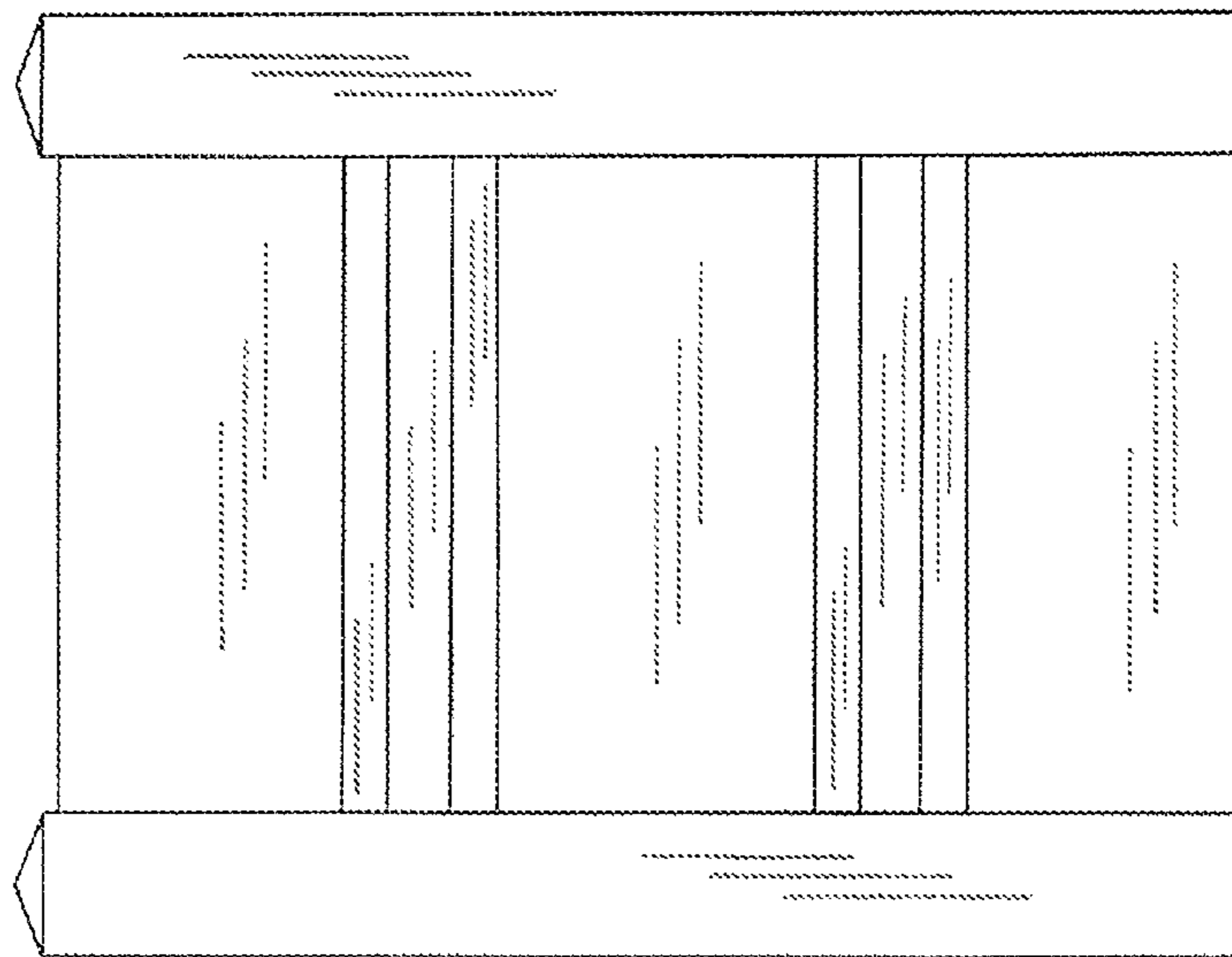

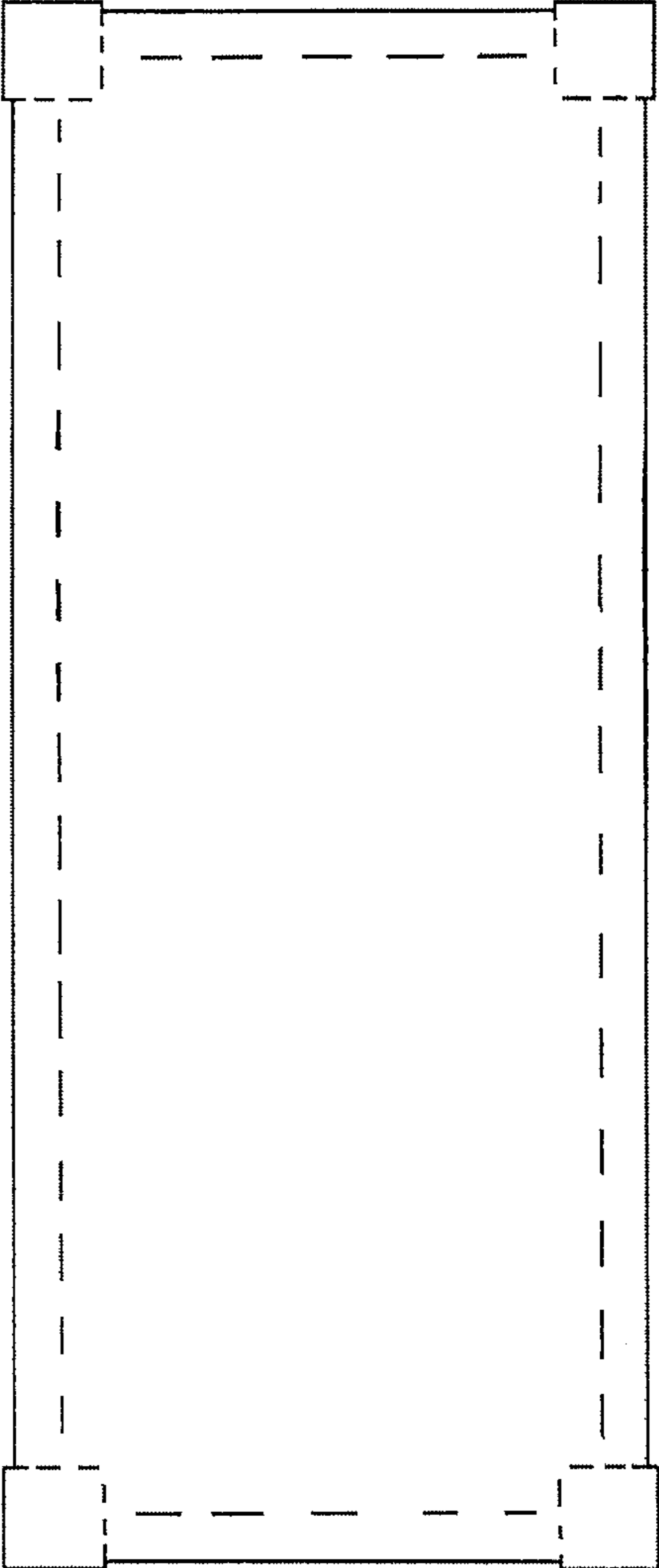

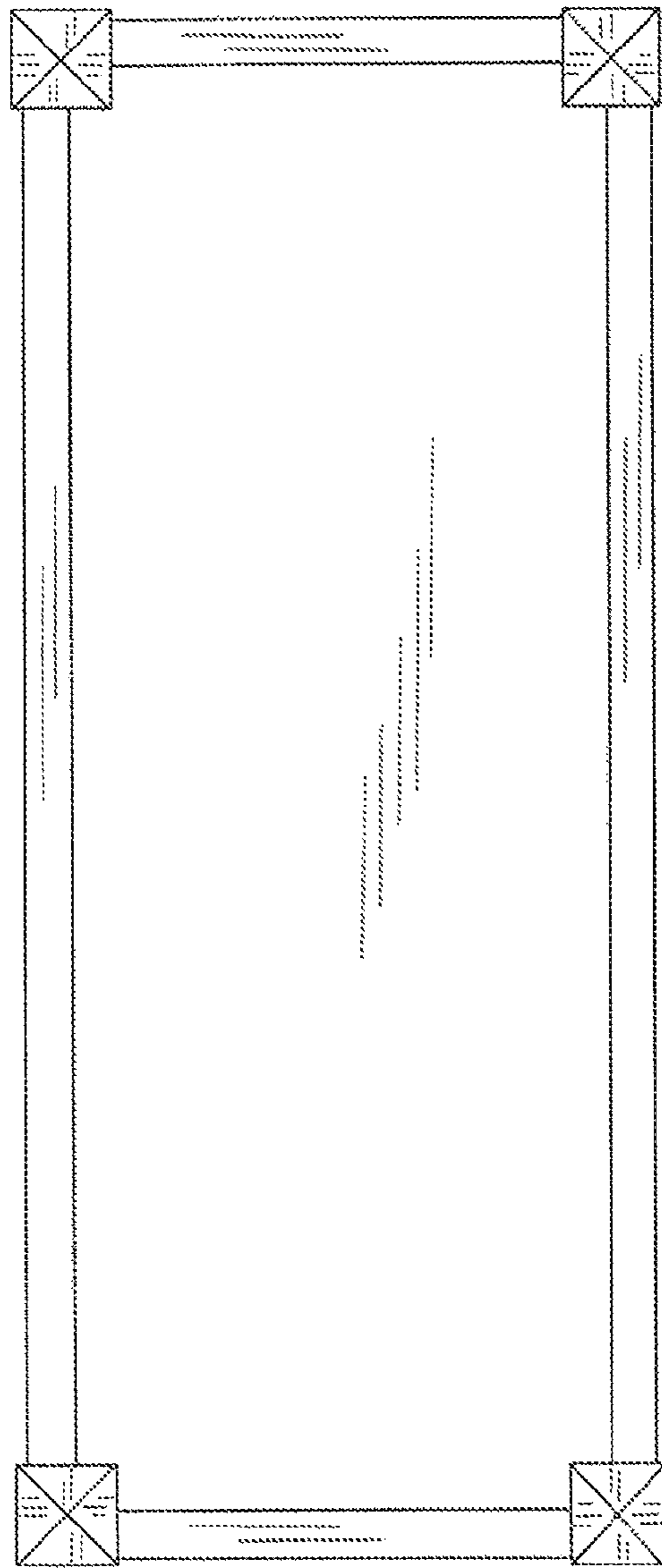
