The ornamental design for a tablet PC, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a tablet PC;

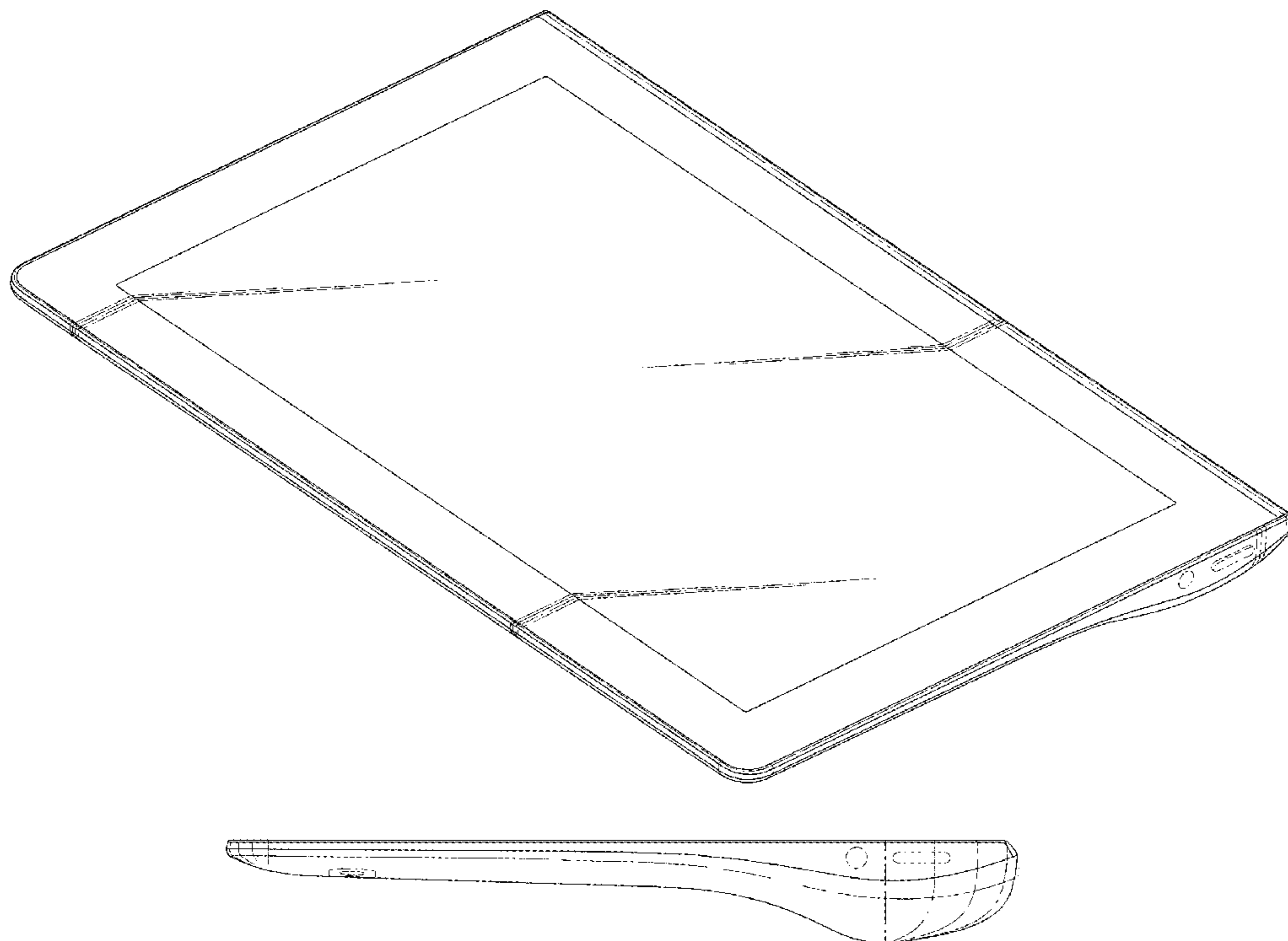

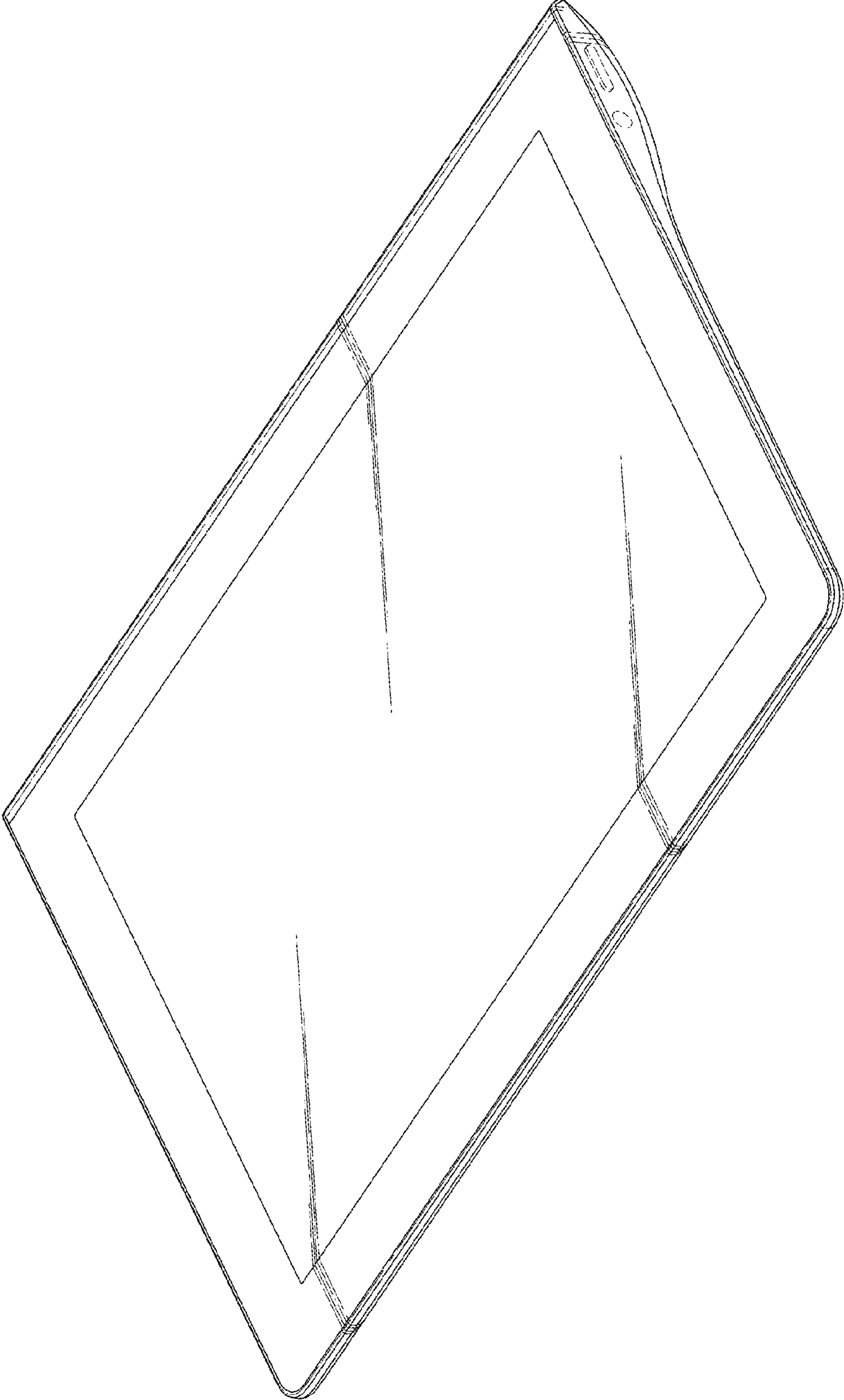

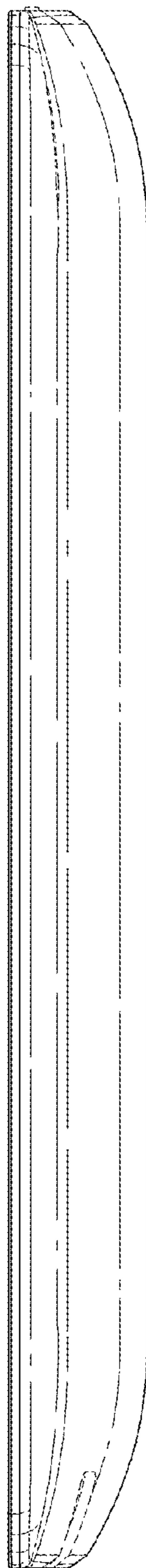

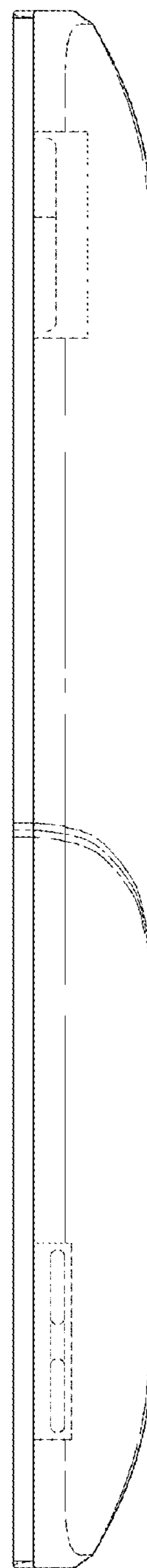

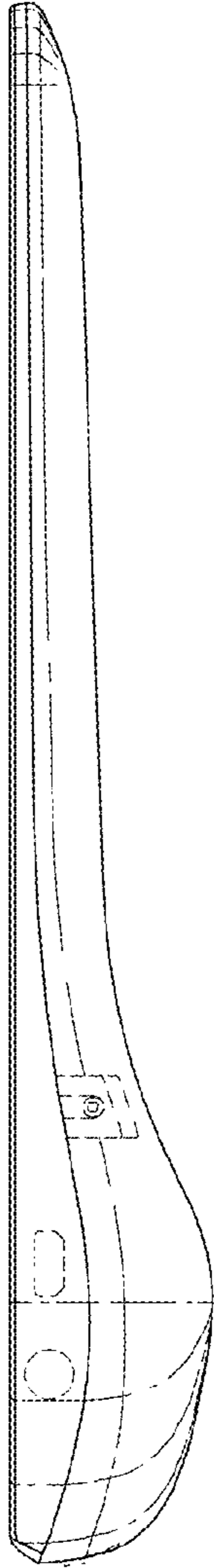

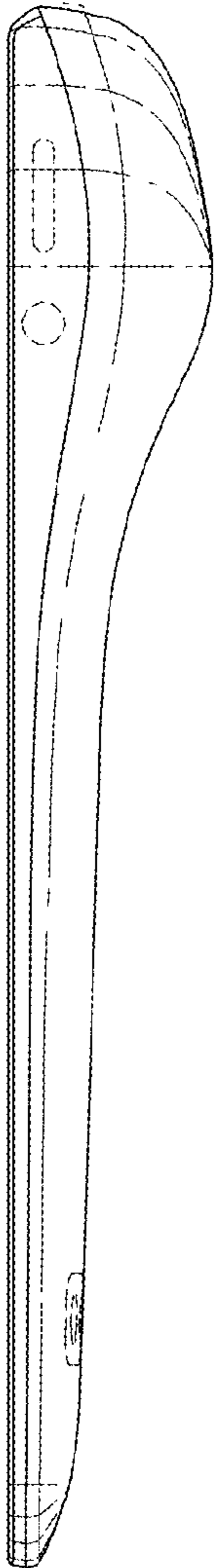

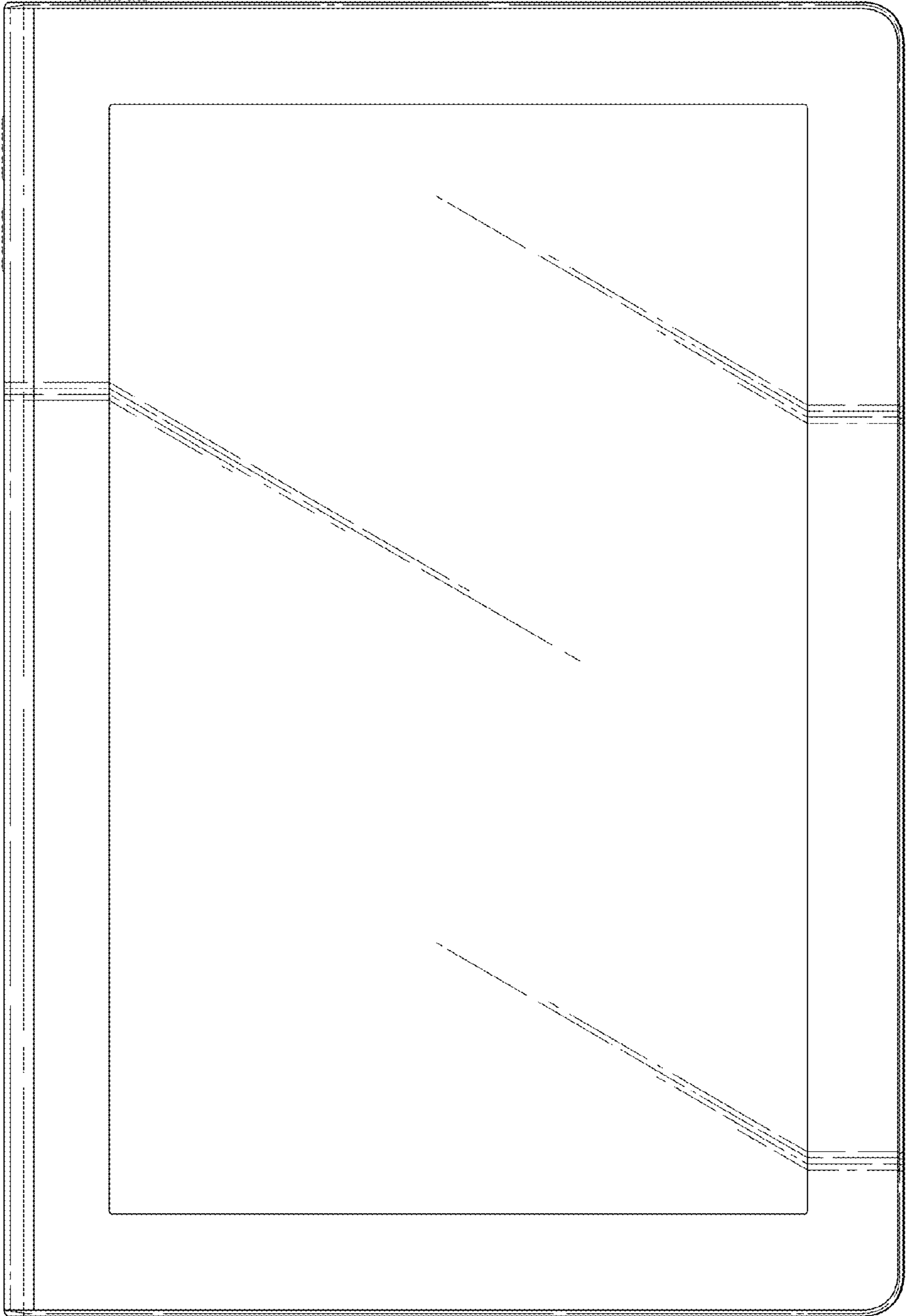
