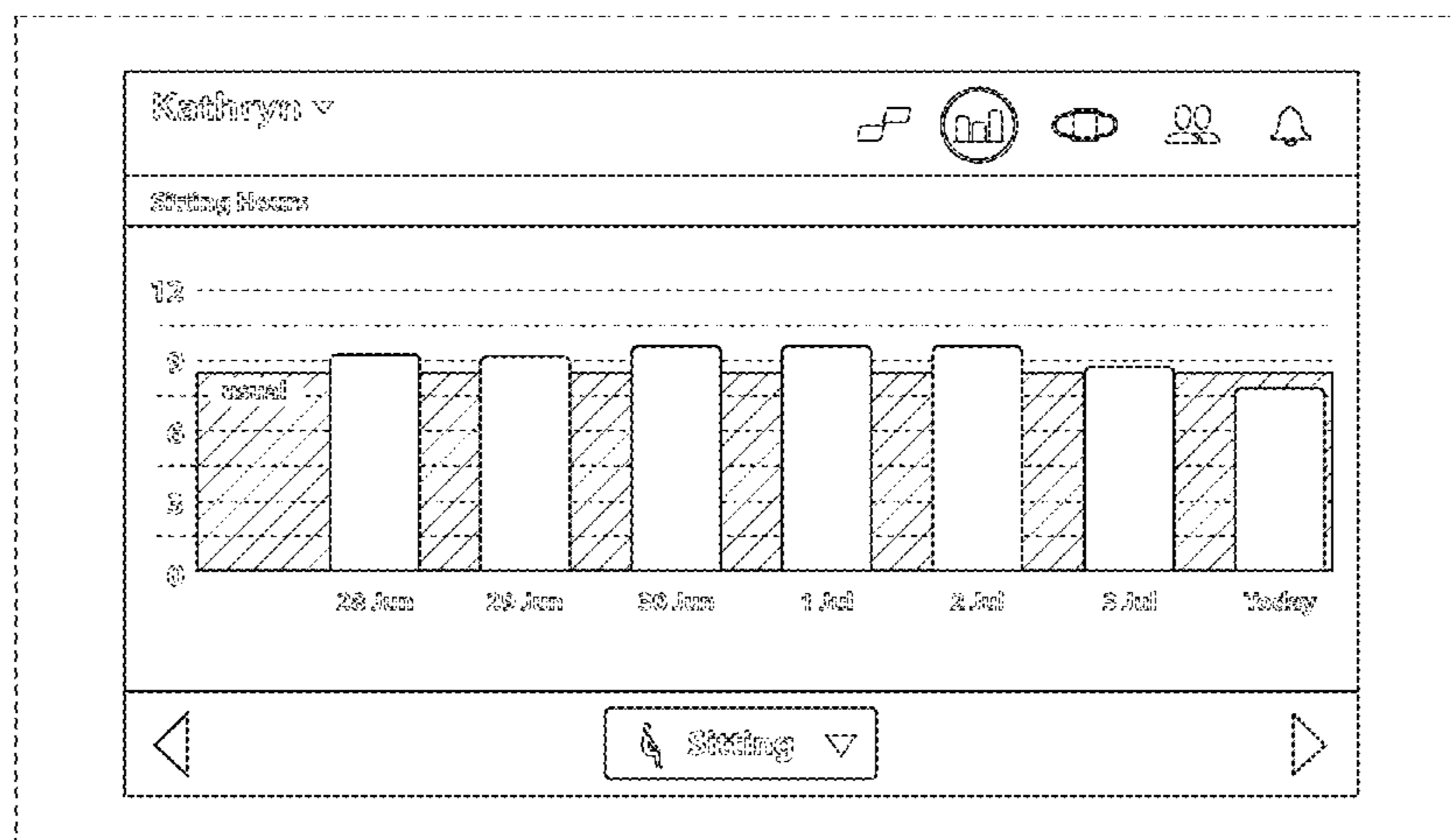
(57) **CLAIM**

The ornamental design for display screen portion having a graphical user interface for patient monitoring, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen portion having a graphical user interface for patient monitoring, showing the new design as it would appear on a mobile device; and, FIG. 2 is a front view of a display screen portion having a graphical user interface for patient monitoring, showing the new design as it would appear on a desktop device. The broken line showings of the device and portions of the graphical user interface are included for the purpose of illustrating environmental structure and form no part of the claimed design.

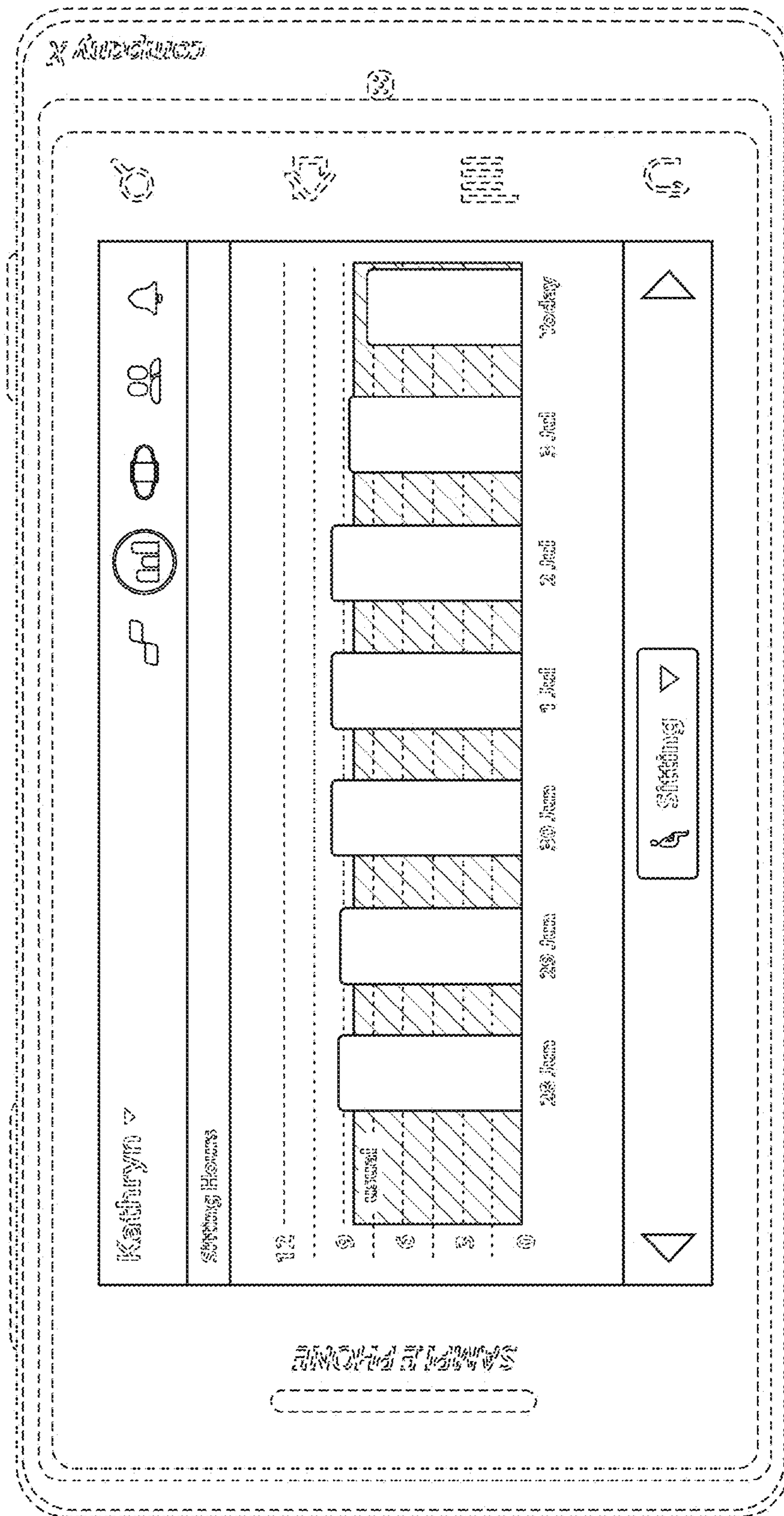

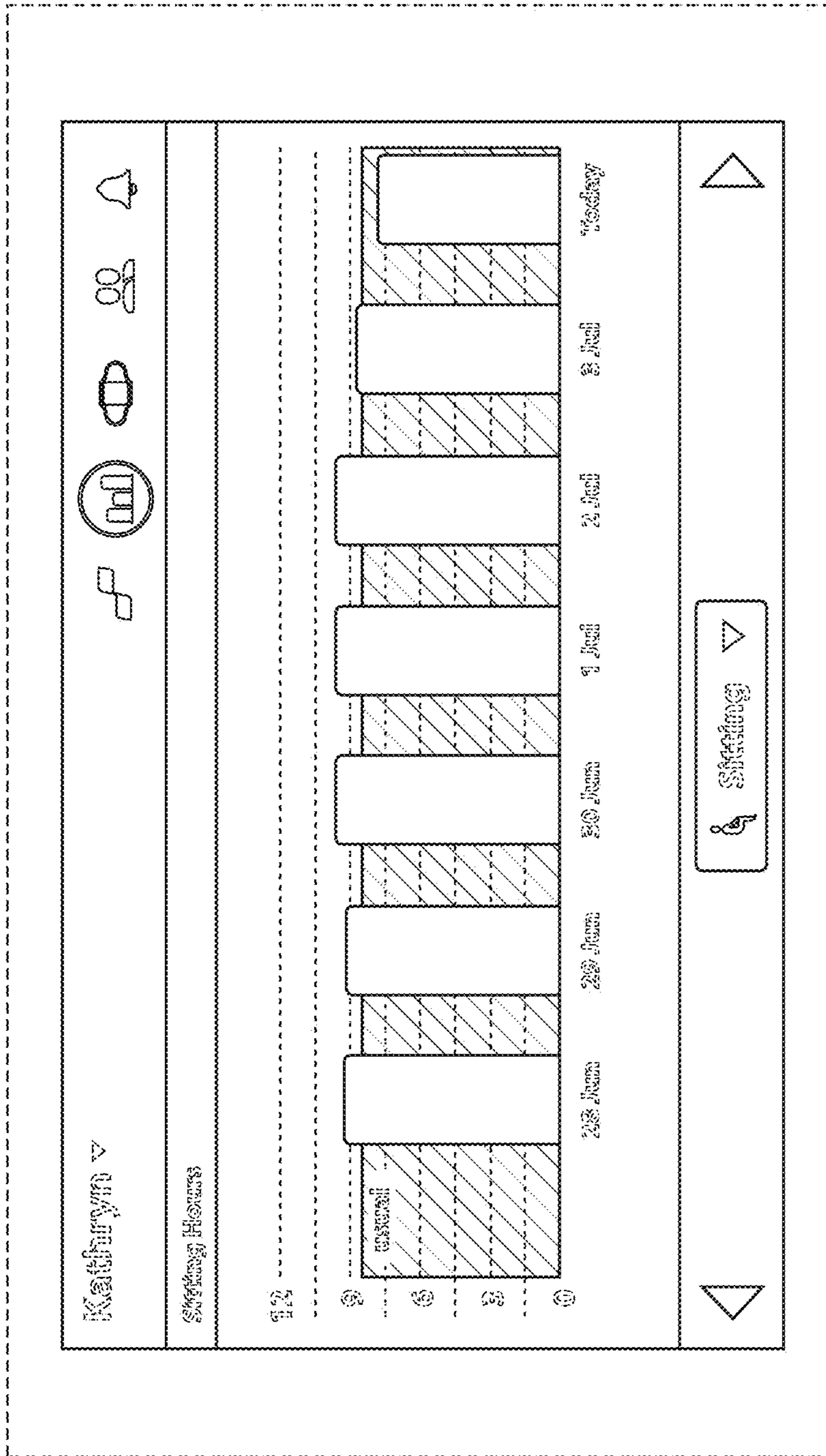
