DESCRIPTION

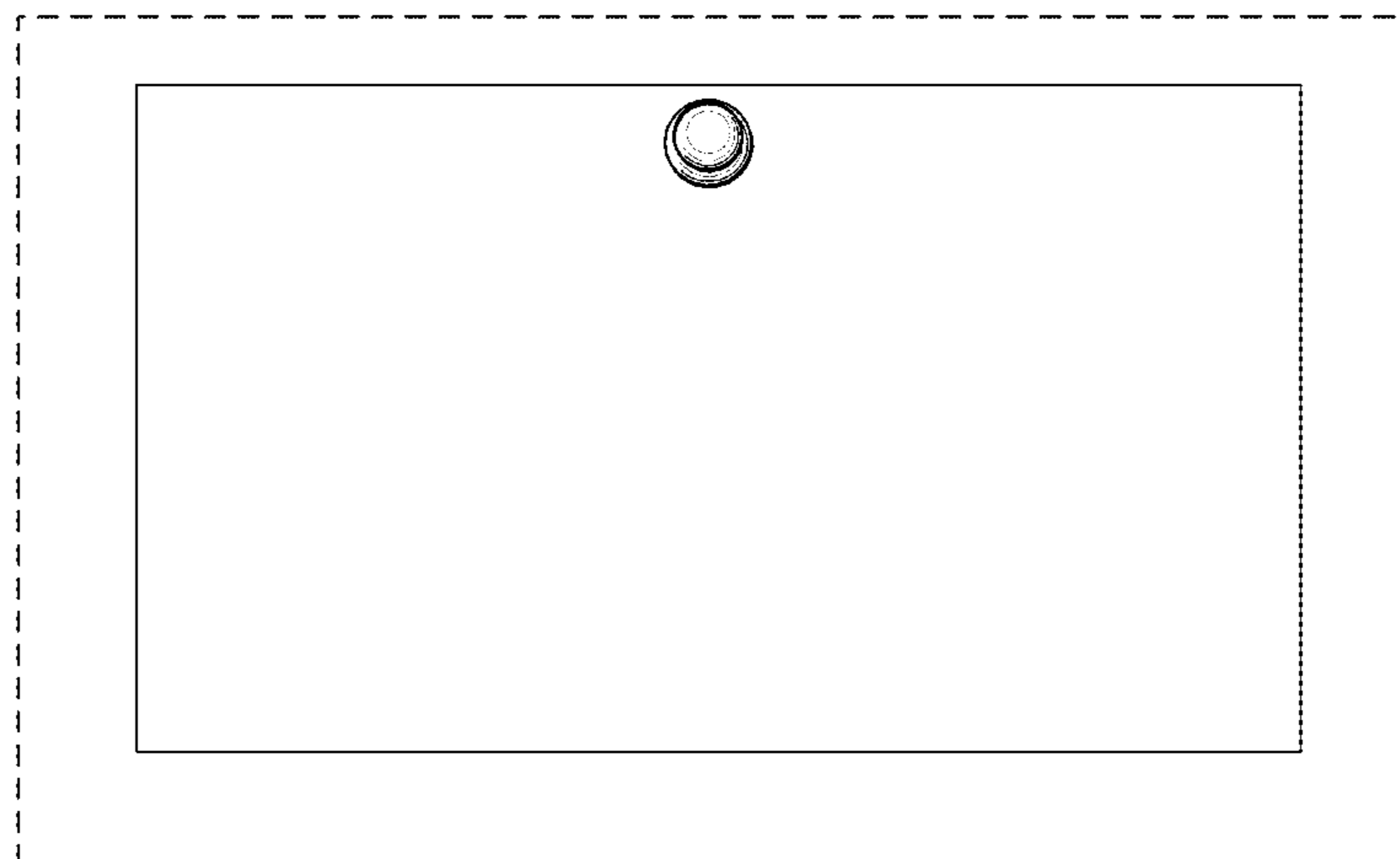
FIG. 1 is a front view of a portion of a display screen with icon

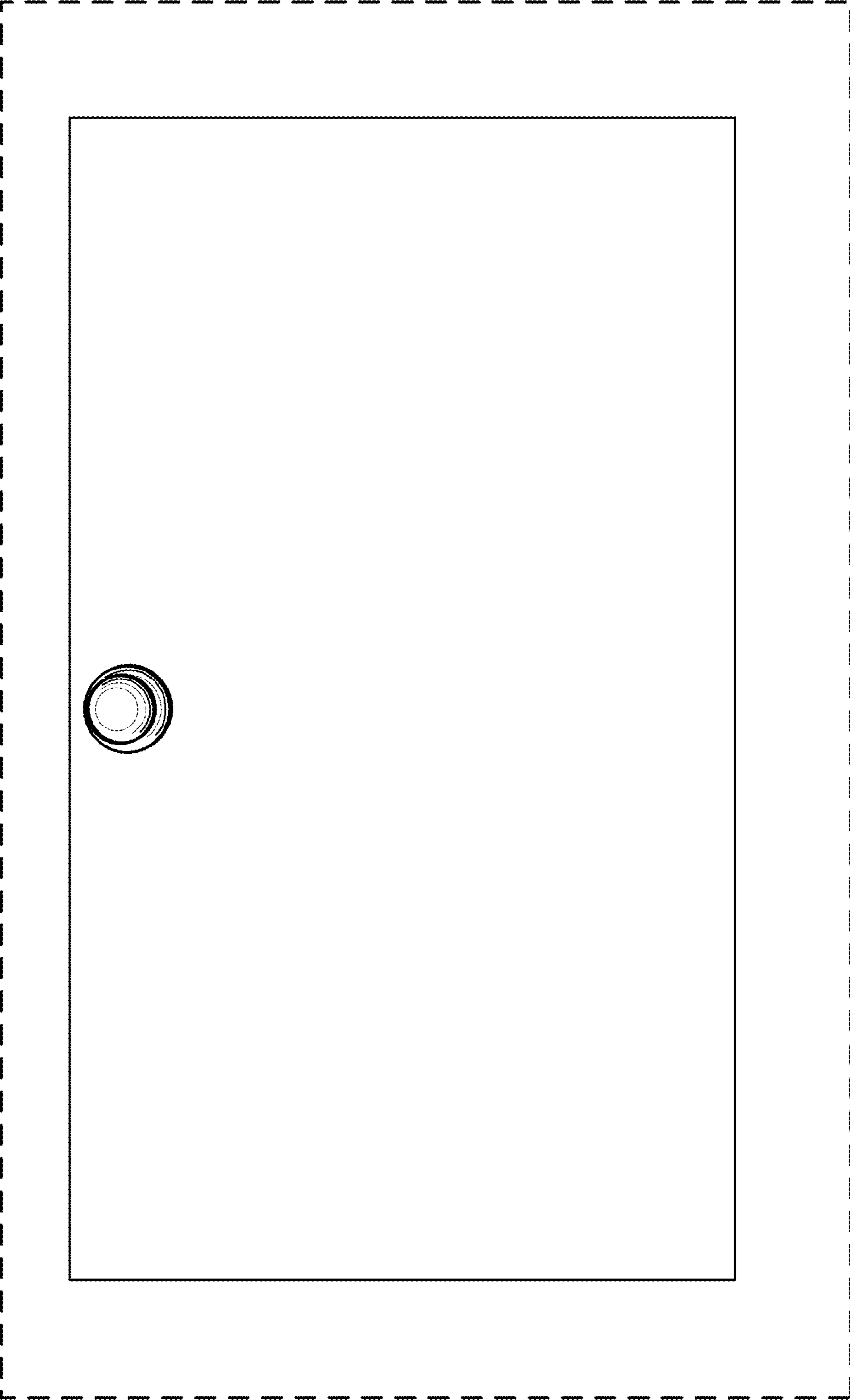

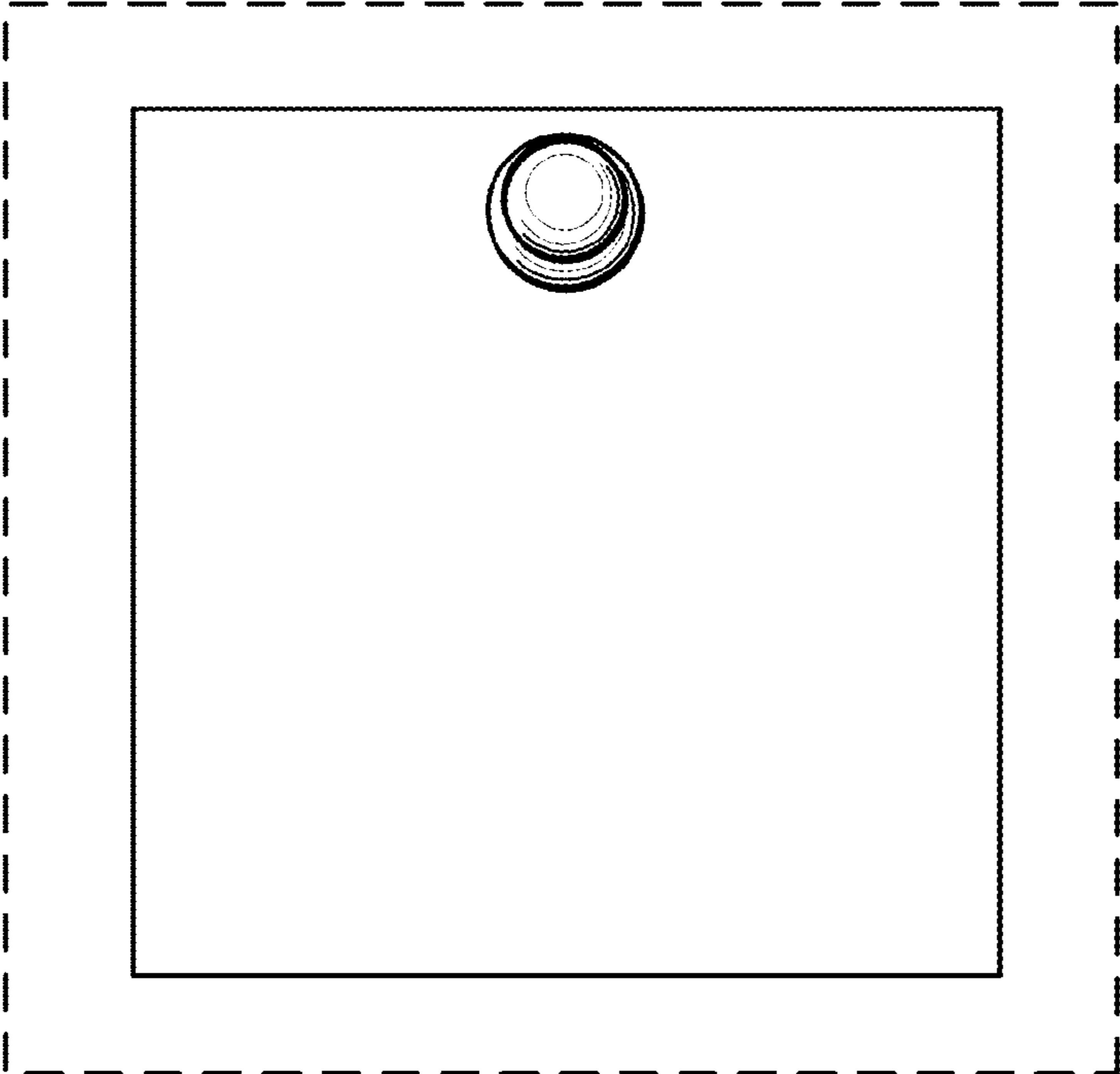
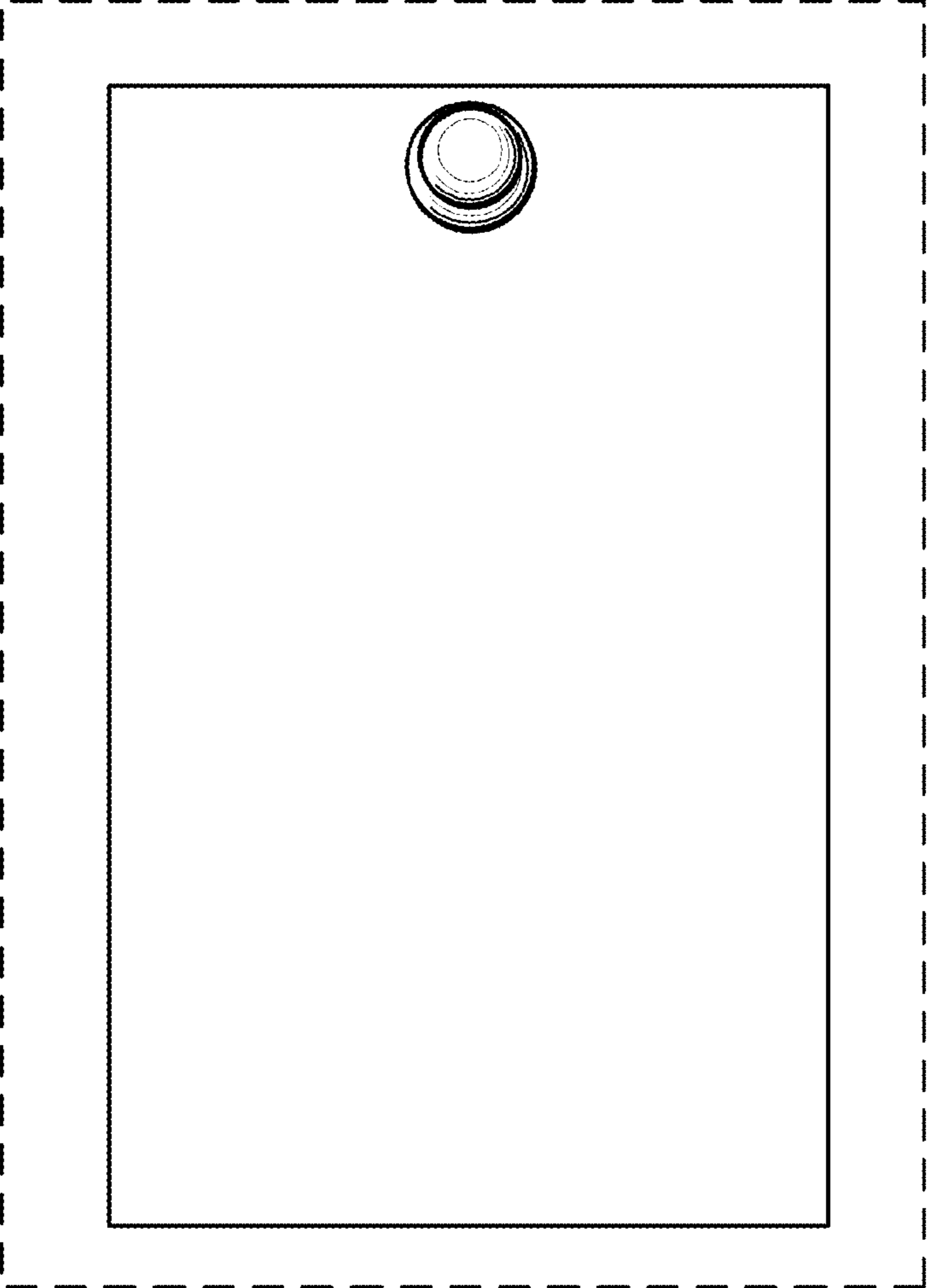
