The ornamental design for a baseball bat, as shown and described.

**DESCRIPTION**

FIG. 10 is a front view of the second embodiment of the baseball bat;

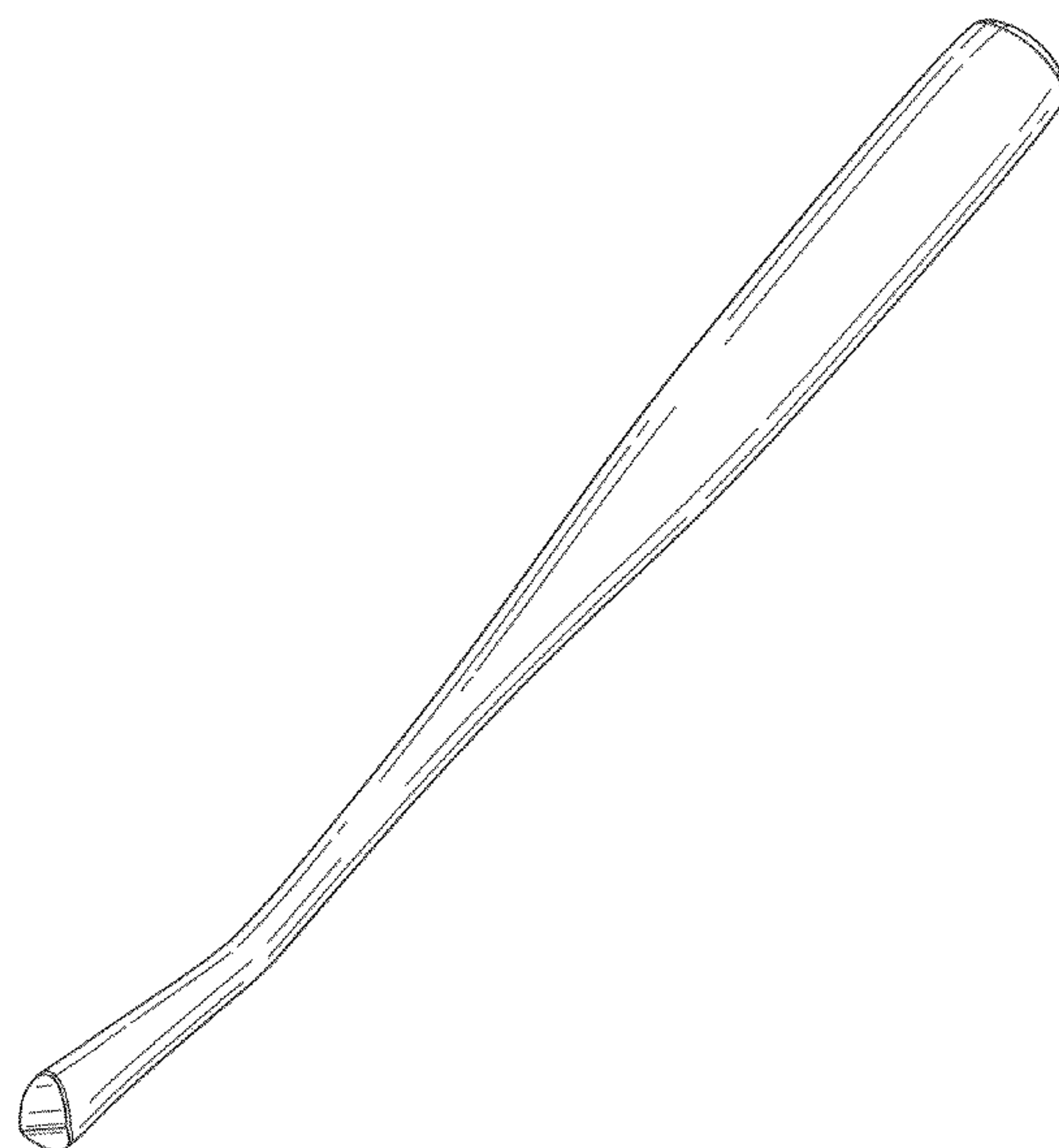
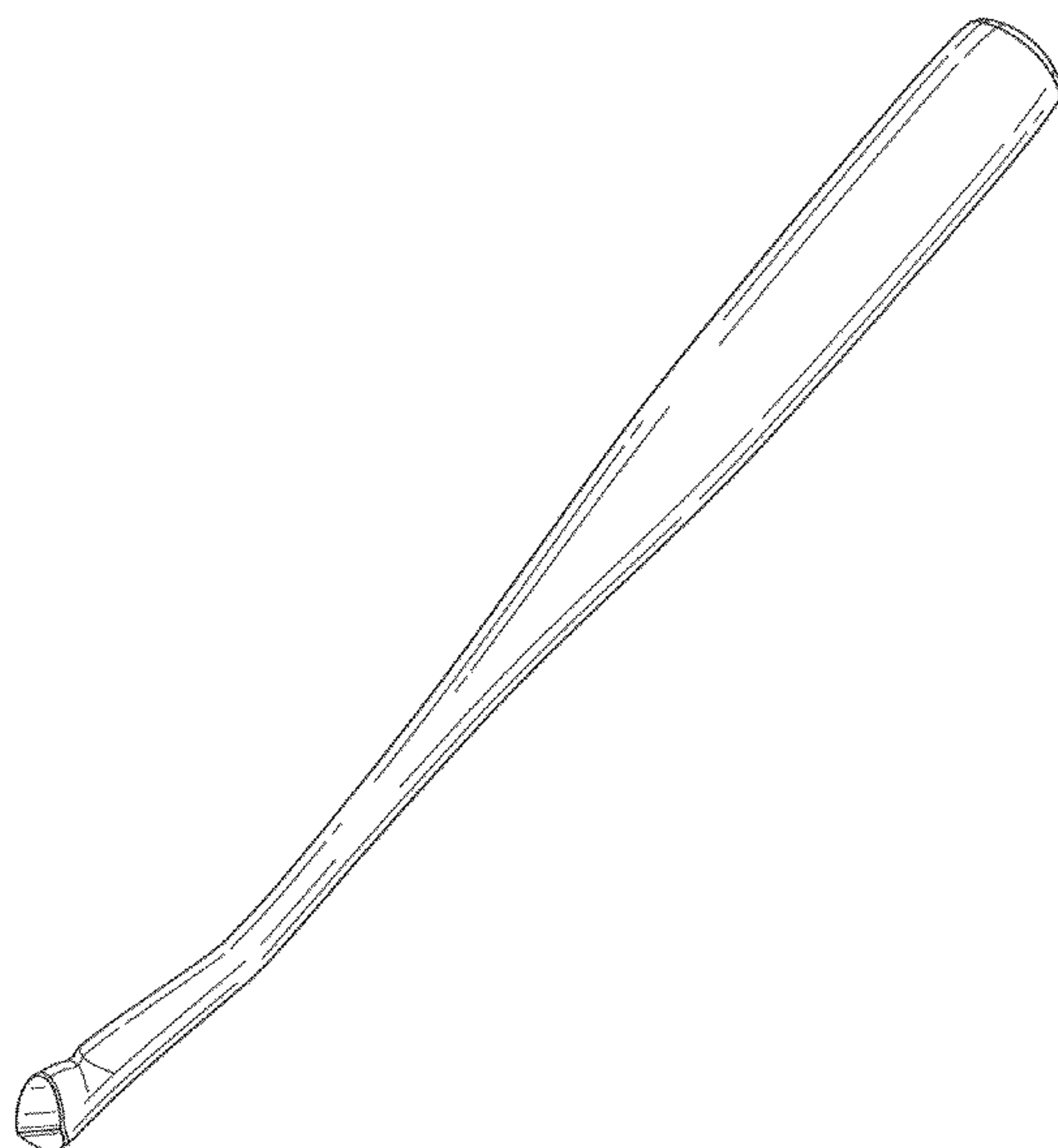
FIG. 11 is a rear view of the second embodiment of the baseball bat;

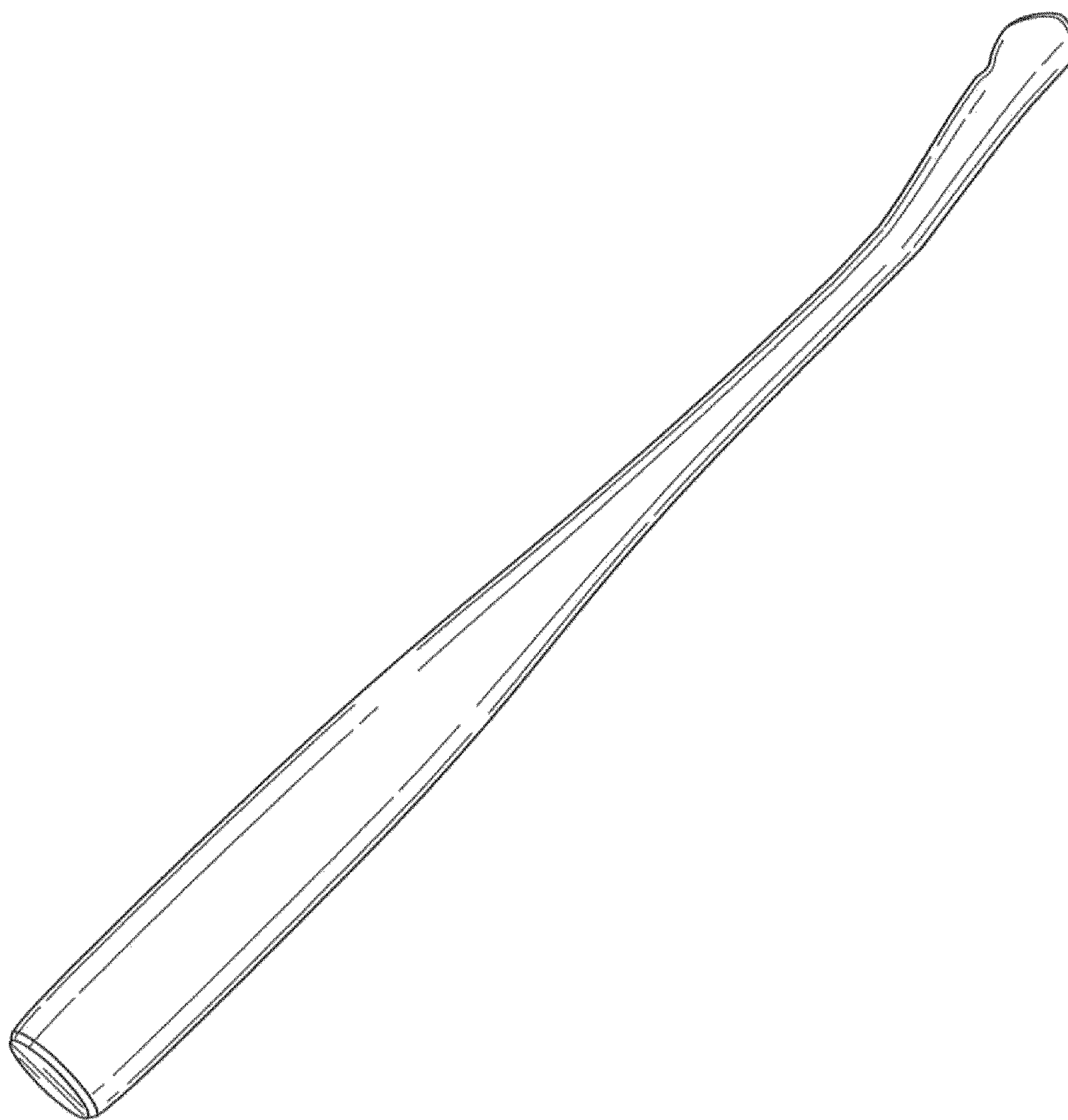

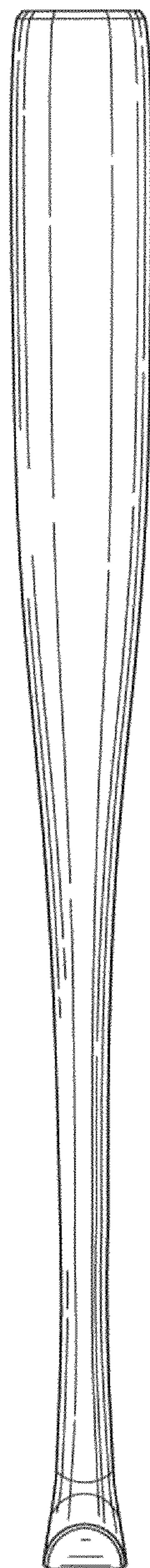

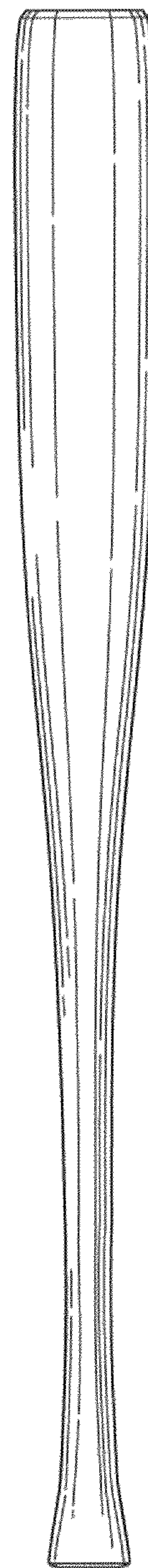

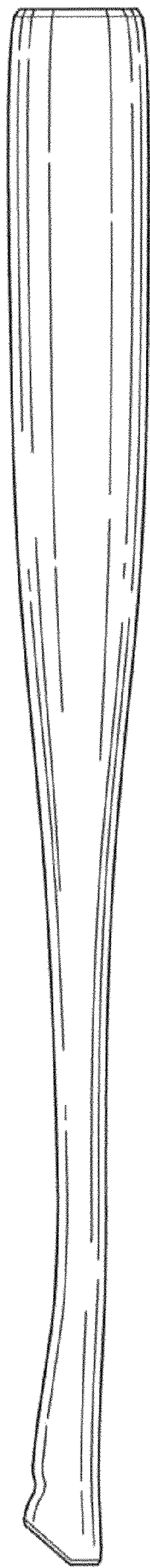

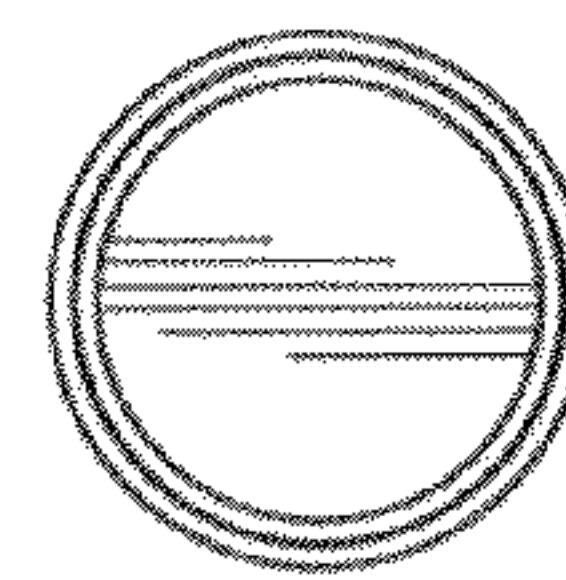

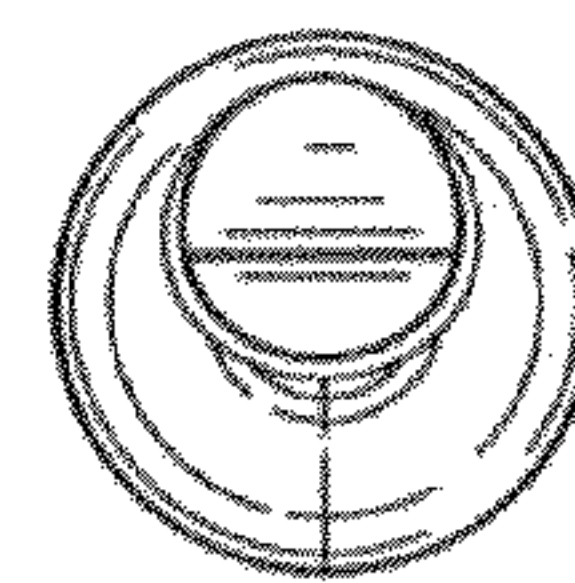

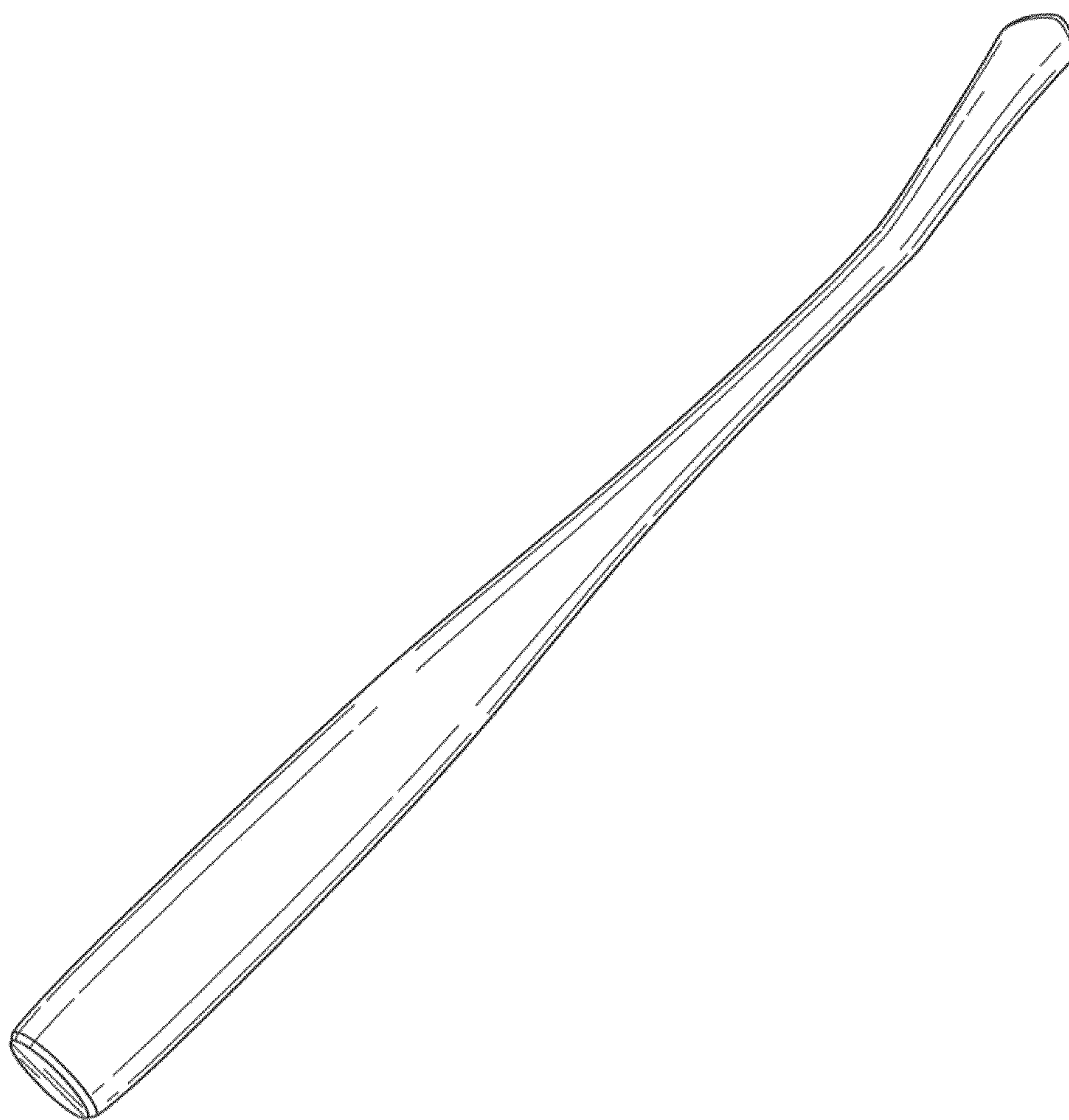

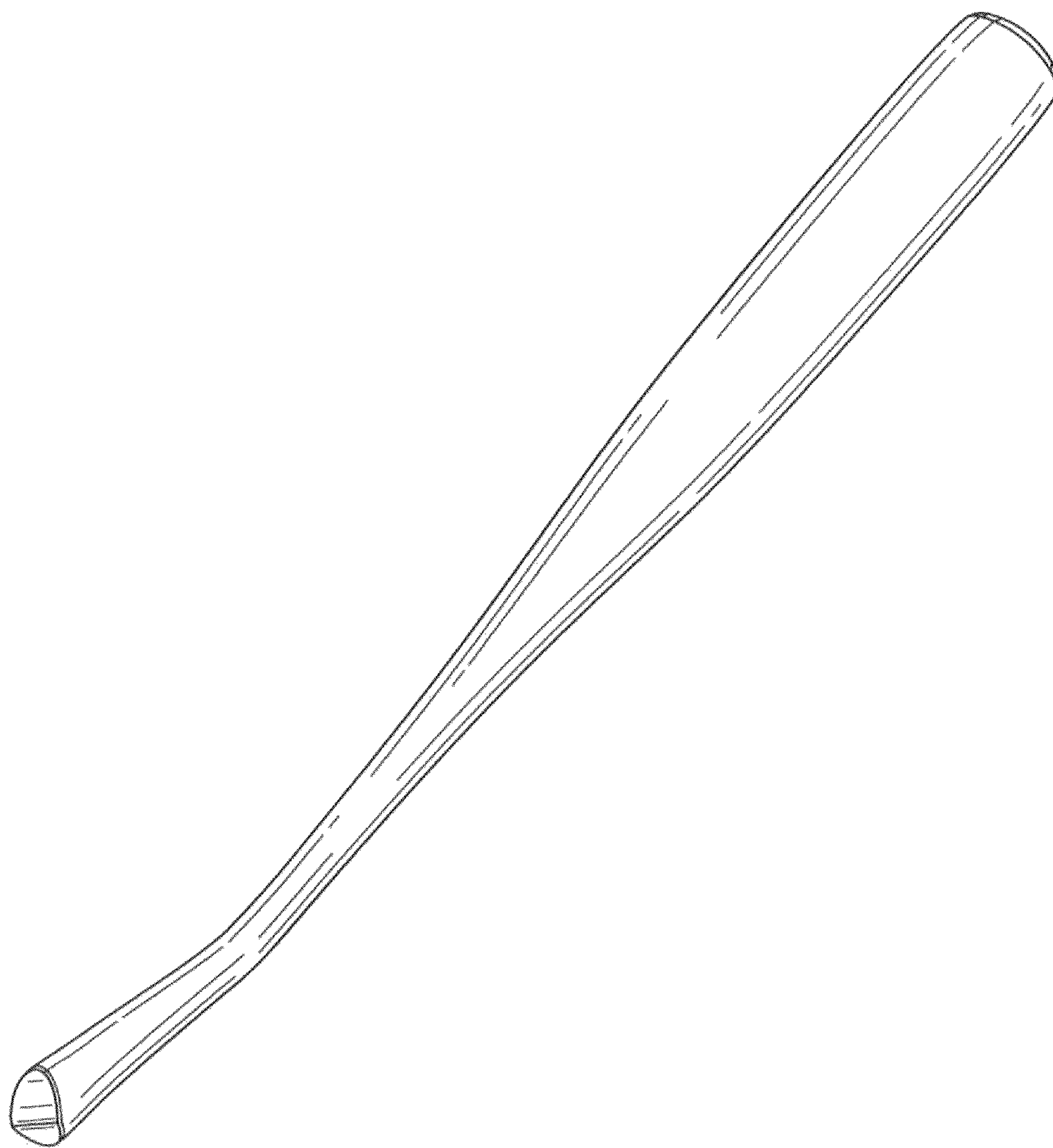

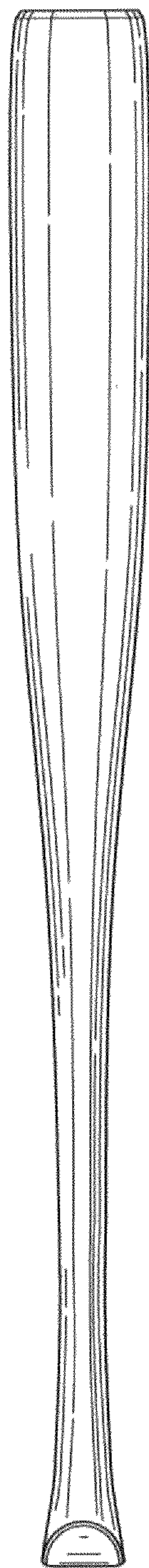

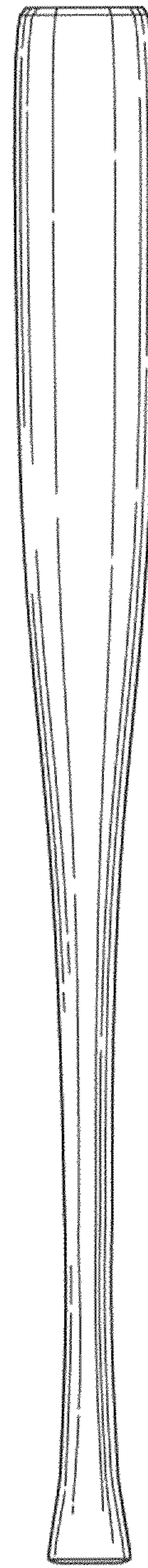

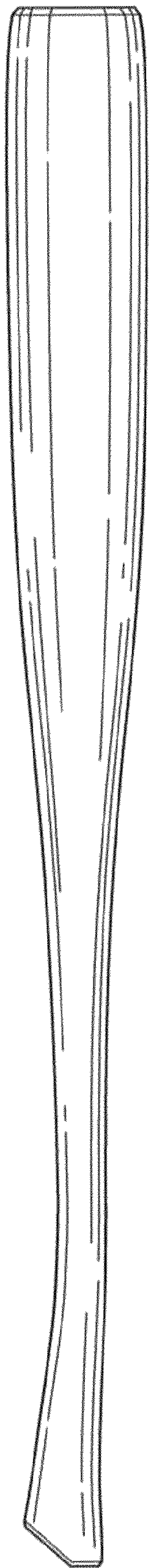

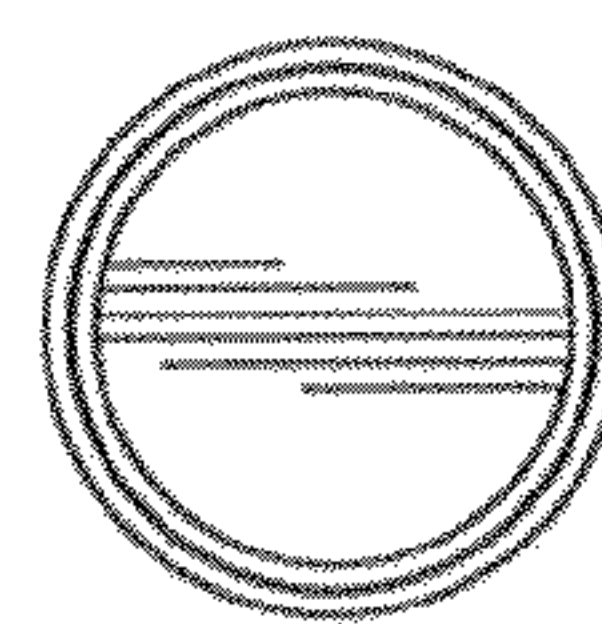

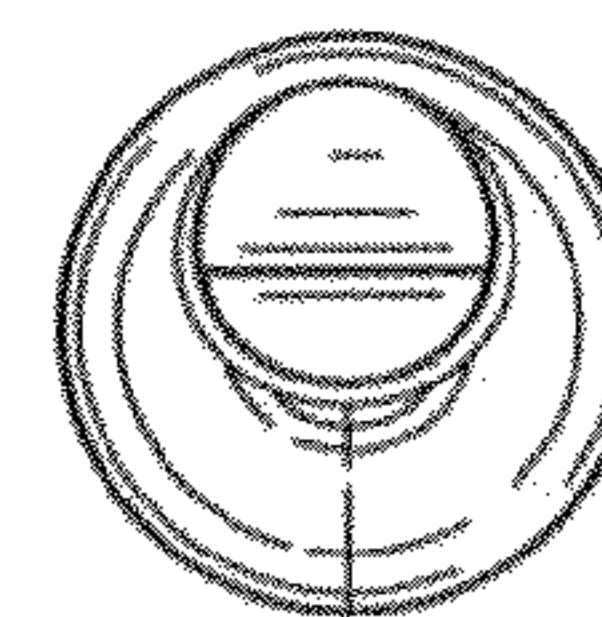
