(57) **CLAIM**

I claim the ornamental design for a lip balm applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the lip balm applicator; FIG. 2 is an exploded perspective view of the lip balm applicator; FIG. 3 is a front elevational view thereof with the top, bottom and rear views being the same in appearance; FIG. 4 is a right side elevational view thereof; and, FIG. 5 is a left side elevational view thereof. The dash-dot lines illustrate the environment and form no part of the claimed design.
