FIG. 3 is a rear elevational view of the snack food of FIG. 1.

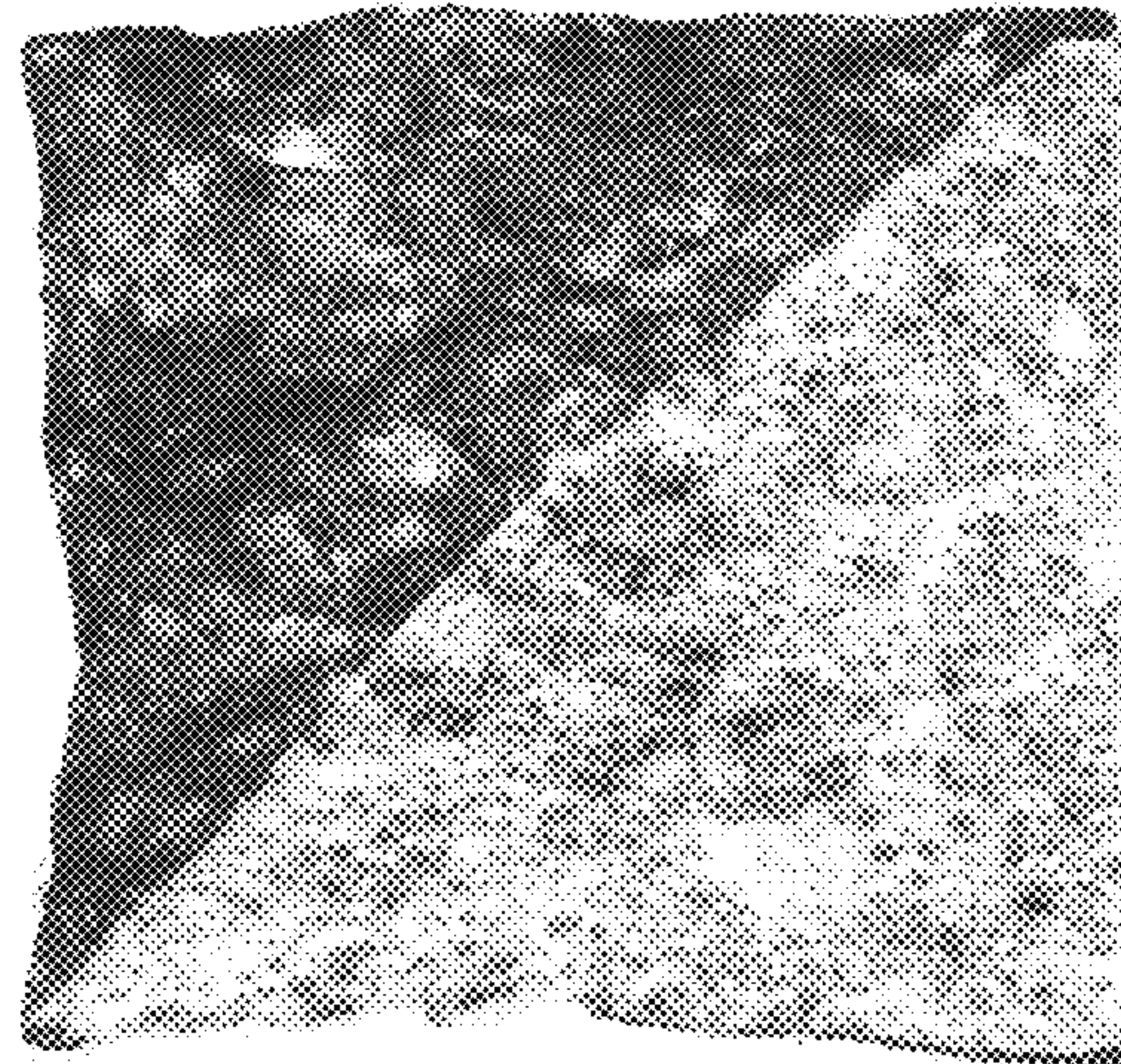
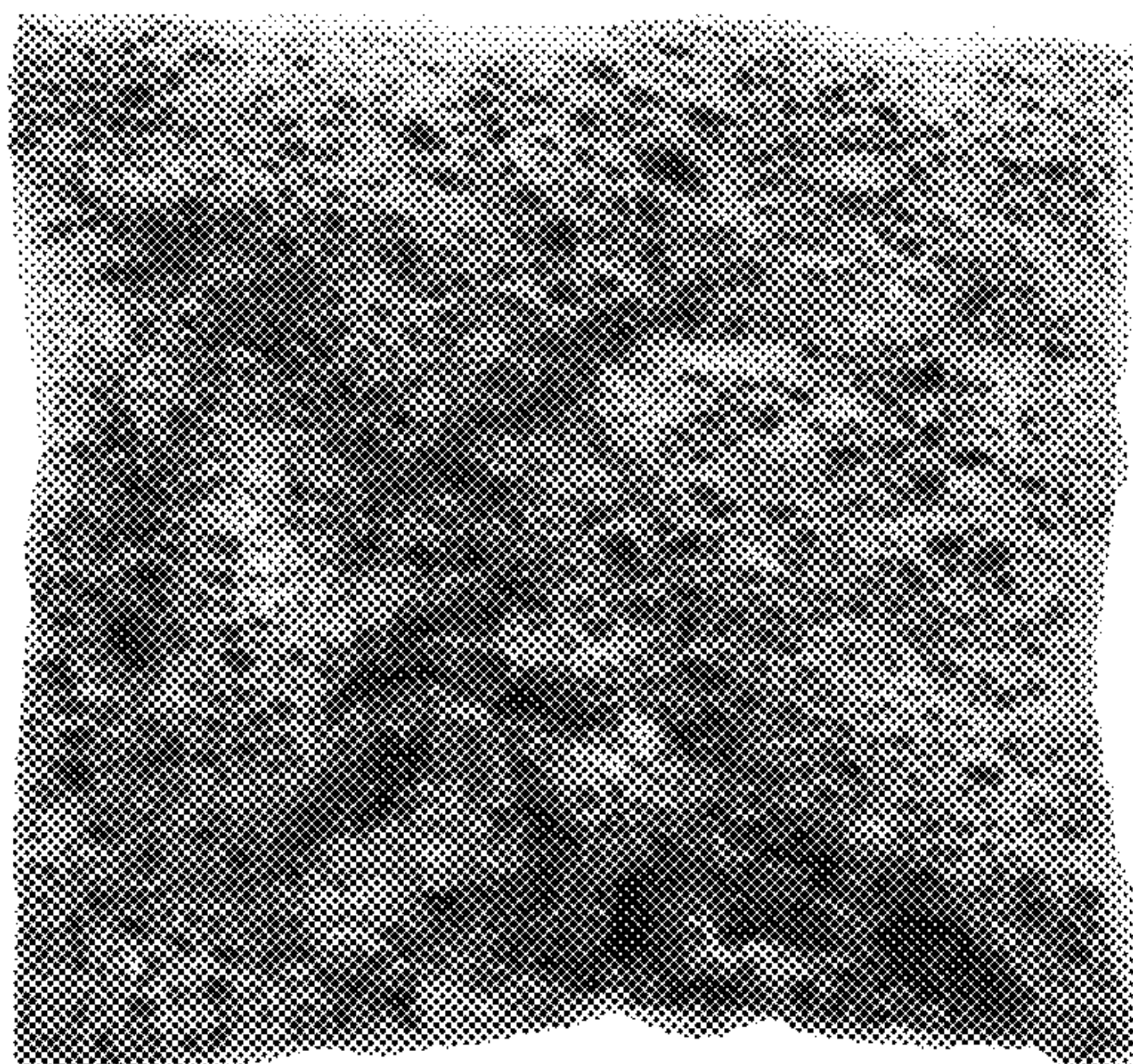
FIG. 4 is a left side elevational view of the snack food of FIG. 1.

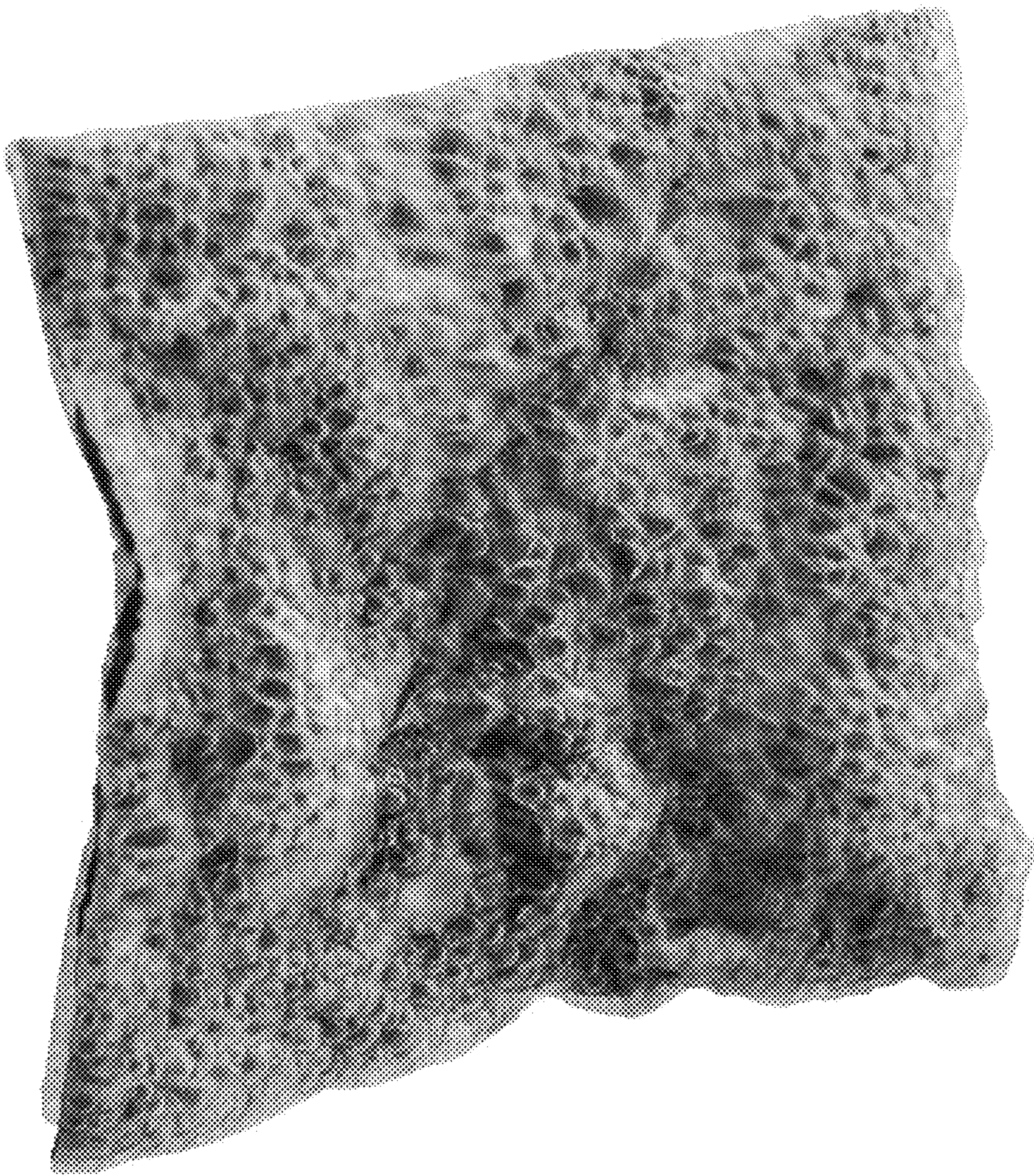

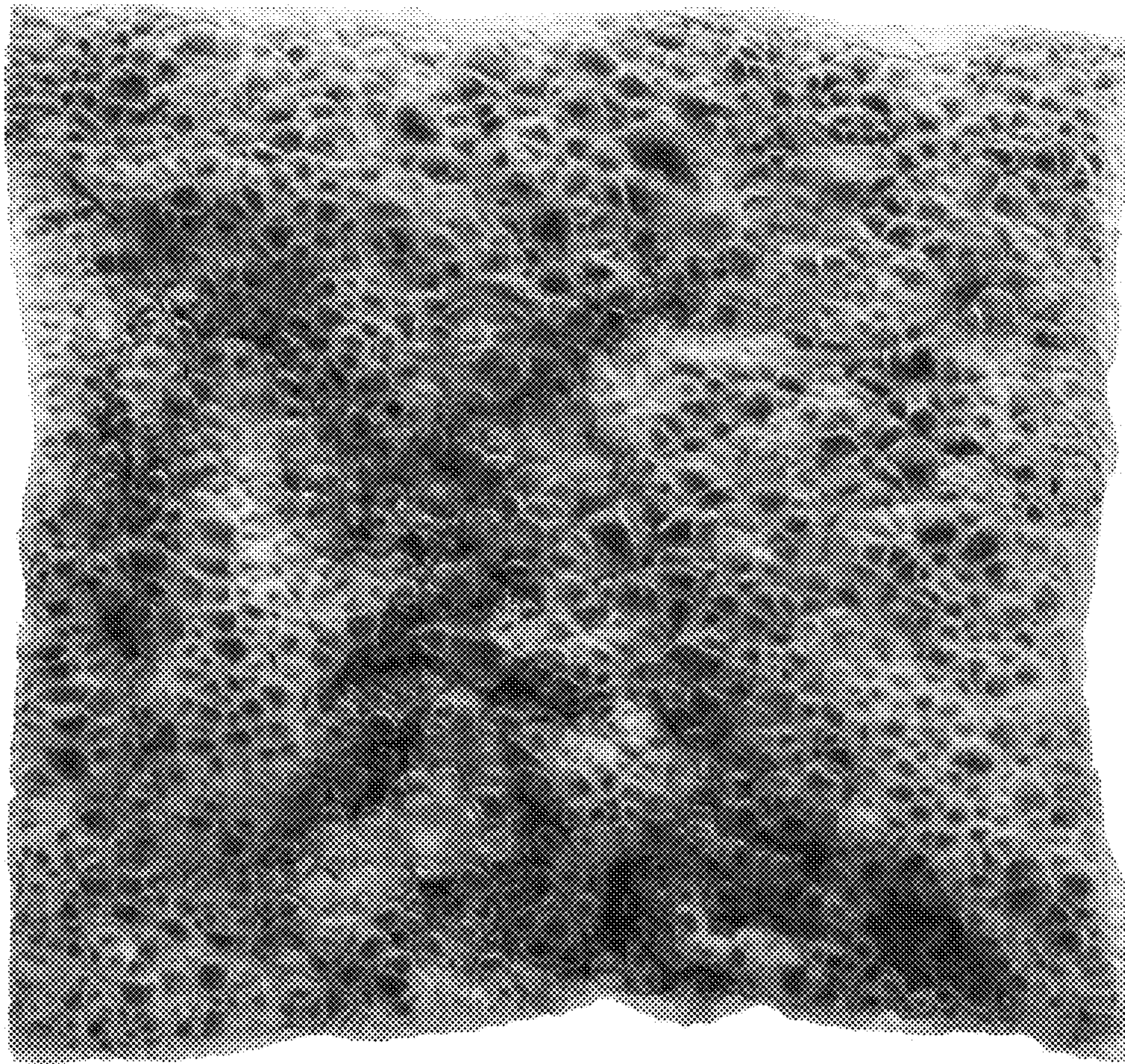

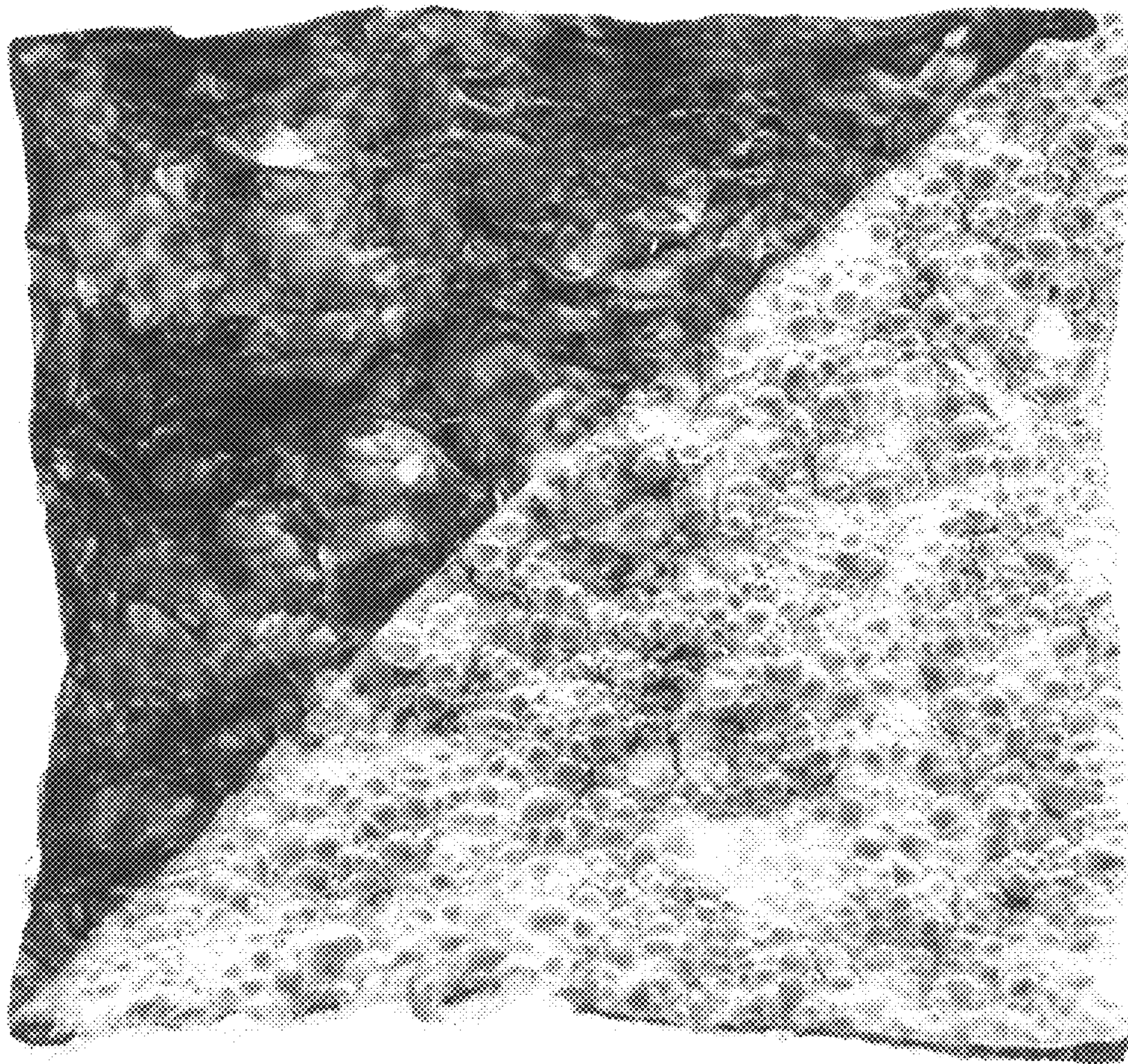

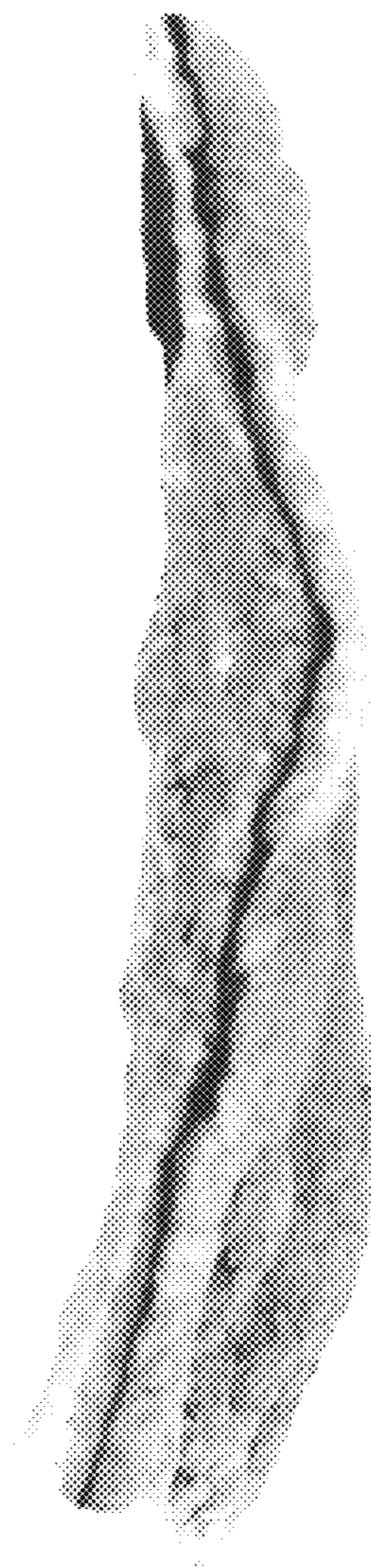

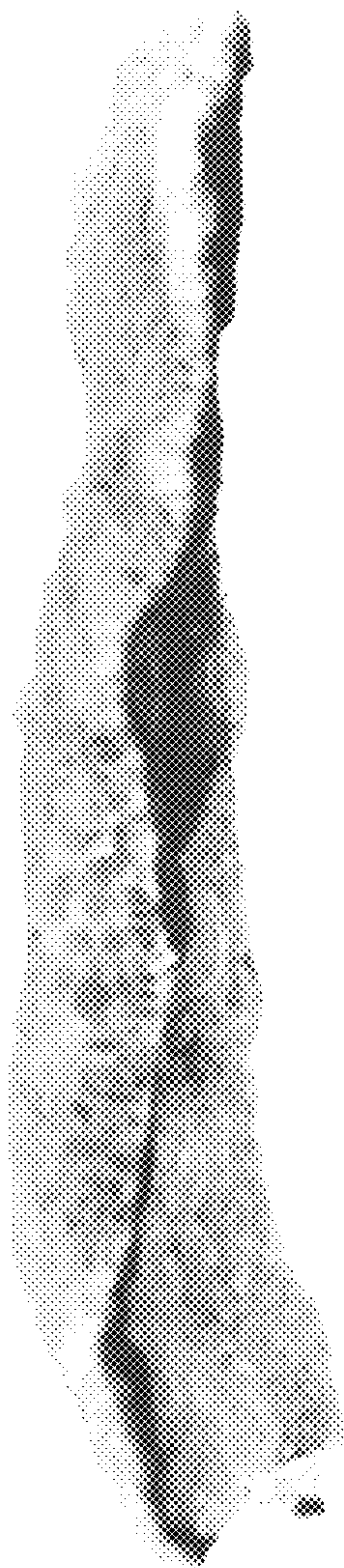
