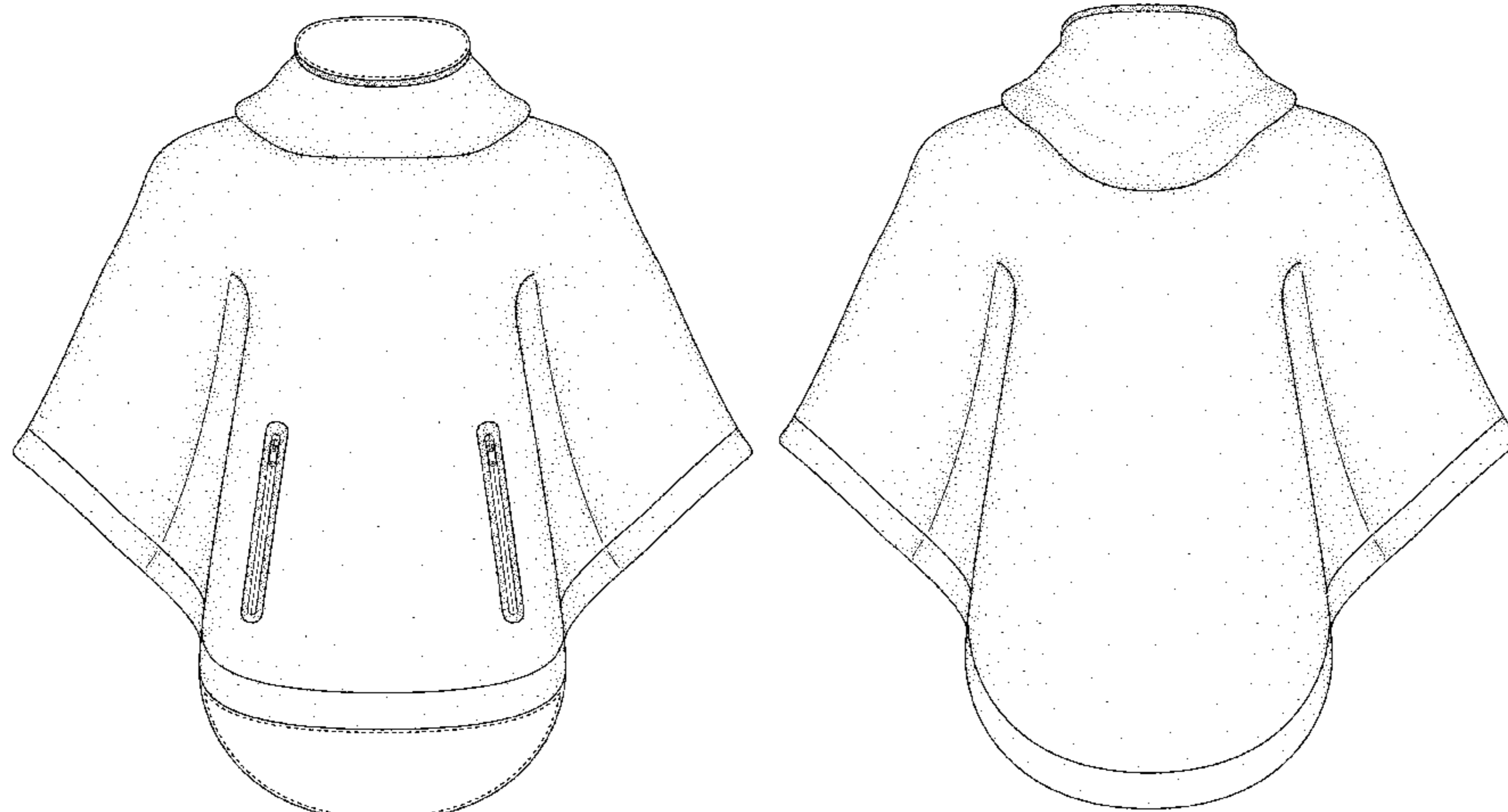
(57) **CLAIM**

The ornamental design for a poncho, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of a poncho showing our new design in an in-use configuration;
FIG. 2 is a right perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right view thereof; and,
FIG. 7 is a top view thereof.
The broken lines showing the remainder of the poncho and the unshaded regions therein are for environmental purposes only and form no part of the claimed design.

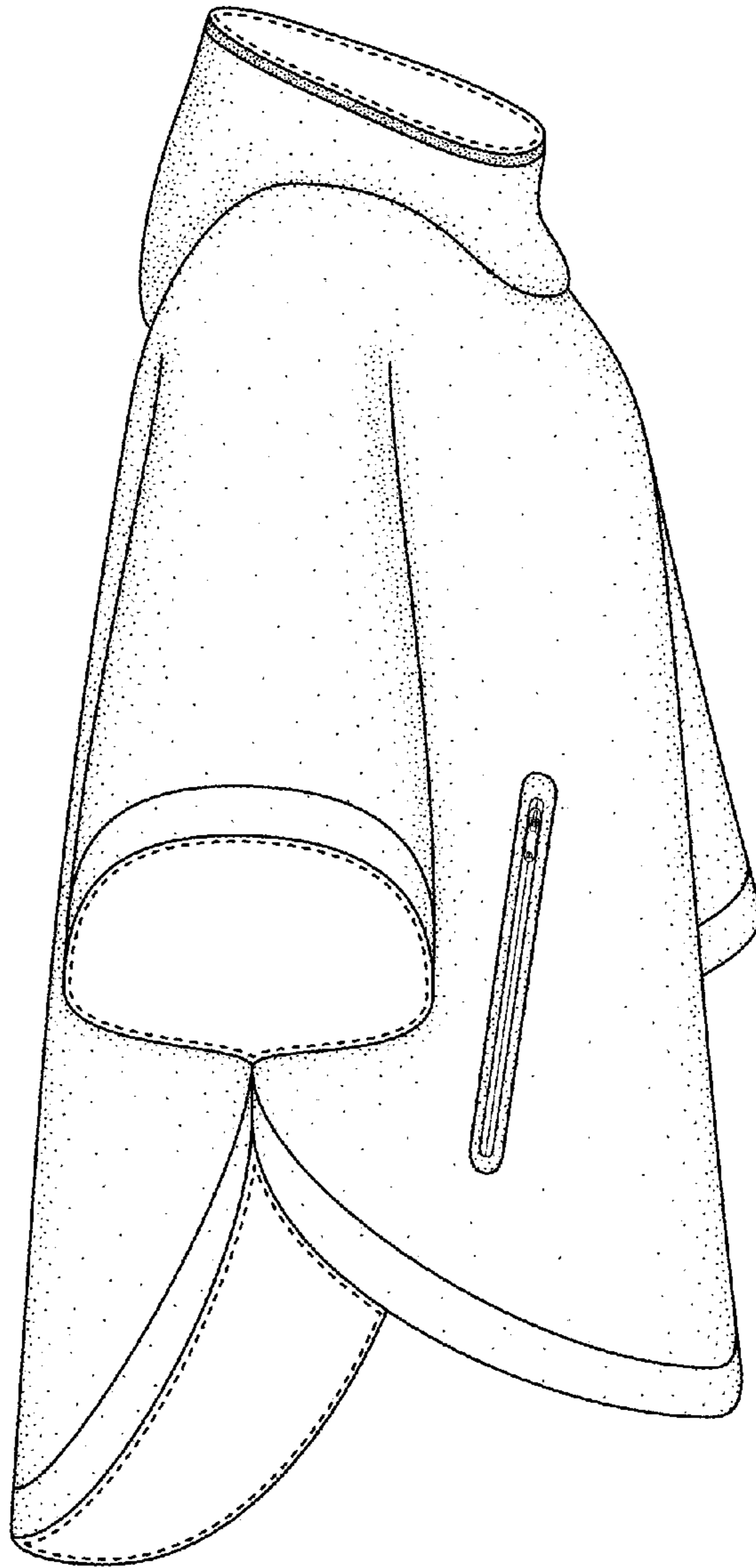

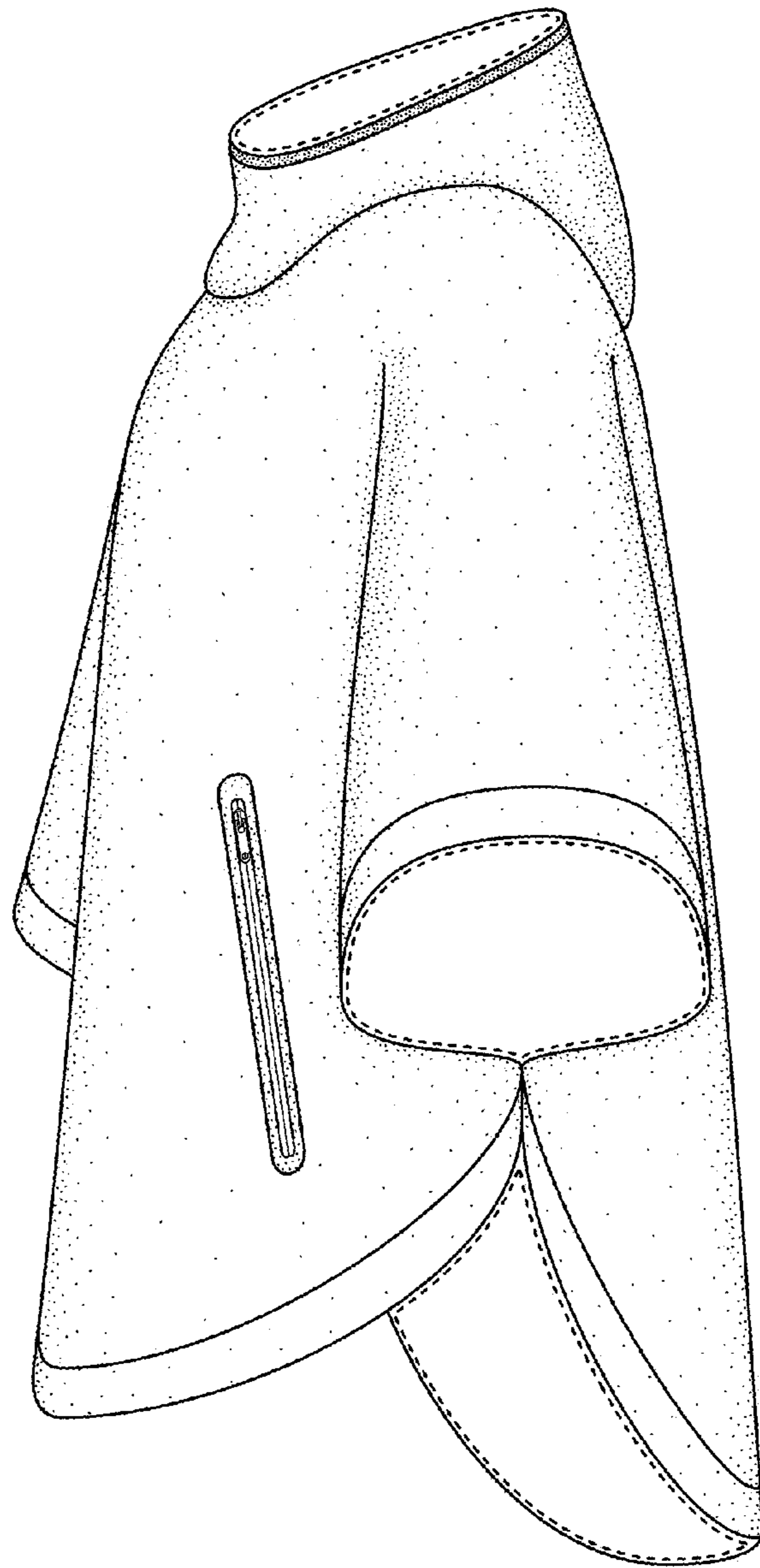

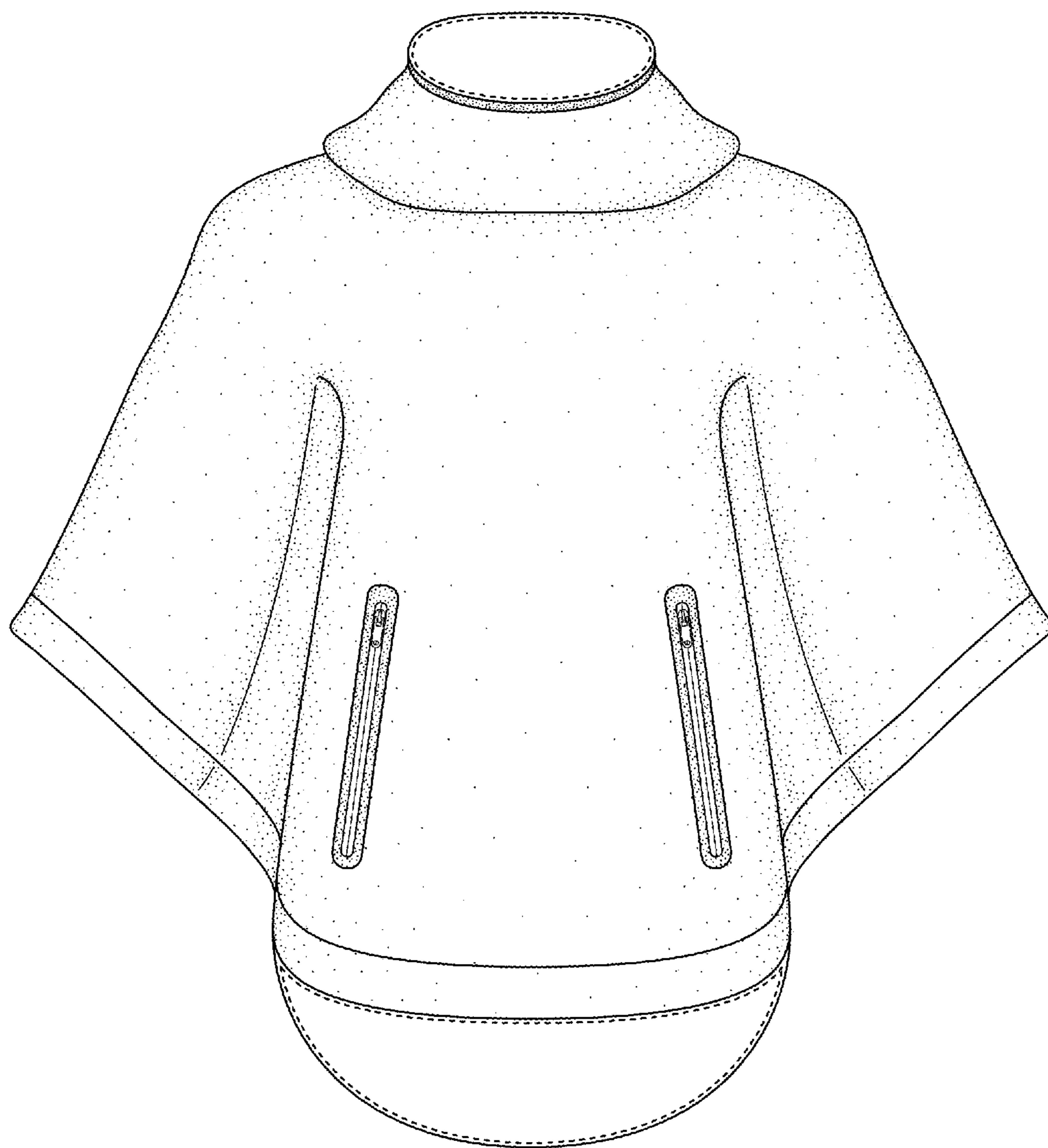

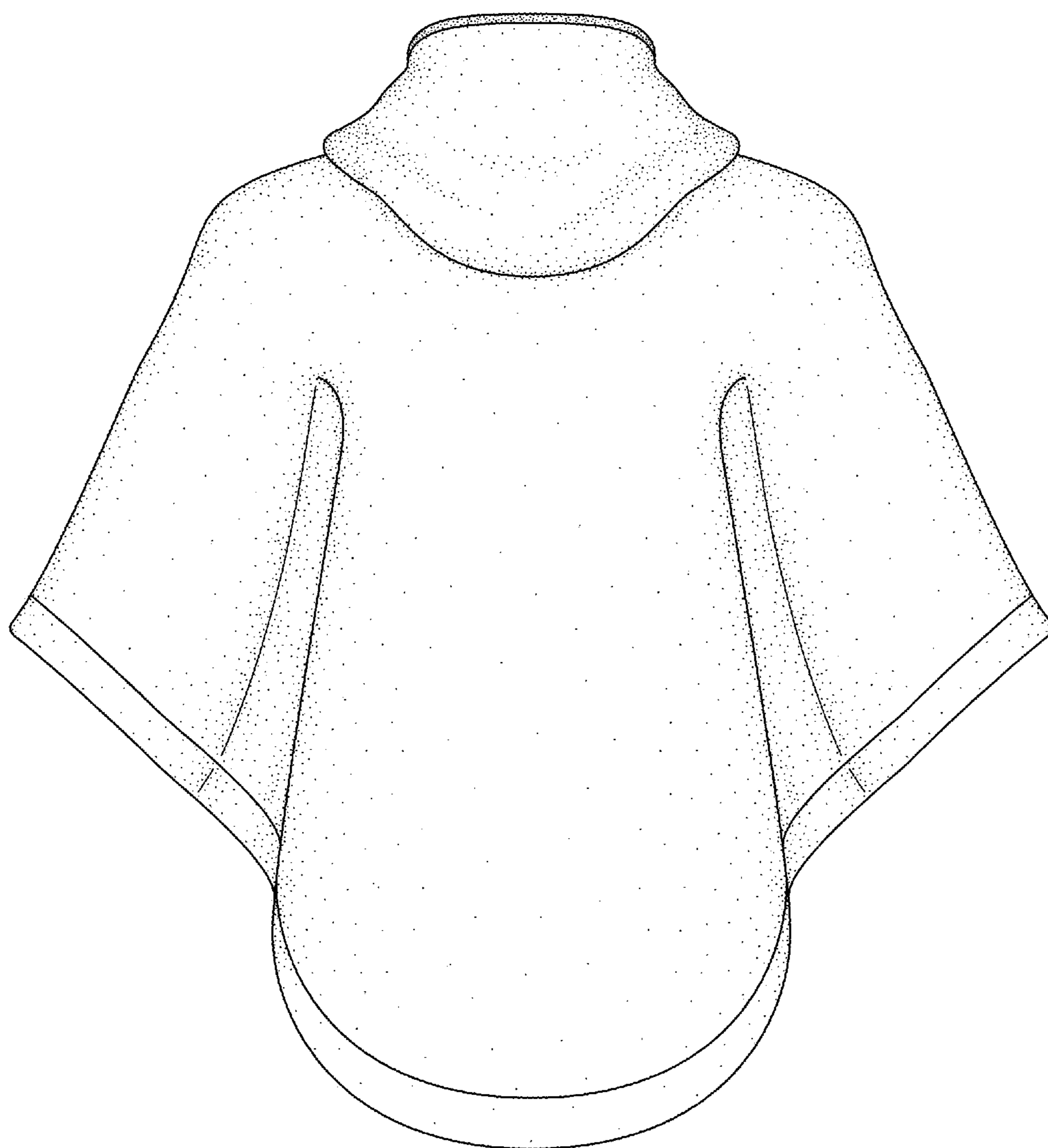

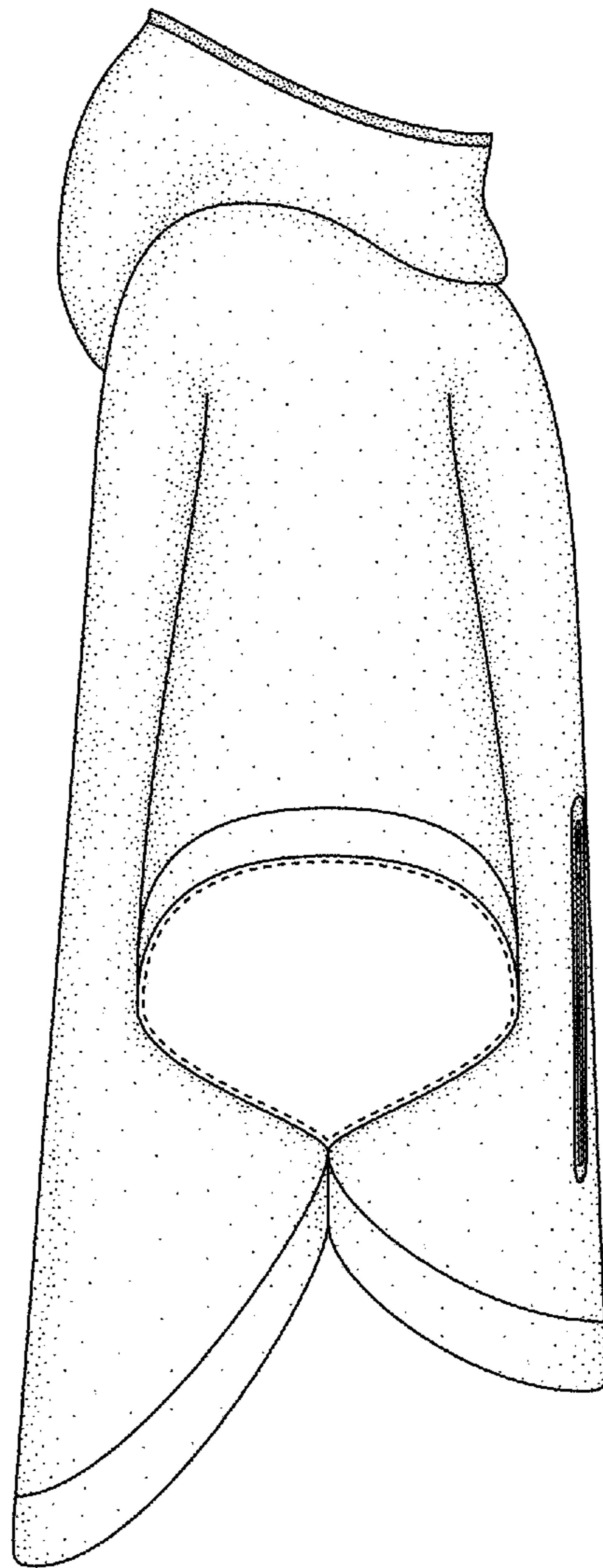

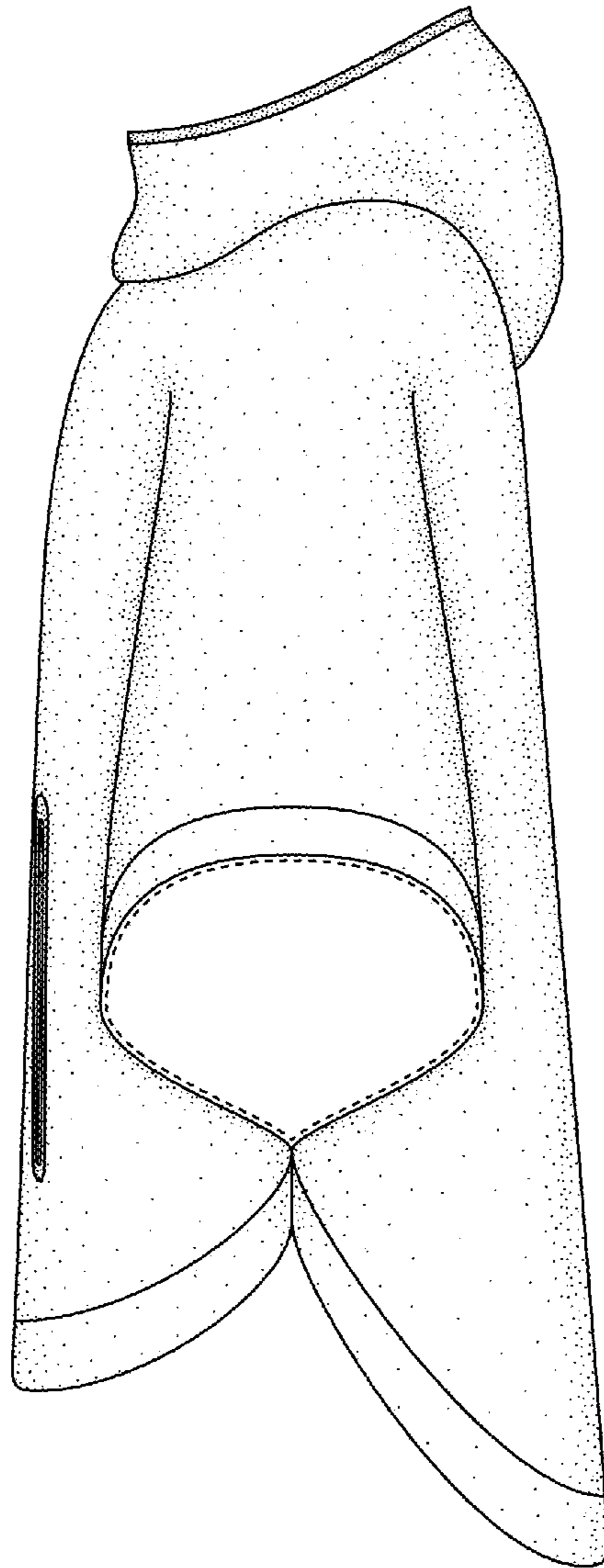

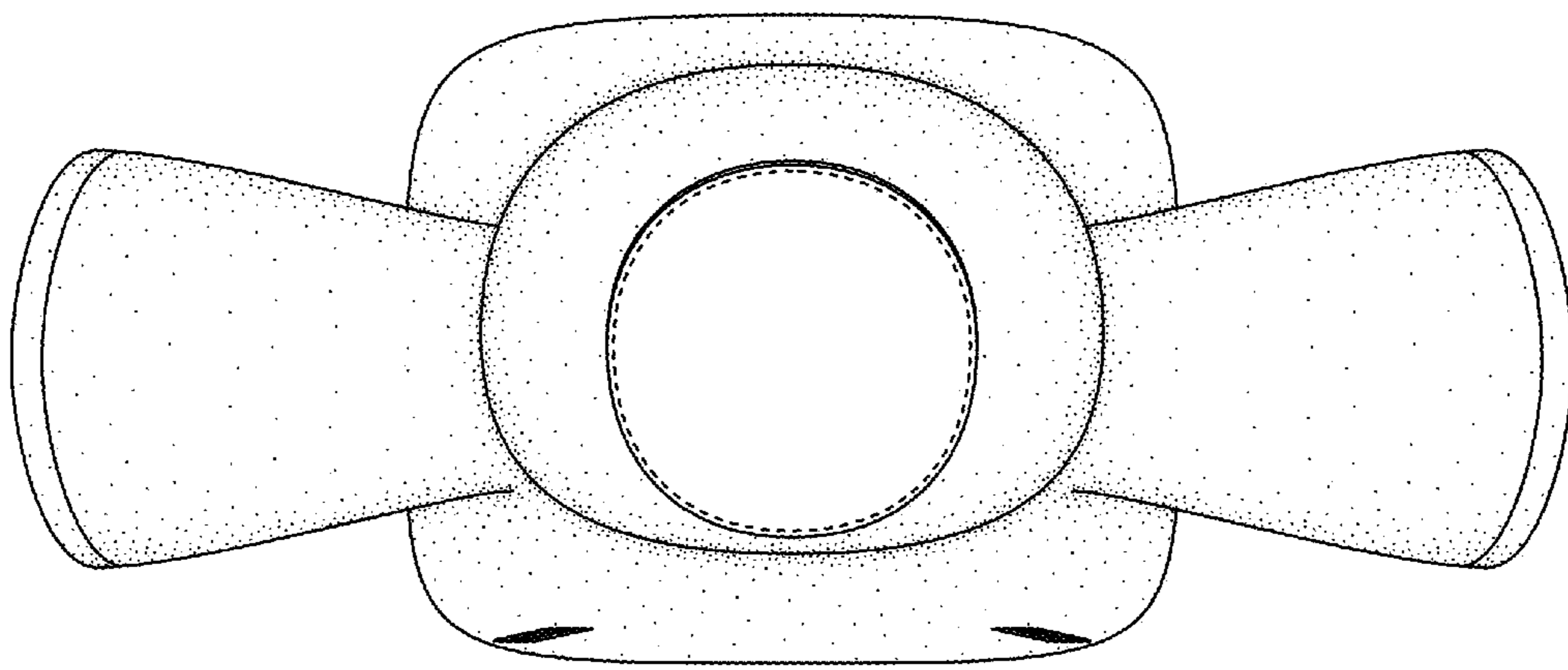
