**DESCRIPTION**

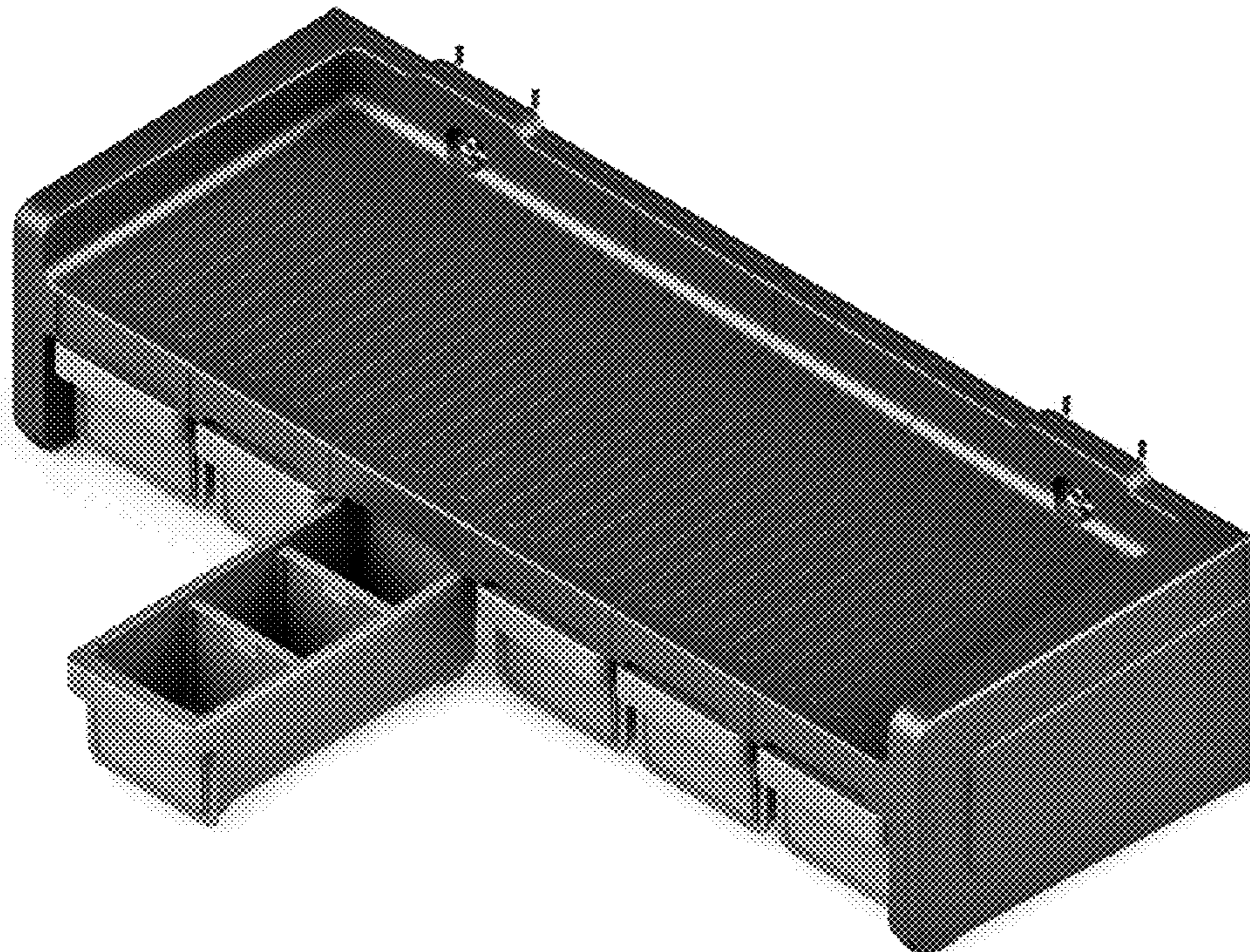
FIG. 1 is a front and left-side perspective view of an organizer, FIG. 2 is a front and left-side perspective view thereof, with one drawer opened,

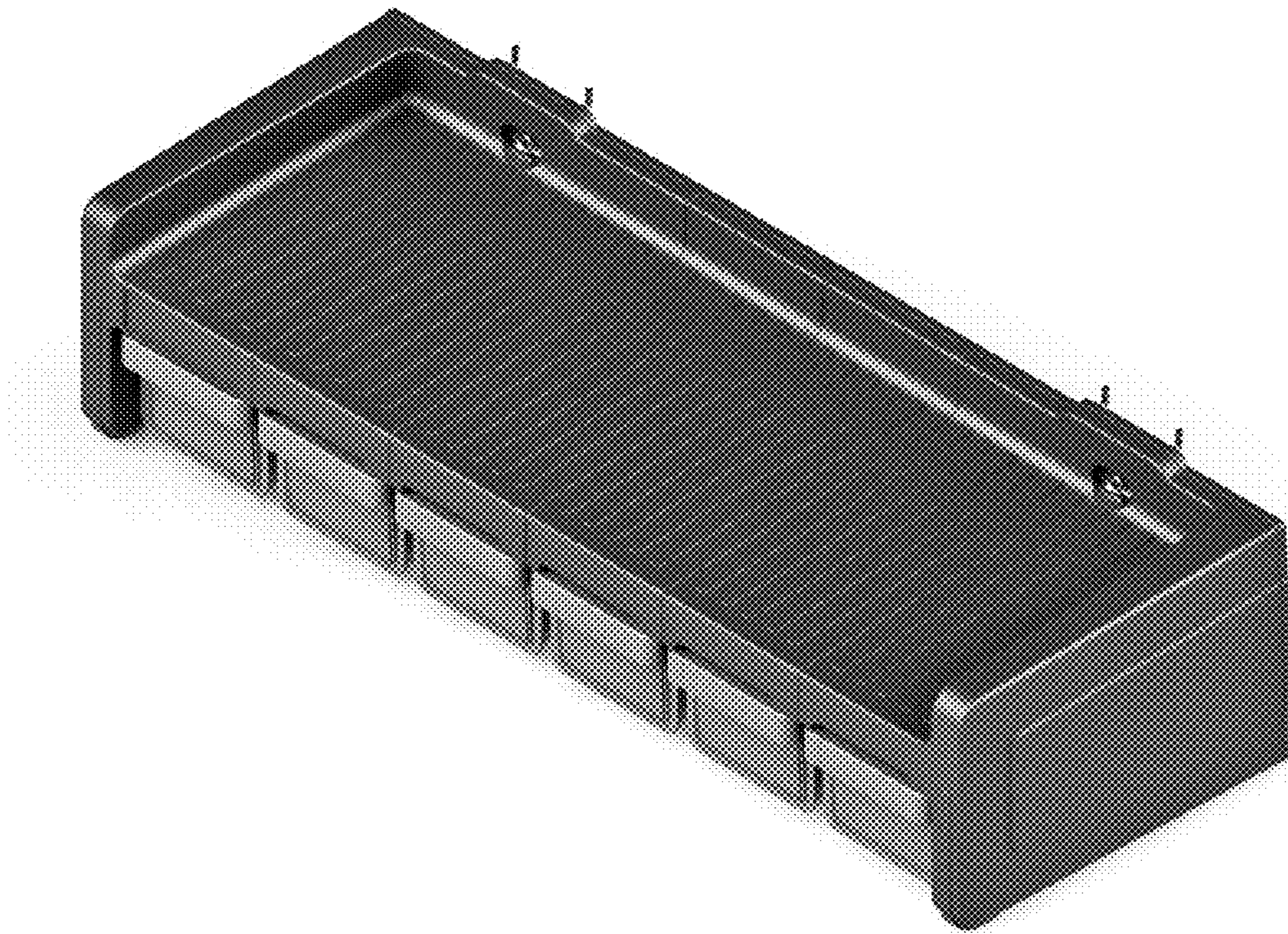

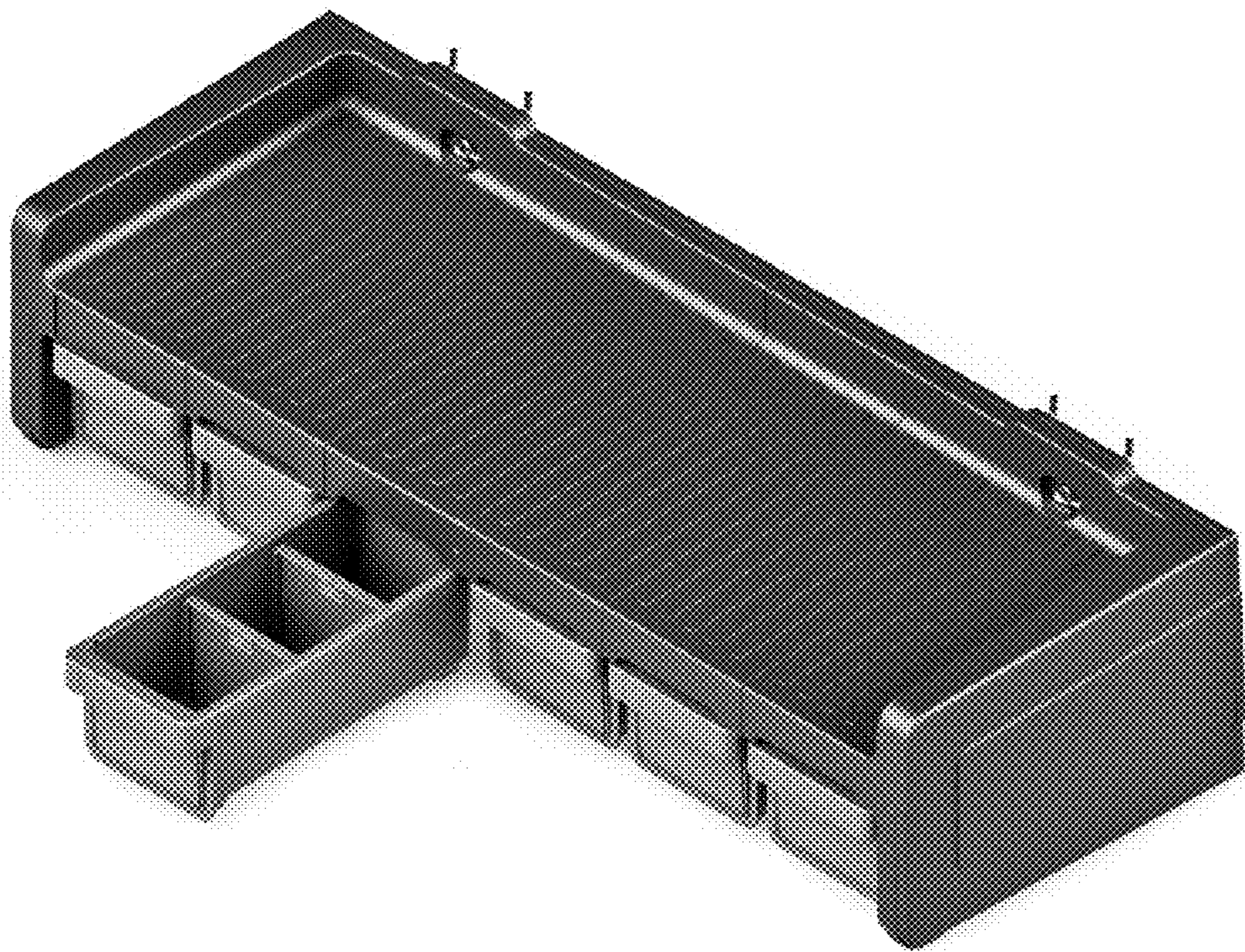

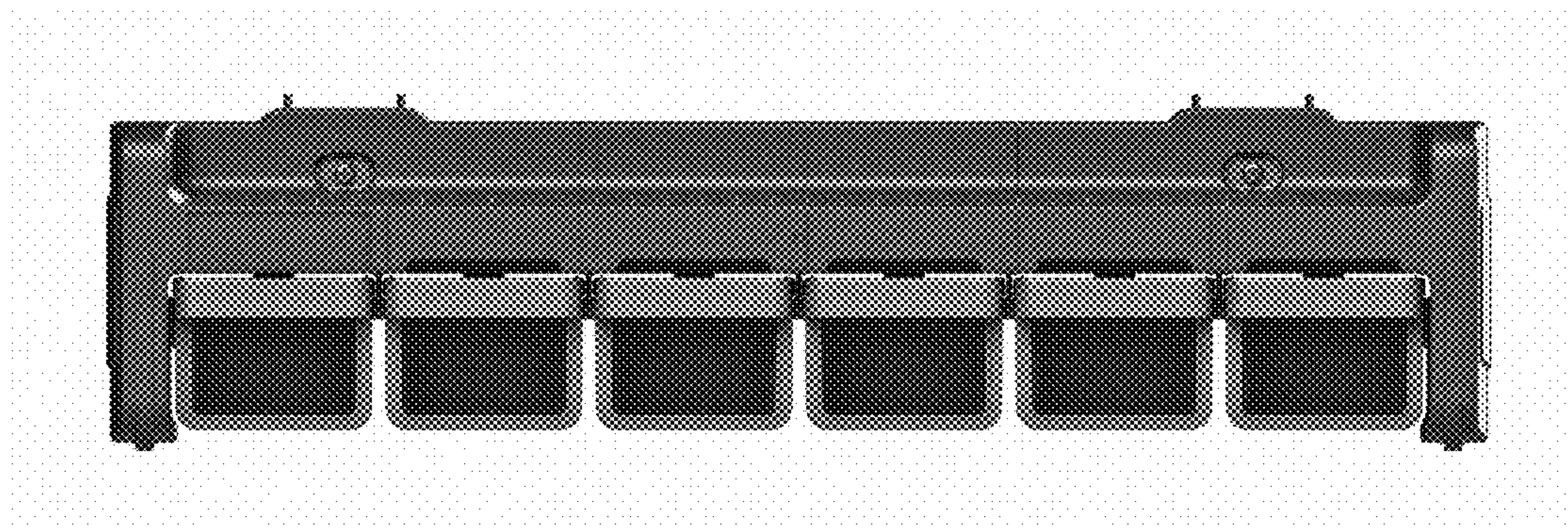

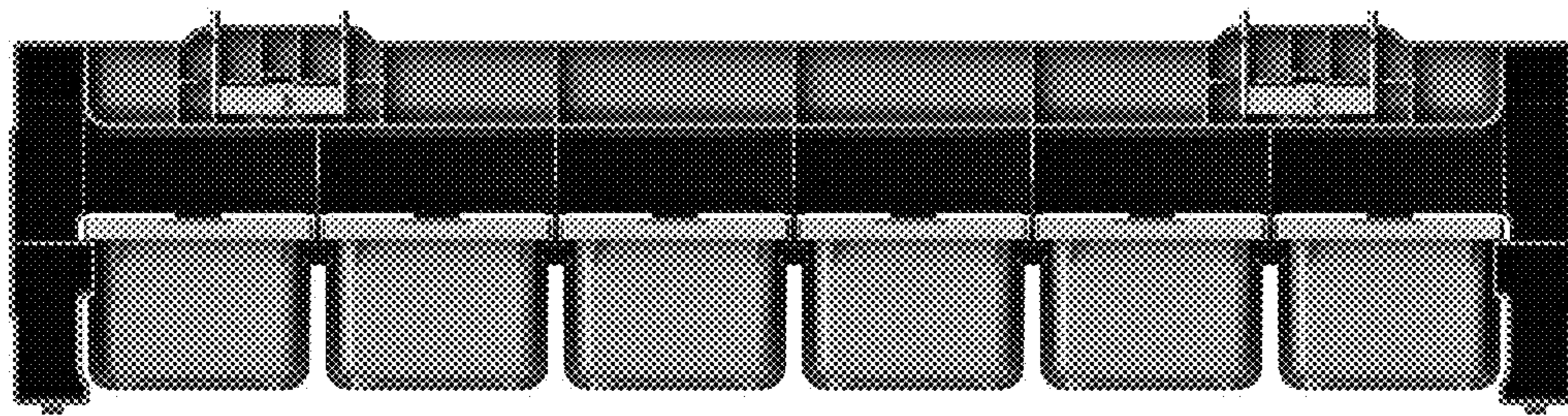

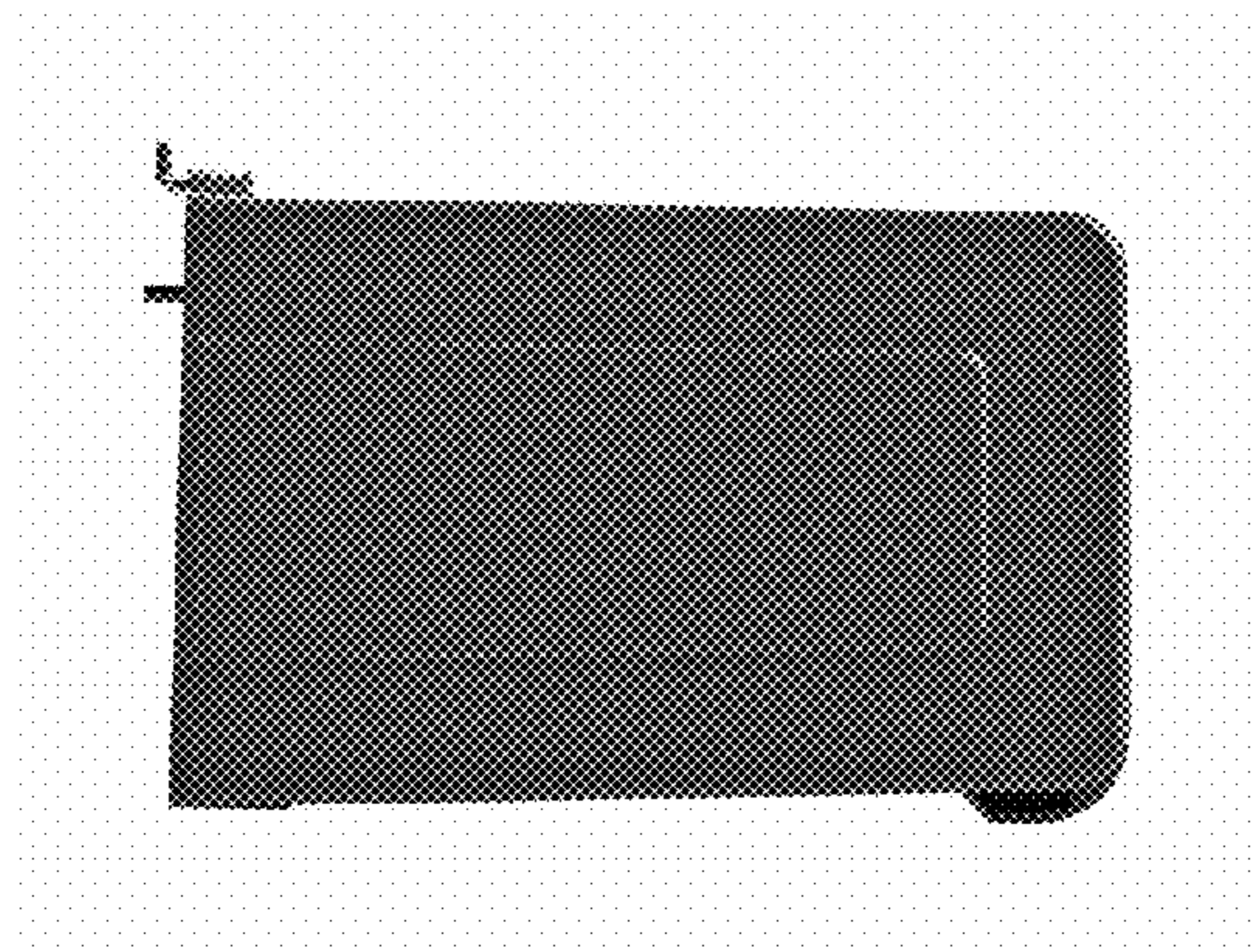

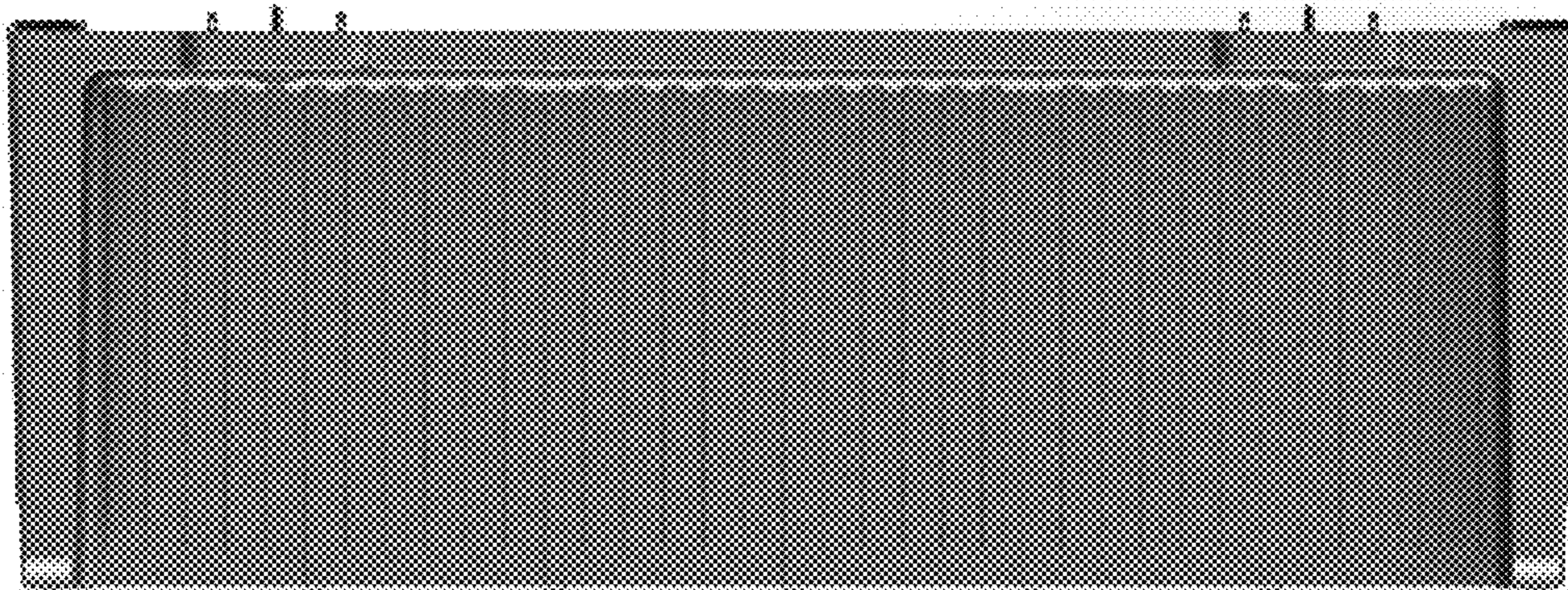

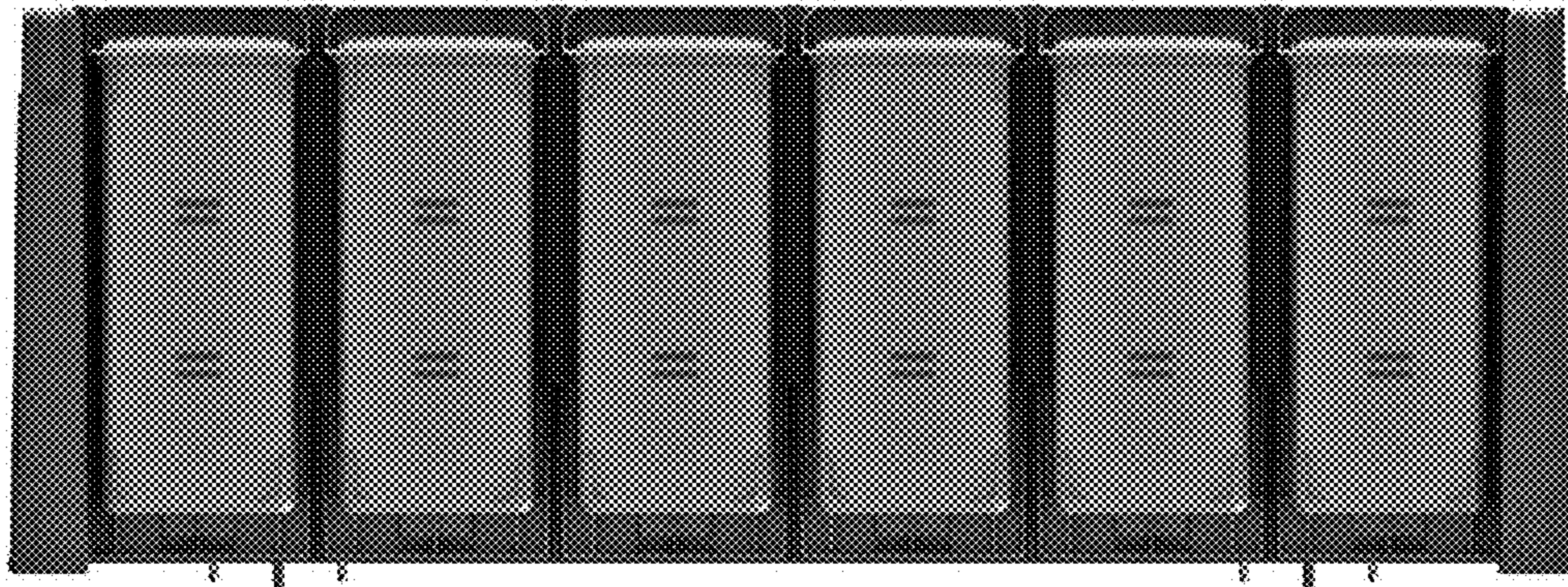
