FIG. 3 is a right side view of the brush of the present invention, the left side being a mirror image thereof;

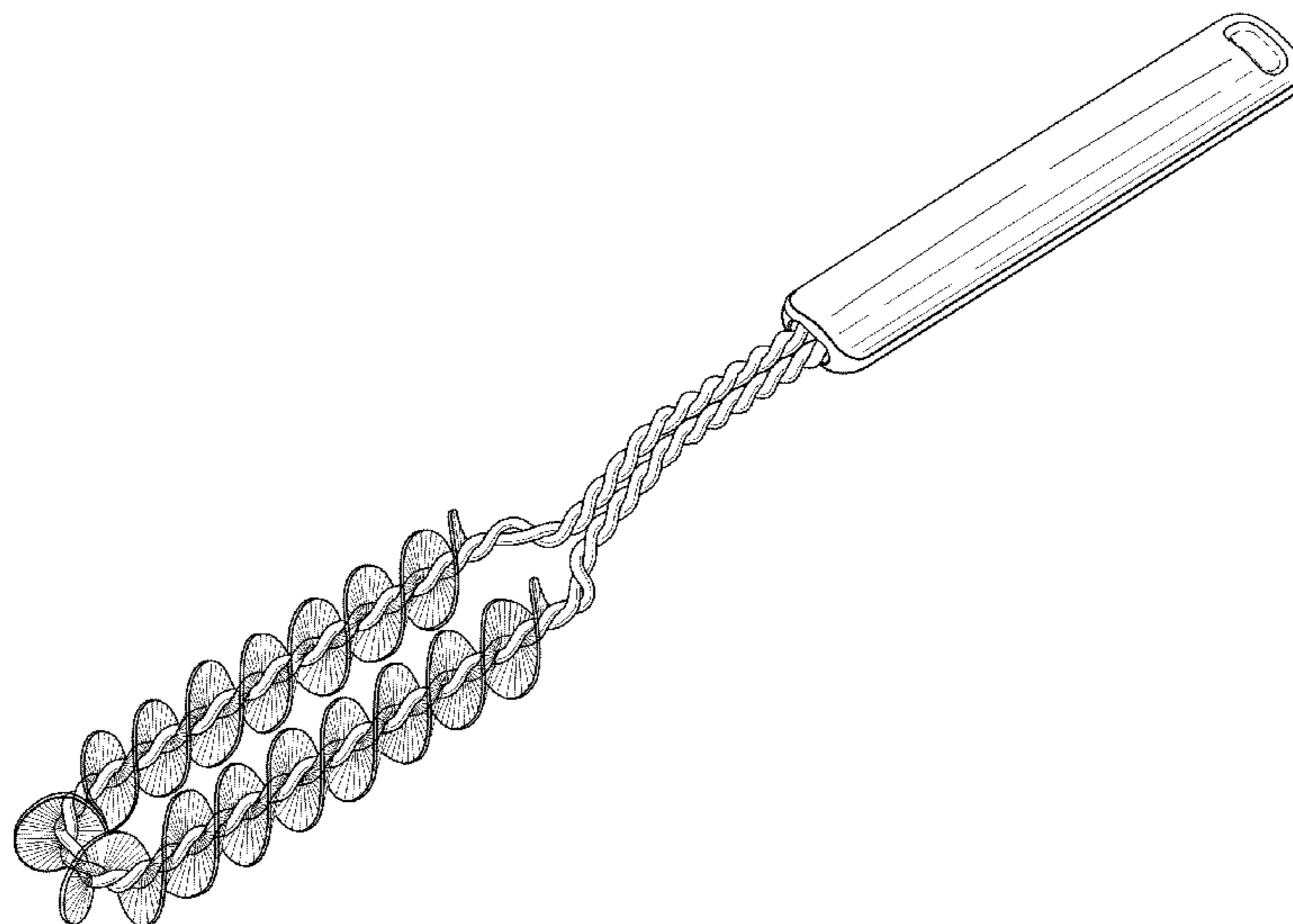
FIG. 4 is a bottom view of the brush of the present invention;

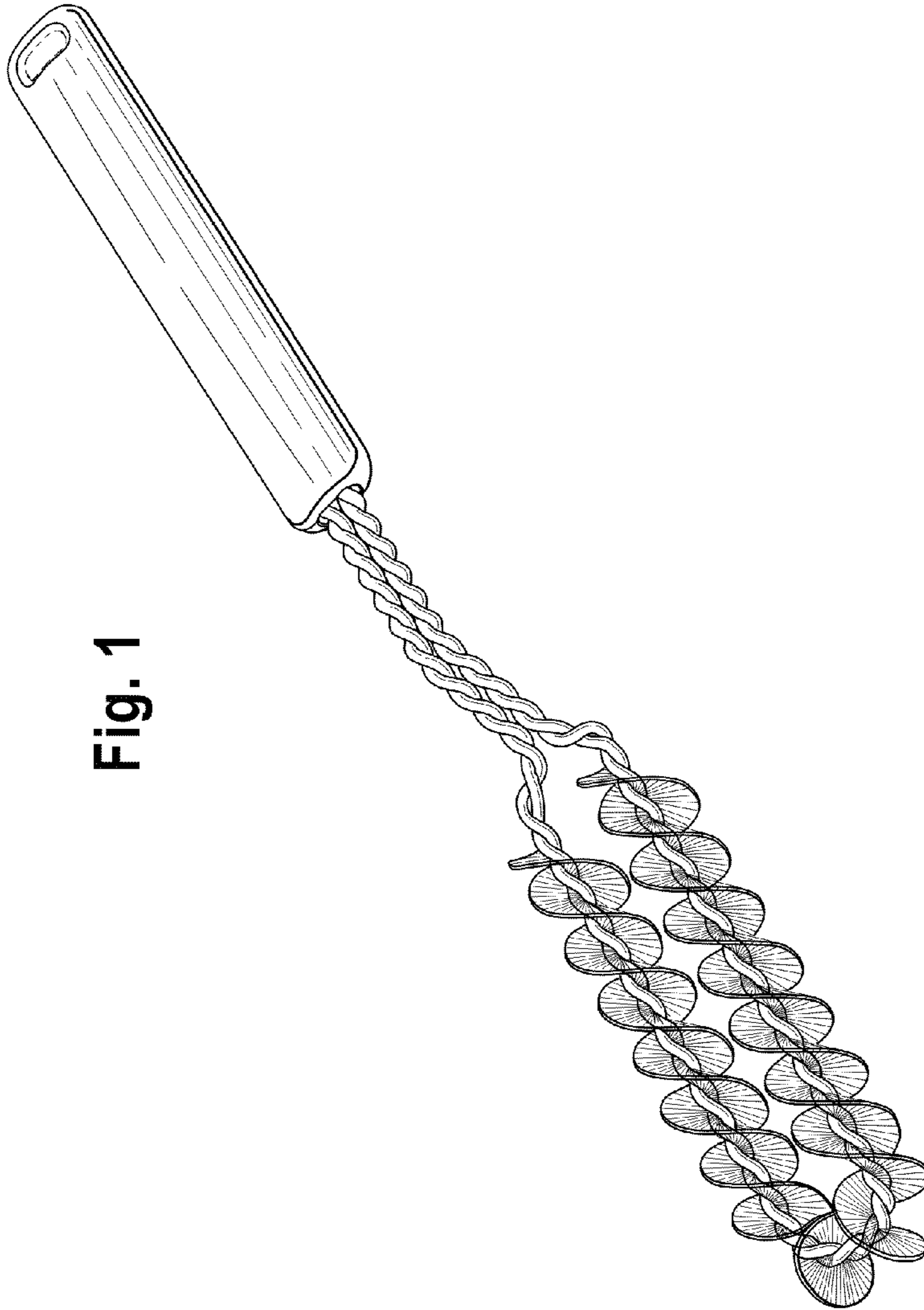

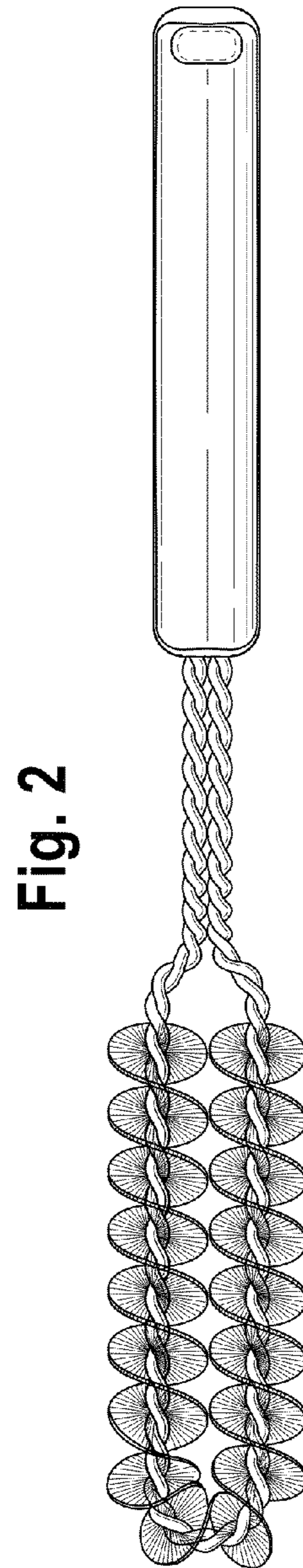

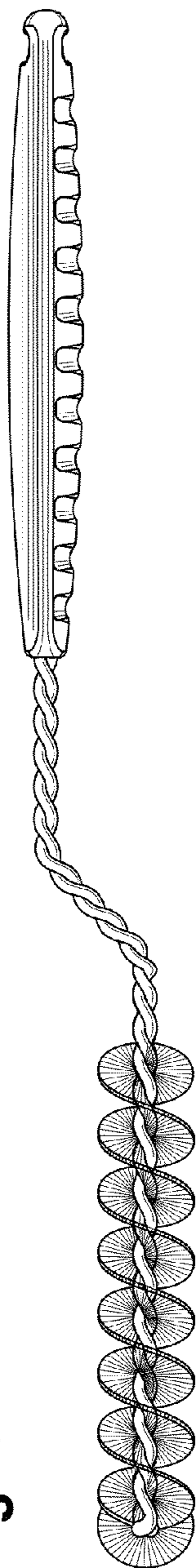

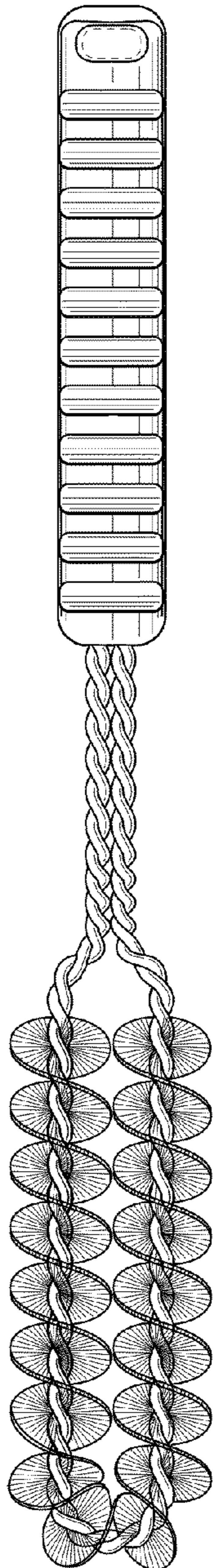

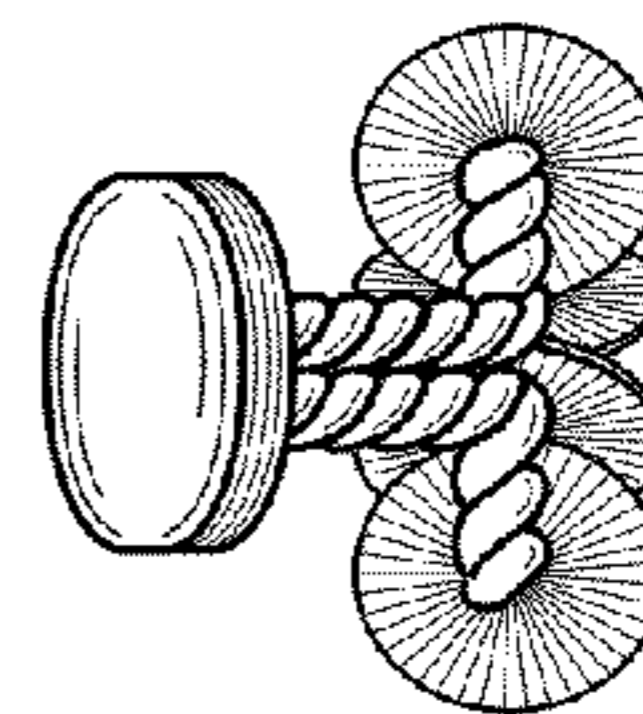
