What is claimed is the ornamental design for an auto hammer, as shown and described.

**DESCRIPTION**

FIG. 3 is a front elevational view thereof;

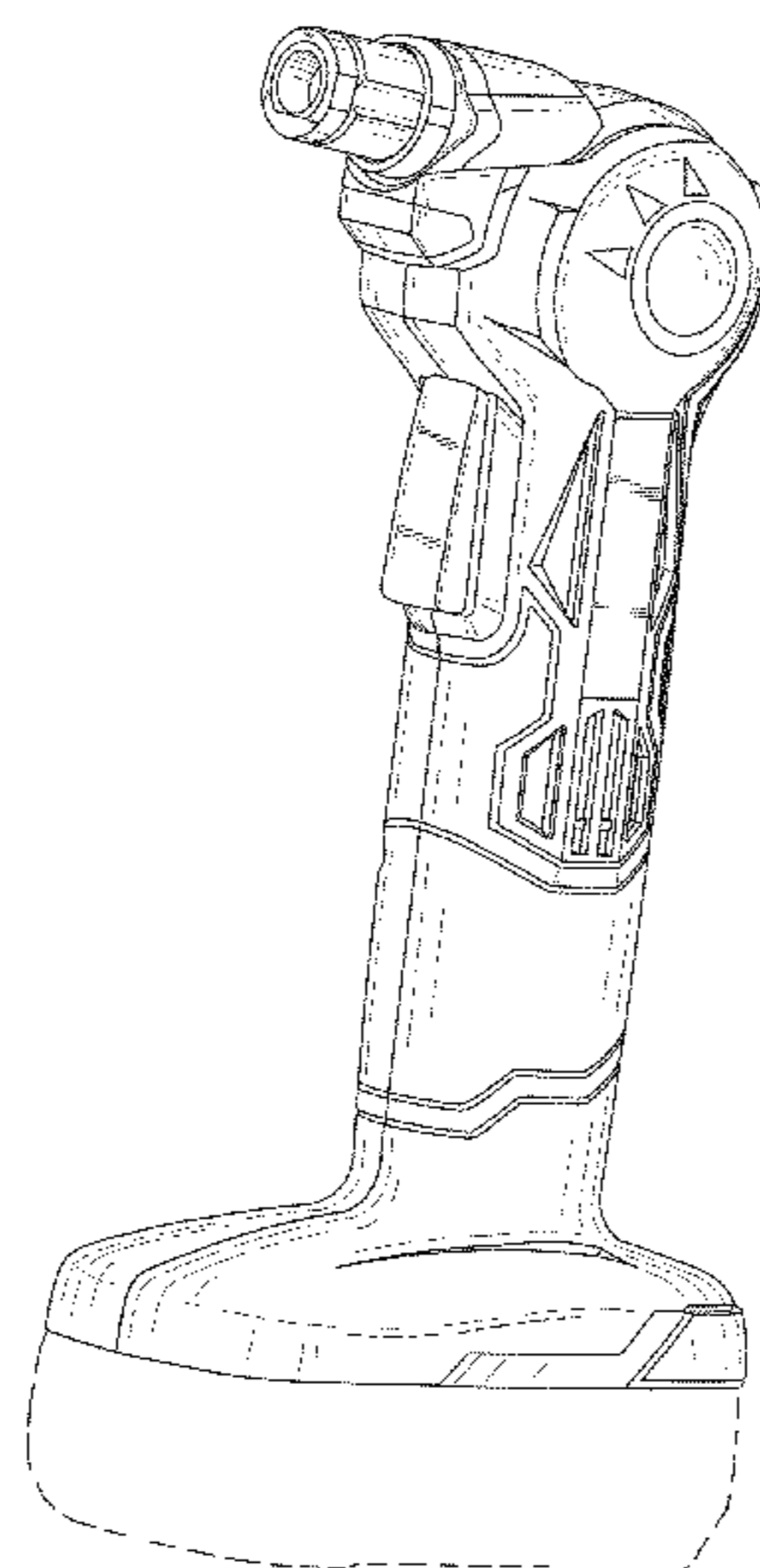
FIG. 4 is a rear elevational view thereof;

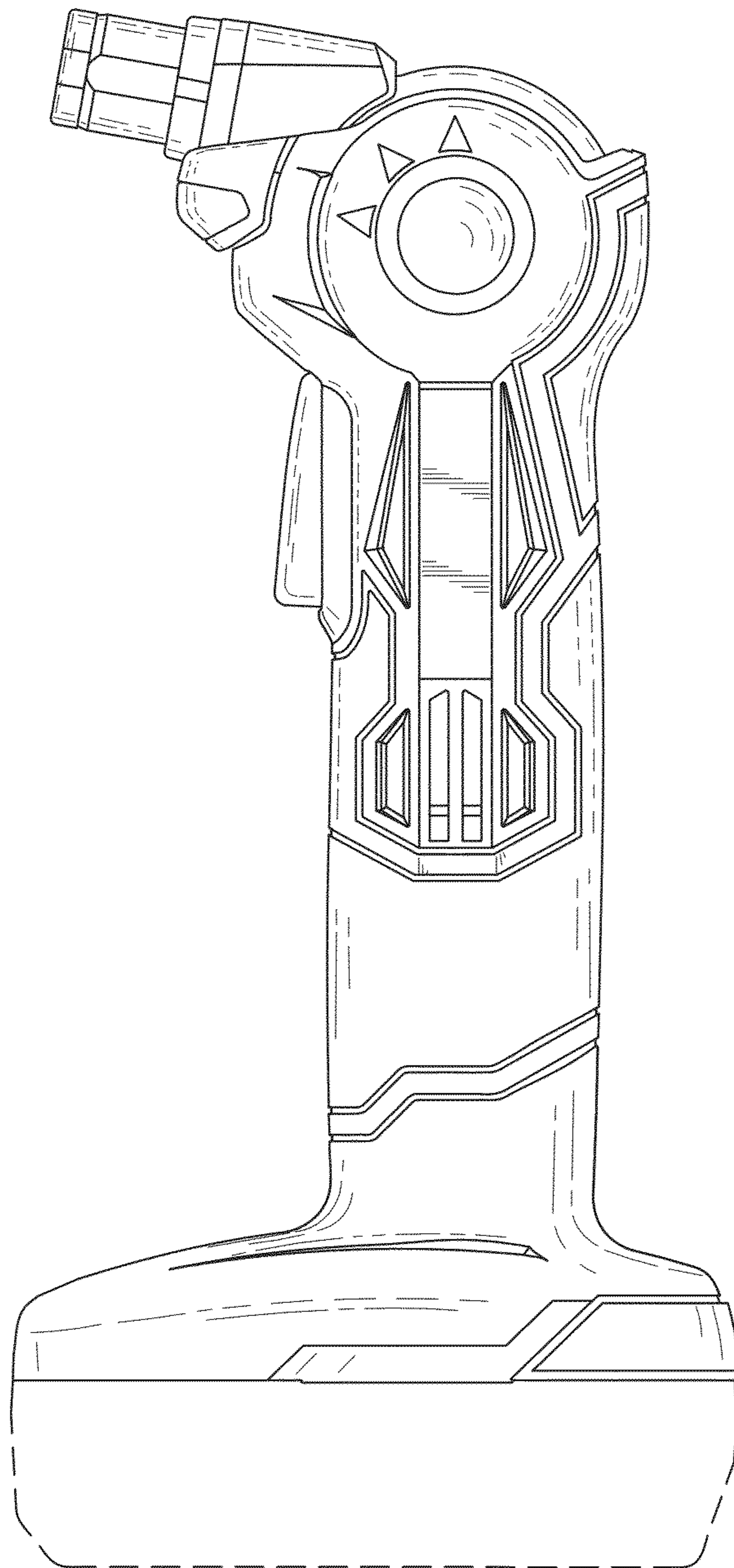

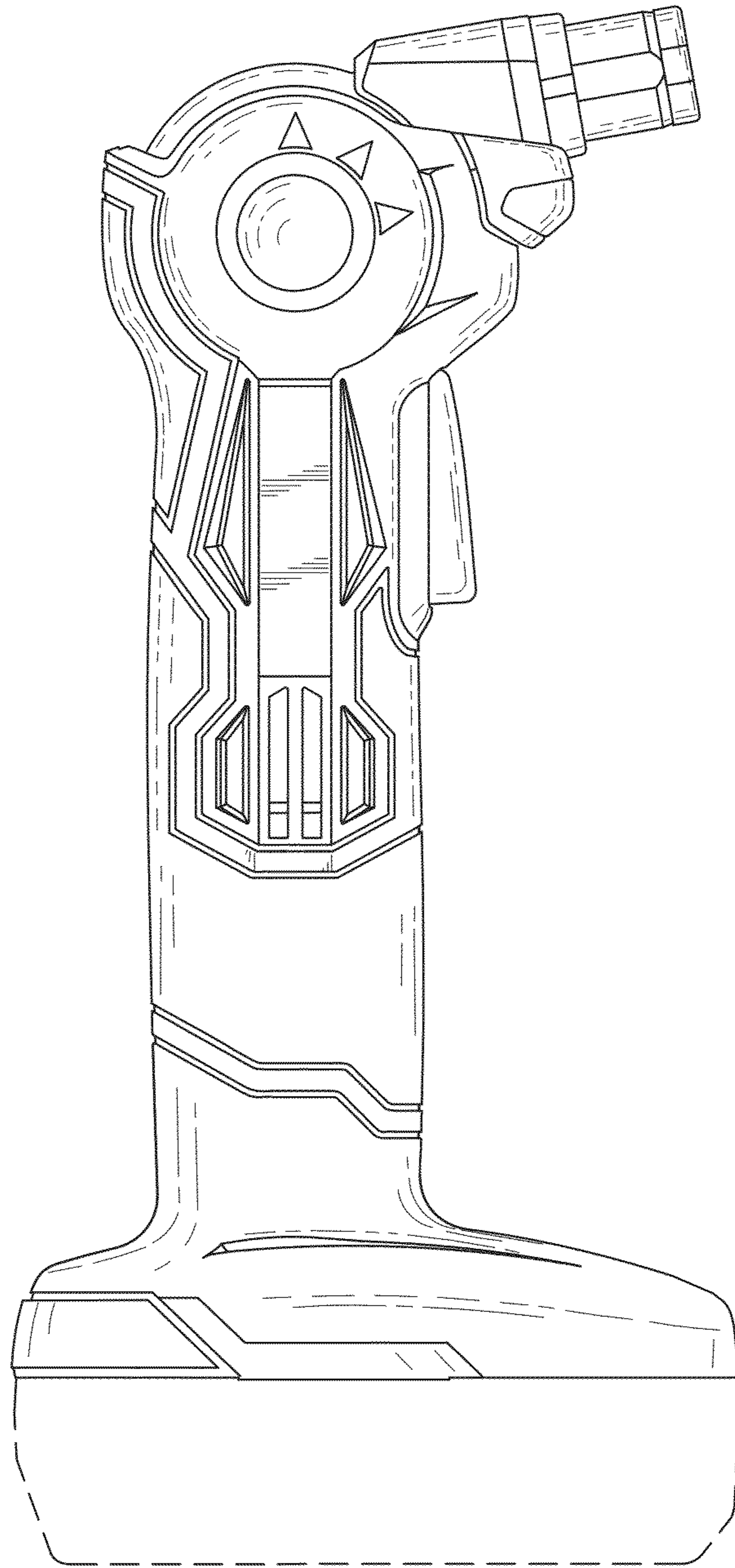

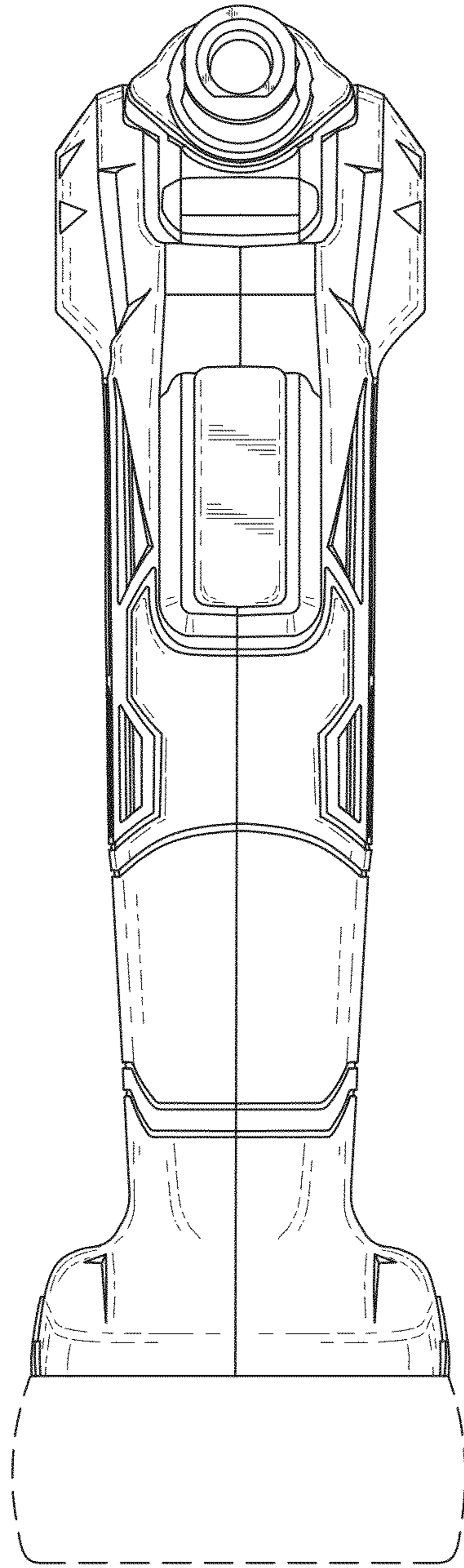

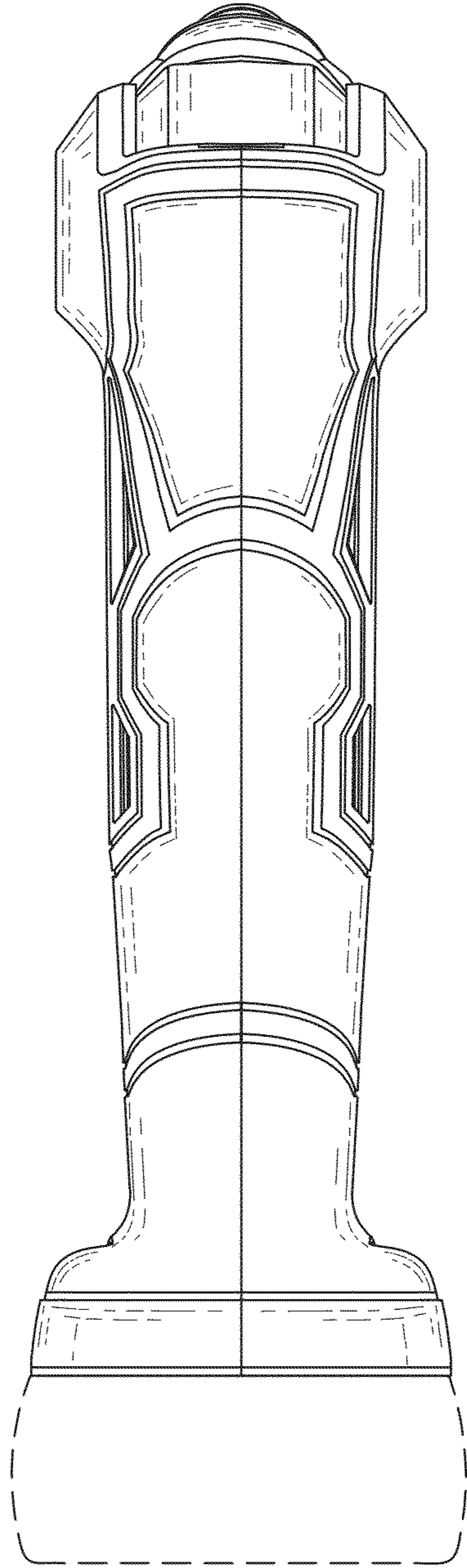

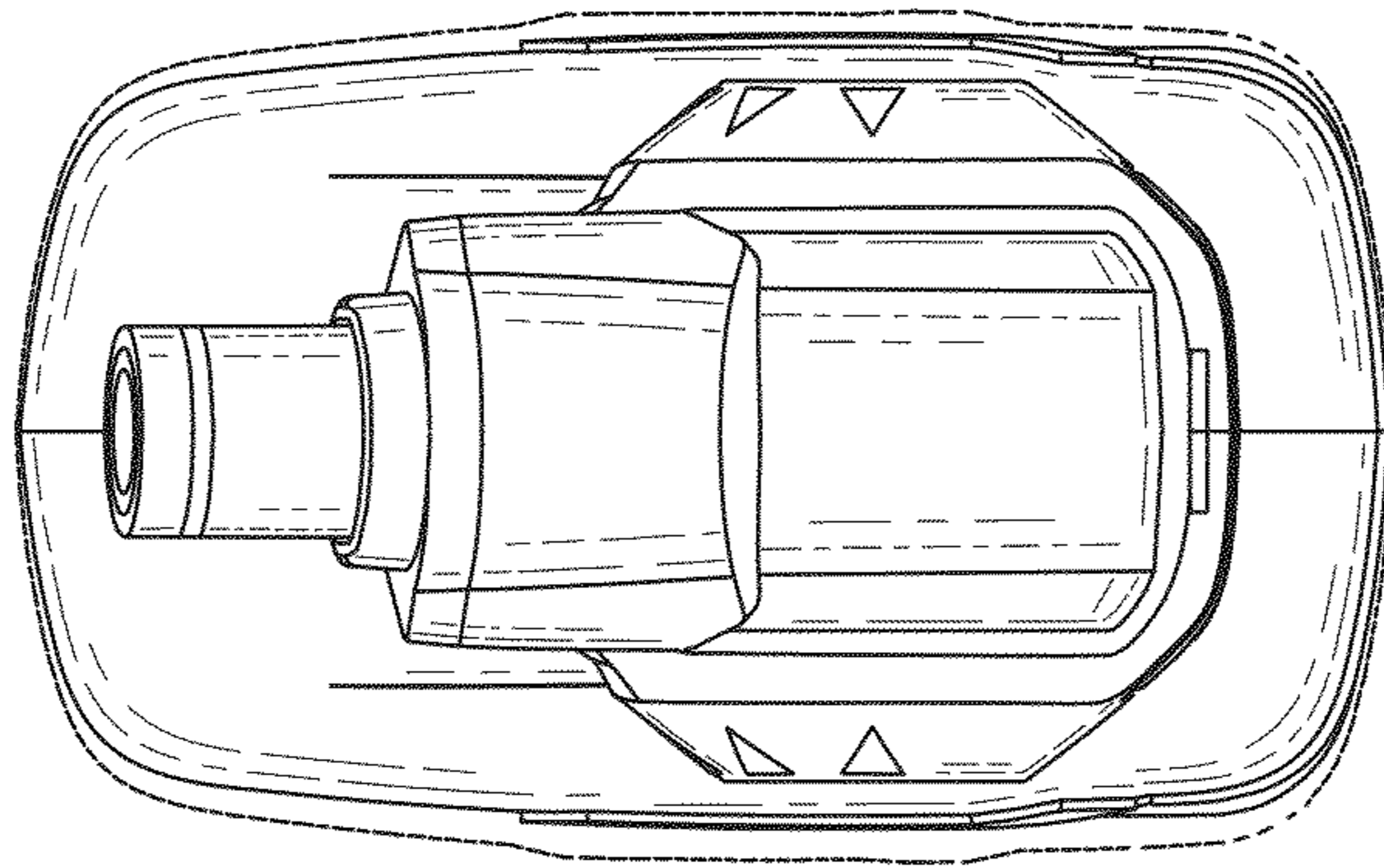

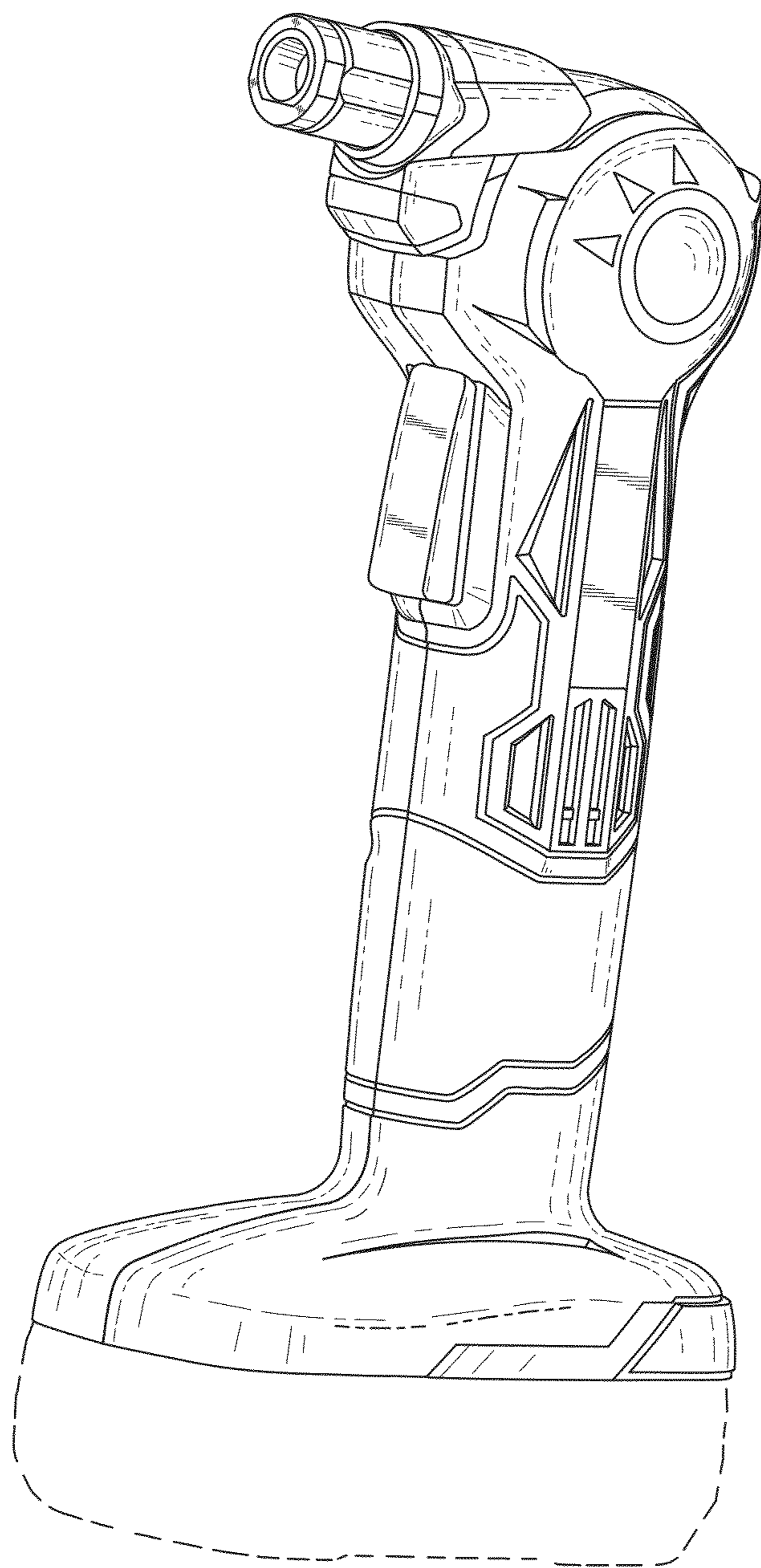
