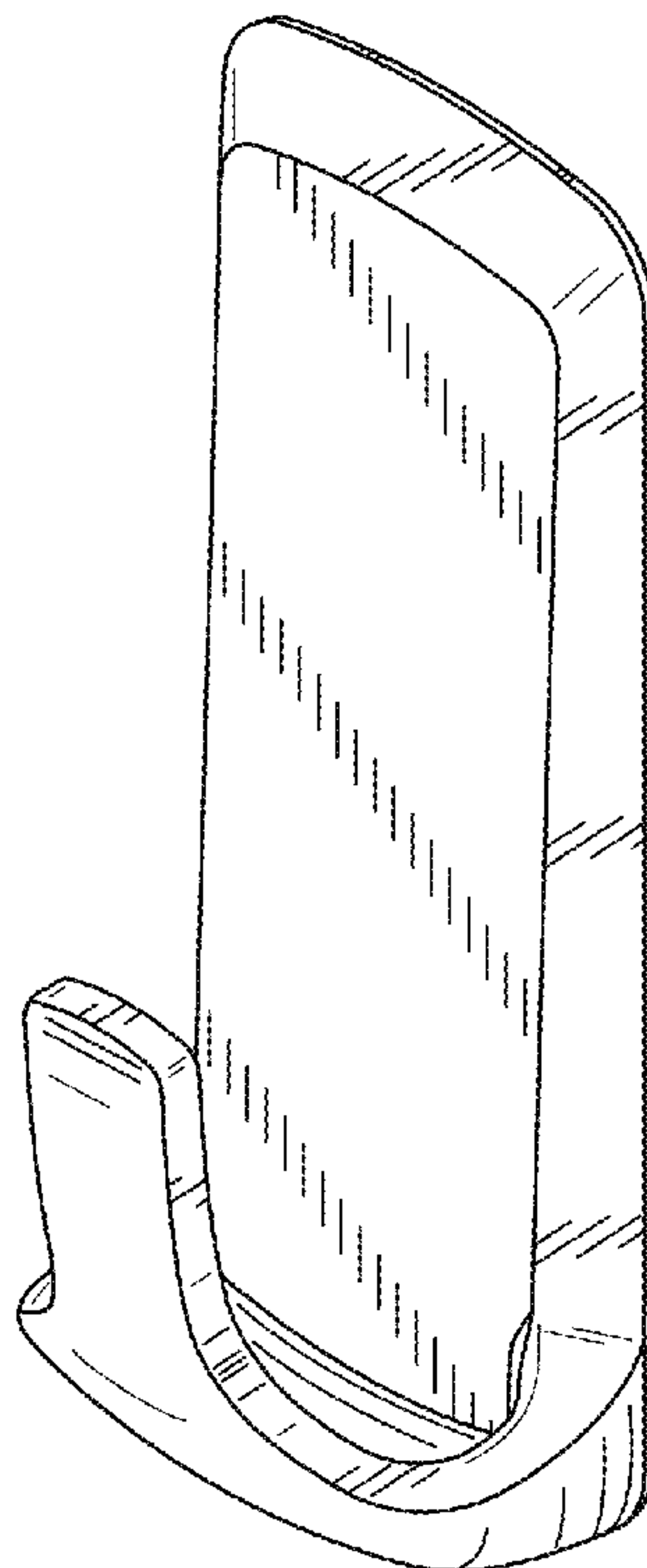

The ornamental design for a hook, as shown and described.

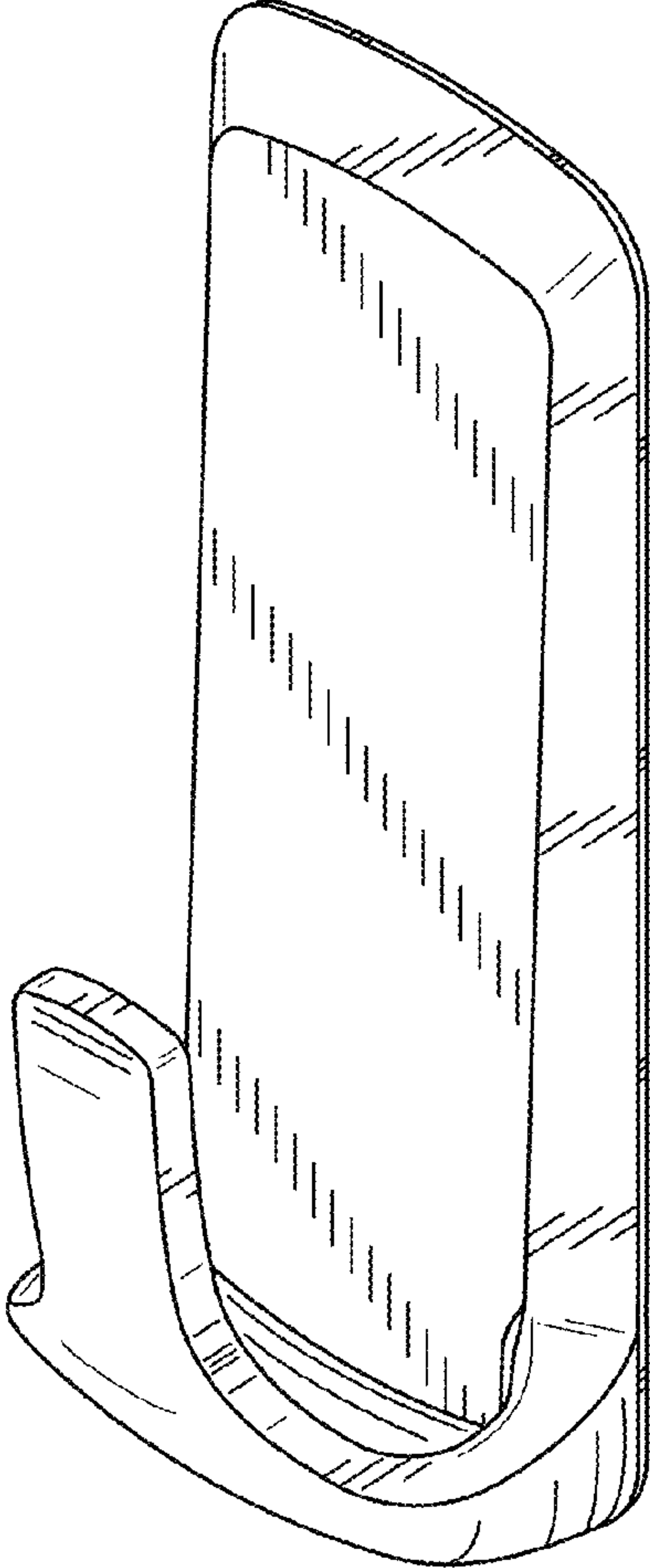
**DESCRIPTION**

FIG. 6 is a bottom view thereof.

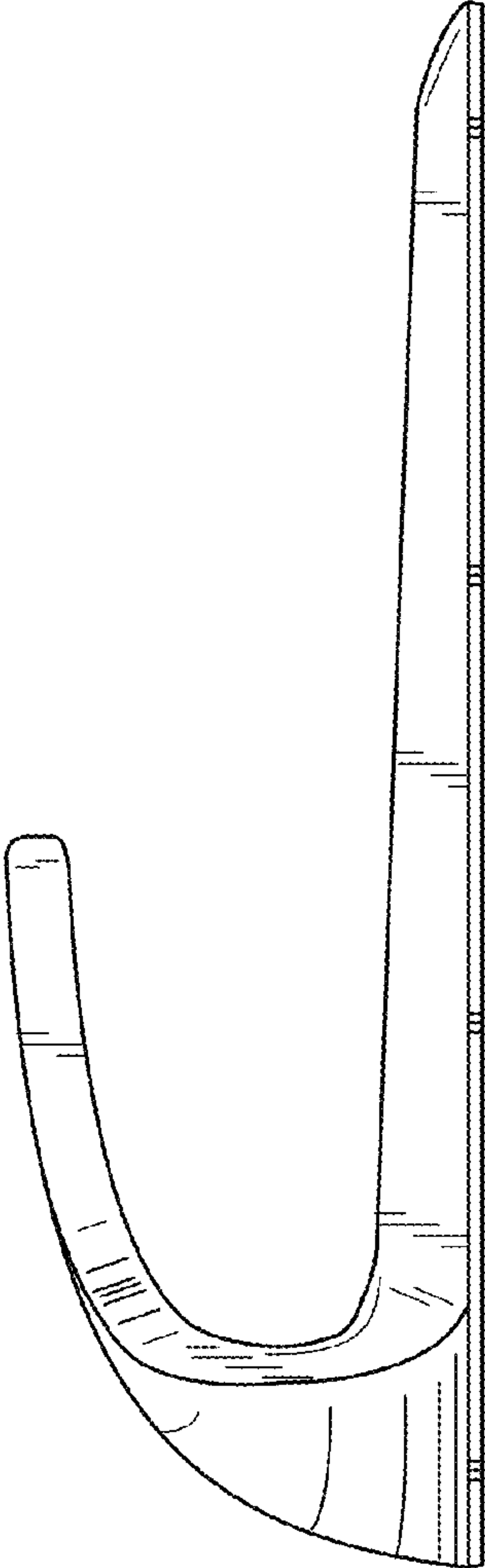

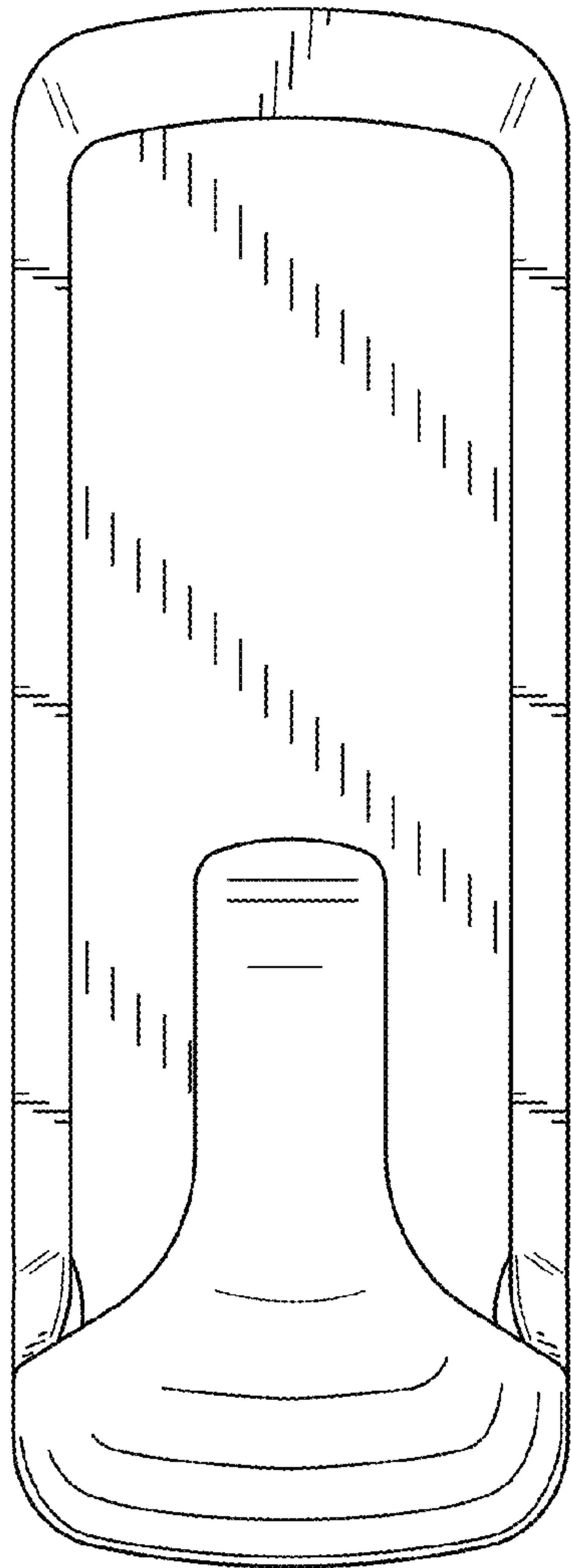




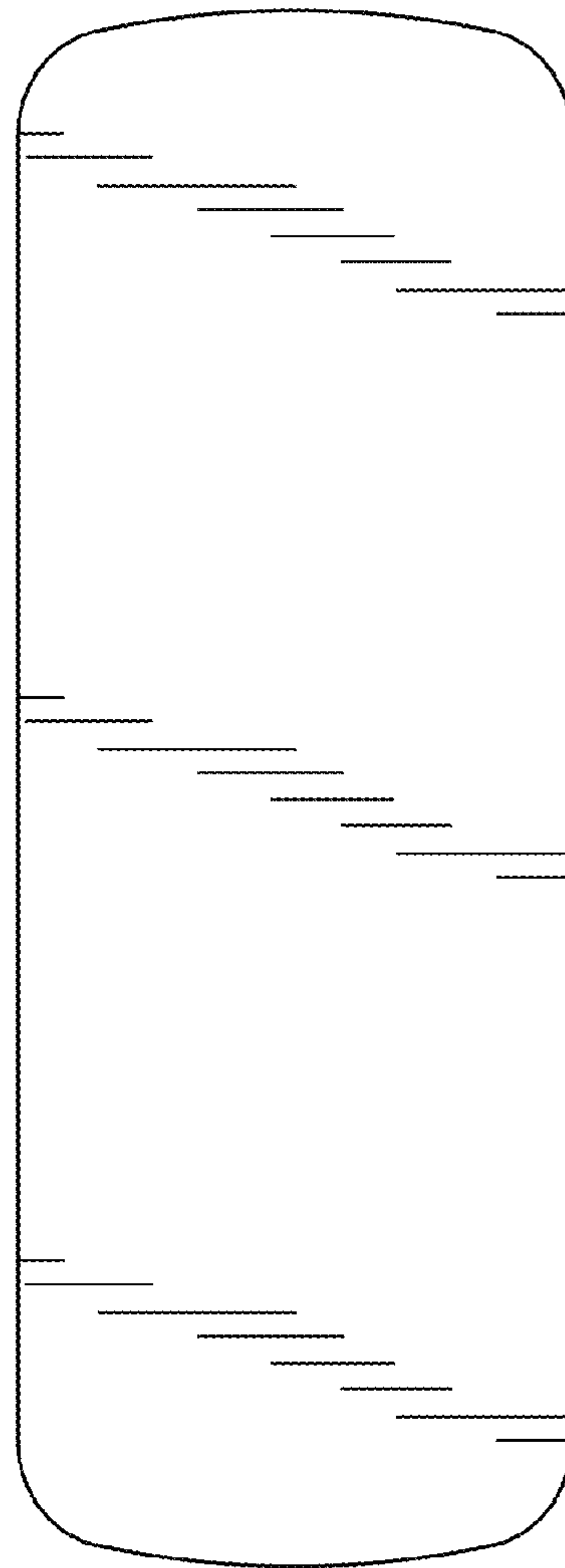

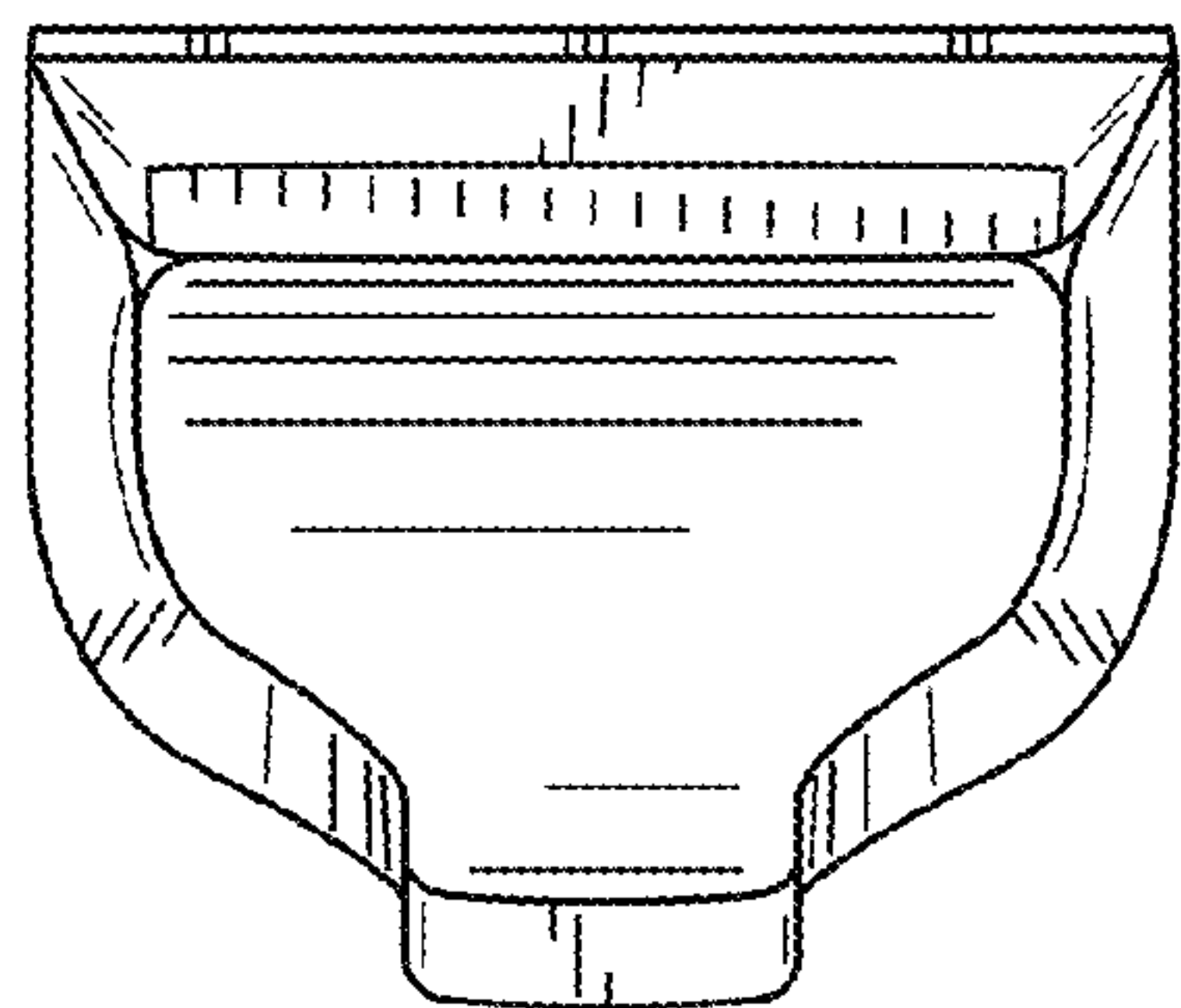

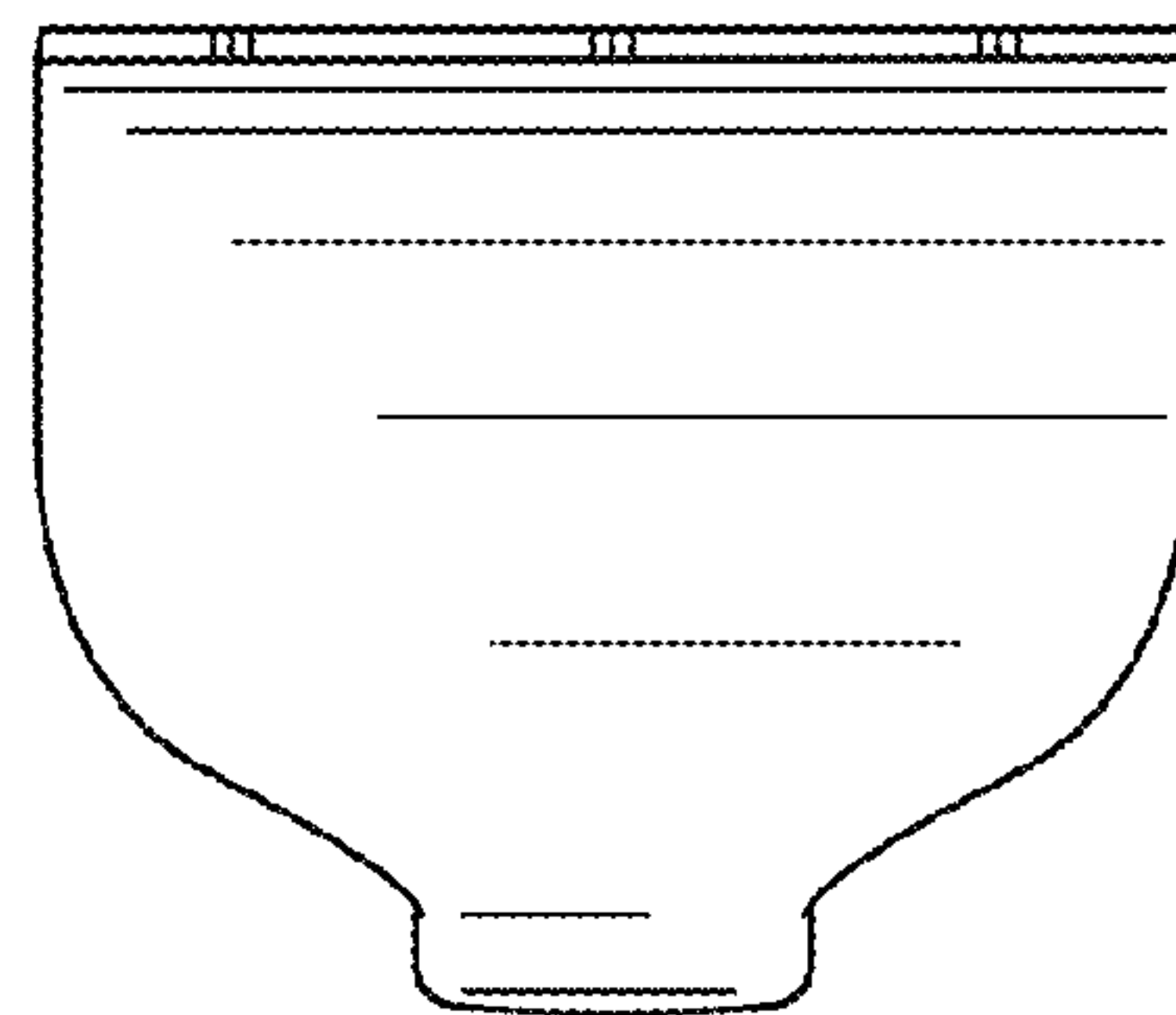
