(57) **CLAIM**

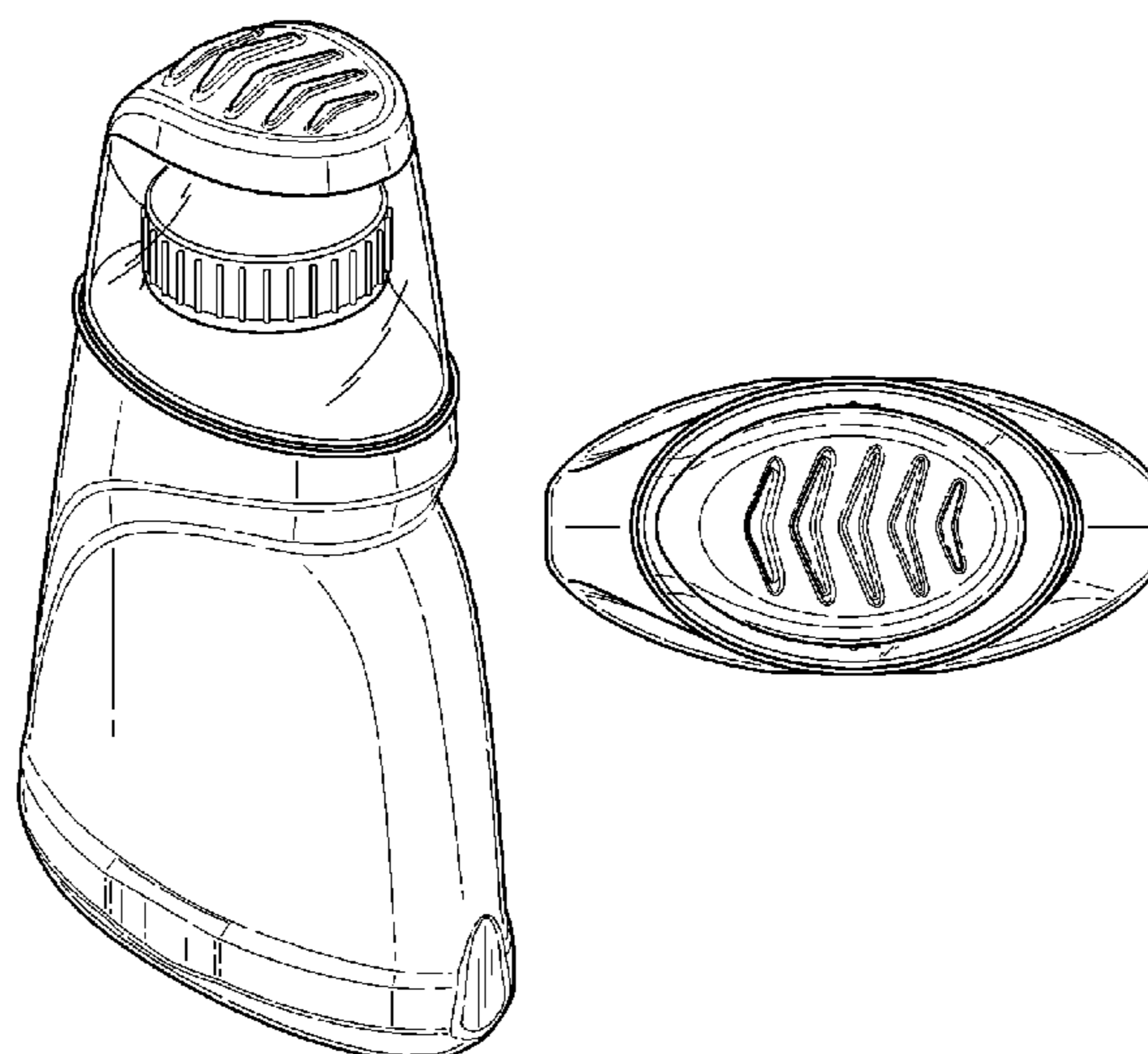
The ornamental design for a bottle with cap and transparent overcap, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a bottle with cap and transparent overcap;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The broken lines shown on the bottom surface in the FIGS. 4, 5, & 7 drawing views are included for the purpose of illustrating environmental structure and form no part of the claimed design.

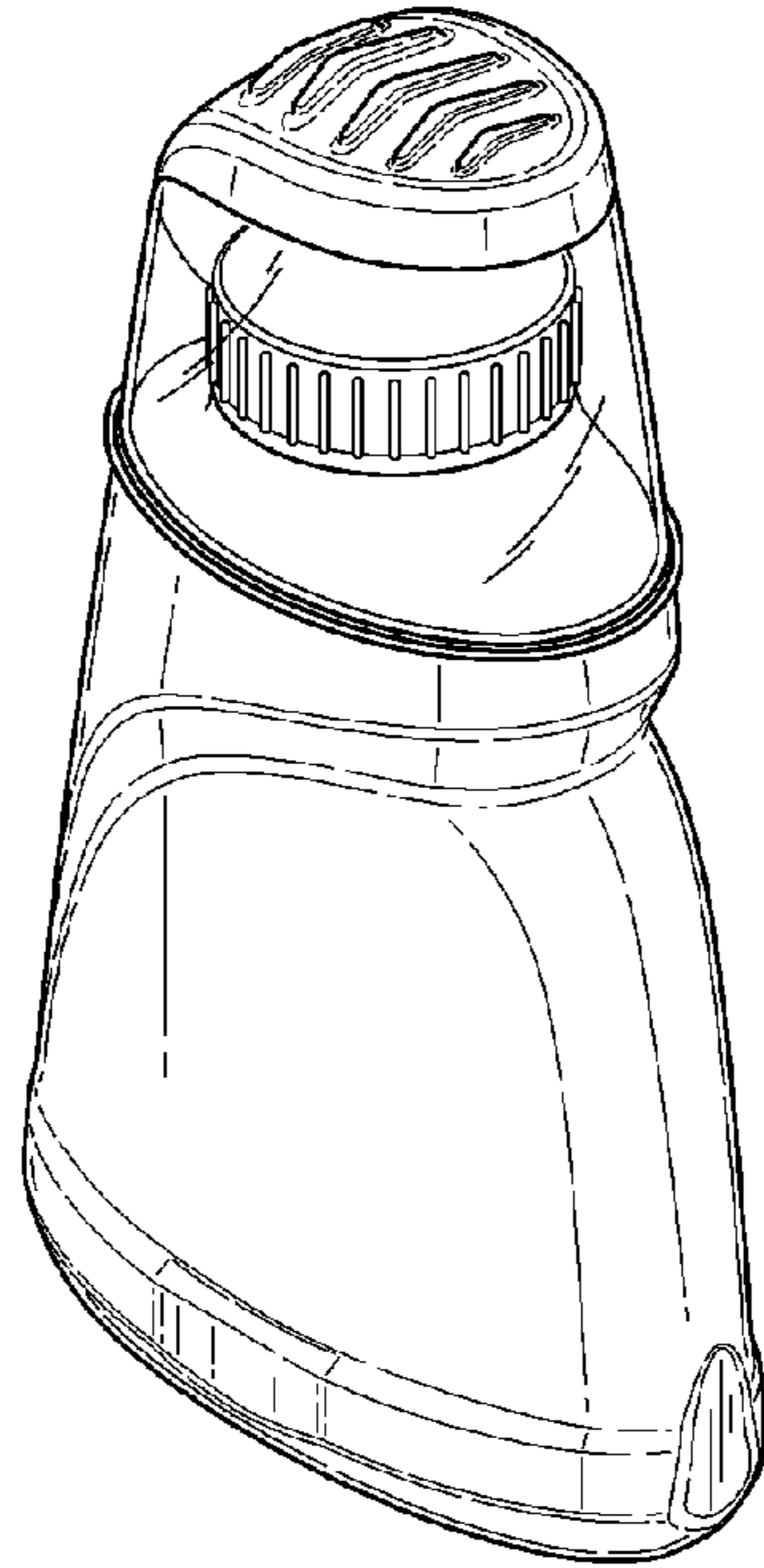

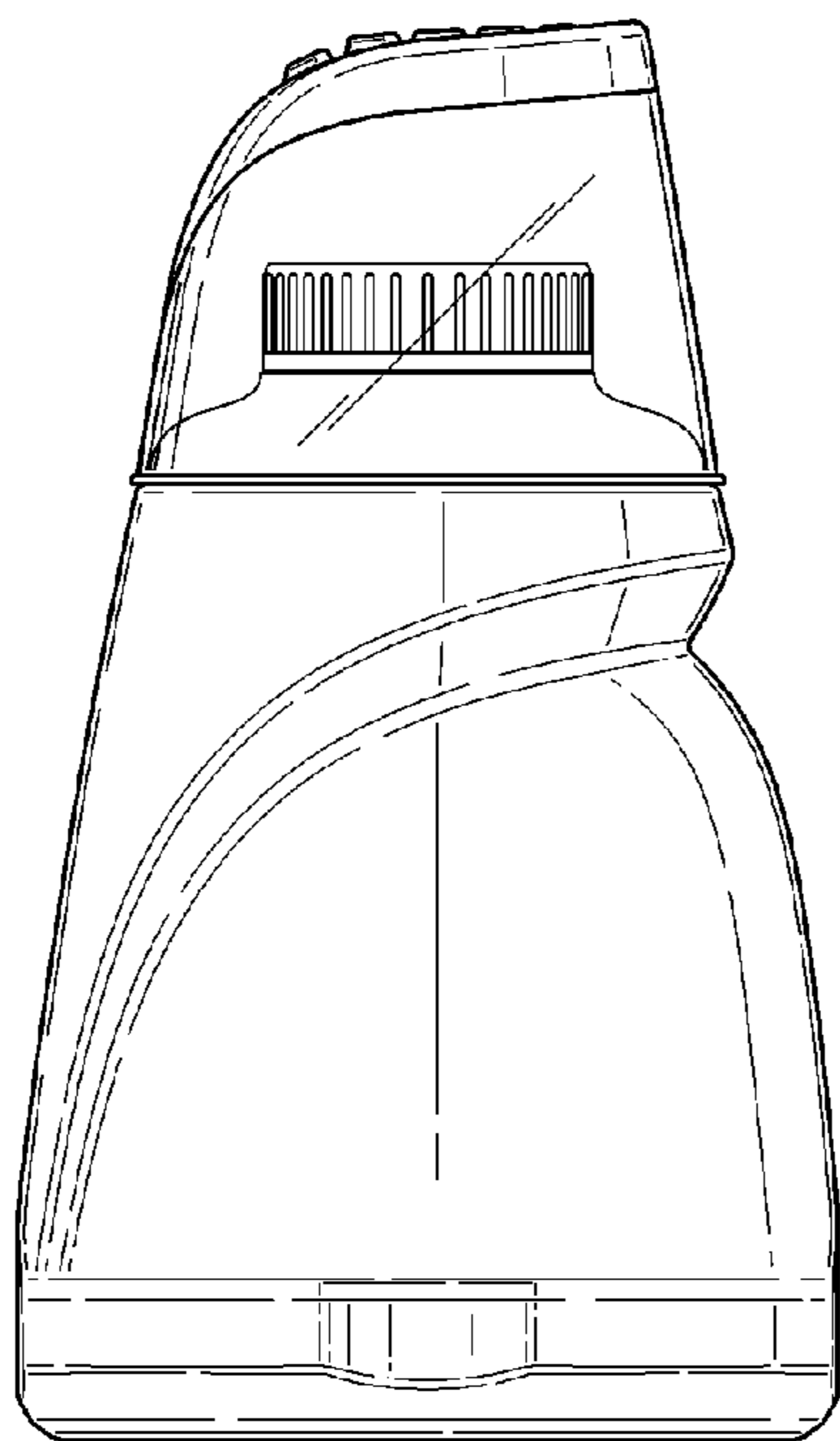

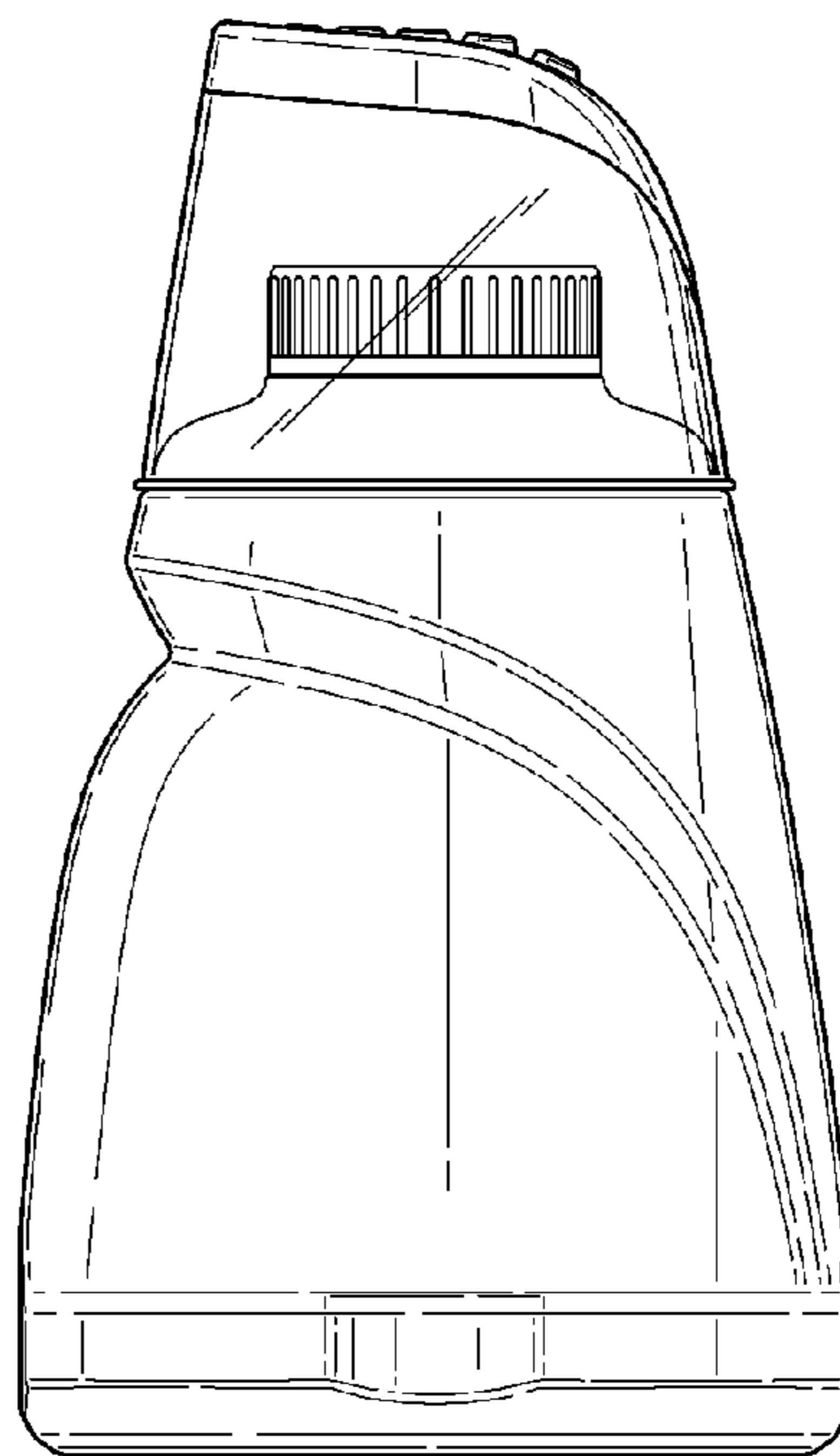

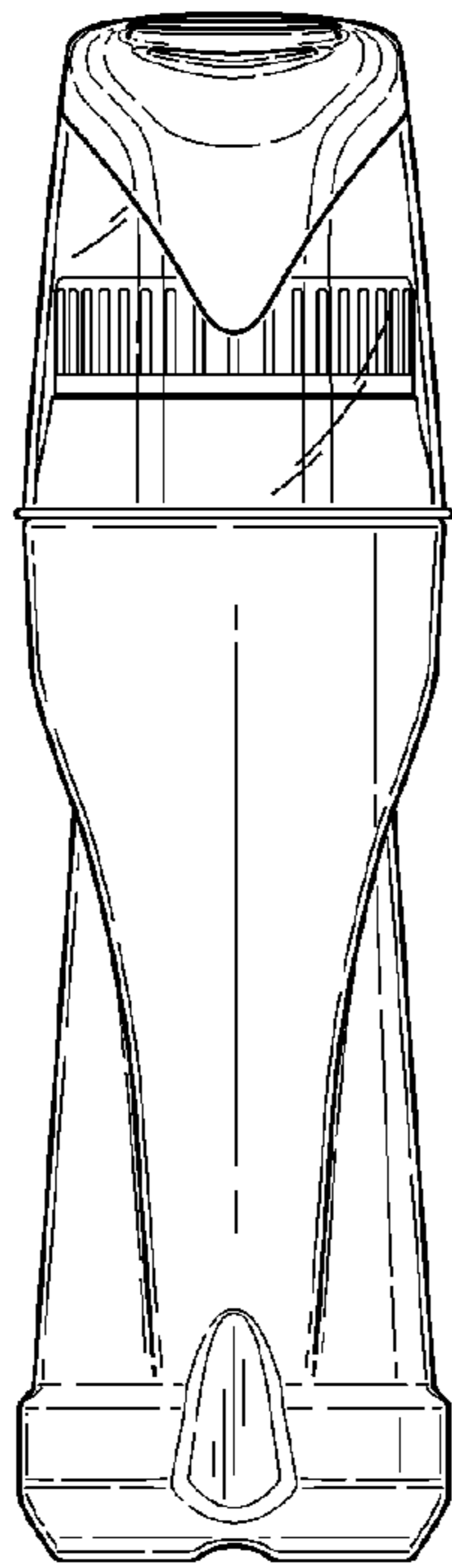

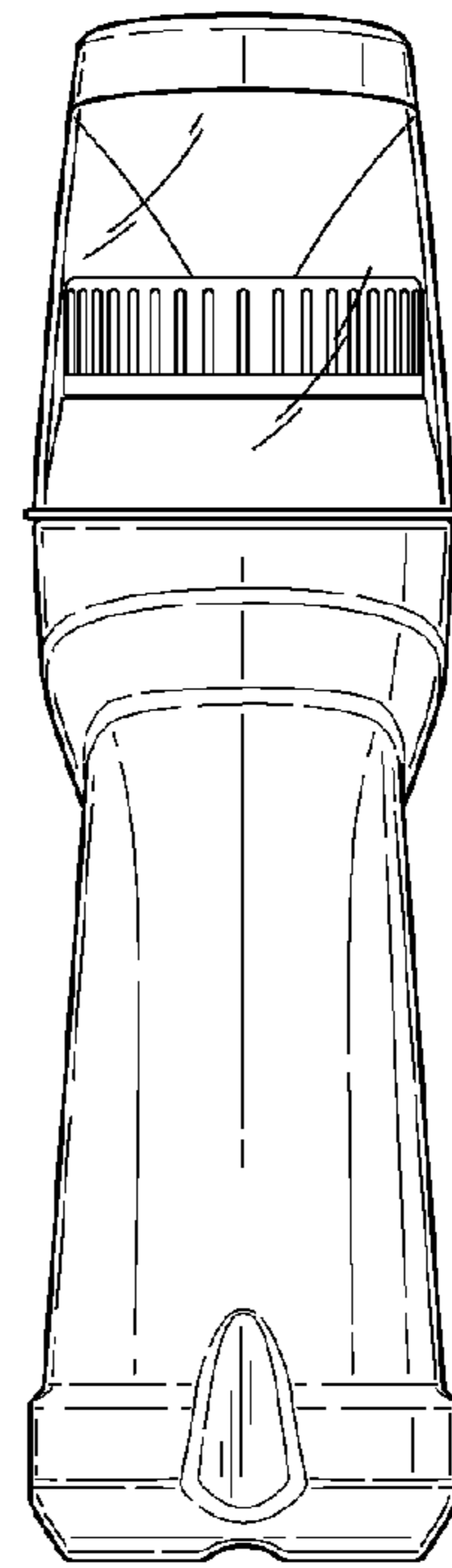

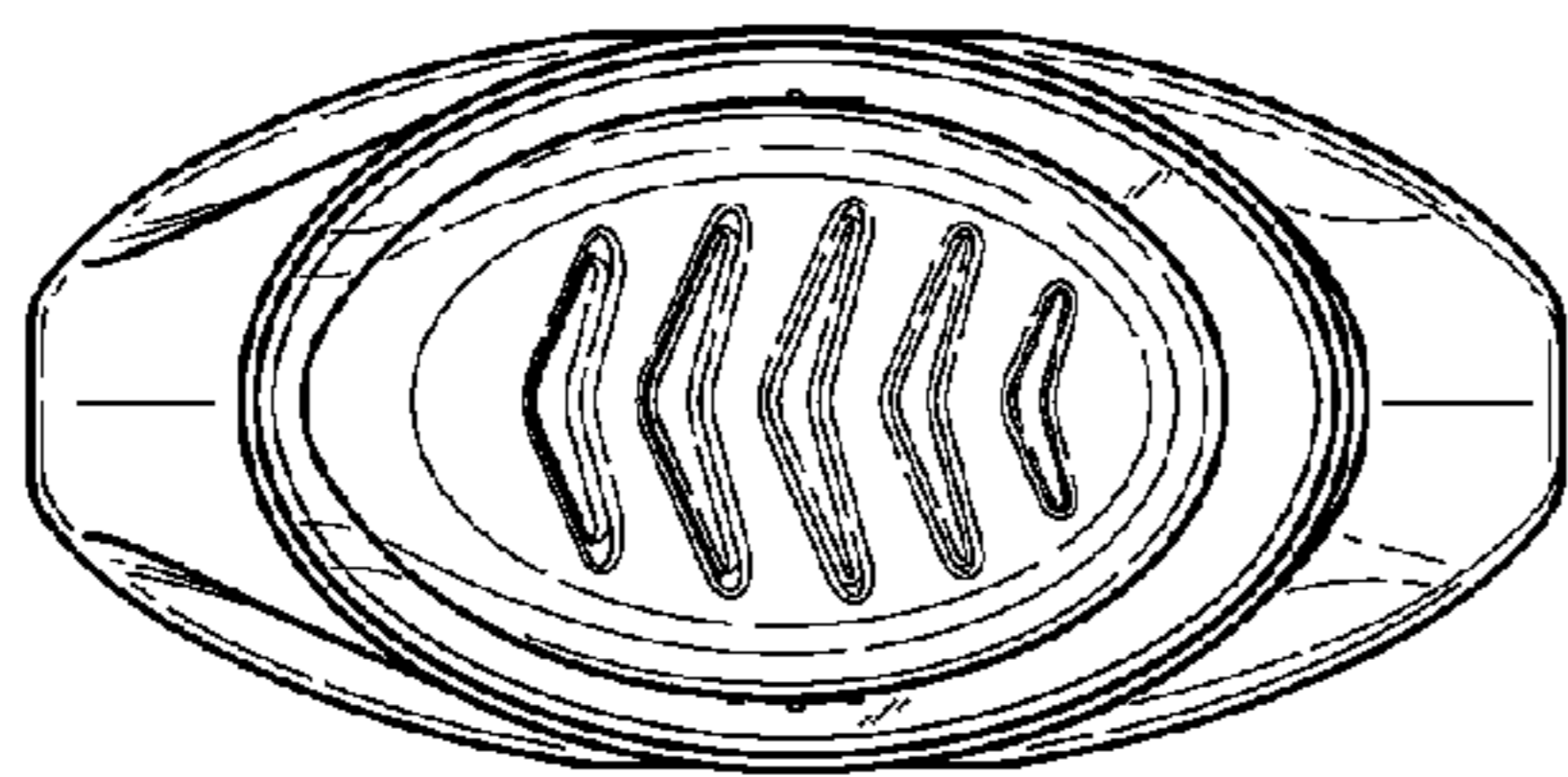

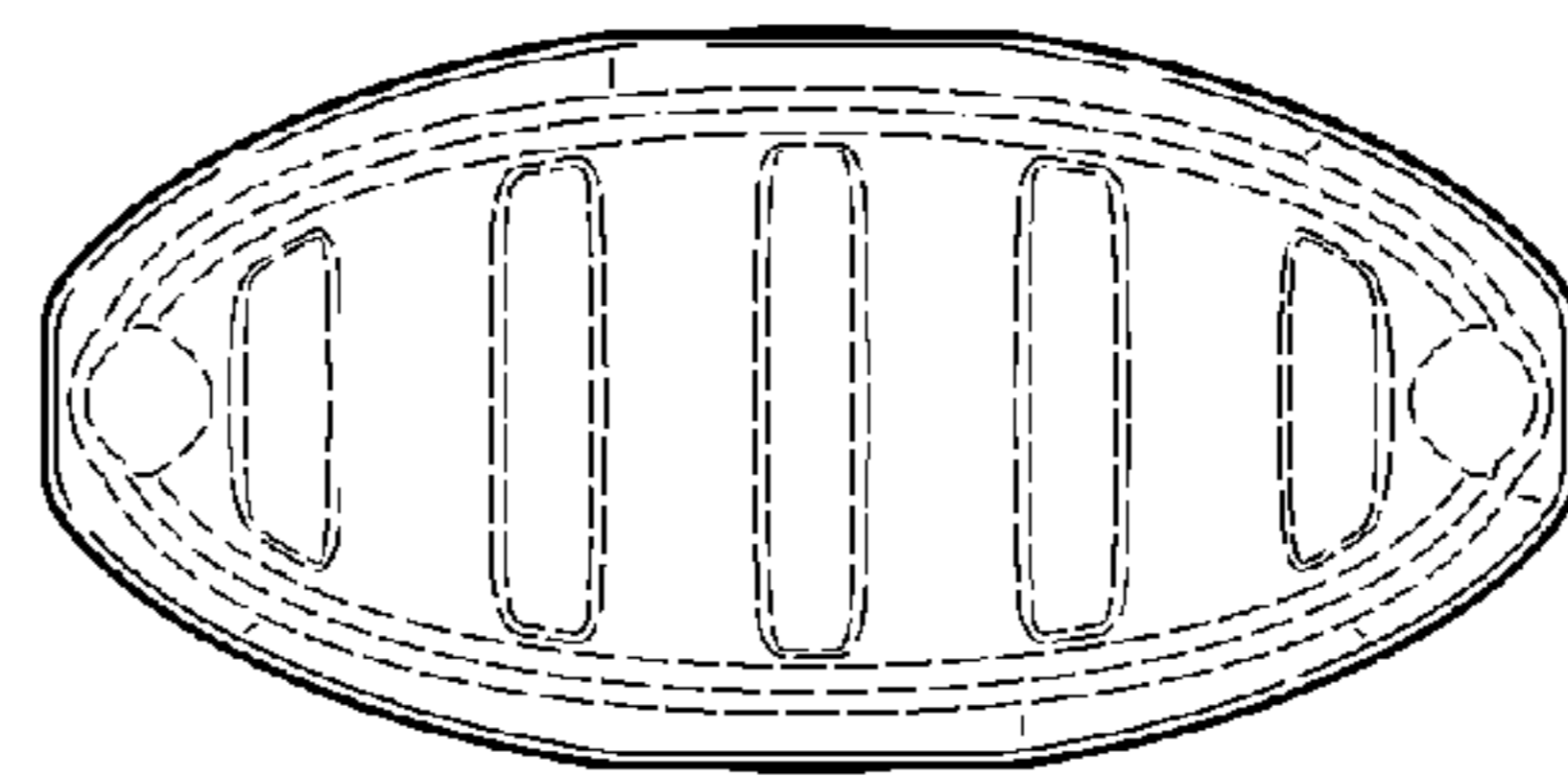
