(57) **CLAIM**

I claim the ornamental design for a dispensing container, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a dispensing container of the present invention;

FIG. 2 is a left side elevation view of the dispensing container of FIG. 1;

FIG. 3 is a top plan view of the dispensing container of FIG. 1, shown at an enlarged scale;

FIG. 4 is a rear elevation view of the dispensing container of FIG. 1;

FIG. 5 is a right side elevation view of the dispensing container of FIG. 1; and,

FIG. 6 is a bottom plan view of the dispensing container of FIG. 1, shown at an enlarged scale.

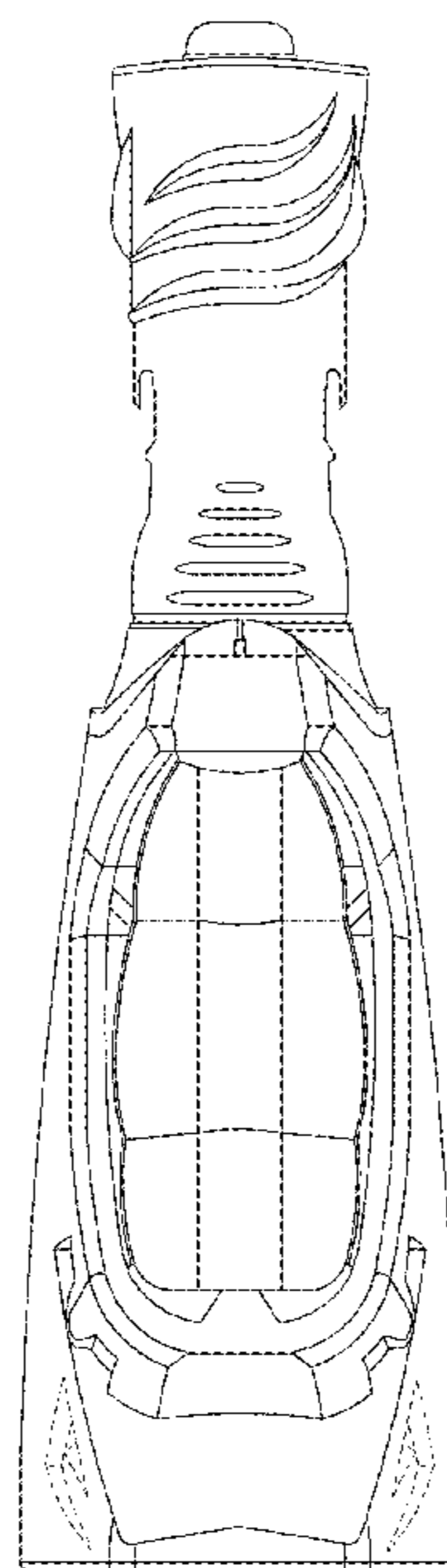
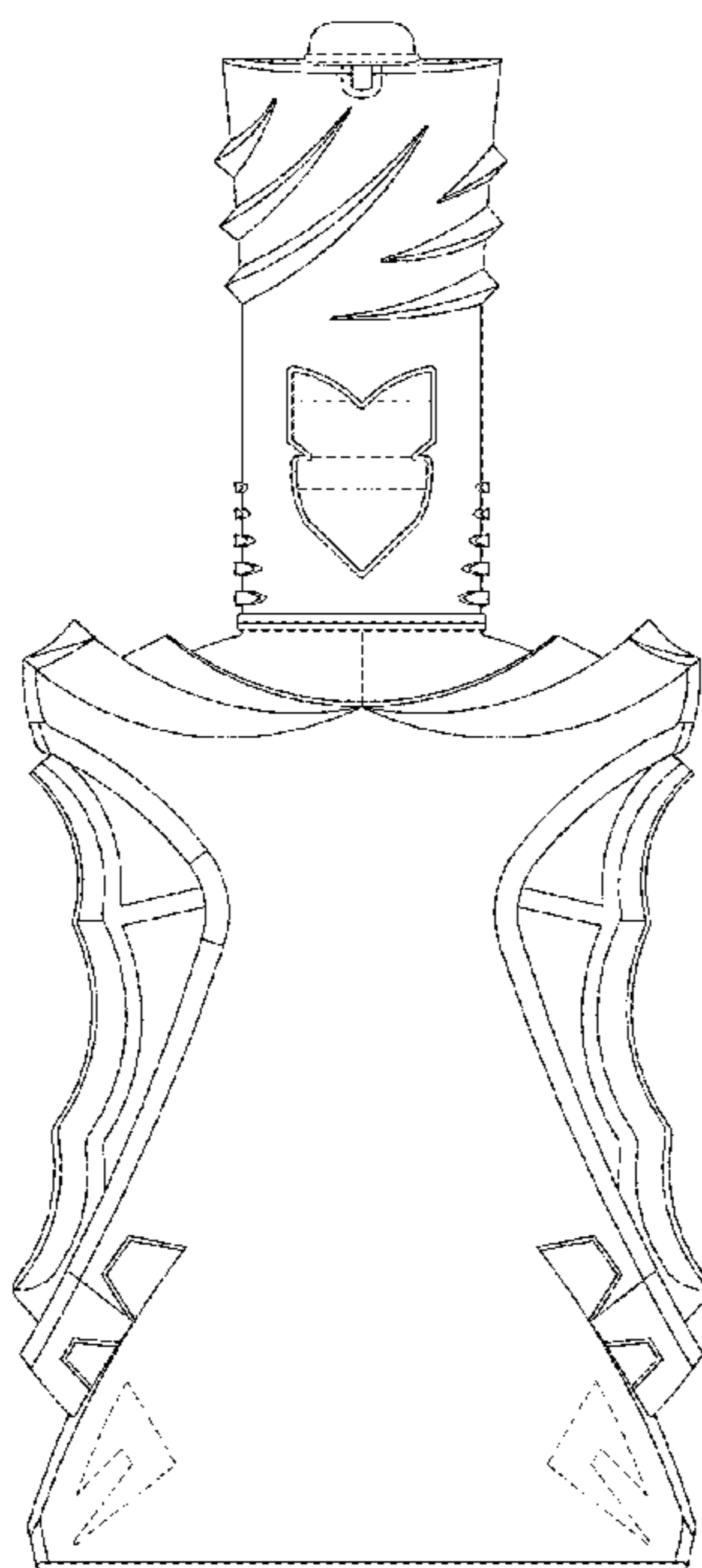

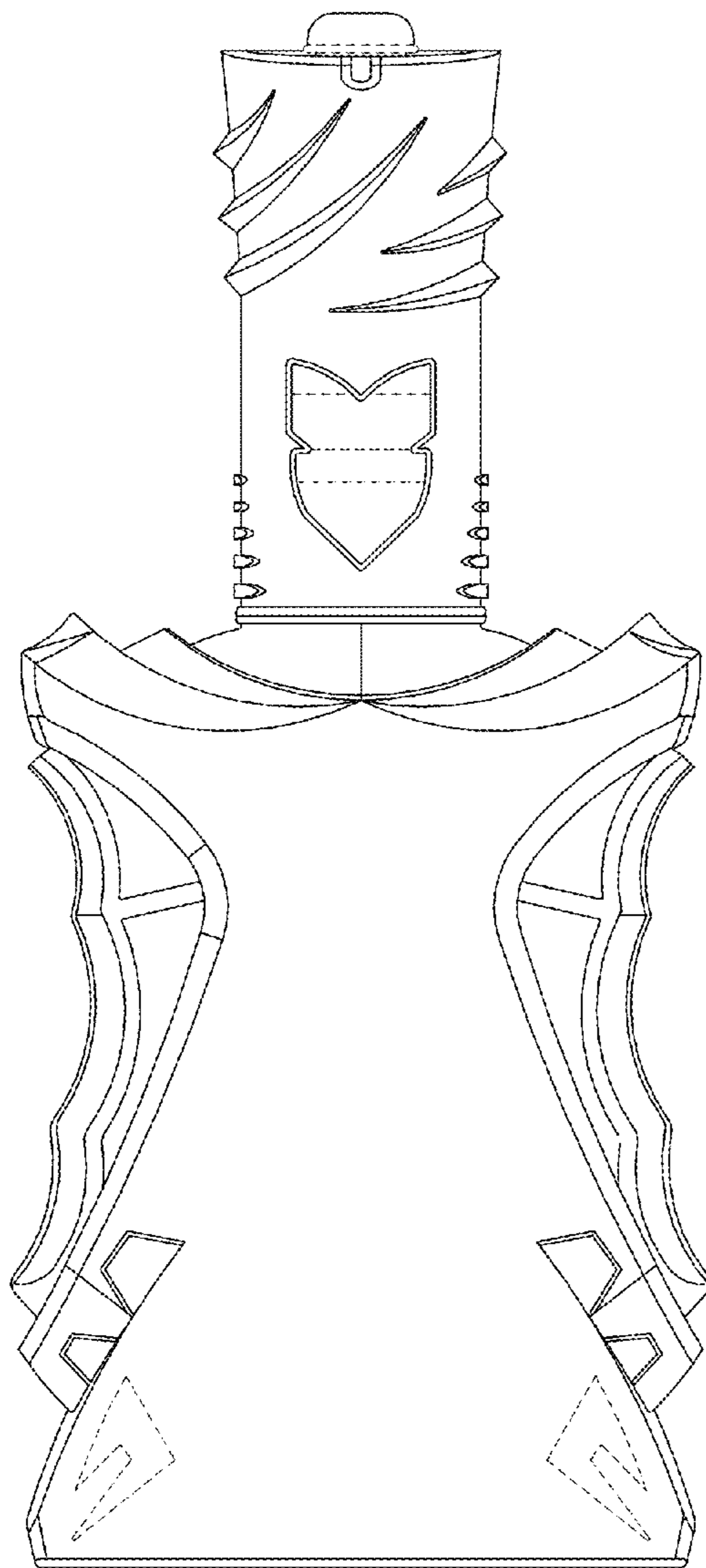

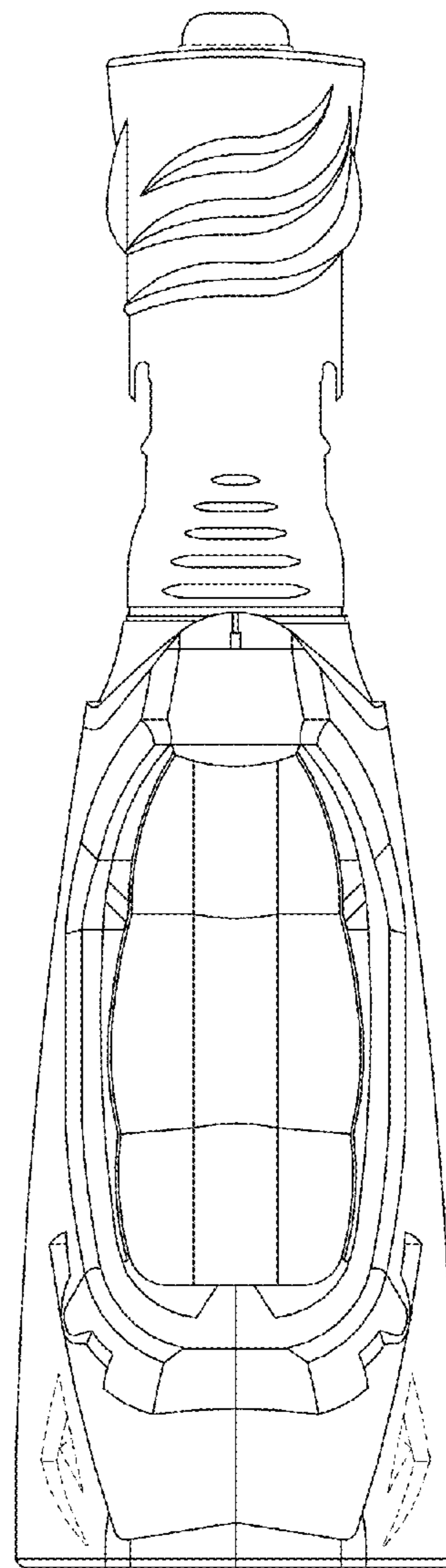

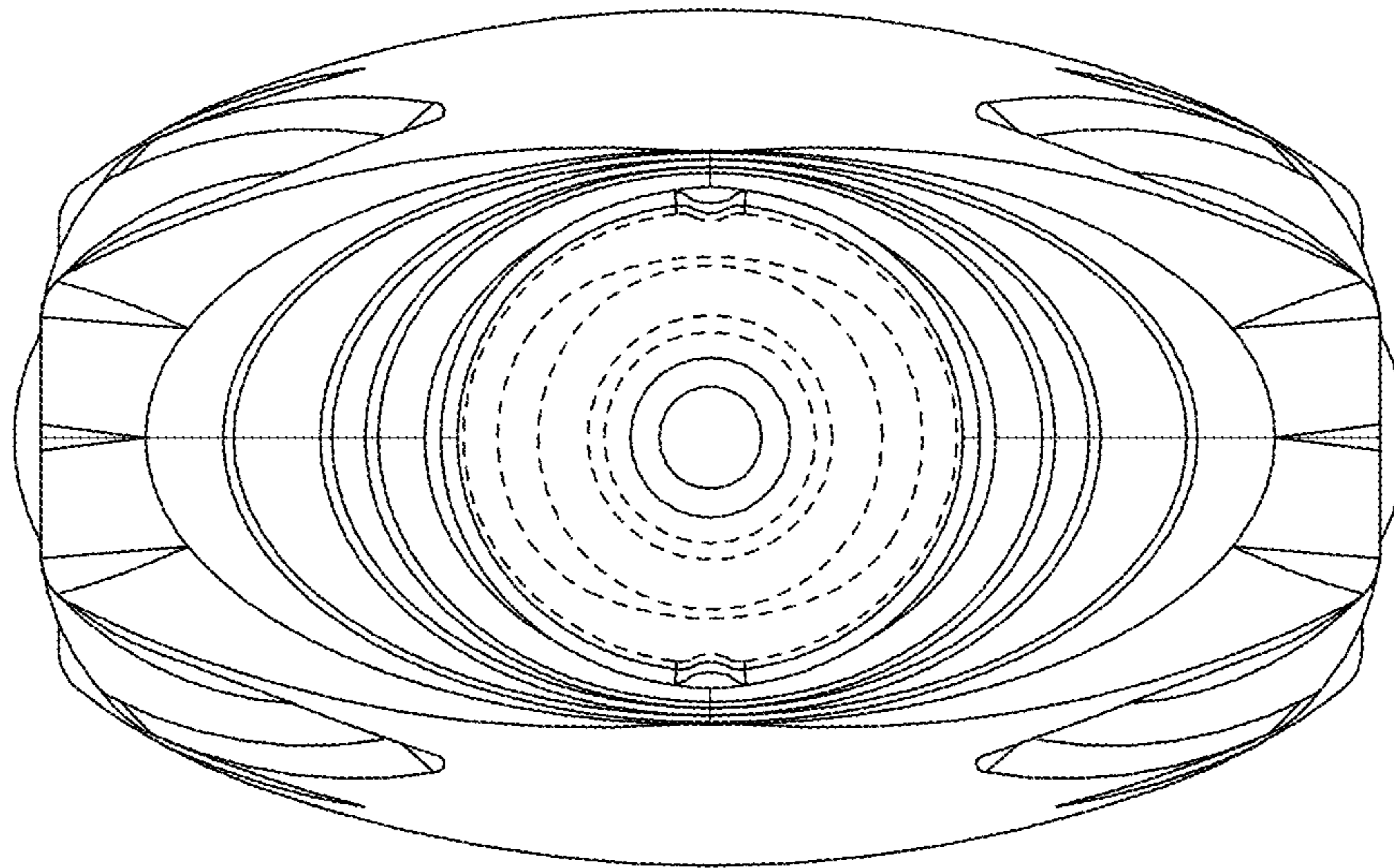

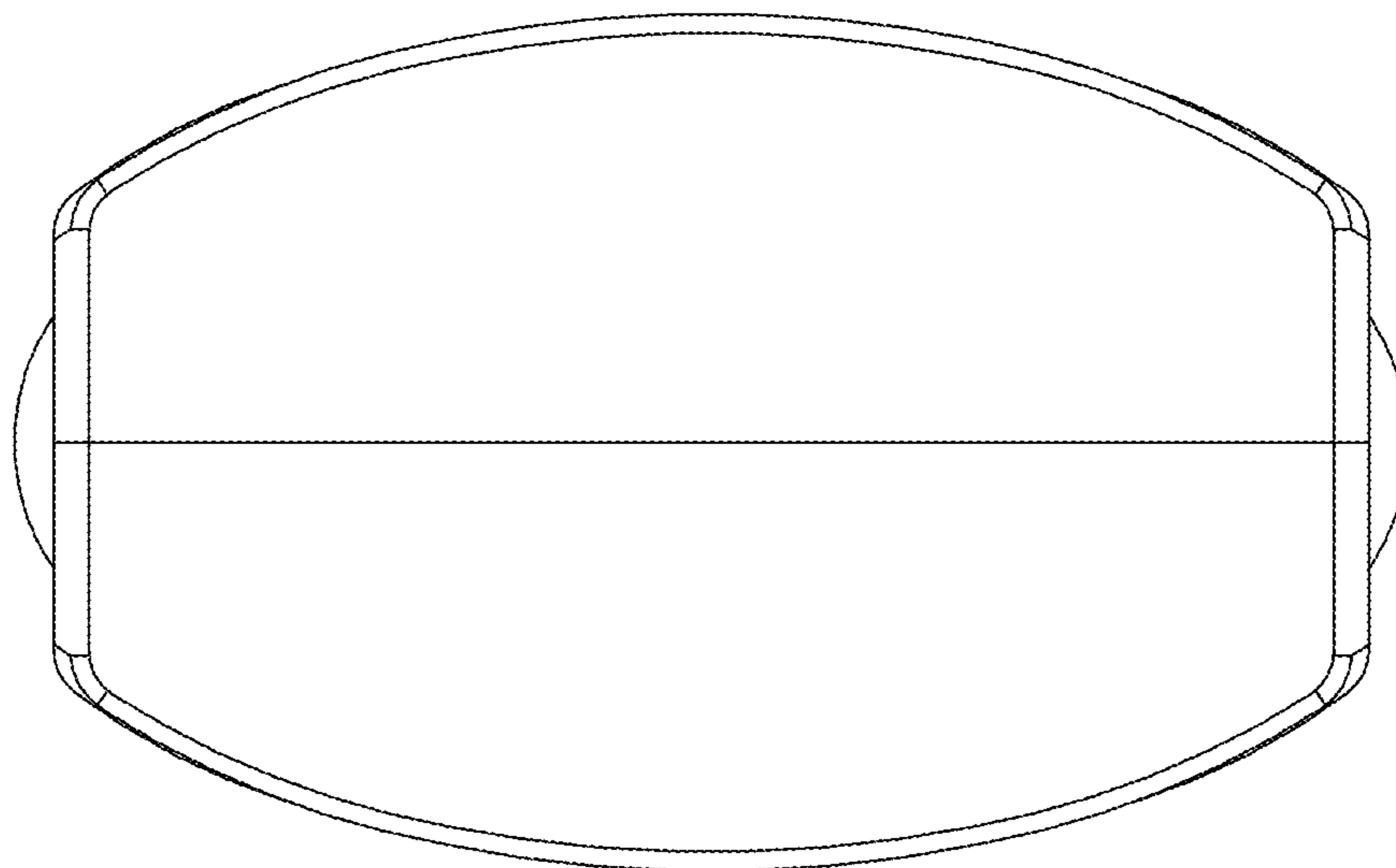

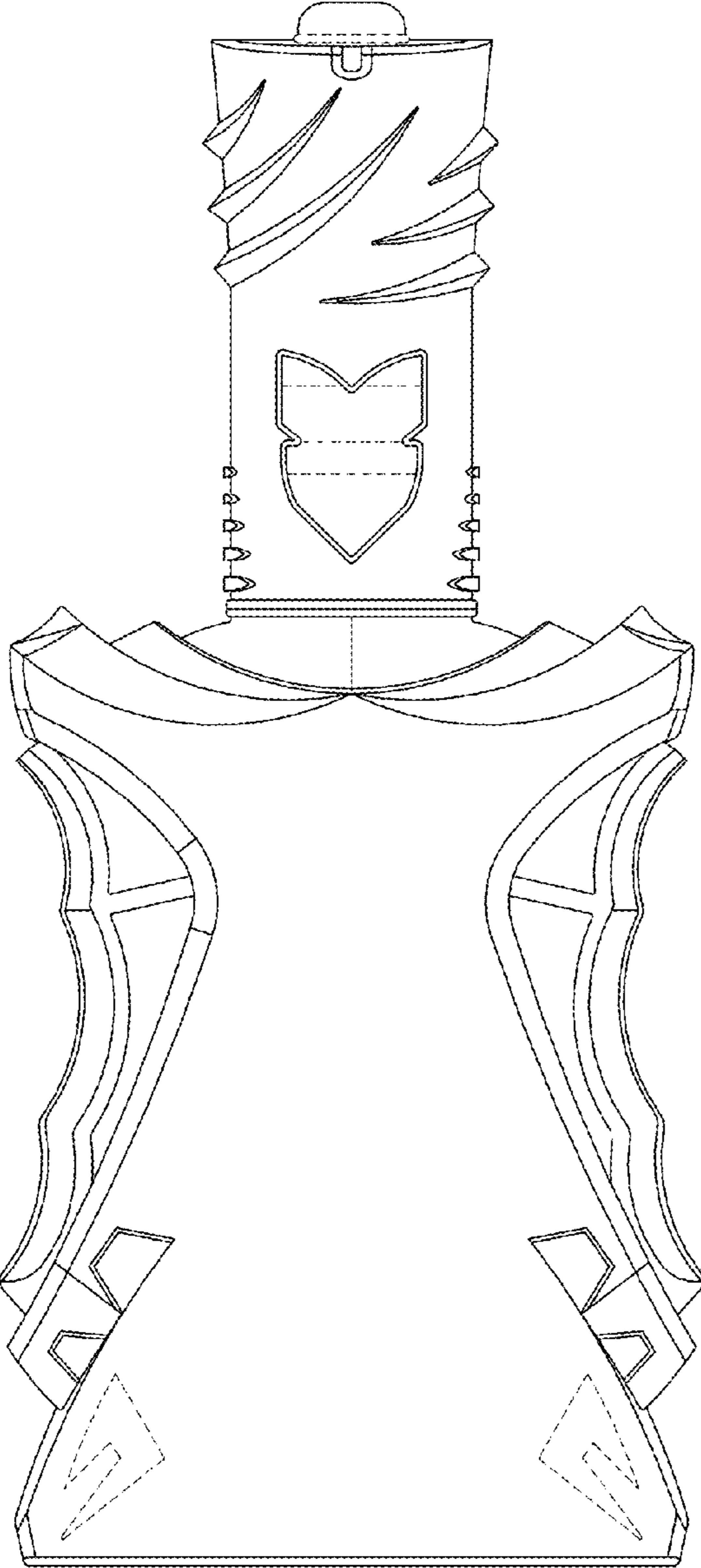
