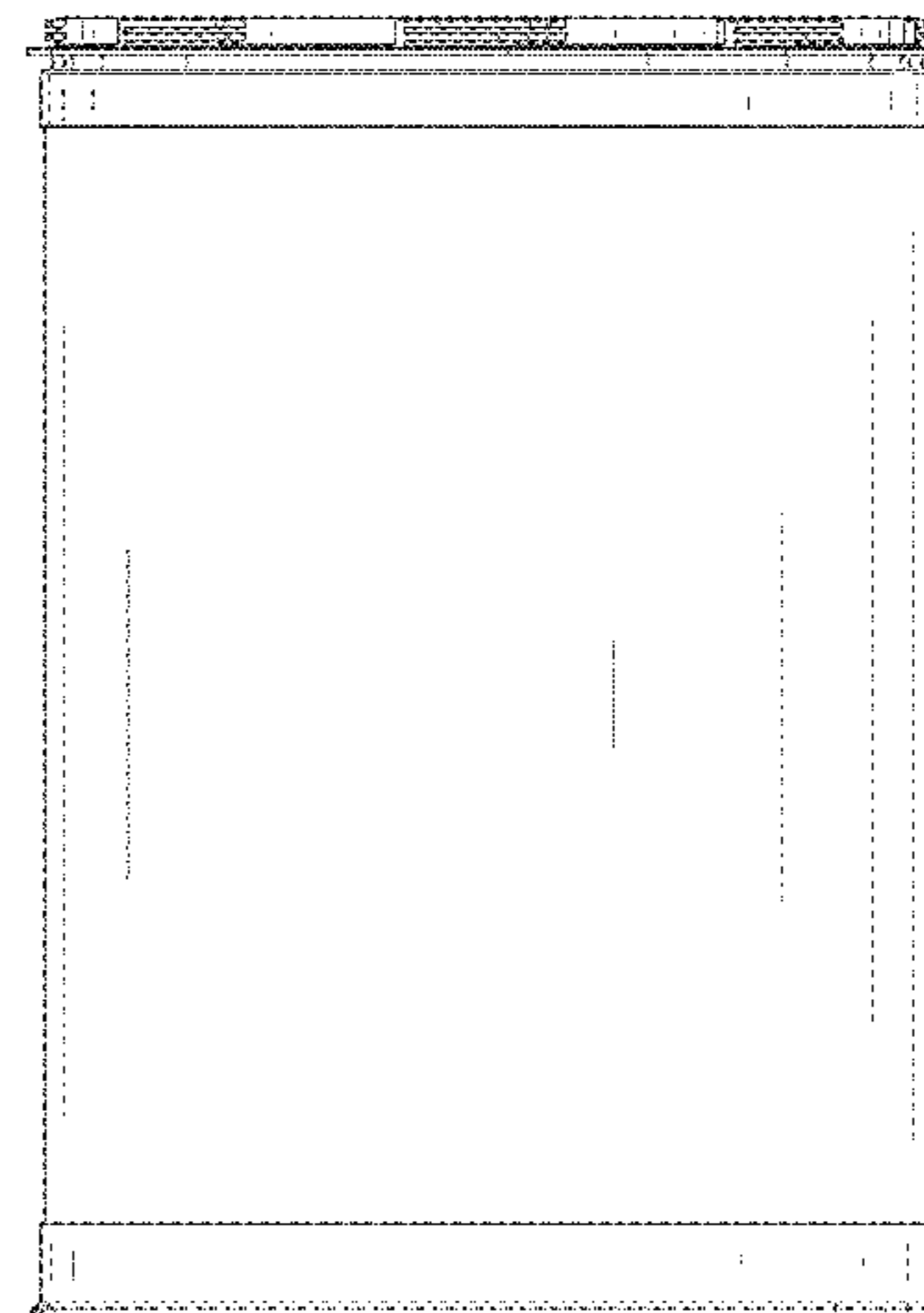
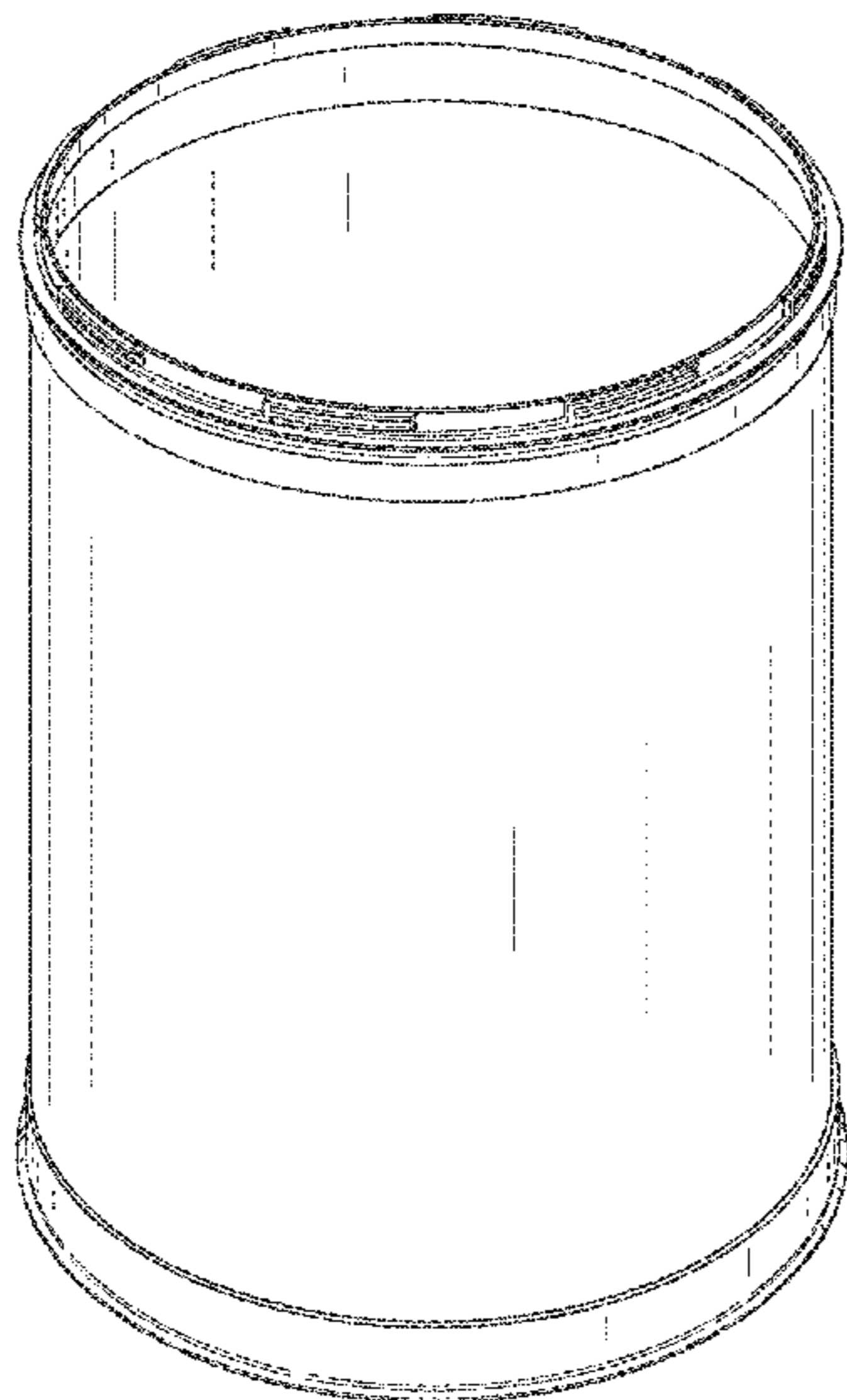
(57) **CLAIM**
We claim the ornamental design for a chime, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of the claimed design;
FIG. 2 is a front view of the claimed design of FIG. 1, with the rear, left, and right views being the same;
FIG. 3 is a top plan view of the claimed design of FIG. 1; and, FIG. 4 is a bottom plan view of the claimed design of FIG. 1. The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design. The dot-dash lines in the drawings form a boundary of the claimed design.

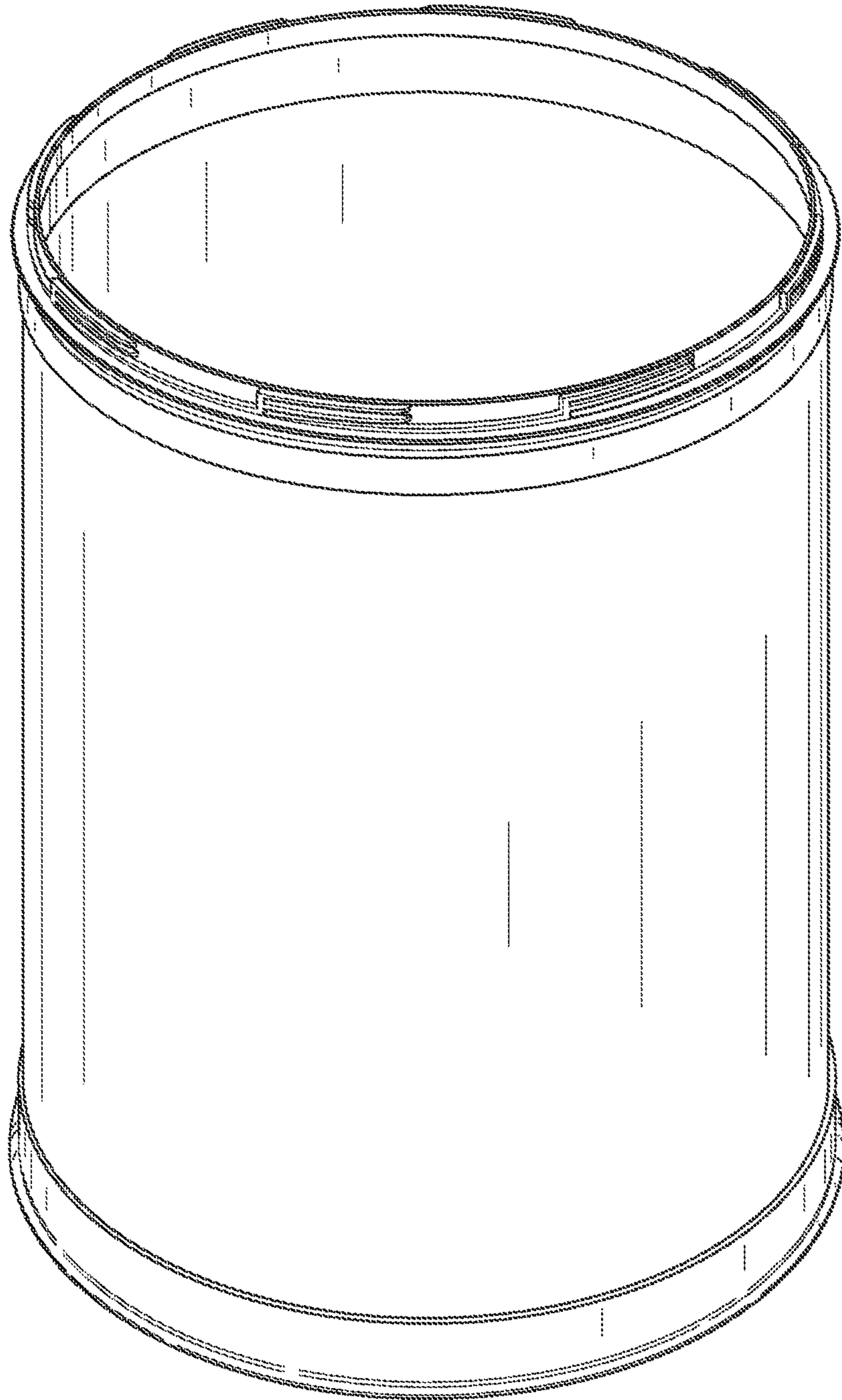

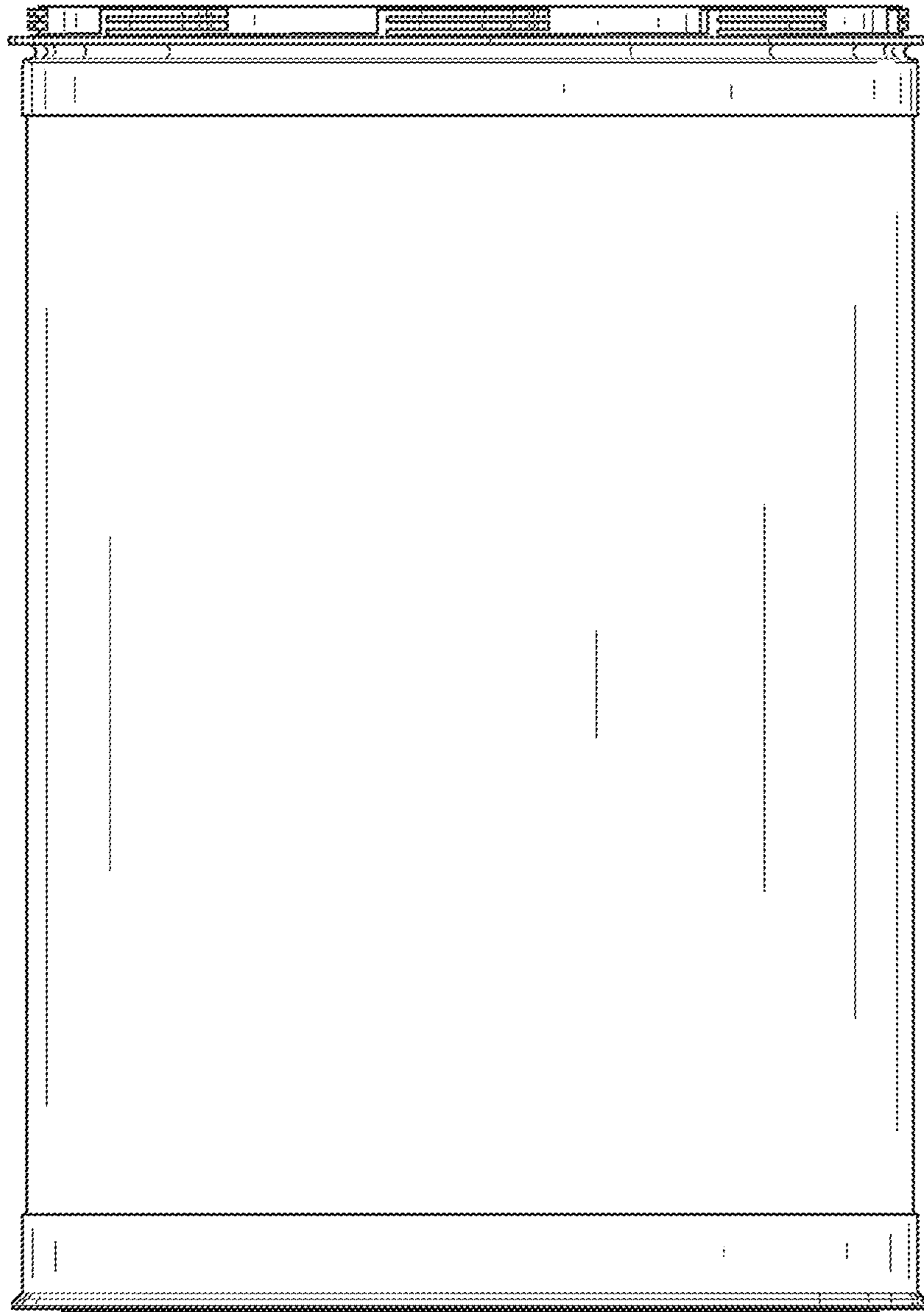

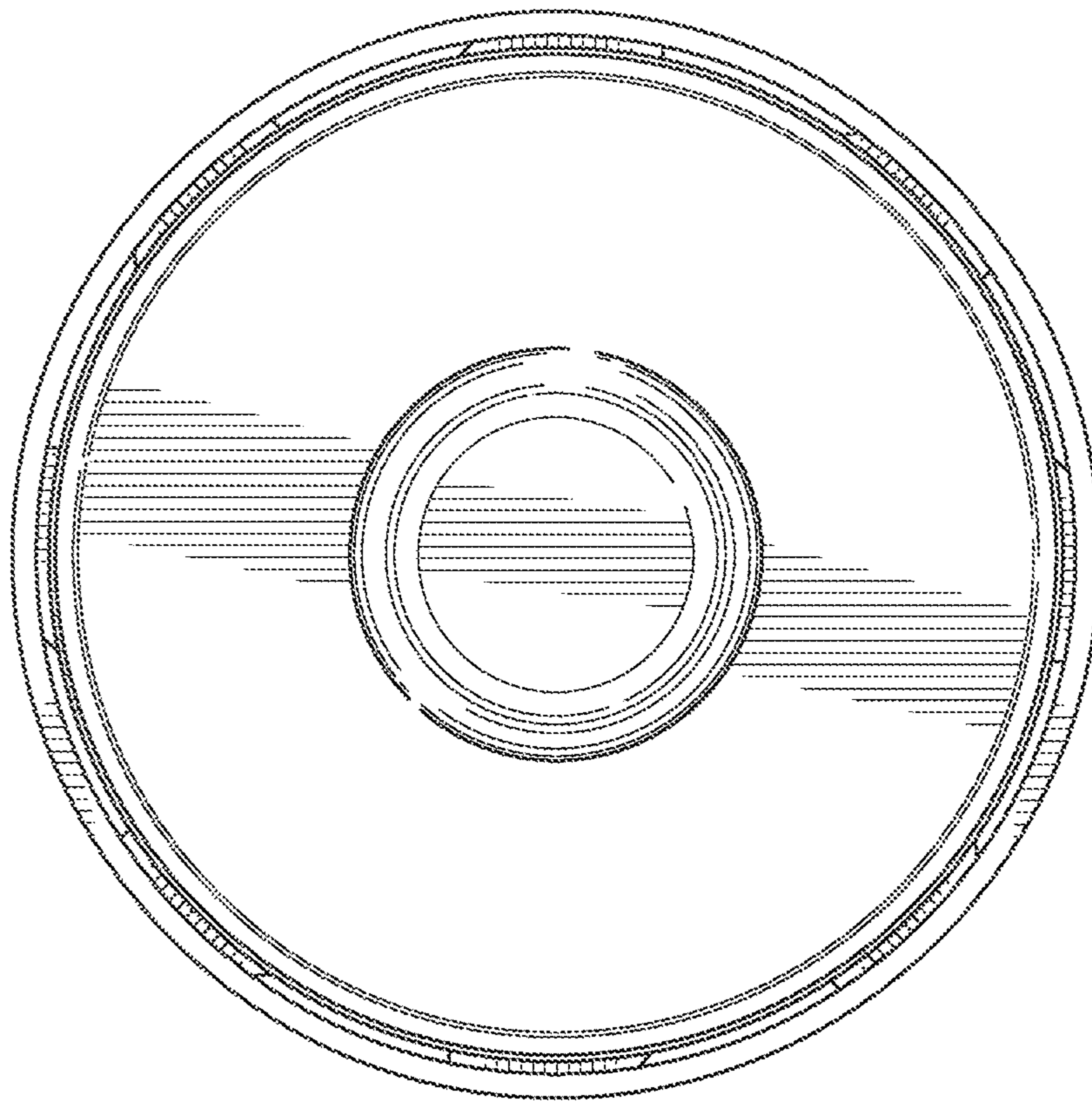

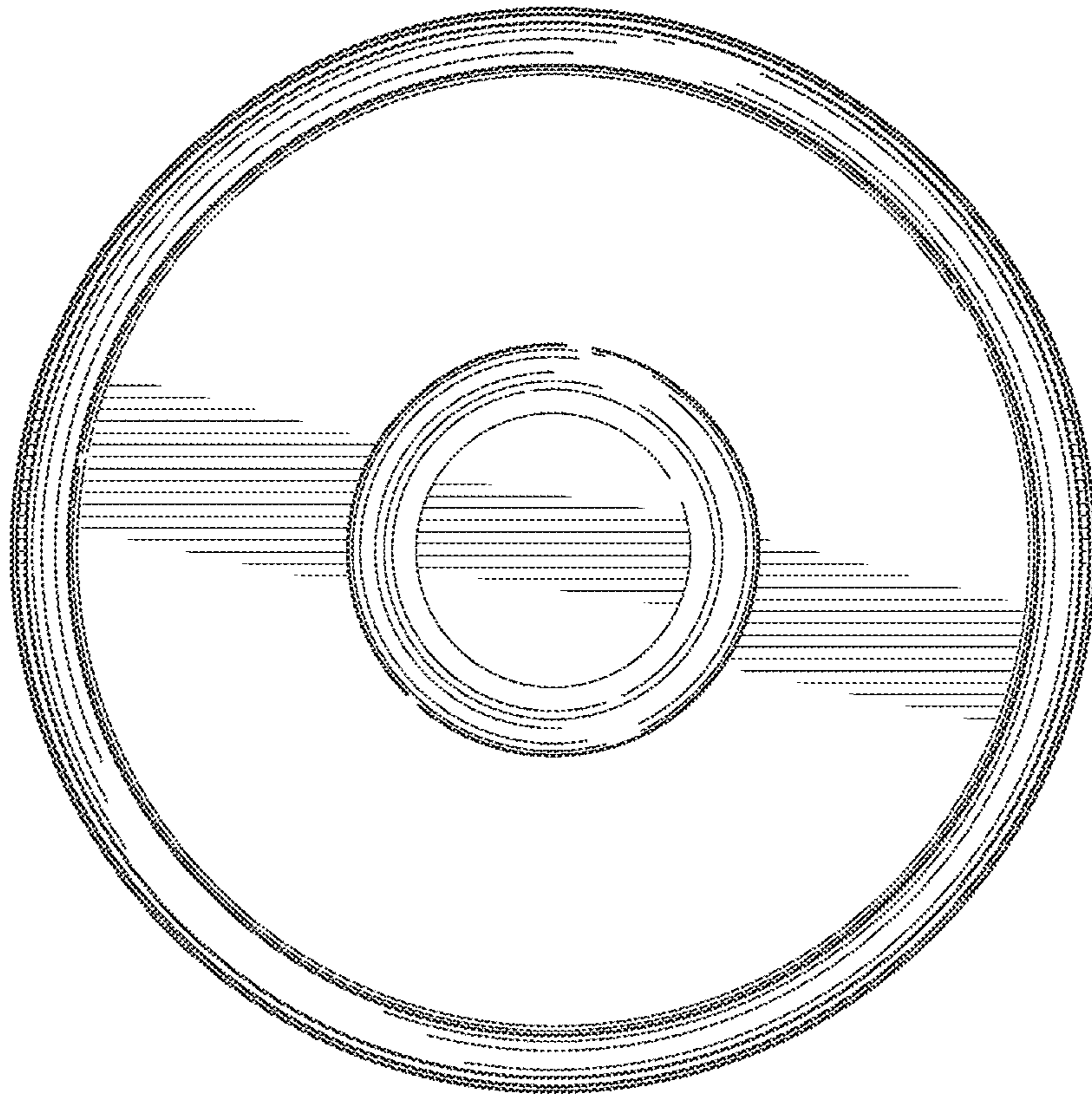
