The ornamental design for a flag pendant, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a flag pendant according to one embodiment;

FIG. 2 is a top plan view of a flag pendant of FIG. 1;

FIG. 3 is a left side elevational view of a flag pendant of FIG. 1;

FIG. 4 is a right side elevational view of a flag pendant of FIG. 1;

FIG. 5 is a bottom plan view of a flag pendant of FIG. 1;

FIG. 6 is a rear elevational view of a flag pendant of FIG. 1;

FIG. 7 is a front elevational view of a flag pendant according to another embodiment;

FIG. 8 is a top plan view of the flag pendant of FIG. 7;

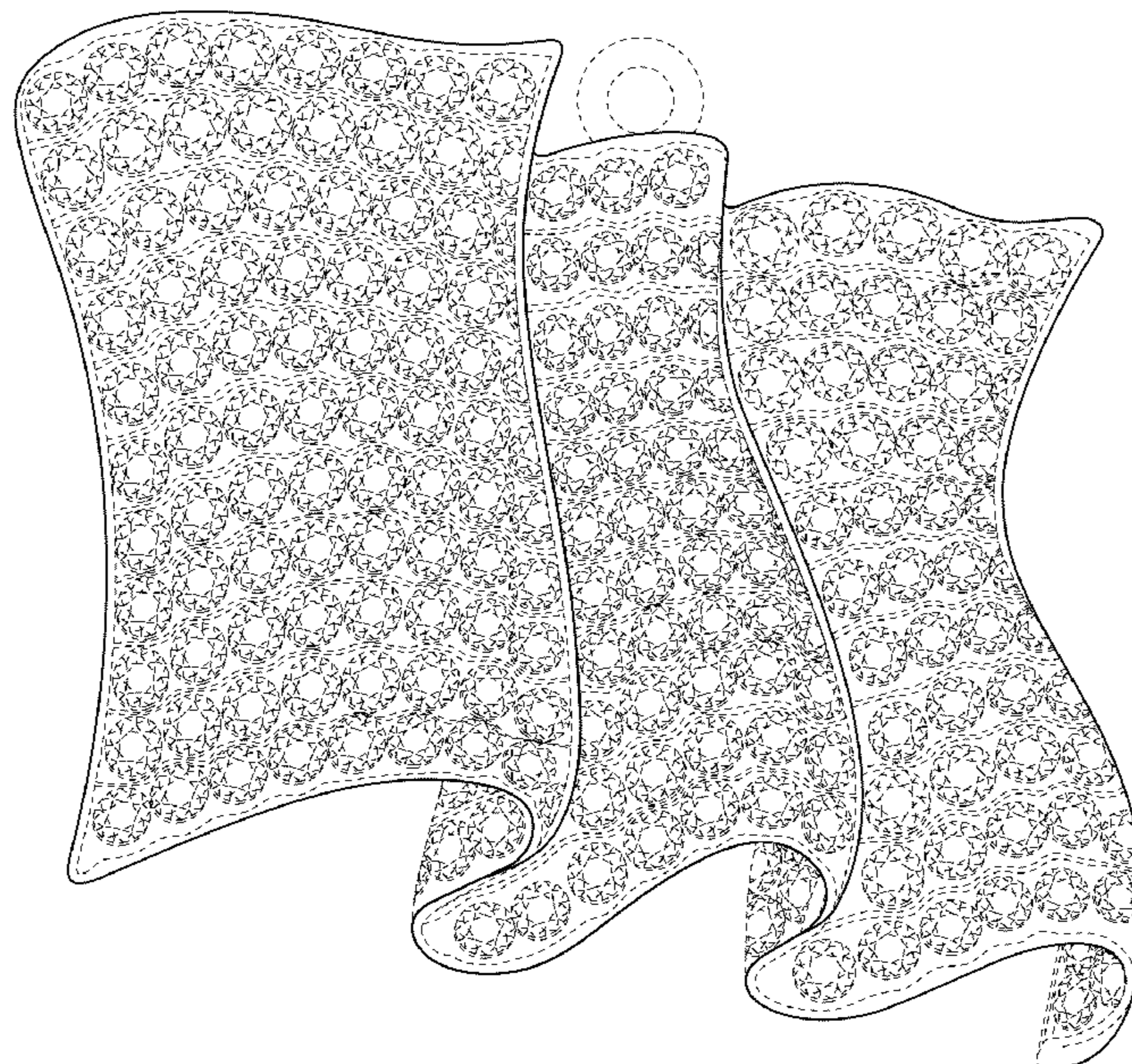
FIG. 9 is a left side elevational view of the flag pendant of FIG. 7;

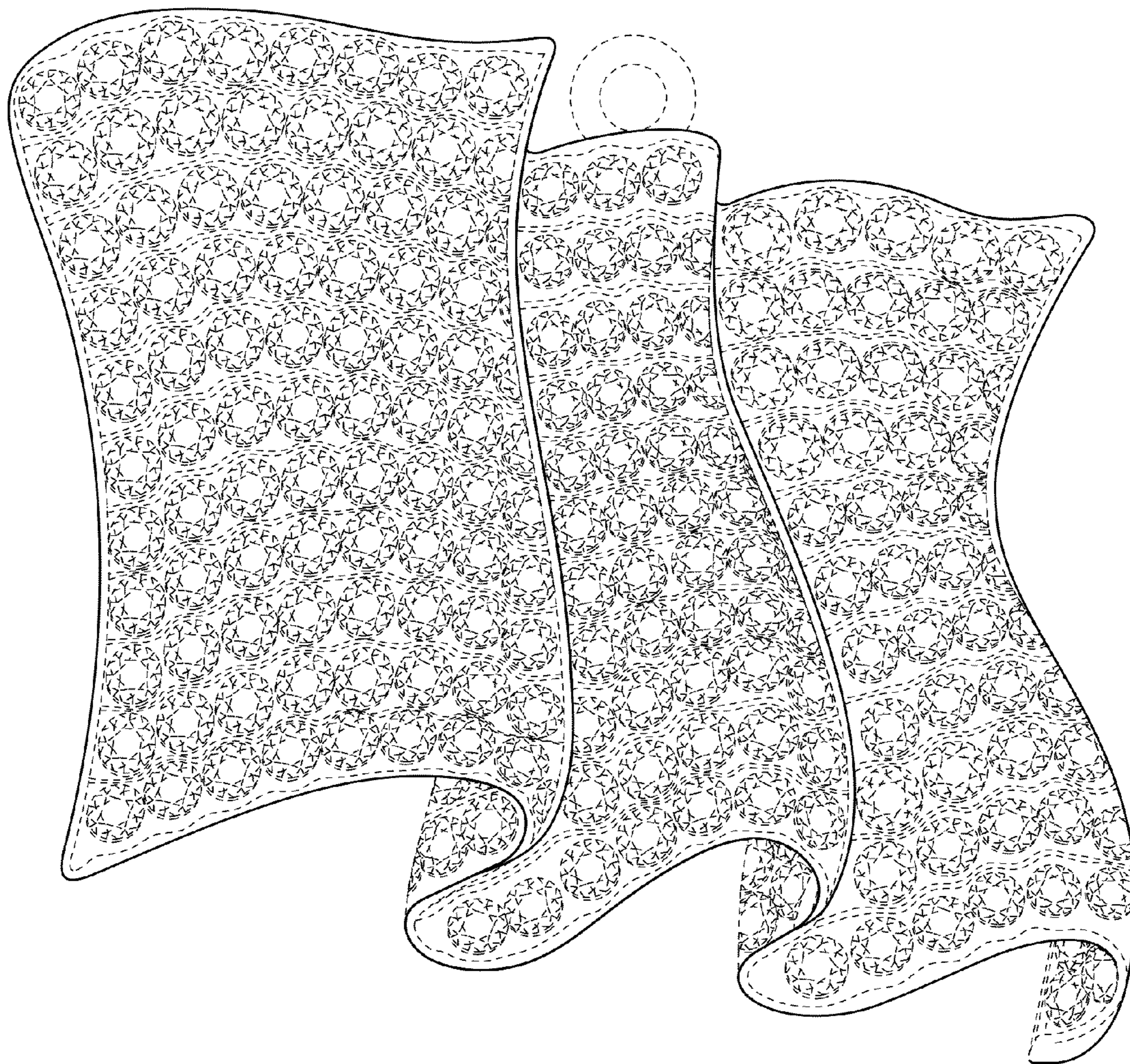

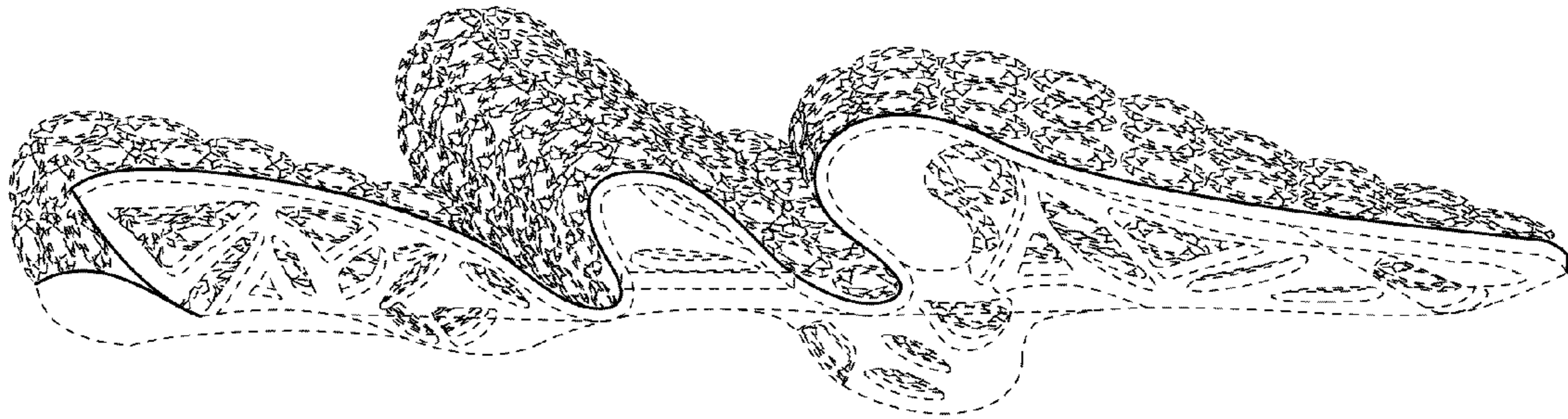

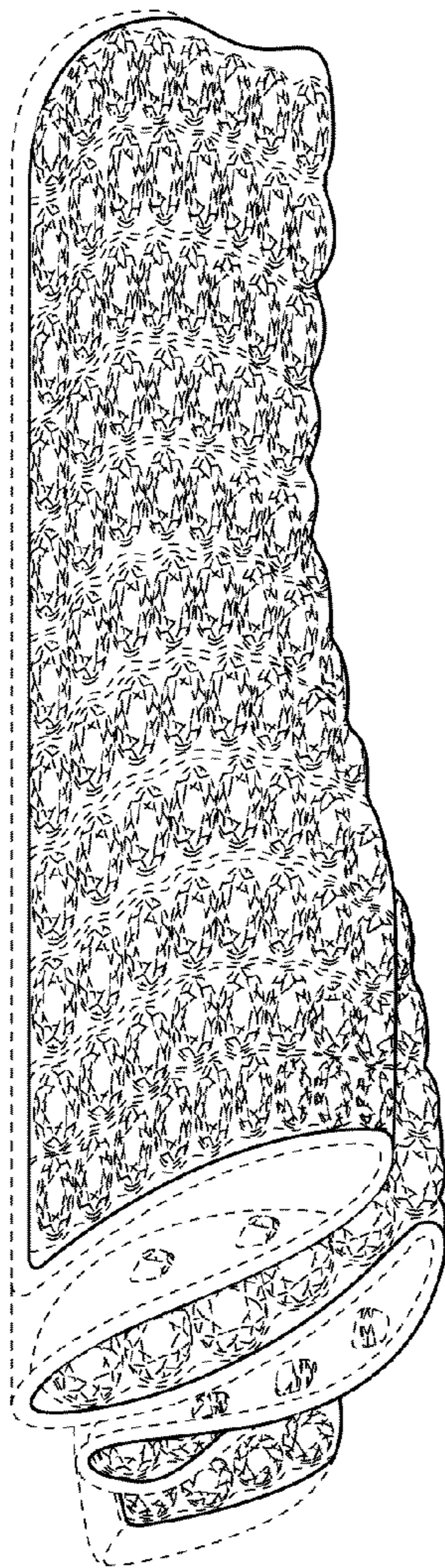

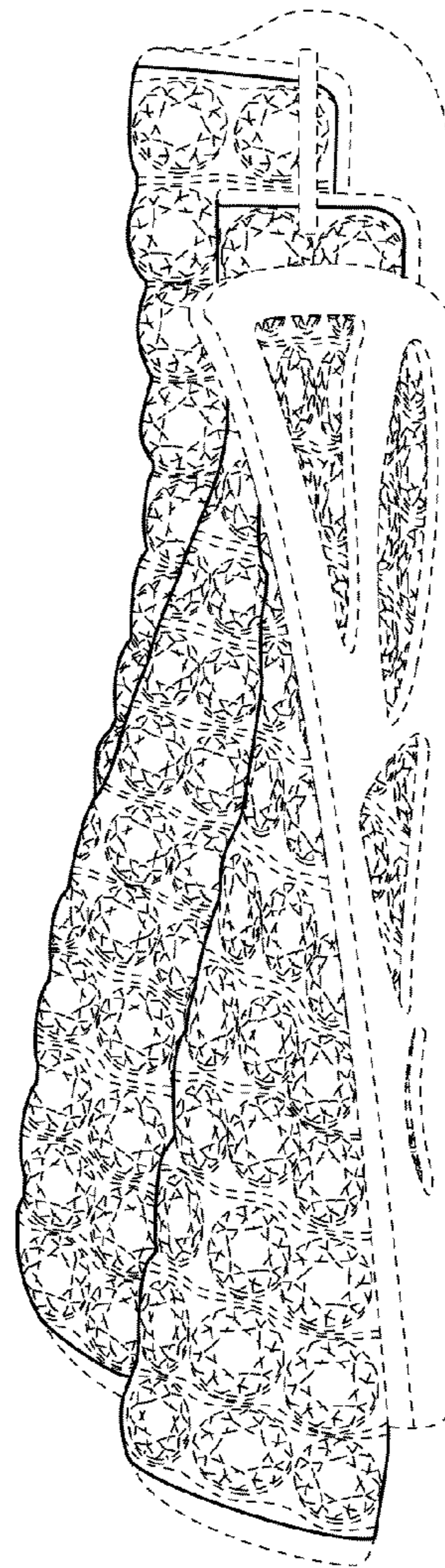

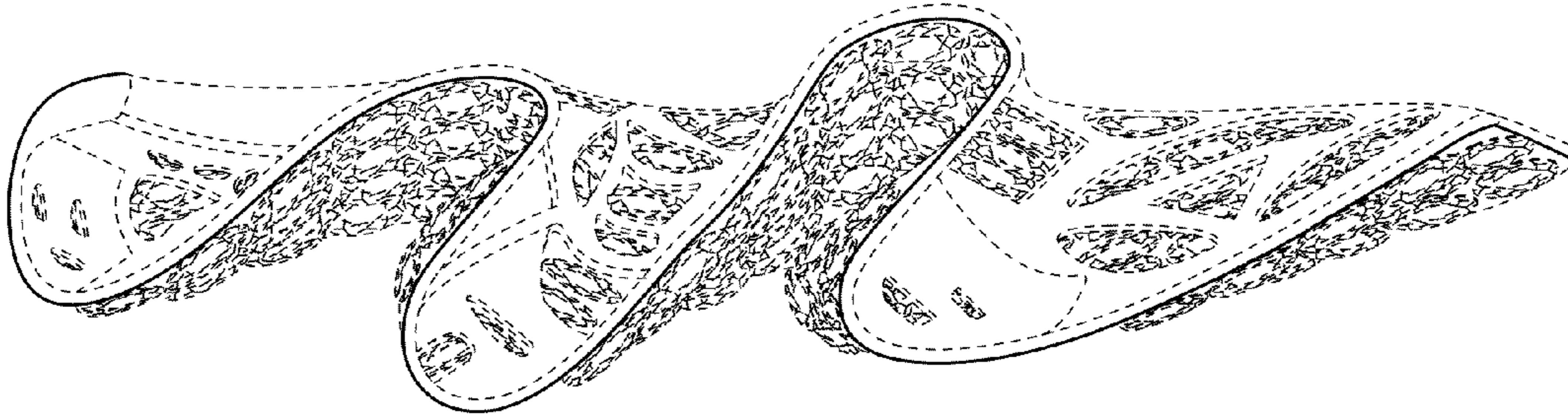

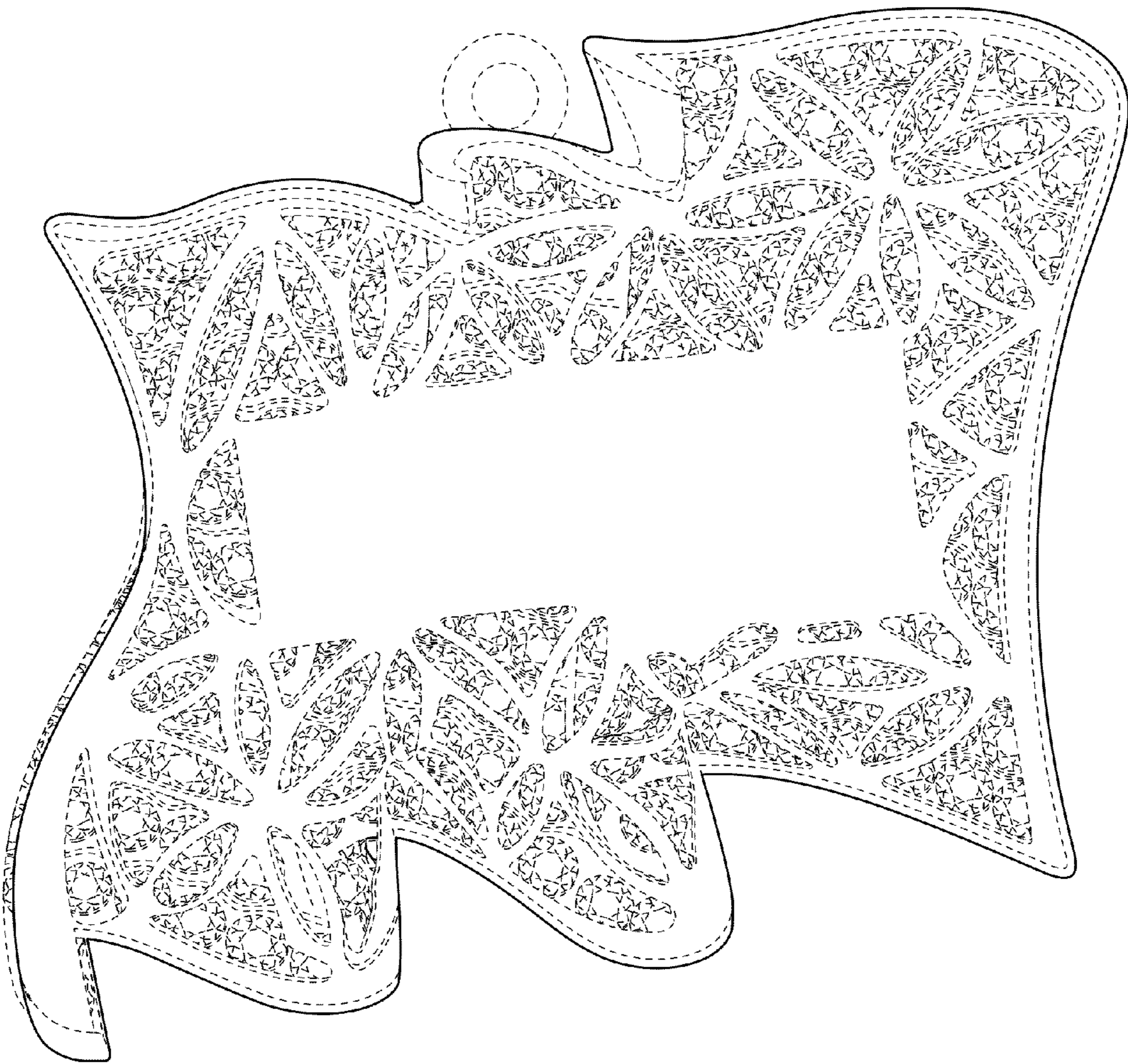

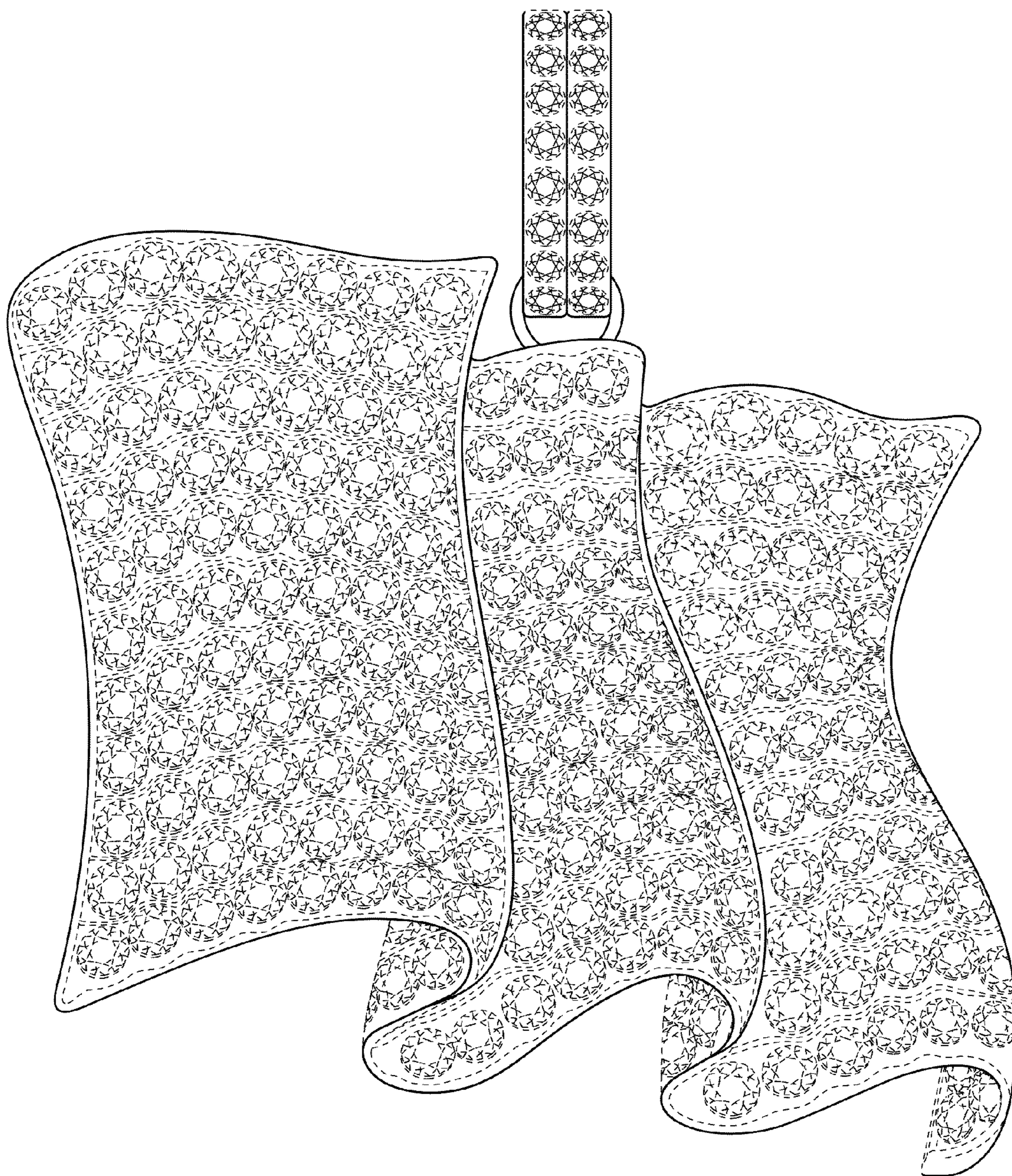

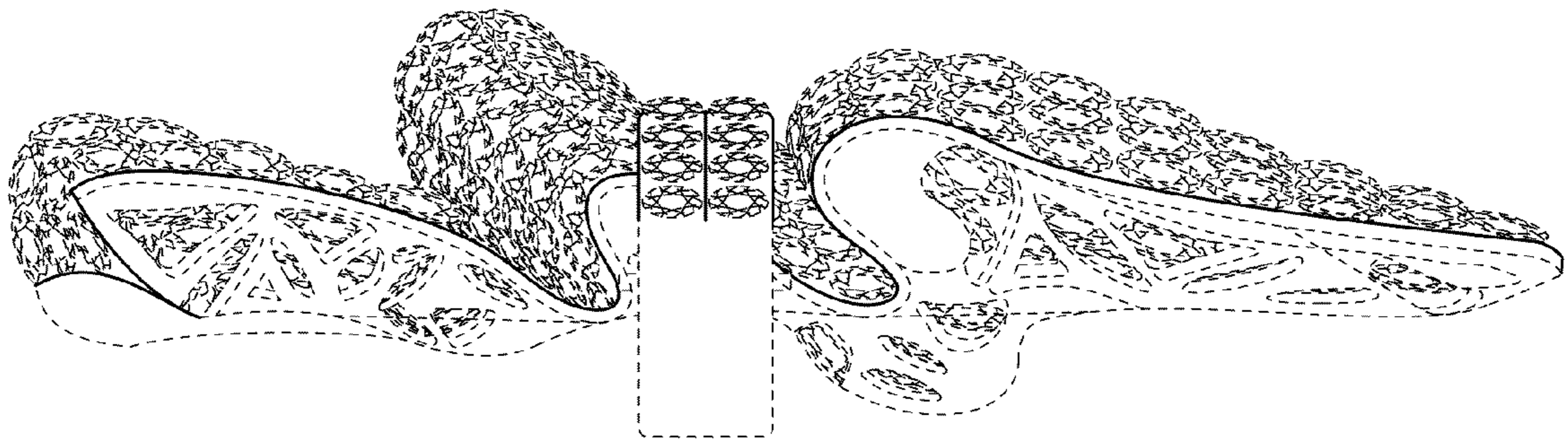

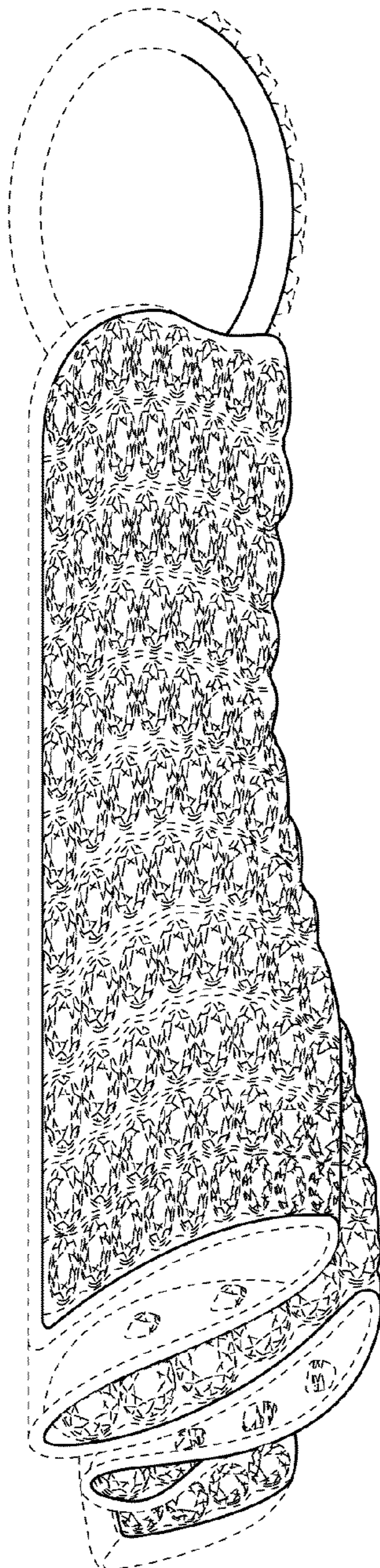

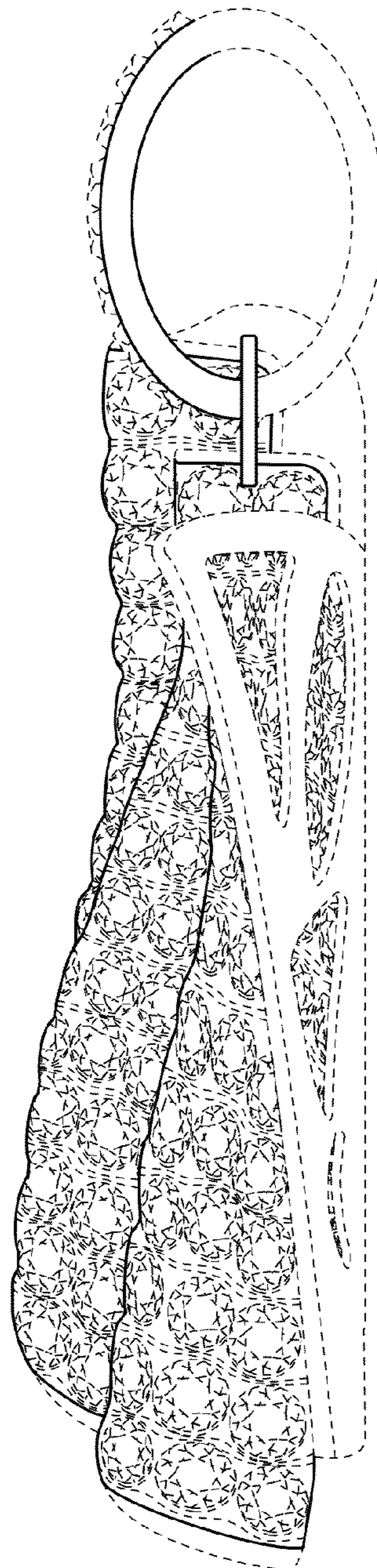

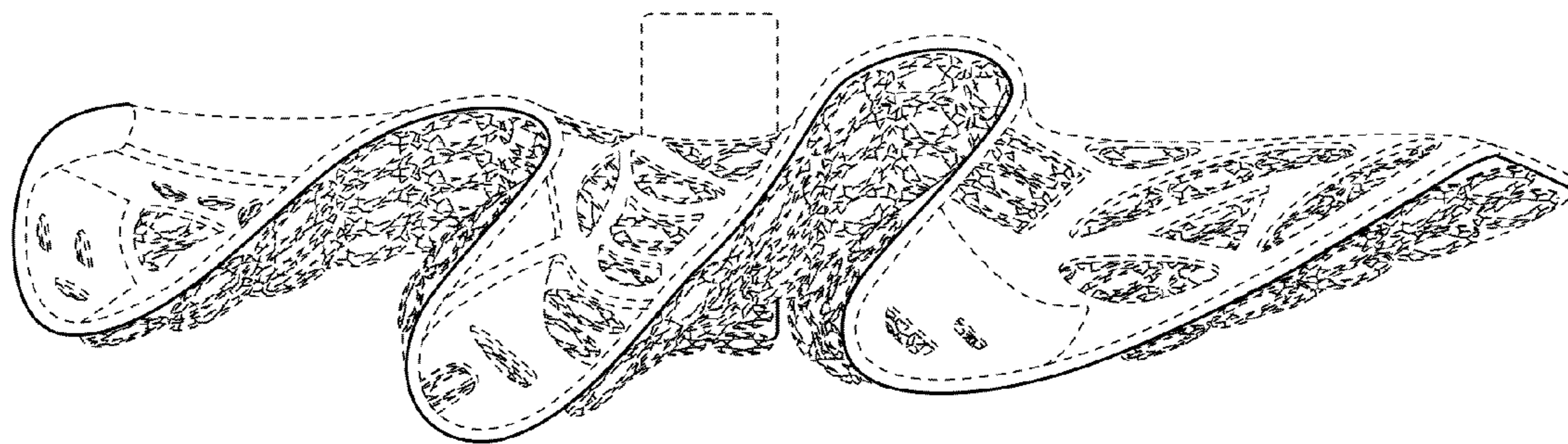

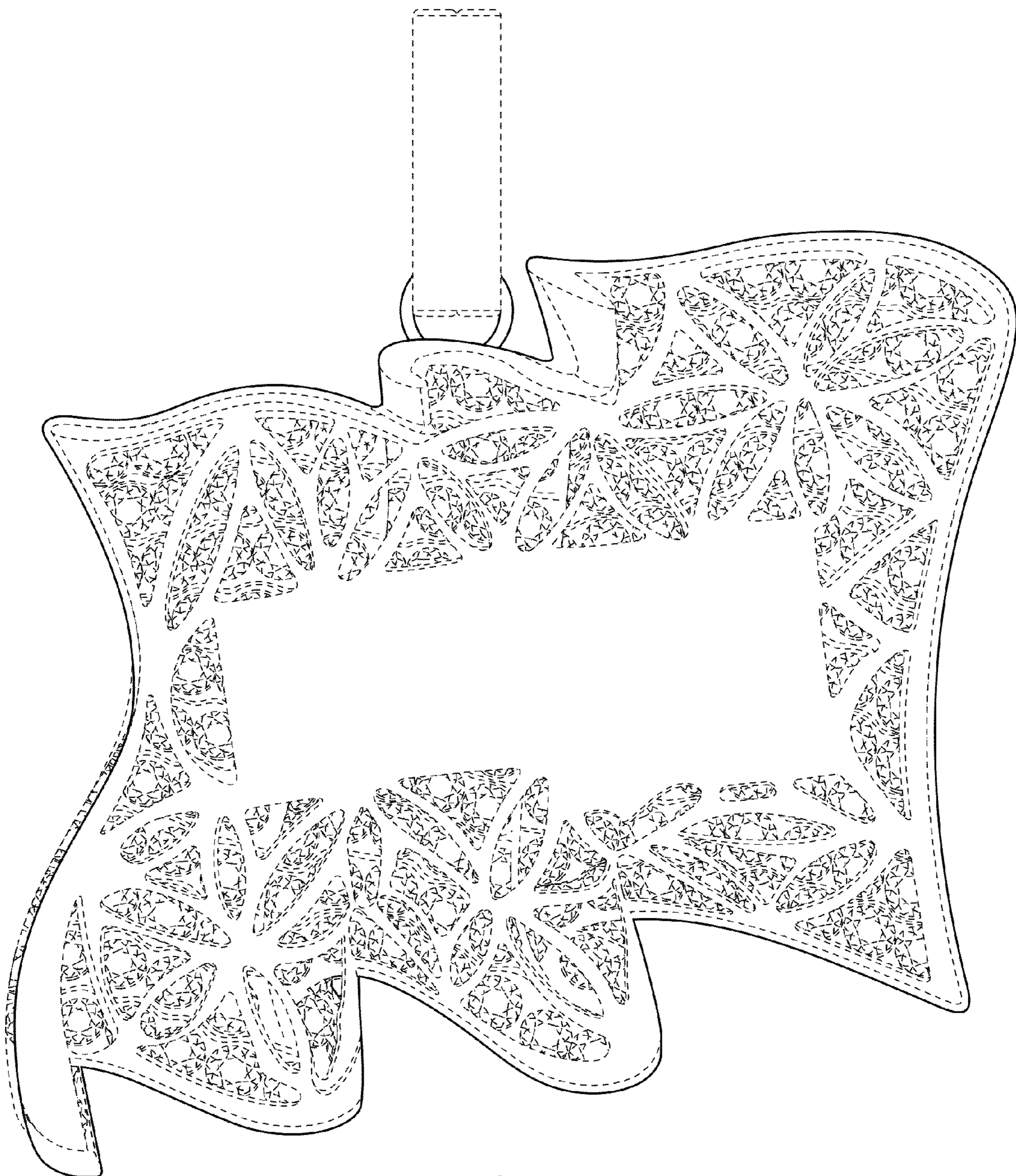
