FIG. 1 is a perspective view of flip flop towel clip showing my new design;

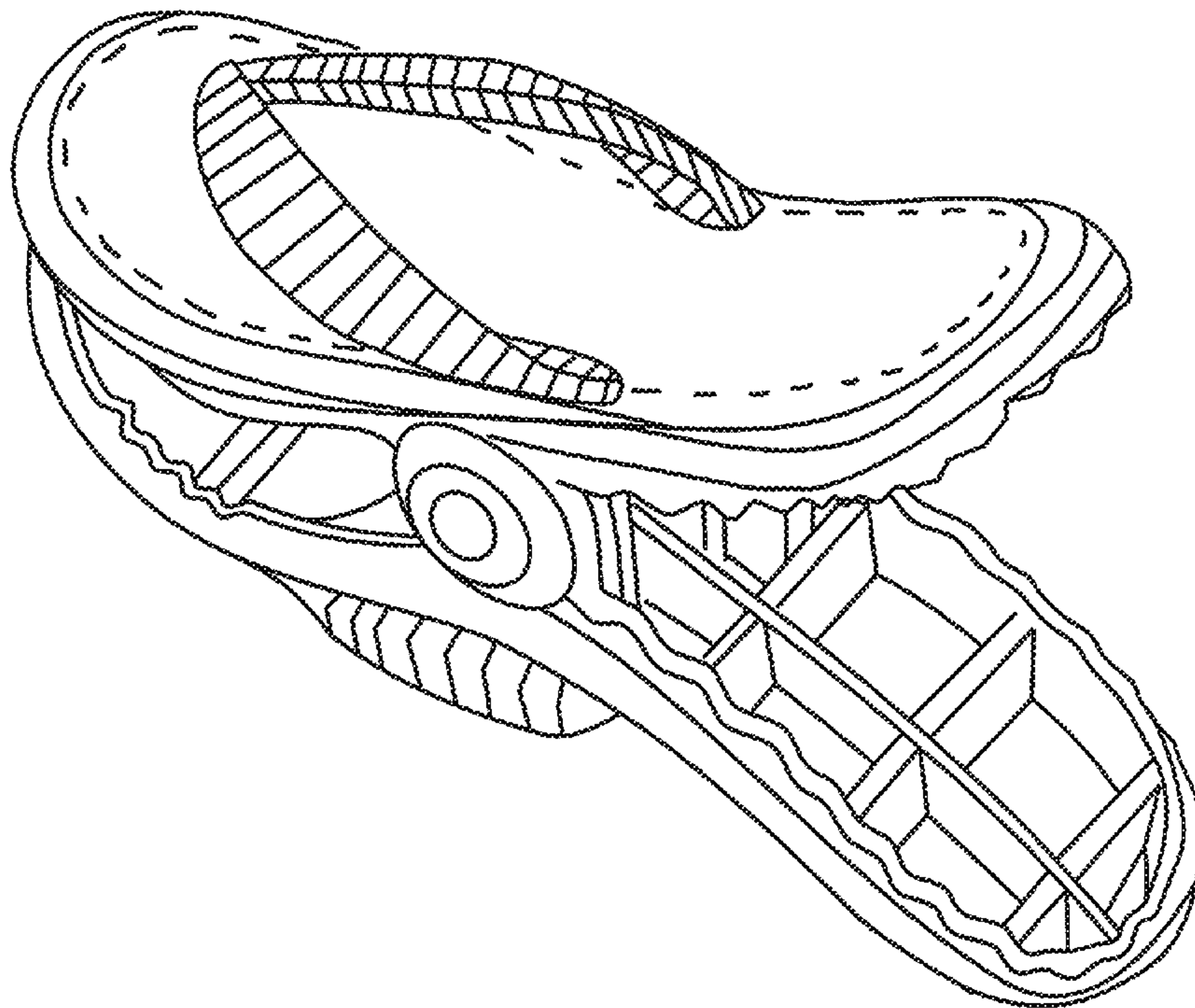
FIG. 2 is a front view thereof;

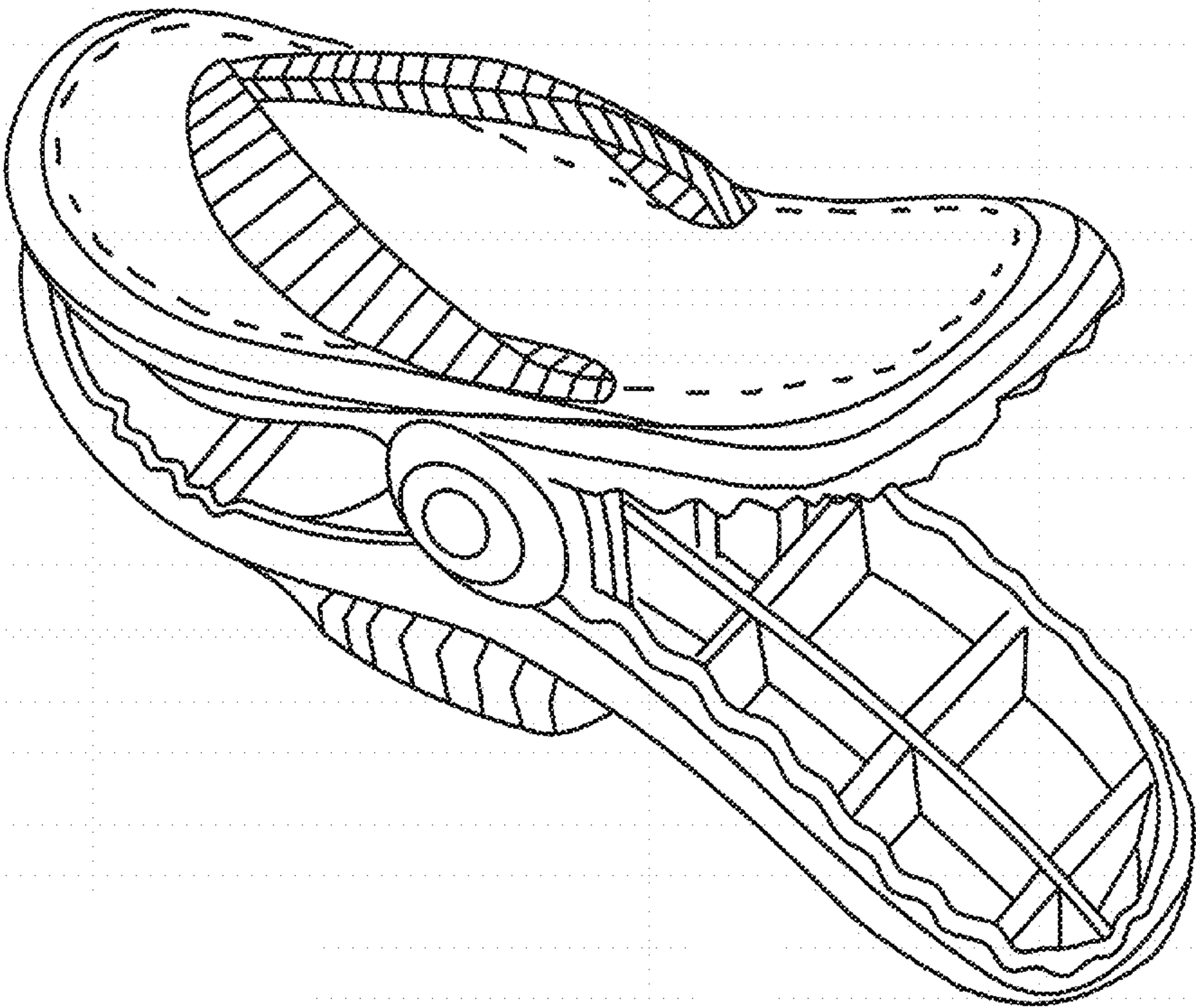

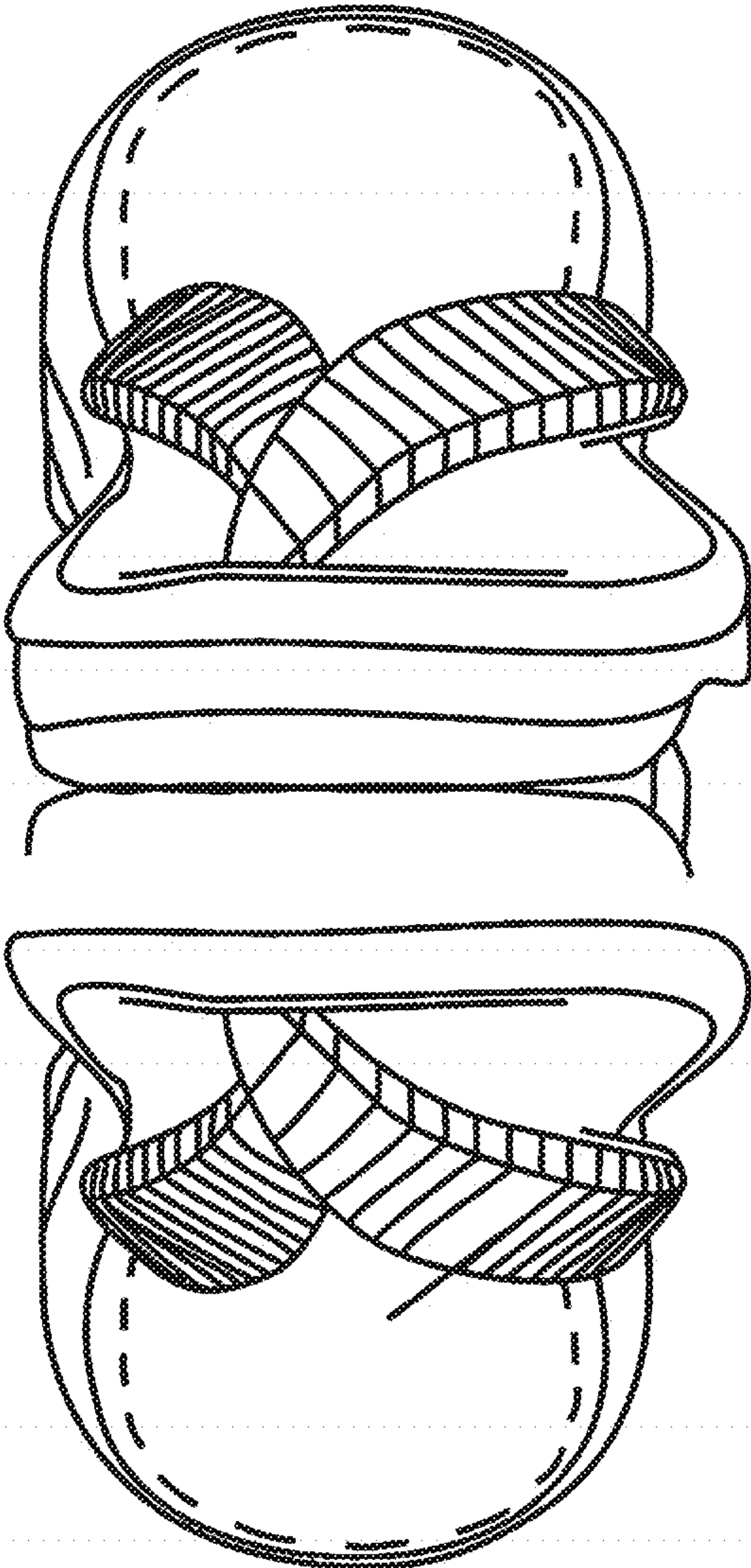

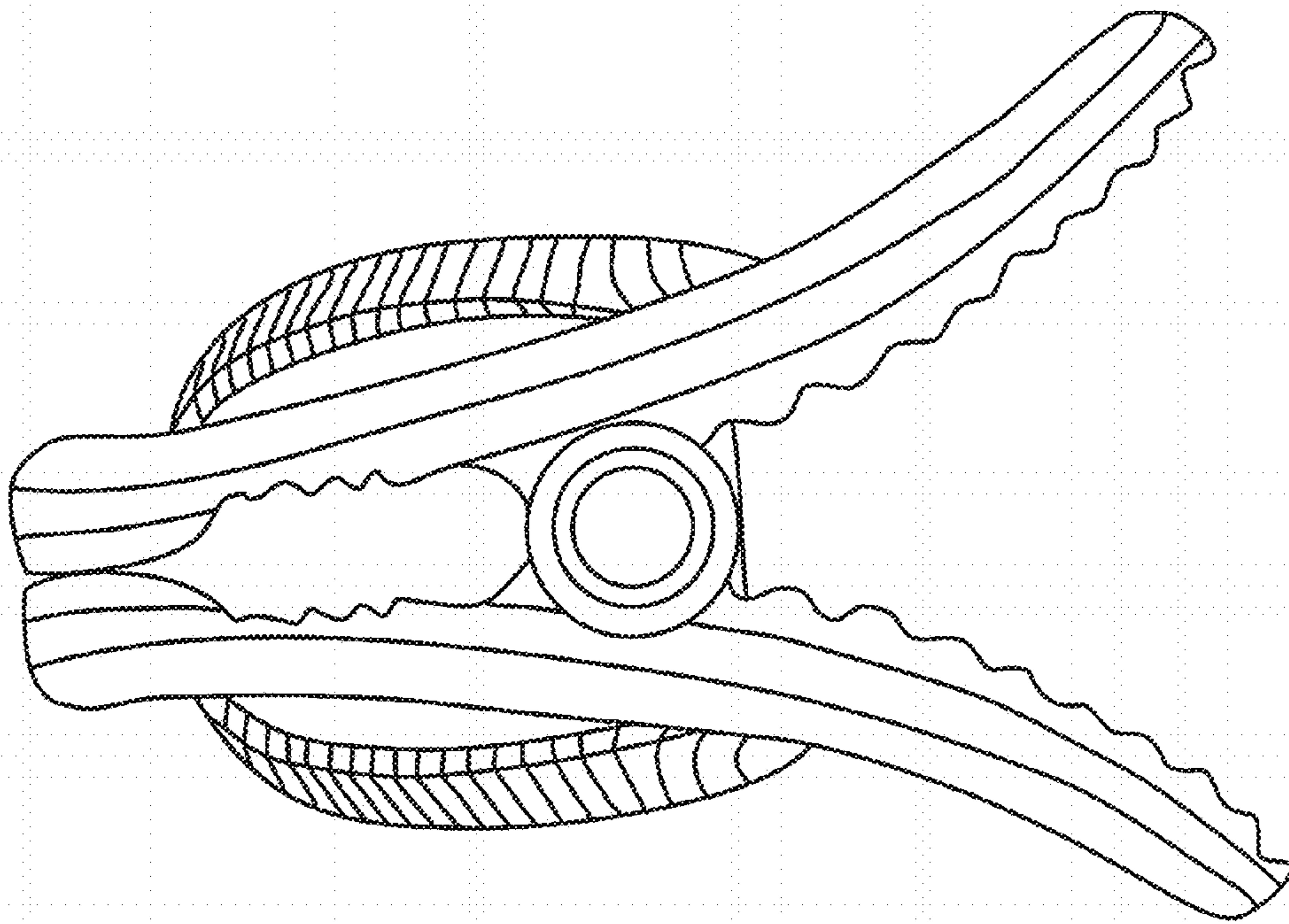

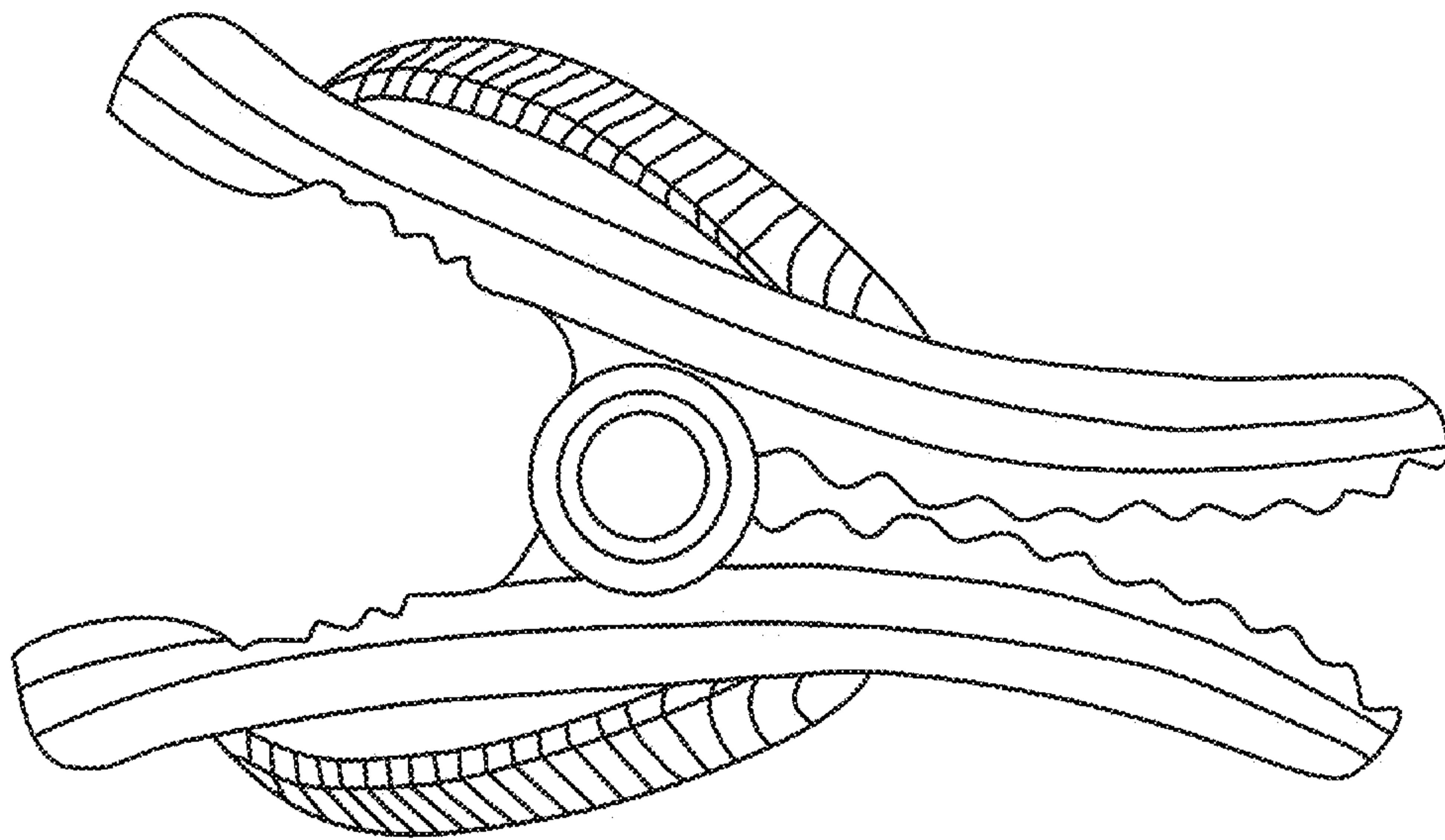

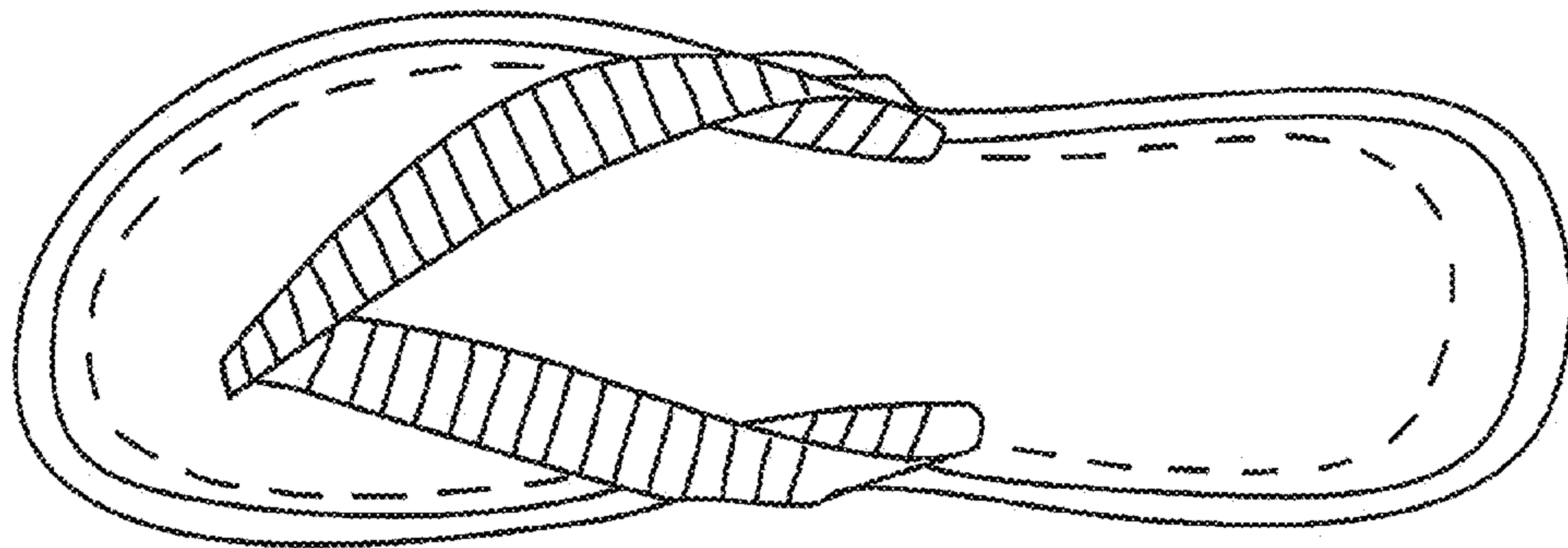
