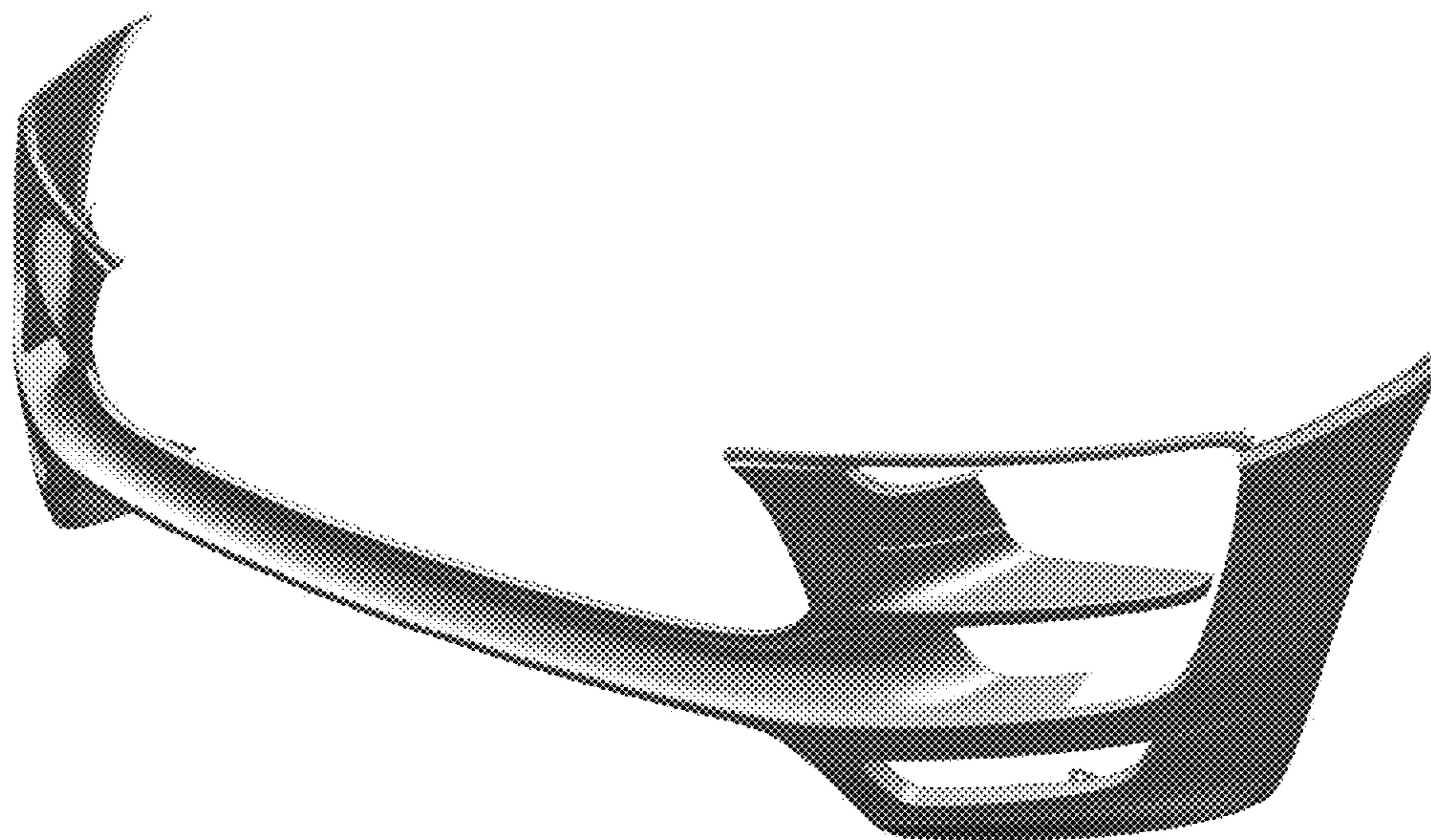
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a bumper for a motor vehicle;

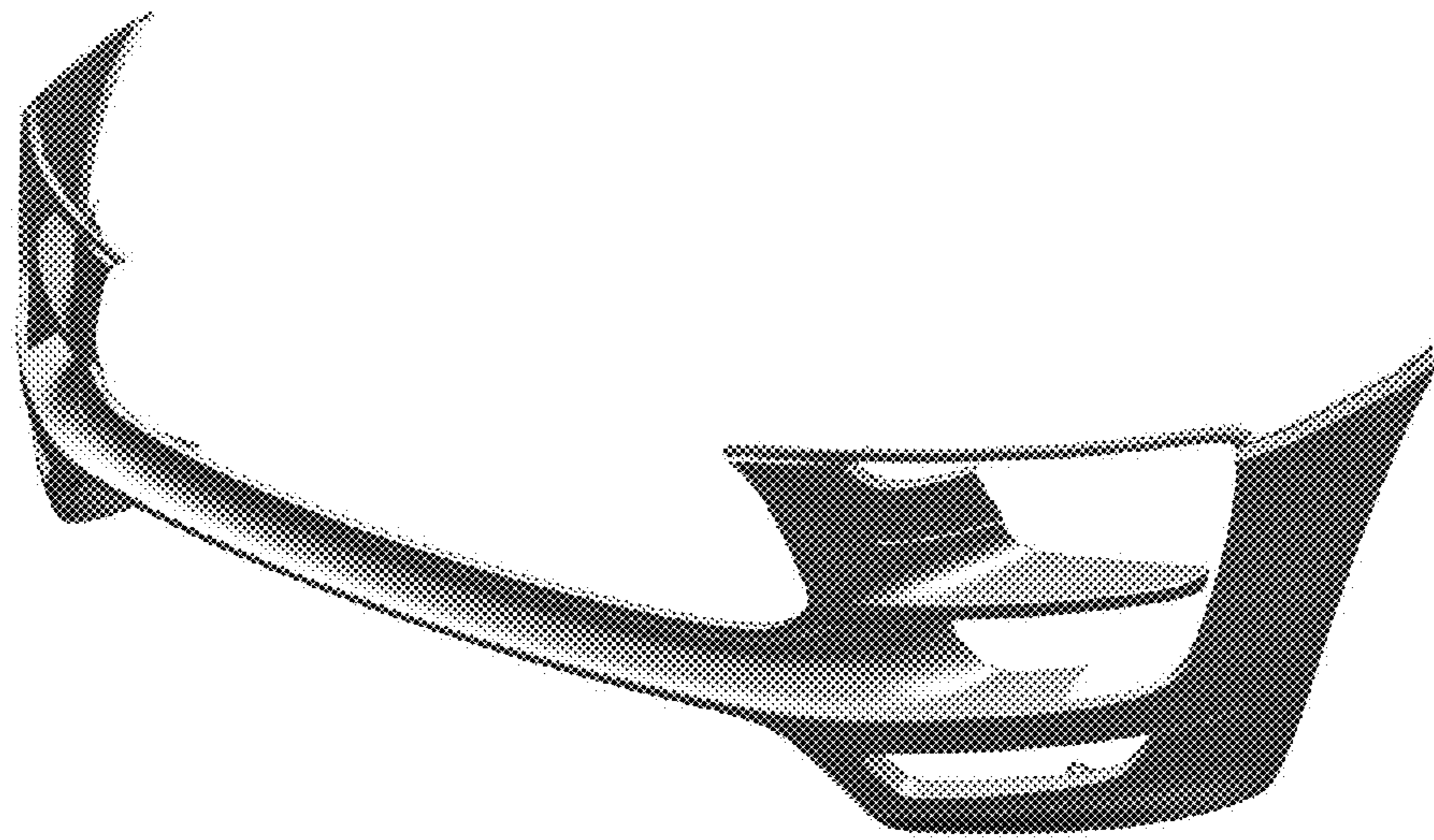

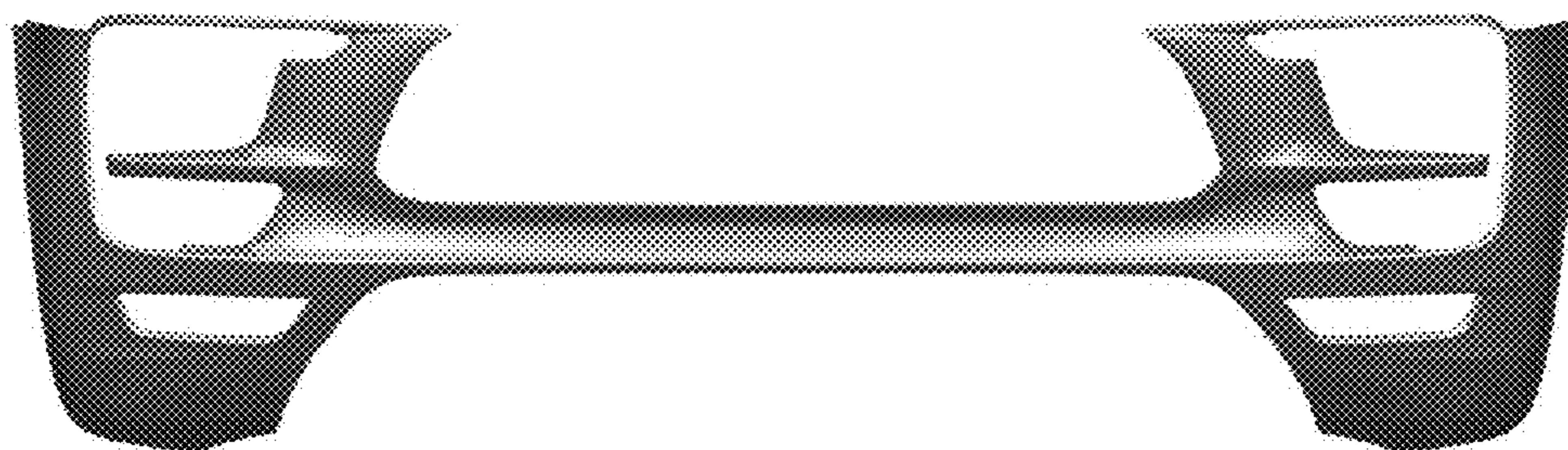

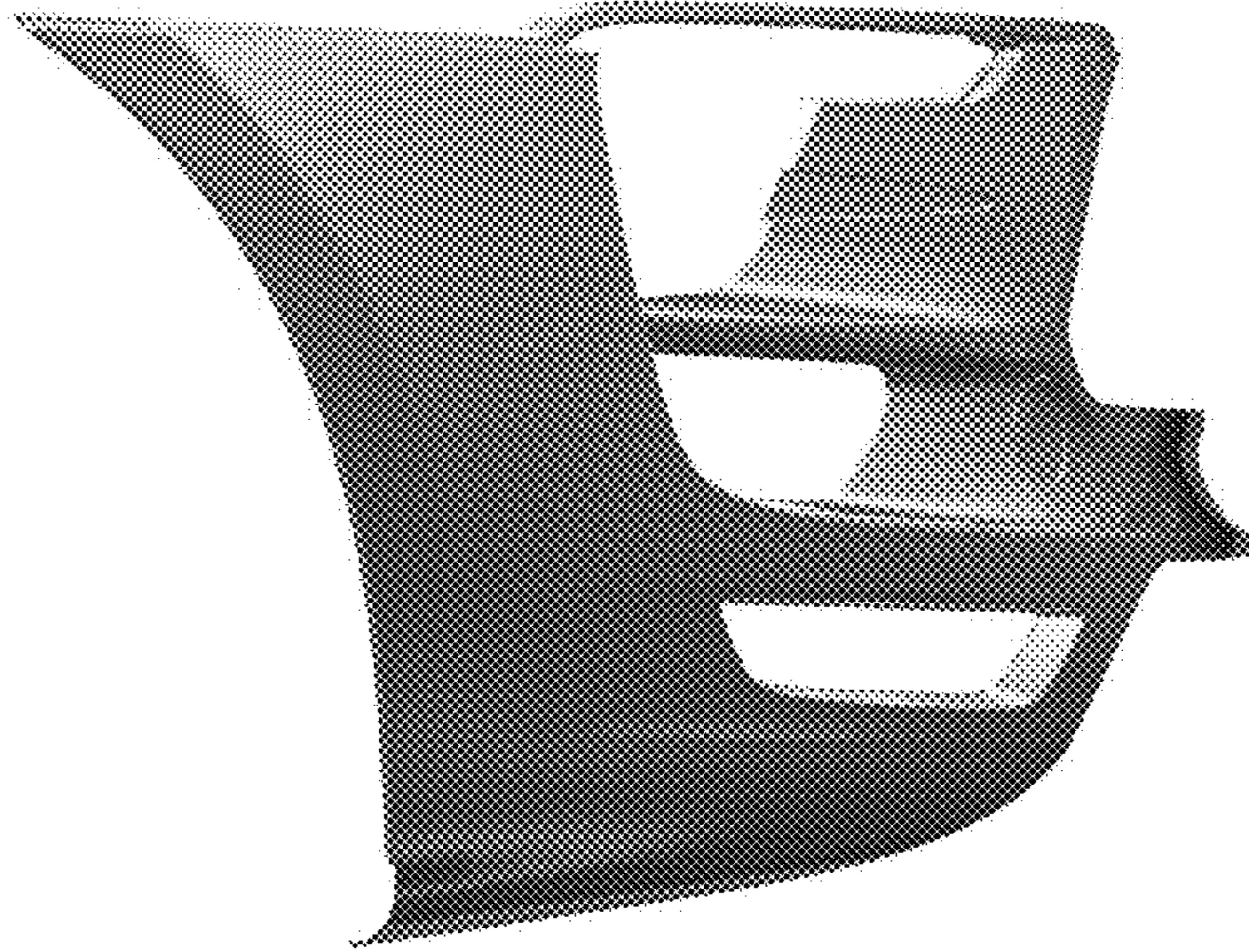

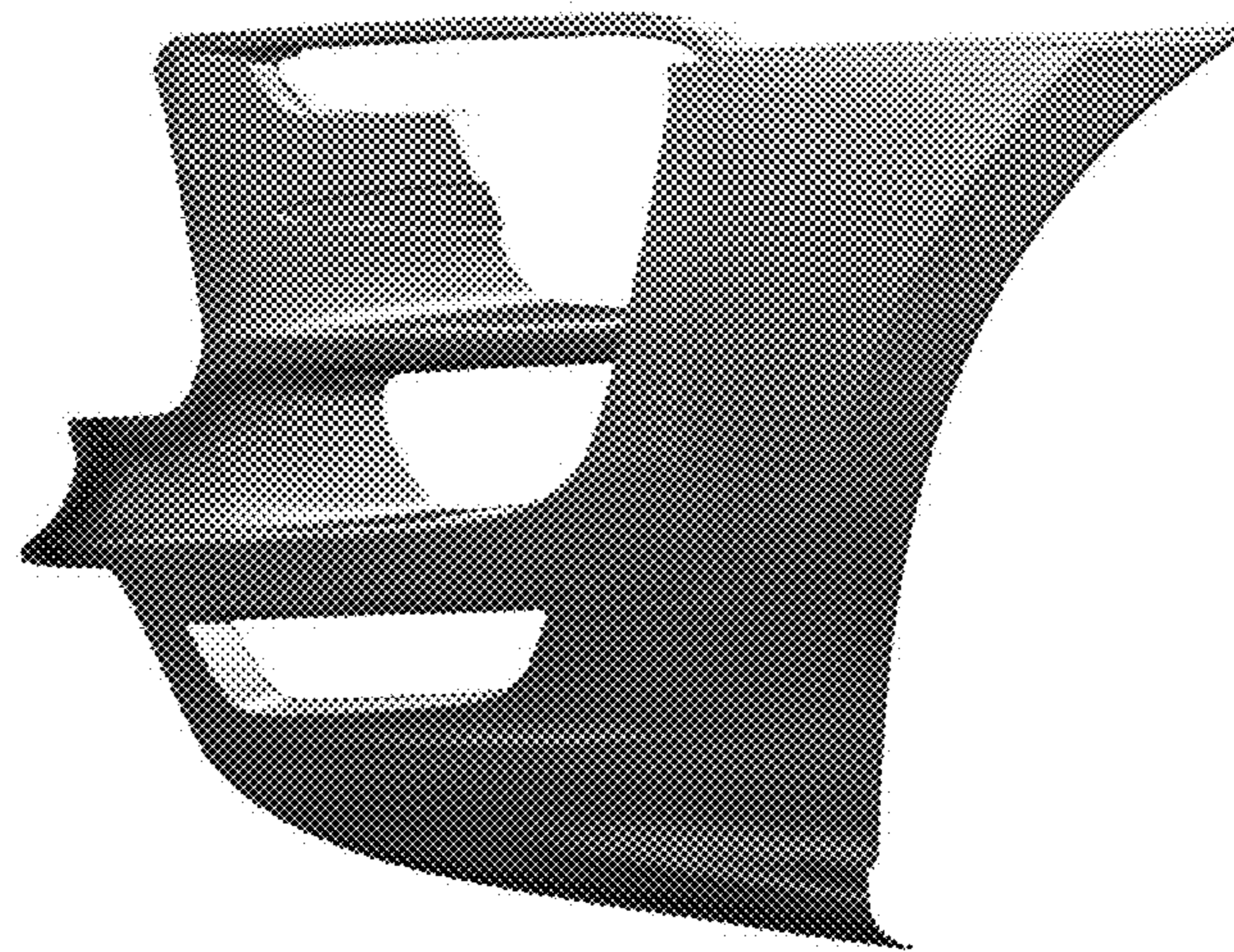

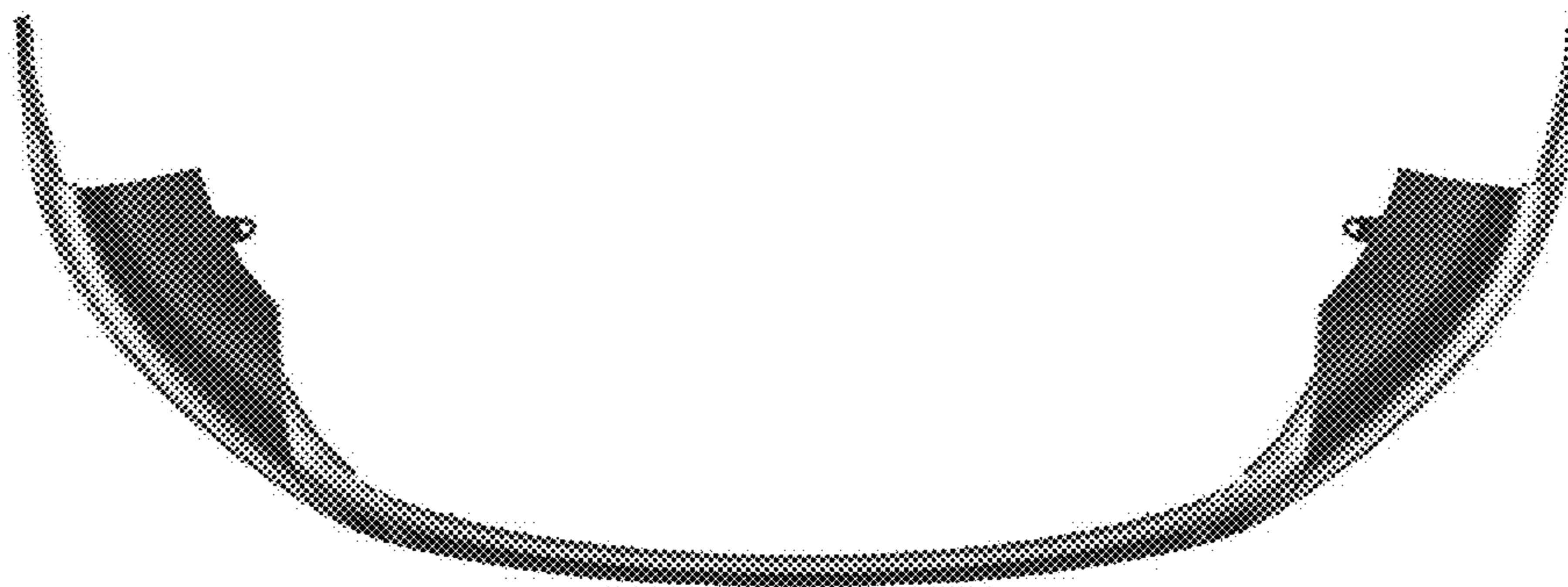
