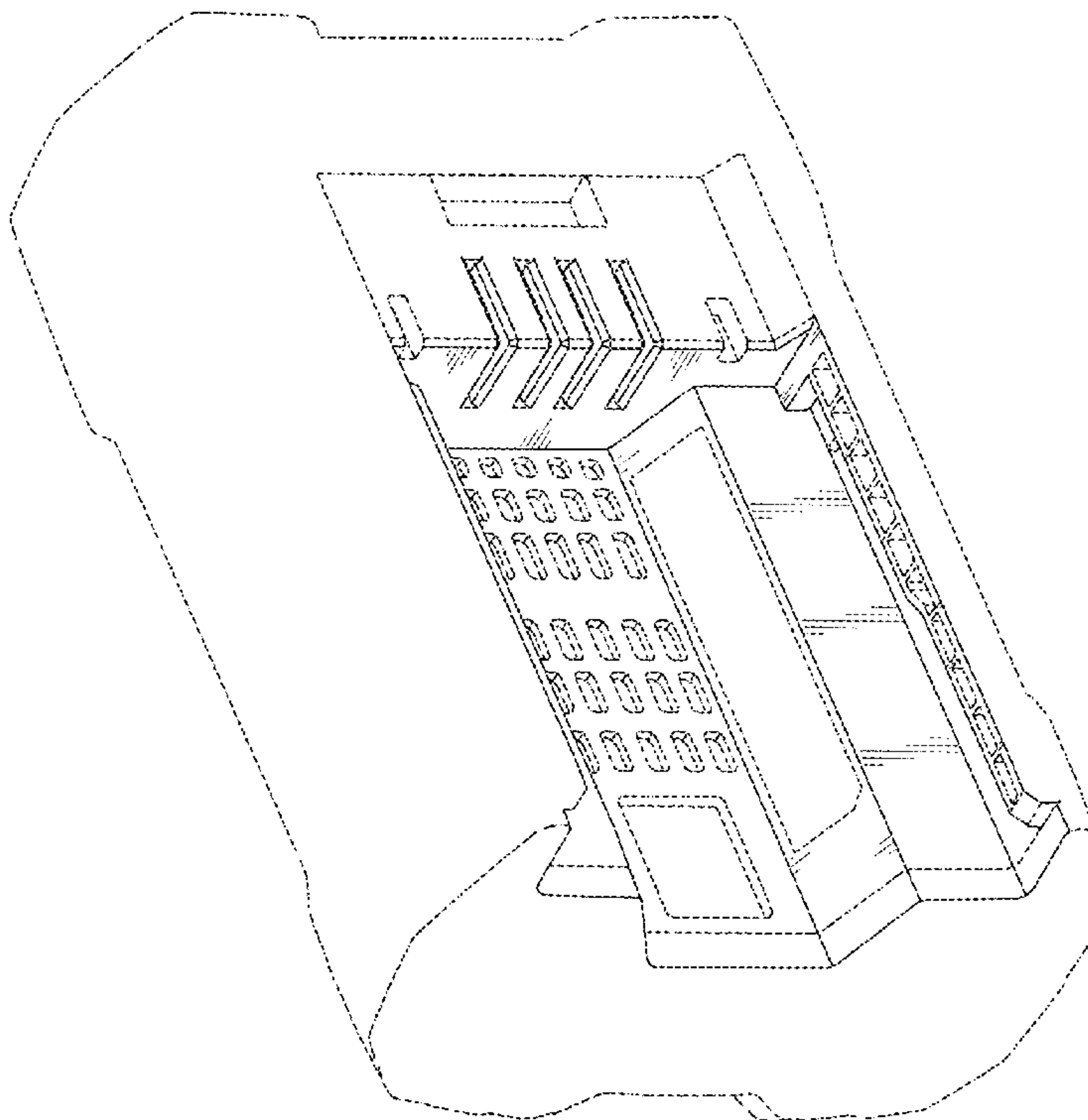
(57) **CLAIM**

What is claimed is the ornamental design for a battery pack, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a battery pack showing the new design;  
FIG. 2 is a front elevational view thereof; and,

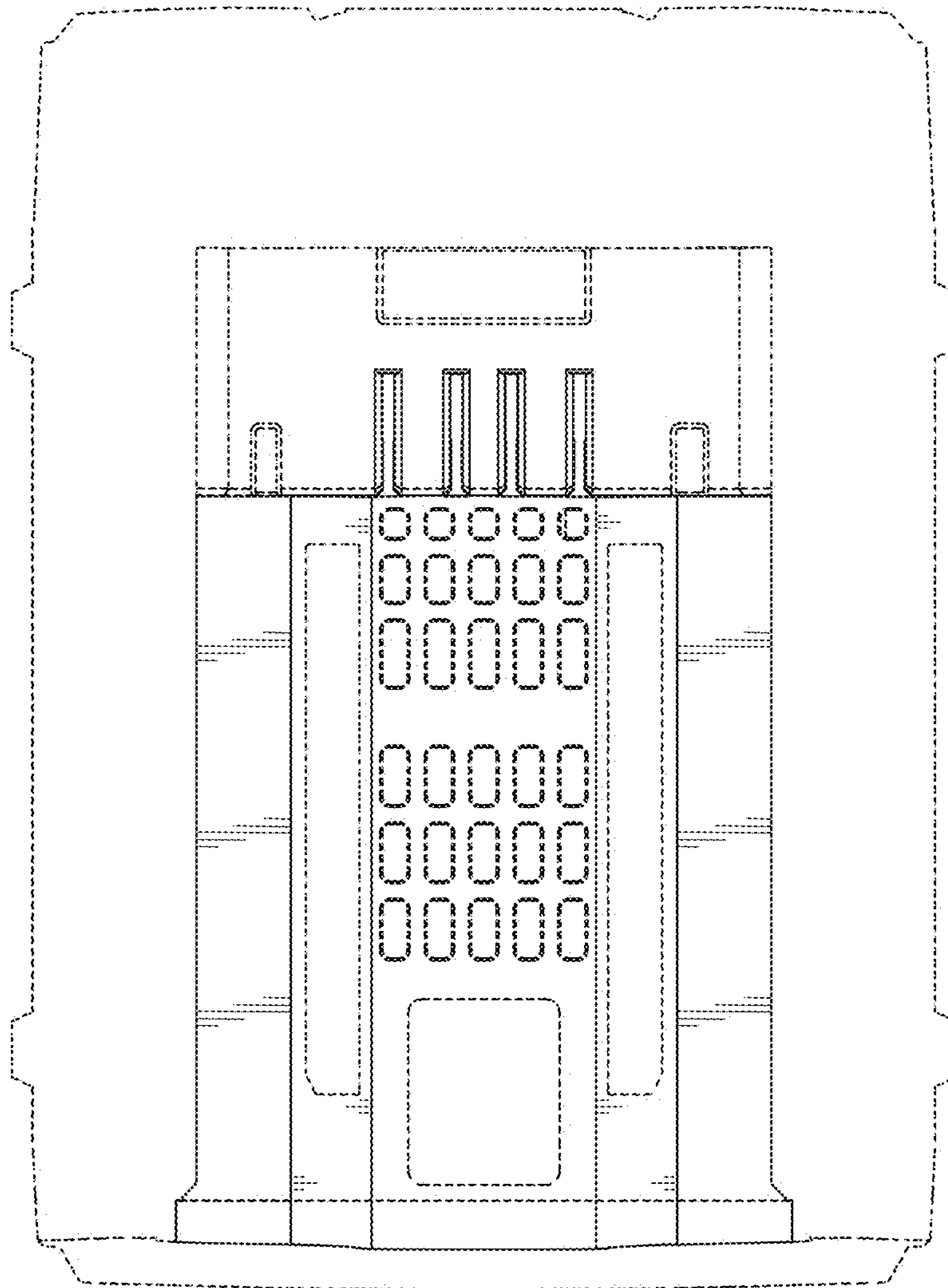

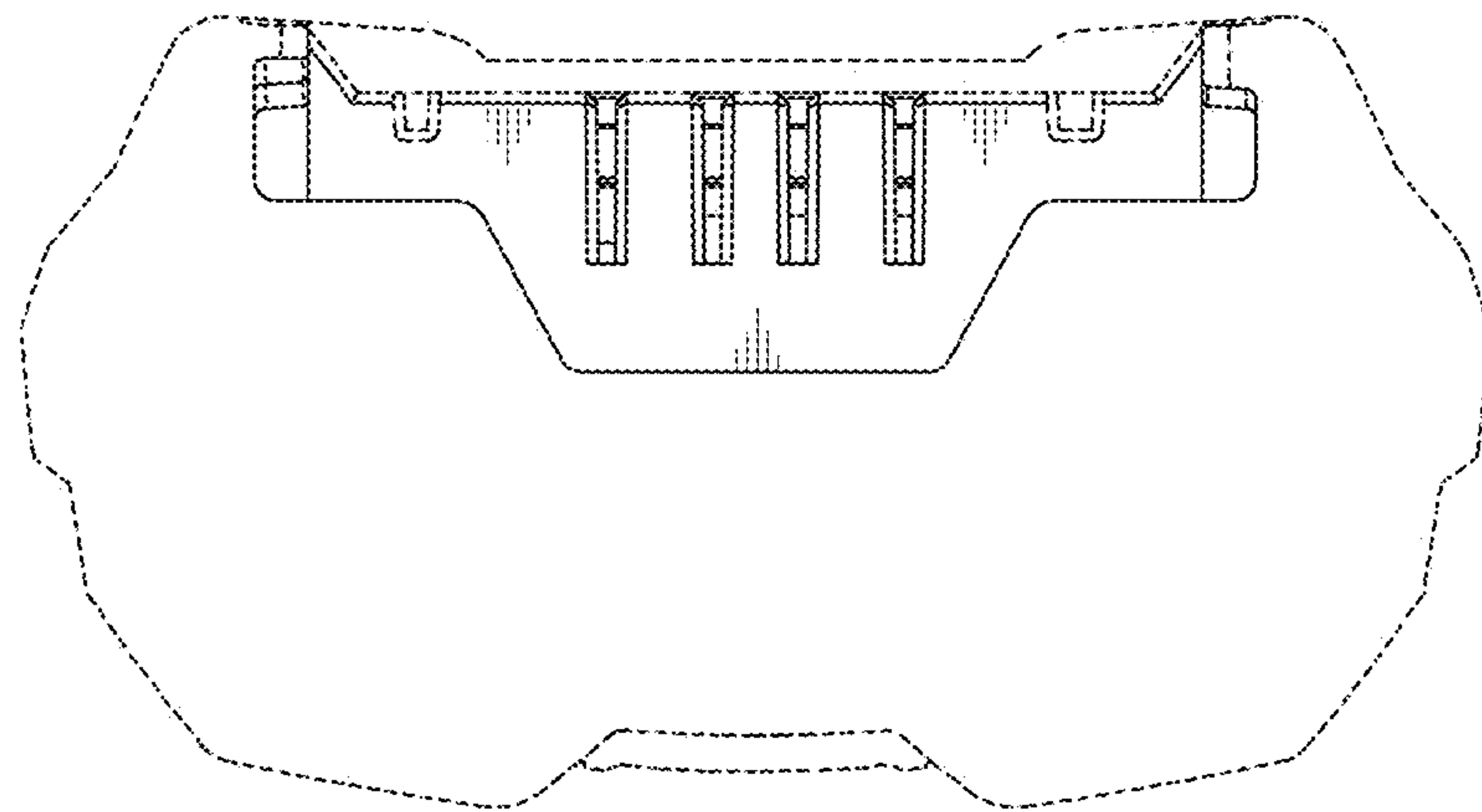

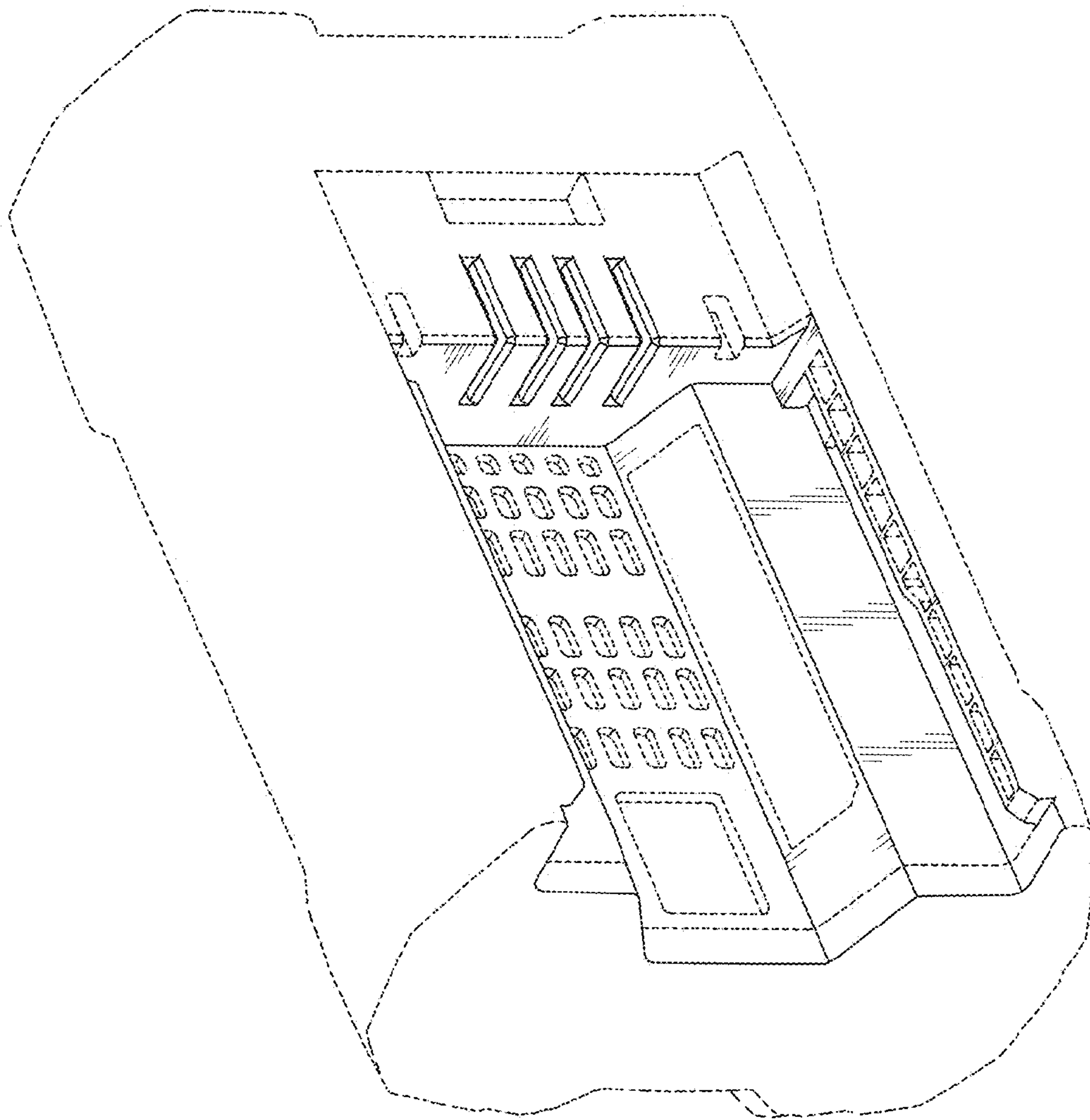
