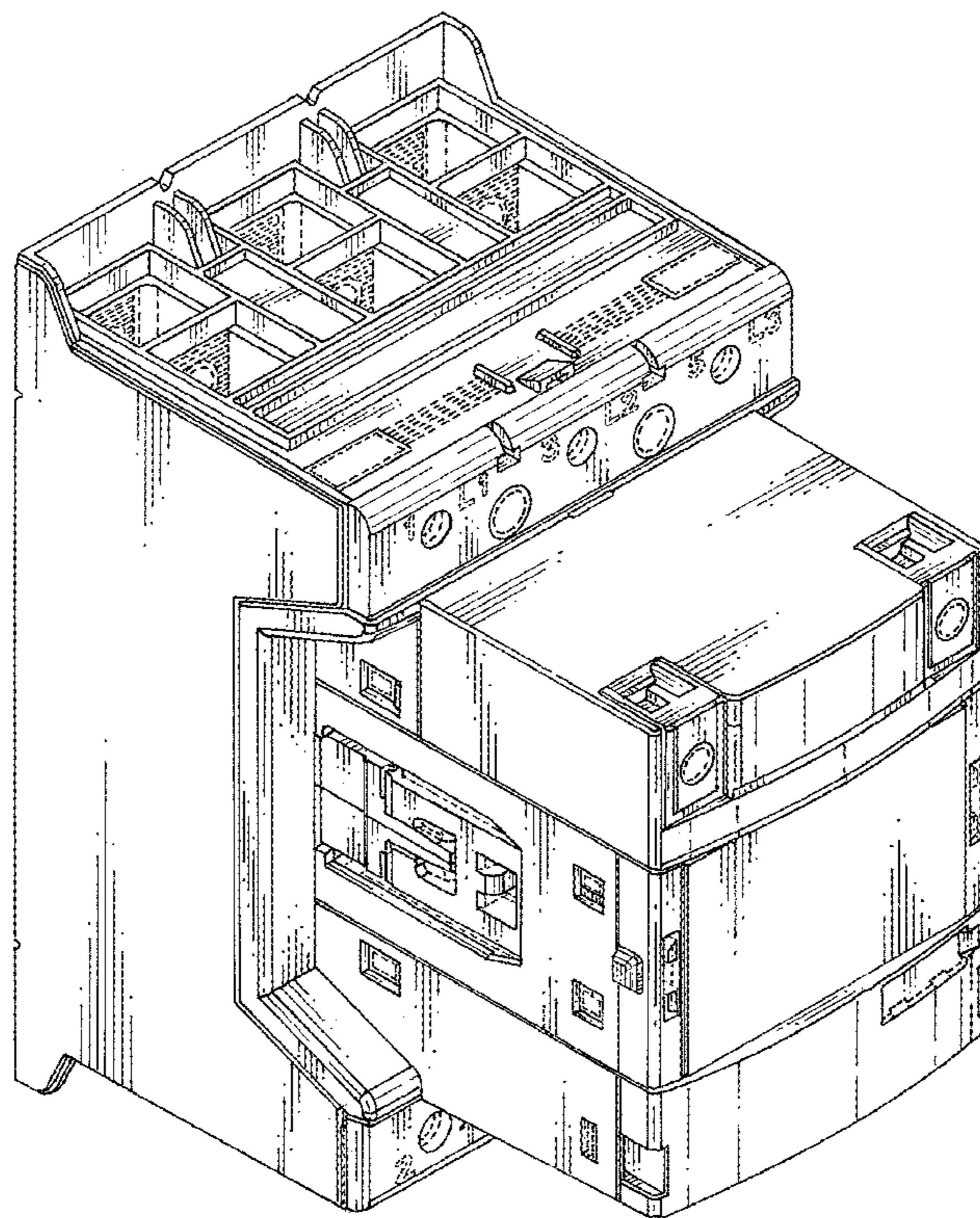
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front right side isometric view of a switching device in accordance with the new design;

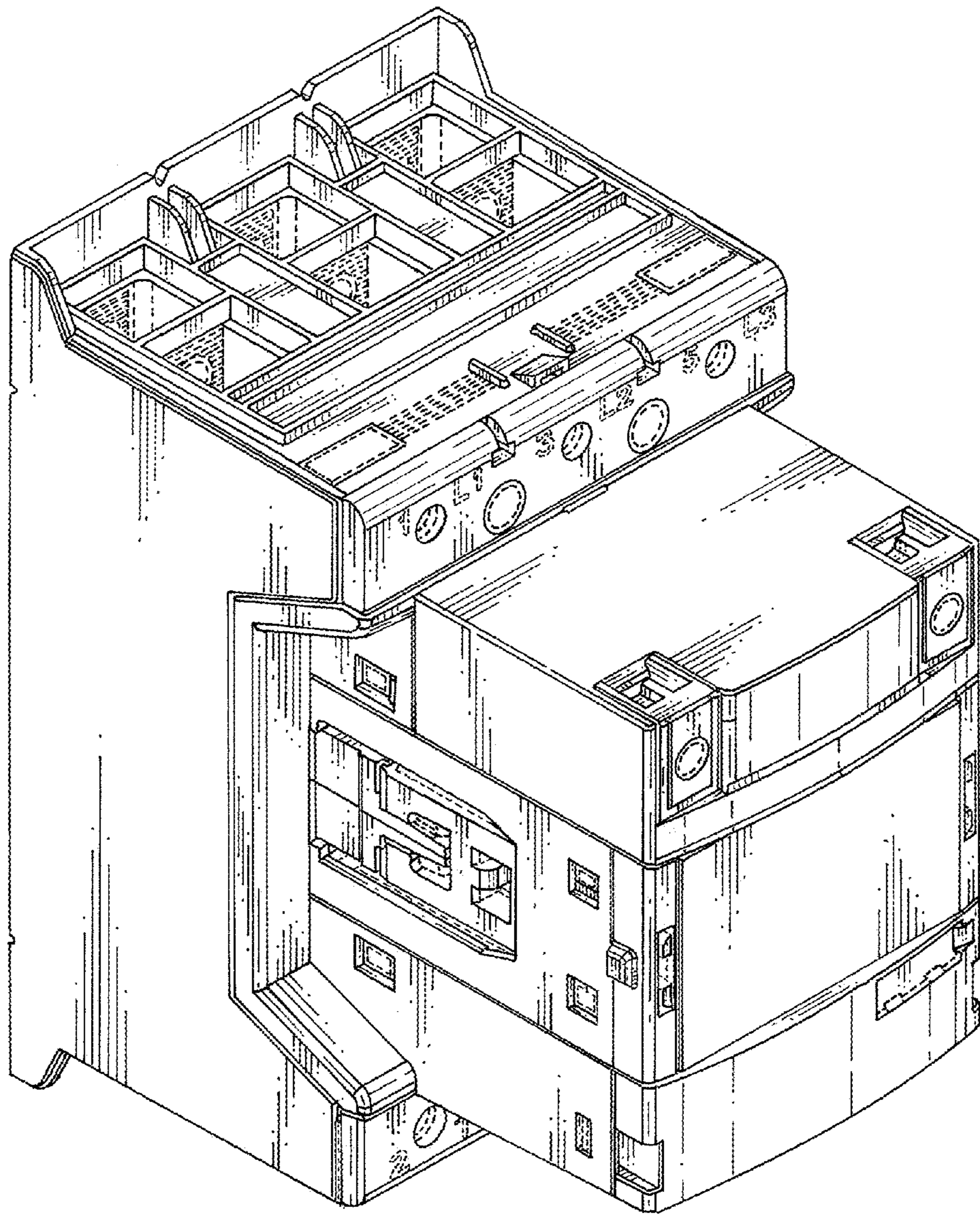

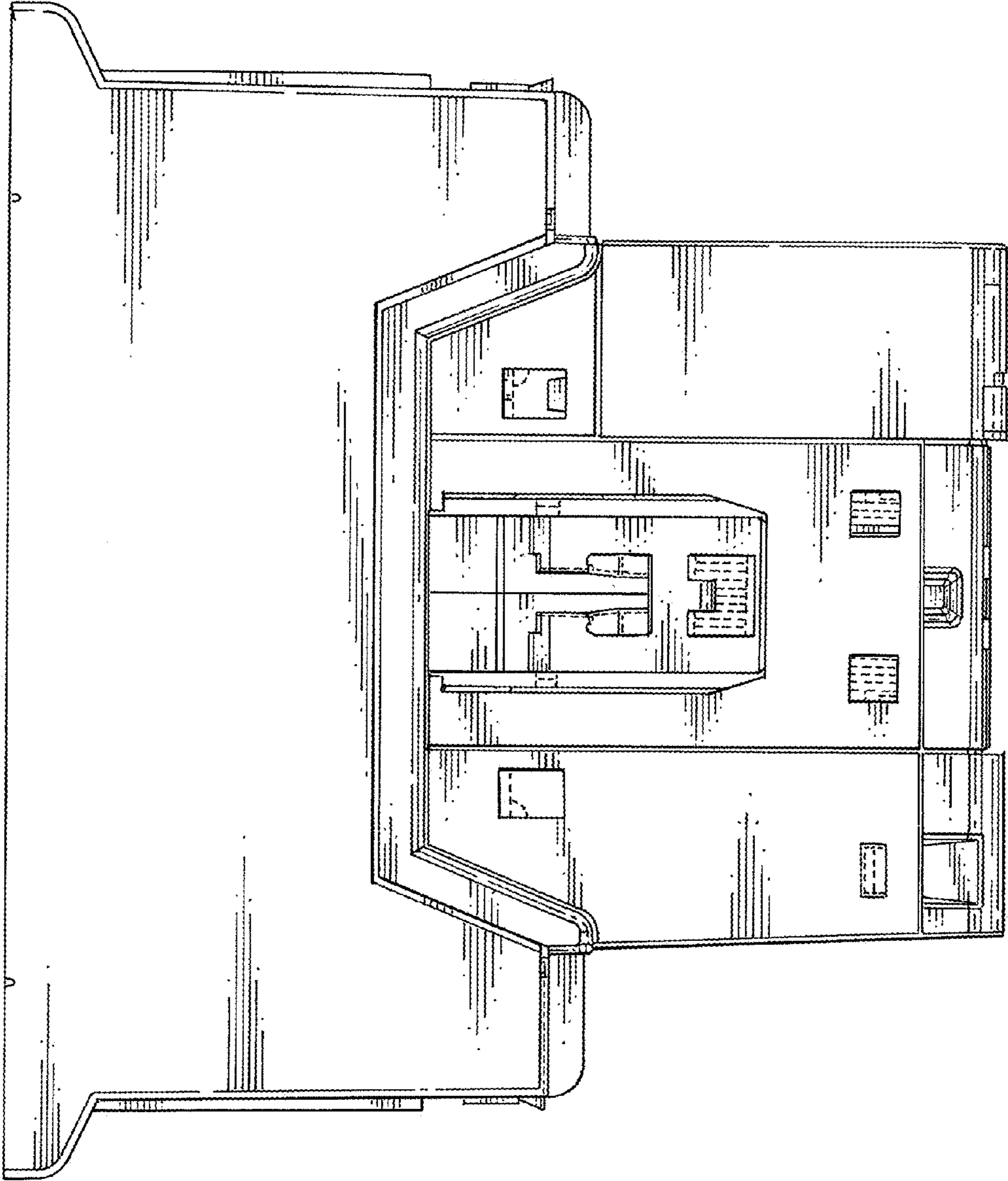

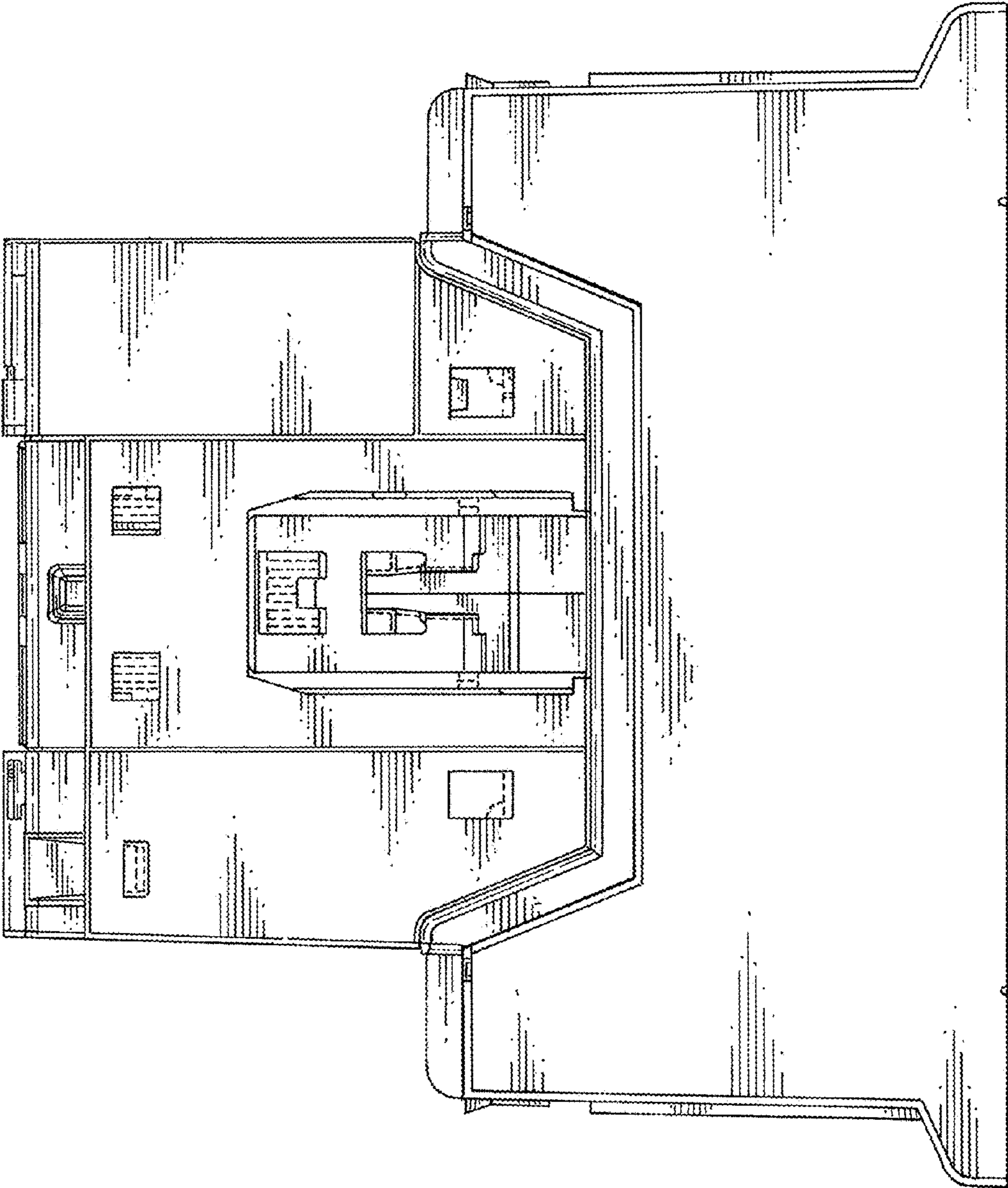

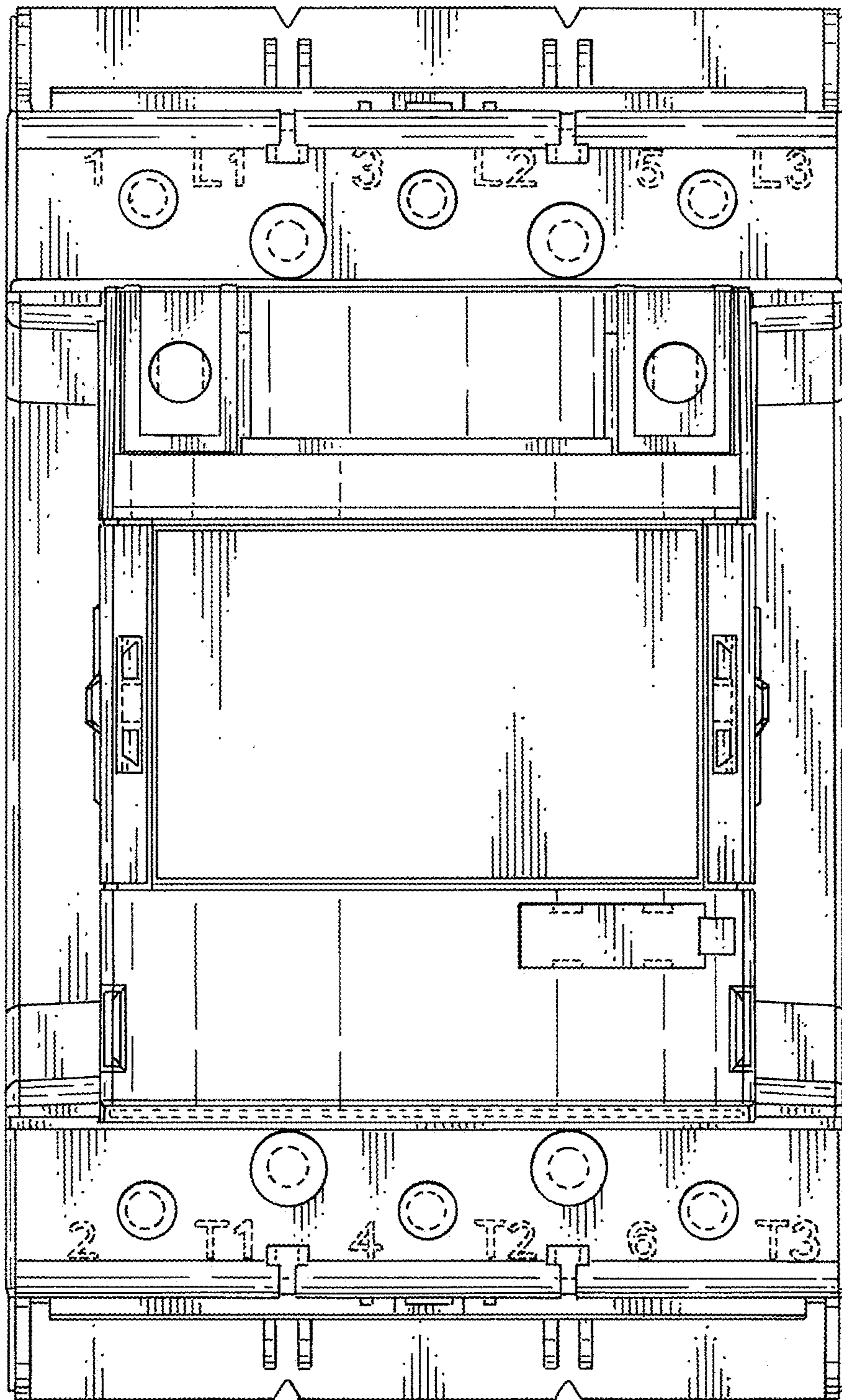

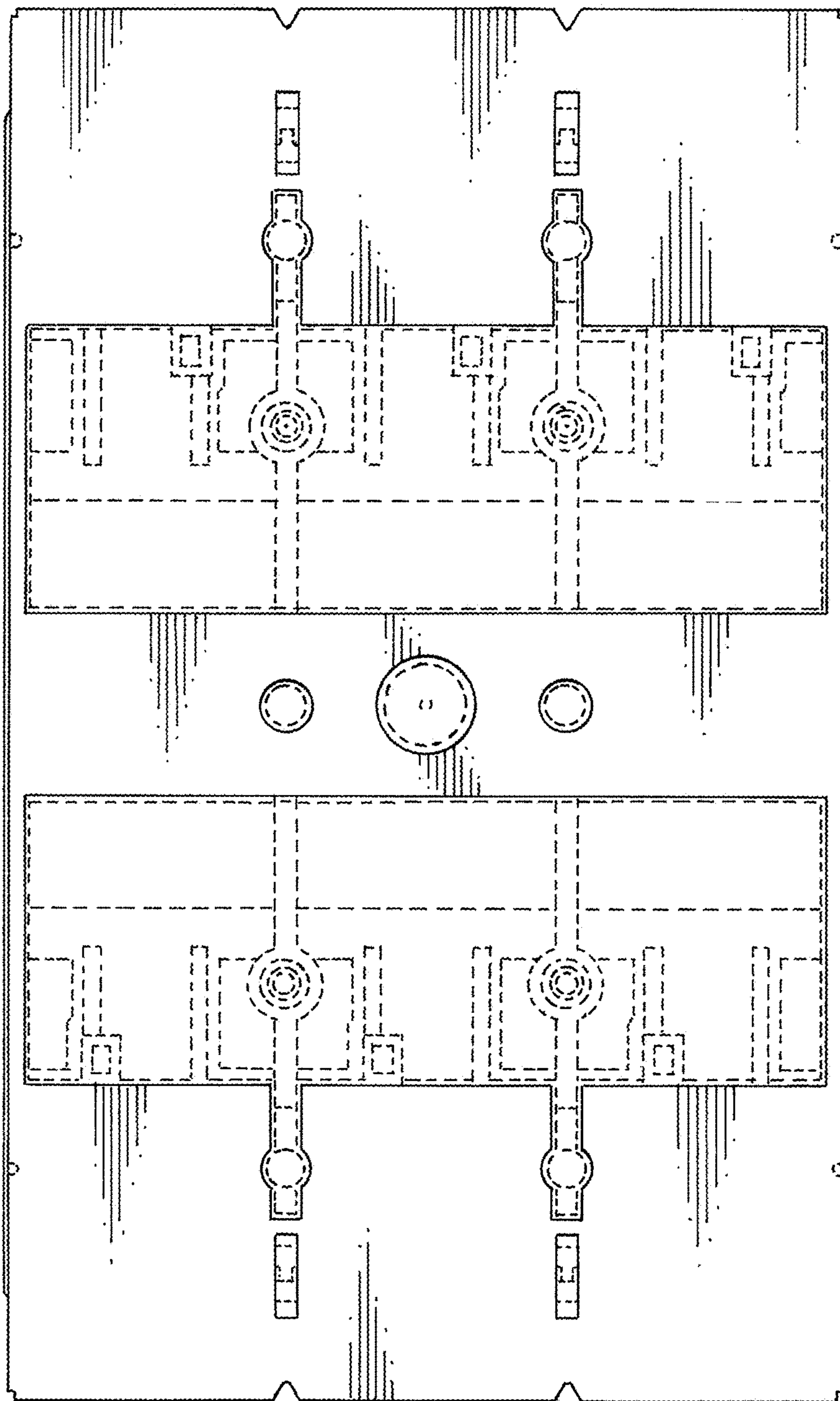

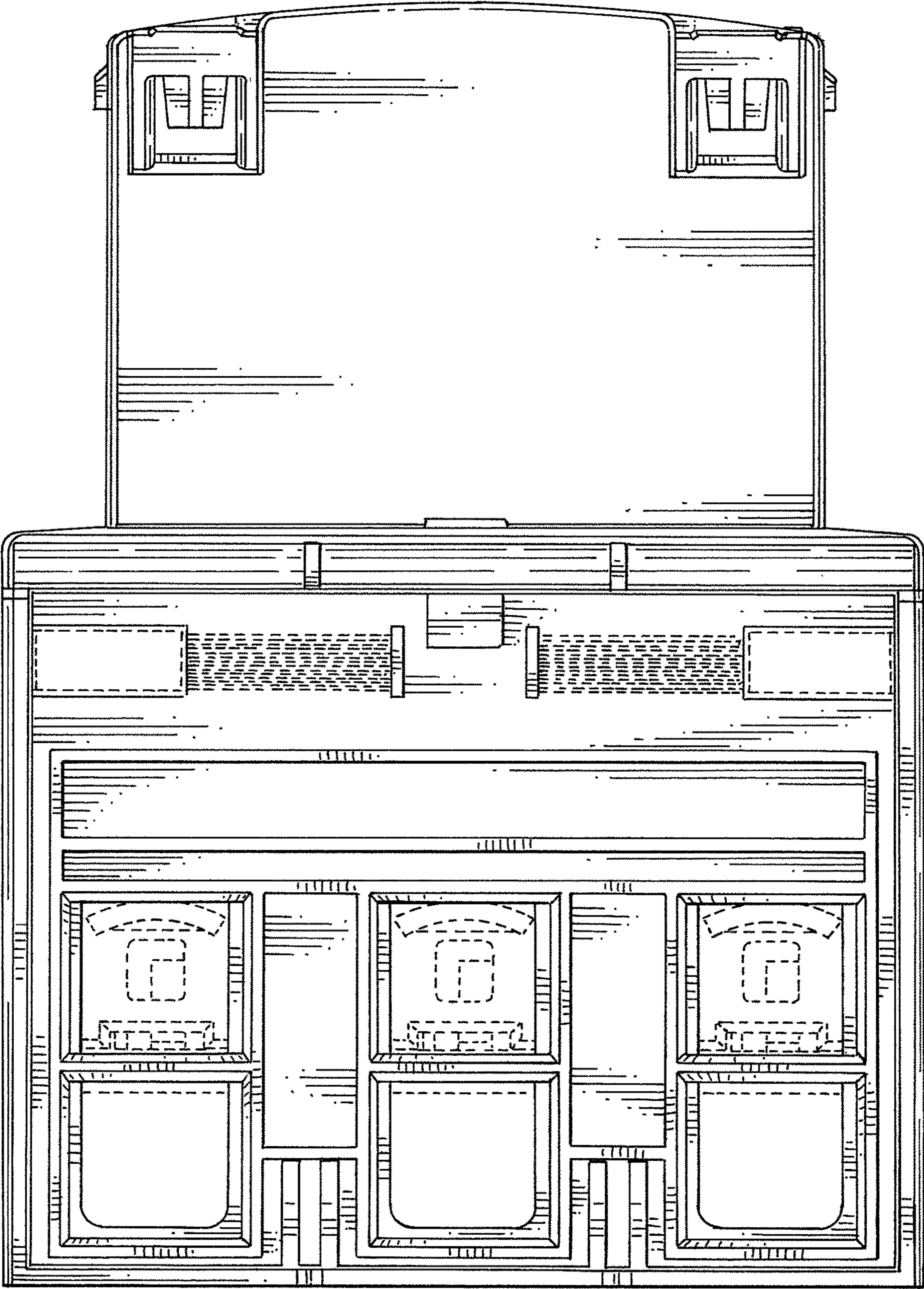

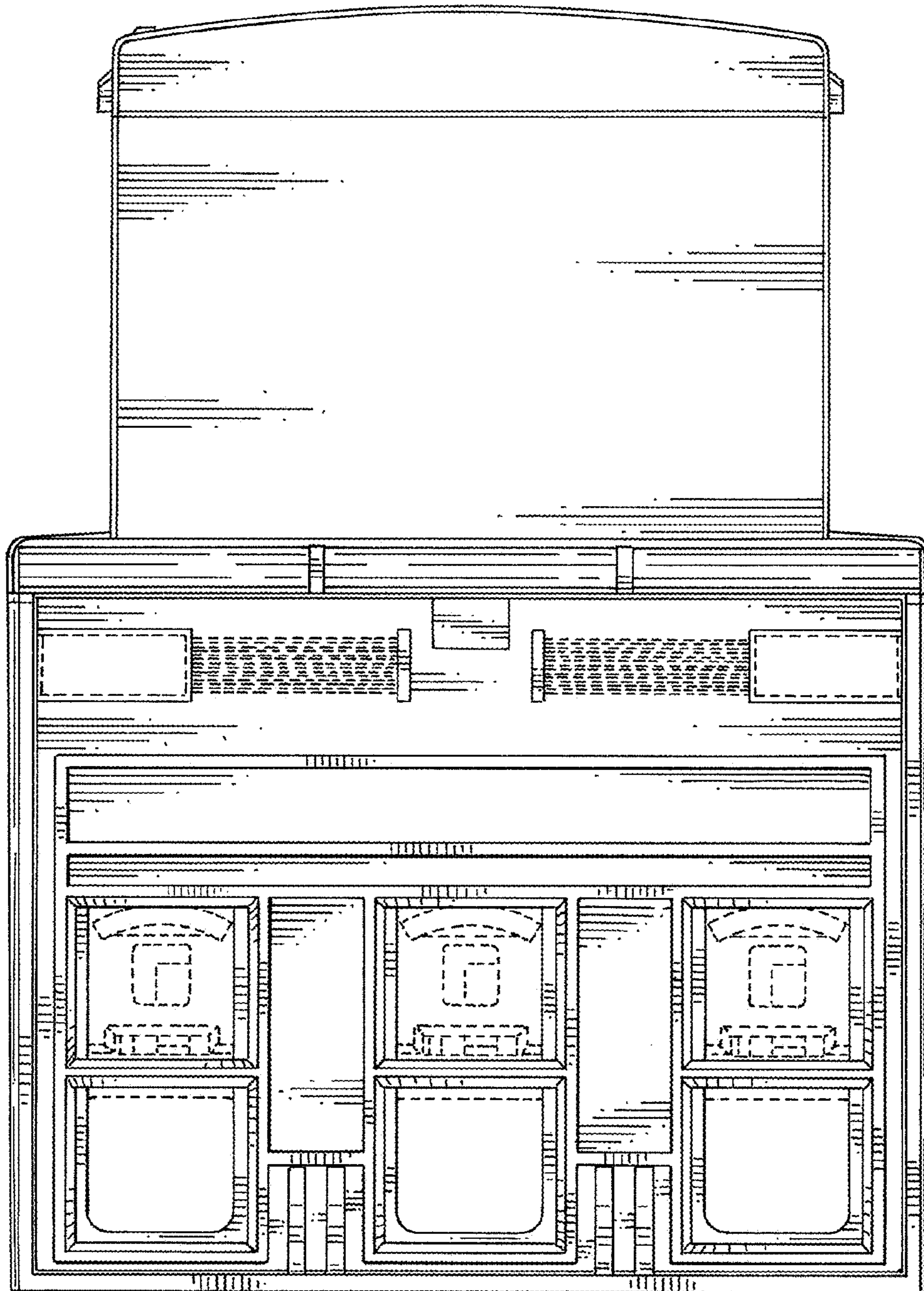
