**DESCRIPTION**

 FIG. 14 is a top plan view thereof.

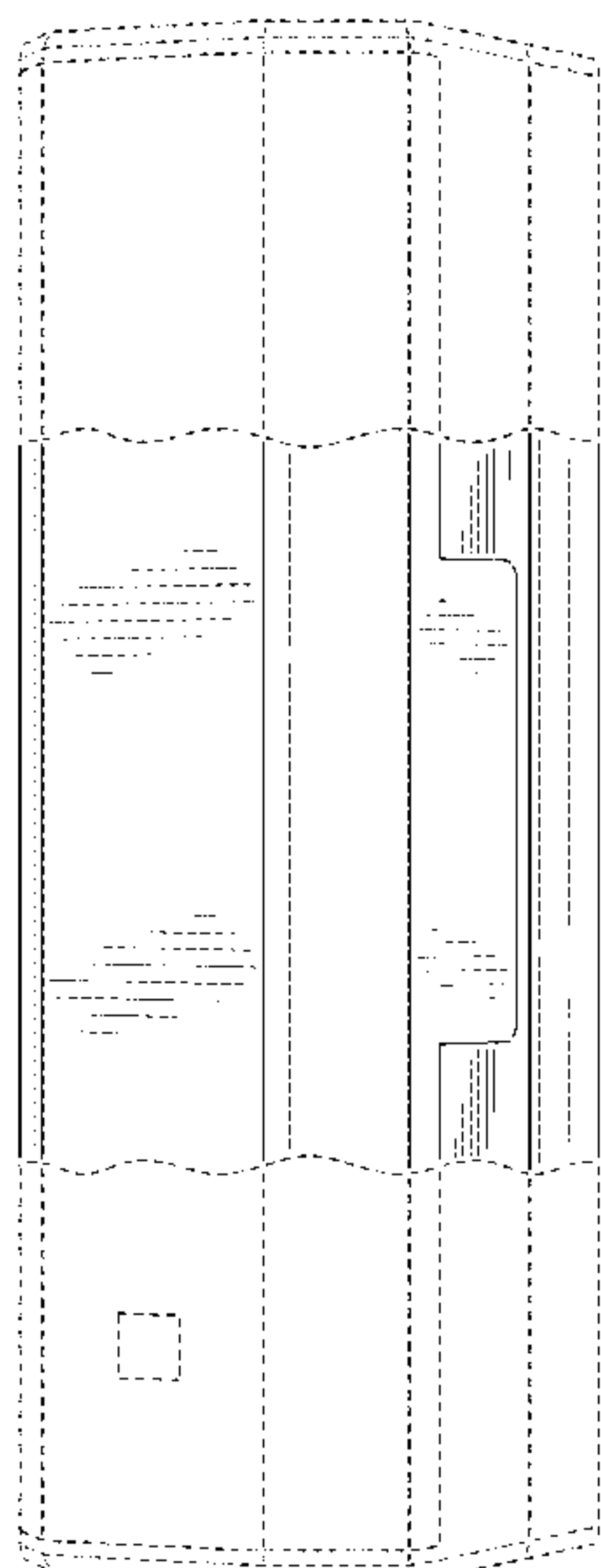

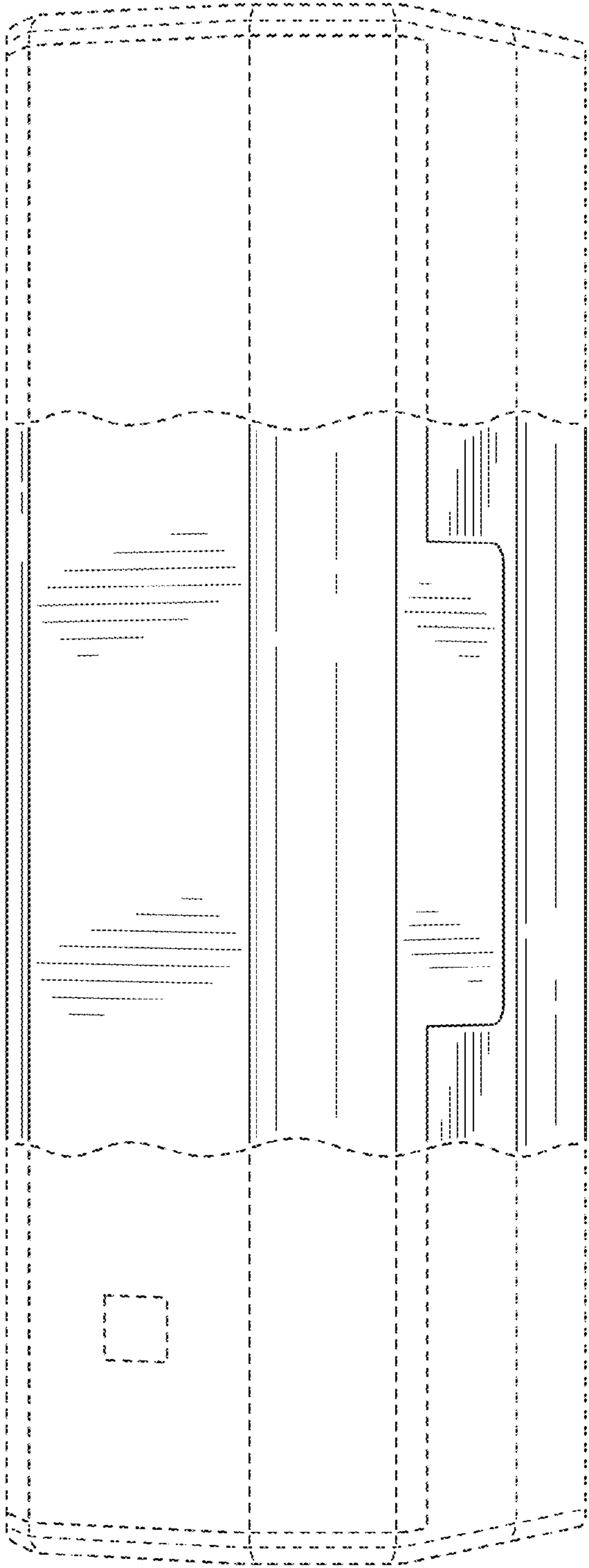

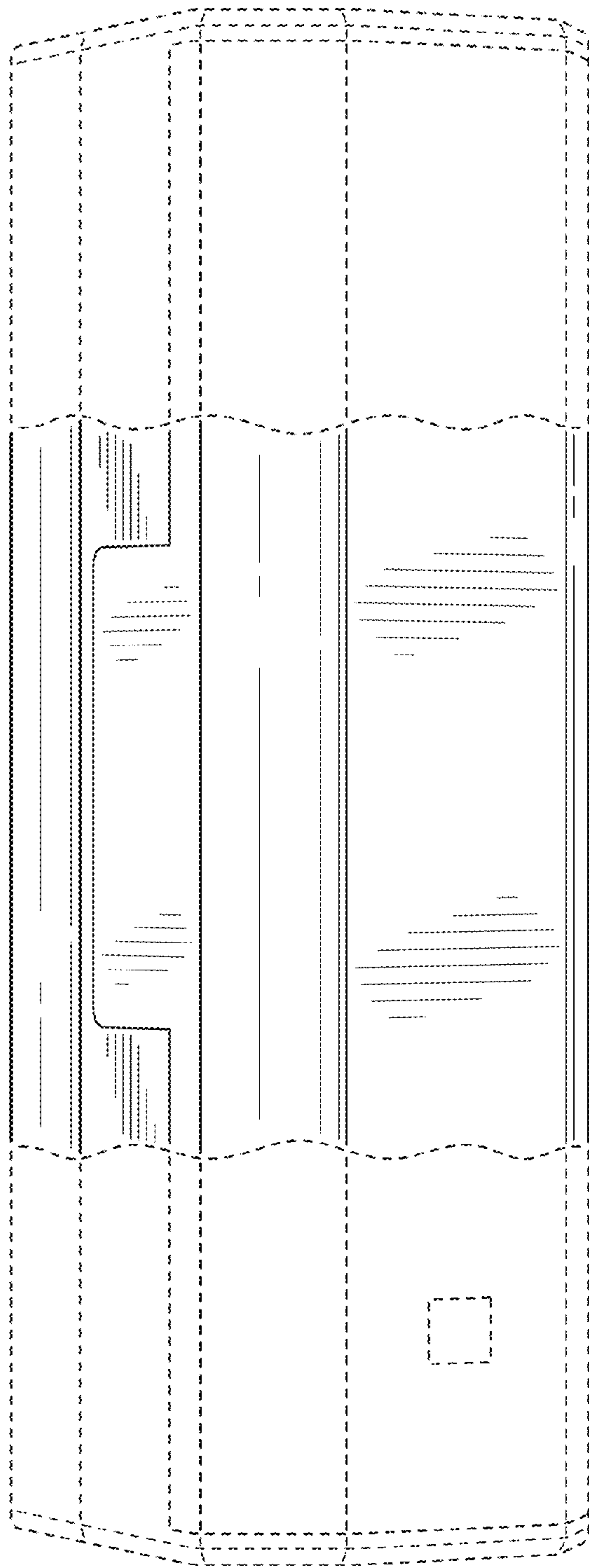

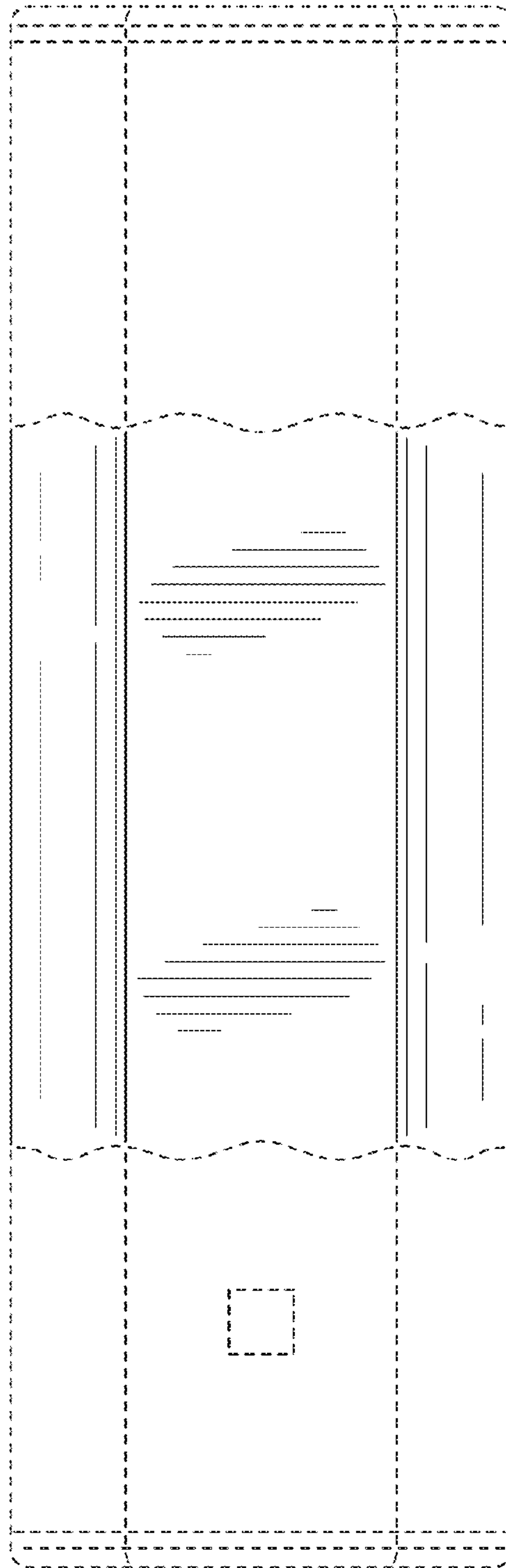

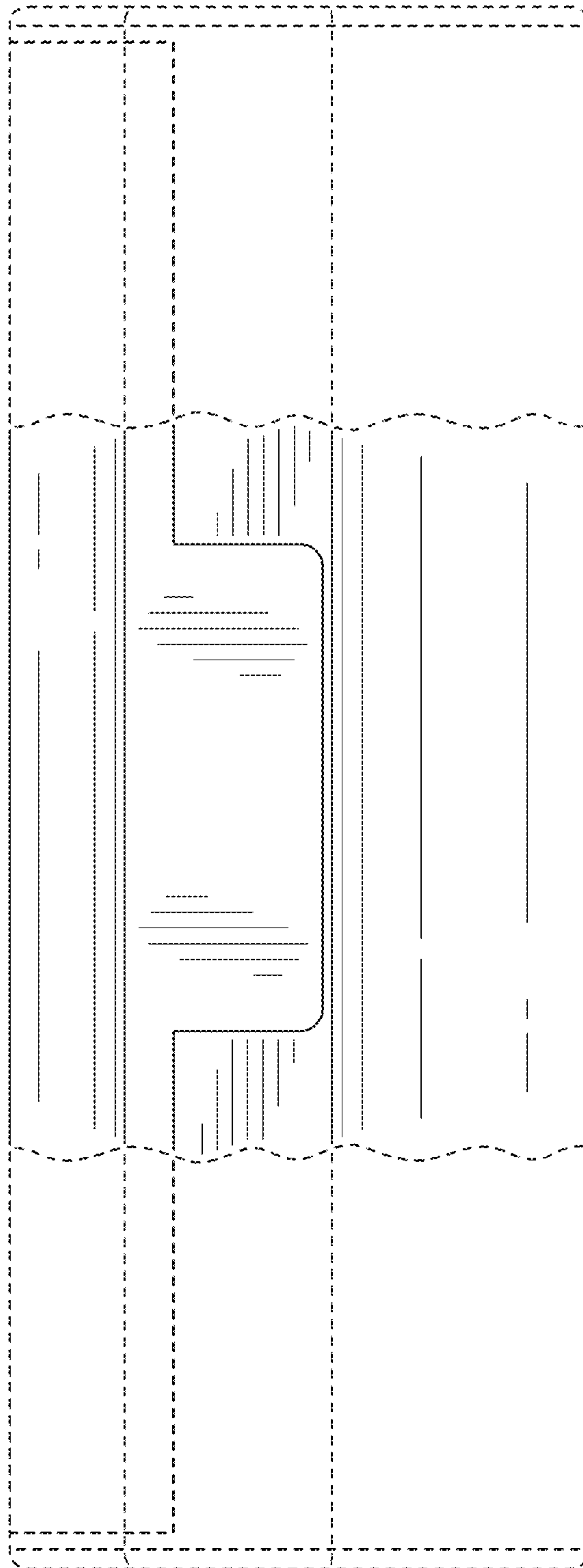

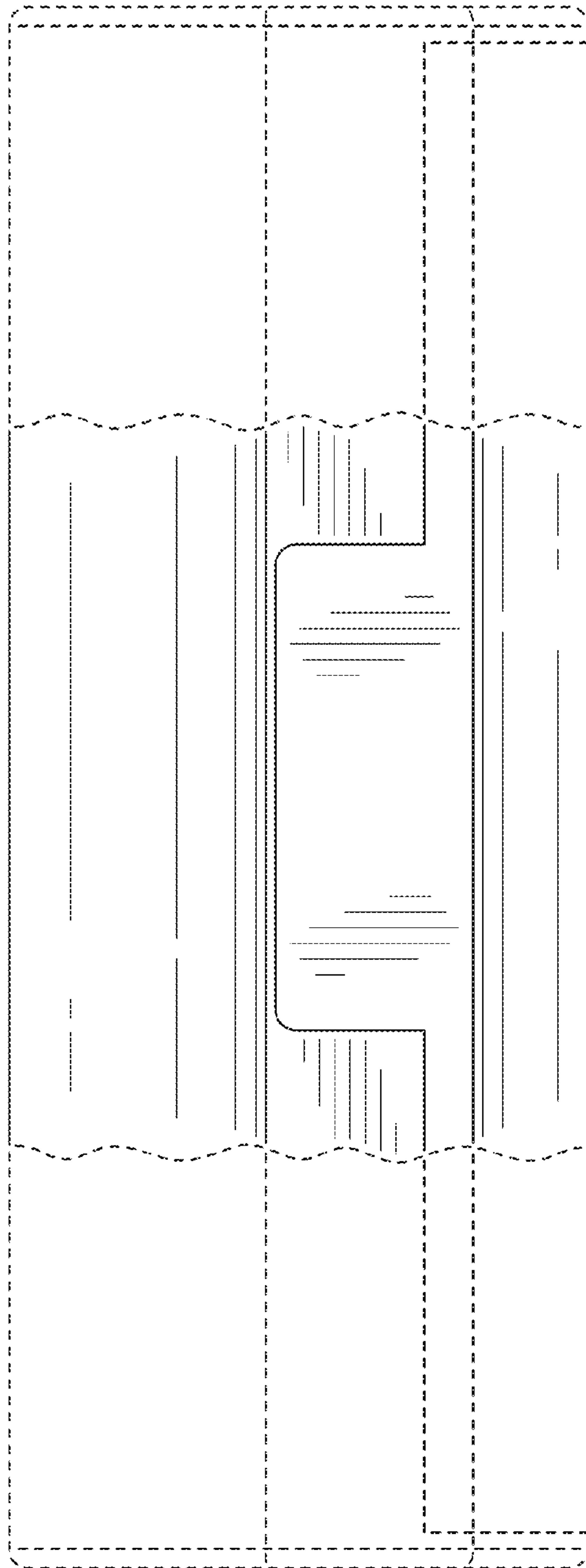

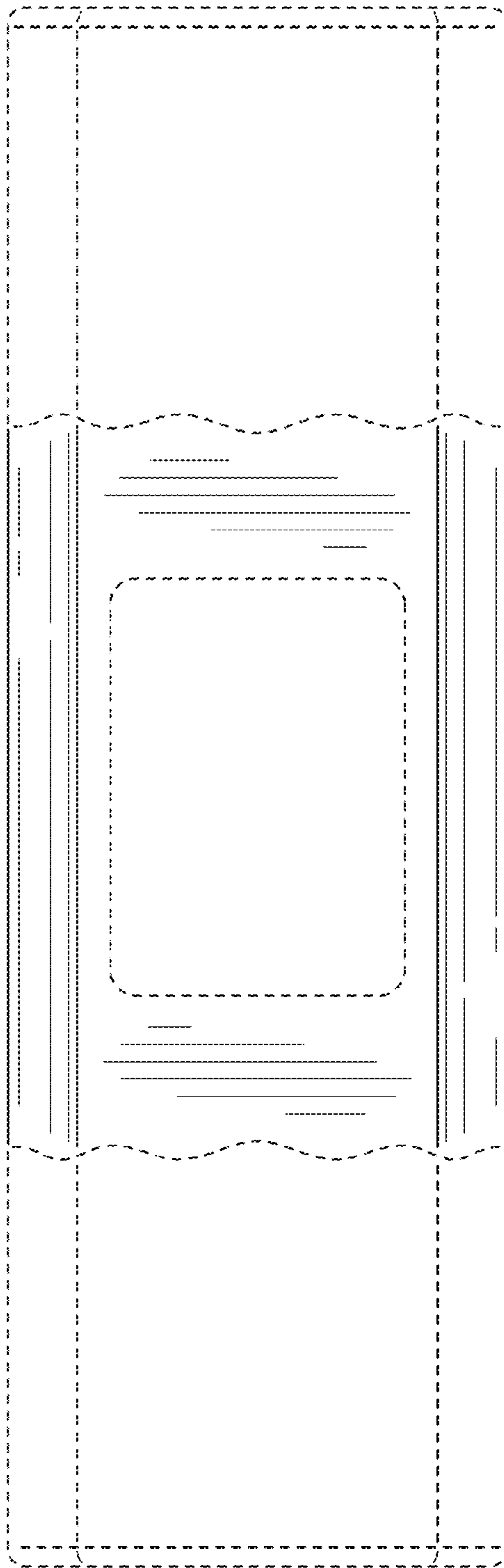
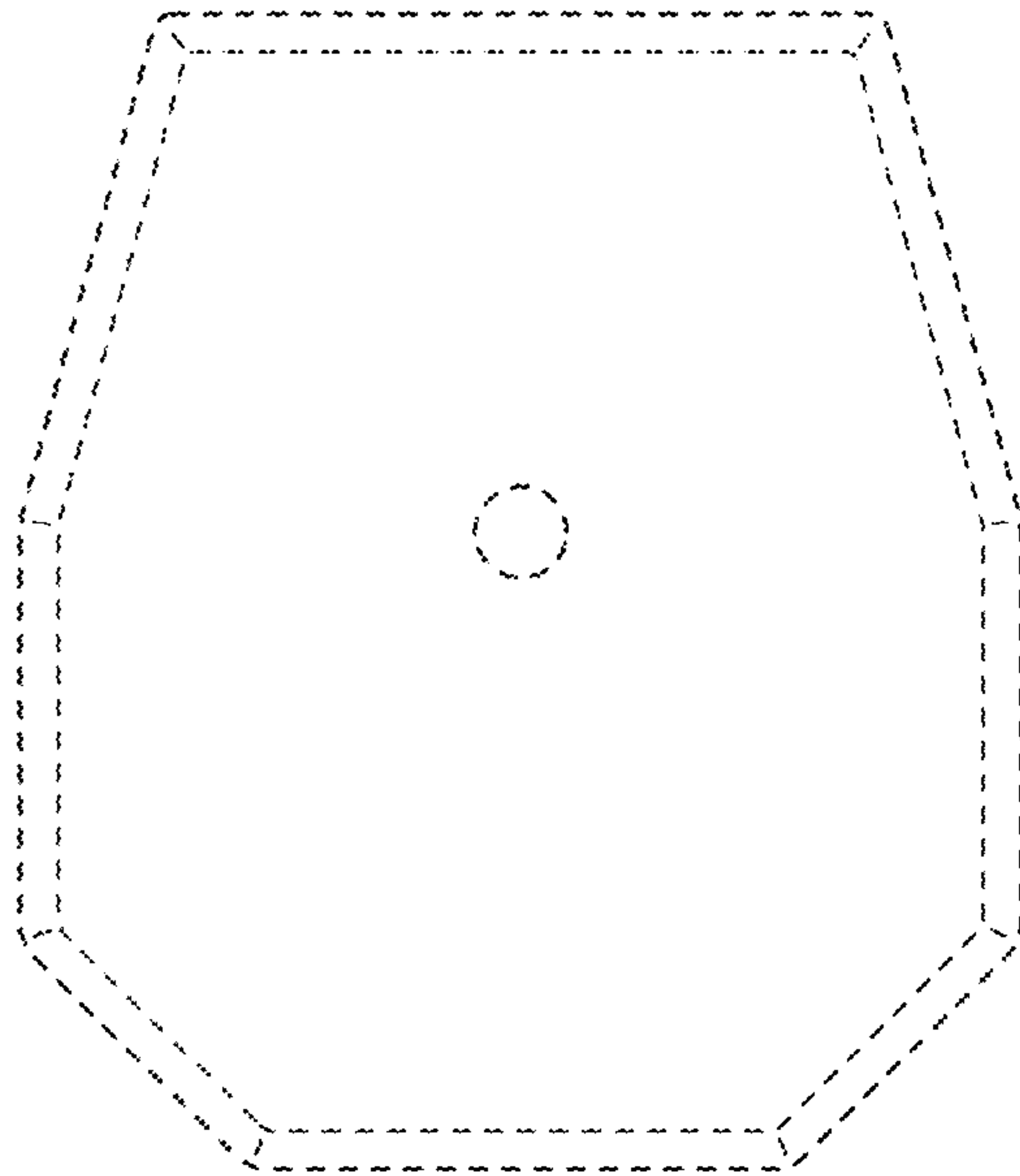

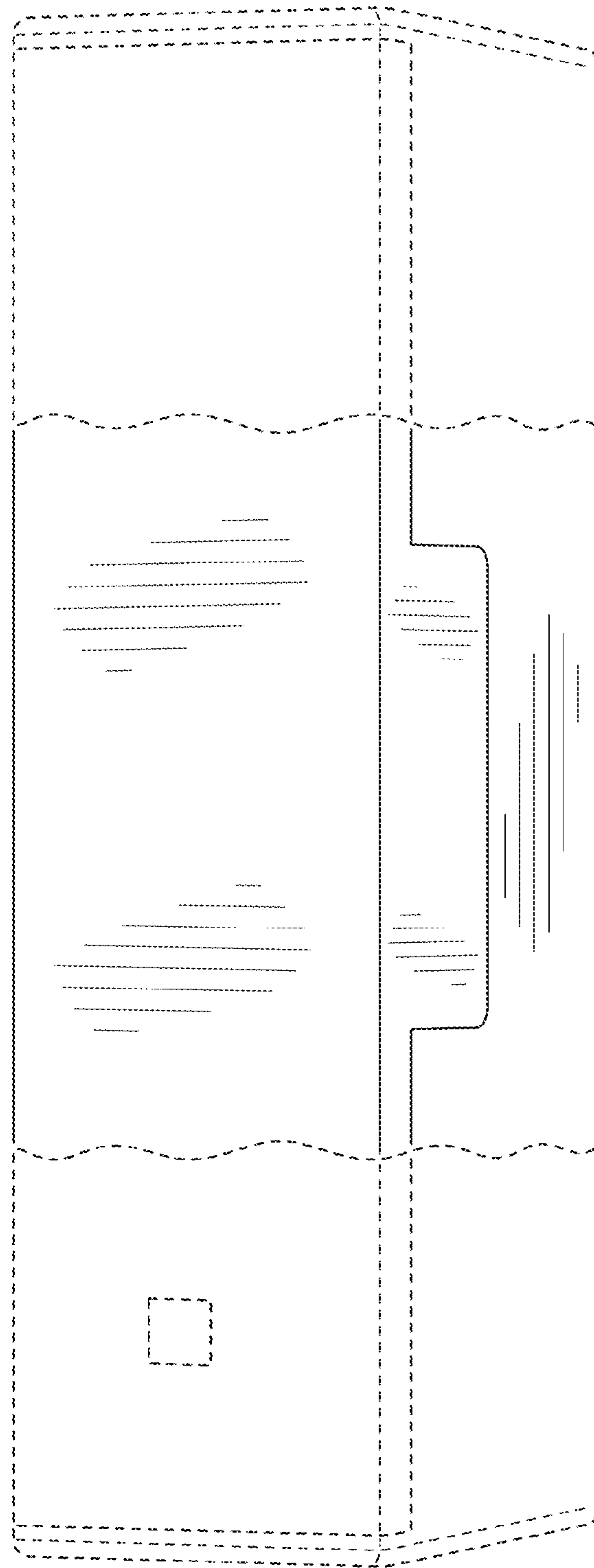

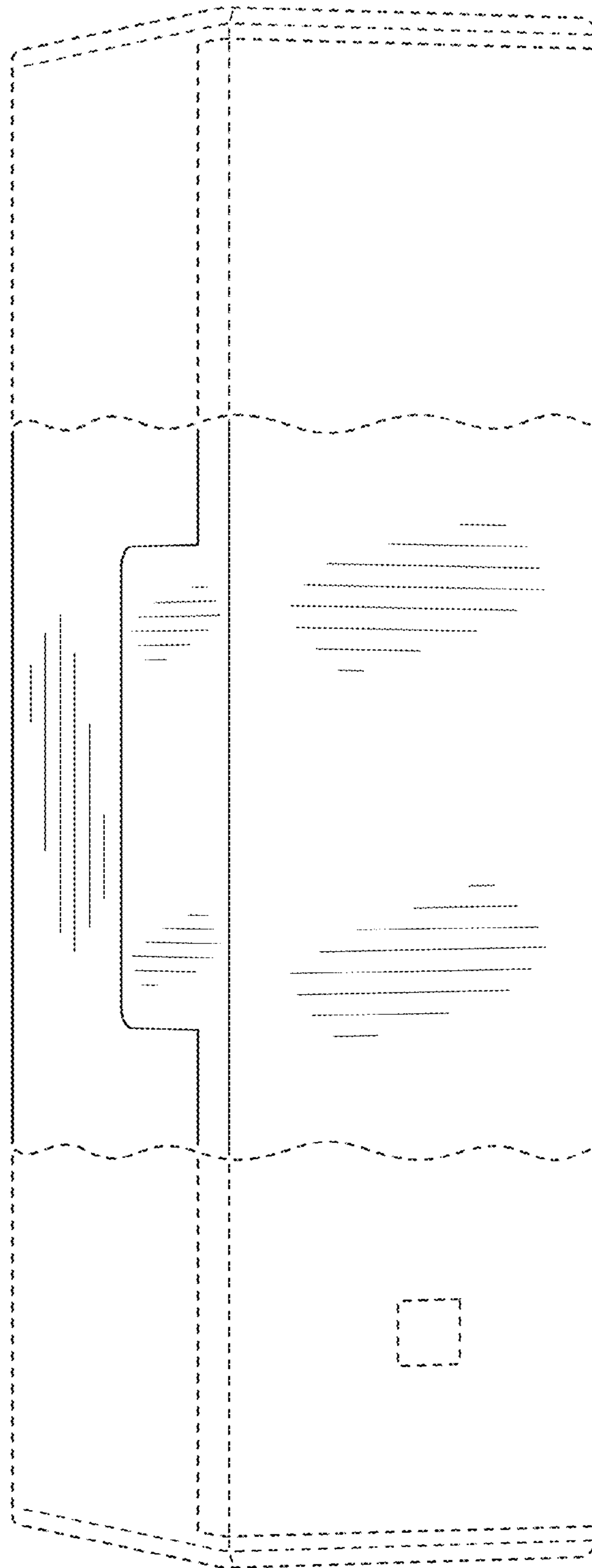
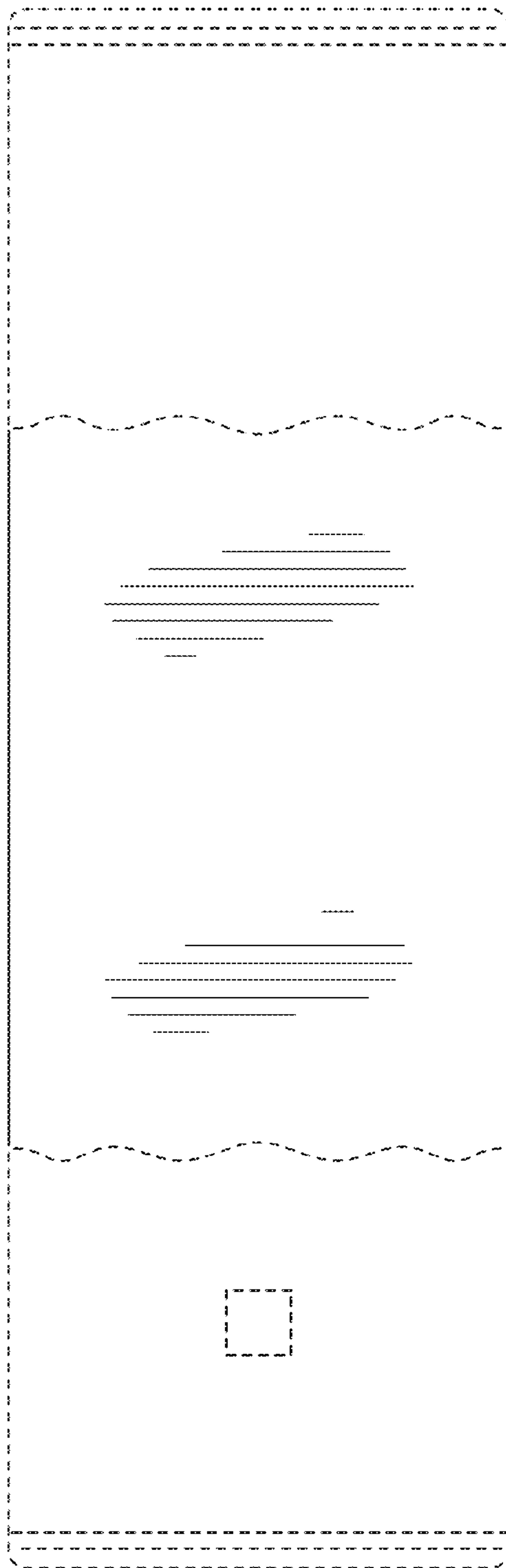

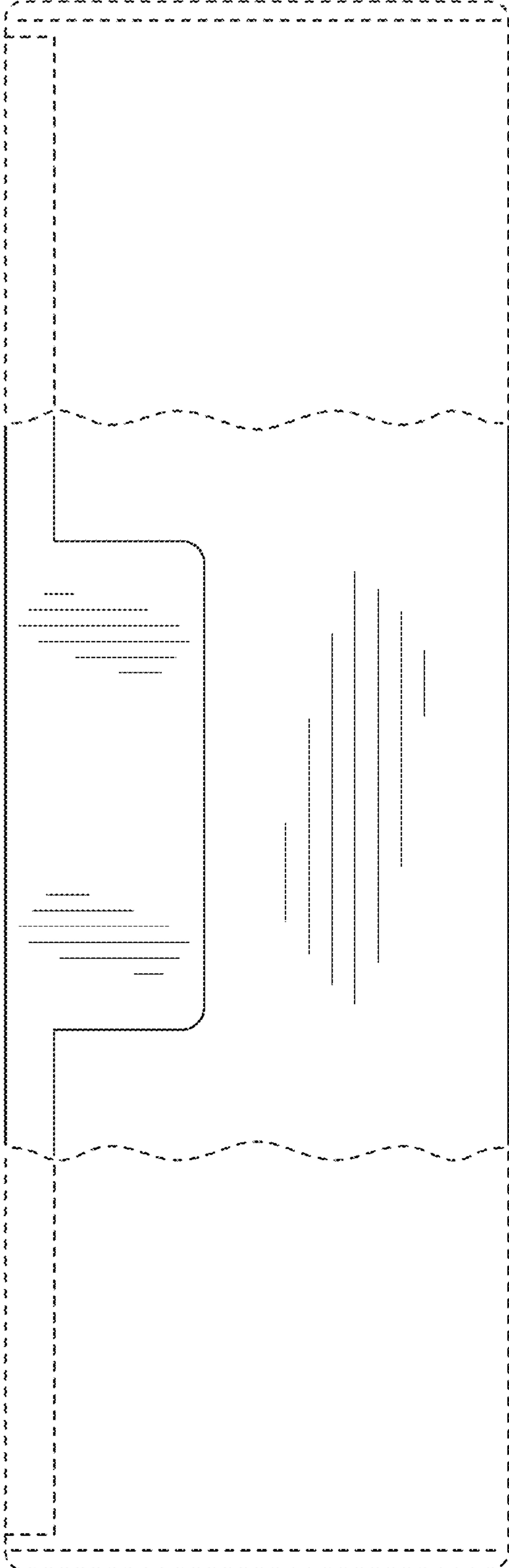

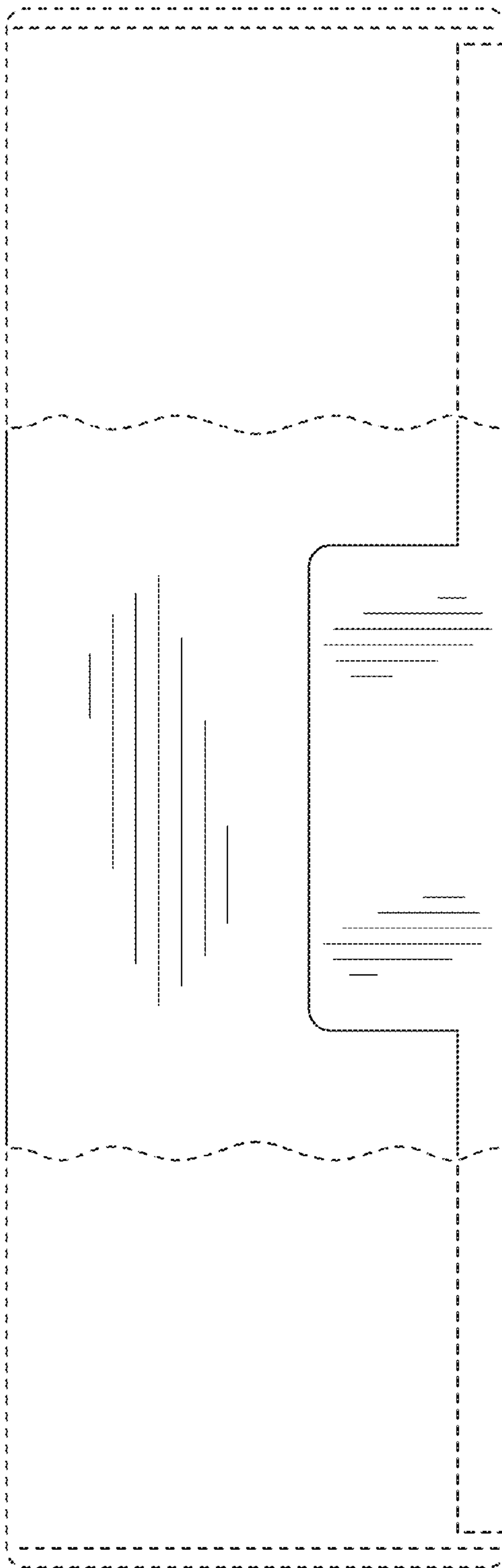
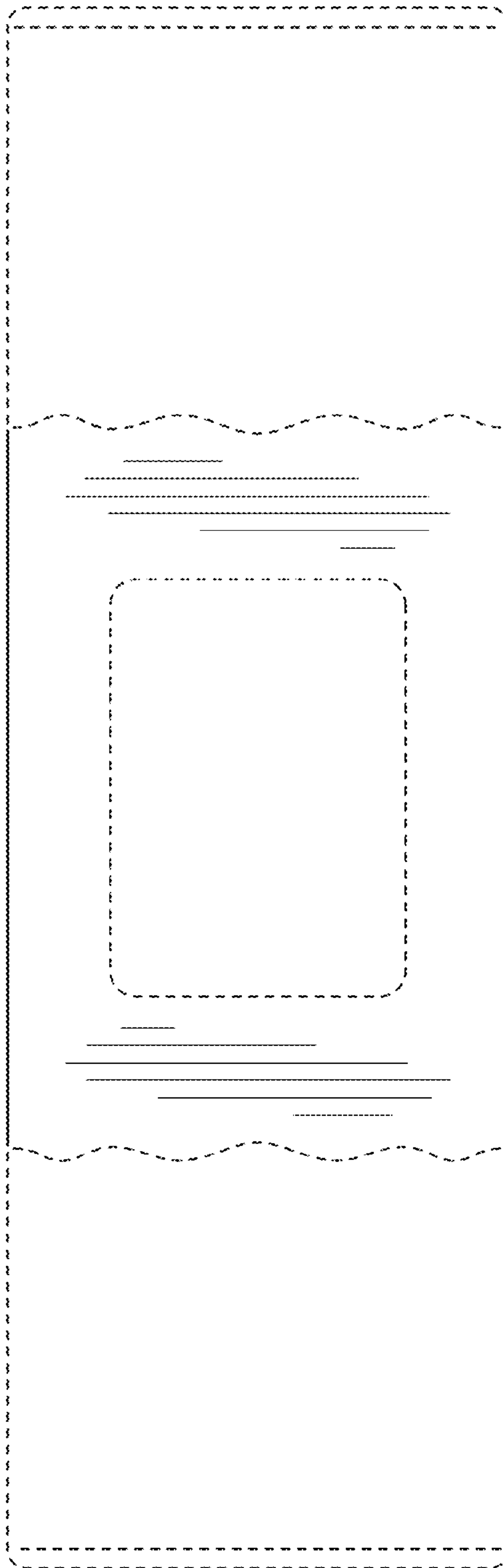
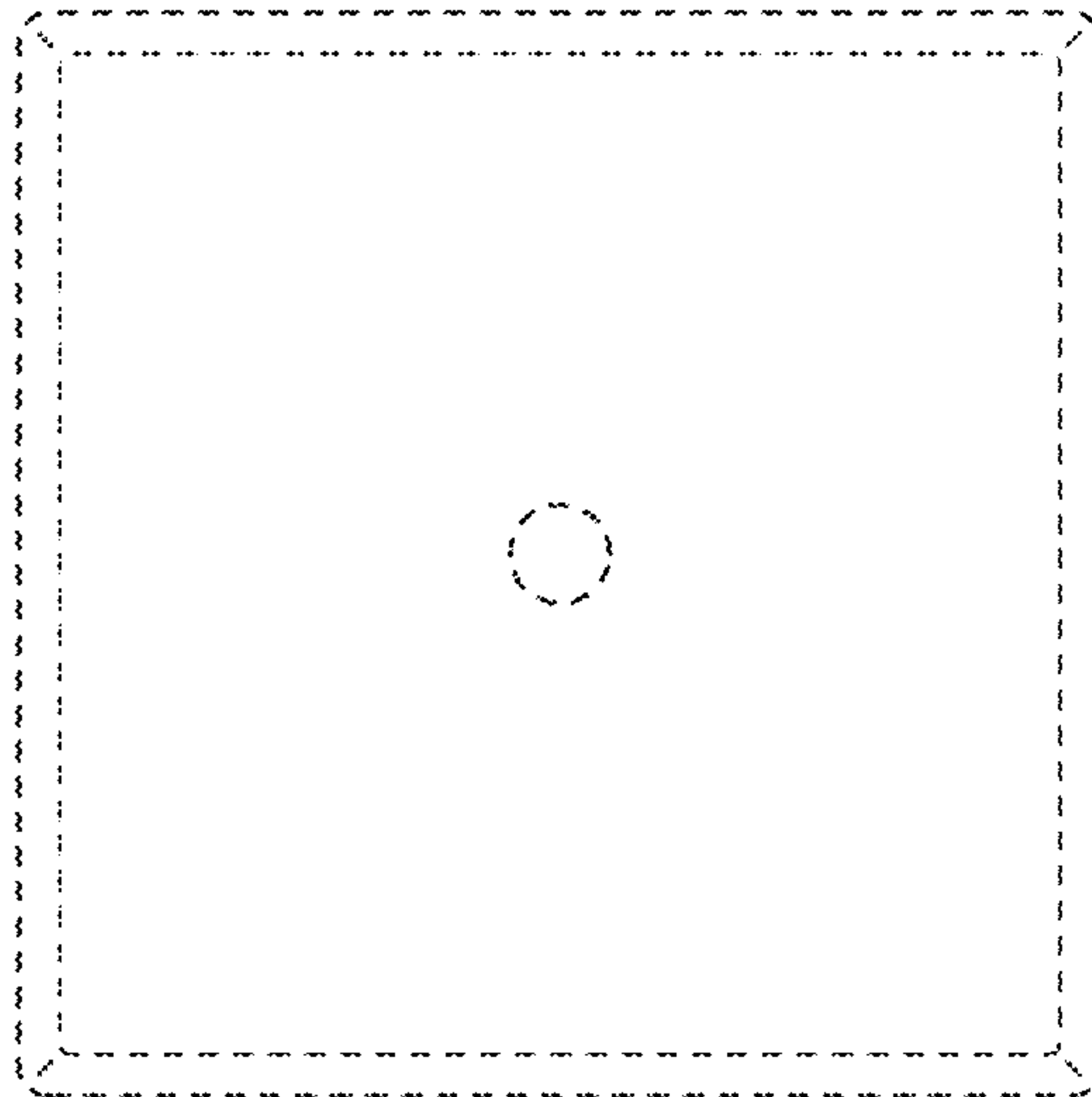
