(57) **CLAIM**

The ornamental design for a case for an electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the front, top and left sides of the case for an electronic device showing my new design.

FIG. 2 is a perspective view of the front, top and right sides thereof.

FIG. 3 is a perspective view of the rear, bottom and left sides thereof.

FIG. 4 is an elevation view of the right side thereof.

FIG. 5 is an elevation view of the left side thereof.

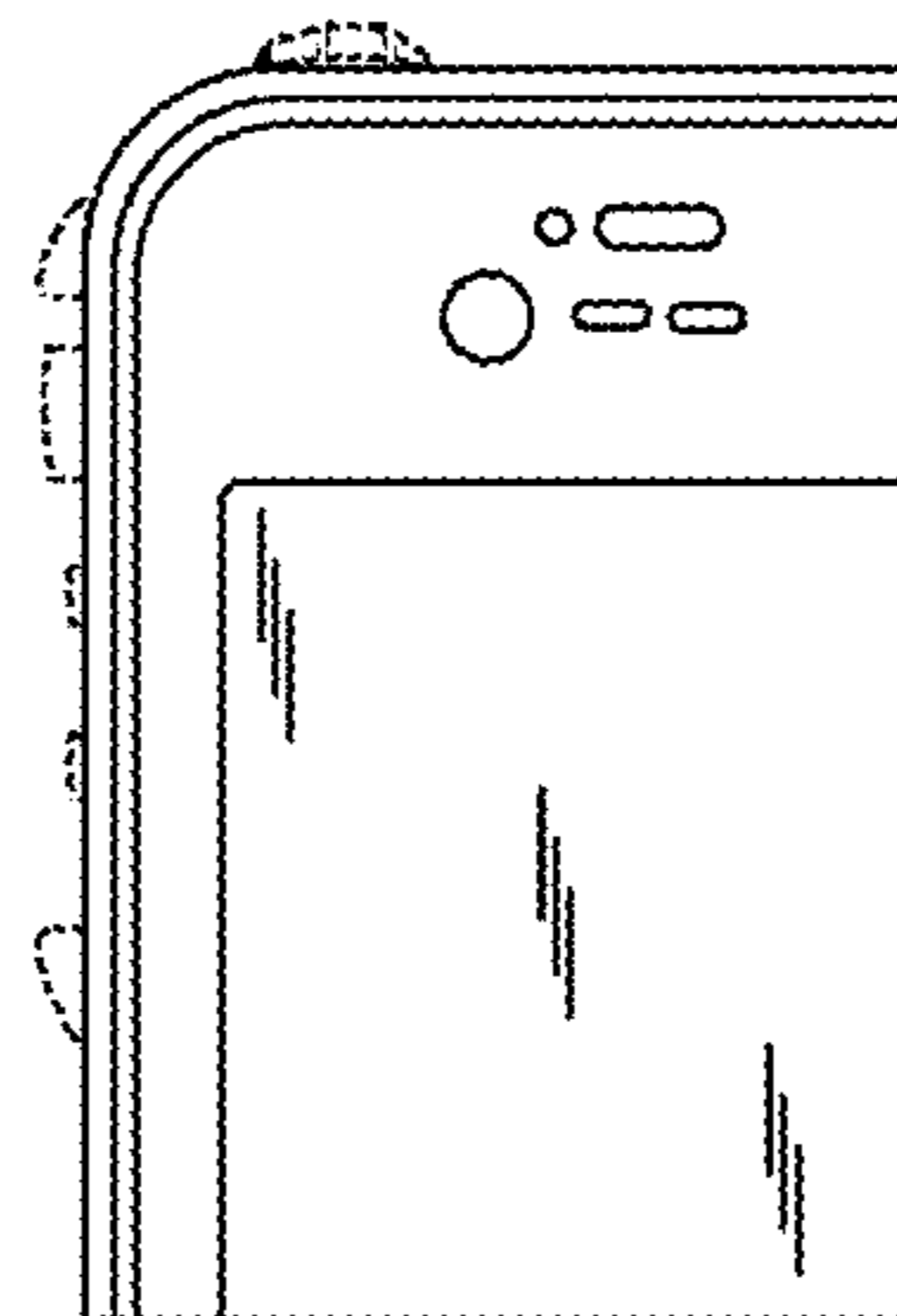
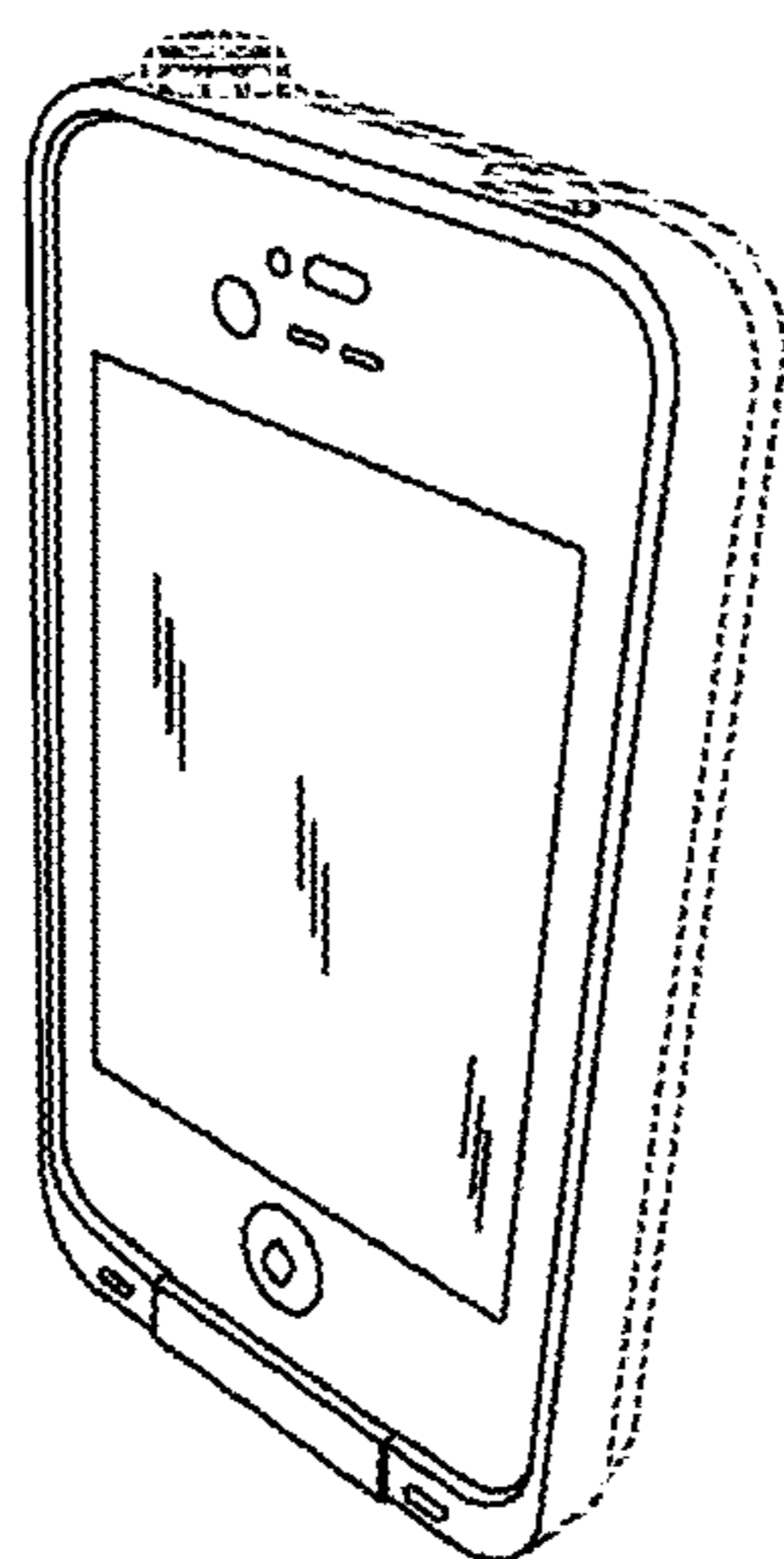
FIG. 6 is a top plan view thereof.

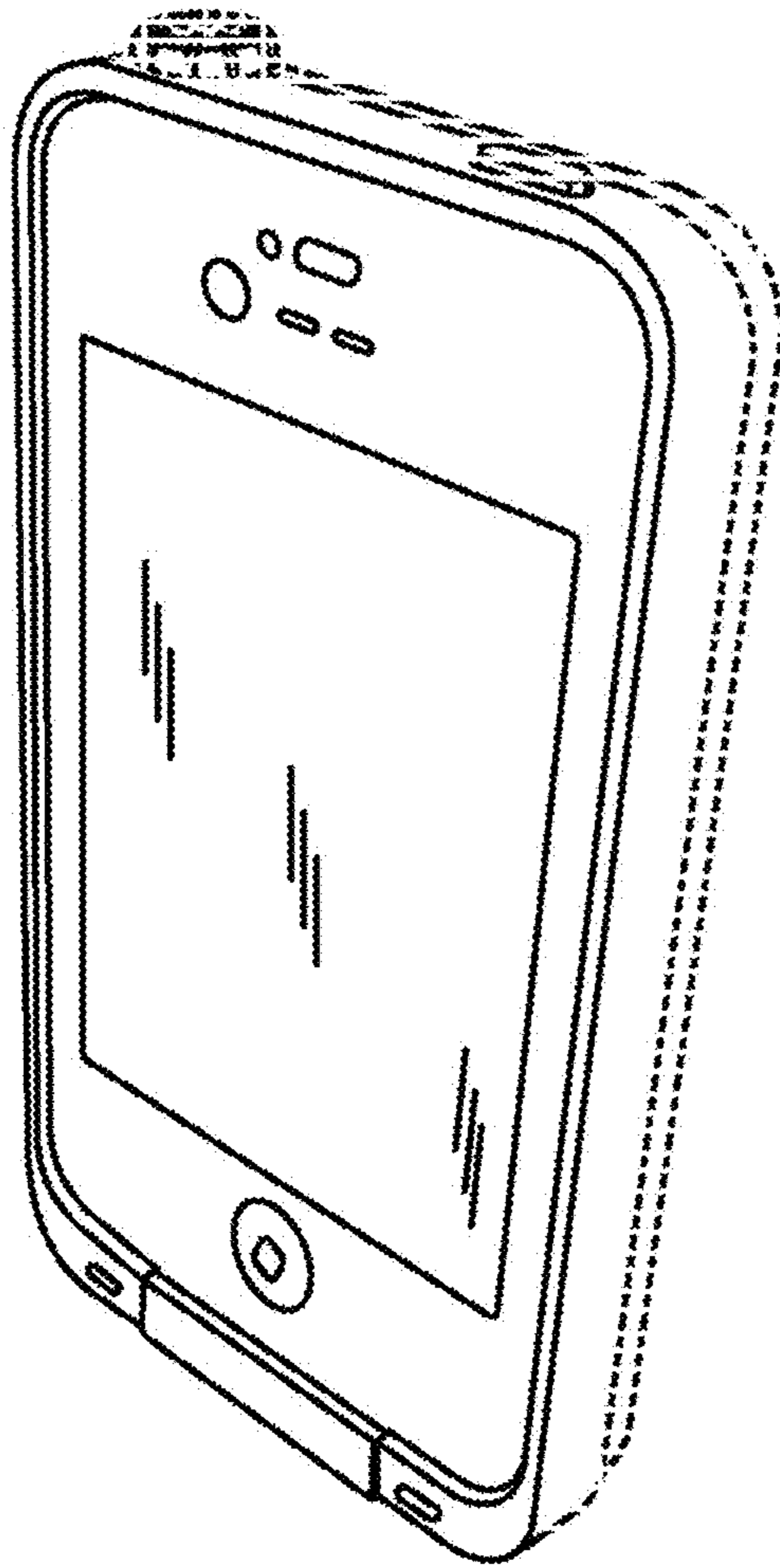

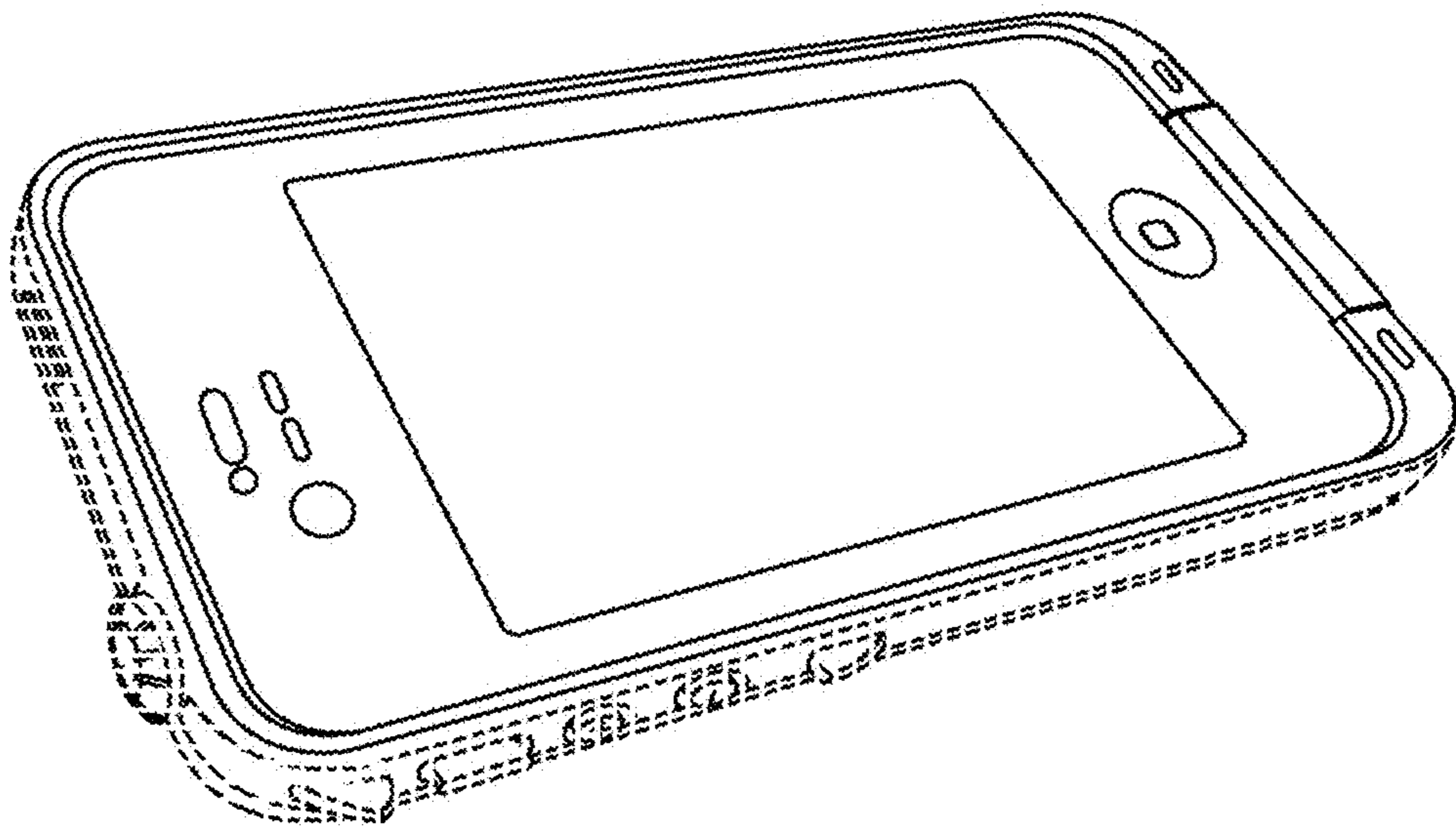

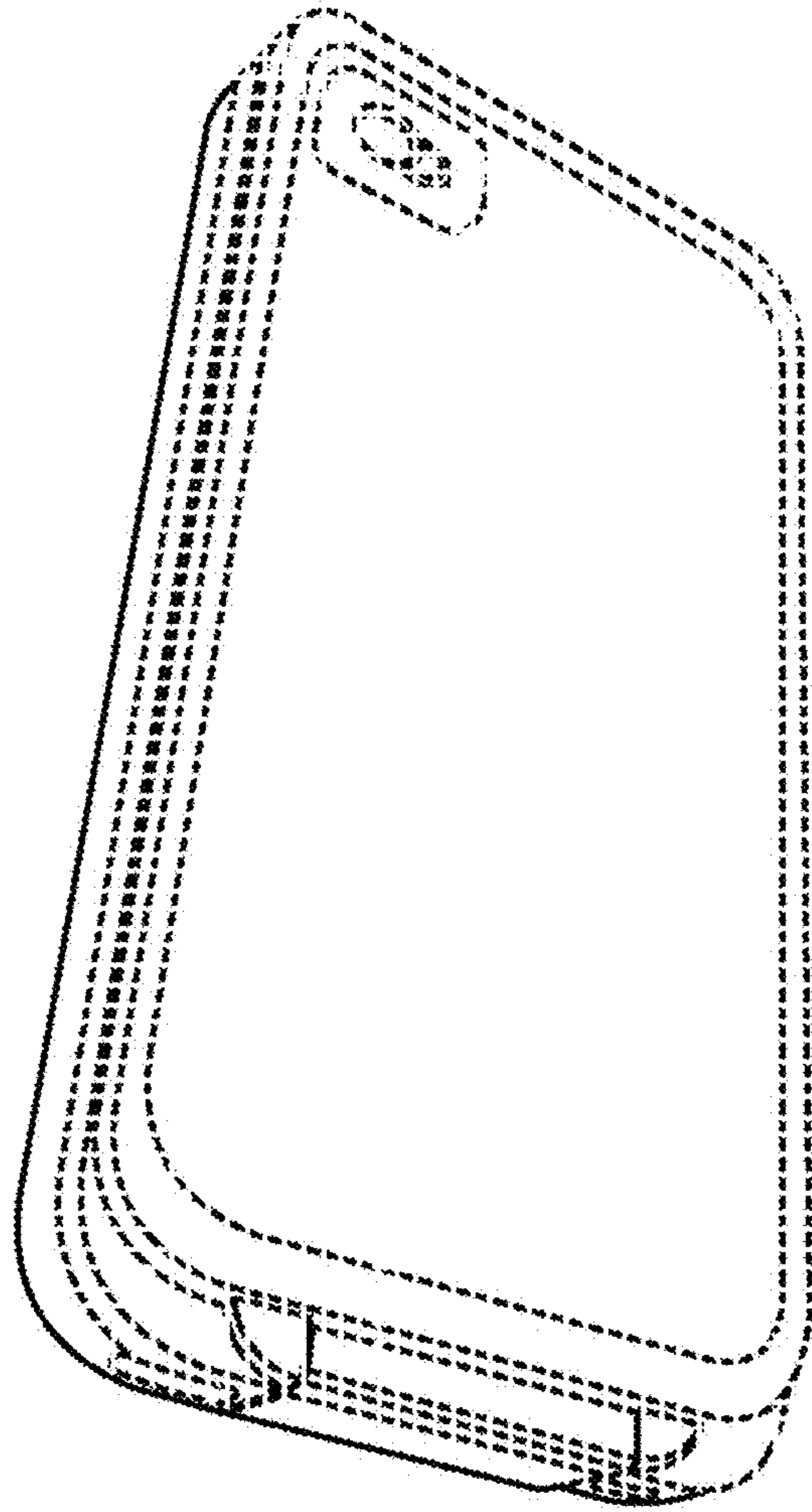

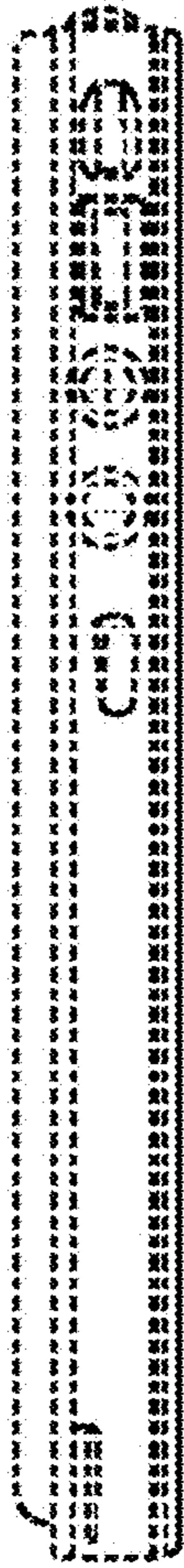

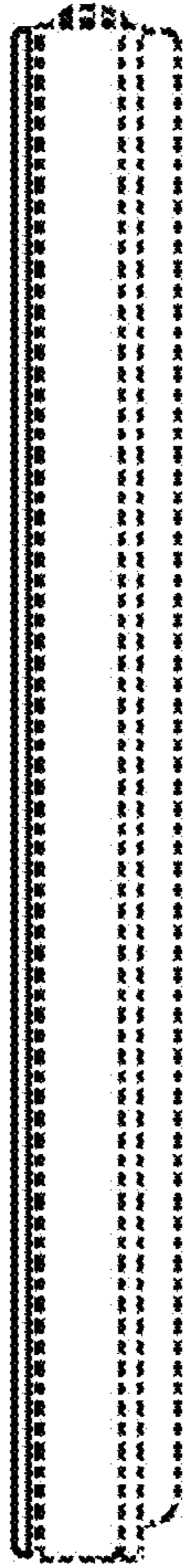

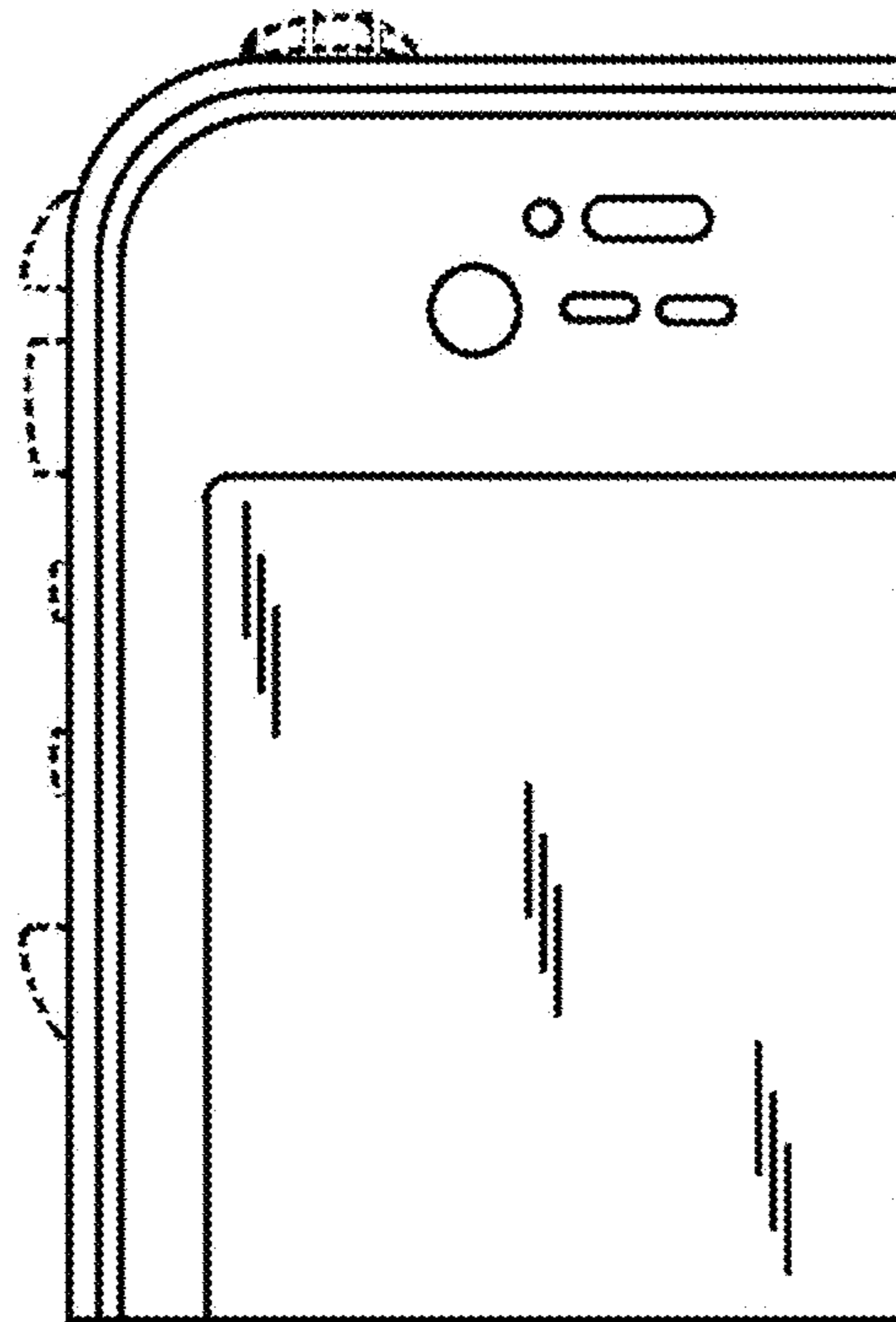
