The ornamental design for an instrument panel for media and navigation systems, as shown and described

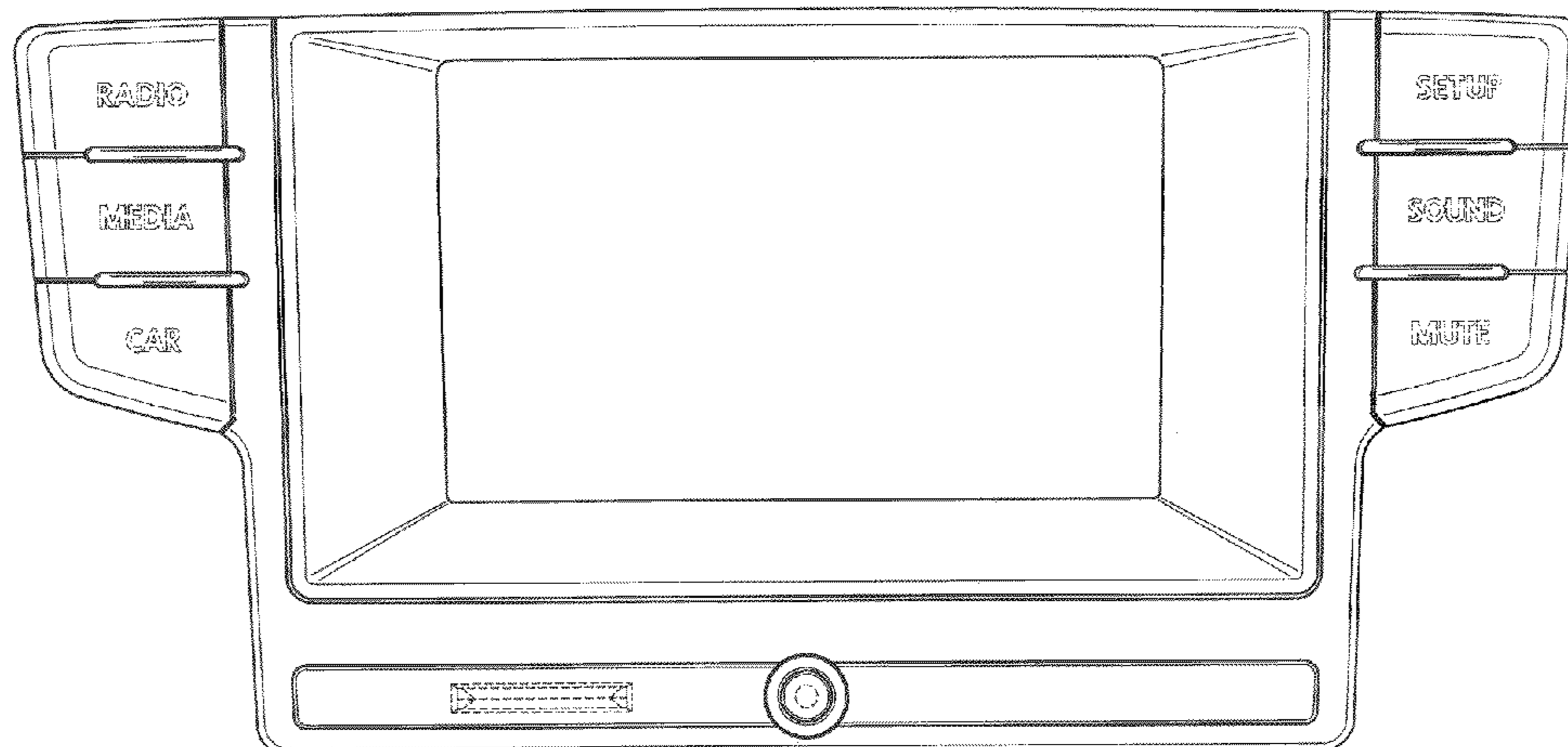
**DESCRIPTION**

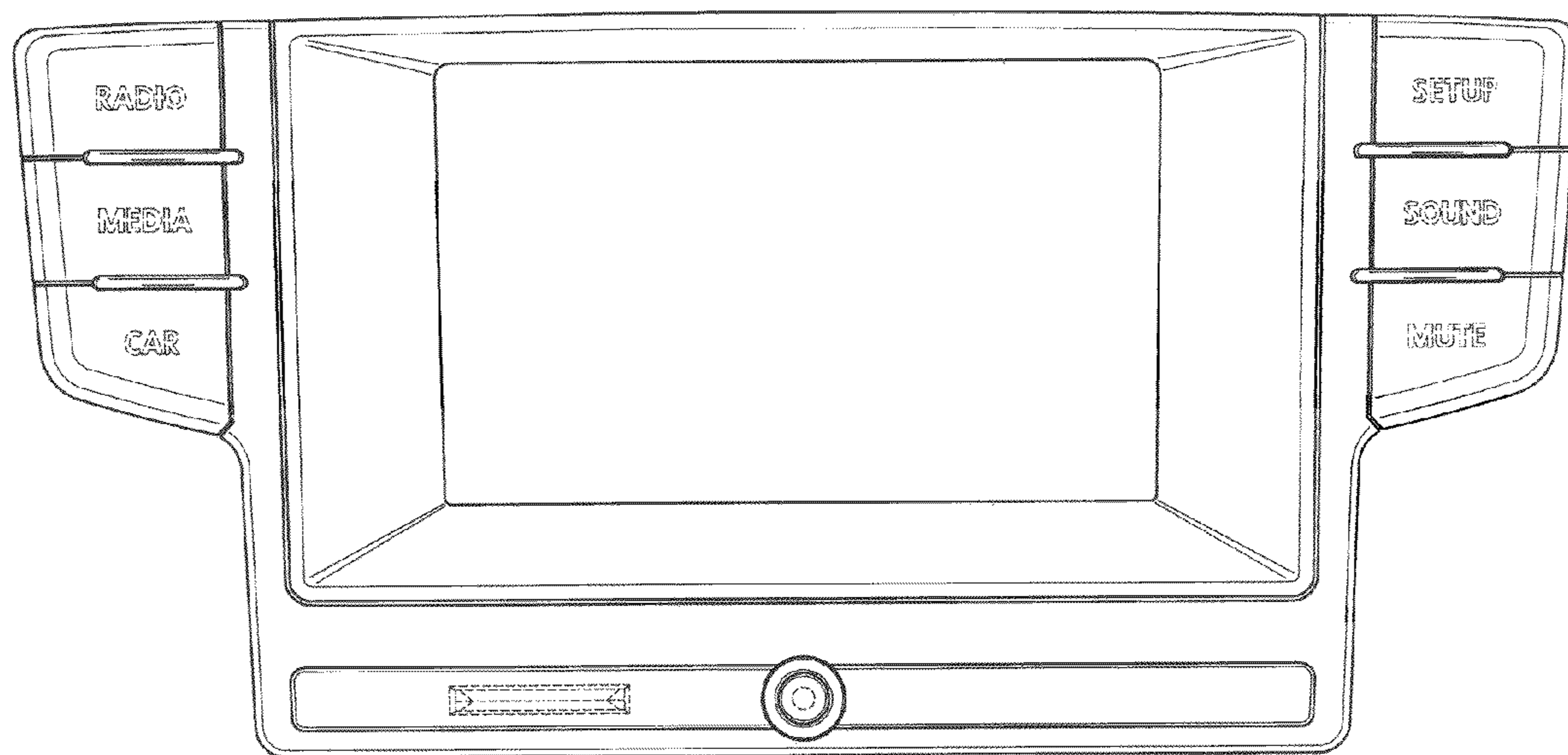

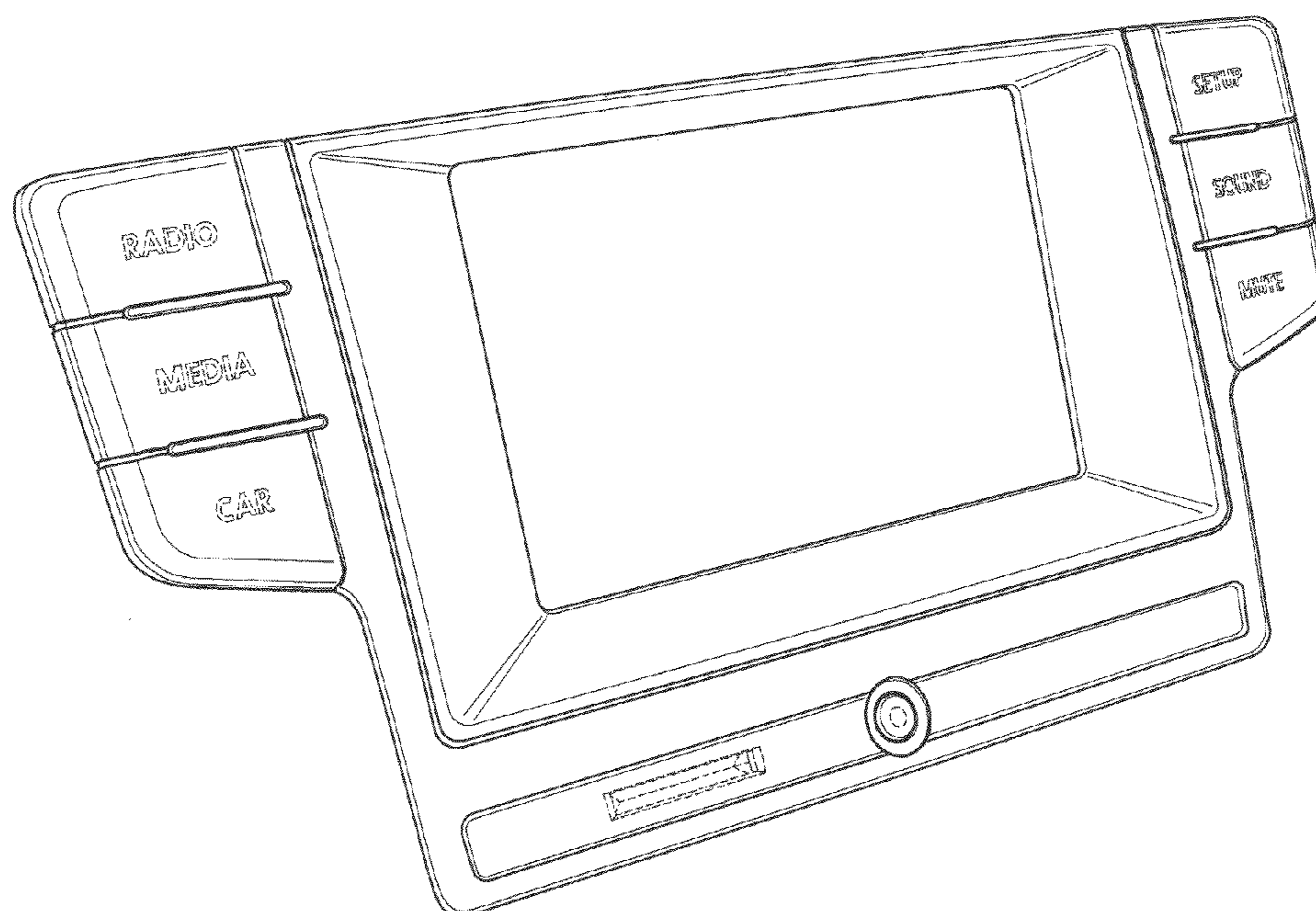
