(57) **CLAIM**

The ornamental design for a portion of a display screen with icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a portion of a display screen with icon, showing our new design; and, FIG. 2 is a front view of the icon of FIG. 1, in which a display screen in broken lines is provided to illustrate an example environment.

The broken line drawing of the device, and the number, symbol and otherwise images shown in broken lines in the generated image of FIGS. 1 through 2 are for illustrative purposes only and form no part of the claimed design. The size, scale, and location of the icon of FIG. 2 is for illustrative purposes and forms no part of the claimed design.

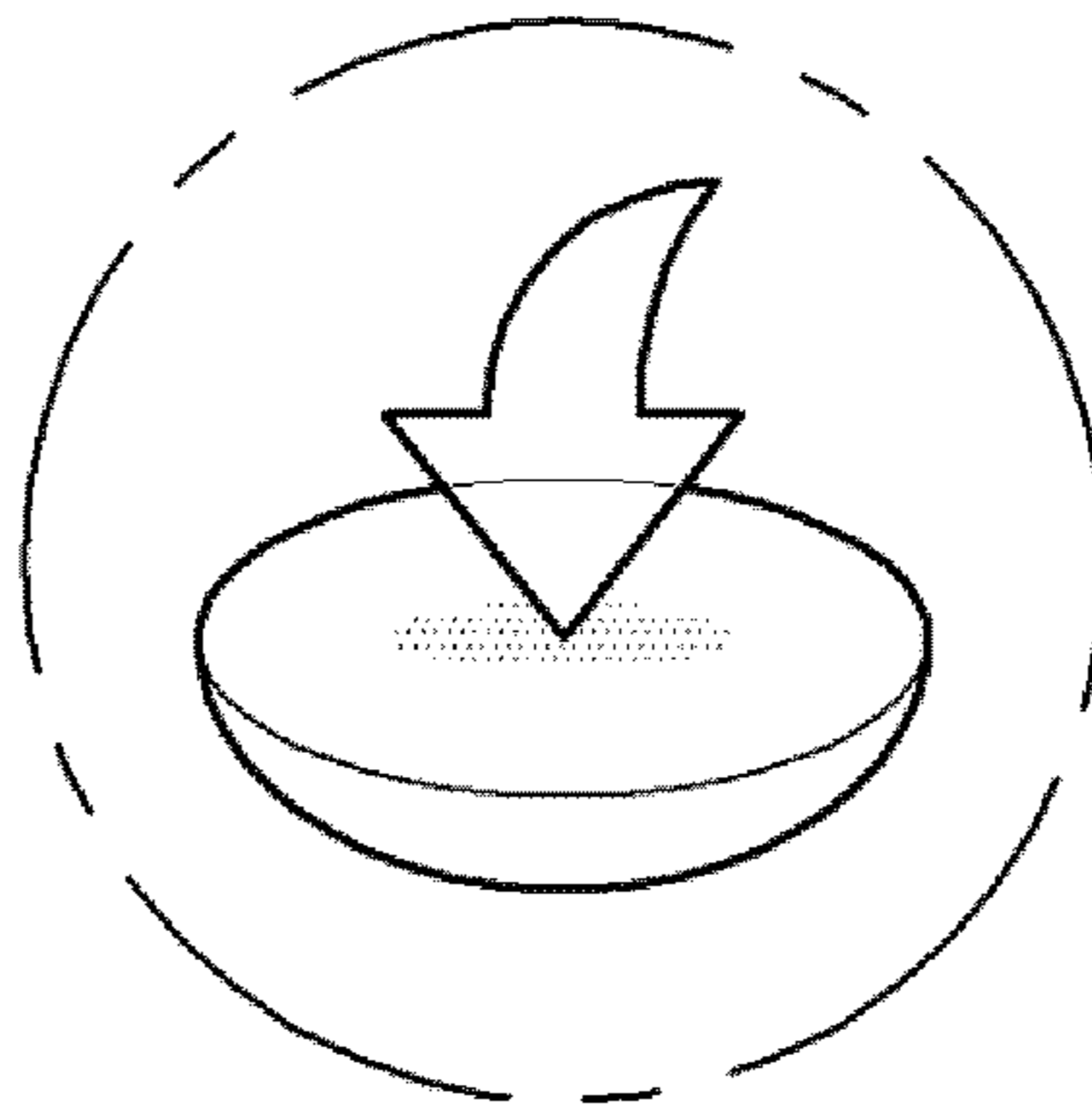

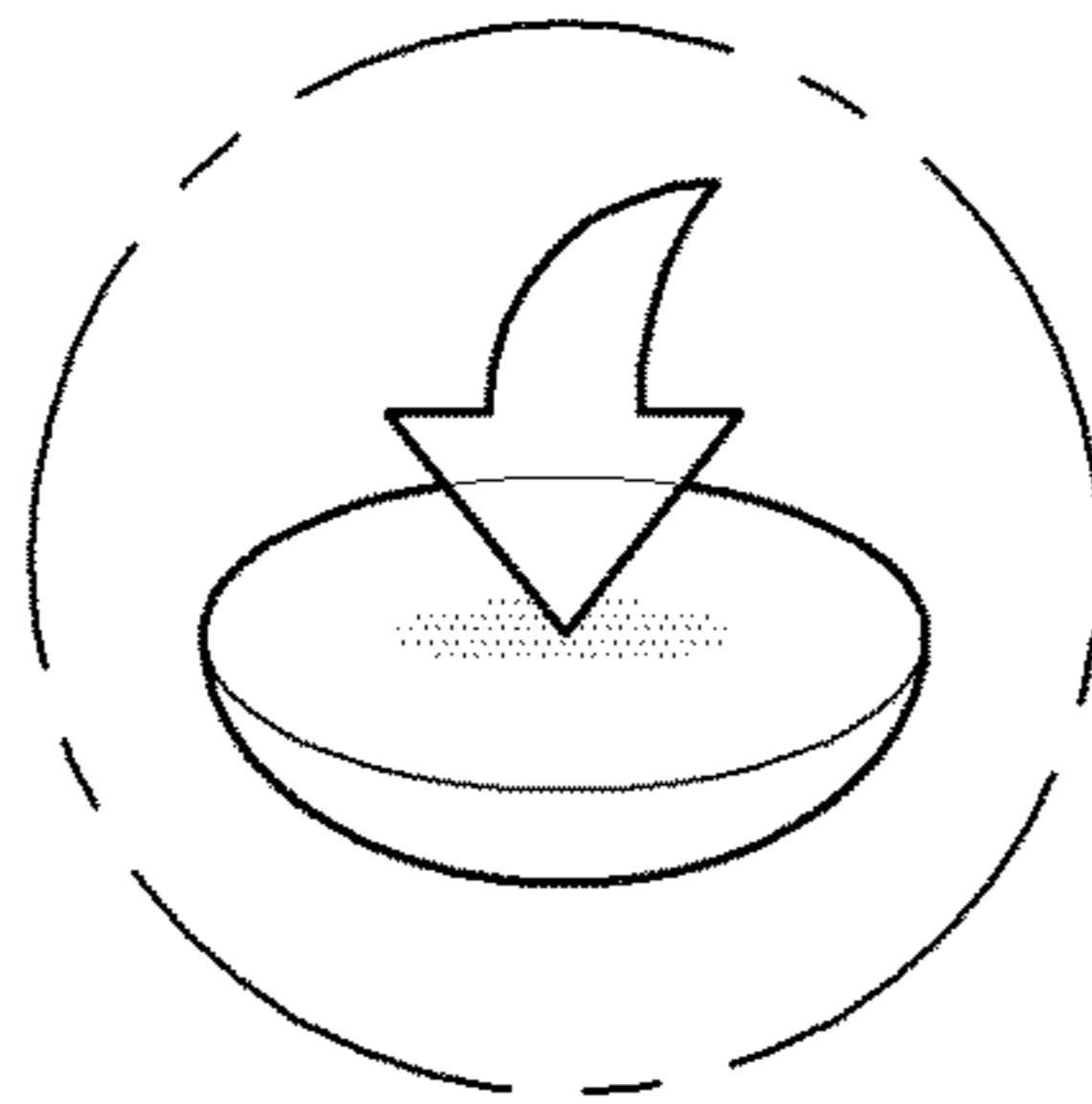
