(57) **CLAIM**

We claim the ornamental design for a TV receiver with a graphical user interface, as shown and described.

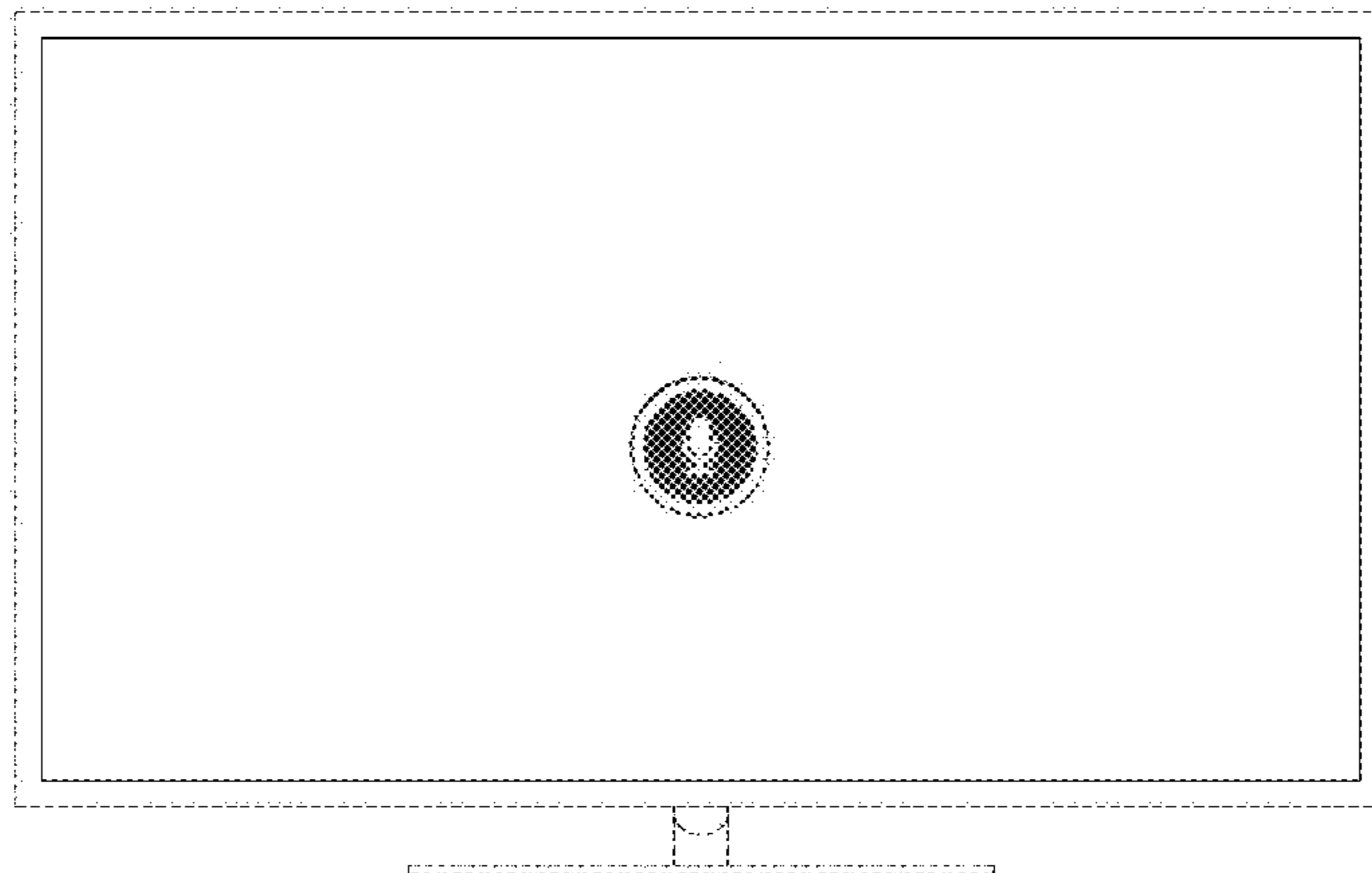

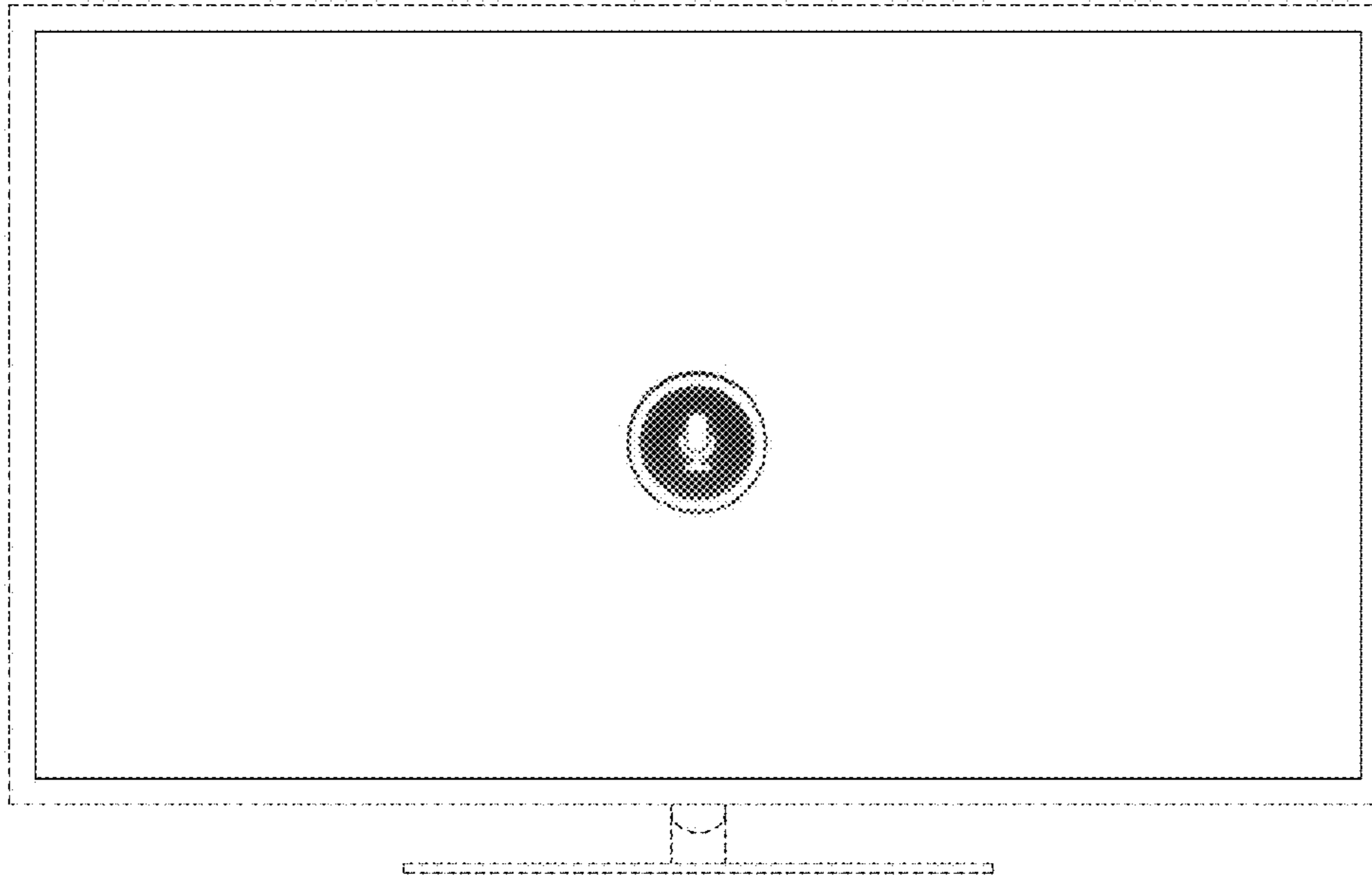

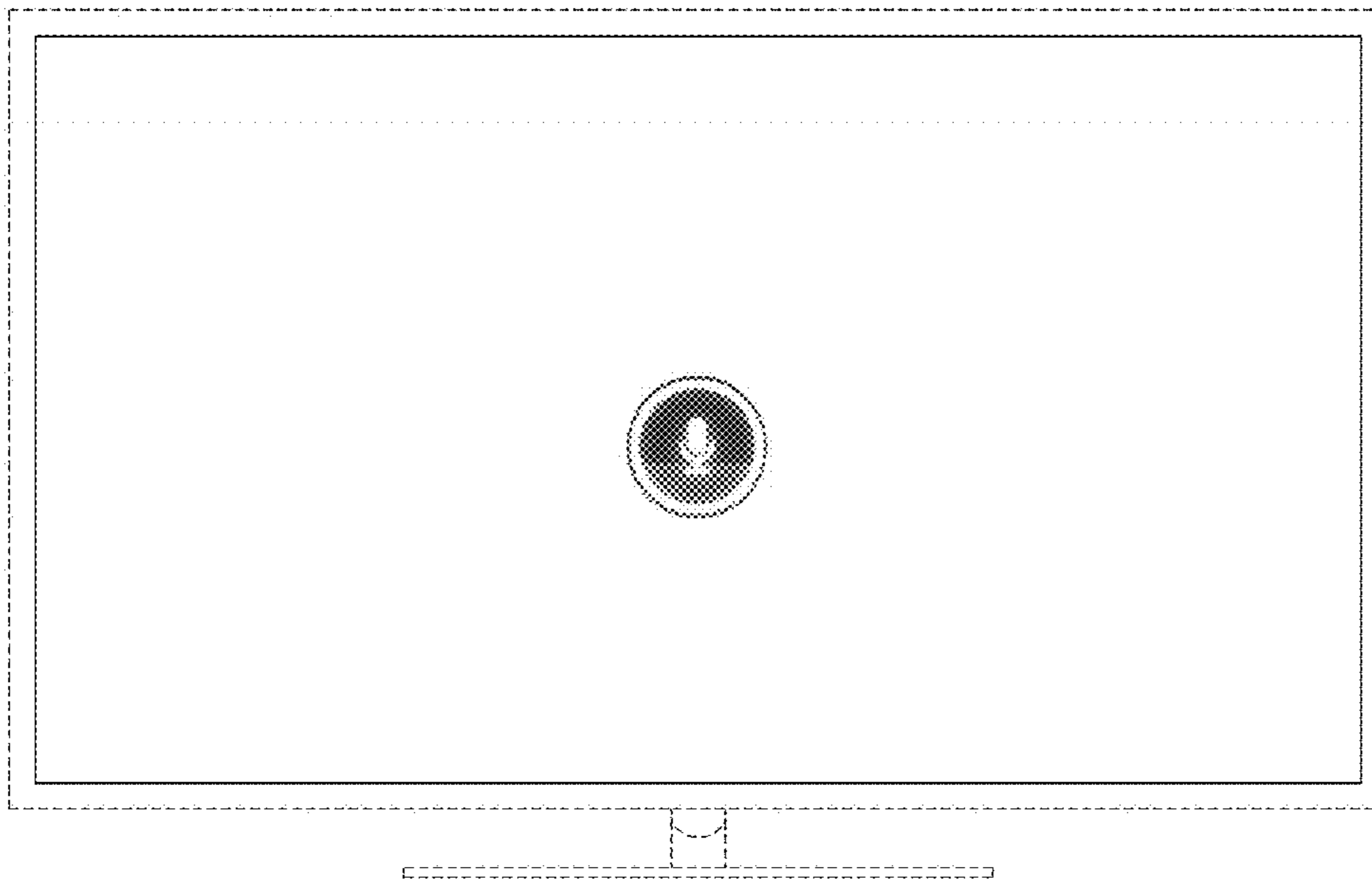

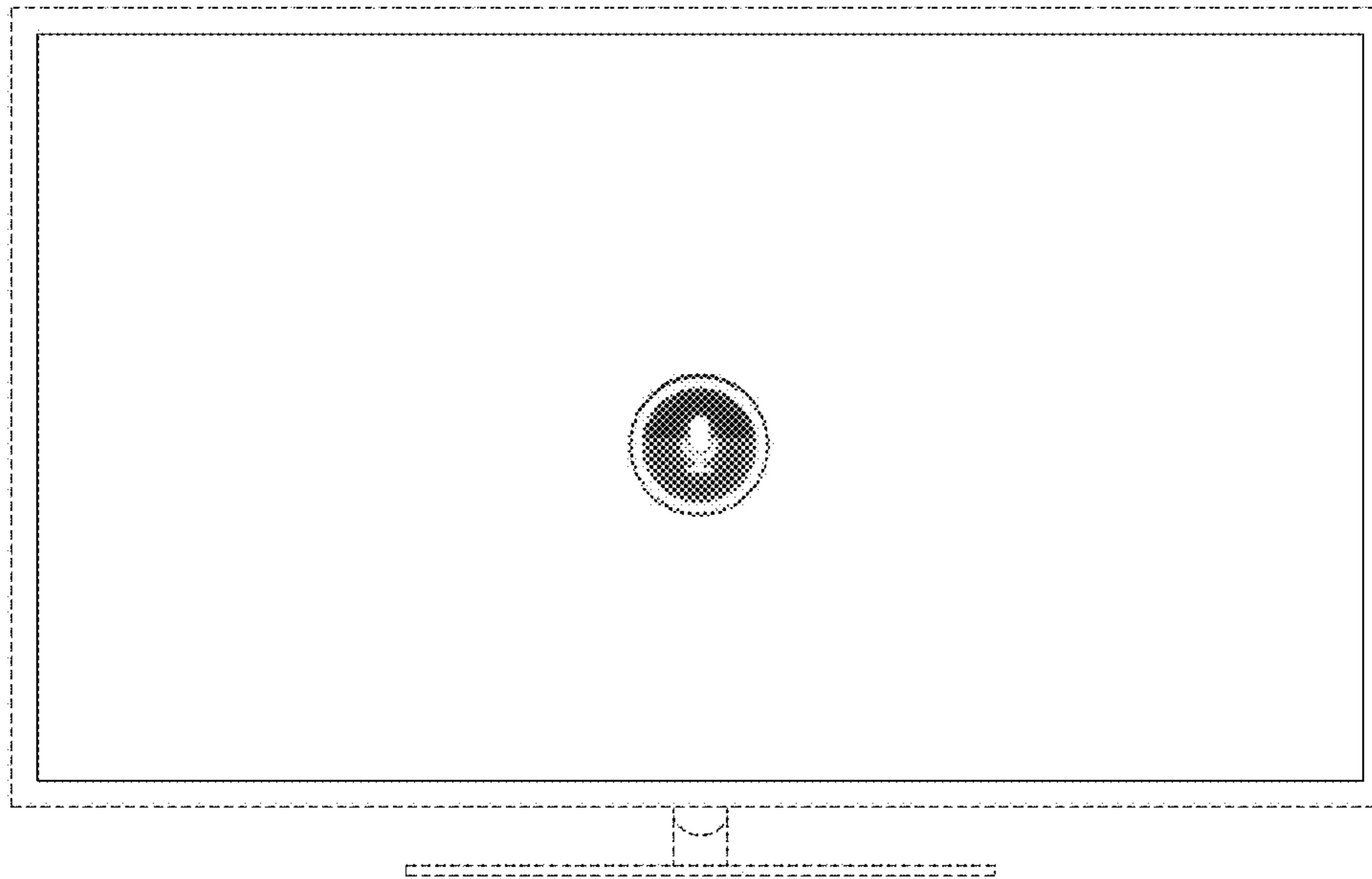
