DESCRIPTION

FIG. 1 is a front, right perspective view of an ice dispenser showing our new design;

FIG. 2 is a front view thereof;

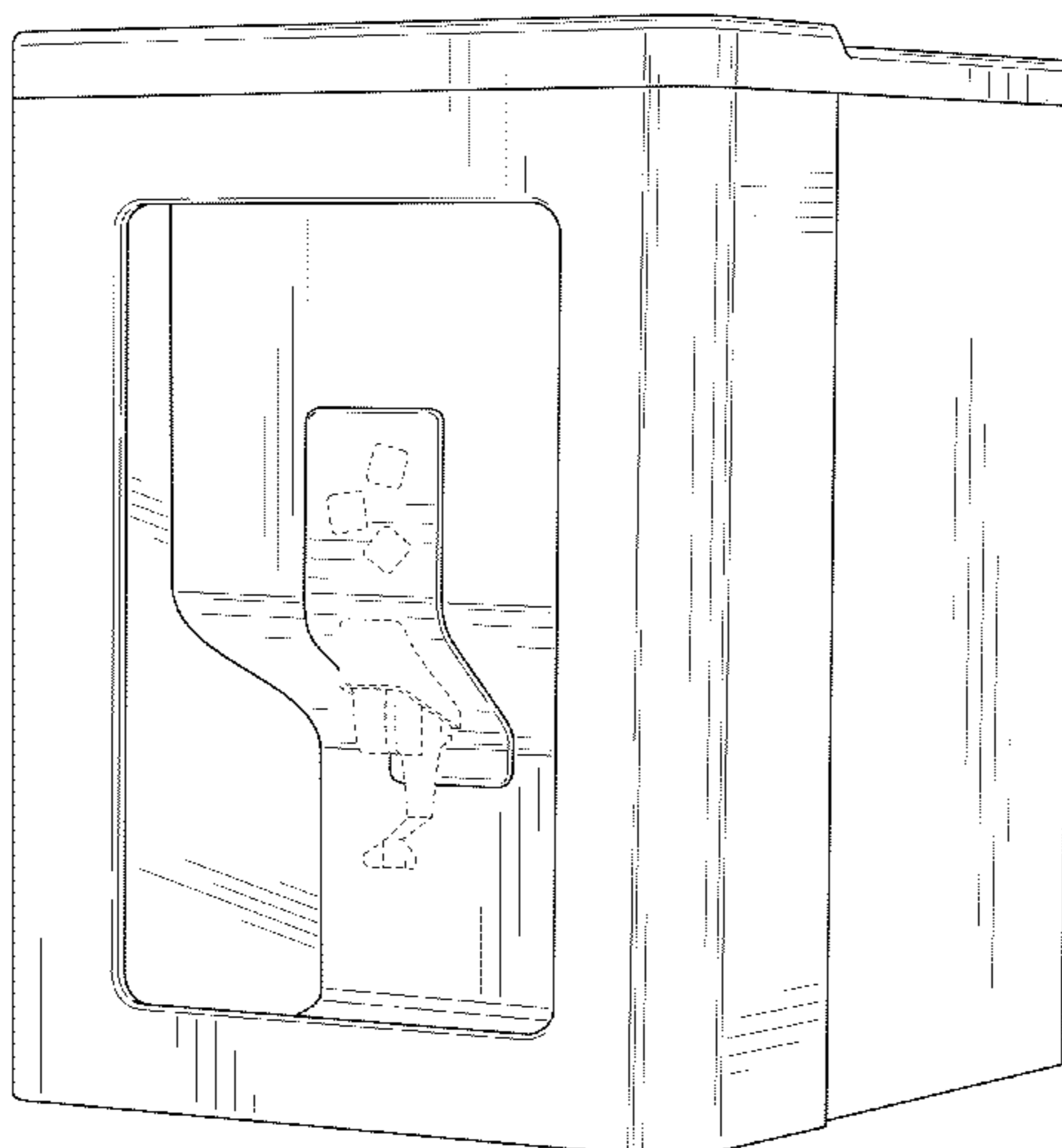
FIG. 3 is a right side view thereof;

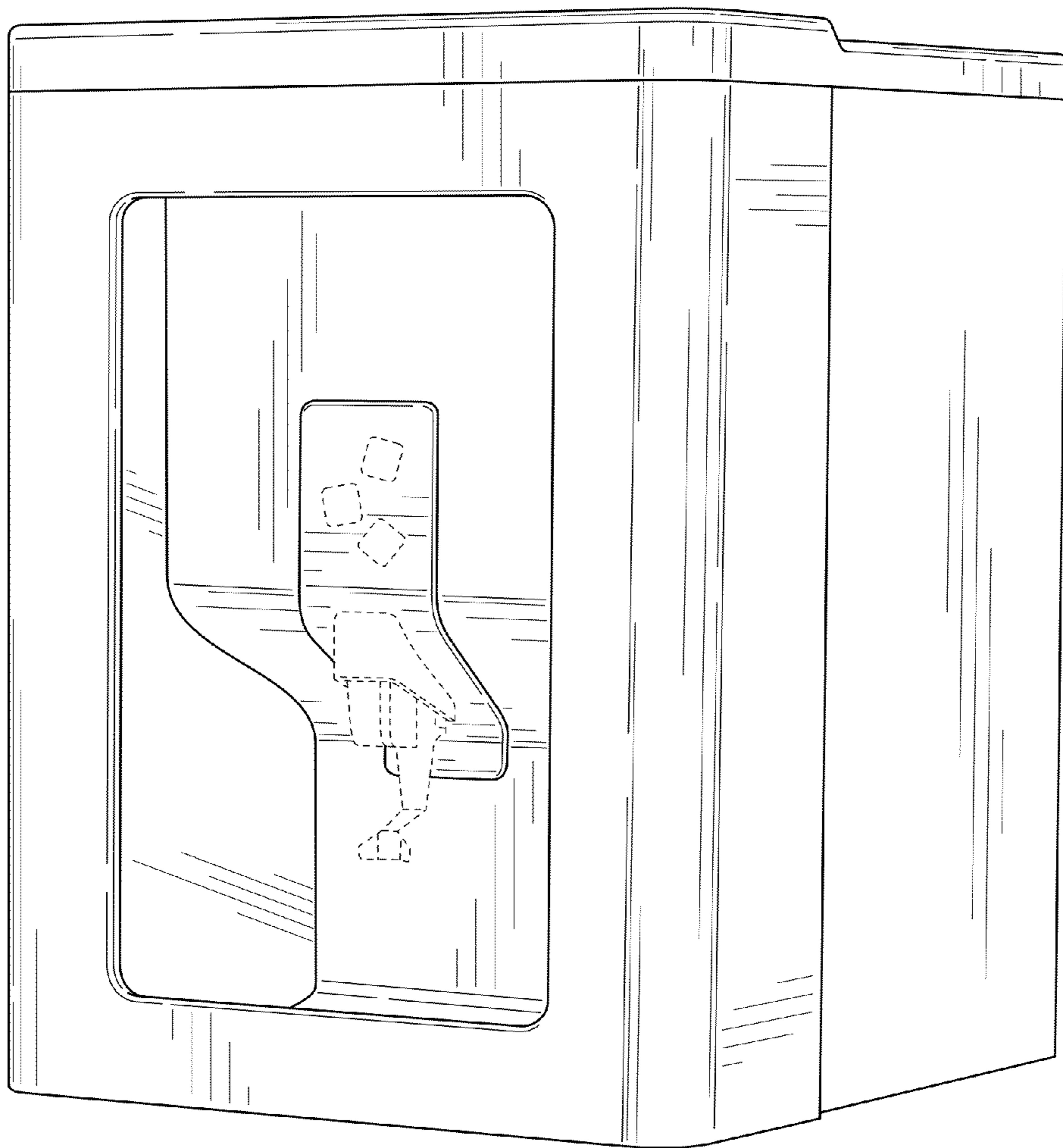

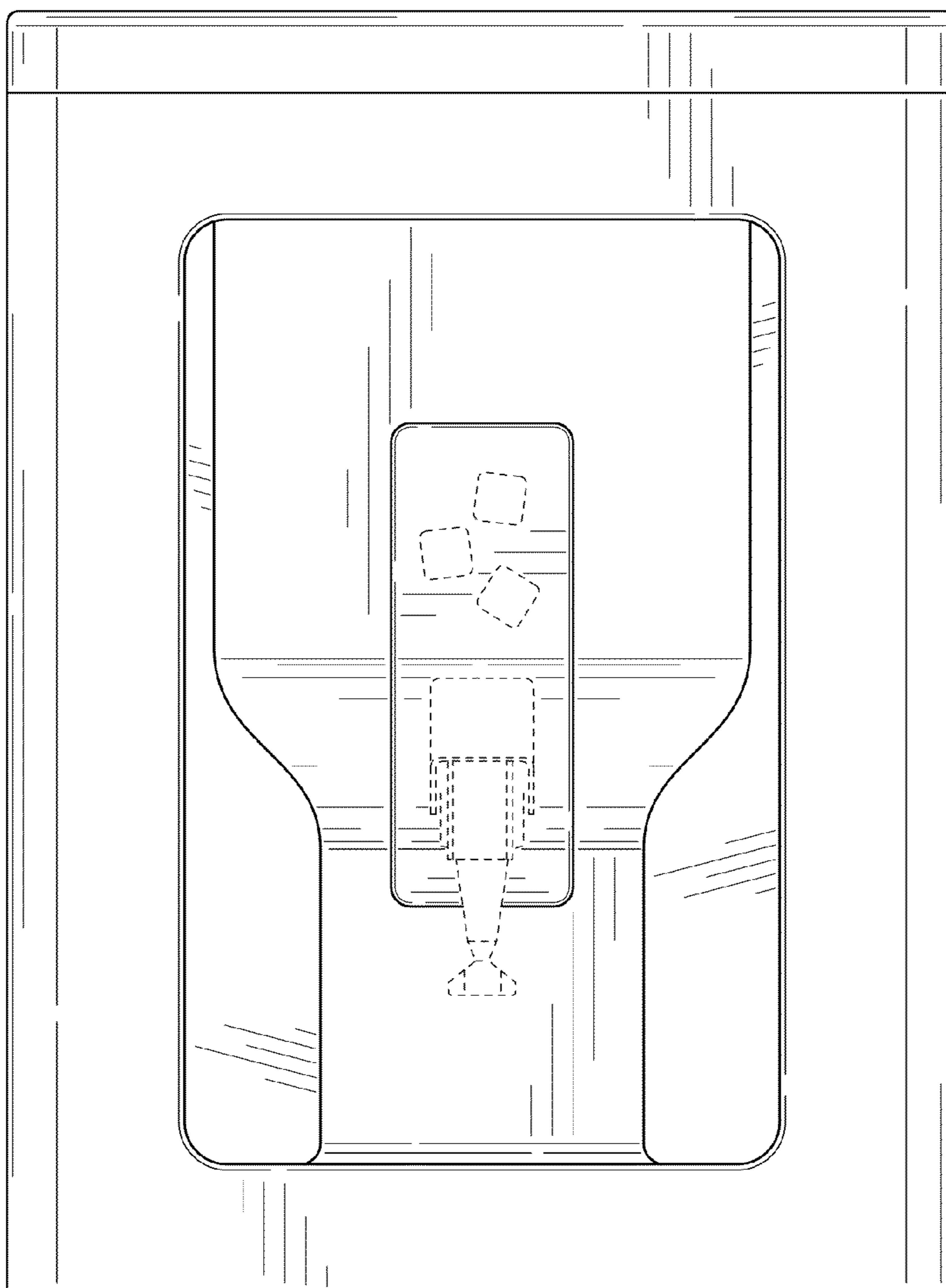

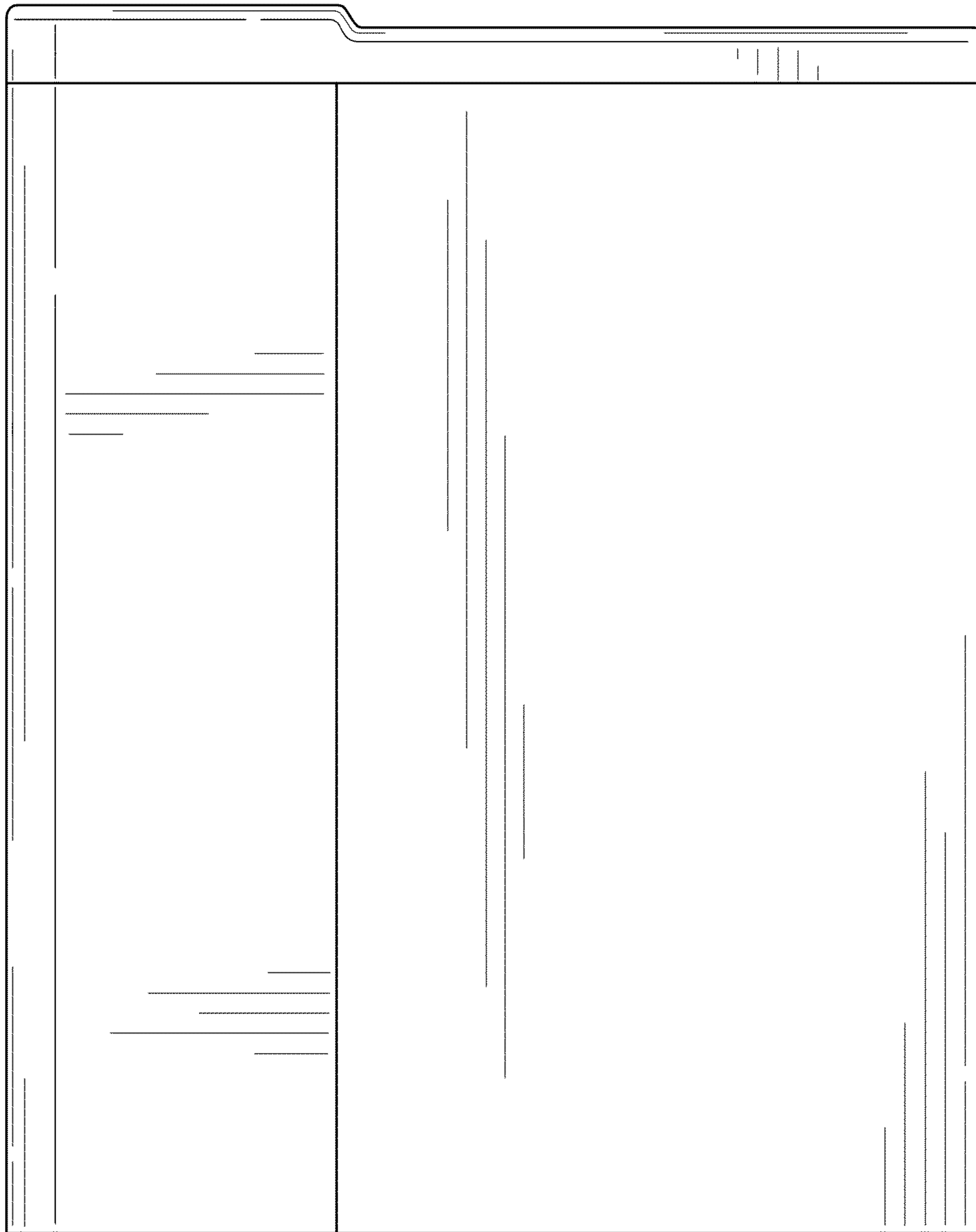

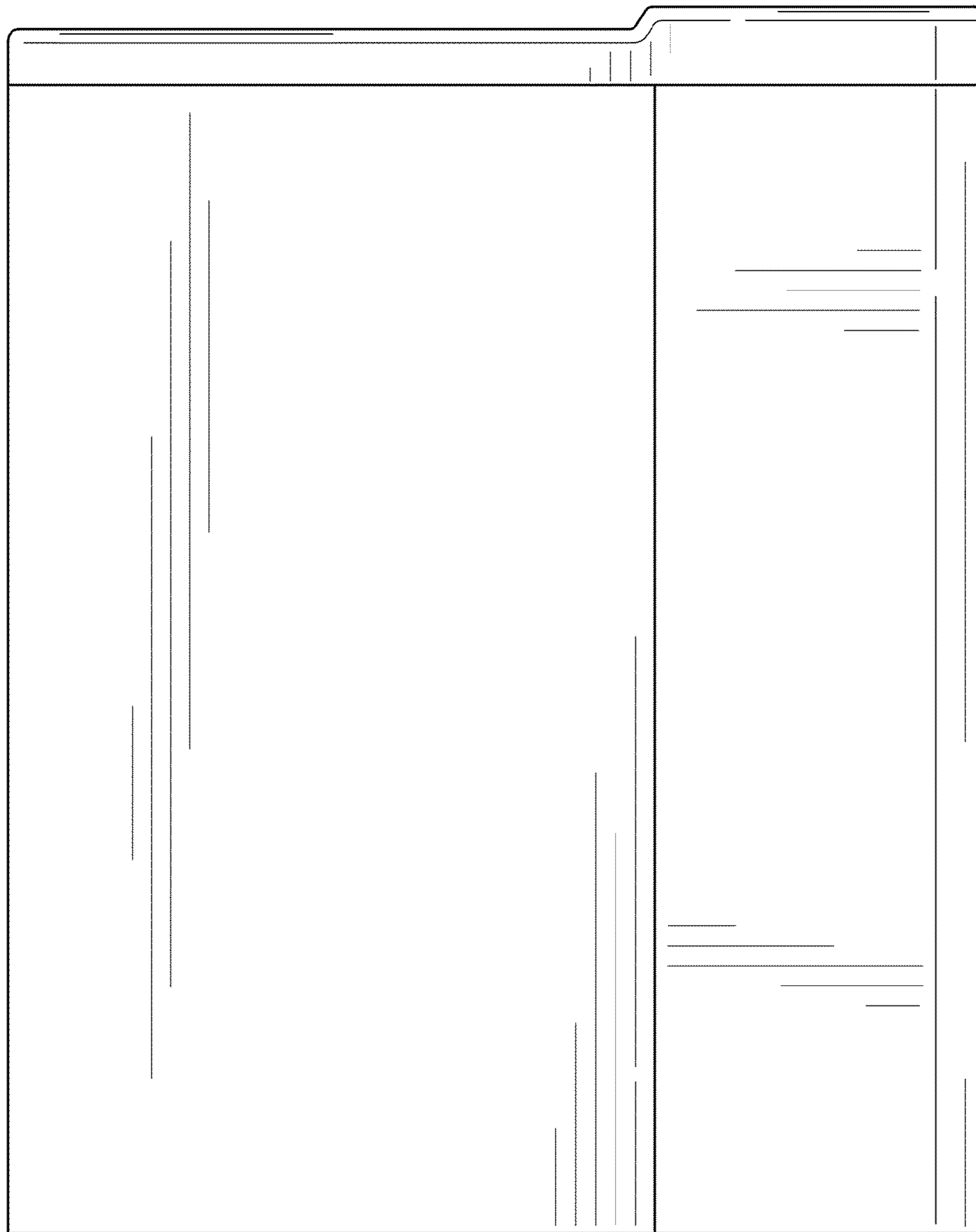

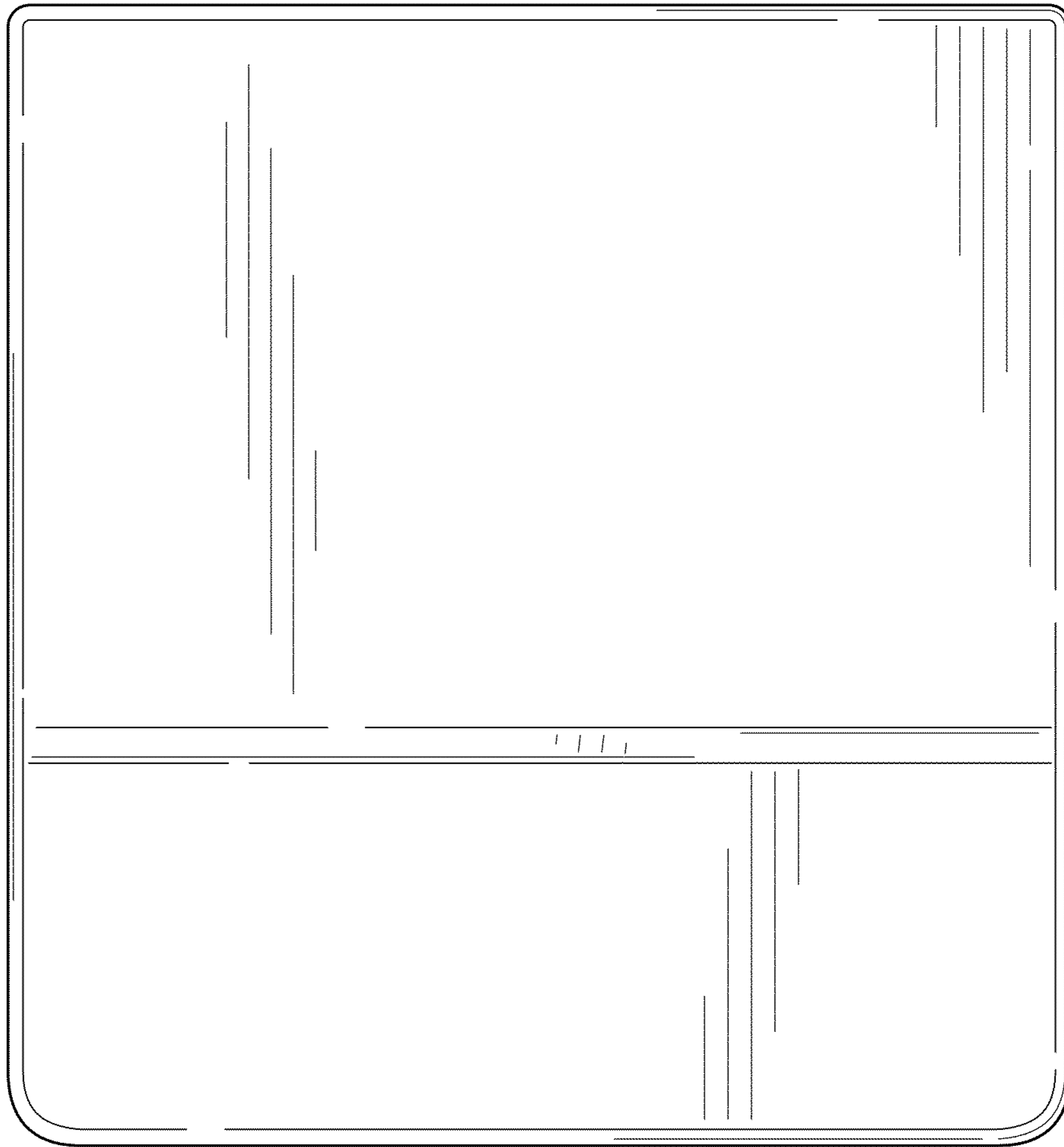
