FIG. 1 is a front perspective view of an electronic flash device showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is an enlarged view of FIG. 1;
FIG. 5 is an enlarged view of FIG. 2;
FIG. 6 is an enlarged view of FIG. 3;
FIG. 7 is a cross-sectional view taken along line 7-7 in FIG. 5 with the internal structure simplified; and,
FIG. 8 is a cross-sectional view taken along line 8-8 in FIG. 5 with the internal structure simplified.

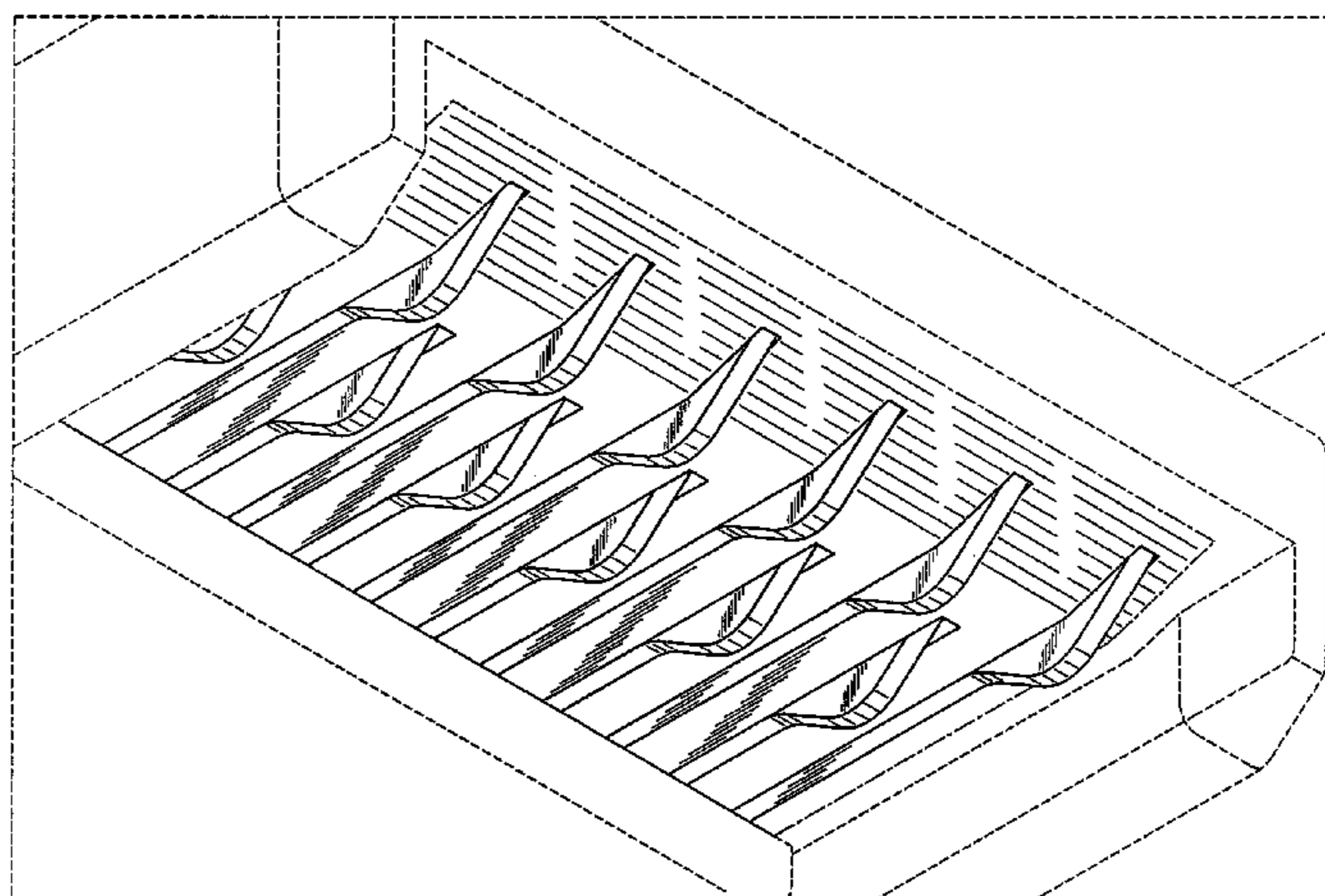
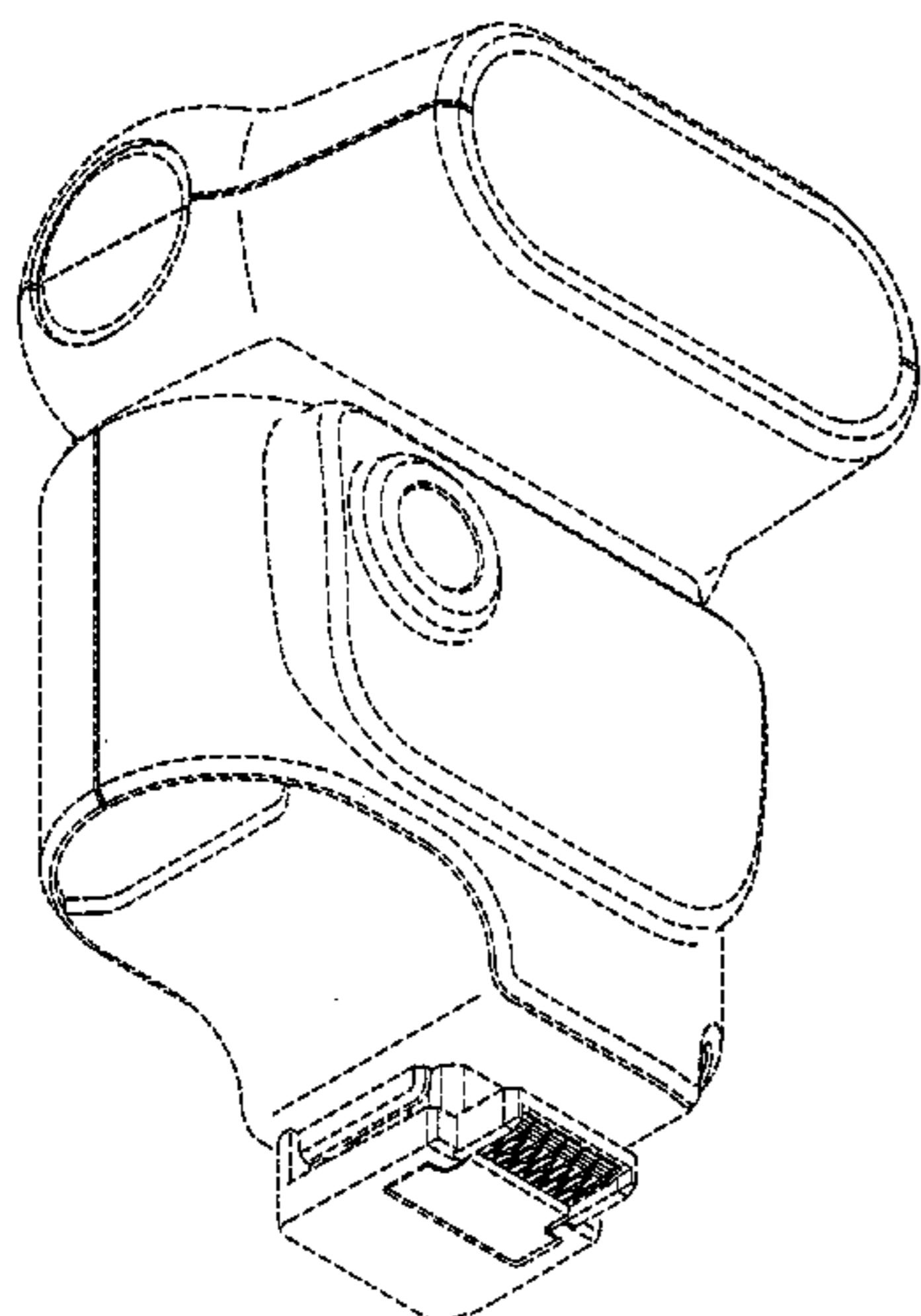

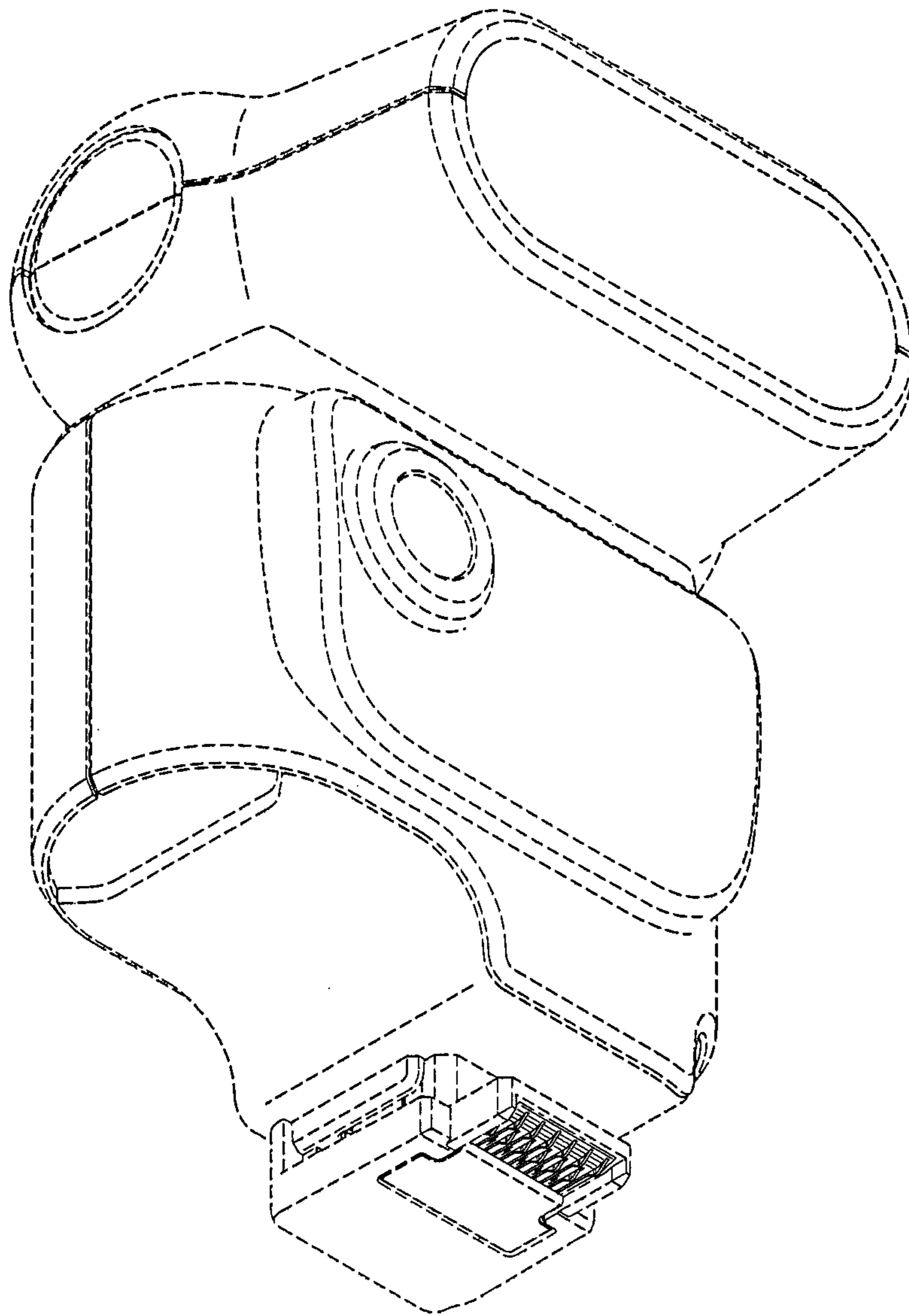

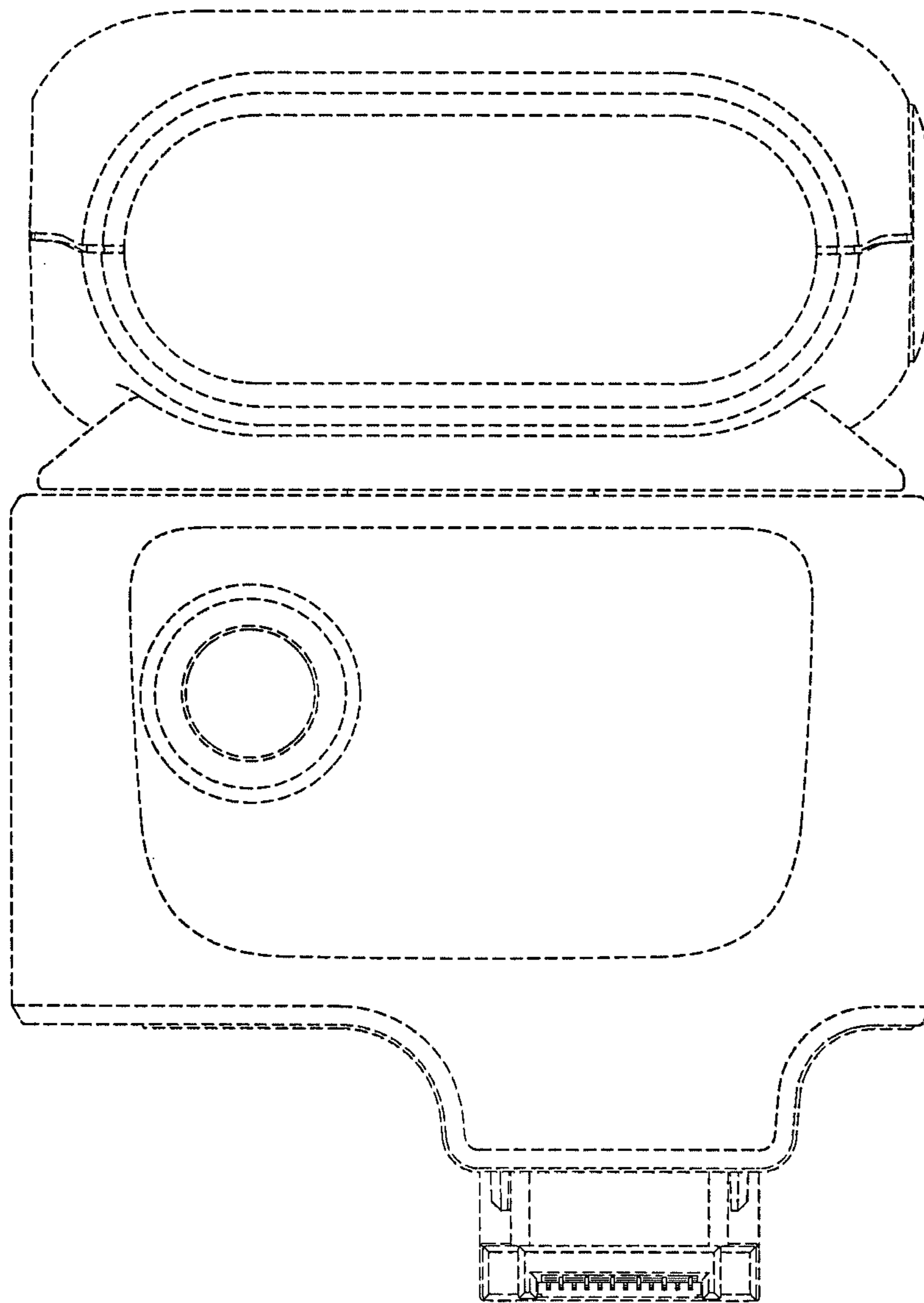

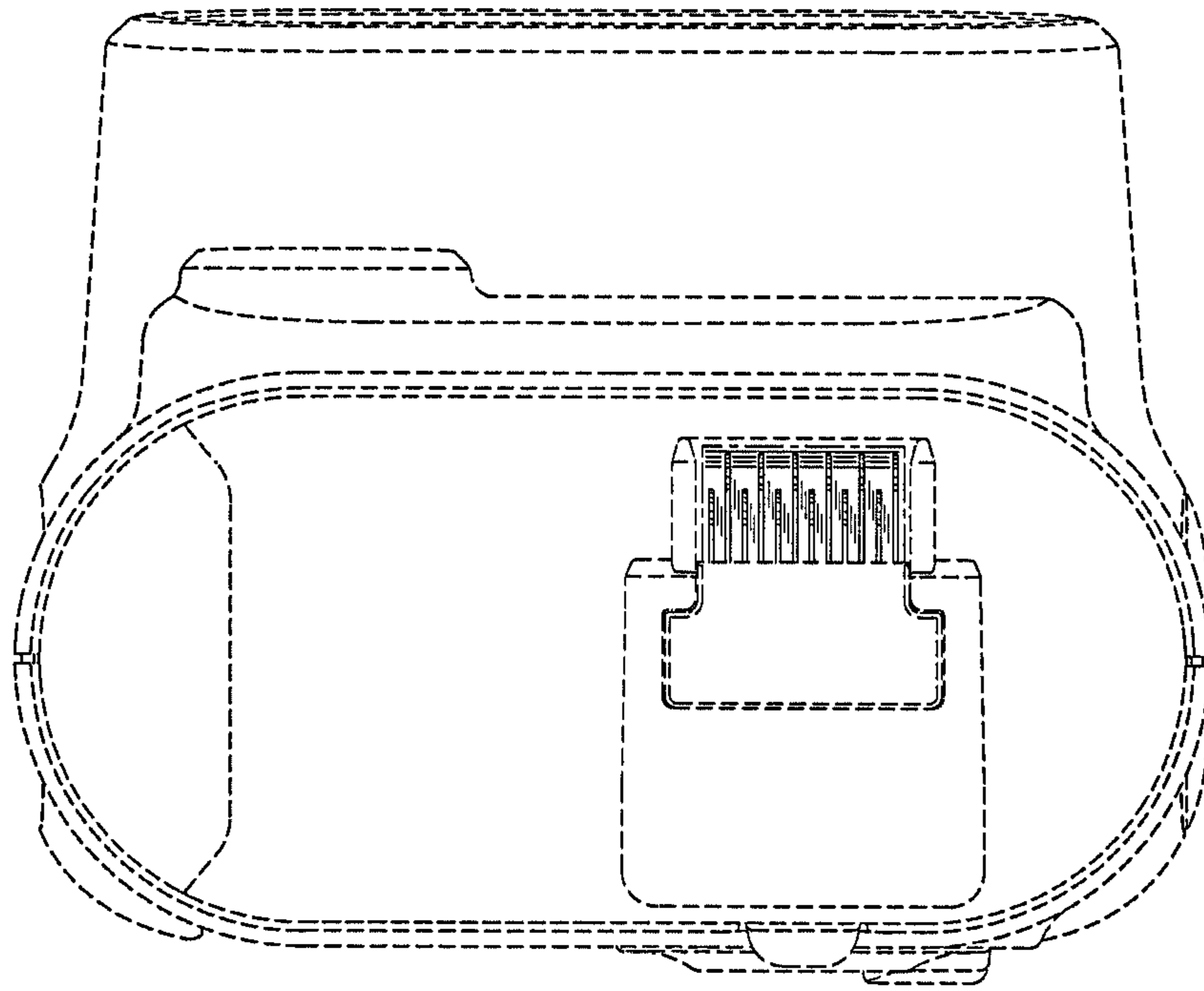

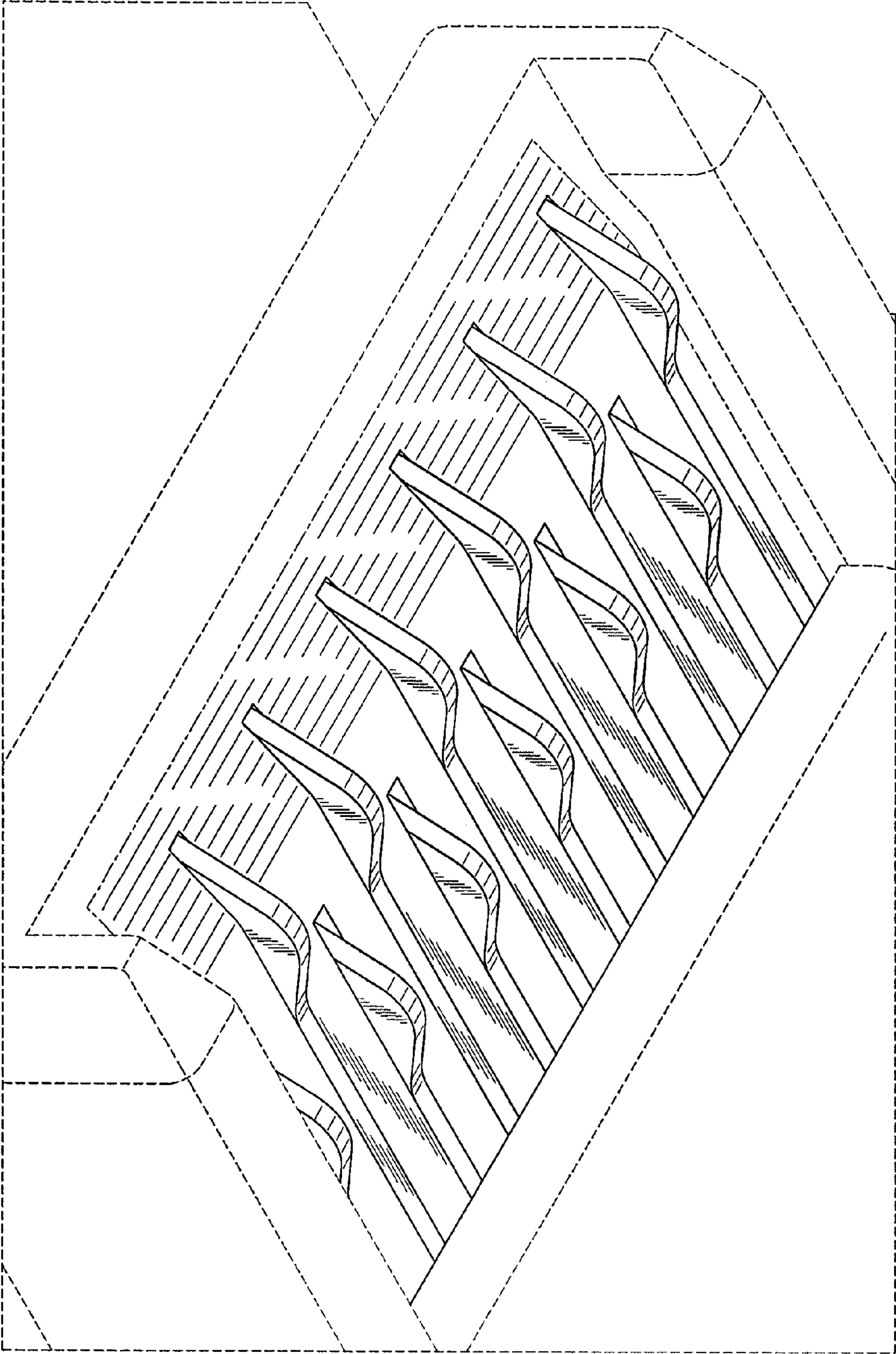
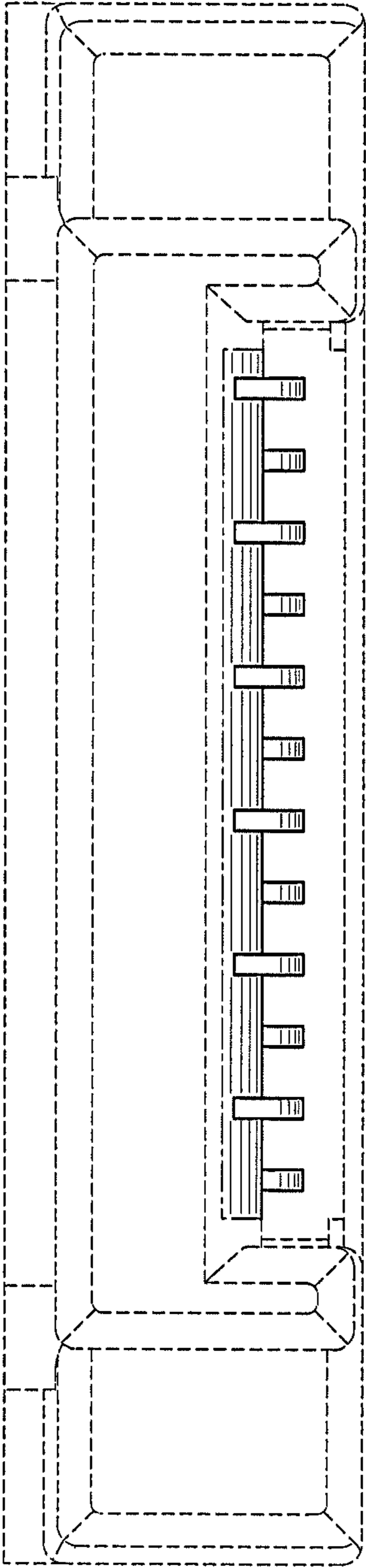

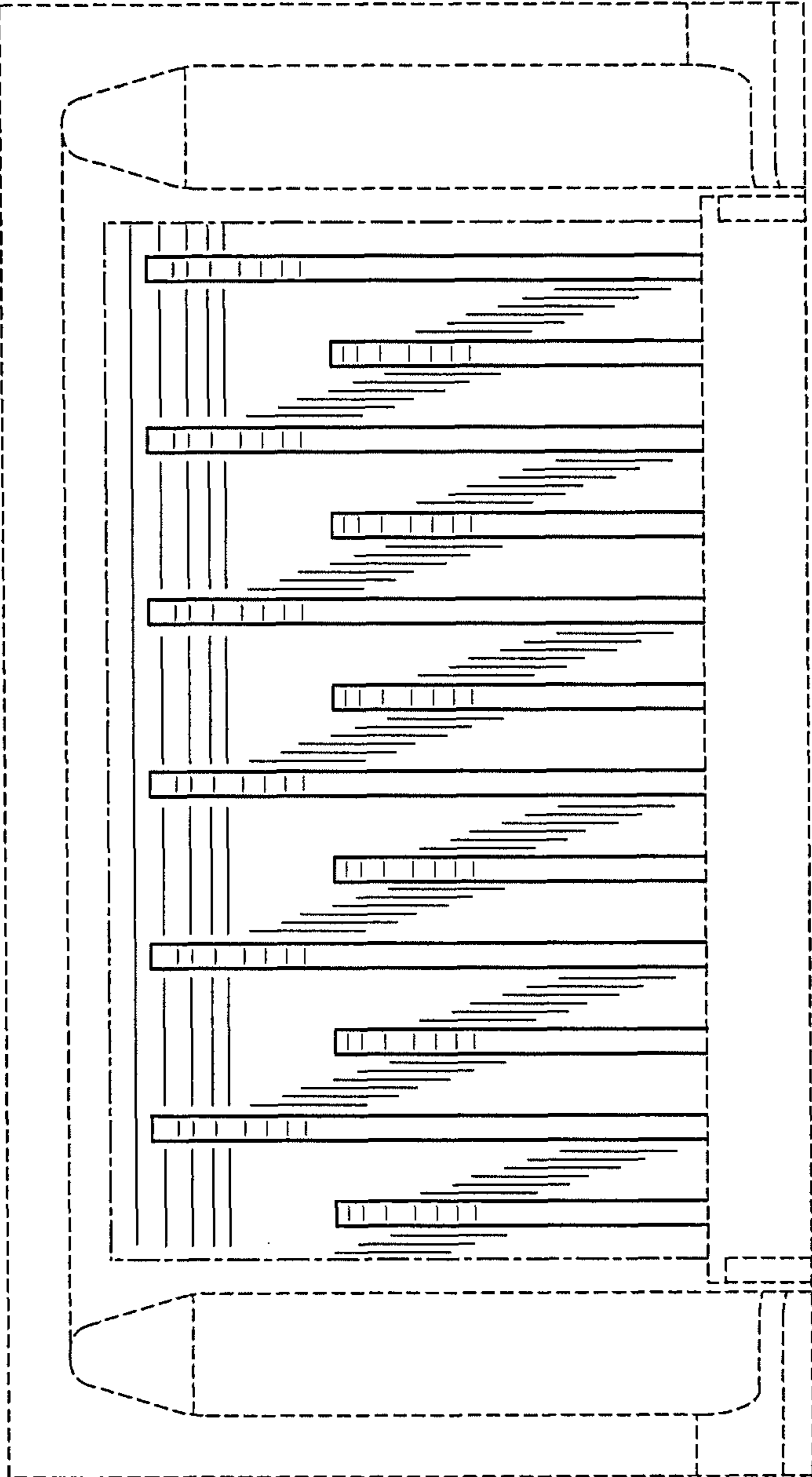

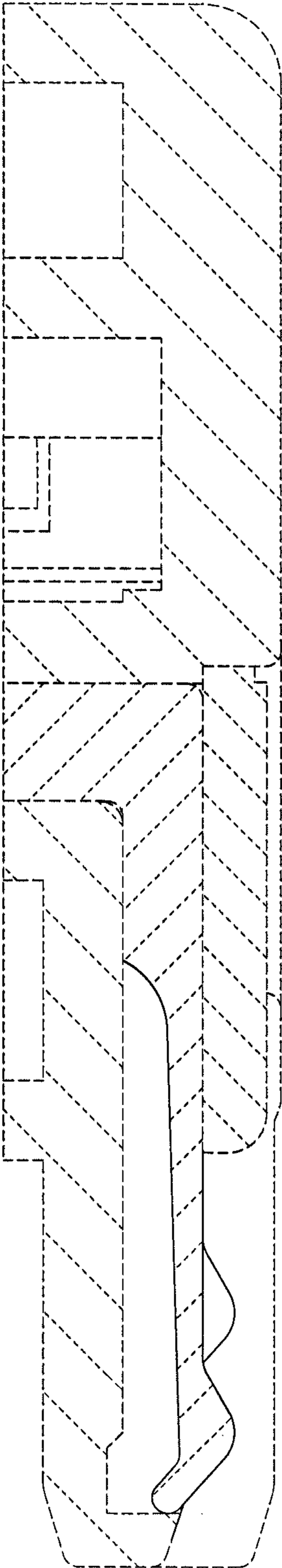
