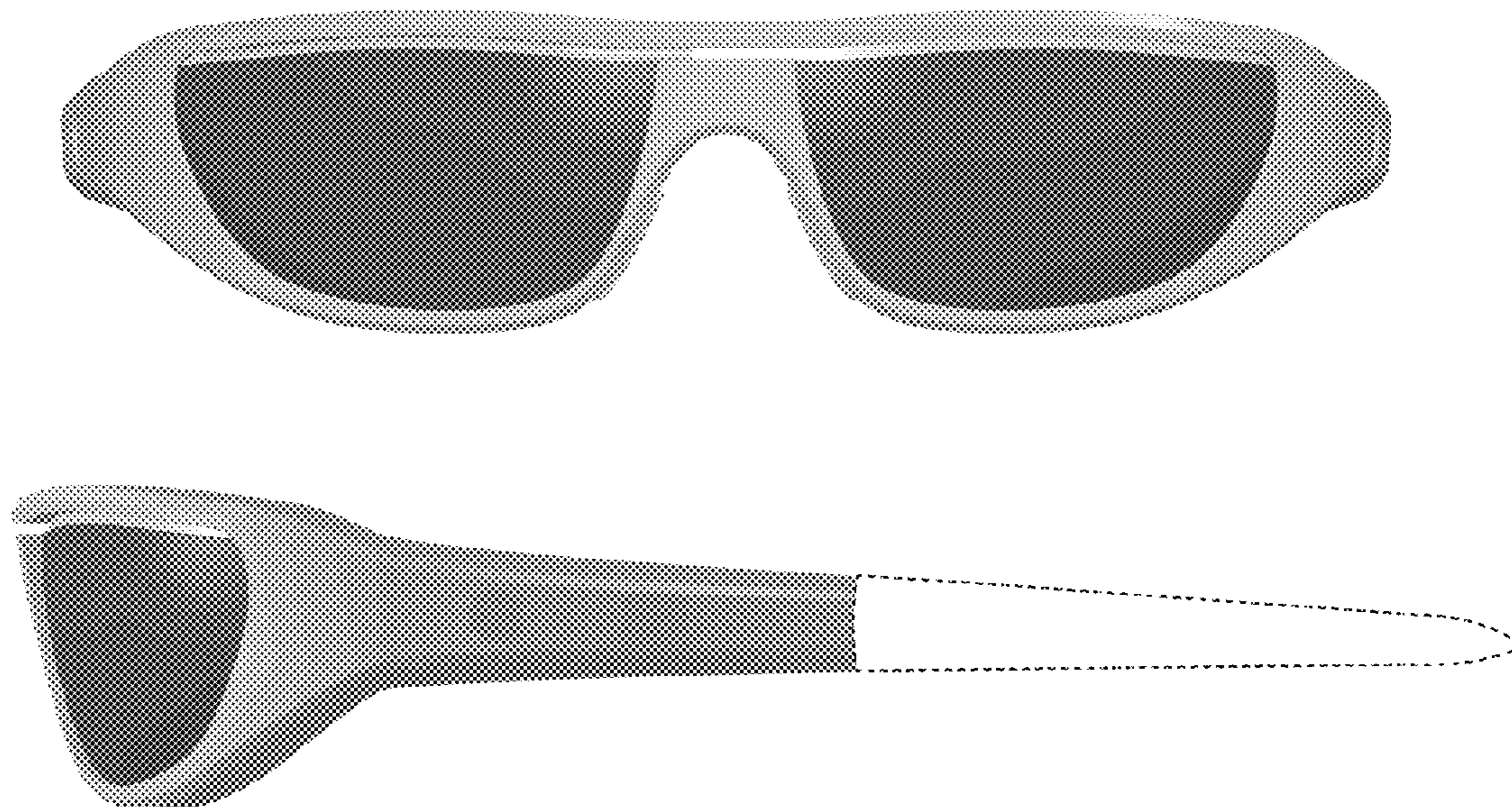
(57) **CLAIM**

The ornamental design of the eyeglasses, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the eyeglasses design.  
FIG. 2 is a top view of the eyeglasses design.  
FIG. 3 is a right view of the eyeglasses design, the left view being a mirror image thereof.  
FIG. 4 is a bottom view of the eyeglasses design.  
FIG. 5 is a rear view of the eyeglasses design; and,  
FIG. 6 is an isometric view of the eyeglasses design showing the front, top and right sides thereof.  
The regions shown within dashed lines show portions of the eyeglasses that form no part of the claimed design.  
No claim to particular colors or relative shades of the shading shown in the figures is made herein.

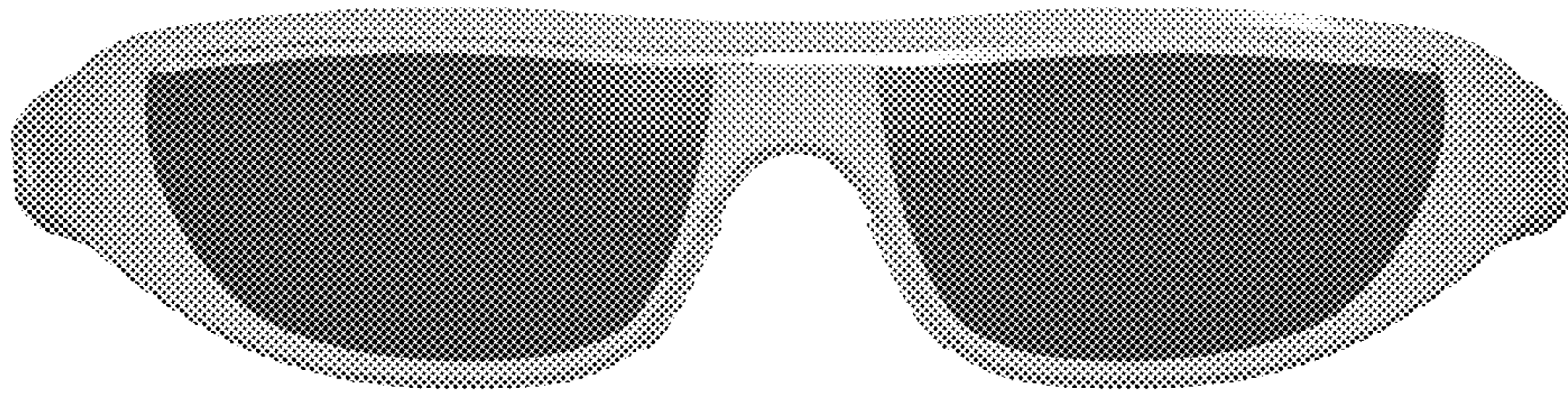

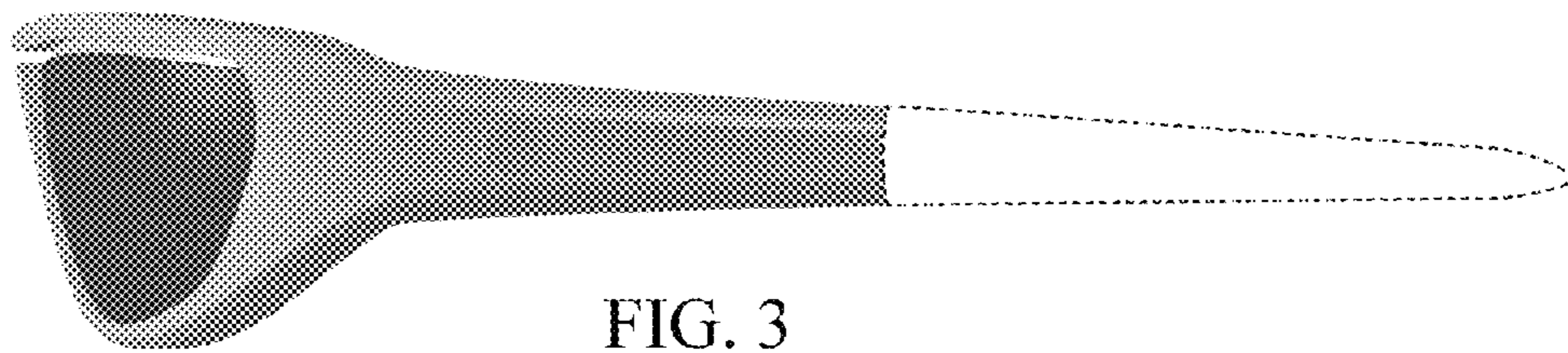

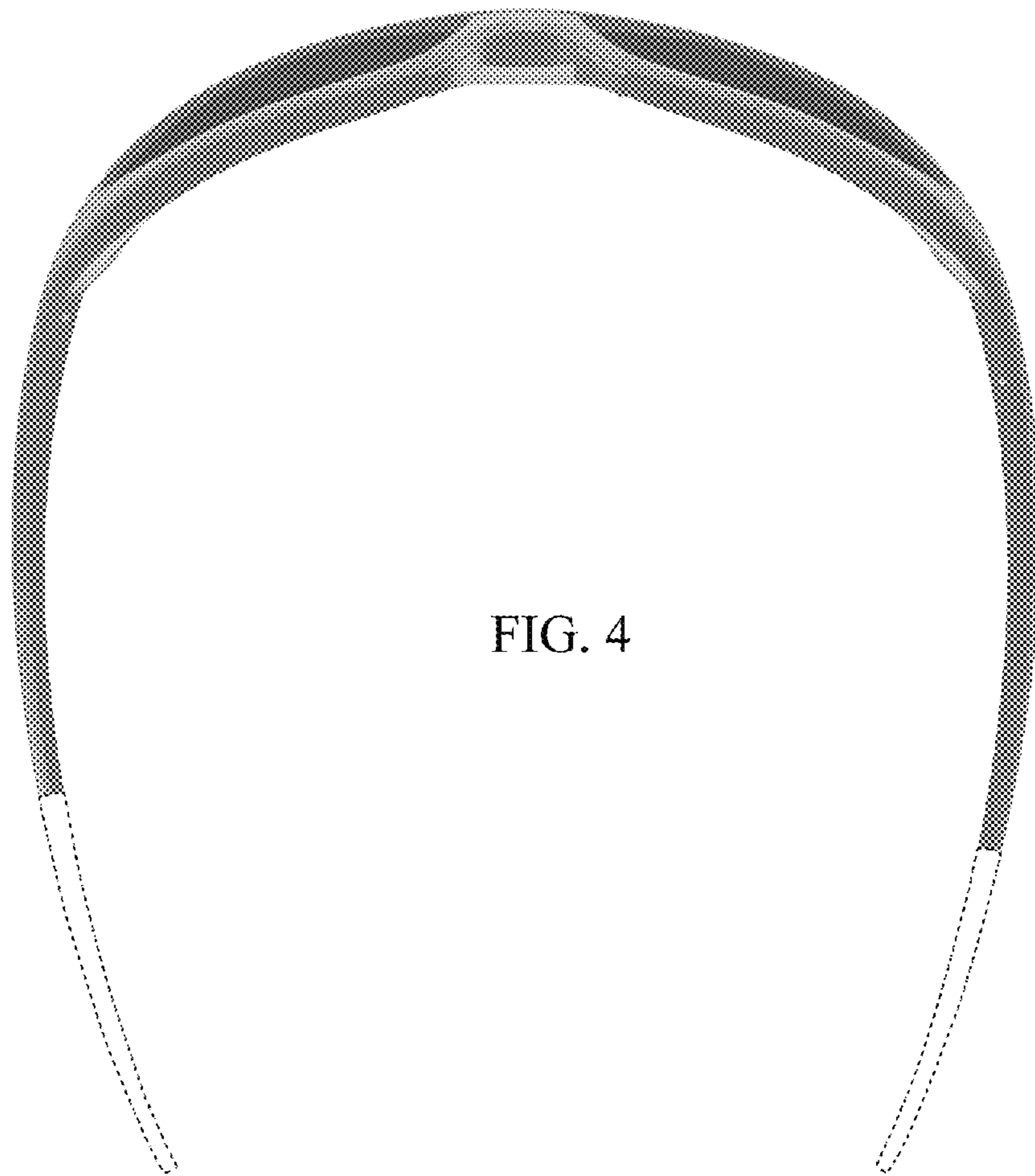

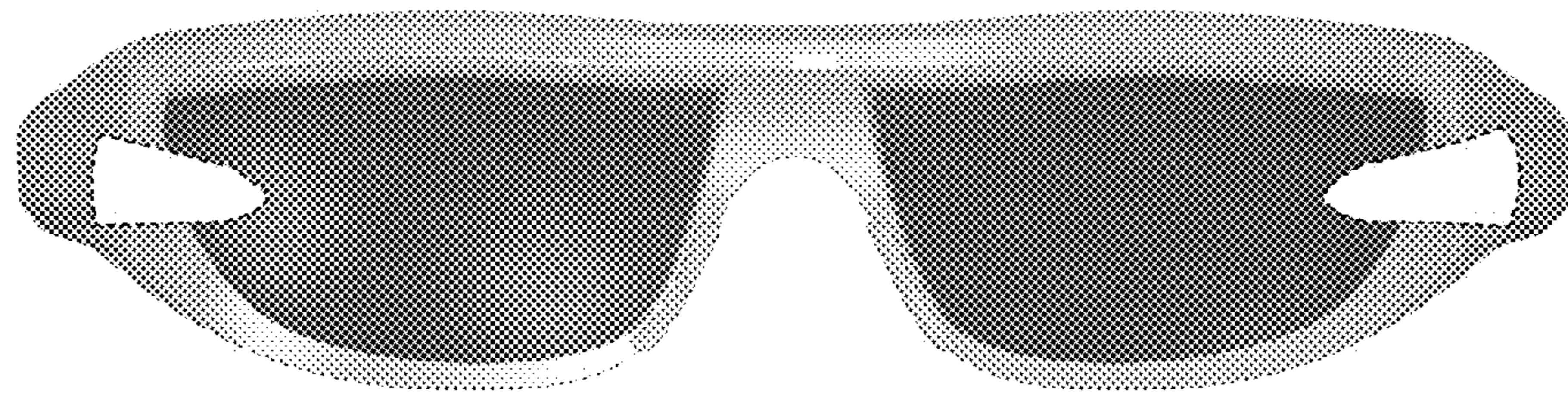

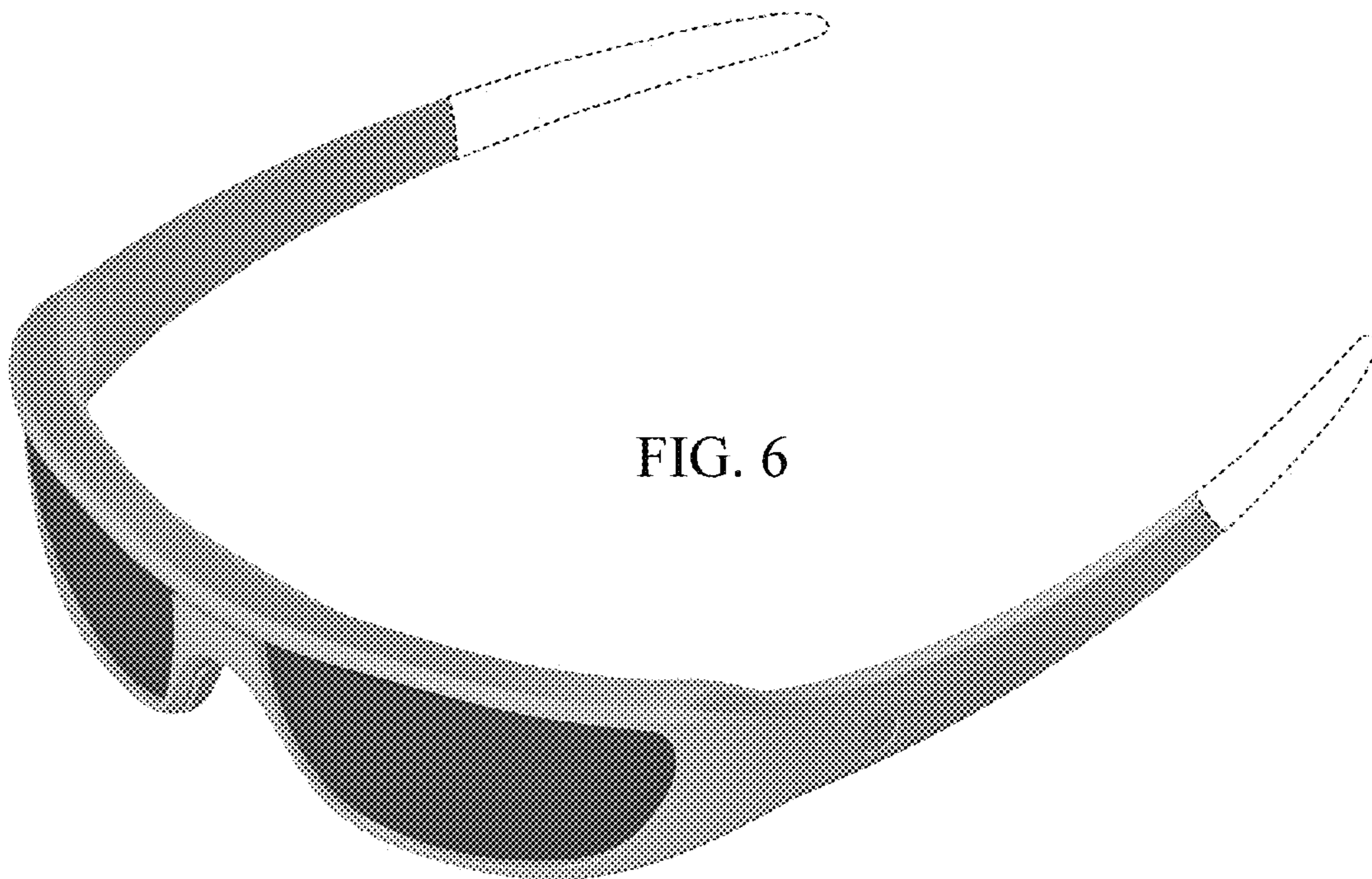
