DESCRIPTION

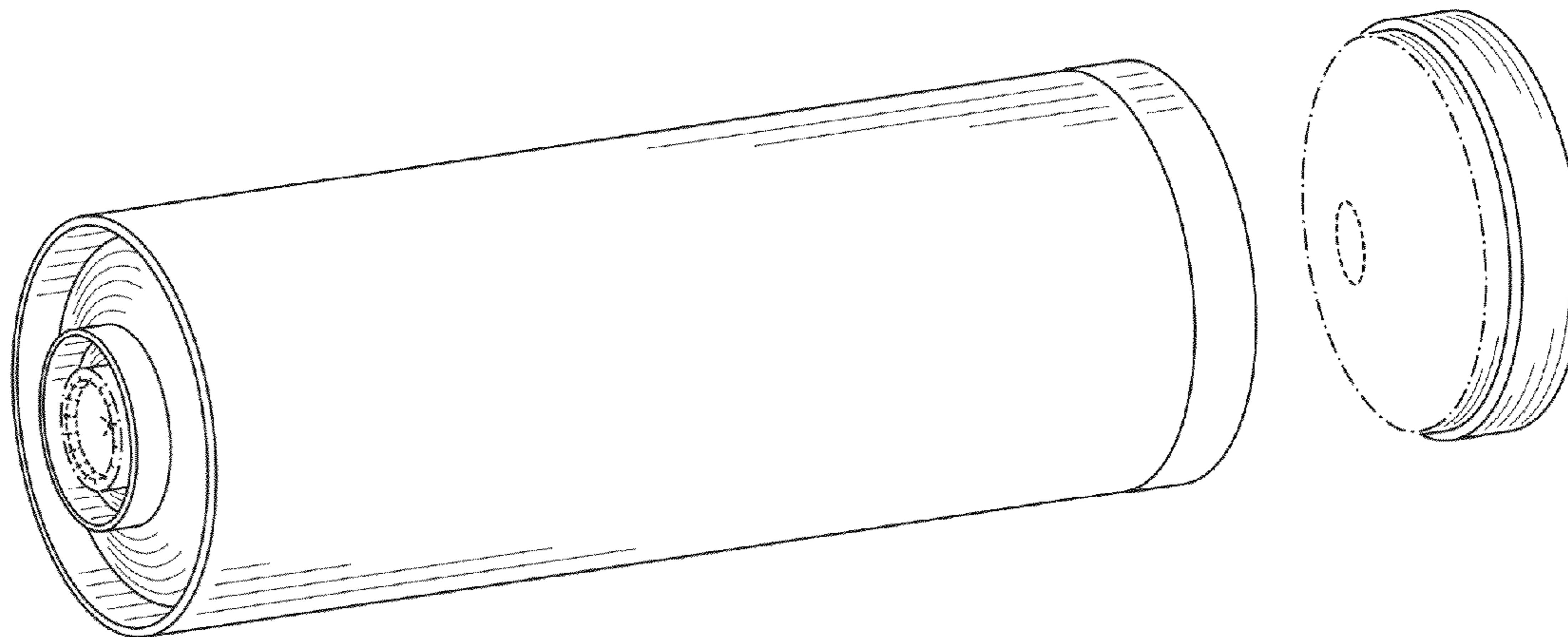
FIG. 1 is a front, top perspective view of a cartridge for ink showing my new design, wherein selected unclaimed detail is omitted for clarity;

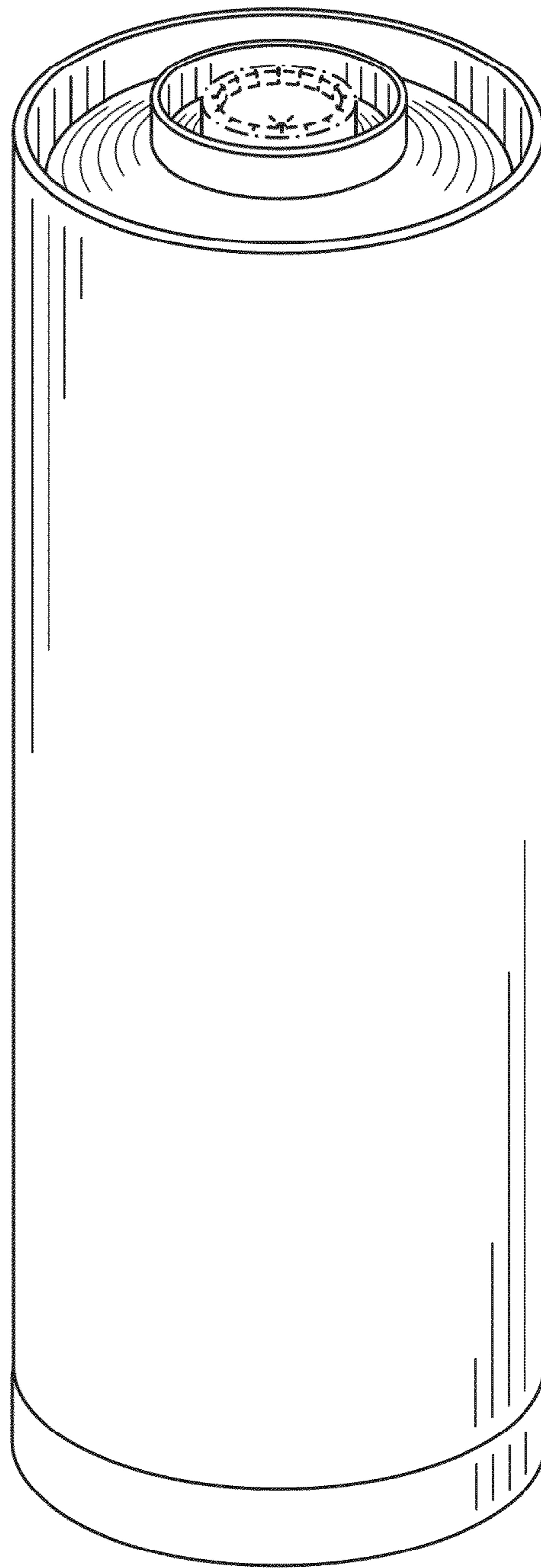

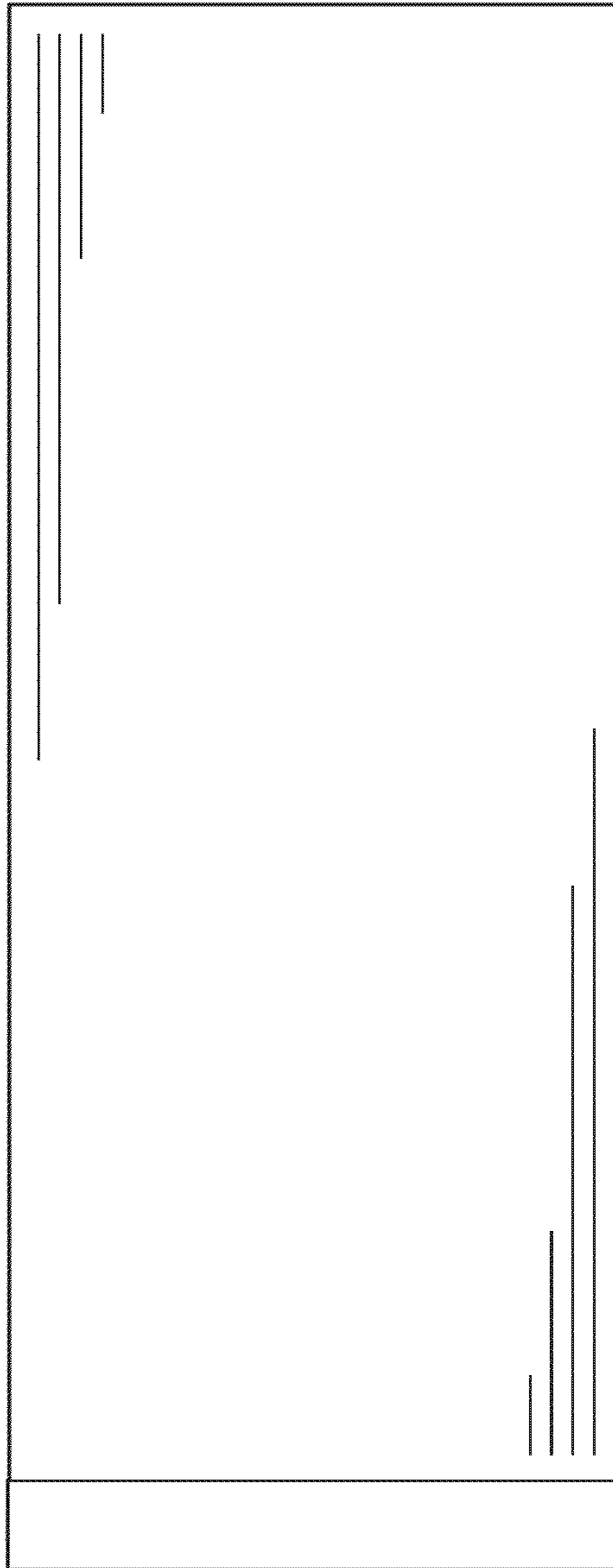

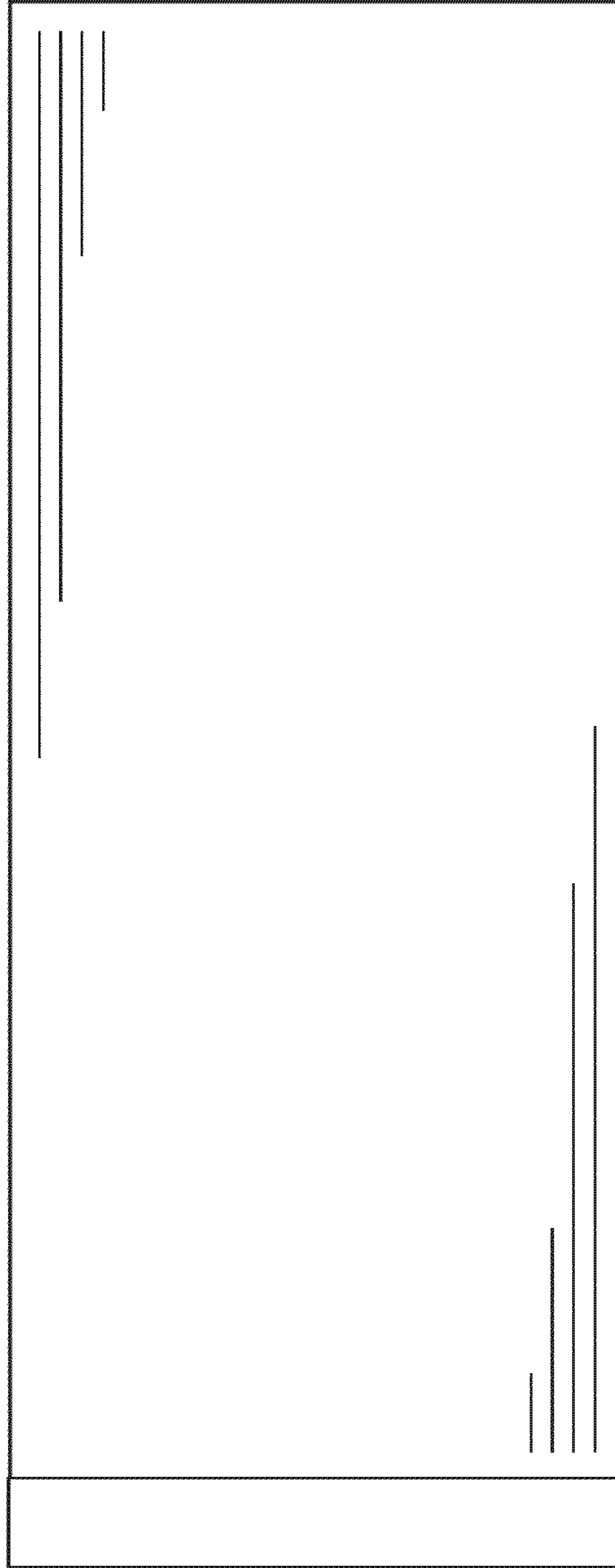

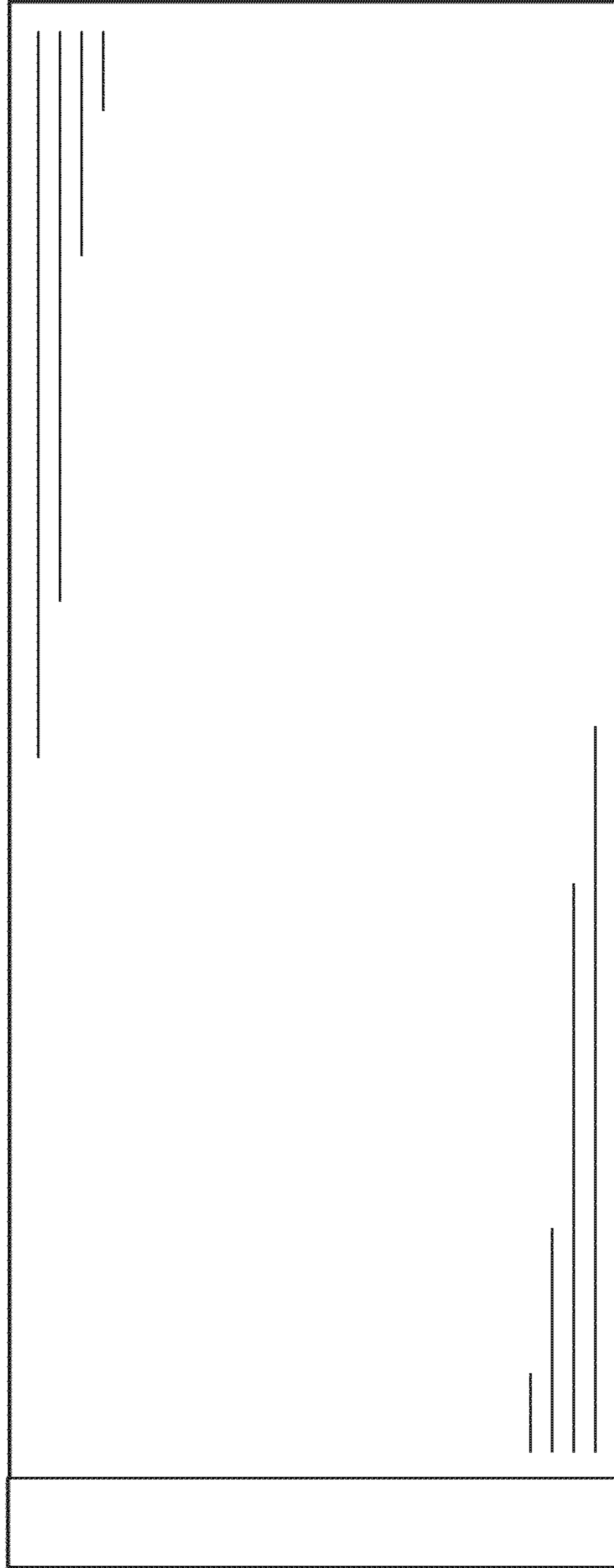

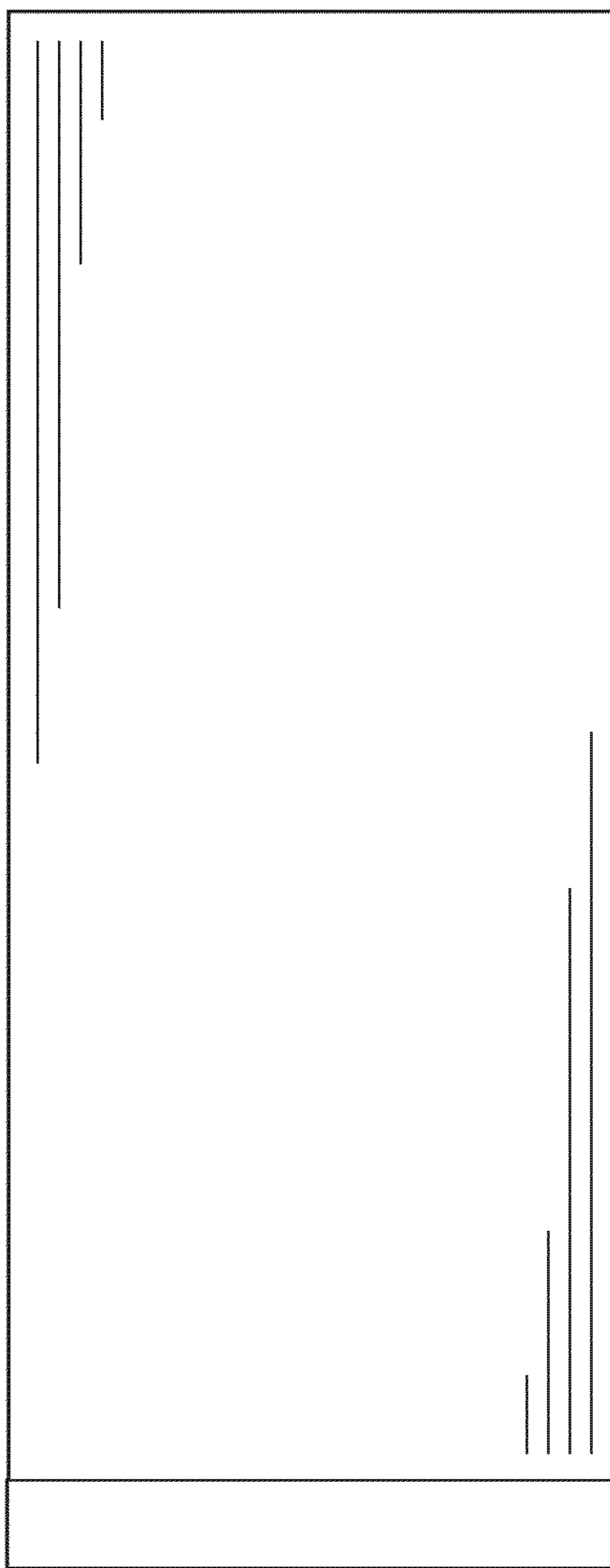

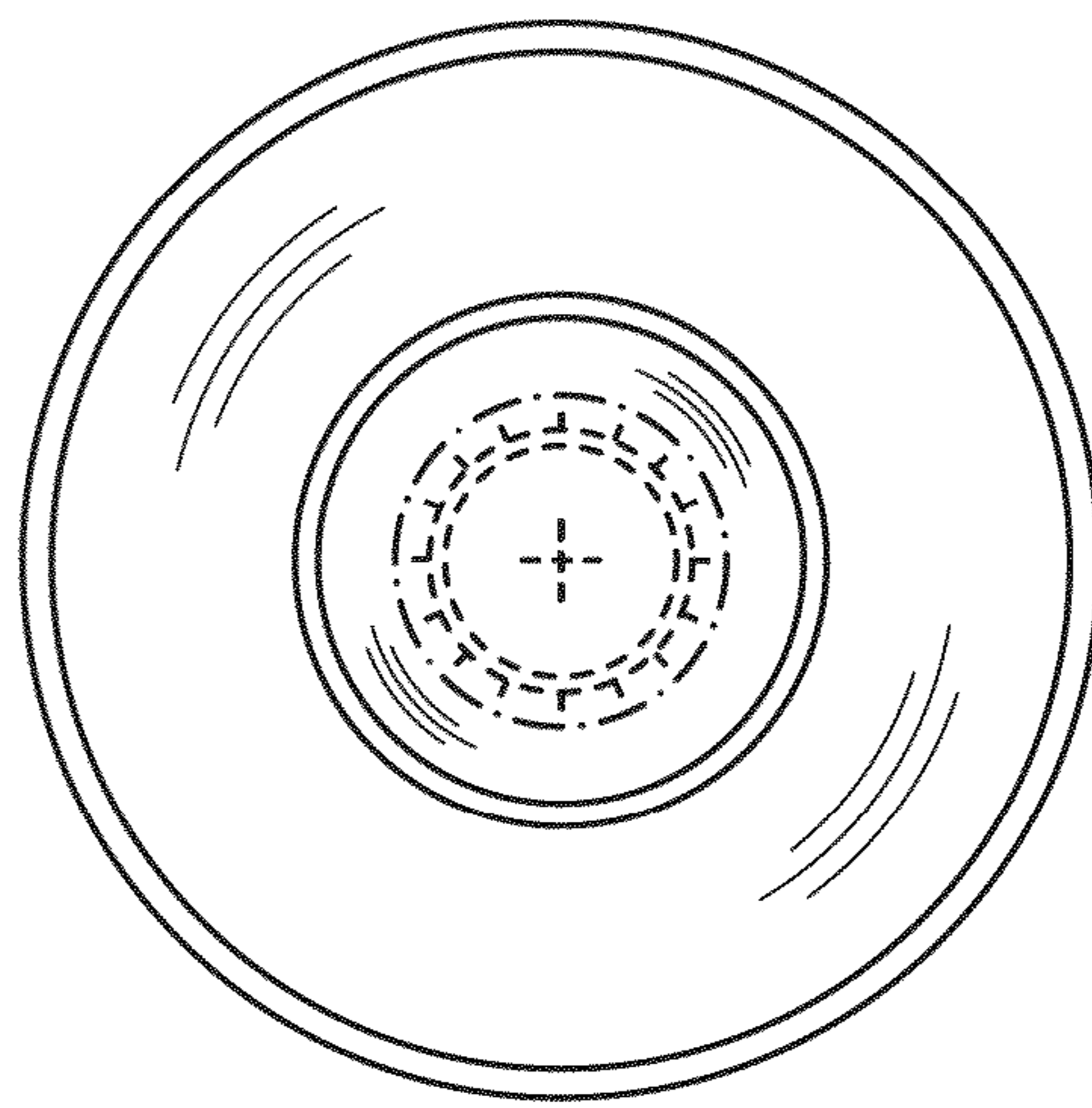

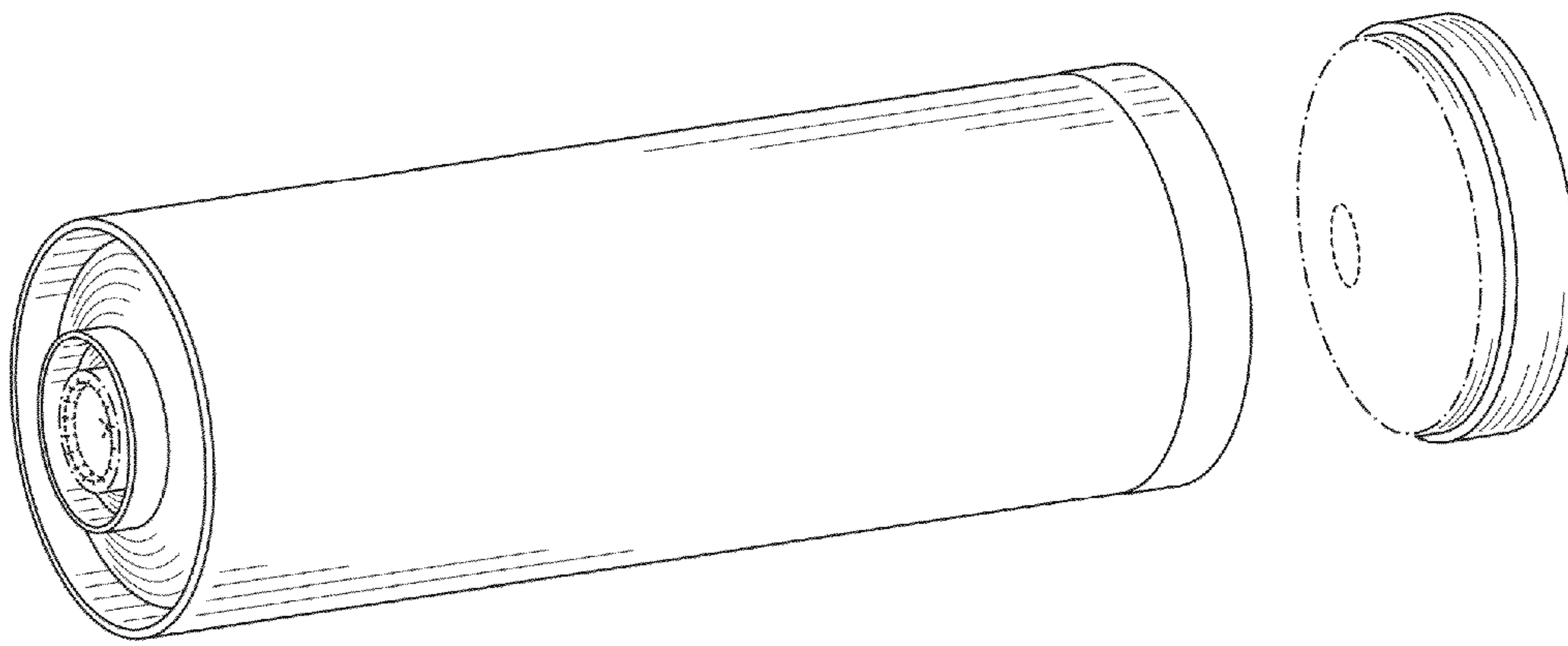

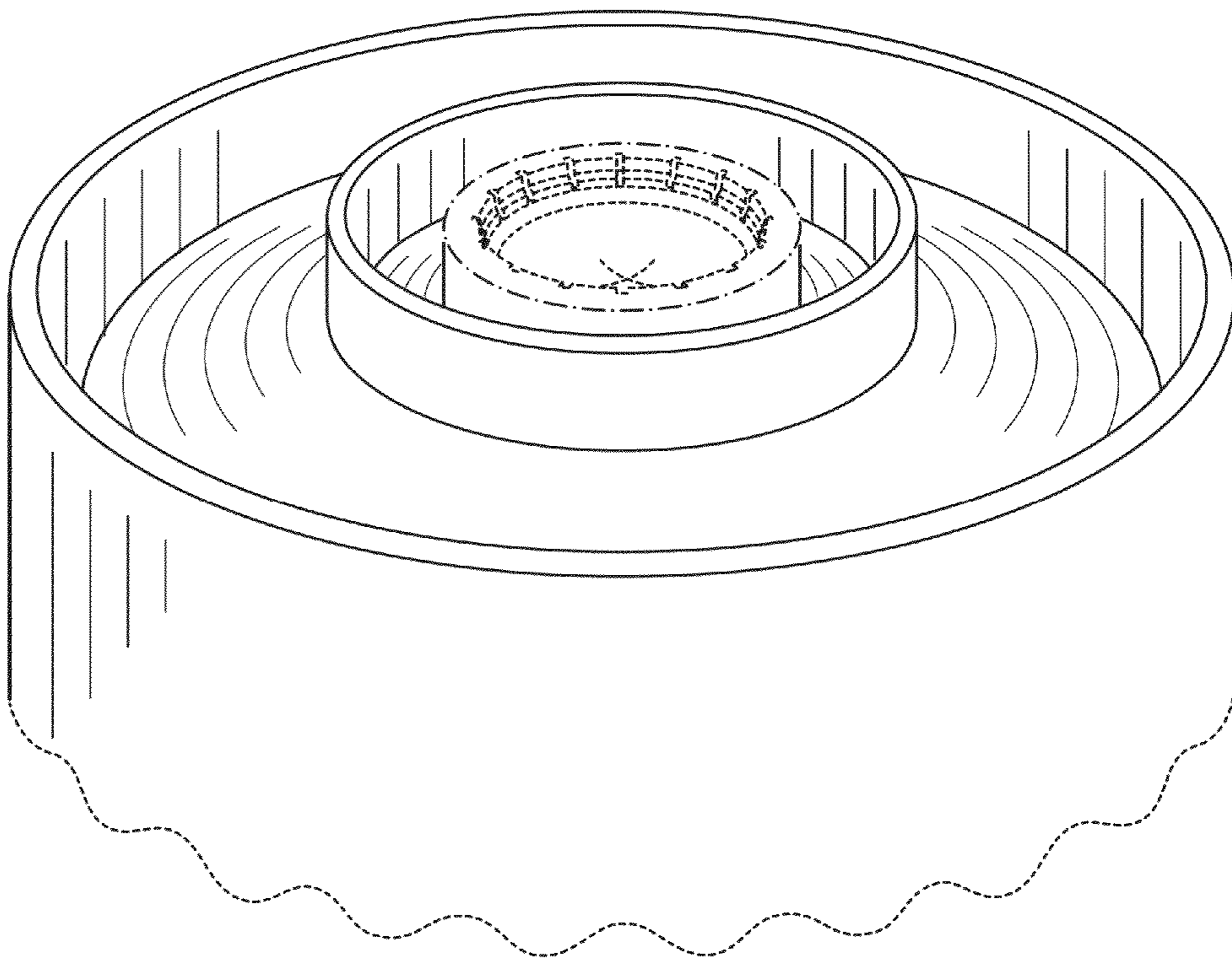
