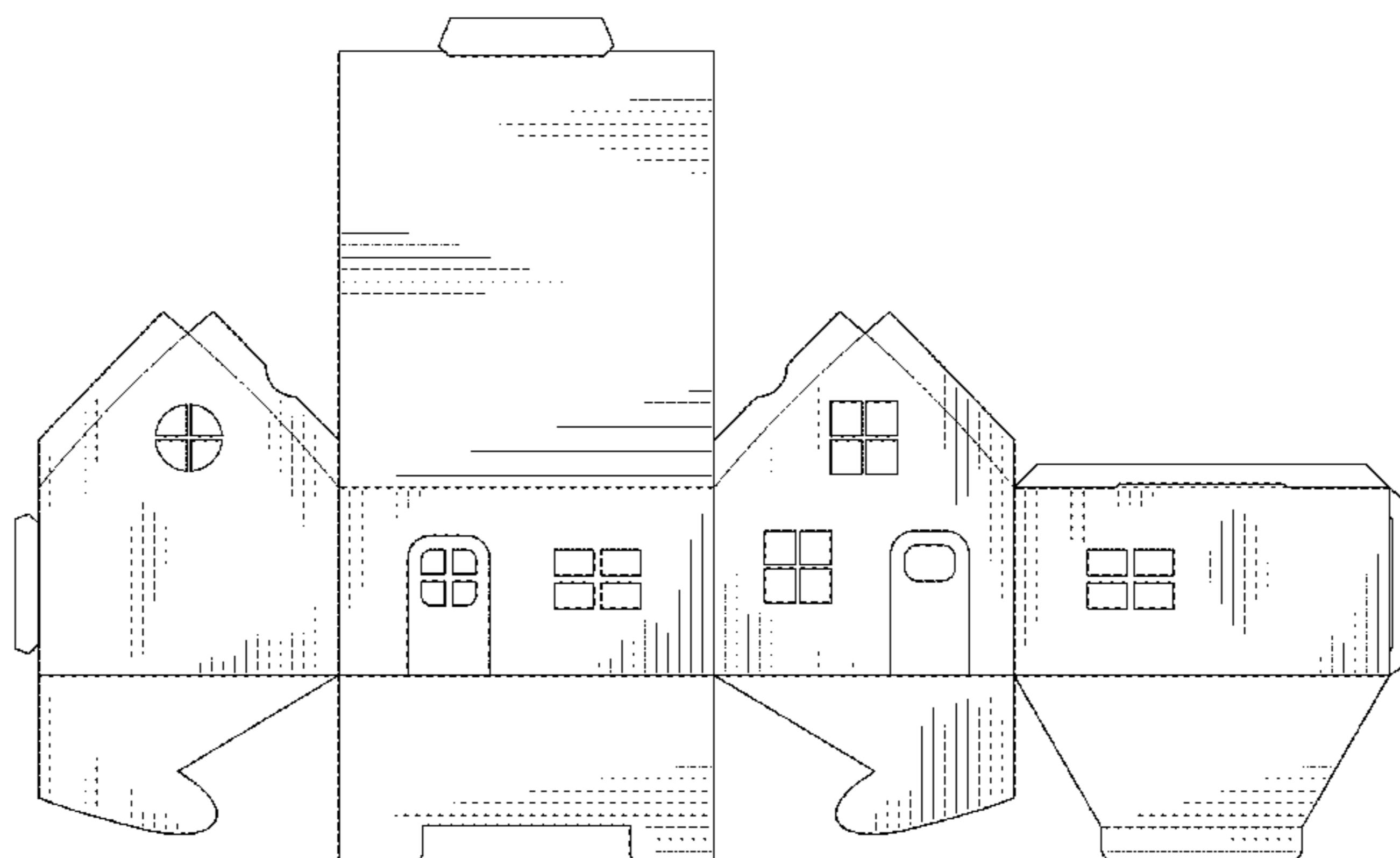
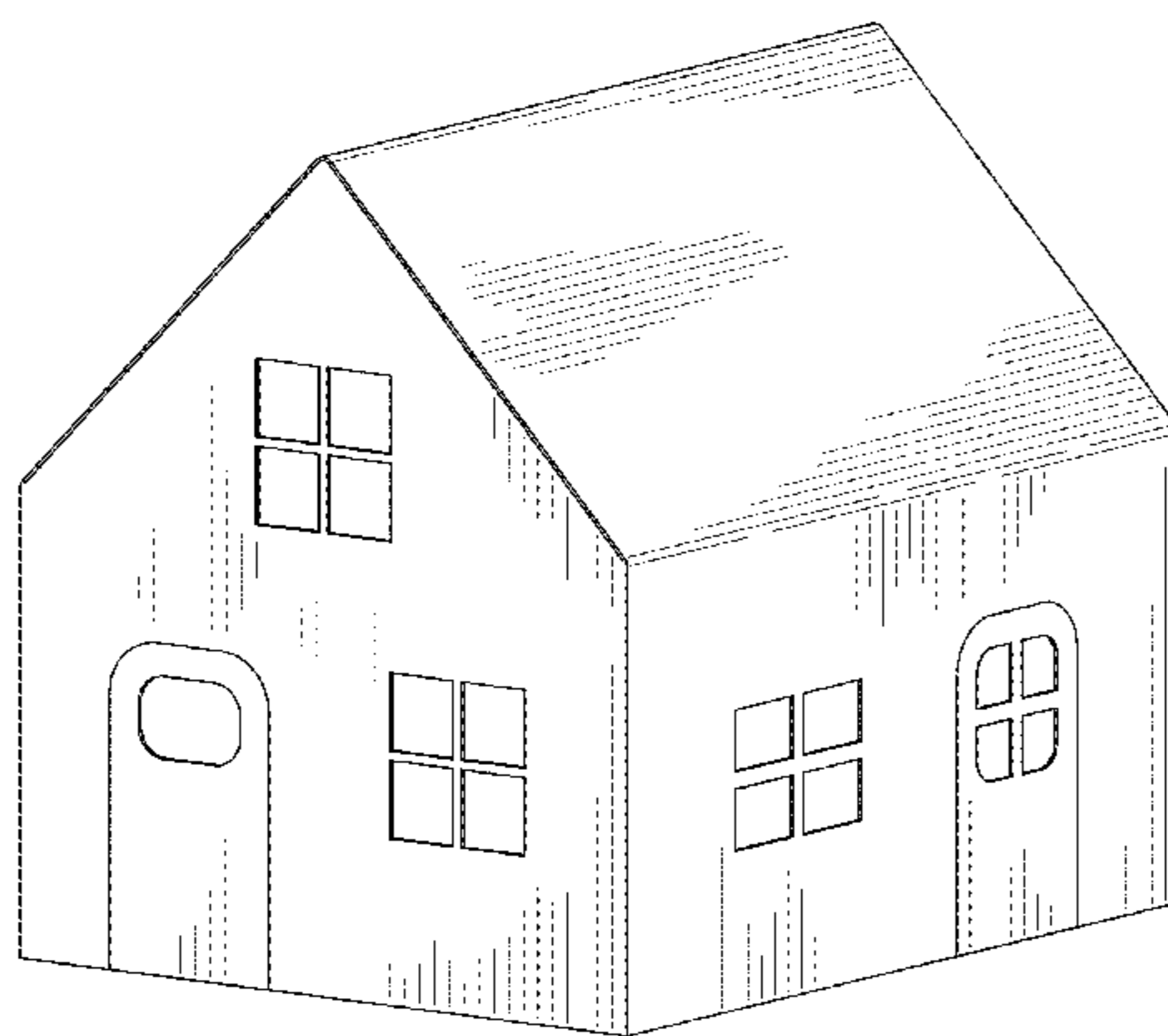
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a foldable house, showing my new design.

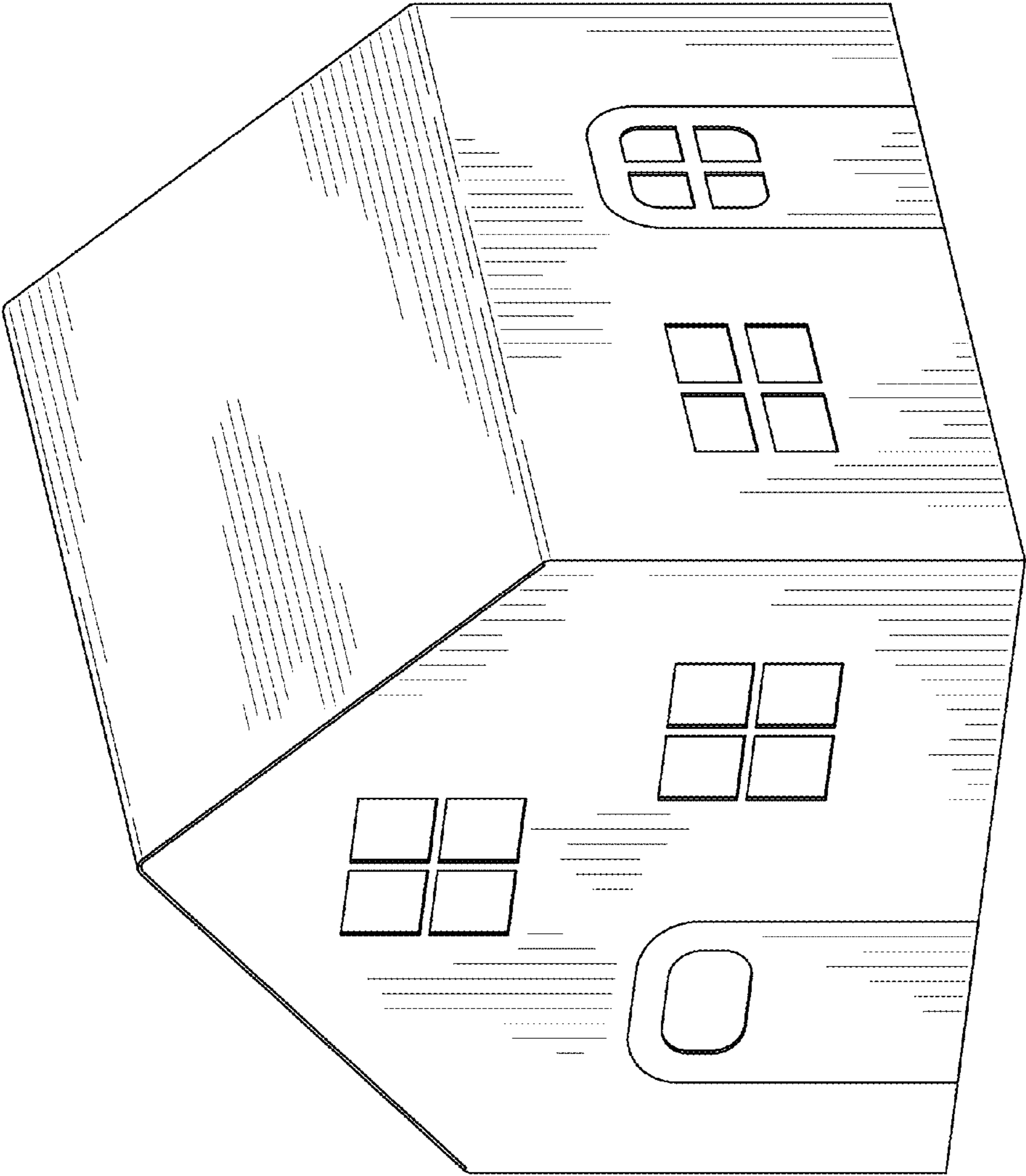

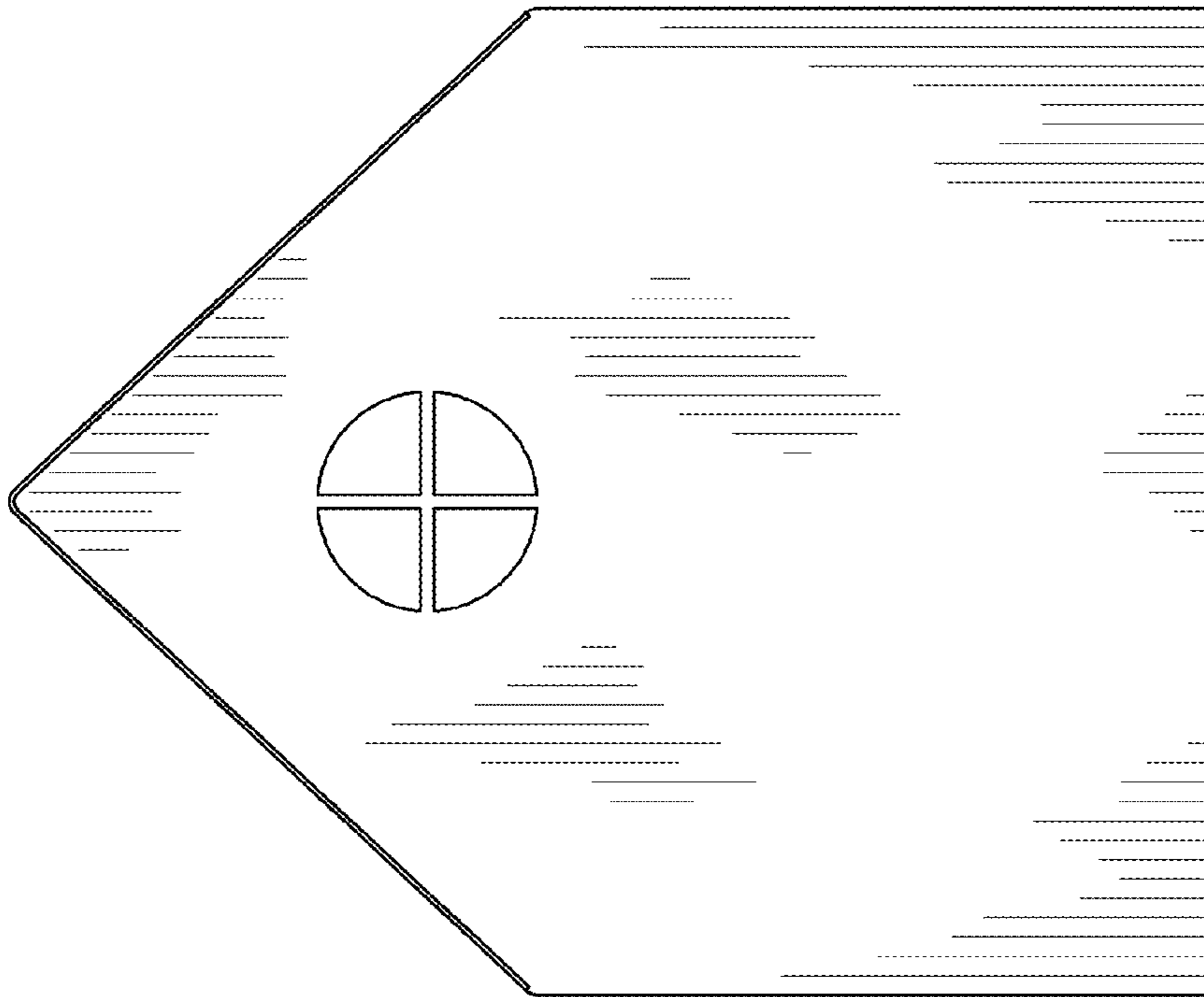

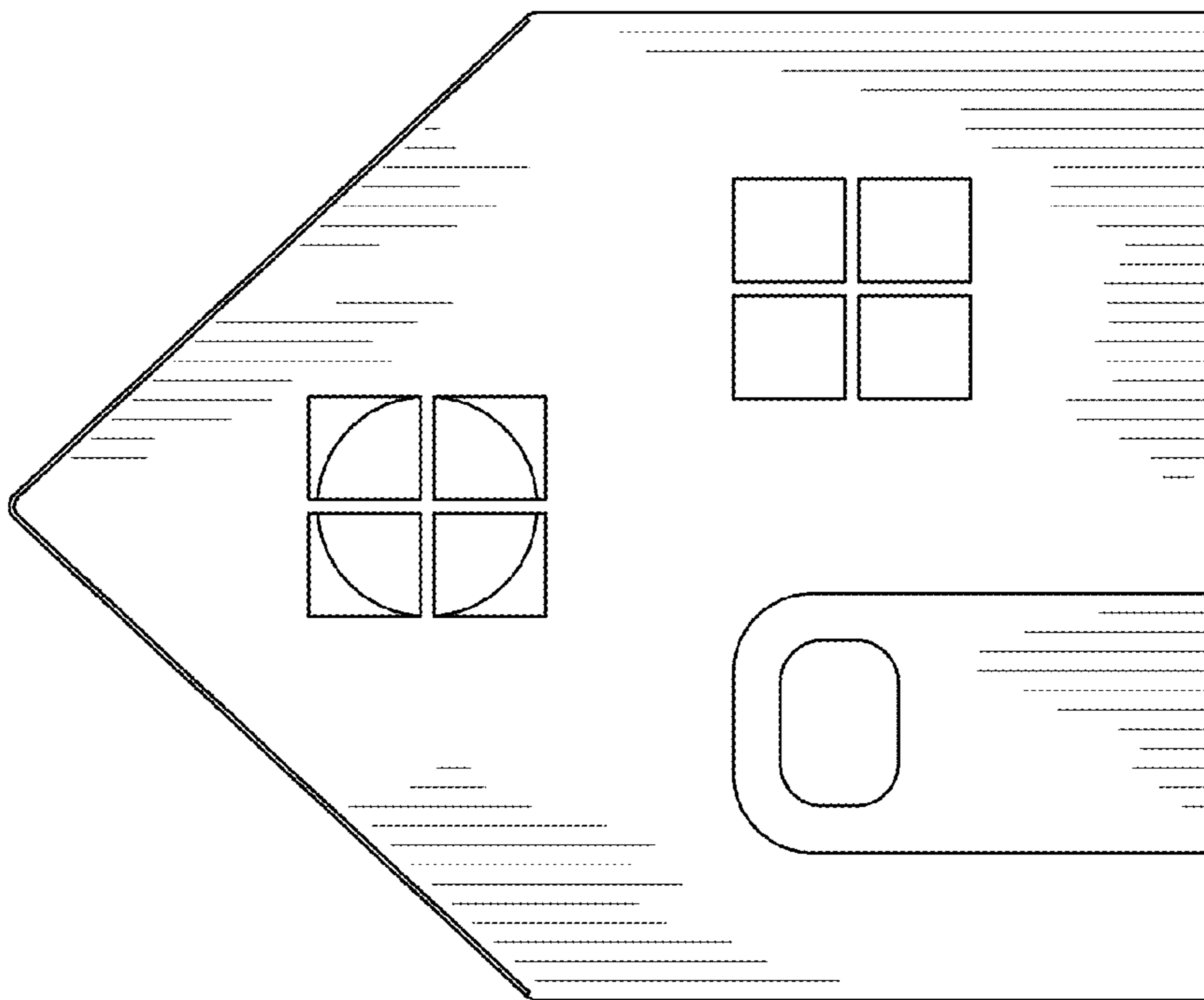

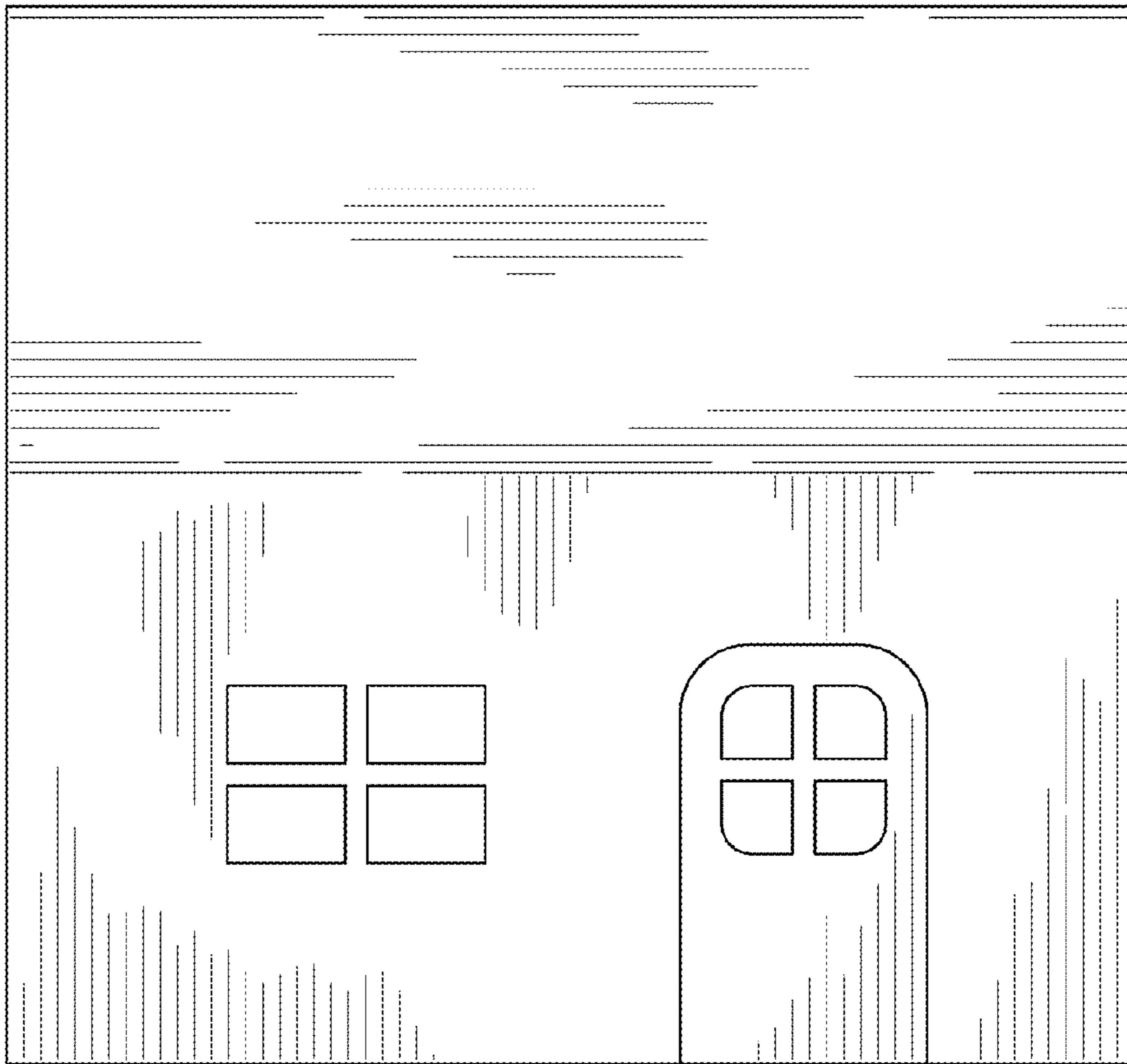

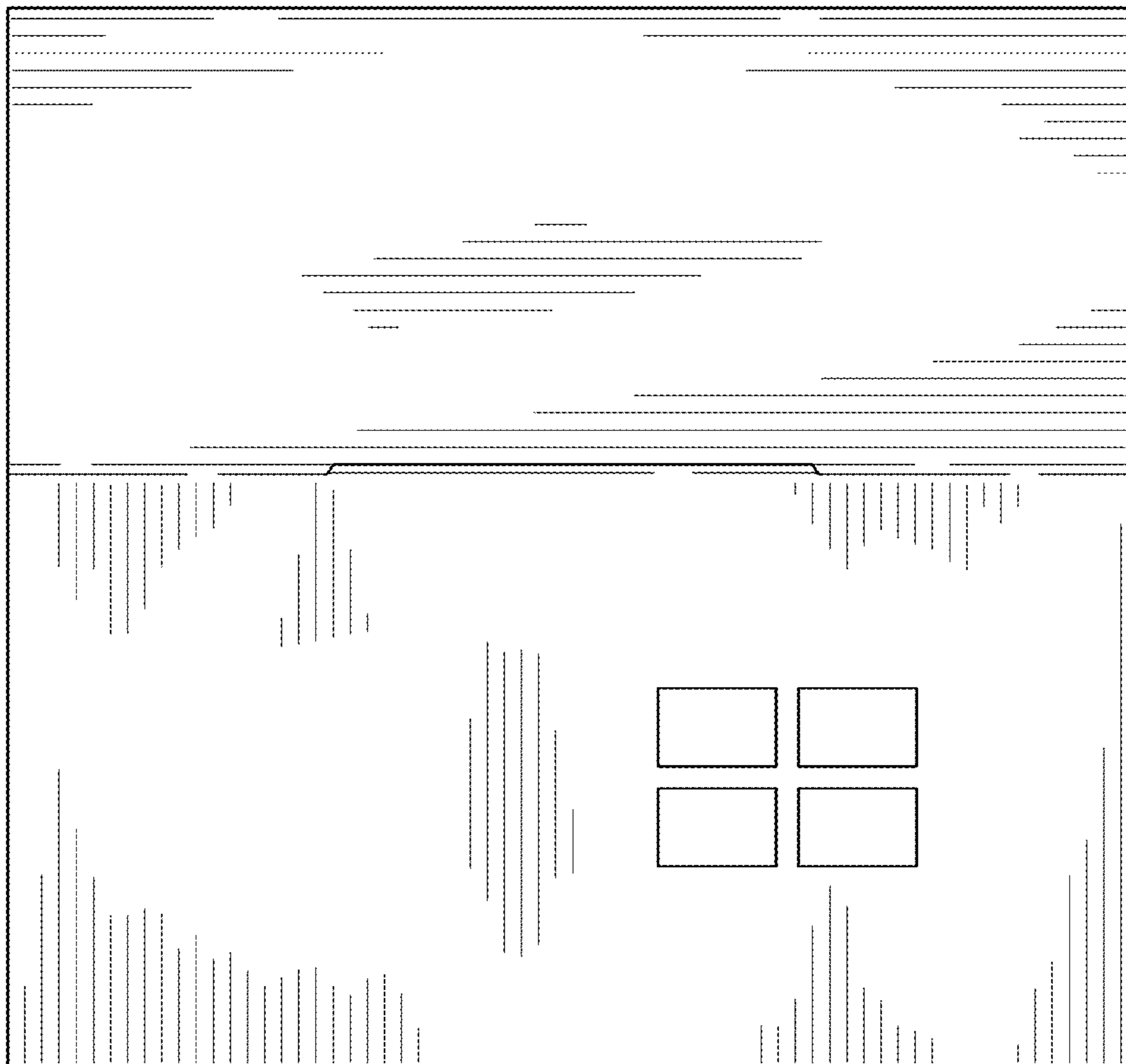

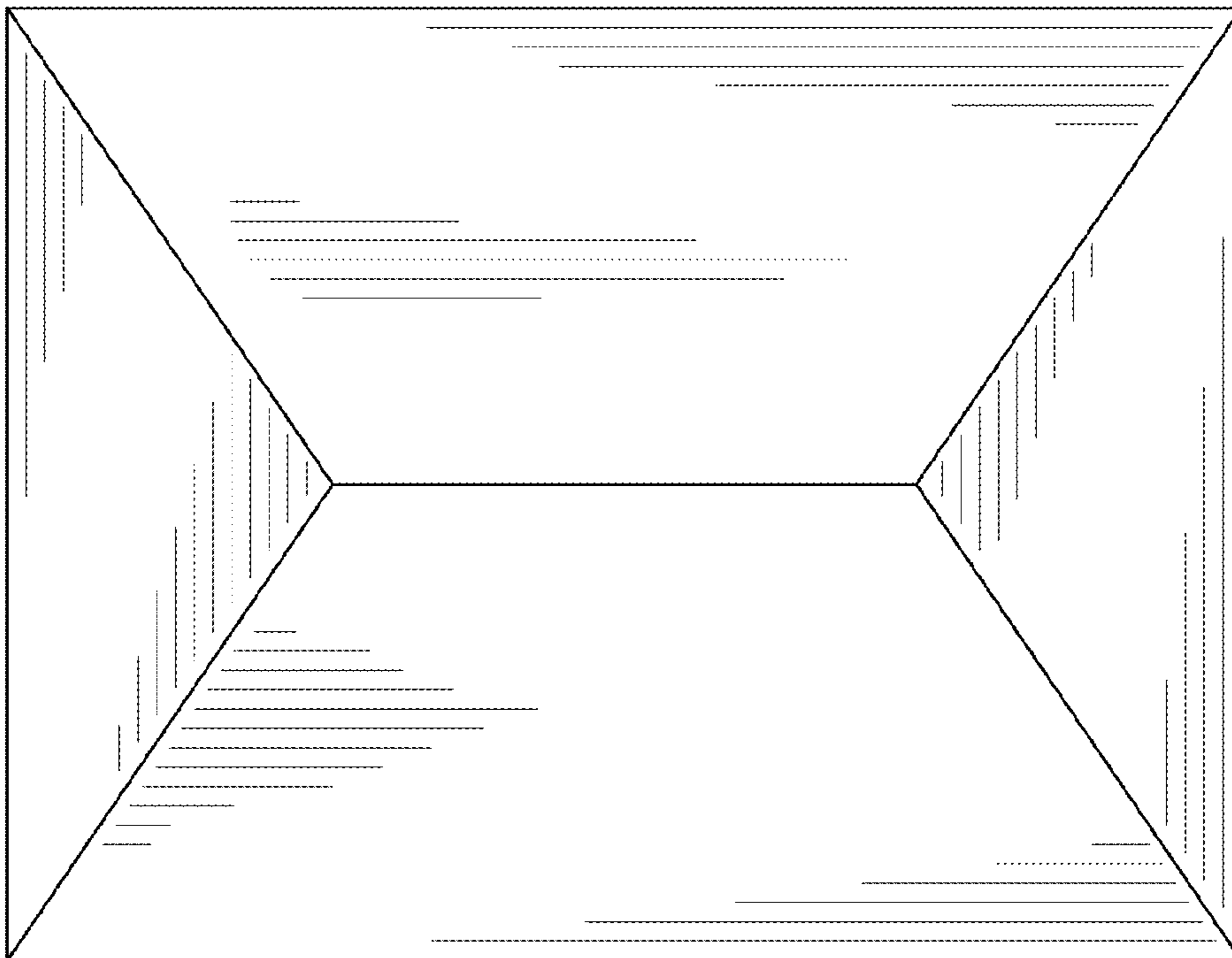

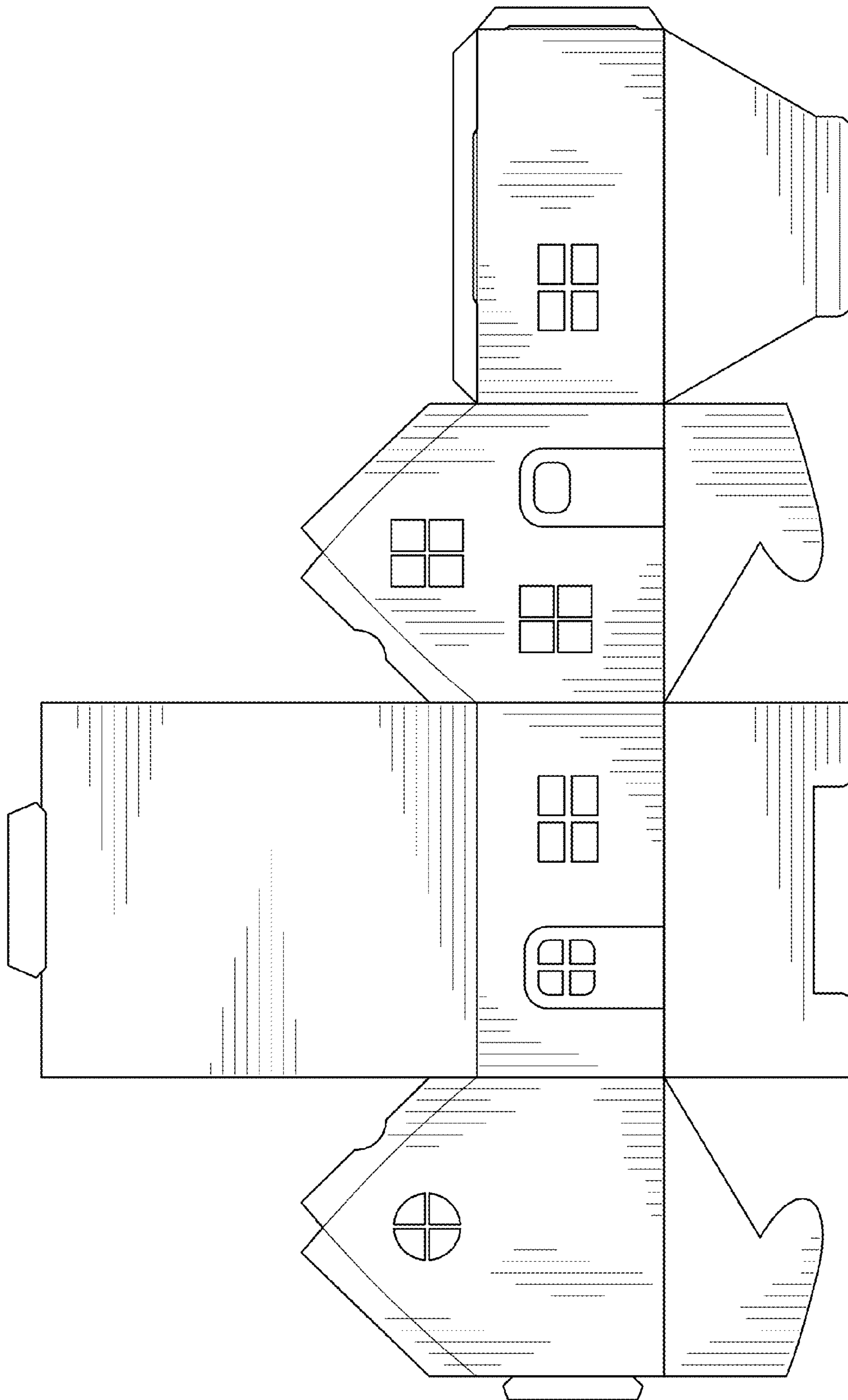
