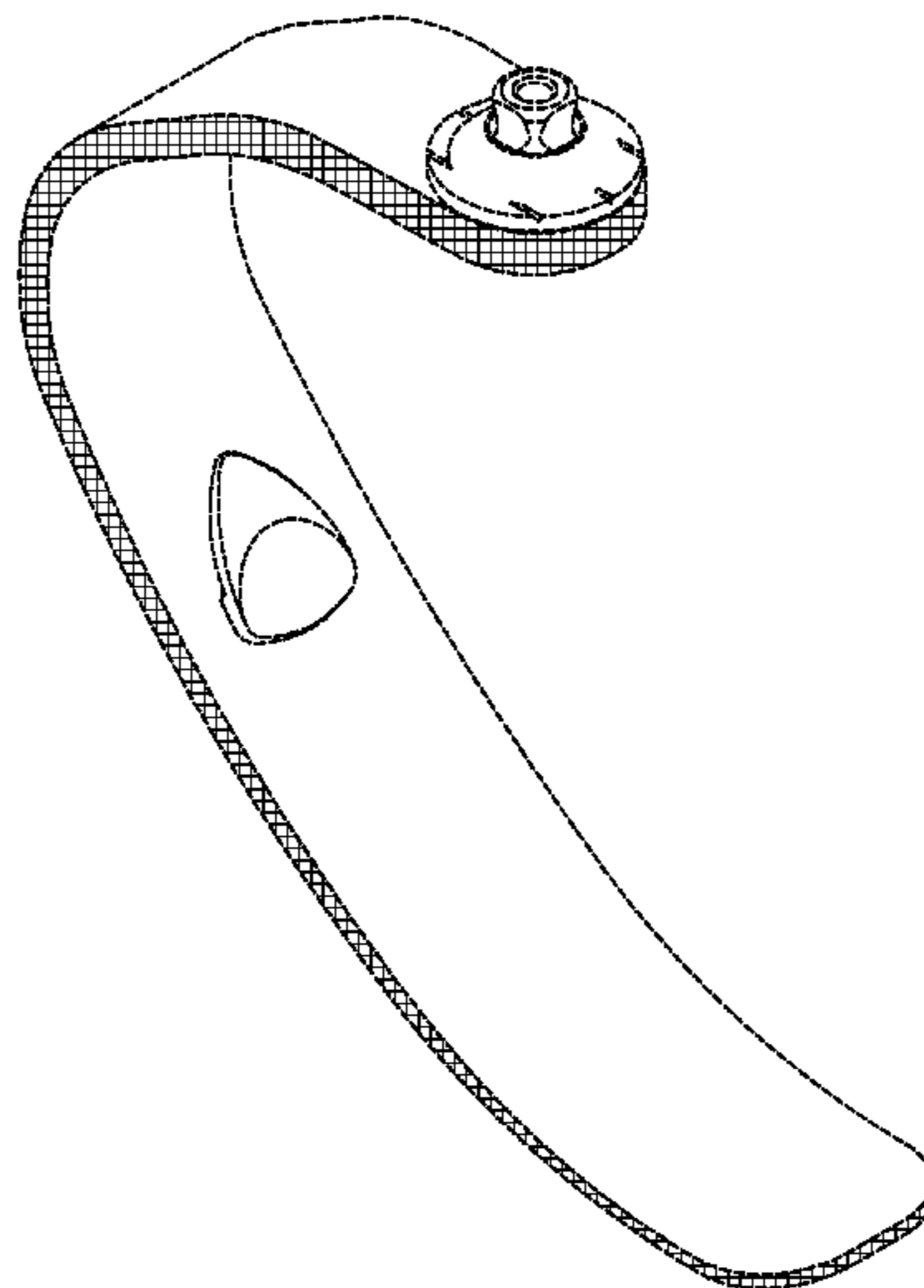
(57) **CLAIM**

The ornamental design for a prosthetic foot with a colored edge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a prosthetic foot with a colored edge showing our new design, lined for the color yellow;
 FIG. 2 is a left side view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a front view thereof.
 FIG. 5 is a back view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a top view thereof;
 FIG. 8 is a perspective view of the design of FIG. 1, lined for the color violet or purple;
 FIG. 9 is a perspective view of the design of FIG. 1, lined for the color blue;
 FIG. 10 is a perspective view of the design of FIG. 1, lined for the color green;
 FIG. 11 is a perspective view of the design of FIG. 1, lined for the color orange;
 FIG. 12 is a perspective view of the design of FIG. 1, lined for the color red or pink;
 FIG. 13 is a perspective view of the design of FIG. 1, lined for the color brown;
 FIG. 14 is a perspective view of the design of FIG. 1, lined for the color black; and,
 FIG. 15 is a perspective view of the design of FIG. 1, lined for the color gray or silver.
 FIGS. 1-15 illustrate one embodiment of a prosthetic foot with a colored edge. Only one perspective view of the embodiments in FIGS. 8-15 is shown, since each one of these embodiments has a colored edge in the same regions shown in FIGS. 1-7. The broken lines, where shown, are for illustrative purposes only and form no part of the claimed design.

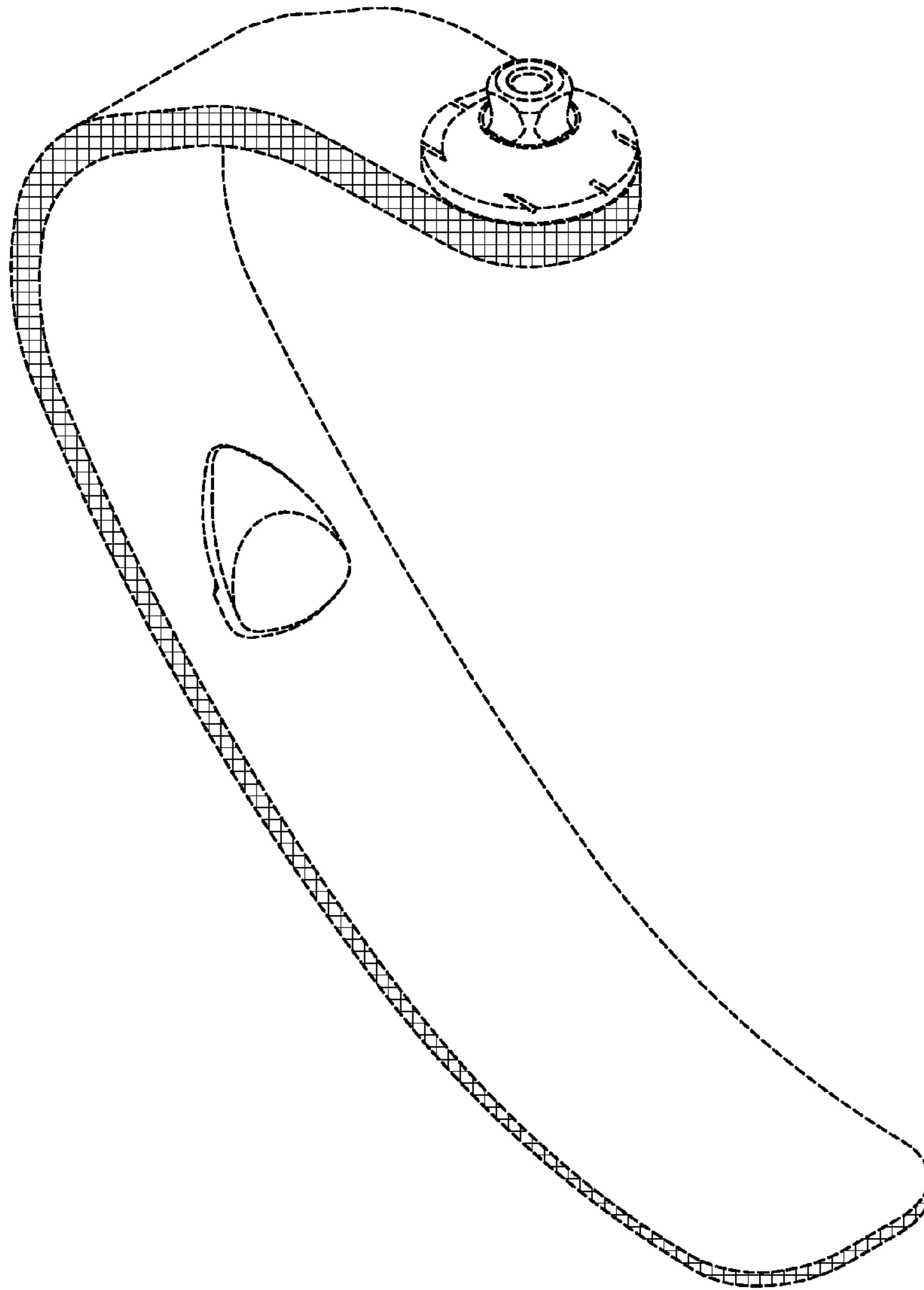

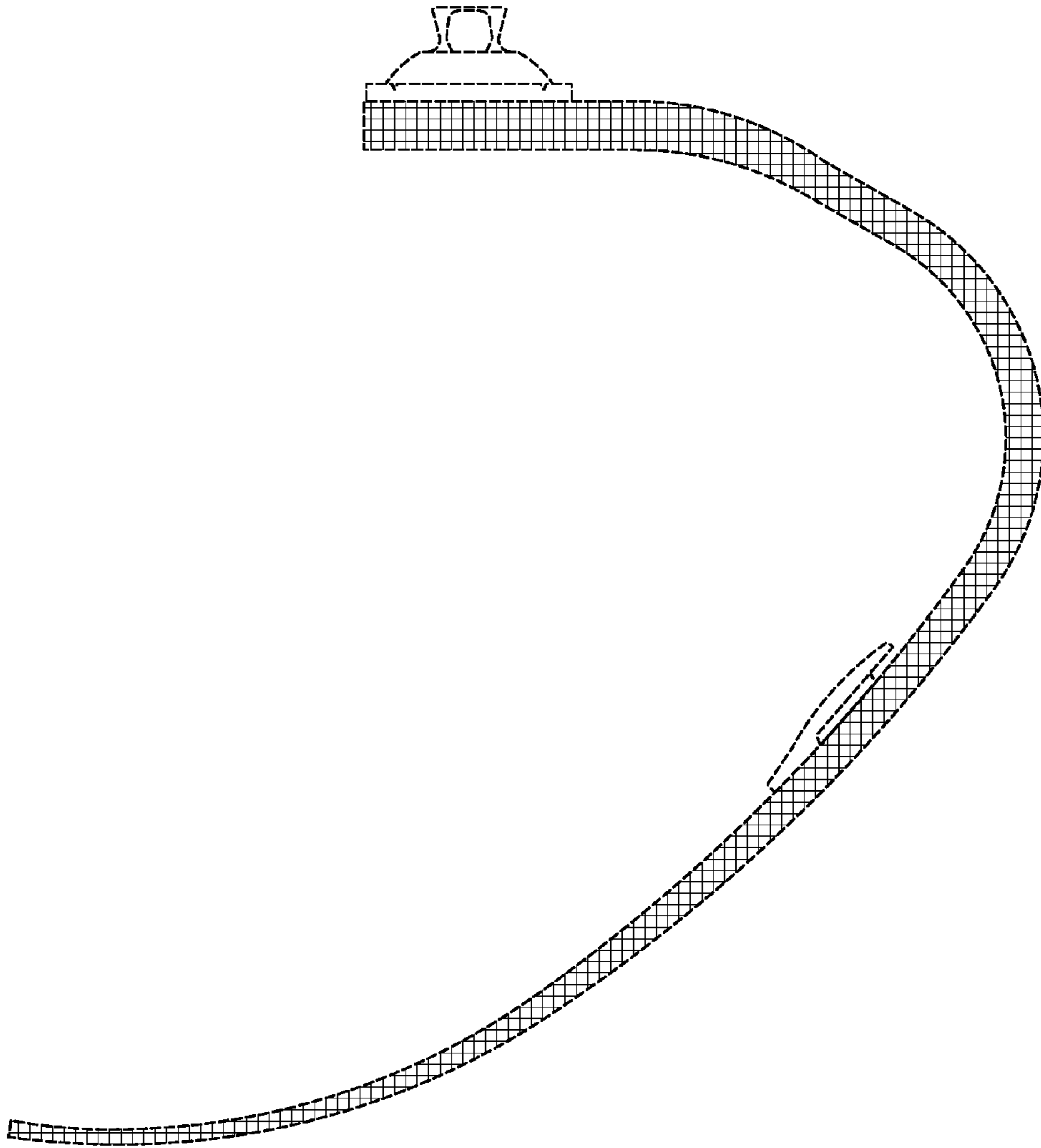

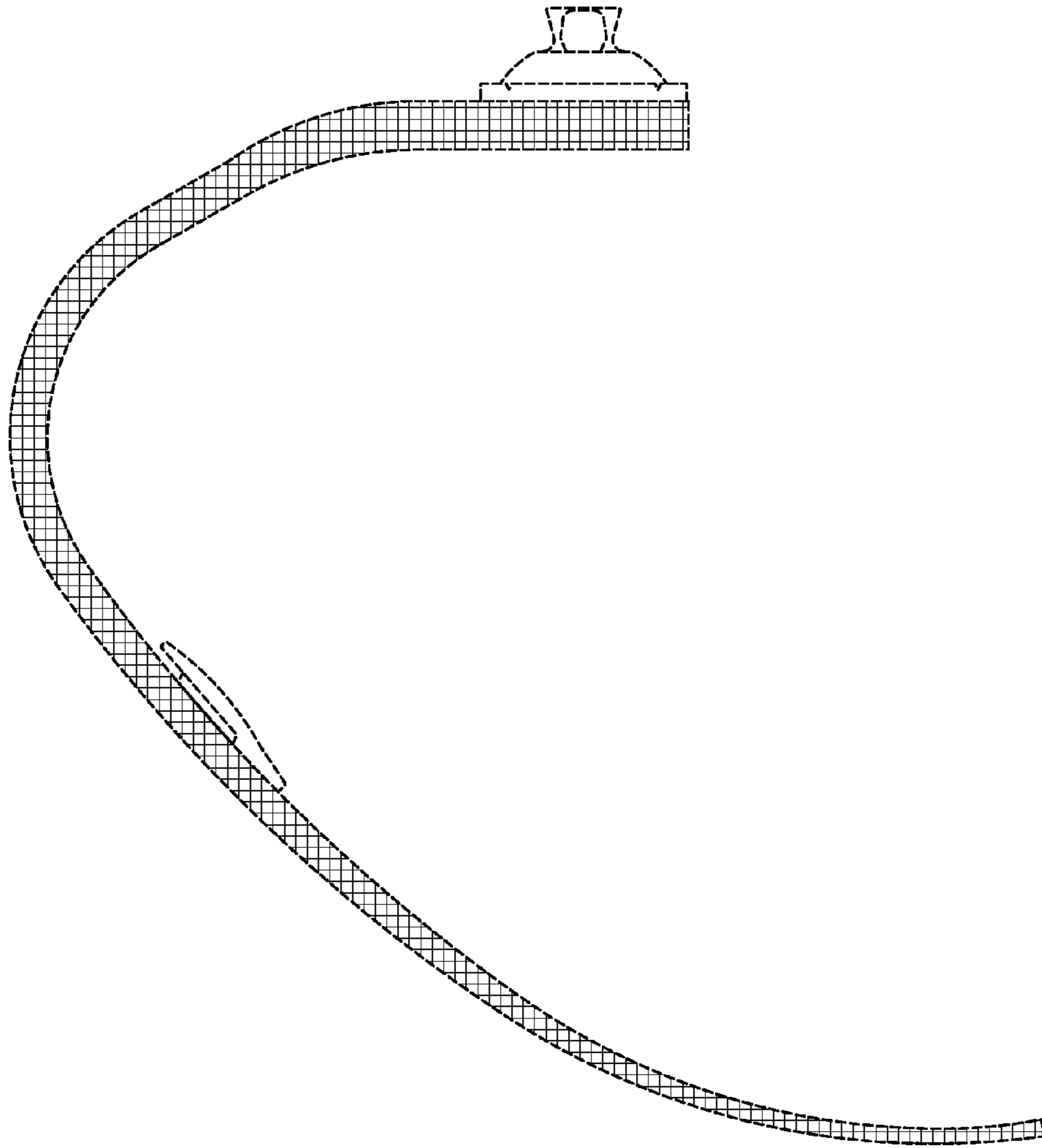

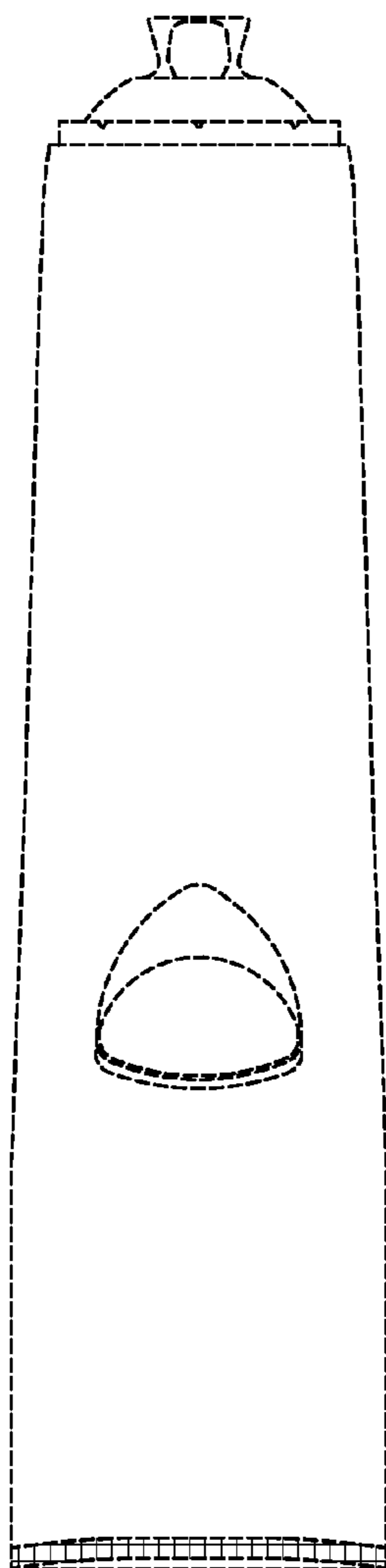

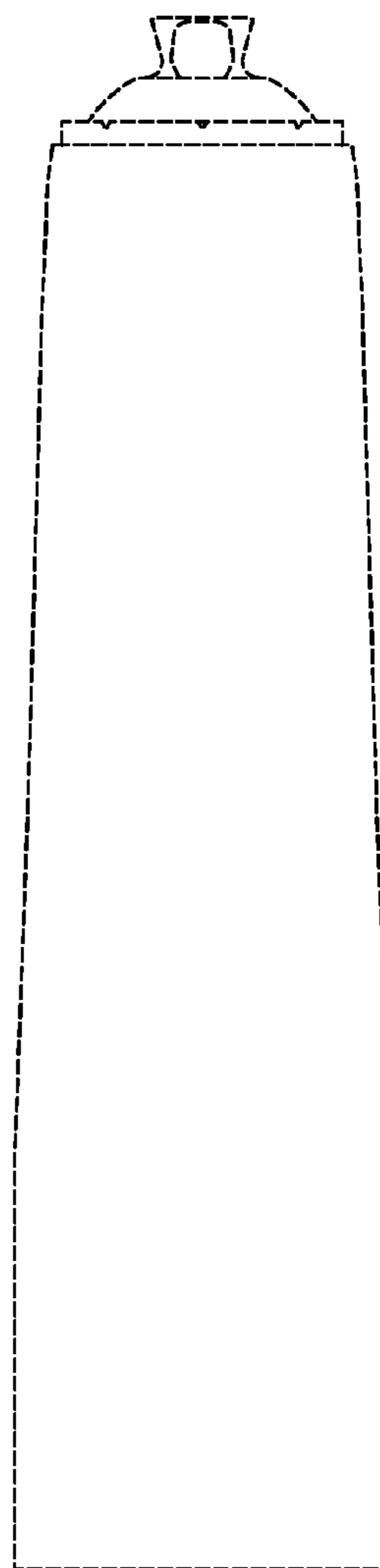

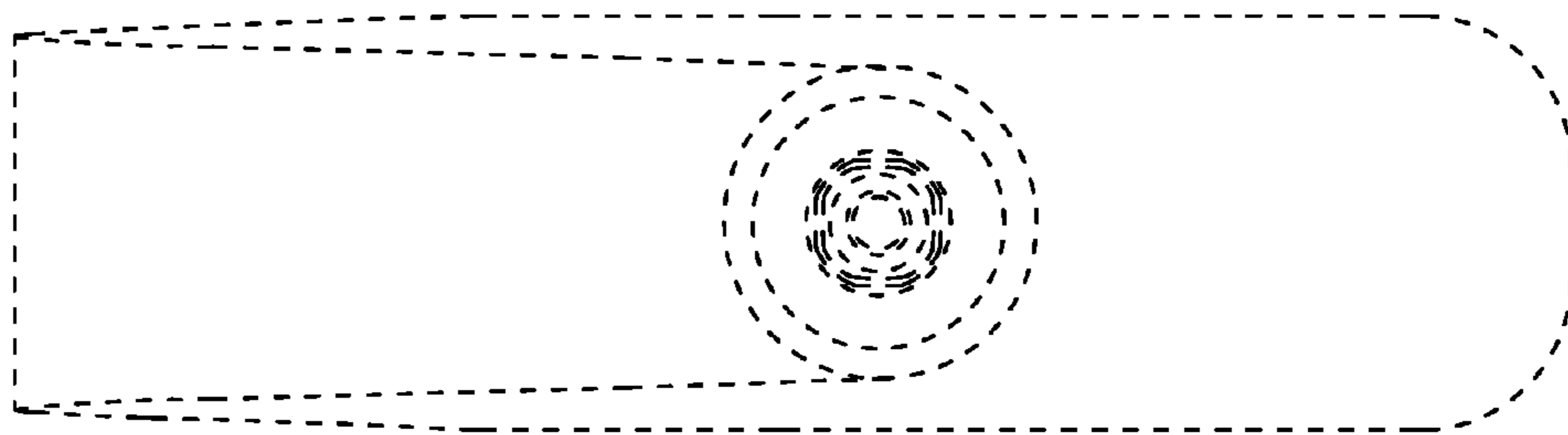

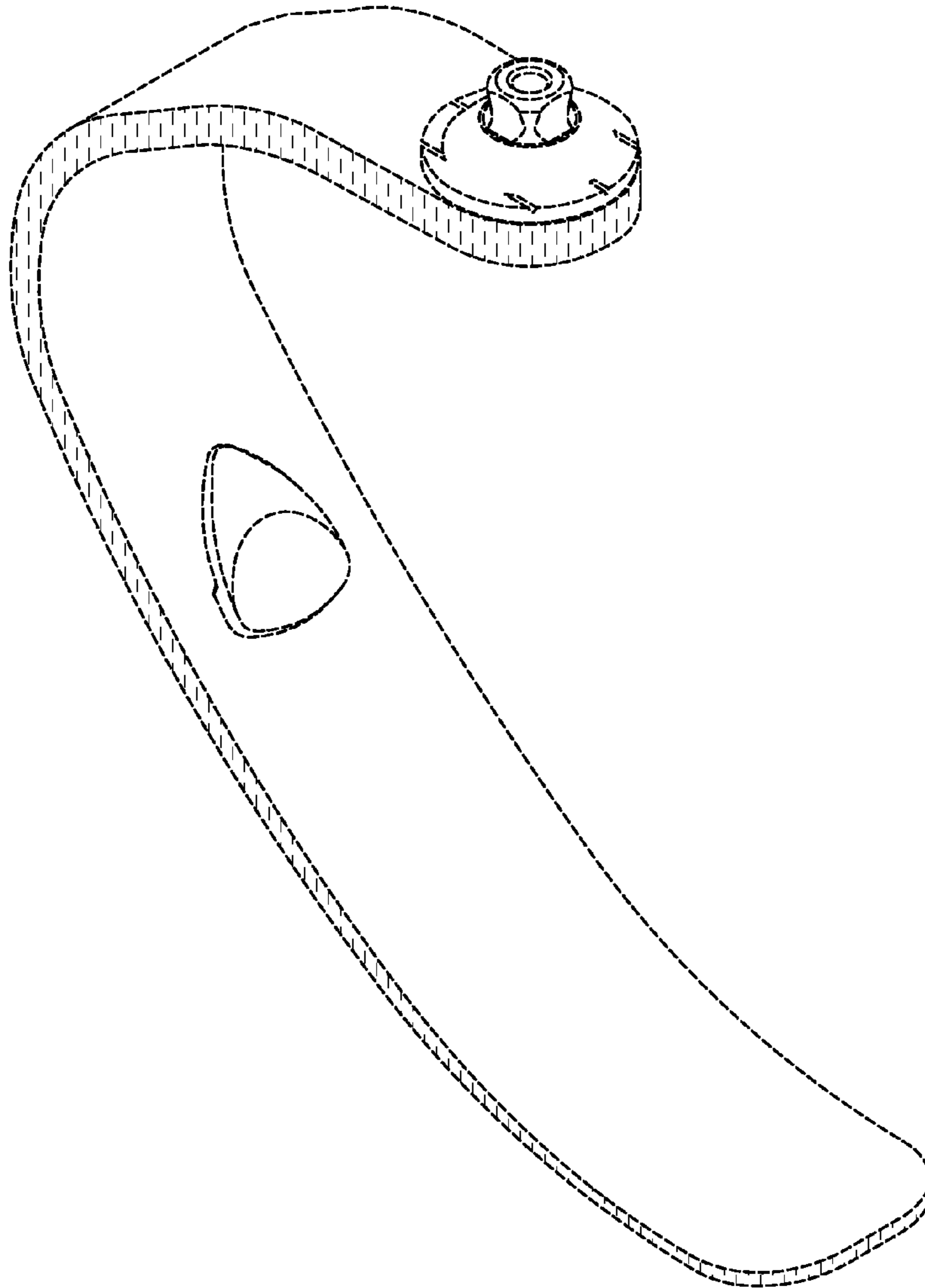

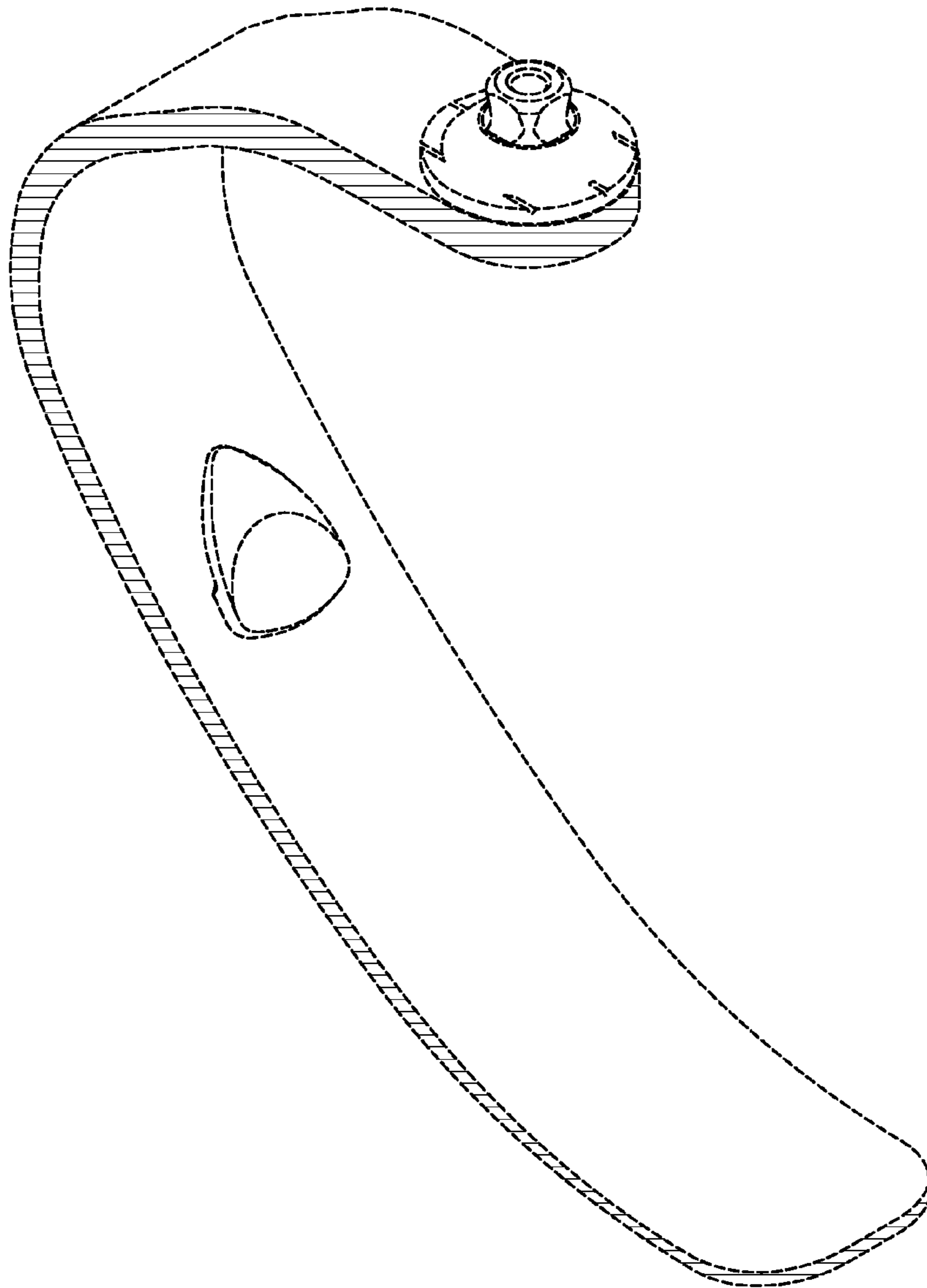

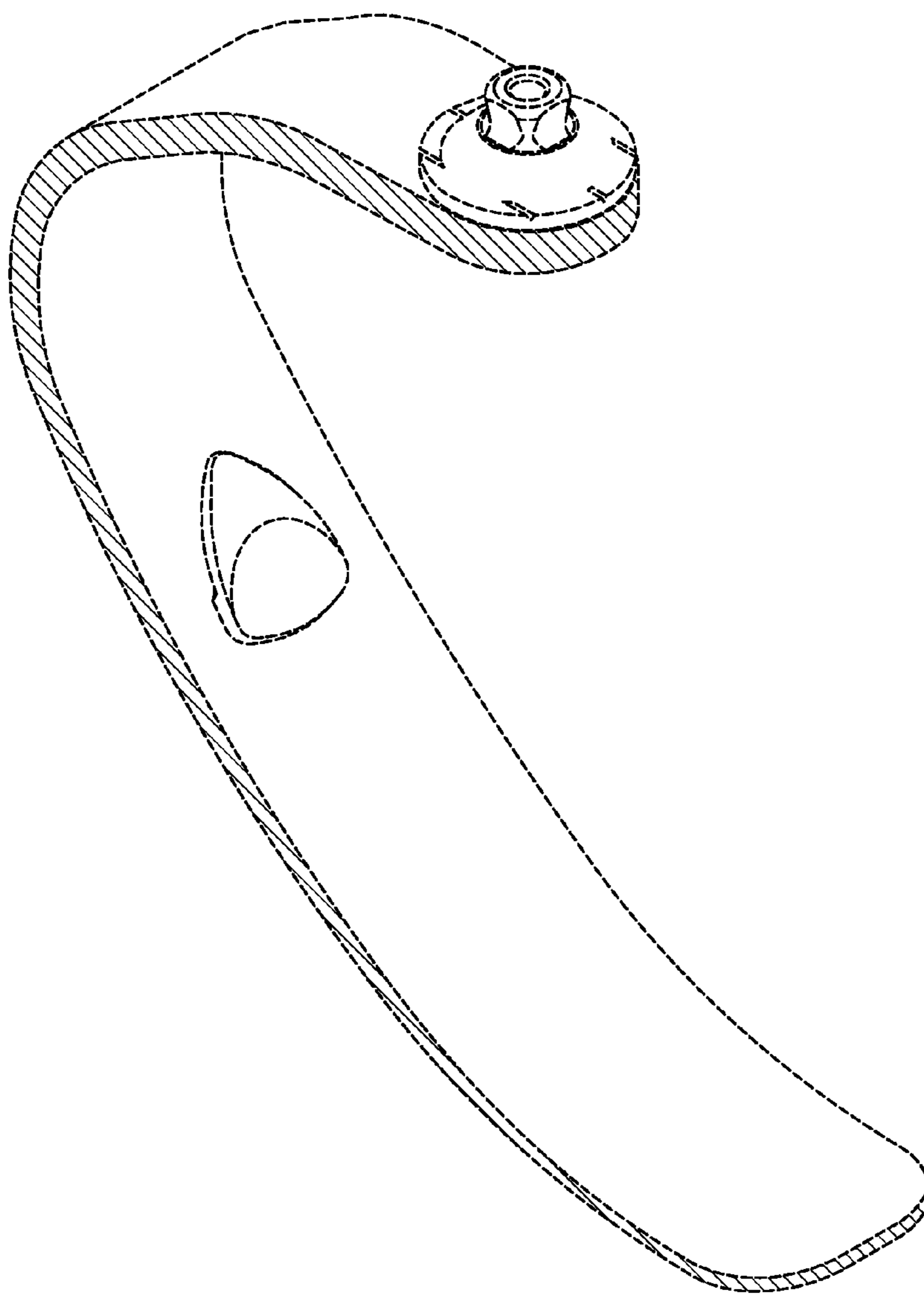

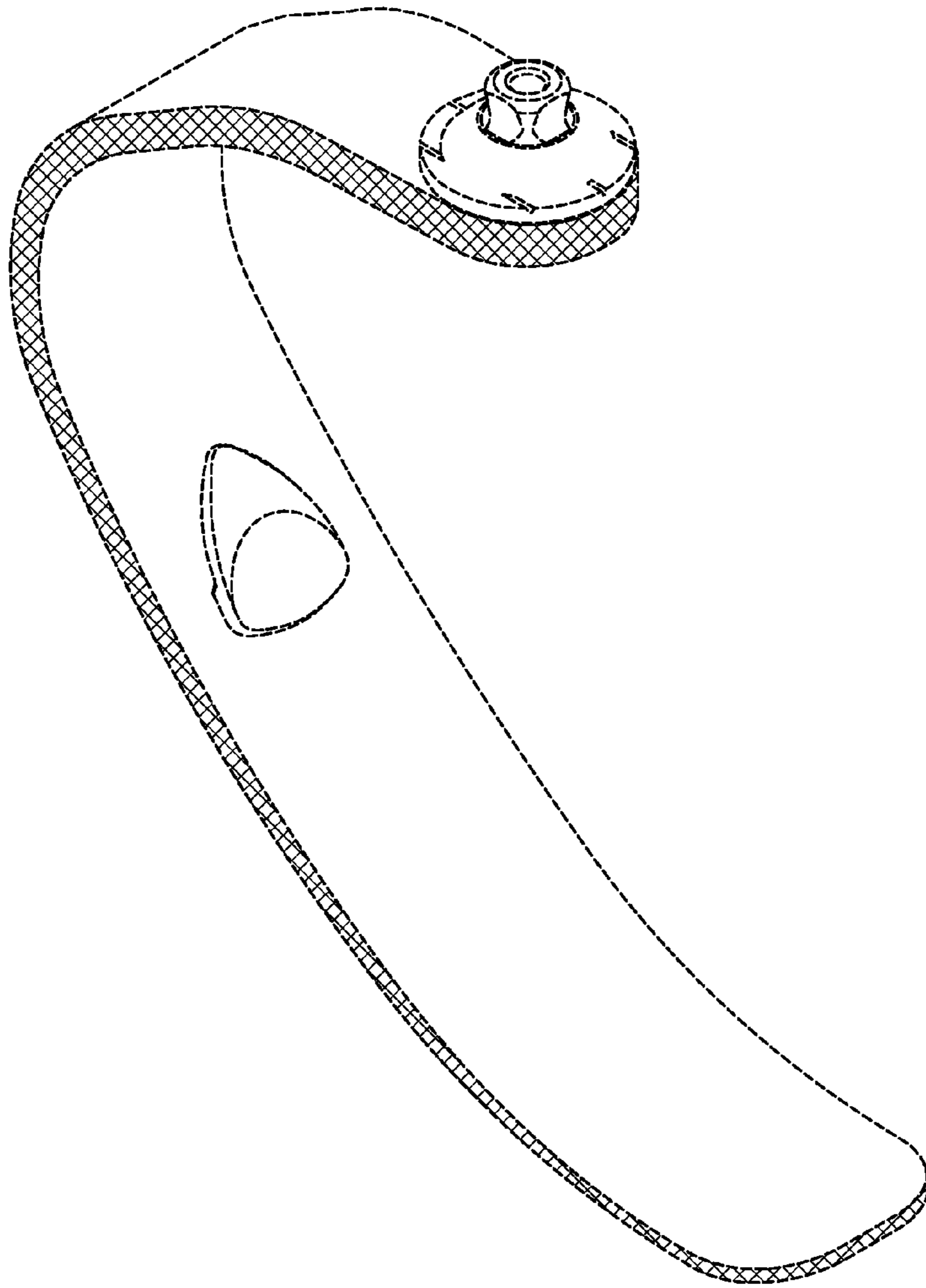

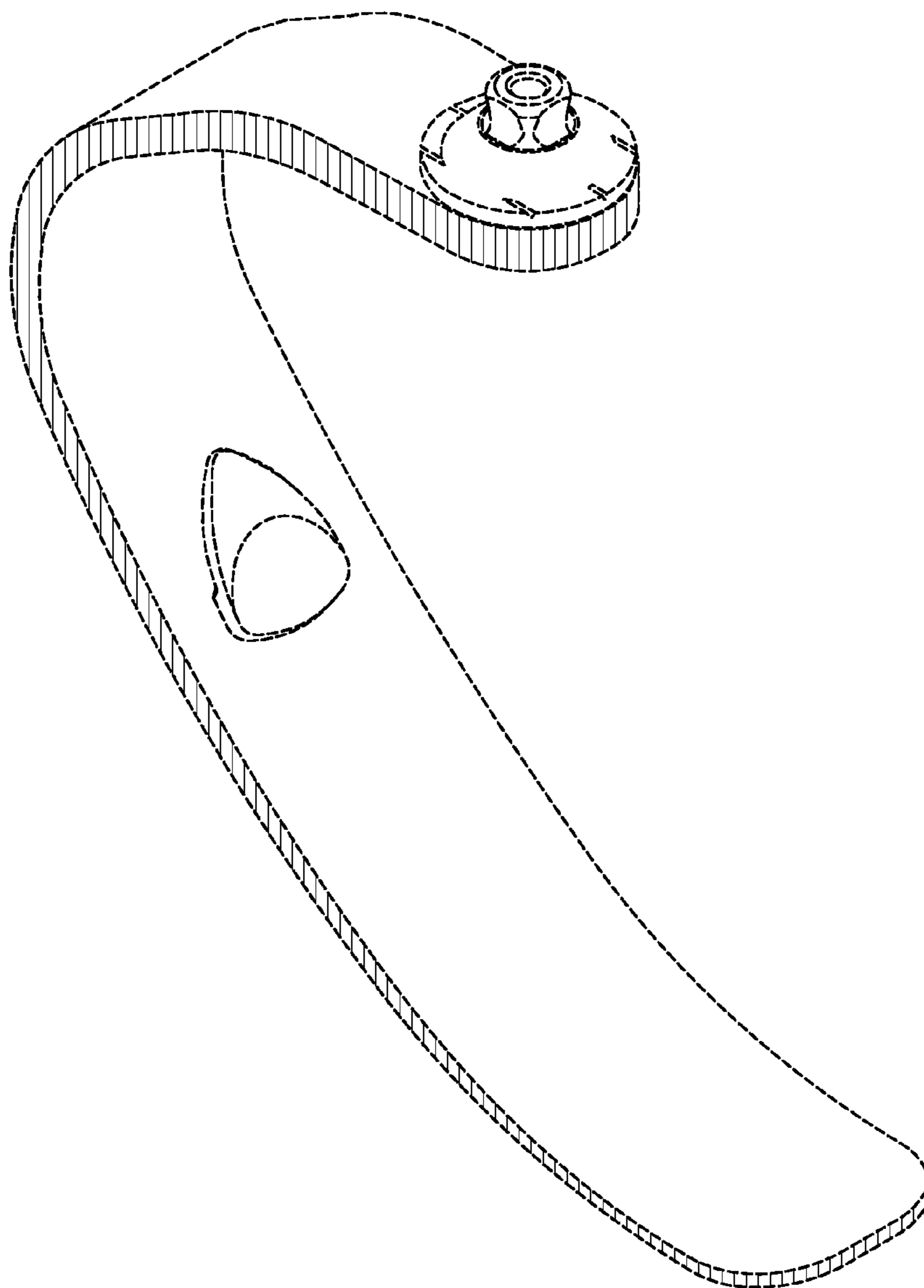

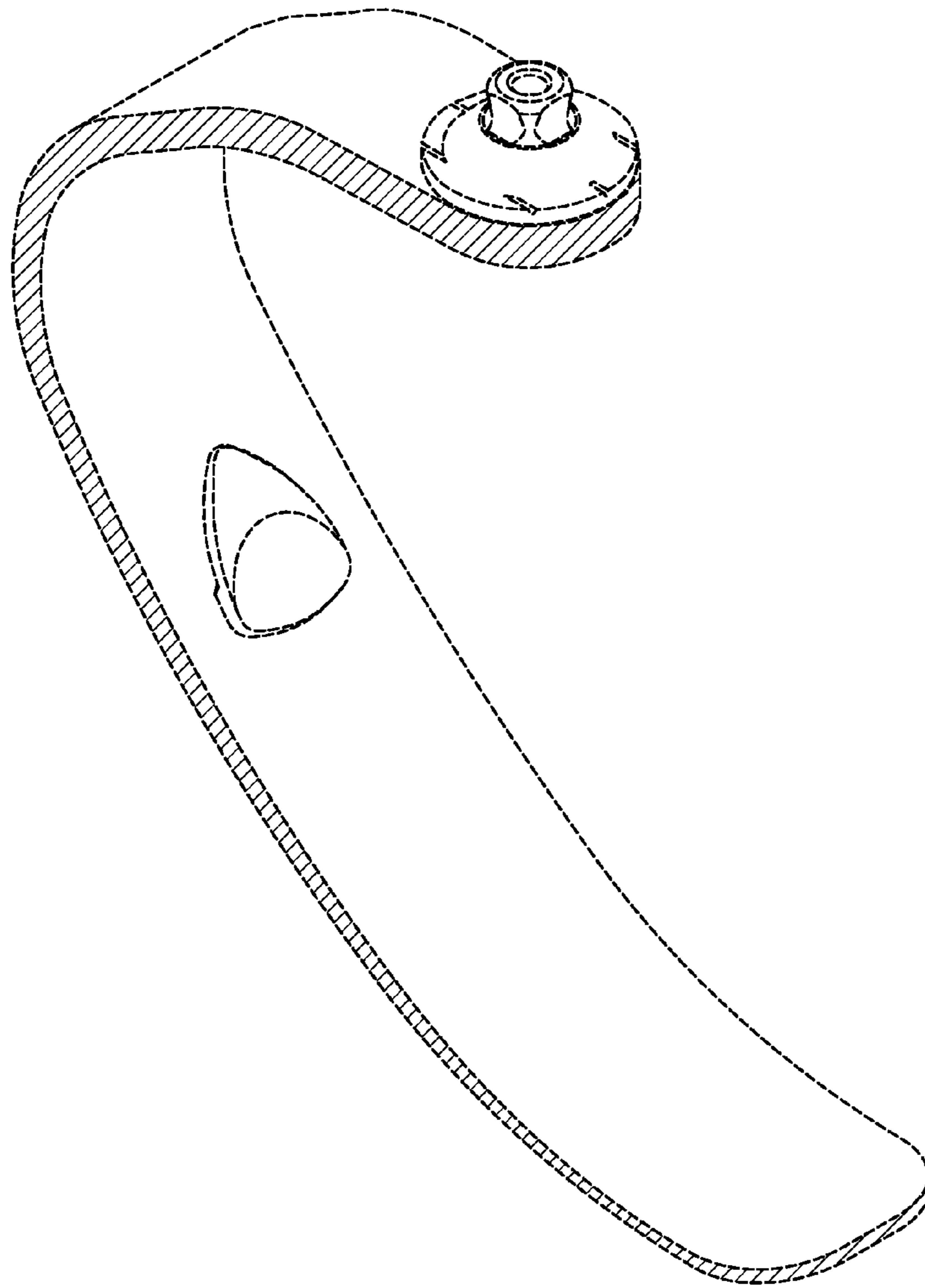

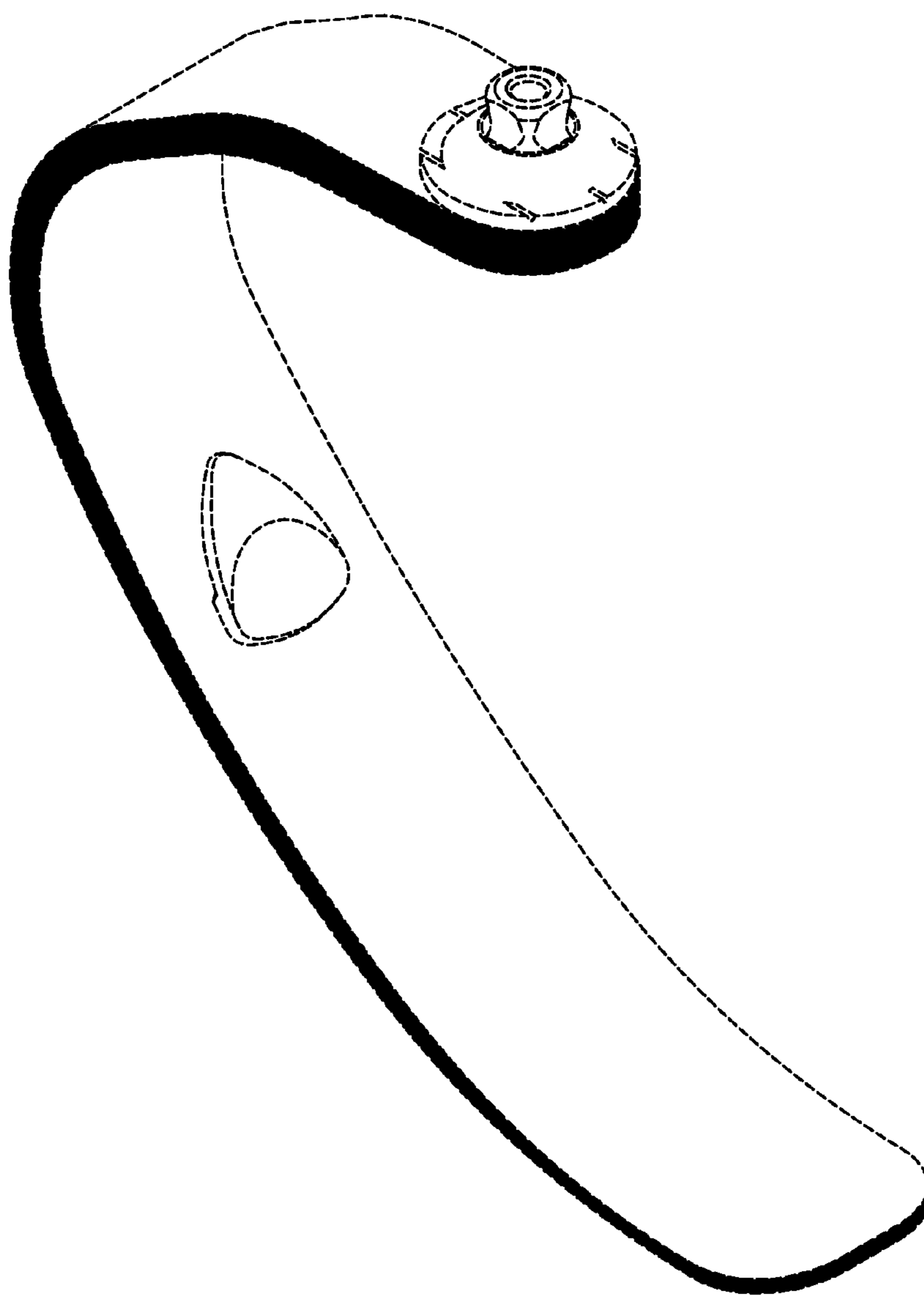

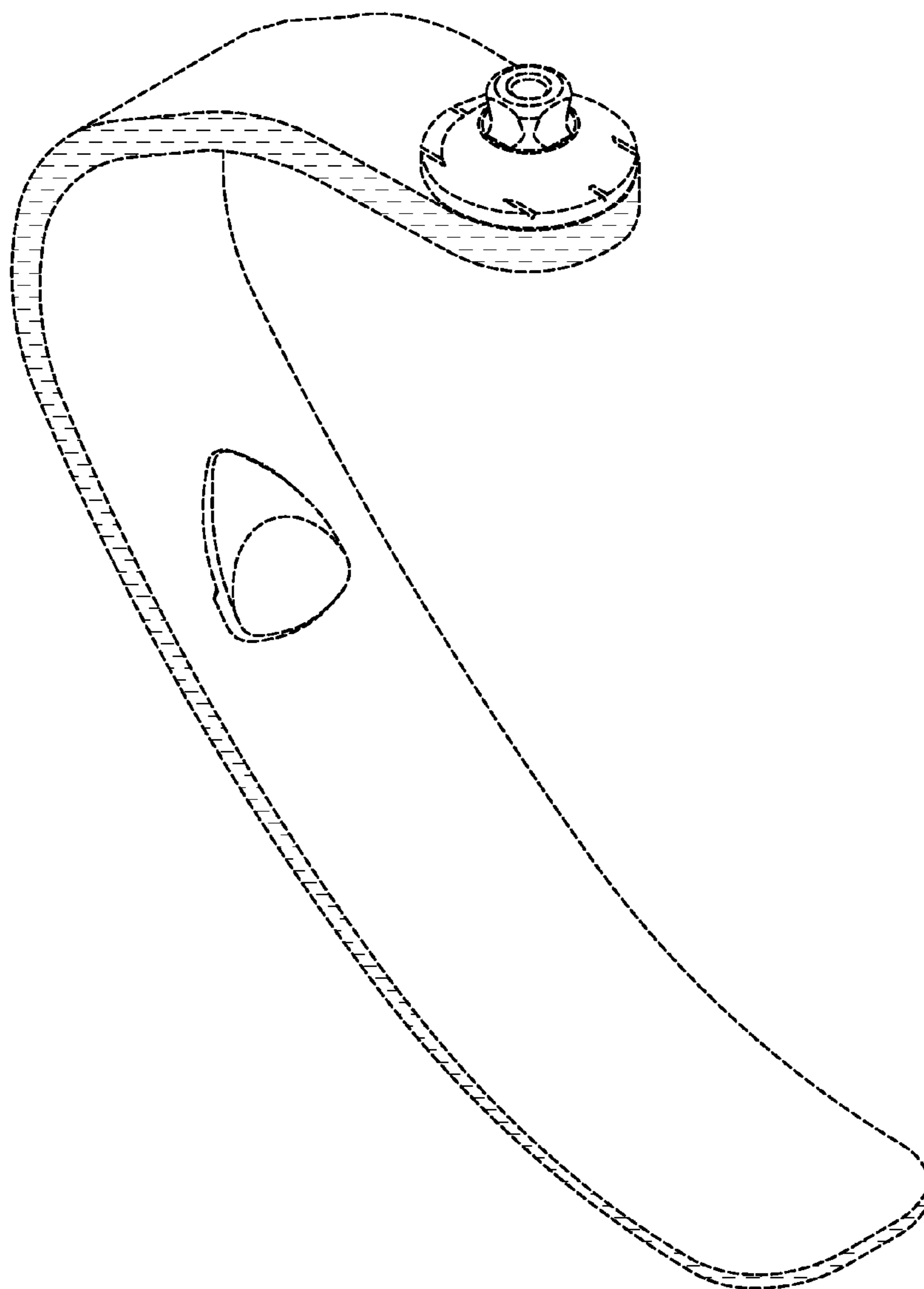
